Form factors in the SS model and its RSOS restrictions

A bstract

New integral representations for form factors in the two parametric SS model are proposed. Some form factors in the paraferm ionic sine-Gordon model and in an integrable perturbation of SU (2) coset conformal eld theories are straightforwardly obtained by different quantum group restrictions. Numerical checks on the value of the central charge are performed.

1 Introduction

Form factors with n particles of an operator are the matrix elements of this operator between the vacuum and an particles state. They are non pertubative objects that can be constructed, up to a normalization, as solution of "bootstrap" equations [1{3], once the exact scattering matrix is known. Besides being solutions of a nice mathematical problem, the form factors are useful tools to determine the long distance expansion of correlation functions by inserting a complete set of asymptotic states. It is often enough to approximate (with a good accuracy) the correlation functions of local operators with the contribution of the form factor with the smallest number of particles, due to the fast convergence of the spectral series ².

In this paper, we construct form factors in a two parametric family of massive integrable quantum eld theories known as the SS model, whose action can be found in [4], and which can be written in terms of three boson elds ' i; i = 1;2;3 with an exponential interaction. We will

restrict ourselves to the unitary regime of this theory [4], where the model has a U (1) U (1) symmetry described by two conserved topological charges:

where $j_i^{0;1}$ are the components of the U (1) current. Both classically and in the quantum case, the charges (eigenvalues of the charges) satisfy the conditions:

The U (1) U (1) sym m etry can be extended up to the sym m etry generated by two quantum a ne algebras U $_{q_1}$ ($\hat{sl_2}$) U $_{q_2}$ ($\hat{sl_2}$). The name of the SS model is unfortunately justified by the expression of its two-particles S-m atrix - rst considered in [5]—in terms of two sine-G ordon S SG -m atrices with different coupling constants $_{1}$; $_{2}$:

where $p_1 = \frac{2}{8} \cdot \frac{2}{1}$; $p_2 = \frac{2}{8} \cdot \frac{2}{2}$ [6], and $p_2 = 1$ 2 is the rapidity dierence. The unitary regime is characterized by the following conditions on the parameters: $p_1; p_2 > 0$ and $p_1 + p_2 = 2$. The SS model includes, as particular cases, the N=2 supersym metric sine-Gordon model, whose S-matrix has the form [7]:

as well as the O (4) non linear sigm a model (Principal chiral eld model [8,9]), which possesses SU (2) SU (2) sym metry; its S-matrix reads [6]

which is nothing but the tensor product of two S-m atrices of the SU (2) invariant Thirring model. It also contains the anisotropic chiral eld [10], which has the U (1) SU (2) sym metry; its S-m atrix is

The SS m odelalso includes other known integrable QFTs, like the O (3) non linear sigm a m odel, the sausage m odel [11] and the cosine-cosine m odel [12]. Let us note in passing that the ground state energy of the model in nite volume was determined in [4] by TBA method, and the nite size e ects for the SS model were recently studied in [13].

In order to construct the form factors in this theory, we give in the rst section a sum mary of the method used in [14,15] to construct form factors in the sine-G ordon model, and recall how to perform RSOS restriction [16] directly on sine-G ordon form factors [17]. In the second section, we propose a generic formula inspired from the SG model for form factors containing an even number of particles in the SS model; in particular we write down the form factors of the trace of the energy momentum tensor, rst obtained in [5], and of some of the exponential elds (this problem was also recently considered in [18], with dierent methods). Two particles form factors of these operators can be expressed in terms of two particles form factors in the SG model. Then we do two dierent kinds of RSOS restrictions, namely [19] to

the paraferm ionic sine-G ordon model (this model includes, amongst others, the N=1 and the restricted N=2 supersymmetric sine-G ordon models), and to the integrable perturbed coset CFT [20] su $(2)_{p_1-2}$ su $(2)_{p_2-2}$ =su $(2)_{p_1+p_2-4}$. A common limit of these QFT's is the Polyakov-W iegmann model [8]. We propose expressions for form factors of the trace operator (they were rst considered in [5]). In particular, we check our expressions for the two particles form factor of the trace of the energy momentum tensor by making a numerical estimation of the central charge and compare it with the exact result.

2 Form factors in the sine-Gordon model and RSOS restriction

In this section we recapitulate known results on form factors in the SG model in the repulsive regime. They will be useful in the next section for the construction of the form factors in the SS model.

The Sine-Gordon model alias the massive Thirring model is dened by the Lagrangians:

respectively. The ferm i eld correspond to the soliton and antisoliton and the bose eld ' to the lowest breather which is the lowest soliton antisoliton bound state. The relation between the coupling constants was found in [21] within the fram ework of perturbation theory:

where s (or +) corresponds to the solitonic state (highest weight state), and s (or -) to the antisolitonic state. Form factors containing an arbitrary number of particles for the energy momentum tensor, the topological current and the sem i-local operator $e^{i\frac{1}{2}'sg}$ were rst constructed in [3] by Sm imov; form factors of non-local exponential elds $e^{ia'sg}$ were constructed in [22] by Lukyanov, using free eld representation techniques that provide integral representations different from those of [3]. Below, we make the choice to present the posterior construction presented in [14,15] by Babu jian and K arow skiet. al.

We rst introduce the minimal form factor f_p (12) of the SG model; it satisfies the relation

The number of integration variables m is related to the topological charge Q (Q 2 Z) of the operator considered and the number n of particles through the relation Q = n - 2m. For example, for n = 2 and Q = 0,

The function p_n (;u) is the only ingredient in formula (3) which depends on the operator considered. If the operator is chargeless, the form factors contain an even number of particles, and if in addition the operator is local, then the p-function satis es the conditions⁵:

Finally, the integration contours C consist of several pieces for all integration variables u_j : a line from 1 to 1 avoiding all poles such that Im $_i$ < Im u_j < Im $_i$; and clockwise oriented circles around the poles (of the $(_i \ u_j)$) at $_i = u_j$, (j = 1; :::; m).

Trace of the energy momentum tensor. The trace operator is a spinless and chargeless local operator. Its p-function is [15]:

The two particles form factor can be computed explicitly:

in agreement with the result rst obtained by diagonalization of the S SG -m atrix in [1]. The normalization for two particles is chosen to be N $_2=\frac{1}{p}iM^2C_p^4$ (M being the mass of the soliton), in order to have:

Exponential elds. The p-function of the spinless, chargeless, non local, exponential eld $e^{ia'_{SG}(x)}$ in the SG model is not written in [15], though it is a minor extension of the results contained in this paper. It reads

The form factors of exponential elds were rst constructed in [22] with a di erent representation. For $a = \frac{k}{2}$, with $k \ 2 \ Z$, the form factors can be computed explicitly, and their expression can be found in [22]; In particular, the form factors of the sem i-local operator $e^{-i\frac{\pi}{2}' \, S \, G^{-(x)}}$ were rst obtained in [3]; their expression with two particles is $e^{-i\frac{\pi}{2}}$.

An important remark to be made is that there exists an alternative p—function to eq. (4) for the trace of the energy momentum tensor. Indeed, if one remembers that in the SG model the trace is identiced as the term in the action \cos ' $_{SG}$, up to inessential \cos cients, then one can rewrite its p—function in a suggestive form as a sum of p—functions for exponential elds with a = and a =, i.e.:

RSOS restriction [16]. The RSOS restriction describes the $_{1;3}$ -perturbations of m in im alm odels of CFT [25] for rational values of p. When p is an integer, we deal with $_{1;3}$ -perturbations of m in im alm odels M $_p$ with central charge c=1 $\frac{6}{p(p+1)}$. In particular, we remind that $S_3^{RSOS}=1$ is the Ising S-matrix. Form factors in the model M $_p$ can be directly obtained from those of the SG model, as explained in [17]. For the trace operator, the RSOS procedure consists of 'taking the half' of the p-function (4), such that its p-function reads:

the com putation of cturns out to be a non trivial check for the form factor f_{RSOS} ($_{12}$) in equation (8). In Table 1 above are presented the numerical results with two particles contribution for the central charge in the M $_p$ model versus the theoretical result. As one may observe with the case p=3:12, the parameter p can be taken continuous, as the observables depend continuously on \pm 8.

M ore generally [17], one can obtain the form factors of the primaries $_{1;k}$ using the identication $_{1;k}$ $e^{i\frac{(k-1)}{2}$'s $_{g}$ (x), and then 'twisting' the Bethe ansatz state like in (7). In the two particle case, the form factors can be computed explicitly.

3 Form factors in the SS model and its RSOS restrictions

This program (for $p_1; p_2$ 1) was initiated for this model rst by Sm imov [5] for form factors of the energy momentum tensor and the U (1) U (1) current, then continued recently by Fateev and Lashkevich [18], who proposed expressions for the form factors of the exponential elds using the method of [22].

The form-factors $F(_1; _{2n};)$ of a local operator in the SS model satisfy the system of equations [5]:

It has no poles and no zeros in the physical strip $0 < \text{Im}_{12} < \text{and at most a simple zero at}_{12} = 0$.

We make the following ansatz for the form factors in the SS model 9 :

A few comments about our ansatz are in order:

in the equation 12), the residue at the pole located at $_1 = _{2n} + i$ is simple. A sexplained in [5], the introduction of the cosine term in the minimal form factor (13) gives a zero at $_1 = _{2n} + i$, and consequently we should look for the residue at a second order pole of the integral representation proposed in equation (3).

the properties for the p-function of a local operator are \sin ilar to those of the SG m odel presented in the previous section, though with a \sin all modi cation at $_1 = _{2n} + i$:

clearly [5], the simple tensor product of the form factors of the SG model is not a solution as it spoils the residue equation. At $_1=_{2n}+i$, each of the 2n integration contours get pinched at $u_n=_{2n}$; $_{2n}$ i and $v_n=_{2n}$; $_{2n}$ i (the choice for the integration variables u_n and v_n is arbitrary because of sym m etry). For this reason we introduced the function M $_{2n}$ (;u;v) which must have the properties at $_1=_{2n}+i$:

The function above is not the only one to have the required properties, but we conjecture that this is the one we need.

It is not dicult to check that this expression satis es equations (11); this result agrees with [5]. The constant N $_2$ was chosen equal to N $_2=\frac{\left(c_{p_1}c_{p_2}\right)^4\text{M}^2}{p_1p_2}$, such that the following relation holds: F $(_1+i_1)=2$ M 2 e $_0$; where M is the mass of the fundamental particles. For $p_1=p_2=1$, $p_3=0$, we have two sine-Gordon models at the free fermion point; the expression of equation (16) becomes as expected:

A few numerical checks on the value of the central charge at the level of two particles contributions can be found in Table 2. Compared with the results of Table 1, one sees that the accuracy is rather poor. We have so far no compelling explanation for this phenomenon. It worth mentioning that in [29], it was already noticed that the two-particle approximation to the correlation function does not always give accurate results for the numerical estimation of the central charge, in contradiction with the common belief.

Exponential elds. We introduce a non locality factor $e^{2i \cdot (\frac{a_1}{1} \cdot \frac{a_2}{2})}$ in front of the product of the S-m atrices in the residue equation. We propose the p-function:

For more than two particles, there should be some signicant simplications in our general formula.

Fateev and Lashkevich constructed in [18] with a very different method the form factors for the most general exponential elds of the type $e^{2ia_1'}{}_1+2ia_2'{}_2+i(2a_3)^3$, which supposes that we introduce in the p-function a dependence with respect to an extra parameter a_3 , that does not a ect the non locality factor. For the time being, I do not see how to do this for a_3 arbitrary. The rst proposal that one could in agine for the exponential elds $e^{2i(a_1'}{}_1+a_2'{}_2$ $\frac{k}{2}$ a_3' a_3 , where k is an odd integer, is the following p-function:

However if one considers the free ferm ion point, one does not recover the expected result (unless k = 1), so this proposal should be rejected.

It is unclear to me what the form factors of exponential elds are for $a_3 \in 2_3$. The results of [18] indicate it should be possible to construct them, but I am not capable of making any comparisons with the results of this paper: in particular the authors of [18] have not succeeded in their article into making explicit evaluations of their two-particles integrals for the simpler cases $a_i = \frac{k_i}{2}$ i, so even their two particle form factor for the trace operator is not explicitly computed.

One may think of introducing a dependence w.r.t a_3 by considering linear combination of functions of the type (15) where we would change the number of elements of T. However, such a function (15) is very close to a similar function obtained in closely related mathematical problems though dierent physical contexts in [30,31]; in these articles only the function with # T = n 1 was considered, and it seems to me that this is what should be done also here¹².

RSOS restrictions.

For integer values of p_2 and p_2 3, the QFT adm its a quantum group restriction with respect to the symmetry group U_{q_2} (sl₂), $q_2 = \exp(\frac{2i}{p_2})$, giving the paraferm ionic sine-

The expression (23) for the two particles form factor of the trace of the energy momentum tensor correctly reproduces in a more or less accurate way the known value for the UV central charge c = 3 $6=p_2$: numerical checks are presented in Table 3. One sees that increasing p_2 with p_1 xed, the conformal dimension of the perturbing operator gets closer and closer to one, so one may expect a badly convergent integral (9), which would be responsible for the observed lack of precision in the numerical tests. For p_2 xed and increasing p_1 , the conformal dimension again gets close to one: we do not have any explanation for the fact that for $p_2 \notin 3$, the accuracy becomes better for p_1 bigger.

A gain, if we use the expression (6) for p_{SG} , we not the following value for the normalization constant N_2 :

Let us mention that another interesting case is obtained for $p_1 = 2$ and p_2 arbitrary integer. The QFTP $(2;p_2)$ possesses N = 2 supersym metry and is known as the N = 2 supersym metric restricted sine-Gordon model. The UV central charge is the same as before. The numerical checks on the central charge can be found in Table 4. We have found interesting to present in the table above three cases where p_2 is not an integer: as one may expect, the observables depend continuously on the parameter p_2 .

For integer values of p, the previous QFT P $(p_1;p_2)$ adm its an additional restriction with respect to the second quantum group $U_{q_1}(sl_2)$, $q_1=\exp(\frac{2i}{p_1})$. The resulting QFT [19], which corresponds to integrable perturbations with an operator c of conformal dimension c c of the coset model [20] su $(2)_{p_1-2}$ su $(2)_{p_2-2}$ =su $(2)_{p_1+p_2-4}$, is denoted by C $(p_1;p_2)$. For $p_1 = 3$, the QFT C(3; p_2) describes m in imal CFT models perturbed by the operator $p_1 = 3$, the QFT C(3; p_2) describes m in imal CFT models perturbed by the operator

For $p_1=4$, the QFT C (4; p_2) describes N=1 supersym m etric m in im alCFT m odels perturbed by the supersym m etry preserving operator $_{\rm C}$. In particular, the m odel C (4;4) possesses N=2 supersym m etry. The corresponding CFT has central charge c=1. It describes the special point at the critical line of the A shkin-Teller (Z₄) m odel. At the N=2 supersym m etric point the therm alloperator coincides with the operator $_{\rm C}$.

The basic elds in the coset CFT can be represented in terms of elds $_{\rm j}$ from the $\rm Z_{p_2}$ $_{\rm 2}$ CFT and a scalar bosonic eld 'as [36]:

Let us note that we certainly expect for sym metry reasons the p-function

to give the same result for the form factors.

The num erical checks provide results for the central charge in Table 5, to be compared with the exact result c=3 6 ($p_1^{-1}+p_2^{-1}$ ($p_1+p_2^{-2}$). For $p_1=3$, they are identical to those of Table 1. A gain, increasing p_1 ; p_2 make the conformal dimension of the perturbing operator closer and closer to one, leading to a badly converging integral (9), which may be responsible for the decrease of accuracy of the numerical results. Let us note again that the normalization constants N_2 do not reproduce the correct vev for the trace: indeed, with the p-function (27), we would obtain

Certainly, if $p_2 = 3$ we recover the form -factors of the operators $e^{ia_{1k}'(x)}$ in the m in im al model M p_1 :

A comm on limiting case of these two RSOS restrictions is the Polyakov-W iegm ann model [8], which is the same as the perturbation of the SU(2) W ZNW model at level k with action

where J^a (J^a) are the holomorphic (antiholomorphic) SU (2) currents. The S-m atrix of the model is given by:

We get the Principal Chiral Field model [8,9] in the extreme lim if k=+1. Whether one considers S_{+1}^{RSOS} (12) or S_{+1}^{SG} (12) amounts to the same result. The numerical estimations for the central charge with two particles contribution are given in Table 6.

The Polyakov-W iegm ann model is asymptotically free, and the trace operator is of conformal dimension one for any k; from the results above we deduce that the approximation with two particles leads to a conformal dimension of the trace operator which is less than one in the case of the SU (2) Thirring model (k=1), whereas when one increases k, it becomes closer and closer to one already at the level of two particles. Numerically, the value for the central charge is given by an integral that becomes logarithmically divergent when the conformal dimension of the perturbing operator is one. It is not clear why for small k the results are quite good, and poor for big k.

4 Conclusion

A few remarks should be made concerning the formula (15), which is one important result obtained in this paper.

The function M is universal as it does not depend on the scattering of the theory, and appears in models where the S-matrix is given by a tensor product of dierent S-matrix. Typically, such a construction (with suitable modications) is encountered in integrable massless ows [30,33,37], which contain three dierent types of scattering, between right/right

m overs, left/left m overs, and right/left m overs. It has also been used in a di erent physical context in $\beta1$.

O ther m athem atical solutions are obtained by changing in formula 15) the number of elements of the set T. It is not clear to what they could correspond.

Of course it is crucial to make a comparison with the results of [18].

The so-called one to one correspondence between operators of the UV CFT and operators in the massive/massless theory is a issue which deserves, to the opinion of the author, better understanding.
