Jain states on a torus: an unifying description

A bstract: We analyze the modular properties of the elective CFT description for Jain plateaux, proposed in [1], corresponding to the llings $=\frac{m}{2pm+1}$. We construct its characters for the twisted and the untwisted sector and the diagonal partition function. We show that the degrees of freedom entering the partition function go to complete a Z_m -orbifold construction of the RCFT $v^d(1)$ sum v_1 proposed for the Jain states [2, 3]. The resulting extended algebra of the chiral primary elds can be also viewed as a RCFT extension of the $v^d(1)$ W m minimal models [3]. For m = 2 we prove that our model, the TM, gives the RCFT closure of the extended minimal models $v^d(1)$ W v_2 .

1. Introduction

Historically the motivations for the use of the E ective Conform al Field Theory (ECFT) in describing a Quantum Hall Fluid (QHF) at the plateau [4,5] go back to the observation that the ground state wave function (Laughlin states) for the lling = 1=(2p+1) [6] can be written as correlators of vertex operators describing the anyon states (charged states), which were identiced as primary states of a two dimensional chiral CFT with central charge c = 1 [7]. The ECFT description of a QHF at the plateau accounts for the incompressibility of the Laughlin uid. The dynamical symmetry of this uid in the disk geometry is the area-preserving dieomorphisms of the plane which imply the W $_{1+1}$ algebra. This is the unique centrally extended quantum analogue of the classical area preserving dieomorphisms algebra \mathbf{w}_1 on the circle. For general lling it is known that it is necessary to introduce neutral elds in order to describe the area-preserving edge deformations of the incompressible uid. In this context two classes of CFTs have been proposed for Jain plateaux: the multi-components theory [2], characterized by the extended algebra \mathbf{w}_1 and the W $_{1+1}$ minimal models [8] both with central charge $\mathbf{c} = \mathbf{m}$.

In spite of having the same spectrum of edge excitations, they manifest dierences in the degeneracy of the states and in the quantum statistics.

An alternative and simple construction of the hierarchical model based upon the so called m-reduction procedure was given in [1], where a c = m (daughter) CFT was obtained from a c = 1 (mother) one. The daughter theory preserves the W $_{1+1}$ symmetry of the mother theory. In fact it is well known that for any positive integer m, the W $_{1+1}$ algebra with central charge c is isomorphic to its subalgebra consisting of elements of degrees divisible by m and which appear with central charge m c [9, 10], so implying the incompressibility of the QHF for any given plateau.

This procedure was developed in [11] and employed for both the Jain llings = $\frac{m}{2pm+1}$ in [1] and the non standard ones = $\frac{m}{pm+2}$ in [12] where it was shown how naturally it induces twists on the boundary, given by a Z_m group generated by the phases $j = e^{\frac{2-ij}{m}}$, $j = 1; \ldots; m$. As a consequence the chiral primary elds naturally appear as composite operators with a charged and a neutral component. It has been proved that their correlators reproduce the ground state wave function for the Jain as well as for the paired states, so generalizing the Laughlin type wave function on the plane [1, 12]. Only one $u^{i}(1)$ charged current survives to the discrete twist group while the role of the neutral degrees of freedom is to cancel out the m-root singularity present in the correlators of the charged operators, so restoring locality.

In this paper we present a detailed analysis of such a model, the T w isted Model (TM), for the Jain states on a torus (genus g=1 R iem ann surface), so extending the previous description given on the plane [1]. For the paired states this analysis was given in [13].

We construct the characters associated to the extended chiral algebra and show that they provide a nite dimensional representation of the $_0$ (2) subgroup of them odular group SL (2; Z)=Z₂. Finally we exhibit the diagonal partition function which is invariant under such a subgroup. The resulting theory is the Z_m -orbifold of the Rational CFT (RCFT) describing the multi-components theory. Furtherm one the extended algebra of the TM can be also viewed as a particular RCFT extension of the W $_{1+1}$ m in in almodels [14].

Indeed their extensions are the constituents of the periodic-periodic (P-P) and periodicantiperiodic (P-A) sector of this orbifold construction respectively. In addition to them the twisted (A-P) sector, is exactly what is needed in order to obtain the closure under $_0$ (2). We should also comment on the presence of quasihole states in the twisted sector and clustering properties [1,16] as it happens in the paired states.

All that emphasizes the key role of the m-reduction procedure in producing a RCFT which realizes a consistent W $_{1+\,1}$ extension of the classical area-preserving dieom orphisms of the plane.

 $^{^1}$ W e recall that the W $_{1+1}$ m in in alm odels [14], which are dened by the full degenerate representations of W $_{1+1}$; are not a RCFT because it is impossible to build a nite extended algebra by assembling their primary elds, each taken with multiplicity one, that is closed under the S modular transformation. Instead the multi-components bosonic theories are RCFT extensions of the W $_{1+1}$ m in imal models [8, 14, 15] where the extended primary elds are dened by collecting the elds of the full degenerate W $_{1+1}$ representations, but with multiplicity dierent from one. The TM is also a RCFT extension of the theory with a W $_{1+1}$ symmetry in which there are dierent multiplicities in any dierent sector.

The paper is organized as follows:

In sec. 2 we review the K-m atrix construction [2] of the multi-components theory of the Jain llings and brie y summarize the properties of the ground state wave functions on the plane of a system of interacting layers which have been rst analyzed in [17].

In sec. 3 we review the symmetries of the ECFT which are known in the literature: the RCFT with symmetry $\mathfrak{A}(1)$ sum $\mathfrak{A}(n)$ and the W $\mathfrak{A}(n)$ m in in almodels [8]. We also give the decomposition of the $\mathfrak{A}(1)$ sum $\mathfrak{A}(n)$ characters in terms of those of the W $\mathfrak{A}(n)$ m in in almodels [8, 14, 15]. Finally we indicate the $\mathfrak{A}(n)$ discrete group with respect to which the orbifold construction is made.

In sec. 4 we brie y sum m arize the m -reduction construction on the plane (genus g=0), which has been used in [1] to construct the TM for the Jain series at lling $=\frac{m}{2pm+1}$.

In sec. 5 we generalize it to the torus topology (genus g=1) and derive the extended chiral prim ary elds both for the twisted and the untwisted sectors and the corresponding characters. Then a comparison of the TM with the multi-components theory [2] is given and the features of the Z_m -orbifold construction shown. The factorization of the characters in terms of charged and neutral components is derived. Finally the special m=2 case is also analyzed.

In sec. 6 we construct the complete diagonal partition function of the TM.

In sec. 7 we show that the TM provides a RCFT closure of the extended m in imal models $\mathfrak{C}^{l}(1)$ W $_{m}$ Z₂. In fact we prove that the P-A sector of the TM gives a realization of the chiral algebra containing only degenerate W $_{1+1}$ representations.

Finally in sec. 8 we give conclusions and comments.

In App. A we describe the properties of the $_0$ (2) subgroup of the modular group.

In App. B we describe the extended odd RCFT $\mathfrak{A}^{(1)}_q$ for the Laughlin lling, $=\frac{1}{q}$ where q is odd, which we use as mother theory for the m-reduction, pointing out the reason for requesting the closure under $_0$ (2) only.

In App. C we give the transform ations of the characters of the TM under the elements of $_0$ (2), showing that they provide a nite representation for it. We also prove that the TM diagonal partition function is invariant under its action.

2. K -m atrix construction of the multi-components theory

The CFT for a m-levels QHF at lling = $\frac{m}{2pm+1}$ was given in [2, 18, 19] introducing the sym m etric and positive K m atrix:

The entries $K_{(i;j)}$; depending on m and p, de ne the braiding factors between electrons in the i and j level. In this simplified picture the levels are considered independent and fully equivalent and we will refer to them also as layers. The wave function on the plane for such a system can be given in terms of K as:

This is a special class of more general trial functions for the ground state of a multi-layer system. For the simplest case of only two layers (or levels) they can be codiled in the so called (m,n,k) states introduced by Halperin [17]. The integers in the bracket are in correspondence with the entries of the K matrix, i.e. $m=K_{(1;1)}$; $n=K_{(2;2)}$ and $k=K_{(1,2)}$. Some values of these integers give interesting models for special plateaux. The (p+2,p+2,p) generalize the well studied (3,3,1) state and it was analyzed recently in the m-reduction approach in [13]. Another interesting case is the (1,1,1) for which theoretical studies predict the existence of a Josephson like elect. Nevertheless this state does not satisfy the non-degeneracy of the K matrix so it does not enter the theories we are studying now.

The CFT of the system with a general K matrix is realized by m free bosons with an extended chiral algebra. These elds satisfy the compactication conditions given by [2]:

It is actually a metric of the lattice which refers to the electron eld. The compactication matrix (2.3) for diagonal h = ht, where t is the charge vector which satisfies the condition t^T (K) 1 t = and coincides with t^T = (1;::;1), defines the following compactication radius for the Q $^{(i)}$ bosons:

The primary elds for this theory are given by the vertex operators:

where $a = a^T R$ and $Q_b(z)$ is the boson with winding numbers b; their conformal dimensions $h_{a;b}$ are:

The extended RCFT, the multi-components $u^d(1)_K^m$ theory, can be constructed by means of the following physical conditions [20]:

1) The topological order [19] given by det (K) is an odd number and coincides with the number of primary elds of the extended algebra [20].

²R is the positive root of K and is well de ned because K is a sym m etric and positive de nite m atrix.

- 2) The characters of the extended theory are closed under $_0$ (2).
- 3) The extended theory is given by the request that its conform alblocks correspond to primary elds with conform aldimensions which dier by a sem i-integer from those of the lowest weight states.

The extended prim ary elds of the $u^d(1)_K^m$ theory are obtained by imposing that the weights are in the lattice $Z_K = \frac{Z^m}{K Z^m}$ and the corresponding vertex operators are:

where $L_0 = \frac{1}{2} n^T$ (K) 1 n [19] is the eigenvalue of the L_0 m ode of the V irasoro algebra and $J = t^T$ (K) 1 n is the charge relative to n, the vector denning the weight of the descendent state in the H ilbert space H of the primary eld with highest weight . Explicitly eq.(2.10) becomes:

where the non-analytic phase was introduced in β and it is necessary to de neproperly the transport of charges. The extended theory $u^d(1)_K^m$ has 2pm+1 independent primary states as it is requested by the topological order and the characters are closed under 0 (2).

3. The sym m etries of the ECFTs

In this section we brie y analyze the sym m etry properties of the dierent ECFTs proposed to describe the Jain llings.

3.1 The $\mathfrak{G}^{1}(1)$ sum \mathfrak{g}_{1} models

The factorization of the multi-components $\psi^1(1)_K$ m odel in a charged and a neutral sector allows us to evidence an $\psi^1(1)_{m (2pm+1)}$ swim $\psi^1(1)_{m (2pm+1)}$ extended symmetry³ while the neutral one has a full swim $\psi^1(1)_{m (2pm+1)}$ extended symmetry³ while the neutral one has a full swim $\psi^1(1)_{m (2pm+1)}$ extended symmetry³ while the neutral one has a full swime $\psi^1(1)_{m (2pm+1)}$ symmetry. Moreover the two sectors are not independent but are coupled by a discrete group so implying that a superselection rule, called m-ality rule, must be taken into account in order to build the physical excitations of the model (i.e. a holon-spinon topological coupling).

The factorization into a charged and neutral sector is explicitly obtained by diagonalizing the K m atrix. The orthogonalm atrix O_m , which does it, has been explicitly given in [21], and the new elds Q $^0(z) = O_m Q$ (z) can be identified with those of ref.[1]. We define the charged boson X (z) $\frac{m}{1-2} \frac{Q_1^0(z)}{m}$ and the neutral vector (z) with components Q $^0_1(z)$

Thus the charged component of $\mathfrak{G}(1)_{K}^{m}$ is just the $\mathfrak{G}(1)_{m (2pm+1)}$ extended theory. By using the neutral elds one gets the following currents:

satisfying the $su(m)_1$ algebra⁴. Let us recall that starting from j, j = 1; :; mthe basic weight b_0 of the a nealgebra \sin (m), one can obtain all the other fundam ental weights $b_j = b_0$, j = 1; m = 1. For a general weight $b = b_{i=0}^{p} n_i b_i$ one can de ne the m-ality charge as $l=\sum_{i=1}^{p} \ln_i m$ od (m). It is a good quantum number useful to classify the excitations. As pointed out above, the theory ${\vec q}(1)_K^{\ m}$ is not a simple tensor product of the charged and the neutral component. This is well evidenced by the explicit expression of the $\psi^{l}(1)_{K}^{m}$ characters given in eq.(2:11); which were introduced in [21] for the m = 3 case and in [3] for generic m as:

with b = 0;::;2pm and where $\frac{\sin (m)_1}{1}$ () are the characters of the $\sin (m)_1$ representations with integrable highest weight (h.w.) $b_1 2 P_+^1 (P_+^1)$ being the set of all the dominant weights of $\sin (m)_1$) and conform alweight $h_1 = \frac{1(m-1)}{2m}$ (i.e. a spinon with m-ality charge equal to 1). Above $K_c^{(m-(2pm+1))}$ (w j) are the characters of the extended $u^4(1)_{m-(2m-p+1)}$ theory and are explicitly given in Appendix B⁵.

Furtherm ore the form of the K matrix allows to consider various discrete symmetries. Here we focus our attention on its sym metries under the permutations of the Landau levels. They can be analyzed in the diagonal basis in which the su (m), sym m etry is evidenced. We distinguish two kinds of sym metries, one acting as an outer automorphism of the su (m) lattice and the other one associated to inner autom orphisms of the algebra (i.e. the W eyl group). Inner autom orphism spreserve the commutation relations of the algebra (although the action on the algebra generators is nontrivial). We let D (g) and D (g) stand for the sym m etry group of the su (m) and su (m) D inkin diagram s respectively. A sit is well known the group of the outer autom orphism $s \circ f \circ j \circ O(s) = O(s) = O(s)$; is the dual of the center of the group of g, i.e. B (G) [22] which in the case of su (m) is Z_m . Moreover it acts on the changing the m-ality of a fundam ental representation: g(l) = l + 1. The B (G) group action on the algebra generators is trivial. We stress that outer autom orphisms also must preserve the commutation relations of the algebra, so that the characters will be still given in terms of the \sin (m)₁ ones. The extended $i^{d}(1)_{K}^{m}$ theory satis es the important property that under the action of 0 (g) all its extended characters are xed points, that is they satisfy a gluing condition between the charged and the neutral sector which couples a Z_m subgroup of the $u^d(1)$ to the m-ality charge in an invariant way. Thus the P-P, periodic-periodic sector of the TM will be invariant with respect to this coupled group (i.e. the permutation group acts as an inner autom orphism for the full theory). This behavior is di erent from that of the paired states [13], where the Halperin theory does not coincide with the P-P untwisted sector of its Z_m -orbifold. The m -reduction procedure induces naturally this sym m etry and gives the correct coupling between the charged and the neutral sector [1].

Furtherm ore quotienting by a discrete group that is not in the center it breaks all the a ne representations; therefore the partition function of the TM in the twisted sector cannot be described in terms of the a ne characters (i.e. the a ne sym m etry is broken in these sectors to the W $_{\rm m}$ one).

3.2 The W $_{m}$ M in im alm odel

The ECFT description of a QHF at the plateau is justiled by the incompressibility of the Laughlin uid. The dynamical symmetry of this uid in the disk geometry is the area-preserving dileomorphisms of the plane which imply the W $_{1+1}$ algebra. This is the unique

In [3] a param etrization which evidences the independence of the neutral component from the uxpwas chosen. In this paper we give the same param etrization for the P-P and P-A sector. centrally extended quantum analogue of the classical area preserving dieom orphisms algebra \mathbf{w}_1 on the circle.

The in nite generators W $_{m}^{n+1}$ of W $_{l+1}$ of conform alspin (n + 1) are characterized by a mode index m 2 Z and satisfy the algebra:

where the structure constants q and d are polynom ials of their arguments, c is the central charge, and dots denote a nite number of similar terms involving the operators $W_{m+m}^{n+n^0}$ 21 [23, 25].

Such an algebra contains an Abelian $u^{1}(1)$ current for n=0 and a V irasoro algebra for n=1 with central charge c. Their zero m odes eigenvalues are identied as the charge and angular-m omentum of the edge excitations of the QHF.

In the literature [23, 24] the unitary representations of W $_{1+1}$ have integer central charge and can be of two types: generic or degenerate.

The generic representations, with central charge c=m, are equivalent to those of the multi-components bosons $d(1)_K^m$, where the K matrices dene the lattice $Z_K = \frac{Z^m}{K Z^m}$ whose weights = (1; ::; m) satisfy the conditions $a > b \ge Z$, 8a $6 > b \ge 1; ::; m$.

The degenerate representations, with central charge c=m, are contained into those of the multi-components and satisfy the conditions a=b 2 Z.

In particular the full degenerate representations are those whose weights all de ne degenerate representations. These conditions select uniquely the lattices Z_K as the ones generated by the K matrices of the Jain series. The theory with full degenerate representation only is also called W $_{1+1}$ m in im almodel [8].

The W $_{1+1}$ m odels are isom orphic to $v^d(1)$ W $_m$ theory, where W $_m$ is the algebra with central charge c=(m-1), defined by the q! 1 \lim it of the Zam olodchikov-Fateev-Lukyanov algebra with c=(m-1) 1 $\frac{n(n+1)}{q(q+1)}$ [26]. In this \lim it an in nity of degenerate representations appears which are in one-to-one relation to the degenerate representations of the above m in im almodels.

The W $_{\rm m}$ algebra can be also de ned by a coset construction of the kind W ($\hat{g}=g;k$) based on the C asim ir operators of a nite algebra g (see [23] and [14] for details). The relevant coset for Jain series is W (su ($_{\rm m}$) $_{\rm k}$ =su ($_{\rm m}$); k = 1), which involves the nite algebra su ($_{\rm m}$), thus the central charge of the W $_{\rm m}$ has the same value of the full theory su ($_{\rm m}$) $_{\rm l}$, i.e. $c_{\rm W} = c_{\rm su}$ ($_{\rm m}$) $_{\rm l} = m$ 1. The h.w. representations of W $_{\rm m}$ are dened by decomposing those of su ($_{\rm m}$) in terms of su ($_{\rm m}$) ones. The characters of the coset W $_{\rm m}$ are thus the branching functions constructed by decomposing the characters of the a nealgebra in terms of those of the nite one:

where b_1 is the set of the weights in the h.w. representation of \hat{su} (m) relative to b_1 , the integrable h.w., is the nite part of the a new eight b.

The above su (m) characters are explicitly given by:

The equivalence \sin (m) $_1 = \sin$ (m) W $_m$ gives \sin (m) $_1$ as a RCFT extension of the algebra W $_m$. Eq.(3:12) shows that any integrable h.w. b_1 representation of \sin (m) $_1$ is given by collecting in nite representations of W $_m$, such that b_1 P b_1 , each one with multiplicity d_{\sin} ().

N evertheless this extension is not a m in im alone which should be given by collecting in nite primary elds of W $_{\rm m}$, everyone with multiplicity one.

The main point for this minimal W $_{\rm m}$ theory is that it is not a RCFT, that is the characters relative to the extended primary elds are not closed under the modular transformation S. We propose a theory in which both symmetries can be taken into account, being realized in dierent sectors of the full TM . It is based on another interesting realization of the W $_{\rm m}$ algebra given in [9] by using twisted bosons. The representation theory for this realization was studied in [10]. This realization is the relevant one for the m-reduction and introduces new topological sectors to the description of the Jain llings. In order to obtain the twisted characters of the W $_{\rm m}$ algebra it is necessary to add the special vector $\frac{1}{m} = \frac{1}{m} \int_{i=1}^{m} \frac{1}{i}$; with $\frac{2}{m} = \frac{m (m^2 - 1)}{12}$; to all the representations. Nevertheless these are not representations of the algebra $\frac{1}{m}$, so this symmetry is explicitly broken in this vacuum. This vector changes the conformal dimensions of the vacuum state according to:

M oreover not only the $\psi^1(1)$ sum $)_1$ is contained in our RCFT and it coincides with the P-P sector of the TM but also an extended W m minimal model is realized in the P-A sector, as it will be shown explicitly in the following sections.

4. The m -reduction on the plane

In this section we brie y review the m-reduction procedure on the plane as a starting point for its generalization to the torus which is the main content of this paper. Our approach is meant to describe all the plateaux with odd denominator starting from the Laughlin lling = 1=(2pm+1), which is described by a CFT with c=1, in terms of a scalar chiral eld compactied on a circle with radius $R^2=1=2pm+1$ (or its dual $R^2=4=(2pm+1)$). Then the u(1) current is given by $J(z)=i\theta_zQ(z)$, where Q(z) is the compactied Fubinield with the standard mode expansion:

The primary elds are expressed in terms of the vertex operators U s (z) = $:e^{i sQ}$ (z): with s=1; ::; 2pm+1 and conformal dimension $h=\frac{s^2}{2(2pm+1)}$. The $h=pm+\frac{1}{2}$ eld (s+2pm+1) describes the electron with electric charge $q_e=1$ in units of the electron charge e and magnetic one e0 e1 in unit of e1 e2, while to other 2pm primary elds correspond to anyons with lowest charges e1 e2 e3 and e4 e6 e7. The dynamical symmetry is given by the W e1+1 algebra with e1, whose generators are simply given by a power of the current J (z).

We start with the set of elds in the above CFT (mother theory). Using the m-reduction procedure, which consists in considering the subalgebra generated only by the modes in eq.(4.1), which are multiple of an integer m, we get the image of the twisted sector of a c=m orbifold CFT (daughter theory, i.e. the TM) which describes the Lowest Landau Level (LLL) dynamics of the new lling =m=(2pm+1).

We perform a \double "-reduction which consists in applying this technique into two steps.

1) The m -reduction is applied to the Fubini eld Q (z): This induces twisted boundary conditions on the currents. It is useful to de ne the invariant scalar eld:

naturally satisfy twisted boundary conditions so that the J (z) current of the m other theory decomposes into a charged current given by J (z) = $i \ell_z X$ (z) and m 1 neutralones ℓ_z ^j (z) [1].

2) The m -reduction applied on the vertex operators $U^{\circ}(z)$ of the m other theory also induces twisted boundary conditions on the vertex operators of the daughter CFT. The discrete group used in this case is just the m-ality group.

The vertex operator in the mother theory can be factorized into a vertex that depends only on the invariant eld:

The set of primary elds generated by their product can be given in terms of the fundamental representations $_1$ of the su(m) Lie algebra. By looking at their conformal dimension we are led to identify them as \sin (m) \sin spinons given in a m-ality diagonal basis. Indeed we can dene the full set of elds:

Higher spin currents in W $_{1+1}$ algebra are given by the in nite generators in the enveloping algebra of the u(1) charged sector and by the W $_{\rm m}$ currents obtained from the neutral sector. The explicit form for m = 4 was given in [9]. We report here only the rst element beyond the spin two of the series which in our basis is expressed as:

All the elds given in eq.(4.6) are invariant under the Z_m group twisting the j (z) elds. The remaining primary elds in the neutral sector which are not invariant are given by:

with g=2; ...; m. This decomposition breaks explicitly the nite su (m) symmetry of the multi-components model. As we will show in the next section the residual symmetry of the twist invariant sector is just the W $_{1+1}$ one.

5. The m -reduction on the torus

In the following we consider the case of prime m only, the more general case will be the subject of a forthcoming paper.

5.1 The TM for primem > 2

The present discussion is valid for any prime m > 2 while in $\sec.(5.2)$ it is analyzed the special m = 2 case. This is not only to clarify the construction in the simplest case but also for the peculiarity of the m = 2 case in which the m-reduction furnishes special results.

The extended TM theory is the realization on the torus topology of that proposed in [1] to describe the plateaux for the Jain series $=\frac{m}{2pm+1}$ on the plane. We can obtain the full theory by applying the m-reduction on the torus and by implementing the modular invariance condition. The mother theory describes the Laughlin lling $=\frac{1}{2m\;p+1}$ corresponding to the $t^d(1)_{2m\;p+1}$ symmetry (see appendix B for details).

By applying the m-reduction on the elds in the mother theory we obtain the twisted sector of the TM immediately. In this procedure it is necessary to take into account two points:

- 1) The $\psi^{0}(1)_{2pm+1}$ m other theory is not an ordinary RCFT but a theory which is invariant only under $_{0}$ (2).
- 2) The TM is a ferm ionic theory so it must be of the same type of the mother theory (i.e. the conform ald in ensions of its primary elds are dened only mod (1=2)).

The extended primary elds in the twisted sector have conformal dimensions⁶:

The corresponding characters can be easily given in terms of those of the mother theory:

The closure under $_0$ (2) of the TM allows us to obtain part of the elds in the untwisted sector. We get 2pm + 1 new primary elds for this sector with conformal dimensions:

Their peculiarity is that the neutral part of the vertex operator is the identity. It gives a contribution only by means of its descendents which are just the W $_{\rm m}$ currents.

Although these elds are su cient to satisfy the $_0$ (2) covariance they are not the complete set of elds in the TM . As for the paired states case analyzed in [12], the periodic-periodic sector of the theory can be obtained by exploring the contents of the orbifold theory $\mathfrak{A}^{\!1}(1)_K^{}=\!\!Z_m$, which is the daughter CFT we obtained by m-reduction. Therefore in the next section we study this orbifold in detail and extract the information we need to complete the model.

5.1.1 The orbifold $\mathfrak{G}(1)_{K}^{m} = \mathbb{Z}_{m}$

Starting with the $v^d(1)_K^m$ theory, which is invariant under the discrete sym metries analyzed in $\sec.(3.1)$, we perform an orbifold construction with respect to the discrete Z_m group. It should be noticed that the $v^d(1)_K^m$ is a $v^d(2)$ -RCFT so the generated orbifold will be of the same kind.

All the primary elds of the extended $\mathfrak{A}^l(1)_K^{m}$ theory correspond to diagonal weights b=bt. De ning g as the generator of the Z_m group, permuting the levels, we see that all these elds are invariant under its action and are xed points with respect to this symmetry. The stabilizer S_b for a general eld corresponding to the weight b is just Z_m , i.e. $S_b=g^i:i=0$;::m1 and it has melements.

The untwisted P-A sector of the orbifold is obtained introducing a new primary eld for any element $2 S_b$ and any eld in the mother theory. The generic conformal eld is parametrized by the index b and an element $2 S_b$ and its conformal dimension given by:

The twisted A-P sector of the $\psi^{\dagger}(1)_{K}^{m}$ =Z_m model can be obtained by the request of covariance under $_{0}$ (2). Indeed from $_{(s;(1,y^{i}))}$ (w j) we can generate the characters of the

tw isted sector by m eans of the transform ation S . The closure under T 2 im plies that also the characters $_{(s;(g^i;g^j))}$ (w j) = K $_s^{(2pm+1)}$ (w j $_m^{+2j}$); for j = 1;::;m 1; belong to this sector 7 .

The full twisted sector of this $u^d(1)_K^m = Z_m$ orbifold is given then by the characters

As we have seen the P-P sector of this orbifold coincides with the $\mathfrak{A}^1(1)_K^{m}$ itself. The remaining part of the untwisted sector coincides with the untwisted sector of the theory built by the m-reduction procedure, when we take into account the m-1 degeneracy. The twisted A-P sector is given by characters of eq.(5.7). Looking at eq. (5.7) and eq.(5.2), we not the relationship between these characters and the characters obtained by m-reduction. Indeed as a consequence of the invertibility of the equality (5.2) for any xed j, the characters in eqs.(5.7) and (5.2) simply dene two different basis of the same twisted sector.

Thus we can conclude that the m-reduction procedure generates the non periodic part of the untwisted sector (P-A) and the twisted sector (A-P) of the Z_m -orbifold of $u^d(1)_K^m$, by considering that any extended primary eld has degeneracy m 1.

5.1.2 C harged and neutral components of the characters of the TM

In ref.[1] the TM was given in terms of charged and neutral components on the plane. There it was shown that the charged component coincides with the compactified theory with $R^2 = (2mp+1) = m = 1 = 1$. In the torus topology this separation can be given by the decomposition of the characters in terms of those of the charged and neutral ones. This decomposition also tells us the way in which the primary elds of the charged and neutral components must combine in order to generate the extended primary elds of the full TM theory.

For the P-P sector the separation is given in eq.(3.7), while for the P-A sector of the TM we obtain

To clarify the relationship between the TM and the W $_{\rm m}$ m in im almodel we point out that the twist group acts only on the su (m), while the W $_{\rm m}$ algebra is una ected under it. Therefore we can write $(su (m)_1 = Z_m = su (m) = Z_m W_m)$ and the e ect of the twist is only in the reduction of the degeneracy of the W $_{\rm m}$ representations as it happens in the m in im al m odels.

Nevertheless, while the characters of \dot{su} (m) transform covariantly under the modular group, the W m ones do not close under this group. That can be easily understood if one notes that the SL (2; Z) also acts on the representations of the nite su (m) algebra.

Therefore one cannot have a covariance of the W $_{\rm m}$ characters without a covariance of the degenerate vacuum states of dimension d($_{\rm a}$ +). To do that we relate a nite subgroup of the m odular group to the su (m) automorphism s.

We must observe that the neutral part does not depend on p, that is on the ux attached to the charged component. That can be seen by showing that the characters of the neutral part, de ned in the above formula, can be written in terms of the ones with p=0 as: $N_{(a;(s;f))}^{(p)}()=N_{(a;f^0)}^{(0)}()$; where $f^0=f$ 2as mod (m).

Looking at eqs.(3.7),(5.8) and (5.10) and taking into account the parametrization change, we conclude that the charged component is the same in any sector of the TM and it coincides with the extended theory $\mathfrak{A}^{1}(1)_{m}$ (2m p+1).

Let us notice that the characters given here are written in a basis which is explicitly invariant under the permutation of the Landau levels. In this basis we do not see the excitations content of the theory. We could introduce another basis in which the m-ality is diagonal, evidencing the primary elds with conformal dimensions $h_{(l,b)} = \frac{((2pm+1)l+m b)^2}{2m (2pm+1)} + \frac{l(m-l)}{m}$ which are the charged excitations corresponding to the l-electrons (b=0) and the l-anions (b \(\frac{1}{2} \) 0) which are xed under the twist group. Moreover in the twisted sector there are also neutral excitations with conformal dimensions $h = \frac{m^2-1}{24m}$ (i.e. twist operators) which are a characteristics of the TM and it was not present in the models given in [3, 2]. They were independently introduced in [1] and [16] giving rise to a clustering phenomenon in the correlator of Nelectrons (see [1] for details). The role of the twisted sector has been

recently clari ed for the paired states in [29]. In that description the neutral current was shown to originate from a point-like interaction between the layers, which can be attributed to the presence of a localized impurity. We will give a similar analysis in a forthcoming paper.

5.2 The TM form = 2

Form = 2 the TM is built following the same construction made in 5.1, for the case m > 2 and prime.

The content of the tw isted sector is given by the m -reduction procedure applied to the m other theory with symmetry $\psi^d(1)_{(4p+1)}$. The extended primary elds have the conformal dimensions

Eqs.(5:17), (5:18) and (5:16) show that the charged component of the TM form = 2 is the extended theory $\vartheta^l(1)_{2(4p+1)}$ which is an ordinary RCFT, closed under the full modular group. It justifies the particular modular behavior of the characters of the P-A sector which is closed under the modular transformation T. It is due to the bosonic nature of the 2-electron. It is worth noticing that even in such a case the full TM theory remains a $_0$ (2) RCFT.

Finally we notice that the P-A sector is bigger than the theory built by the action of the generator of the discrete sym m etry group Z_2 . This can be seen by writing the results of section 5.1 for m = 2. The comparison of eq.(5:8), evaluated at m = 2; i.e.

This anom alous behavior can be understood by noticing that the c=1 Z $_2$ -orbifold has an extra sym m etry due to a h=1 current (c). Its radius corresponds to the multicritical point in which orbifold and Gaussian theory coincide. The Gaussian formulation can be obtained by means of a non-linear transform ation as it was given in ref.[28].

The eld content of the neutral sector can be easily deduced by the well know spectrum of the c= 1 Z₂-orbifold at the radius R² = 4. They are: I (h = 0), @ (h = 1), (h = $\frac{1}{4}$), (h = $\frac{1}{4}$), i (h = $\frac{1}{16}$), i (h = $\frac{9}{16}$), and are two kinds of $\frac{1}{4}$ (2) spinons. They can be im mediately related to the standard basis as follows: = (1) + (2); = (1) (2).

Dierently from the paired states case the elds and are not independent so they do not realize two independent CFTs as it happens in that case. They instead realize Gentile paraferm ions. As it is well known, a Gentile paraferm ion gives a $\frac{m-1}{m}$ contribution to the central charge. We need to have mof such a paraferm ions to build a unitary CFT with integer charge c = m - 1. As a consequence their fusion rules are:

Due to the lack of zero modes in the twisted current the pseudospin $J_3^{su\;(2)}=m=(N^{(1)}-N^{(2)})=2$ is zero (or 1/2) so that the ground state has an equal number of the states for m=0 or $N^{(1)}=N^{(2)}+1$ for m=1=2. While increases the (m-ality) l! l+1, acts only on the third component as m! m+1=2.

7. The sym m etries of the TM sectors

In this section we will discuss the relationship between the TM and the $\dot{\psi}^{d}(1)_{m (2pm+1)}$ W m in im almodels in detail.

Thus the $^{\circ}_{0}$; $^{\circ}_{1}$ h.w. representations of su (2) $_{1}$ are built respectively by the even and odd degenerate representations of W $_{2}$.

Now we will derive the identication of the neutral component of the P-A untwisted sector of our TM and show that it is related to the W $_{\rm m}$ m inimal models.

There is just one extended primary eld in the neutral component of the P-A sector of our TM and it can be written in terms of the W_2 characters as:

This extra parity can be seen as the residual symmetry of the nite su (2) algebra due to cocycles. As a consequence the P-A sector of the TM contains only degenerate representations of W $_2$. Therefore we can consider it as alm inimal sector" of the full theory. Nevertheless in this sector the extended symmetry is given by u (1) W $_2$ Z $_2$. We could take the Z $_2$ even superposition of W $_2$ degenerate characters as it was done in [3] but we can see that only the odd superposition given by the characters $\sim_{(l,b)}$ of the TM belong to a RCFT. It is necessary to give a well dened S transformation for the characters of the P-A sector which produces the twisted A-P sector of the TM. In this sector the W $_2$ characters are non minimal generic representations.

For generic m the extended characters in the P-A sector contains only W $_{\rm m}$ representations with $_{\rm a}$ $_{\rm b}$ 2 m Z with the same structure of the m = 2 case. Thus only

the weights in the $^{\circ}_{0}$ representation contribute and furtherm ore, by the isomorphism $\sin (m)_{1} = \sin (m)$ W $_{m}$, we have that in any $\sin (m)$ multiplet just one is selected out. Instead in the A-P sector the dierences $_{a}$ $_{b}$ \geq Z are not integer in general.

8. Conclusions

In this paper, by using the m-reduction procedure, we constructed the twisted model (TM) for the Jain series at the lling $=\frac{m}{2pm+1}$, generalizing to the torus topology a recent construction for the plane[1]. The extended chiral prim ary elds were derived both for the twisted and untwisted sectors together with their corresponding characters. Also their factorization in terms of charged and neutral components was given. By constructing the complete diagonal partition function, which turns out to be invariant under $_0$ (2) it has been shown that the multi-components theory coincides with its P-P sector content. A detailed relation between the TM, the multi-component and the W $_m$ minimal model has been worked out throughout the paper. For m=2 it has been explicitly shown that the P-A sector contains only degenerate representations of W $_2$, so resulting into a \minimal sector of the full theory. Finally it has been shown that the presence of the A-P sector assures the closure of the TM partition function under modular transformations. The special m=2 case has been also analyzed. In the appendices it has been reported on the properties of the $_0$ (2) group together with the modular transformations of the $u^{(1)}$ and TM characters.

Appendix B

The ECFT of the Laughlin lling

Here we want to construct the ECFT that describes the Laughlin lling $=\frac{1}{q}$ with q=2pm+1 odd.

This ECFT has to be a free bosonic theory com pacti ed on a circle with radius $R^2 = q$, the topological order, that is the degeneracy of the quantum Hall ground state on the torus, has to coincide with the number of the extended primary elds of the ECFT [20]. Furtherm ore because the ground state is described by electrons (ferm ions), the behaviour required under modular transform ations is not the closure under the entire modular group $SL(2;Z)=Z_2$, but only under the subgroup O(2).

The \sm aller" RCFT of a free boson with $R^2 = q$ (here it means $R^2 = \frac{2q}{2}$ o by duality $R^2 = \frac{4}{q}$) with qodd, is a $t^d(1)_k$ of level k = 2q. The extended primary elds are dened by the vertex operator:

There are 4q extended primary elds and the correspondent characters are closed under the entire modular group, SL (2; Z)=Z2. Thus the ordinary RCFT $\psi^d(1)_{2q}$ does not satisfy the requests of an ECFT for the Laughlin lling = 1=q.

The ECFT which does is not an ordinary RCFT. It can be built starting from $\mathfrak{G}(1)_{2q}$; by de ning in a di erent way the extended prim ary elds. The chiral extended algebra is de ned by assembling in any extended prim ary eld all the prim ary elds of $\mathfrak{G}(1)_{2q}$; whose conform ald in ensions dier by half integer. We de ne this extended theory as $\mathfrak{G}(1)_q$. Its extended prim ary elds are de ned by the vertex operators 12

Finally we notice that the extended theory $u^{l}(1)_{q}$ coincides with the $_{0}(2)$ -invariant part of the ordinary RCFT $u^{l}(1)_{2q}$. This is a consequence of the relation among the characters of the two theories:
