# Jain states on a tonus：an unifying description

A bstract：$W$ e analyze the $m$ odular properties of the e ective CFT description for Jain plateaux，proposed in［1］，corresponding to the llings $=\frac{\mathrm{m}}{2 \mathrm{pm}+1}$ ． W e construct its charac－ ters for the tw isted and the untw isted sector and the diagonal partition function．$W$ e show that the degrees of freedom entering the partition function go to com plete a $Z_{m}$－orbifold construction of the RCFT $\mathcal{U}^{d}(1)$ su $(m)_{1}$ proposed for the Jain states 目，蔡］．The resulting extended algebra of the chiral prim ary elds can be also viewed as a RCFT extension of the $\mathcal{U}^{d}(1) W_{m} \mathrm{~m}$ in m alm odels 目］．For $m=2$ we prove that our $m$ odel，the $T M$ ，gives the RCFT closure of the extended $m$ in $\dot{m}$ alm odels $̛(1) \quad W_{2}$ ．

## 1．Introduction

H istorically the m otivations for the use of the E ective C onform alF ield $T$ heory（ECFT） in describing a Q uantum $H$ allF luid（Q H F ）at the plateau 4 ，5］go back to the observation that the ground state wave function（Laughlin states）for the lling $=1=(2 p+1)$［G］ can be w ritten as correlators of vertex operators describing the anyon states（charged states），which were identi ed as prim ary states of a two dim ensional chiral CFT with central charge $c=1$［］．The ECFT description of C Q HF at the plateau accounts for the incom pressibility of the Laughlin uid．The dynam ical symm etry of this uid in the disk geom etry is the area－preserving di eom orphism s of the plane which im ply the W $1+1$ algebra．This is the unique centrally extended quantum analogue of the classical area preserving di eom orphism s algebra $\mathrm{w}_{1}$ on the circle．For general lling it is known that it is necessary to introduce neutral elds in order to describe the area－preserving edge deform ations of the incom pressible uid．In this context two classes of CFTs have been proposed for Jain plateaux：the m ulti－com ponents theory［⿴囗⿱一兀$]$ ，characterized by the extended algebra $\mathcal{U}(1)$ su $(m)_{1}$ and the $W_{1+1} \mathrm{~m}$ inim alm odels 8$]$ both $w$ ith central charge $c=m$ ．

In spite of having the sam e spectrum of edge excitations, they $m$ anifest di erences in the degeneracy of the states and in the quantum statistics.

An altemative and simple construction of the hierarchical m odel based upon the so called $m$ reduction procedure was given in [1] , where a $\mathrm{c}=\mathrm{m}$ (daughter) CFT was obtained from a $c=1$ ( $m$ other) one. The daughter theory preserves the $W_{1+1}$ sym $m$ etry of the $m$ other theory. In fact it is well know $n$ that for any positive integer $m$, the $W_{1+1}$ algebra w ith central charge $c$ is isom orphic to its subalgebra consisting of elem ents of degrees divisible by $m$ and which appear with central charge $m \mathrm{c}$ [9, 10], so im plying the incom pressibility of the Q H F for any given plateau.
$T$ his procedure w as developed in 11] and em ployed forboth the Jain llings $=\frac{\mathrm{m}}{2 \mathrm{pm}+1}$ in [1] and the non standard ones $=\frac{m}{p m+2}$ in [12] where it was shown how naturally it induces tw ists on the boundary, given by a $Z_{m}$ group generated by the phases ${ }^{j}=e^{\frac{2 \text { ij }}{m}}$ , $j=1 ;::: ; m$. As a consequence the chiral prim ary elds naturally appear as com posite operators w ith a charged and a neutralcom ponent. It hasbeen proved that their correlators reproduce the ground state wave function for the Jain as well as for the paired states, so generalizing the Laughlin type wave function on the plane [1, 12]. O nly one ul(1) charged current survives to the discrete tw ist group while the role of the neutral degrees of freedom is to cancel out the $m$ root singularity present in the correlators of the charged operators, so restoring locality.

In this paper we present a detailed analysis of such a m odel, the T w isted M odel (T M ), for the Jain states on a torus (genus $g=1 \mathrm{R}$ iem ann surface), so extending the previous description given on the plane 17]. For the paired states this analysis was given in [13].

W e construct the characters associated to the extended chiral algebra and show that they provide a nite dim ensionalrepresentation of the 0 (2) subgroup of them odular group $S L(2 ; Z)=Z_{2}$. Finally we exhibit the diagonal partition function which is invariant under such a subgroup. The resulting theory is the $Z_{m}$-orbifold of the $R$ ational CFT (RCFT) describing the m ulti-com ponents theory. Furtherm ore the extended algebra of the TM can be also view ed as a particular RCFT extension of the $W_{1+1} \mathrm{~m}$ inim alm odels ${ }^{1}$ [14].

Indeed their extensions are the constituents of the periodic-periodic ( P P ) and periodicantiperiodic ( $\mathrm{P}-\mathrm{A}$ ) sector of this onbifold construction respectively. In addition to them the tw isted ( $\mathrm{A}-\mathrm{P}$ ) sector, is exactly what is needed in order to obtain the closure under 0 (2). W e should also com $m$ ent on the presence of quasihole states in the tw isted sector and chustering properties [1] 16] as it happens in the paired states.

A ll that em phasizes the key role of the m reduction procedure in producing a RCFT which realizes a consistent $W_{1+1}$ extension of the classical area-preserving di eom orphism s of the plane.

In sec．目 we review the $K \mathrm{~m}$ atrix construction 目］of the $m$ ulti－com ponents theory of the Jain llings and brie y sum $m$ arize the properties of the ground state $w$ ave functions on the plane of a system of interacting layers which have been rst analyzed in［17］．

In sec． 3 we review the sym m etries of the ECFT which are known in the literature： the RCFT w ith sym $m$ etry $\mathcal{U}^{d}(1) \quad \operatorname{su}(m)_{1}$ and the $W_{1+1} \mathrm{~m}$ inim alm odels［8］．$W$ e also give the decom position of the $\mathcal{U}^{( }(1)$ sul $(m)_{1}$ characters in term $s$ of those of the $W_{1+1} m$ inim al models $8,14,15]$ ．Finally we indicate the $Z_{m}$ discrete group $w$ ith respect to which the orbiffld construction is m ade．

In sec． 4 webrie $y$ sum $m$ arize them－reduction construction on theplane（genusg＝0）， which has been used in［1］to construct the TM for the Jain series at lling $=\frac{\mathrm{m}}{2 \mathrm{pm}+1}$ ．

In sec．固 we generalize it to the torus topology（genus $g=1$ ）and derive the extended chiralprim ary elds both for the tw isted and the untw isted sectors and the corresponding characters．Then a com parison of the TM w ith the multi－com ponents theory 园］is given and the features of the $Z_{m}$－orbiffld construction show $n$ ．The factorization of the characters in term $s$ of charged and neutral com ponents is derived．Finally the specialm $=2$ case is also analyzed．

In sec． 6 we construct the com plete diagonal partition function of the TM．
In sec． 7 we show that the TM provides a RCFT closure of the extended minim al $m$ odels $\mathcal{U}_{(1)} \mathrm{W}_{\mathrm{m}} \quad \mathrm{Z}_{2}$ ．In fact we prove that the $\mathrm{P}-\mathrm{A}$ sector of the TM gives a realization of the chiral algebra containing only degenerate $\mathrm{W}_{1+1}$ representations．

Finally in sec． 8 we give conclusions and com $m$ ents．
In App．A we describe the properties of the 0 （2）subgroup of the m odular group．
In App．B we describe the extended odd RCFT $\mathcal{U}^{( }(1)_{q}$ for the Laughlin lling，$=\frac{1}{q}$ where $q$ is odd，which we use asm other theory for the $m$ reduction，pointing out the reason for requesting the closure under 0 （2）only．

In A pp．C we give the transform ations of the characters of the TM under the elem ents of $0(2)$ ，show ing that they provide a nite representation for it．$W$ e also prove that the TM diagonalpartition function is invariant under its action．

## 2．$K-m$ atrix construction of the $m u l t i-c o m$ ponents theory

The CFT for a m－levels QHF at lling $=\frac{\mathrm{m}}{2 \mathrm{pm}+1} \mathrm{was}$ given in 0 ，18，19］introducing the sym $m$ etric and positive $K \mathrm{~m}$ atrix：

$T$ he entries $K_{(i ; j)}$ ；depending on $m$ and $p$ ，de ne the braiding factors betw een electrons in the $i$ and $j$ level．In this sim pli ed picture the levels are considered independent and fiully equivalent and we w ill refer to them also as layers．The wave function on the plane for such a system can be given in term s of K as：

This is a special class of $m$ ore general trial functions for the ground state of a multilayer system. For the sim plest case of only two layers (or levels) they can be codi ed in the so called ( $m, n, k$ ) states introduced by $H$ alperin [17]. T he integers in the bracket are in correspondence $w$ th the entries of the $K m$ atrix, i.e. $m=K_{(1 ; 1)} ; n=K_{(2 ; 2)}$ and $k=K_{(1 ; 2)}$. Som e values of these integers give interesting $m$ odels for specialplateaux. T he ( $p+2, p+2, p$ ) generalize the well studied $(3,3,1)$ state and it w as analyzed recently in the $m$-reduction approach in [13]. A nother interesting case is the ( $1,1,1$ ) forwhich theoretical studies predict the existence of a Josephson like e ect. N evertheless this state does not satisfy the non-degeneracy of the $K \mathrm{~m}$ atrix so it does not enter the theories we are studying now.

The CFT of the system $w$ ith a general $\mathrm{K} m$ atrix is realized by $m$ free bosons $w$ th an extended chiral algebra. T hese elds satisfy the com pacti cation conditions given by fa:

The com pacti cation $m$ atrix 2.3) for diagonalh $=h t$, where $t$ is the charge vector $w h i c h$ satis es the condition $t^{T}(K)^{1} t=$ and coincides $w$ ith $t^{T}=(1 ;: ; 1)$, de nes the follow ing com pacti cation radius for the $Q{ }^{(i)}$ bosons:

The extended RCFT, the m ulti-com ponents $\left.\mathcal{U}^{(1)}\right)_{K}^{m}$ theory, can be constructed by $m$ eans of the follow ing physical conditions 20]:

1) T he topological order [19] given by $\operatorname{det}(K)$ is an odd num ber and coincides $w$ ith the number of prim ary elds of the extended algebra 20].

[^2]2) The characters of the extended theory are closed under 0 (2).
3) The extended theory is given by the request that its conform alblocks correspond to prim ary elds w ith conform al dim ensions whidh di er by a sem i-integer from those of the low est w eight states.

The extended prim ary elds of the $\left.\mathrm{u}^{(1)}\right)_{\mathrm{K}}{ }^{m}$ theory are obtained by im posing that the weights are in the lattice $\mathrm{Z}_{\mathrm{K}}=\frac{\mathrm{Z}^{\mathrm{m}}}{\mathrm{K} \mathrm{Z}^{\mathrm{m}}}$ and the corresponding vertex operators are:

 states as it is requested by the topological order and the characters are closed under 0 (2).

## 3. The sym m etries of the ECFT s

In this section we brie y analyze the sym m etry properties of the di erent ECFT s proposed to describe the Jain llings.
3.1 T he ư(1) su( $m)_{1} \mathrm{~m}$ odels

The factorization of the m ulti-com ponents $\mathcal{U}^{d}(1)_{\mathrm{K}}{ }^{\mathrm{m}} \mathrm{m}$ odel in a charged and a neutral sector allow s us to evidence an $u^{(1)}(1)_{m}(2 \mathrm{pm}+1) \quad \mathrm{sul}(m)_{1}$ algebraic structure. T he charged sector has an $\mathcal{U}^{(1}(1)_{m(2 p m+1)}$ extended sym $m$ etry ${ }^{3}$ while the neutral one has a full su $(m)_{1}$ sym $m$ etry. M oreover the two sectors are not independent but are coupled by a discrete group so im plying that a superselection nule, called $m$-ality rule, $m$ ust be taken into account in order to build the physical excitations of the $m$ odel (i.e. a holon-spinon topological coupling) .

The factorization into a charged and neutral sector is explicitly obtained by diagonalizing the K m atrix. T he orthogonalm atrix $\mathrm{O}_{\mathrm{m}}$, which does it, has been explicitly given in 21], and the new elds $Q^{0}(z)=O_{m} Q(z)$ can be identi ed $w$ th those of ref. [1]. W e de ne the charged boson $X(z) \quad \frac{m_{1=p^{2}} Q_{1}^{0}(z)}{\bar{m}}$ and the neutral vector $(z)$ w ith com ponents $Q{ }_{i}^{0}(z)$

Thus the charged com ponent of $\mathcal{U}^{d}(1)_{K}{ }^{m}$ is just the $\mathcal{U}^{d}(1)_{m(2 p m+1)}$ extended theory. By using the neutral elds one gets the follow ing currents:

satisfying the $s u(m)_{1}$ algebra $^{4}$. Let us recall that starting from $\quad j, j=1 ;: ; m \quad 1$, and the basic weight $\mathrm{b}_{0}$ of the a ne algebra $\mathrm{su}(\mathrm{m})_{1}$, one can obtain all the other fundam ental
 de ne the $m$-ality charge as $l={\underset{m}{m}=1}_{1}$ in $n_{i} \bmod (m)$. It is a good quantum num ber useful to classify the excitations. A s pointed out above, the theory $\mathcal{u}^{(1)}(1)_{K}{ }^{m}$ is not a sim ple tensor product of the charged and the neutral com ponent. This is well evidenced by the explicit expression of the $\mathcal{U}^{( }(1)_{K}{ }^{m}$ characters given in eq. 2:11); which were introduced in 21] for the $m=3$ case and in 目] for generic $m$ as:

Furtherm ore the form of the $K \mathrm{~m}$ atrix allow $s$ to consider various discrete sym $m$ etries. H ere we focus our attention on its sym $m$ etries under the perm utations of the Landau levels. $T$ hey can be analyzed in the diagonalbasis in which the su $(m)_{1}$ sym $m$ etry is evidenced. W e distinguish two kinds of sym $m$ etries, one acting as an outer autom onphism of the su $(m)_{1}$ lattioe and the other one associated to inner autom onphism s of the algebra (i.e. the W eyl group). Inner autom onphism spreserve the com $m$ utation relations of the algebra (although the action on the algebra generators is nontrivial). W e let D (g) and D ( 9 ) stand for the sym $m$ etry group of the su $(m)$ and su ( $m$ ) D inkin diagram s respectively. A $s$ it is well known the group of the outer autom orphism s of $\hat{g} ; \mathrm{O}(\hat{g})=\mathrm{D}(\hat{g})=\mathrm{D}(\mathrm{g})$; is the dual of the center of the group of g, i.e. B (G) 22] which in the case of $s u(m)$ is $Z_{m}$. M oreover it acts on the
 changing them -ality of findam ental representation: $g(1)=1+1 . T$ he B (G) group action on the algebra generators is trivial. W e stress that outer autom orphism salso m ust preserve the com $m$ utation relations of the algebra, so that the characters $w$ illbe still given in term $s$ of the $s u(m)_{1}$ ones. The extended $U^{d}(1)_{K}{ }^{m}$ theory satis es the im portant property that under the action of $O$ ( 9 ) all its extended characters are xed points, that is they satisfy a ghing condition betw een the charged and the neutral sector which couples a $Z_{m}$ subgroup of the $u^{l}(1)$ to the $m$-ality charge in an invariant way. $T$ hus the $P ~ P$, periodic-periodic sector of the TM w illbe invariant $w$ ith respect to this coupled group (i.e. the perm utation group acts as an inner autom orphism for the full theory). This behavior is di erent from that of the paired states [13], w here the $H$ alperin theory does not coincide $w$ th the $P$ untw isted sector of its $Z_{m}$-orbifold. T hem reduction procedure induces naturally th is sym $m$ etry and gives the correct coupling betw een the charged and the neutral sector [1]].

Furthem ore quotienting by a discrete group that is not in the center it breaks all the a ne representations; therefore the partition function of the TM in the tw isted sector cannot be described in term sof the a ne characters (i.e. the a ne sym $m$ etry is broken in these sectors to the $W_{m}$ one).
3.2 T he $\mathrm{W}_{\mathrm{m}} \mathrm{M}$ in im almodel

The ECFT description of a Q HF at the plateau is justi ed by the incom pressibility of the Laughlin uid. The dynam ical symmetry of this uid in the disk geom etry is the areapreserving di eom onphism sof the plane which im ply the $W_{1+1}$ algebra. This is the unique

[^5]centrally extended quantum analogue of the classical area preserving di eom orphism salgebra $\mathrm{w}_{1}$ on the circle.
$T$ he in nite generators $W_{m}^{n+1}$ of $W_{1+1}$ of conform al spin $(n+1)$ are characterized by a m ode index m 2 Z and satisfy the algebra:


where the structure constants $q$ and $d$ are polynom ials of their argum ents, $c$ is the central charge, and dots denote a nite num ber of sim ilar term $s$ involving the operators $W \begin{gathered}n+n^{0} \\ m+m\end{gathered}$ 23, 25].

Such an algebra contains an Abelian $\mathcal{U}^{d}(1)$ current for $n=0$ and $a V$ irasoro algebra for $\mathrm{n}=1 \mathrm{w}$ th central charge c . T heir zero m odes eigenvalues are identi ed as the charge and angular-m om entum of the edge excitations of the Q HF.

In the literature 23, 24] the unitary representations of $W_{1+1}$ have integer central charge and can be of two types: generic or degenerate.

The generic representations, $w$ ith central charge $c=m$, are equivalent to those of the m ulti-com ponents bosons $\mathcal{U}^{(1)}(1)_{K}^{m}$, where the $K m$ atrices de ne the lattice $Z_{K}=\frac{Z^{m}}{K Z^{m}}$ whose weights $=(1 ;:: ; m)$ satisfy the conditions $a \quad b z Z, 8 \mathrm{a} \in \mathrm{b} 21 ;:: ; \mathrm{m}$.
$T$ he degenerate representations, $w$ th central charge $c=m$, are contained into those of the multi-com ponents and satisfy the conditions a b 2 Z .

In particular the fill degenerate representations are those whose weights all de ne degenerate representations. These conditions select uniquely the lattices $Z_{K}$ as the ones generated by the K m atrices of the Jain series. T he theory w ith full degenerate representation only is also called $W_{1+1} \mathrm{~m}$ inim alm odel [f].

The $W_{1+1} \mathrm{~m}$ odels are isom onphic to $\mathcal{U}^{d}(1) \mathrm{W}_{\mathrm{m}}$ theory, where $\mathrm{W}_{\mathrm{m}}$ is the algebra w th central charge $c=(m 1)$, de ned by the $q$ ! 1 lim it of the $Z a m$ olodchikov $\mp a t e e v-$ Lukyanov algebra with $c=\left(\begin{array}{llll}m & 1) & \frac{n(n+1)}{q(q+1)} & \text { 26]. In this lim it an in nity ofdegenerate }\end{array}\right.$ representations appears which are in one-to-one relation to the degenerate representations of the above $m$ in $m$ alm odels.

The $W_{m}$ algebra can be also de ned by a coset construction of the kind $W$ ( $\hat{=}=\mathrm{g} ; \mathrm{k}$ ) based on the $C$ asim ir operators of a nite algebra $g$ (see 23] and [14] for details). The relevant coset for Jain series is $W$ (su $\left.(m)_{k}=s u(m) ; k=1\right)$, which involves the nite algebra $s u(m)$, thus the central charge of the $W_{m}$ has the sam e value of the full theory $s u(m)_{1}$, ie. $\mathrm{c}_{\mathrm{Nm}}=\mathrm{C}_{\mathrm{su}(\mathrm{m})_{1}}=\mathrm{m} \quad$ 1. Theh.w. representations of $\mathrm{W}_{\mathrm{m}}$ are de ned by decom posing those of $s u(m)_{1}$ in term s of su( $m$ ) ones. The characters of the coset $W_{m}$ are thus the branching functions constructed by decom posing the characters of the a ne algebra in term s of those of the nite one:

Eq. $3: 12$ ) show s that any integrable $h . w . b_{1}$ representation of $s t(m)_{1}$ is given by collecting in nite representations of $W m$, such that $b_{2} P_{+}^{1} \backslash b_{1}$, each one w th $\mathrm{m} u$ ltiplicity $\mathrm{d}_{\mathrm{su}}(\mathrm{m})(\mathrm{r})$.
$N$ evertheless this extension is not a minim al one which should be given by collecting in nite prim ary elds of $W \mathrm{~m}$, everyone w th m ultiplicity one.
$T$ he $m$ ain point for this $m$ inim $a l W_{m}$ theory is that it is not a RCFT, that is the characters relative to the extended prim ary elds are not closed under the m odular transform ation $S$. W e propose a theory in which both sym $m$ etries can be taken into account, being realized in di erent sectors of the fill TM. It is based on another interesting realization of the $W \mathrm{~m}$ algebra given in [9] by using tw isted bosons. The representation theory for this realization w as studied in 10]. T his realization is the relevant one for the $m$ reduction and introduces new topological sectors to the description of the Jain llings. In order to obtain the $t w$ isted characters of the $W_{m}$ algebra it is necessary to add the special vector $\bar{m}=\frac{1}{m}{ }^{\mathrm{P}}{ }_{\mathrm{i}=1}^{\mathrm{m}} 1$ i; w th ${ }^{2}=\frac{\mathrm{m}\left(\mathrm{m}^{2} 12\right)}{12}$; to all the representations. N evertheless these are not representations of the algebra $s u(m)_{1}$, so this sym $m$ etry is explicitly broken in this vacuum . This vector changes the conform al dim ensions of the vacuum state according to:

$M$ oreover not only the $\mathcal{U}^{(1)}$ ( $s u_{(m)}$ is contained in our RCFT and it coincides w ith the $P \mathrm{P}$ sector of the $T M$ but also an extended $W \mathrm{~m}$ in im alm odel is realized in the $P-A$ sector, as it will be show $n$ explicitly in the follow ing sections.

## 4. The m -reduction on the plane

In this section we brie y review the m reduction procedure on the plane as a starting point for its generalization to the toruswhich is the $m$ ain content of this paper. O ur approach is $m$ eant to describe all the plateaux $w$ ith odd denom inator starting from the Laughlin lling
$=1=(2 \mathrm{pm}+1)$, which is described by a CFT w ith $\mathrm{c}=1$, in term s of a scalar chiral eld com pacti ed on a circle w th radius $\mathrm{R}^{2}=1==2 \mathrm{pm}+1$ (or its dual $\mathrm{R}^{2}=4=(2 \mathrm{pm}+1)$ ). $T$ hen the $u(1)$ current is given by $J(z)=i C_{z} Q(z)$, where $Q(z)$ is the com pacti ed Fubini eld w th the standard $m$ ode expansion:

 a power of the current $J(z)$.

W e start w the set of elds in the above CFT (m other theory). U sing the $m-$ reduction procedure, which consists in considering the subalgebra generated only by the $m$ odes in eq. 4.1), which are multiple of an integer $m$, we get the im age of the tw isted sector of a c = m orbifold CFT (daughter theory, i.e. the TM) which describes the Low est Landau Level (LLL) dynam ics of the new lling $=m=(2 \mathrm{pm}+1)$.

Then the elds in the m other CFT can be factorized into irreducible orbits of the discrete $Z_{m}$ group which is a sym $m$ etry of the $T M$ and can be organized into com ponents which have well de ned transform ation properties under this group. To com pare the orbifold so built w ith the $c=m$ CFT, we use the $m$ apping $z!z^{1=m}$ and the isom onphism de ned in ref. 11] betw een elds on the $z$ plane and elds on the $z^{m}$ covering plane given by the follow ing identi cations: $a_{n m+1}!p \bar{m} a_{n+l=m}, q$ ! $\frac{1}{\bar{m}} q$.

W e perform a \double"reduction which consists in applying this technique into two steps.

1) T hem reduction is applied to the Fubini eld $Q(z): T$ his induces tw isted boundary conditions on the currents. It is usefiul to de ne the invariant scalar eld:

2) Them reduction applied on the vertex operators $U{ }^{s}(z)$ of the $m$ other theory also induces tw isted boundary conditions on the vertex operators of the daughter CFT. The discrete group used in this case is just the $m$-ally group.
$T$ he vertex operator in the $m$ other theory can be factorized into a vertex that depends only on the invariant eld:

By looking at their conform al dim ension we are led to identify them as su $(m)_{1}$ spinons given in a $m$ ality diagonalbasis. Indeed we can de ne the fiull set of elds:

$H$ igher spin currents in $W_{1+1}$ algebra are given by the in nite generators in the enveloping algebra of the $u(1)$ charged sector and by the $W m$ currents obtained from the neutral sector. The explicit form form 4 was given in [9]. W e report here only the rst elem ent beyond the spin tw o of the series which in our basis is expressed as:

All the elds given in eq. (4.6) are invariant under the $Z_{m}$ group twisting the ${ }^{j}(z)$ elds. T he rem aining prim ary elds in the neutral sector which are not invariant are given by:

w th $\mathrm{g}=2$; :::; m . T his decom position breaks explicitly the nite su(m) sym $m$ etry of the m ulti-com ponents m odel. As we w ill show in the next section the residual sym m etry of the tw ist invariant sector is just the $W_{1+1}$ one.

## 5. Them -reduction on the torus

In the follow ing we consider the case of prim e m only, the m ore general case will be the sub ject of a forthcom ing paper.

### 5.1 The TM for prim em>2

The present discussion is valid for any prim em $>2 \mathrm{while}$ in sec. 52. ) it is analyzed the specialm $=2$ case. $T$ his is not only to clarify the construction in the sim plest case but also for the peculiarity of the $m=2$ case in which the $m$ reduction fiumishes special results.

The extended TM theory is the realization on the torus topology of that proposed in [1] to describe the plateaux for the Jain series $=\frac{m}{2 p m+1}$ on the plane. We can obtain the fill theory by applying the $m$ reduction on the torus and by im plem enting the $m$ odular invariance condition. T he m other theory describes the Laughlin lling $=\frac{1}{2 \mathrm{mp}+1}$ corresponding to the $\mathcal{U}^{(1)}(1)_{2 m p+1}$ sym $m$ etry (see appendix B for details).

By applying the $m$-reduction on the elds in the $m$ other theory we obtain the $t w$ isted sector of the TM im m ediately. In this procedure it is necessary to take into account two points:

1) The $\mathcal{U}^{\mathrm{d}}(1)_{2 \mathrm{pm}+1} \mathrm{~m}$ other theory is not an ordinary RCFT but a theory which is invariant only under 0 (2).
2) The TM is a ferm ionic theory so it must be of the sam e type of the $m$ other theory (i.e. the conform al dim ensions of its prim ary elds are de ned only mod (1=2)).
$T$ he extended prim ary elds in the tw isted sector have conform al dim ensions ${ }^{6}$ :

The term $\frac{m^{2} 1}{24 \mathrm{~m}}$ is due to the tw isted conditions. The condition 2) im plies that the num ber of conform al blocks of the extended theory are $m$ instead of $2 m$. The corresponding characters can be easily given in term $s$ of those of the $m$ other theory:

Their peculiarity is that the neutral part of the vertex operator is the identity. It gives a contribution only by $m$ eans of its descendents $w$ hich are just the $W m$ currents.

A though these elds are su cient to satisfy the 0 (2) covariance they are not the com plete set of elds in the TM. A s for the paired states case analyzed in 12], the periodicperiodic sector of the theory can be obtained by exploring the contents of the orbifold theory $\mathrm{U}^{\mathrm{d}}(1)_{\mathrm{K}}{ }^{\mathrm{m}}=\mathrm{Z}_{\mathrm{m}}$, which is the daughter C FT we obtained by m -reduction. Therefore in the next section we study this orbifold in detail and extract the inform ation we need to com plete the m odel.
5.1.1 The orbifold $\mathcal{U}^{d}(1)_{K}{ }^{m}=Z_{m}$

Starting $w$ ith the $\mathcal{U}^{d}(1)_{K}{ }^{m}$ theory, which is invariant under the discrete sym $m$ etries analyzed in sec. 3.1), we perform an orbifold construction $w$ ith respect to the discrete $Z_{m}$ group. It should be noticed that the $\mathcal{U}^{( }(1)_{\mathrm{K}}{ }^{m}$ is a $0(2)$ RCFT so the generated orbifold will be of the sam e kind.

A 11 the prim ary elds of the extended $\mathcal{U}_{(1)_{K}}{ }^{m}$ theory correspond to diagonal weights $\mathrm{b}=\mathrm{bt}$. De ning $g$ as the generator of the $\mathrm{Z}_{\mathrm{m}}$ group, perm uting the levels, we see that all these elds are invariant under its action and are xed points $w$ ith respect to this sym $m$ etry. The stabilizer $S_{b}$ for a general eld corresponding to the weight b is just $Z_{m}$, i.e. $\mathrm{S}_{\mathrm{b}}=g^{i}: i=0 ;: ; \mathrm{m} \quad 1$ and it has m elem ents.
$T$ he untw isted P -A sector of the orbifold is obtained introducing a new prim ary eld for any elem ent $2 \mathrm{~S}_{\mathrm{b}}$ and any eld in the m other theory. The generic conform al eld is param etrized by the index b and an elem ent $2 \mathrm{~S}_{\mathrm{b}}$ and its conform aldim ension given by:

Eq. 5.6) im plies that the conform al block relative to the identity coincides $w$ th that of the $\mathcal{U}^{\mathrm{d}}(1)_{\mathrm{K}}{ }^{\mathrm{m}}$ theory while there is a $m \quad 1$ degeneracy in the other blocks. $T$ he characters $\left(b ;\left(1 ; g^{i}\right)\right)(w j)$ of the orbifold are equivalent to the characters ${ }^{\mathrm{P}} \overline{\mathrm{m}} \sim_{\mathrm{b}}$ (wj) given in eq. (5.4).
$T$ he tw isted A P sector of the $\mathcal{U}^{( }(1)_{K}{ }^{m}=Z_{m}$ m odel can be obtained by the request of covariance under $0(2)$. Indeed from $\sim_{\left(s ;\left(1 ; g^{i}\right)\right)}(w j)$ we can generate the characters of the
tw isted sector by $m$ eans of the transform ation $S$. T he closure under $T^{2}$ im plies that also the characters $\left(s ;\left(g^{i} ; g^{j}\right)\right)(w j)=K_{s}^{(2 p m+1)}\left(w \frac{+2 j}{m}\right) ;$ for $j=1 ;:: ; m \quad 1$; belong to th is sector ${ }^{7}$. The full tw isted sector of this $\mathcal{U}^{( }(1)_{K}{ }^{m}=Z_{m}$ orbifold is given then by the characters

A s w e have seen the P P sector of this orbifold coincides $w$ th the $U_{(1)}{ }_{K}{ }^{m}$ itself. The rem aining part of the untw isted sector coincides $w$ ith the untw isted sector of the theory built by the $m$ reduction procedure, when we take into account the $m \quad 1$ degeneracy. $T$ he tw isted A P sector is given by characters of eq. 5.7) . Looking at eq. (5.7) and eq. (52), we nd the relationship betw een these characters and the characters obtained by $m$ reduction. Indeed as a consequence of the invertibility of the equality (5.2) for any xed $j$, the characters in eqs. 5.7) and (5.2) sim ply de ne tw o di erent basis of the sam e tw isted sector.

Thus we can conclude that the $m$ reduction procedure generates the non periodic part of the untw isted sector $(P-A)$ and the tw isted sector $(A-P)$ of the $Z_{m}$-orbifold of $\mathcal{U}^{d}(1)_{K}{ }^{m}$, by considering that any extended prim ary eld has degeneracy m 1.

### 5.1.2 C harged and neutral com ponents of the characters of the TM

In ref. [1] ] the TM was given in term s of charged and neutral com ponents on the plane. $T$ here it was shown that the charged com ponent coincides $w$ ith the com pacti ed theory w th $\mathrm{R}^{2}=(2 \mathrm{mp}+1)=\mathrm{m}=1=$. In the torus topology this separation can be given by the decom position of the characters in term $s$ of those of the charged and neutral ones. This decom position also tells us the way in whidh the prim ary elds of the charged and neutral com ponents $m$ ust com bine in order to generate the extended prim ary elds of the fill TM theory.

Looking at eqs. (3.7), 5.8) and (5.10) and taking into account the param etrization change, we conclude that the charged com ponent is the same in any sector of the TM and it coincides w ith the extended theory $\left.\mathcal{U}^{(1)}\right)_{m(2 m p+1)}$.

Let us notice that the characters given here are wrilten in a basis which is explicitly invariant under the perm utation of the Landau levels. In this basis we do not see the excitations content of the theory. They were independently introduced in 1] and 16] giving rise to a clustering phenom enon in the correlator of $N$ electrons (see []] for details). T he role of the tw isted sector has been

[^8]recently clari ed for the paired states in 29]. In that description the neutral current w as show $n$ to originate from a point-like interaction betw een the layers, which can be attributed to the presence of a localized im purity. W e w ill give a sim ilar analysis in a forthcom ing paper.

Eqs. (5:17), (5:18) and (5:16) show that the charged com ponent of the $T M$ form $=2$ is the extended theory $\mathcal{U}^{d}(1)_{2(4 p+1)}$ which is an ordinary RCFT, closed under the filllm odular group. It justi es the particular m odular behavior of the characters of the P-A sector which is closed under the $m$ odular transform ation $T$. It is due to the bosonic nature of the 2 -electron. It is worth noticing that even in such a case the full $T M$ theory rem ains a 0 (2) RCFT.

7. The sym m etries of the TM sectors

In this section we willdiscuss the relationship betw een the $T M$ and the $u^{d}(1)_{m}(2 \mathrm{pm}+1) \quad \mathrm{W}_{\mathrm{m}}$ m inim alm odels in detail.

A swe have already seen them in im alm odel is not a RCFT.The fact that the TM is the $Z_{m}$-orbifold of the $\mathcal{U}^{d}(1)_{K}{ }^{m} \mathrm{~m}$ odel clari es the relation between the tw o previous proposed theories for the Jain plateaux: the multi-com ponent bosonic theory, characterized by the extended $\mathcal{U}^{d}(1)_{m(2 \mathrm{pm}+1)}$ su( $\left.m\right)_{1}$ algebra and the extended $m$ in $\dot{m}$ alm odel.

N evertheless in this sector the extended sym $m$ etry is given by $u(1) W Z_{2}$. We could take the $Z_{2}$ even superposition of $W{ }_{2}$ degenerate characters as it was done in ${ }^{3}$ ] but we can see that only the odd supenposition given by the characters $\sim_{(1 ; b)}$ of the TM belong to a RCFT. It is necessary to give a well de ned S transform ation for the characters of the $P$ - A sector which produces the tw isted A $P$ sector of the TM. In this sector the $\mathrm{W}_{2}$ characters are non m in m al generic representations.

For generic $m$ the extended characters in the $P-A$ sector contains only $W_{m}$ representations with a b 2 mZ w th the same structure of the $m=2$ case. Thus only
the weights in the ${ }^{\wedge}{ }_{0}$ representation contribute and furtherm ore, by the isom onphism $\operatorname{su}(m)_{1}=\operatorname{su}(m) \quad W_{m}$, we have that in any su( $m$ ) multiplet just one is selected out. Instead in the A P sector the di erences a b $\quad \mathrm{Z}$ are not integer in general.

## 8. C onclusions

In this paper, by using the $m$-reduction procedure, we constructed the tw isted $m$ odel (TM) for the Jain series at the lling $=\frac{\mathrm{m}}{2 \mathrm{pm+1}}$, generalizing to the torus topology a recent construction for the plane目]. The extended chiral prim ary elds were derived both for the tw isted and untw isted sectors together w ith their corresponding characters. A lso their factorization in term sof charged and neutral com ponents was given. By constructing the com plete diagonal partition function, which tums out to be invariant under o(2) it has been shown that the multi-com ponents theory coincides with its $P$ Pector content. A detailed relation between the TM, the multi-com ponent and the $W m$ in m alm odelhas been worked out throughout the paper. For m = 2 it has been explicitly show $n$ that the P-A sector contains only degenerate representations of $W_{2}$, so resulting into a $\backslash m$ inim al sector" of the fiull theory. Finally it has been show $n$ that the presence of the A P sector assures the closure of the TM partition function under modular transform ations. The specialm = 2 case has been also analyzed. In the appendices it has been reported on the properties of the $O$ (2) group together $w$ ith the $m$ odular transform ations of the $\mathcal{U}^{( }(1)_{q}$ and TM characters.
