Solving the Functional Schrodinger Equation: Yang-Mills String Tension and Surface Critical Scaling.

A bstract: Motivated by a heuristic model of the Yang-Mills vacuum that accurately describes the string-tension in three dimensions we develop a systematic method for solving the functional Schrodinger equation in a derivative expansion. This is applied to the Landau-Ginzburg theory that describes surface critical scaling in the Ising model. A Renormalisation Group analysis of the solution yields the value = 1.003 for the anomalous dimension of the correlation function of surface spins which compares well with the exact result of unity implied by Onsager's solution. We give the expansion of the corresponding—function to 17-th order (which receives contributions from up to 17-loops in conventional perturbation theory).

1. Introduction

In recent years there have been considerable advances in our understanding of the quantum eld theory of systems with higher conserved charges. Deep mathematical structures have emerged in the study of integrable models in two dimensions and in supersymmetric theories in higher dimensions. However the eld theories that are directly applicable to the physical world do not manifest the high degree of sym metry needed for mathematical tractability. This limits us to the use of perturbation theory, which cannot describe strongly interacting theories, and the largely numerical approach of lattice eld theory. This suggests that it is worthwhile to develop new m ethods for the solution of generic non-integrable quantum eld theories. In this paper we will describe an approach to quantum eld theory in which the functional Schrodinger equation is constructed in an essentially standard way, [1]-[16], but is then solved using a derivative expansion for the wave-functional from which the continuum limit is obtained using a version of the Borel transform. Like perturbation theory this yields an approximation in the form of a series, but unlike perturbation theory the method applies at arbitrary values of the coupling. The approach is inspired by a heuristic model of the Yang-Mills vacuum but we will develop it for the toy-model of scalar '4 theory in 1 + 1 dimensions. This is partly because the simplicity of the model allows the series expansion to be calculated to reasonably high order using modest computing resources but also because the strong-coupling behaviour of the vacuum wave-functional describes the surface critical scaling of the

Ising model and so we are able to test the method against exact results which derive from the Onsager solution and conformal eld theory.

In a D -d.im ensional gauge theory there is a constant force between static quarks leading to con nem ent when the W ilson loop, W L [C], associated with a closed curve, C, depends on the minimal area spanning C as exp (Area [C]), [17]. is the string tension. W L [C] is the vacuum expectation value of the trace of the path-ordered functional integral representation DA exp ($S_D = g^2$) trP exp ($_C A dx$) where S_D is the Yang-Mills action in D Euclidean space-time dimensions, and ga coupling. A real behaviour is observed in M onte Carlo lattice studies for D = 2; 3 and 4, but has not been obtained by analytic calculation except in two dimensions where Yang-M ills theory becomes free with the gauge choice $A_1 = 0$. In 1979 G reensite [18] and Halpern [19] proposed a simple model of the conning Yang-Mills vacuum. For sim plicity consider D = 3. If we choose the temporal gauge $A_0 = 0$ and work in the Schrödinger representation so that A_1 and A_2 are diagonal on the quantisation surface t = 0 then the representative of the vacuum hA 0i = A is a gauge-invariant functional of $A_1(x^1;x^2)$ and $A_2(x^1;x^2)$. The idea is to model this three-dimensional exp $(kS_2=q^4)$, with k a vacuum in terms of the two-dimensional action as dim ensionless constant. This guarantees gauge-invariance and if we choose a planar C so that it can be rotated into the quantisation surface then the usual expression of vacuum expectation values within the Schrodinger representation yields

which reduces to the W ilson-loop for a two-dimensional gauge theory for which we can compute the string tension in terms of k. This form of [A] was compared directly to M onte Carlo simulations of the vacuum functional in lattice gauge theory in [20]. It m ight now be timely to repeat this comparison given the improvements in lattice gauge theory technology. This argument was generalised to quantum gravity in [21]-[26].

[A] should satisfy the Schrodinger equation, and this has been used to estimate k, [27]. The Ham iltonian is $d^2x \operatorname{tr}(A^2 + B^2)$ where the inagnetic eld', B, is the 1;2-component of the eld strength from which the two-dimensional action is constructed as $S_2 = d^2x \operatorname{tr}(B^2)$. In the Schrodinger representation $A = ig^2 = A$, so that the Schrodinger equation is

D i erentiating S_2 functionally with respect to A gives the covariant derivative of B , D $_i$ B . D i erentiating again gives a second order partial di erential operator, , so

that for the model vacuum the Schrodinger equation becomes

When the functional trace of is regulated using a heat-kernel based regulator to preserve gauge invariance the result is a divergent constant plus a multiple of S_2 , so that k, and hence , are determined if we ignore (DB)² as a higher order correction. Specifically, if zeta-function regularisation [27] is used we obtain




Figure 1: $p = (g^2 N^2 1)$ against N from lattice QCD, [28]. The horizontal lines correspond to the predictions from (lower) and KKN.

for the gauge-group SU (N), (and where we have adapted the result of [27] to the convention tr $(T_a T_b) = ab = 2$ for the generators of the fundam ental representation.) This form ula shows remarkable agreement with recent lattice studies. Figure (1) plots $P = (g^2N)$ against N as measured in M onte Carlo simulations [28]. $P = (g^2N)$ is shown on the same gure, and the values agree to within a half to one percent which is signicant given that the formula (1.4) has no adjustable parameters. (There is a similar formula, $K = g^4 (N^2 - 1) = (8)$, [29], based on a dierent parametrisation of the canonical variables which is also displayed in the Figure).

This model begs many questions: Can the vacuum functional really be the exponential of the integral of a local quantity, i.e. depending on a single point in space, since this is quite unlike the non-local functionals seen in perturbation theory. For example the free Maxwell eld in four-dimensions has

Is the approach regularisation dependent, and is it consistent with the usual ultraviolet behaviour and renormalisation of gauge theories? Is the model Lorentz invariant? Can corrections to the model be computed and shown to converge to the lowest energy solution to the Schrodingerequation? Applying the argument to four-dimensional gauge theory would give a vacuum functional that is the exponential of the three-dimensional action with a cut-o dependent coe cient that appears to lead to a divergent string tension. Despite these issues the agreement between lattice simulations and the formula for the string tension suggests that it is worthwhile to investigate the approach further and make it more systematic.

In calculating k the contribution of (DB)^2=g^6 was ignored in (1.3). This may be corrected for by including a similar term in the vacuum functional. This leads to an adjustment to the coe cient of the original term proportional to $\operatorname{tr}(B_R^2)$ because $\operatorname{d}^2x^2=A^2$ applied to $\operatorname{d}^2x\operatorname{tr}((DB)^2)$ gives a piece proportional to $\operatorname{d}^2x\operatorname{tr}(DB)^2$, where is a short-distance cut-o as well as $\operatorname{d}^2x\operatorname{tr}((DB)^2)$ so that now, if we set = $\operatorname{exp}W$ then the approximation for W is

which satis es the Schrodinger equation for appropriate values of k_2 and k_3 if now we ignore term s of m ass dimension eight. These higher dimension expressions can then be taken into account by adding further term s so that the process generates an expansion for W consisting of local expressions of increasing dimension with coecients that are them selves series in decreasing powers of the cut-o. Super cially such a derivative expansion would appear to be applicable only to slowly varying elds, making it dicult to address the ultra-violet behaviour that has to be understood in order to renormalise the theory. Furthermore the cut-o dependence of the coecients is unexpected since a theorem due to Symanzik [30] in plies that W should be nite as ! 0 (at least to all orders in perturbation theory).

To address the problem of whether a system atic expansion of the vacuum functional can be obtained as a derivative expansion with the correct ultra-violet behaviour we turn to a simpler model than gauge theory, namely scalar ' 4 theory in two space-time dimensions. The simplicity of the model will allow us to pursue the expansion to high order and, as stated earlier, the strong-coupling ultra-violet behaviour is related to the surface critical scaling of the Ising model, providing exact results to test our approach against.

The Hamiltonian for scalar ' 4 in two space-time dimensions is

where $'_0$, m $_0$ and g_0 are the bare eld, mass and coupling. Quantisation consists $\sin p \ln q$ of replacing $'_0$ by $i = '_0$. We can now look for eigenfunctionals of H . We will assume that, as in quantum mechanics, the vacuum functional has no nodes, so that it can be written as $= \exp W$, giving a Schrodinger equation

where E $_{\rm v}$ is the energy of the vacuum . The first term needs to be regularised, and we adopt a simple momentum cut-o , replacing 2 = 2_0 by

The problem of renormalisation is to tune the bare quantities in terms of s to obtain nite physics. Renormalisation conditions have also to be chosen to replace the (potentially divergent) bare quantities by nite parameters, in this case a mass scale and dimensionless coupling g. We are aided in this by Symanzik's theorem [30] which implies that provided we renormalise $'_0$ multiplicatively $'_0 = \frac{P}{R}Z$ (and tune m_0 and g_0) then W is nite apart from a local term proportional to $\frac{P}{R}Z$.

Conventional sem i-classical perturbation theory can be developed [1] by reinstating \sim in the quantisation $'_{0} = i_{0} = i_{0}$ and expanding $W = W_{1} = v_{0} + W_{2} + v_{0} + v_{0}$

where $! = p^2 + m_0^2$, and bare and renormalised quantities coincide at this (tree) level. Clearly for slowly varying 'we can take $pj < m_0$ and expand $! = m_0 + p^2 = (2m_0) + ::$ to obtain a local expansion. The one-loop, i.e. order ~, correction can be readily obtained, [1], [36], but this is not our purpose here. Instead we will develop the approach of [32] and consider solving for the full W starting from an expansion in a basis of local functionals of the renormalised eld with coe cients fbg:

Now the regulated second functional derivative acts on this local expansion to produce another local expansion, for example

The other terms in the Schrodinger equation are also local functionals of 'so we can reduce this functional dierential equation to an in nite set of algebraic equations for the in nite number of constants flog by equating one cients of the basis functionals to zero. To solve these requires some form of truncation, for example by simply ignoring one cients of local term's containing more than a prescribed number of elds or derivatives. In [32] a di erent truncation was proposed that would use an estimate of such high order one cients. Once the problem has been made nite the equations can be solved, for exam ple num erically, although the stability and convergence of the solutions may be sensitive to the truncation. We will use a dierent approach to that of [32]. Rather than truncate the expansion (1.9) we look for solutions to the full set of (untruncated) equations in the form of expansions of the coe cients flog as power series in 1=s. We will see that the enlarged set of equations obtained by equating to zero the various powers of s form closed systems that can be solved rapidly and $\sin p \ln x$ in term s of the renormalised quantities and g. The quantities Z; g_0 and m_0 will sim ilarly be obtained as power series in 1=s. We will compute these series up to som e xed order, N , determ ined by com puting resources. This is the only truncation we will use.

The continuum limit is obtained by sending s to zero, (and N to in nity) so these series solutions would appear to have little physical relevance, as they are only likely to converge for large s. However the smalls behaviour can be extracted using a version of the Borel transform, which we describe in Section 3.




Figure 2: (g) (upper curve) and (g) from the Schrodinger equation.

We will test our solution of the Schrodingerequation against exact results obtained for the surface critical scaling of the Ising model from the Onsager solution and conformal eld theory [31]. At a critical value of the renormalised coupling, g, the ! 0 lim it of '4 theory describes the Ising model at criticality. More specically the wave-functional describes the Ising model with a boundary (corresponding to the quantisation surface) at the Ordinary Transition'. That part of the wave-functional that is quadratic in ' is related to the correlator of two spins lying in the boundary which is known to depend on their separation jujas 1=juj. This quadratic piece can be written as $dx dy'(x)'(y) = x y^2$ where is the anomalous dimension, so the correspondence with the Ising model requires that = 1. Now a standard Renormalisation Group argument presented in Section 4 gives as the value of $d \log Z = d \log$ (g) computed at the zero of the beta-function dg=d log (q). In Figure 2 we display these two functions computed from our solution when we truncate the series expansions to order 1=s17 term s. The graph indicates good agreem ent

with the exact result, and as we will see the agreement is considerably improved upon extrapolation in the number of terms, N.

2. Solving the Schrodinger Equation for $^{\prime}$ 4.

The Schrodingerequation for the vacuum , H $\exp W = E_{\,\rm v} \exp W$, can be written in term s of the renorm alised $\,$ eld as

where the dots denote an in nite number of terms containing increasing powers of the eld and its derivatives. The two (or three) labels on the coe cients denote the number of elds, the number of derivatives (and a further label to distinguish between di erent term s for which the rst two labels are the sam e). We will not truncate the expansion at this stage. Substituting (1.9) into the Schrodinger equation gives

where again the dots denote an in nite number of local terms all of which we keep in the expansion for the time being. Substituting into the Schrodinger equation gives

These equations have to be solved in conjunction with renormalisation conditions that identify parameters that remain nite as the cuto is removed. We will take to be our nite mass-scale. Symanzik's theorem [30] implies that the coe cients b in the local expansion of Ware nite, with the possible exception of b_2 , so we choose renormalisation conditions

with dimensionless g playing the rôle of renormalised coupling. Our aim is to solve (2.3) and (2.6) for the coe cients b and c, and also for g_0 , m_0 and Z in terms of the nite parameters and g.

Equating the coe cients of the basis functionals to zero in (2.3) gives an in nite set of algebraic equations. This may be divided into two classes. In the rst class are the equations obtained from the coe cients of 1, ' 2 , ' 2 , and ' 4 .

These equations involve the bare quantities g_0 , m_0 , Z and E_v as well as the coexcients b. The second class consists of all the other equations, and these involve only the coexcients b.

We begin by solving this second class for the boxe cients other than b_2 , b_4 and b_2 , b_1 in term sofg, and b_2 using (2.7). Expanding each coe cient as a power series, $b_h = \sum_{r=0::1}^{r} b_n^r = s^r$, and then equating the coe cients of powers of 1=s to zero in each equation gives further equations that can be easily solved in MAPLE to high order. An important feature is that they form a closed system which is easily solved order by order in 1=s. Consider the equation corresponding to the coe cient of a given local term involving F powers of the eld and a total of D derivatives. The equation obtained by equating to zero the coe cient of s p takes the form:

where A and C are known numerical coecients. This can be solved for $b_{F,D,r}^p$ in terms of the coecients $fb_{F^0,D^0,r}^{p^0}$ g where $F^0+2D^0+2p^0$ F + 2D + 2p Q and either $F^0=F$, $p^0<$ p or $F^0<$ F, p^0 p, D^0 D.

To obtain $b_{F,D,r}^p$ explicitly we can build up the solutions starting with p=0. Given that the renormalisation conditions x b_4^0 and $b_{2,2}^0$ we begin by calculating b_6^0 , $b_{2,4}^0$ and $b_{4,2}^0$ and then use these results to calculate b_8^0 , $b_{4,4}^0$, $b_{6,2}^0$ and $b_{2,6}^0$. From these we compute more coecients until all the fb $_{F^0,D^0}^p$ g are known with F^0+2D^0-Q . Then we move on to fb_{F^0,D^0}^1 g by rst using the results obtained to compute b_6^1 , $b_{2,4}^1$ and $b_{4,2}^1$. From these we obtain b_8^1 , $b_{4,4}^1$, $b_{6,2}^1$ and $b_{2,6}^1$ and continue the process until all the fb_{F^0,D^0}^1 g are known with F^0+2D^0+2 Q, and from these we can compute fb_{F^0,D^0}^2 and so on. A lithough this appears complicated in practice it is straightforward. For example (2.10) gives to lowest order in 1=s

Having obtained the b-coe cients and Z , m $_0$ and g_0 we solve (2.6) to obtain the c-coe cients and the energy eigenvalue in terms of , g and b_2 again as power series in 1=s. Finally, given that the energy eigenvalue equals we can invert the series to obtain b_2 in terms of g and , and substitute this into all the other series expansions to express all quantities as power series in 1=s depending on g and . In the Appendix we give the expansions 1 for g_0 , and z_0 up to order 1=s 17 which requires taking terms with F + 2D up to 40 in the local expansions (2.2) and (2.5), of which there are about 625 and 540 respectively.

These expansions can only be expected to converge for large values of s, if at all, but the continuum lim it requires taking s to zero. In the next section we will show how a version of the Borel transform can be used to extract the small s behaviour from these series, and then in Section 4 we will apply this to the bare quantities to extract an anomalous scaling dimension which we can test against the exact result for the Ising model.

 $^{^{1}}$ W e note in passing that such series could be obtained from standard Feynm an diagram expanded in powers of 1=s, for large s. G iven that these expressions contain powers of the coupling to order g^{17} and g^{18} this would require working to 17 loops in conventional perturbation theory.

3. Smalls from large svia Borel

The functional integral representation of wave functionals described in section 4 can be expanded in terms of Feynman diagrams. For massive eld theories Feynman diagrams are analytic in the cut-os for large enoughs, although for smalls they have singularities in the left-half-plane. After renormalisation they have nite limits both as s! 0 and as s! 1 (where they tend to their tree-level values). Assuming that these properties hold beyond perturbation theory we will exploit this analyticity to extract the small-s behaviour from our series expansions.

As an example, consider a function f(s) that has the assumed analyticity properties of wave-functionals, namely it is analytic for large s, and in the right-half-plane, with nite limits as approaches the origin and in nity. For large s it will have a Laurent expansion containing only non-positive powers of s, but suppose that we only know the rst few terms, $A_N(s) = \sum_{n=0:N} a_n = s^n$, from which we wish to estimate the small s behaviour. We can obtain this from the integral

If for I the contour C is now collapsed to surround the singularities of the integrand, then the pole at s_0 contributes $f(s_0)$. We cannot take arbitrarily large, but only as large as allows I^N to be a good approximation to I, which is the case when I^{N-1} diers by no more than say a few percent from I^N . If this condition xes to be then we arrive at the approximation $f(s_0)$ I^N




Figure 3: I^{18} (lower curve) and I^{19}

from which it is clear that $\lim_{t \to 1} I = f(s_0)$. If we use the series truncated at say nineteen terms then A_{19} (s) itself approximates f(s) to better than one percent for s > 1.07. At s = 1 the error grows to three and a halfper cent and for jsj < 1 the error increases rapidly as s gets s aller. Figure 3 plots s and s for s0 = 0.9. The two

curves agree up to about = 9, and for this value provide a very good approximation to $f(s_0) = 0.6725$, ($I^{19} = 0.6724$ and $I^{18} = 0.6727$). For larger values the two curves diverge, and approach $A_{19}(0.9) = 0.4823$ and $A_{18}(0.9) = 0.8524$ which are poor approximations to f(0.9). For much smaller values of s_0 we still obtain reasonable results, for example in the case of $s_0 = 0.05$ the two curves diverge at 7 yielding an approximation of $I^{19} = 0.2123$ to f(0.05) = 0.1522, which is fly per cent out, but it is am using to compare this to the value of $A_{19}(0.05) = 0.25 = 10^{24}$.

We will be principally interested in the value of f at the origin. We can take s_0 ! 0 in the general case, but the new feature that arises is that any cut in the left half-plane that ends at the origin will no longer be exponentially suppressed. However, our assumption that f (s) has a nite limit as s! 0 implies that if f

then > 0 and this behaviour is power law suppressed. A lso the expression for I^N simplies to $_{n=0:N}^{}$ a_n $^n=n!$. In our example I=e=1= and the second term demonstrates this power law suppression. A gain I^{19} and I^{18} agree for up to about 7 yielding an approximation of 0.1416 to f(0)=0.




Figure 4: I^{19} (upper curve) and I^{18} for s! 0




Figure 5: I^{19} and I^{18} for a = 1 (lowest curve), 1:1;::;1:6

Increasing a reduces the size of the last term in I^N in comparison to the penultim ate term, because of the function in (3.6), enabling us to take a larger value of , however increasing a enlarges the region of non-analyticity. Initially this will result in singularities occurring at values of s with large negative parts, causing oscillations in the plot of I^N against . This can be seen in our example, in Figure 5.

Maxim a appear for a=1.4, 1.5 and 1.6 due to these oscillations. Increasing a still further can cause the singularities to migrate to the right half-plane, spoiling our construction altogether. The position of these dominant singularities can be estimated by studying the shape of the curve, thus the exp () decay in our example for a=1 can be seen by thing numerically the curve of I^N to an exponential. To improve our approximation we need to increase a as much as we can without encountering these pathologies. We can do this by taking a as large as possible whilst

maintaining I^N as a monotonic function of in the region where it approximates f (0), < , (we may have to exclude a region close to the origin if I has a turning point not due to a singularity occurring at complex s, this complication can be resolved by studying the N-dependence). So in our example we would take a=1.348004 and obtain the approximation 0:013 when we require that I^{18} and I^{19} dier by 0:01 at =9.77.

The precision with which we require I^{19} and I^{18} to agree introduces arbitrariness into , however because we tune a so that I^{19} is quite at for the estimate we obtain is fairly insensitive to this choice of precision, so for example if we require that I^{19} and I^{18} dier by only 0:001 (instead of 0:01) at the estimate changes to 0:0115 even though has changed to 8:93. Note that I^{19} is considerably less at than I^{19} in the vicinity of . It has a single maximum in this region, whereas the at portion of the latter turns into two turning points that are close together if a is slightly increased. To minimise arbitrariness we should in general base our estimates on the atter curve, which means using I^{N} with N odd in this example.

The integral I is the Borel transform of the function f centred at s_0 . Our approach based on studying the large- behaviour to reconstruct the original function has the advantage over the usual method of avoiding the need to analytically continue the transform, (for example using Pade approximants), prior to inversion using the Laplace transform.

In our application to the Schrodinger equation s is a sharp momentum cut-o.




Figure 6: I^{19} (upper curve) and I^{18} for a = 1:348004 in the vicinity of

It has been observed that in the di erent, but related context, of Polchinski's ow equation that a smooth cut-o increases the rate of convergence of a series solution. The reverse occurs here. Suppose that the series $A_{\rm N}$ resulted from an integral with a sharp cut-o as might be the case for example for a one-loop Feynman diagram. Thus

Our transform I^N is n=0:N a_n n=n! as before, but if we replace the sharp cut-oby a Gaussian one we obtain an alternative to A_N

with a transform $^{P}_{n=0:N}$ (n=2) a_n n =(2n!) which clearly converges much more slowly (if at all) due to the (n=2) in the numerator. That this is the reverse to what occurs in the Polchinski ow equation in [33] is because in that application the corresponding expansions involve positive powers of s rather than negative ones so that (n=2) appears instead in the denominator and enhances convergence.

4. Surface Critical Scaling in The Ising Model

'4 theory is the Landau-G inzburg theory that describes the critical behaviour of the Ising model [34], [35]. The vacuum wave-functional has a functional integral representation as a Euclidean eld theory with a boundary corresponding to the quantisation surface

We have studied massive ' ⁴ theory, but the Renormalisation G roup provides a means of extracting the massless behaviour [34], [35]. It starts from the observation that at short distances the functional integral (4.1) expressed as it is in terms of bare quantities is approximately independent of m_0 . This is based on a perturbative analysis, because in terms of Feynman diagrams differentiating with respect to m_0 introduces a ² insertion in the bulk involving two propagators that are suppressed at large momentum. Now, from the functional integral representation m_0 is a function of the bare variables m_0 , m_0 and the cut-of and is related by wave-function renormalisation to which is given by our solution in terms of and m_0 . The correspondence betwen the Ising model and $^{\prime}$ theory requires that we should be able to obtain (g) = 1 from our solution. The series given in the Appendix express g_0 and Z as functions of $_{\prime}$, s and g. Dierentiating these with respect to \log whilst keeping g_0 and s xed gives

We have calculated these functions for a variety of values of gusing the transform ation of Section 3 to extract the s! 0 lim it. The results are shown in Figure 2 and demonstrate that the —function has a zero at groughly equal to 2 where—is approximately unity in agreement with the Ising model result. Studying the region in the vicinity of g=2 leads to values of 1:955 for the zero and 0:961 for the corresponding value of .




Figure 7: I^{17} (upper curve) and exp (m + c)=m approximating the error.

Comparison with the exact result shows a departure from it by four per cent, but we can estimate the error a priori by examining the shape of I^N . For small the error is mainly composed of exponential terms that are suppressed as increases, we can estimate the dominant term by thing $dI^N=d$ to an expression of the form $\exp(m+c)$ for 0<<0.9 (the region is only taken up to 0.9 rather than because the $dI^{17}=d$ and $dI^{16}=d$ diverge for smaller). In Figure 7 we plot I^{17} and $\exp(m+c)=m$ which shows that the exponential terms account for about six per cent of the value of I^N , this is of course only a rough estimate.

This approximation of the anomalous dimension depends on the number of terms we keep in the series expansions, which in turn determines the type of terms we need to retain in our local expansions of W and U. So far we have worked to order $1=s^n$




Figure 8: The approximation to for n = 17; 15; 13; 11; 9

with n = 17 which has required including terms with F elds and D derivatives such that F + 2D = 40. Since the true continuum $\lim_{n \to \infty} f$ should be obtained as n + 1 it is worthwhile to see how the results vary with n. In Figure 8 we plot the

approximations obtained by keeping n terms against 1=n for n = 17; 15; 13; 11; 9. We also show the exact result as though it would occur at n = 1, to guide the eye. The plot shows roughly linear behaviour, and when a straight-line t through these results is extrapolated we obtain a value of 1:003 for the anom alous dimension, which is in very good agreement with the exact Ising M odel result.

We can compare this result with the predictions of one-loop perturbation theory. The vacuum functional was computed in the sem i-classical approximation in [36] (the perturbative treatment of the three-dimensional case is given in [37]) where the coe cients of $\binom{4}{0}$ and $\binom{6}{0}$ in W were found to be $g_0=(96M)+3.973.10^4\,g_0^3=M^3$ and $1=(4M)+g_0=(48\,M)$, respectively, where M is related to the particle mass by $M=g_0=(8)$. These imply that at one-loop order $=2g+0.617g^2$ and =g=, so that g=3.242 and =g=1.032, which is slightly more accurate than our estimate based on series with 17 terms, but considerably less accurate than the extrapolated value of 1.003.

The expansions in the appendix can be re-ordered to yield estimates for the coe cients of the loop expansion. For example, if we retain only those terms up to and including second order in g in the beta-function we obtain

which gives 0:813g² on resum mation, so to two-loop order the —function ceases to have a zero. The disappearance (and reappearance) of the zero in successive orders of perturbation theory is encountered elsewhere and requires a skilful handling of the perturbation expansion, for example with the use of Pade-Borel resum mation in g, [37]. This is to be contrasted with the results from the Schrodinger equation for which there is always a zero in the —function although its position is corrected at each increasing order of the approximation.

5. Conclusions

We have solved the functional Schrodinger equation for the vacuum of '4 theory and for a state describing a stationary particle by expanding these states in terms of local functionals. The solutions were obtained as power series in 1=s, where s is a short-distance cut-o. The s! 0 lim its of these series were found using a variant of Borel re-sum mation that avoids the use of analytic continuation. A standard Renormalisation G roup argument was used to compute an anomalous scaling dimension in the massless theory. Extrapolating in the number of terms of the series gave the result 1.003 for this scaling dimension which agrees well with the exact result of unity obtained from the conformal eld theory treatment of the surface critical scaling of the Ising model at the Ordinary Transition.

We have only developed the solution to the point where we could make the comparison with the Ising model. Further work remains to be done to describe the particle dynamics in this approach, for example by checking Lorentz invariance and constructing an S-matrix. Neither have we computed inner products of states, although their form is determined by the Hermiticity of the Hamiltonian and they should also be calculable as re-sum med expansions in 1=s.

We concentrated on two dimensional scalar theory as this allowed the series expansions to be obtained using only modest computing resources. Similar resources should be su cient to study other models such as Landau-G inzburg theories with higher order polynomial interactions and integrable models with exponential interactions where the wealth of exact results would provide useful tests of the method. There is nothing intrinsic to the approach that $\lim_{n \to \infty} \frac{1}{n} = 1$

should be possible to apply it to critical phenomena in 3 dimensions and gauge theories in three and four. Indeed the method was motivated by the desire to system atise a heuristic model of the Yang-Mills vacuum that gave an accurate formula for the string tension in three dimensions. Applying it to that case to compute series with large numbers of terms would require some e ort, so we cannot at the moment explain why the formula for the string-tension agrees accurately with Monte-Carlo results, despite being based on just the leading term of the local expansion. However we can understand why the corresponding calculation in four-dimensions appears to give a string-tension that diverges with the cut-o: this is just the rest term in a power series that should re-sum to a nite result. As in the case of scalar eld theory standard perturbation theory is obtained by organising the local expansion in powers of the coupling. In this context it has already been shown how the usual one-loop beta-function for Yang-Mills theory is obtained in this approach [38].

A . Solutions

The solutions listed below for the series expansions of Z, g_0 , and were computed up to order $1=s^{17}$ using MAPLE, working with rational numbers. The exact values for the ∞ cients have been evaluated to ten signi cant gures to save space.
