POW ER LAW INFLATION AND THE COSM IC NO HAIR THEOREM IN BRANE WORLD

A bstract

The Cosm ic no hair theorem is studied in anisotropic B ianchi brane models which adm it power law in ation with a scalar eld. We note that all B ianchi models except B ianchi type IX transit to an in ationary regime and the anisotropy washes out at a later epoch. It is found that in the brane world, the anisotropic universe approaches the isotropic phase via in ation much faster than that in the general theory of relativity. The modication in the Einstein eld equations on the brane is helpful for a quick transition to an isotropic era from the anisotropic brane. We note a case where the curvature term in the eld equation initially drives power law in ation on the isotropic brane which is however not perm itted without the brane fram ework.

During the last couple of years there has been a growing interest to study cosmological m odels in higher dim ensions m otivated by the developm ents in superstring and M -theory [1,2]. These theories may be considered as promising candidates for a quantum theory of gravity. Although a complete theory of quantum gravity is yet to emerge, it is interesting to look for cosm ological issues in the string theories. In the above, one requires dim ensions m ore than four for a consistent formulation. It is therefore, interesting to probe cosmological issues in this fram ework. The work on higher dimensional cosmology began with the work of Kaluza-Klein (KK) [3]. In the past, the usual four dimensional space-time was recovered starting with a higher dimensional one either by a dimensional reduction m echanism or by considering compact extra space dimensions which are not visible today. Recently, the above ideas have been changed remarkably. According to recent views, in higher dim ensional scenario, our observed universe m ay be described by a brane em bedded in higher dimensional space-time with the usual matter elds and force con ned on the brane. The gravitational eld may propagate through the bulk dimensions perpendicular to the brane. Randall and Sundrum [2] shown that even if the extra dimensions are not compact, in the brane world model one recovers four dimensional Newtonian gravity starting with a ve dimensional anti-de Sitter spacetime (ADS₅) in the low energy limit.

Recently there has been a spurt in activities in building cosm ological models of the very early universe in the brane world [4]. It is now generally believed that in ation is one of the essential ingredients in modern cosmology as it can solve some of the problems of the big bang model elegantly. Two varieties of in ationary solutions have been proposed in the literature: (i) exponential or quasi-exponential expansion and (ii) power law in ation. The rst kind of in ation requires a potential which behaves as a cosmological constant and in the second case a power law in ation is obtained by a Salam -Sezgin type exponential potential. The possibility of a chaotic in ation scenario in the brane world was studied by

Maartens et al. [5] and it was found that the modi ed braneworld Friedmann equation leads to a stronger condition for in ation. The brane e ects ease the condition for slow-roll in ation for a massive scalar eld. It was also shown [6] that in the framework of a self-interacting quartic type potential, a chaotic model may be realised and the initial condition > 3M P which is required in the general theory of relativity (GTR) is found to be no longer an essential condition in the braneworld. This is a good feature on branes as chaotic in ation in GTR has been criticised for regarding super Planckian eld values and can lead to a non-linear quantum correction in the potential which was ignored. The dynamics of in aton on the brane due to the high energy brane corrections introduced in the eld equations are addressed in the literature [7].

The behavior of an anisotropic B ianchitype-I brane world in the presence of a scalar eld with a large anisotropy was explored by M aartens, Sahni and Saini [8]. It is shown that a large anisotropy enhances more damping into the scalar eld equation of motion, resulting in greater in ation. In the last couple of years brane models with anisotropic universes exploring dierent aspects of the early universe have been reported in the literature [8-12]. In the brane world the validity of the cosmic no hair theorem for global anisotropy with [13] or without [14] four dimensional cosmological constant has been explored. However, in the latter case the scalar eld potential behaves as an elective four dimensional cosmological constant. Cosmological models with power law in ation in the brane world are of recent interest [15]. It is also important to explore power law in ation in the anisotropic brane world and look for its isotropization. In four dimensions K itada and Maeda [16] extended Wald's idea [17] of the cosmic no hair theorem for scalar elds with an exponential potential which admits power law in ation in Bianchi universes. In this paper the cosmic no hair theorem for power law in ation is studied with exponential potential in anisotropic Bianchi brane models.

The Einstein eld equations in the ve dimensional (bulk) space-time is given by

with $T_{AB}^{(5)} = (y)[$ $g_{AB} + T_{AB}]$. Here ~ represents the ve dimensional gravitational coupling constant, $g_{AB}^{(5)}$, $G_{AB}^{(5)}$ and $G_{AB}^{(5)}$ are them etric, E instein tensor and the cosm obgical constant of the bulk space-time respectively, $T_{AB}^{(5)}$ is them after energy more entum tensor. We have $C_{AB}^{(5)} = \frac{8}{M_P^3}$, where $M_P = 12$ $C_{AB}^{(5)} = 10^{19}$ GeV. A natural choice of coordinates is $C_{AB}^{(5)} = (C_{AB}^{(5)})$, where $C_{AB}^{(5)} = (C_{AB}^{(5)})$ are space-time coordinates on the brane. The upper case Latin letters $C_{AB}^{(5)} = (C_{AB}^{(5)})$ are space-time coordinate indices in the bulk spacetime, the Greek letters $C_{AB}^{(5)} = (C_{AB}^{(5)})$ is the coordinate indices in the four dimensional spacetime and the small case latin letters $C_{AB}^{(5)} = (C_{AB}^{(5)})$ is the three space. The space-like hypersurface $C_{AB}^{(5)} = (C_{AB}^{(5)})$ is negative the brane which is assumed to be positive in order to recover the conventional general theory of gravity $C_{AB}^{(5)} = (C_{AB}^{(5)})$ on the brane. The bulk cosmological constant $C_{AB}^{(5)} = (C_{AB}^{(5)})$ is negative and represents the vedimensional cosmological constant.

The eld equations induced on the brane are derived by Shirom izu et al [18] using a geometric approach which leads to new terms carrying bulk elects on the brane. The modied dynamical equations on the brane are

The e ective cosmological constant and the four dimensional constant on the brane are given by

respectively, where $\,$ c is the critical brane tension which is given by

However one can make the elective four dimensional cosmological constant zero by a choice of the brane tension. The extra dimensional corrections to the Einstein equations on the brane are of two types and are given by:

S : quadratic in the matter variables which is

where T = T, S is signicant at high energies i.e., > ,

E : occurs due to the non-locale ects from the free gravitational eld in the bulk, which enters the equation via the projection $E_{AB}^{(5)} = C_{ACBD}^{(5)} \, n^C \, n^D$ where n^A is normal to the surface ($n^A \, n_A = 1$). The term is symmetric and traceless and without components orthogonal to the brane, so $E_{AB} \, n^B = 0$ and $E_{AB} \, ! \, E_{AB} \, g_B$ as y ! 0.

To analyse the cosm ological evolution, we consider two components of the dynamical equation (2). First we consider the "initial-value" constraint equation

where n is the unit normal to the homogeneous hypersurface. It may be pointed out here that both G n n and R n n are expressed in terms of the three geometry of the homogeneous hypersurfaces and the extrinsic curvature K = 5 n respectively. The extrinsic curvature can be decomposed into its trace K and trace-free part which represents the shear of the timelike geodesic congruence orthogonal to the homogeneous

hypersurface

We consider a scalar eld theory to describe the energy momentum tensor which is given by

with V () = $V_0e^{-c^2}$, where and V_0 are constants. For a homogeneous scalar eld the dynamical equation (6) and (7) can now be written as

where the prime represents dierentiation w.r.t.cosm ic time t. The wave equation for the scalar eld is given by

with $^{(3)}$ R as the scalar curvature of the hom ogeneous hypersurface. To study the cosm ic no hair theorem, we follow K itada and M aeda [16]. A coordingly we use a new time coordinate, which is defined by

instead of the cosm ic time t. This conform all change in the time scale is considered here as in an isotropic and hom ogeneous space time i.e., power law in ation becomes a time independent xed point, the attractor. The equations (9) and (10) can be rewritten with this time as

where the over dot indicates a derivative with respect to the new time scale and K = K e $^{-2}$, $^{-2}$ = e $^{-2}$, $^{(3)}$ R = $^{(3)}$ R e 2 $^{-2}$, E $^{-2}$ = E 2 $^{-2}$. The scalar eld equation becomes

In Bianchi universes except for Bianchi type IX, the three curvature is negative [17] i.e., we have

Now using the above inequality, it is evident from equation (13) that the constraint equation leads to the inequality $K^2 > 0$ i.e., K > 0 (i.e., it will expand for ever) if the space-time is initially expanding satisfying the constraint

In this paper we consider zero contribution for the dark energy. So, we have

for all time t. Moss and Sahni [19] rst extended Wald's idea for an anisotropic universe with cosm ological constant. To study the cosm ic no hair theorem with exponential potential, it is required to de nea term introduced by Wald [17] and subsequently for power law in ation by Kitada and Maeda [16]. Let us now de nea new term in the brane world scenario which is

U sing the inequality (17) it is found that K is always positive de nite. The time di er-

where $_{\rm iso}=\frac{6}{^{\sim 2}{\rm V}_{\rm o}}$, which is a constant, depends on the brane tension. On integrating the inequality (21) we get

where K $_{_{\odot}}$ = K (= $_{\odot})$ and K decays exponentially with respect to time .

The expansion rate of the universe is dom inated by the in aton energy density. The shear (\sim), and the three curvature ($^{(3)}$ R) are decreasing rapidly leading to vanishing magnitude. In particular, the decay in anisotropy leads to an isotropic and hom ogeneous space-time. It is observed that the new time coordinate depends on the scalar eld, or in other words the isotropization time scale depends on . To understand the isotropization in term of the cosmic time scale, the equations of motion are to be solved. As an isotropic power law in ation can be realized rapidly in the -time coordinate, one may estimate it using the isotropic attractor solution. For this we consider a power law solution given by

where a_0 ; o are constants and is to be determined. Sahni et al [15] shown that for a suitable choice of parameter values of the scalar eld potential, which is exponential, one

can realize power law in ation on the brane. The extra dimensions in the theory lead to in ation on the brane which however is not capable of sustaining in ation in GTR. We note that an isotropic power law in ation (a(t) = a_0 t²) is possible on the brane, which is due to the curvature term in the eld equations. The initial size of the universe is determined $a_0^2 = \frac{12}{\sim^2 V_0}$, when the potential energy of the in aton eld dominates in a closed model of the universe. It is evident from eq. (22) that

where is a positive constant which can be determ ined using (12) and (22). This implies that K , , $^{(3)}$ R varies as $\frac{t}{t_o}$ and K 2 / $\frac{t}{t_o}$. In the brane, the isotropization scale $^{(3)}$ is very small as $^{(2+)}$ 1 at a very high energy scale. In the low energy scale, $^{(3)}$ 1 o, thus compared to GTR isotropization takes place rapidly on the brane.

To conclude, it is found that the Bianchi universes (except type IX) perm it power law in ation with a scalar eld with exponential potential in the brane world. It is also noted that in the brane world scenario, the universe isotropizes faster than that in GTR.
