#### Abstract

$T$ he supersym $m$ etric quantum $m$ echanics of a two-dim ensional non-relativistic particle sub ject to extemalm agnetic and electric elds is studied in a super eld form ulation and with the typical non $m$ in im al coupling of $(2+1)$ dim ensions. B oth the $N=1$ and $N=2$ cases are contem plated and the introduction of the electric interaction is suitably analysed.

## In troduction

Since the pioneerinc ....... on supersym $m$ etric quantum $m$ echanics (SQM a great deal of work and book $\quad$ the researcn in the eld being stwactive. in parucular, a very usual question in this eld is the realization of supersym $m$ etry (SU SY) in quantum $m$ echanical system $s$ involving charged or neutral particles in interaction with m agnetic elds, in various space dim ensionalities. N ot related to SQM , however, it is a well-known fact that in (2. 1 arise and allow s for a $m$ agnetic $m$ om ent interaction even in the case of spin-zero particles (scalar $m$ atter elds). These tw o aspects, SQ M and non $m$ in im al coupling, have not yet been contem plated sim ultaneously in the literature, and so the present work is intended to address this problem.

Here, from the very beginning, a super eld form ulation is carried out that involves charged particles w ith m agnetic m om ent sub ject to extemal electric and m agnetic elds whose potentials are functions of the particle super eld coordinates. B oth $\mathrm{N}=1$ and $\mathrm{N}=2$ cases are considered.

A nother interesting question that rem ains open in the literature is whether an electric eld interaction $m$ ay be present w thout explicitly break UU SY . For N = 1SQM, the traditional answer is $n$ p.51], but here this question is also reassessed and II is show $n$ that, in a non $m$ inim alcoupling schem $e$, this indeed $m$ ay occur: an $N=1$ supersym $m$ etric quantum $m$ echanicalsystem isproposed, where the electric eld interaction appears along
$w$ ith the coupling betw een the $m$ agnetic dipole $m$ om ent and the $m$ agnetic eld. It is shown under which conditions in ay take place. In the case $N=2, W$ itten's m ode $\quad$ is the m ost celebrated and the one w ith m ore applications. The corresponding literature show s that an electric interaction (via a scalar potential) is possible $w$ thin such supersym $m$ etric $m$ odels, but it occurs only in each of the two sectors (bosonic' and 'eerm ionic') of the Ham iltonian: the two electric potentials (the bosonic ${ }^{\prime}$ and the 'ferm ionic'), although deriving from the same superpotential, have di erent expressions in tem s of it and thus do not refer sim ultaneously to the sam e particle, but rather refer to tw o alm ost isospectral system s (the alm ost' here refers to the ground state), typical of (unbroken) supersym $m$ etric system $s . O n$ the other hand, in the $\mathrm{N}=2-(\mathbb{N}=1$ imav ofP auliequation in tw $\circ$ (three) space dim ension the two sectors of the H am iltonian (the bosonlc' and the 'rem ionic' ones) refer to the two di erent spin states of the same spin $-1=2$ system. In the present work, a proposition is $m$ ade about the possibility of a supersym $m$ etric $P$ auli $H$ am iltonian in (2+1) dim ensions including electric interactions, with a non-m inim alcoupling.

It is worthw hile to stress here that the eld rede nitions above, though form ally acceptable, should not be used to elim inate physical e ects inherent to the nonm inim al coupling. Indeed, the latter describes a m agnetic dipole $m$ om ent even for scalar particles and $m$ ay lead to contact interactions.betw een the test particle and the eventual souroes of the electrom agnetic eld acting upon the particle. T he electrom agnetic eld, though non quantized, is not a xed background. It is generated by extemal sources and they $m$ ay induce interactions once the test particle is located in the region of the sources.
$T$ he non-m inim al coupling studied here $m$ ay be considered as resulting from the dim ensional reduction of a Lorem-Sim ons model in (3+1) dim ension derivative:

where is a constant (like q, a property of the particle), is the (Levi-C ivita) totally antisym $m$ etric tensor in $(3+1)$ dim ensions and $v$ is a xed (Lorentz-breaking)

Thus, choosing $v=(0 ; v)$ and $v=\left(0 ; 0 ; v^{3}\right)$, one immodiately veri es that the rede nitions stated in Eqs. are exactly recovered, $w$ ith the $(3+1)-$ dim ensional quantity $v^{3}$ playing the role of its $(2+1)-$ dim ensional counterpart $g$, and $w$ ith only the third ( $z$ ) com ponent of the ( $3+1$ )-dim ensionalm agnetic eld $B$ and the in-plane $(x ; y)$ components of the $(3+1)-$ dim ensional electric eld E contributing to the H am irtonian, just as it should be in (2+1) dim ensions.

In connection w ith planar physics, it voke the Quantum Hall E ect (QHE
and its fractional version ( $F Q H E$ ). Indeed, in ReI.
a parallel was $m$ ade between the particle $w$ ith charge $q$ and $m$ agnetic $m$ om ent $g$, as described here, and the c FQHF $\quad$ in which $g$ is associated to the CF magnetcic ux. H ow ever, $\quad$ m s of a 4-dim ensional theory w ith Lorentz violatio: the CF ux, g, contains a contribution from the parcicle itself by $m$ eans of the param eter ) and another one from the background vector, $v$, that breaks Lorentz sym $m$ etry. A $n$ interpretation is also possible for $w$ : it is responsible for the connem ent of the electrons to the plane and, therefore, it is natural to relate $v$ to the $z$-com ponent of the threedim ensional $m$ agnetic eld, which is very large in the FQHE ( 10 T ) and forbids the electrons to m ove in the z-direction, breaking in this $w$ ay their ( $3+1$ )-dim ensional Lorentz sym $m$ etry. Indeed, the construction of a CF is possible only in tw o space dim ensions.

N ow, if one w ishes to supersym m etrize this m odel, it is im portant to notice that this is not possible (in $\mathrm{N}=1$ SQM) for a scalar potontial interaction such as the one given by expression .Therefore, in order to keep invariance under $N=1-S U S Y$, it is necessary that:

The super eld form ulation of $W$ itten's ( $c$ $m$ ension, $N=2-) S Q M m$ ay be found in Refs in term sof a scalar supenpotential (a function oI the onedim ensional real supercoordinate). A genion to d space dim ensions is presented in Refs. also in term s of a scalar superpotential, but now as a function of d real super eld coordinates. A di erent approach to tw o space dim ensions, using a vector mpotential instead of a scalar one, is outlined in Ref but w ithout a super eld form ulation.
$T$ he $N=2-S Q M$ of $P$ auli equation in two space dim ensions is form ulated in term s of (com plen) chiral super eld coordinates in Refs. by $m$ eans of a (K ahler) super(pre)potential (a runction of those super eld coordinates). The introduction of an electric interaction into the planar $P$ auli equation out the explicit breaking of SU SY wasm ade in Ref
but there a n magnetic eld was consiaered. In Refs. the Pauli operator (including an extemal scalar potential) in two space dim ensions is identi ed w th the 22 com ponent of a total 44 super H am iltonian. A $\mathrm{n} \mathrm{N}=2$-super eld form ulation encom passing all these issues, viz., P auliequation in (2+1) dim ensions w ith electric interactions, and also considoring the planar non-m inim alcoupling studied in Sectio: is lacking. The present Section is devoted to ll this gap. N on-stationary situations are not considered in this paper, and so the electric interaction is due only to a scalar potential. A lso, the m entioned possibility of the P aulioperator to be a com ponent of the total super $H$ am iltonian will not be considered here, but rather it will alw ays be regarded as the total super-Ham iltonian itself.

It was show $n$ in Section that, in order to obtain the Schrodinger equation $w$ ith anon-m inim al coupling, it is necessary to add the term to the free H am iltonian,
and also to porform the replacem ent expressed by Eq Ifcondition is valid, then there is no scalar potencial interaction in the resulting $H$ am iltonian, which therefore becom es pure-m agnetic', allon one to derive it from the chiral superaction of $R$ ef. Such a superaction contains, instead of $\AA$ ( $\mathrm{x} ; \mathrm{y}$ ), the (real) K ahler prepotential K ( $x ; y$ ) (as will be seen below), which satis es the follow ing relations (from now on, $A_{i}$ stands for $\left.(\mathbb{A})_{i}\right)$ :

(note that this conclusion is valid independently wherner the coupling is $m$ inim alor non-m inim al).

It should be notioed that the extension from $\mathrm{N}=1$ to $N=2-S U S Y$ carried is simply due to a well-established resu: $N=2$ is the true SUSY of $(2+1)$-dim ensional pauli equation, in contrast to the $(3+1)$-dim ensional case, which is just $N=1$ supersym $m$ etric. $T$ herefore, this part of the present w ork should not be confused w the equ-lnoe between $\mathrm{N}=1-$ and $\mathrm{N}=2-\mathrm{SQ} \mathrm{M}$ as shown in Ref even for the (3+1)-dim ensionalP auliequation. In the latter case, the second supercharge is non-local (since it involves explicitly the parity operator). Indeed, a sensible question that rem ains to be investigated in detail is the transition from such a non-local supercharge of the (3+1)-dim ensional $P$ auli equation to a local one, when the dynam ics is restricted to be ( $2+1$ )-dim ensional; or, equivalently, when the ( $3+1$ )-dim ensionalm agnetic eld is considered to depend only on $x$ and $y$ and to be parallel to the $z$-axis (there is also a third possibility: when the $m$ agnetic old has a de nite xparity, B ( $)=$ B $(x)$; see R ef p.110] or Ref.

IV . D ISCUSSION AND CONCLUSIONS

Hom it has been shown the possibility, expressed by Eq. for SUSY to be kept even with an electric eld apprea, provided a non m inim al coupling schem e holds. $M$ oreover, since this work deals $w$ ith planar physics, it $m$ ay suggest -............ation to the quantum H all e ect $Q H E$ w as already pointed out in $K$ ef $\quad$ where a parallelw as $m$ ade betw een the particle with cnarge and $m$ agnetic $m o-$ $m$ ent as described in Sectio of Jain's m odel for the fractional Q H F
N ow, assum ing the validity of such a paralel, the present work brings a SU SY tothe system ofcom posite ferm ions. A nother result is Eq. a condition also obtained in eld theoretical works (w ith other interpretations) and which here guarantees the gyrom agnetic ratio to be equal to its standard value, tw o. All the calculations are $m$ ade in super eld form ulation.

The (pseudo-)classical extemal eld ${ }^{0}(z)$, although not quantized, must anticommute $w$ ith as well as w th itself. Therefore, it m ay be represented also by a 2 m atrix. These anticom $m$ utation requirem ents, how ever, im pose such severe restrictions on the $m$ atrix
${ }^{0}(z)$ that inder the quantization procedure $m$ ontioned in Section the contribution of the term s to the H am ittonian is zero. To bypass such an obstruction, it is reasonable to open the possibility of a di erent $m$ atrix representation for the $G$ rassm annian coordinates, and , and their corresponding m om enta. $N$ otioe that this interaction $m$ ixes the four com ponents of the wave function, contrary to the original H am itonian. The G rassm ann elds ${ }^{0}(z)$ and ${ }^{0}(z) m$ ay be interpreted as photino-type (pseudo-)classical extemal
elds, in the sam e way as the electrom agnetic prepotentialk ${ }^{0}(z ; z)$ (or the potentials and $\left.\overparen{A}\right)$ is usually considered as a photon-type classical extemal eld. The m otivation for adopting 4 -com ponent $w$ ave functions is sim ilar to $w$ hat happens in $(2+1) D$ eld theories $w$ th $m$ assive ferm ions, when one is forced to introduce 4-com ponent spinors, rather than 2 -com ponent ones, in order that the $m$ ass term be com patible $w$ ith parity sym m etry. This is a peculiar feature of planar theories.
