# C onform al Field Theory at central charge c = 0 and Two-D im ensional Critical System s with Quenched D isorder

W e exam ine two-dimensional conformal eld theories (CFTs) at central charge c = 0. These arise typically in the description of critical systems with quenched disorder, but also in other contexts including dilute self-avoiding polymers and percolation. We show that such CFTs must in general possess, in addition to their stress energy tensor T(z), an extra eld whose holom orphic part, t(z), has conform alweight two. The singular part of the Operator Product Expansion (OPE) between T(z) and t(z) is uniquely xed up to a single number b, dening a new `anomaly' which is a characteristic of any c = 0 CFT, and which may be used to distinguish between di erent such CFTs. The extra eld t(z) is not primary (unless b = 0), and is a so-called logarithm ic operator except in special cases which include a ne (K ac{M oody) Lie-super current algebras. The num berb controls the question of whether V irasoro null-vectors arising at certain conform alweights contained in the c = 0 K ac table m ay be set to zero or not, in these nonunitary theories. This has, in the fam iliar manner, in plications on the existence of di erential equations satis ed by conform alblocks involving prim ary operators with K ac-table dimensions. It is shown that c = 0 theories where t(z)is logarithm ic, contain, besides T and t, additional elds with conform alweight two. If the latter are a ferm ionic pair, the OPEs between the holom orphic parts of all these conform al weight-two operators are autom atically covariant under a global U (11) supersymmetry. A full extension of the V irasoro algebra by the Laurent modes of these extra conform alweight-two elds, including t(z), remains an interesting question for future work.

### I. IN TRODUCTION

In the last four decades rem arkable progress has been m ade in our understanding of second order phase transitions. Beginning with the scaling hypothesis put forward in the sixties and continuing with the subsequent development of the renorm alization group m ethods, m any questions regarding the properties of m atter in the vicinity of critical points have been thoroughly answered. A further m ilestone was set in 1984 with the developm ent of conform al eld theory (CFT) by A.A.Belavin, A.M. Polyakov and A.B.Zam olodchikov [1, 2]. Indeed, the methods of CFT provided access, in a completely nonperturbative manner, to a vast variety of problem s involving second order phase transitions of classical statistical mechanics in two dimensions. The various exact solutions can be classi ed, and in part distinguished, by a param eter called central charge c. Physically the central charge m easures the response of a scale invariant (or critical) eld theory in two dimensions to a change of the geometry of the space on which it lives. Equivalently, the central charge is universally related to the coe cient of the length dependence of the ground state (or Casim ir) energy of a critical (1 + 1)-dimensional relativistic eld theory living on a space of nite length L with periodic boundary conditions, i.e. where space-time is a cylinder. (These results are due to W.J.Blote, J.L.Cardy and M.P.Nightingale [3] and simultaneously I.A eck [4].)

Once the central charge c of a given critical physical system is known, the techniques of CFT m ake it possible, in m any in portant cases, to calculate exactly all its correlation functions in a quite straightforward way [1, 2]. At the same time, nding the central charge of a given system may not be entirely obvious. In some cases the central charge can be obtained by elementary computation. This is the case for example for the Ising model, whose central charge c = 1=2 can be obtained using the free M a prana ferm ion representation. In other cases, the central charge of a system can be found from symmetry analyses, as is the case e.g. for Wess-Zumino-Witten (WZW) models[2, 5], which have found many applications in Condensed Matter Physics, including e.g. one-dimensional Quantum Spin Chains [6], the K ondo e ect[7], topologicalQ uantum C om putation [8], and m any others. If not known analytically, the central charge of a given system can also be determ ined num erically, using the nite size scaling methods mentioned above.

However, there exists a class of problem s where knowing the central charge tells us close to nothing about the solution of the CFT. These are problem s where second order phase transitions happen (in two dimensions) in the presence of quenched disorder. Critical eld theories describing such problem s can be shown to typically have vanishing central charge, c = 0. It turns out, unlike in the case of their pure (i.e. disorderless) counterparts which have  $c \in 0$ , that the know ledge of their central charge c = 0 does not contribute much to the solution of these theories. Indeed, there is a large variety of CFT s with vanishing central charge, each of which corresponds to a di erent critical point. And with very few exceptions little is known about these theories.

These theories arise for example in the description of disordered electronic system s.[45] Consider a quantum mechanical particle moving in a random potential in d dimensions. The system is described by a Ham iltonian

where x denotes d-dimensional space, and V (x) is a random, time-independent potential. When describing universal critical properties, the latter m ay offen be taken, without loss of generality, to have a probability distribution which is a short-ranged G aussian with zero m ean

where h:::i denotes the average over all con gurations of the disorder potential V (x).

All relevant information concerning the motion of a quantum particle can be extracted from its (advanced or retarded) G reen's functions [46]

These can be calculated with the help of the following Gaussian functional integral, involving a complex [47] scalar eld (x); (x)

where d is the dimensionality of space, and Z is the partition function Ζ

The plus or m inus sign in the exponential is chosen to insure convergence. A though this maps the problem of a G reen's function of a quantum particle moving in a random potential into a correlation function of a eld theory, this eld theory is intractable, as written. Indeed, the correlation function has to be computed for any arbitrary random function V (x), and the corresponding eld theory is not even translationally invariant. If, how ever, we concentrate on computing G reen's functions which are averaged over all disorder con gurations V (x), further progress is possible. It is not practical, of course, to average (4) over random V (x) directly, because of the factor 1=Z in (4), where the 'partition function' Z is itself a random variable. Instead, one can employ one of the following two 'tricks', commonly referred to as 'replica'- and 'supersymmetry tricks'. In the present paper we concentrate mostly on the supersymmetry trick, which involves rewriting the denominator of (4) as a functional integral over anticommuting (G rassmann) variables

The total partition function is unity, because the ferm ionic and bosonic contributions to it cancel. Now averaging over the random potential becomes possible with the help of the standard G aussian identity

In sum m ary, the problem of computing an averaged G reen's function of a quantum m echanical particle in a random potential in d dimensional space, has been m apped into a problem of computing a correlation function in a d-dimensional eld theory of interacting bosonic and ferm ionic degrees of freedom. As we already m entioned, (8) is often referred to as the supersymmetry (SUSY) approach to disordered system s.[48]

Theories of this kind have been extensively studied in the literature [9], using a variety of techniques in various dimensionalities. Progress in accessing critical properties can sometimes be made if a small parameter is available, such as for example in the d = 2 + expansion. The topic of this paper is two-dimensional physics, and here a small parameter is typically unavailable. A coordingly, one needs to rely on nonperturbative techniques, and CFT is expected to provide such tools. To be specific, let us discuss in a little more detail a specific disordered two-dimensional electronic system known to possess a critical point. Consider a quantum mechanical particle moving in a plane (coordinate x) in the presence of a perpendicular constant magnetic eld and in a random potential V (x). In order to write down an elective eld theory for this problem, we proceed as above, but now choosing H<sub>0</sub> to be the H am iltonian for a free particle in d = 2 dimensions, moving in a constant magnetic eld

where 1 is the magnetic length.

It also turns out that the disorder averaged G reen's function hG (E) i, as in Eq. (8), does not exhibit any critical behavior whatsoever, in this, and in the other problem s discussed above. It decays exponentially on distances larger than the particle's m ean free path. How ever, the average of the advanced/retarded product

can be critical[10]. Such a product can also be cast into the form of a correlation function in a eld theory if only one chooses two independent functional integral representations such as (6) for the two G reen's functions involved in the product, subject to the same disorder potential, and then averages over disorder V (x). The resulting eld theory is similar to (8) but contains two copies of each of the two basic elds (bosonic) and (ferm ionic). As the parameter E (energy) is adjusted, the resulting eld theory goes through a critical point, called the Integer Q uantum Hall plateau transition. This transition is experimentally observed [49] in the Integer Quantum HallE ect (see e.g. [12, 13]). Even though much is known from num erical work [14] about the critical properties [50] of this transition (in the absence of interactions), and even though a theoretical description in terms of a nonlinear sigm a model with topological term [15, 16] was given a long time ago, an analytical solution of the transition has been lacking for, by now, about two decades. As already mentioned, this is due to the fact that this problem lacks a small parameter, and a genuinely nonperturbative approach is unavoidable; conform al eld theory is expected to provide such a nonperturbative tool. Nevertheless, CFT techniques have not yielded a solution to this problem, to date. This is due to certain technical' di culties which CFTs, aim ed at describing disordered critical points, present. It is because of these di culties' that exact, nonperturbative solutions of the in nite number of constraints in posed by the conform al symmetry group, have not been forthcoming as readily as was the case in pure (i.e. nonrandom) critical theories[1]. Some of these di culties are the subject of this paper.

Even though an analytical solution of the Integer Q uantum H all plateau transition is still lacking as of today, it has been possible, fairly recently, to nd an analytical solution of the rather sim ilar (but not identical) problem of the so-called Spin Q uantum H all E ect (SQ H E) plateau transition [17]. The resulting theory is a supersymmetric form ulation of the 2D percolation problem .51] Percolation and the problem of dilute self-avoiding walks, in fact, are two of the best understood disordered systems in two dimensions. In spite of this, the nature of their CFT, including for example multi-point correlation functions, is quite poorly understood [19]. Both systems have central charge c = 0, and we will describe aspects of their CFT below. Because the self-avoiding polymer problem is (in a form al sense) closely related to our form ulation of particle localization in (9), let us describe this now in some detail. The statistics of self-avoiding dilute polymer chains in d dimensions can be described by the following SUSY Landau {G inzburg action [52] due to Parisi and Sourlas[20]

with  $H_0$  as in (1) with h = m = 1. Note that, in contrast to the problem of the motion of a quantum particle, described by the theory (9), the 'convergence factors' i have disappeared, and it turns out that the analog of the 'single-particle G reen's function',

now exhibits critical behavior (has power-law decay, at E = 0) and characterizes the statistics of a polymer chain with end points xed at positions x and y.

As was already mentioned, conform all eld theories describing disordered critical points in 2D typically have central charge c = 0. Indeed, as emphasized below (7), these theories are constructed in such a way that their partition function is always exactly equal to unity,

as a consequence of exact cancellation of bosonic and ferm ionic integrals. The free energy is therefore exactly zero. This is also true when the theory is de ned on a cylinder. Hence the central charge vanishes.

Let us end our introductory rem arks by brie y m entioning the so-called replica approach to disordered system s[21]. This involves introducing, before taking the average over disorder realizations, several copies of, say, the commuting eld , ( = 1; :::;n), instead of introducing the anticommuting eld , and then taking the number n of copies to zero (n ! 0) (Bosonic Replicas'). (A n equivalent form ulation can be obtained by using n copies of the anticommuting (G rassmann) eld, and no commuting elds (Fermionic Replicas').) For example, introducing Bosonic replicas in (4),

which describes the G reen's function of a particle moving in a random potential, and perform ing the average over disorder, one easily nds that the following functional integral can be used as an alternative to (8),

where the 'replicated action'  $S_r(n)$  is given by

Calculating the Green's function (13) now involves doing the functional integral at arbitrary integer n and then analytically continuing the answer to n ! 0. In fact, the same comments as those given after (10) in the SUSY context apply here, and a duplication of the so-far introduced variables is required for the quantum particle in a random potential, but we refrain here from writing out the details. (The low energy e ective theories are in fact nonlinear sigm a models[10], both in the replica and the SUSY descriptions.)

The replica method is easily used in perturbative calculations, where the number n of copies typically appears in the form of a polynomial in n, in any order in perturbation theory. This is easily, and unambiguously, continued to n ! 0. In the context of a nonperturbative analysis, one would, at least naively, need a critical theory for all (large) integer values of n, each of which would have a central charge c(n). This may (but typically will not uniquely) determ ine an analytic continuation into n ! 0. Such an approach is known not to be feasible for the 2D theory describing the Integer Q uantum H all plateau transition discussed above. On the other hand, the dilute self-avoiding polymer problem is known to be described (in any dimensionality d), due to P.G. deG ennes [2], as the n ! 0 lim it of the replica analog [53] of the SUSY action (11). In d = 2 dimensions, a number of properties of this replica action can be obtained exactly [23, 24] in the continuous range 2 n + 2 of the parameter n, and this model is offen referred to as the 0 (n) m odel. A similar analysis and corresponding results exist also for the 2D q-state Potts m odel in the continuous parameter range 0 q 4. The q ! 1 lim it of the q-state Potts is known [25] to describe percolation.

A lthough the SUSY technique is better controlled than the replica approach, it is limited to non-interacting random system s. This is because the SUSY technique is based crucially on the ability to represent the inverse partition function, such as (5), in terms of a ferm ionic functional integral. This is only possible if the original problem without disorder did not contain interactions (non-G aussian terms). A much-studied example of a disordered classical 2D statistical mechanics system which is interacting is provided by the random -bond q-state Potts model. It can be analyzed [26] with the help of the replica trick in an expansion in (q 2) about the Ising case (q = 2).

This paper contains attempts by the authors to understand in more detail conformal eld theories at central charge c = 0. Our prime motivation arises from the desire to understand better the structure of CFT underlying twodimensional disordered critical points. There is a signi cant number of such critical points which are of great physical interest but which are typically poorly understood. (Some have been mentioned above.) In particular, we give here a pedagogical and detailed exposition of results which appeared earlier in Ref. [27], but we also present a variety of new, so-far unpublished results.

Speci cally, we review certain unusual features, which distinguish c = 0 conform all theories from ordinary, say unitary CFTs. One of the most dramatic such features is the indecom posability, or 'logarithmic' structure which typically (except in certain special cases, including a ne current algebras) appears in the identity representation of the V irasoro algebra at c = 0. This manifests itself through the appearance of a so-called 'logarithm ic partner' t(z)of the stress energy tensor. M oreover, c = 0 CFT s possess a novel 'anom aly' number sometimes denoted by b, which plays, in some sense, a role similar to the central charge in  $c \in 0$  theories: the parameter bm ay be used to distinguish di erent c = 0 theories. These general properties of a c = 0 CFT are discussed in Section II, where we also motivate and derive the fundamental OPE between the (ordinary) stress tensor and its logarithm ic partner.

An important role is offen played in CFT by so-called null-vectors (or: singular vectors). These are V irasono descendants which are them selves prim ary. They are known to occur when prim ary operators have conform alw eights contained in the K actable (here at c = 0). It is important to know if such a null-vector can be set to zero, because in that case correlation functions involving the K actable operator will satisfy di erential equations, which m akes them easily computable. W hile in an ordinary (unitary) CFT null-vectors are always set to zero, this is not necessarily the case in a nonunitary theory, like a c = 0 CFT.

In Section III we make a connection between the 'anomaly' number b and Kac null-vectors. Interestingly, the number b controls the question as to whether certain Kac-table null-vectors vanish identically or not, and hence whether certain correlation functions satisfy the corresponding di erential equations. We discuss the cases of Kac-table operators with nonvanishing two-point functions, rst those with nonvanishing, and subsequently those with vanishing conform alweights.

In Section IV we review aspects of critical disordered systems described by the supersymmetry method. In these theories, a partner of the stress tensor, of the kind that appeared in Section II entirely from considerations of conform al symmetry, emerges naturally on grounds of supersymmetry. Moreover, a pair of conform al weight-two ferm ionic operators appears together with the stress tensor and its partner in the same supersymmetry multiplet.

In Section V we show that based purely on conform al sym m etry considerations, there m ust exist additional eds, besides the stress tensor T (z) and its partner t(z), whose holom orphic parts have conform alweight two, if t(z) is logarithm ic'. Under the only assumption that these additional eds form a ferm ionic (anticom m uting) pair, we show that the (holom orphic) OPEs between all these weight-two eds are autom atically covariant under a global U (1jl) SUSY.

W e end the main part of the paper by comments and speculations about a possible extended chiral symmetry in c = 0 CFT, based on the notions developed here.

Three appendices provide a number of technical details. We show in Appendix A that the anomaly number bm ust be unique in a given theory (as discussed at the beginning of Subsection IIIA). Appendix B addresses details of the computation of the OPE of descendant operators in the c = 0 CFT possessing the logarithm ic features discussed in this paper. We also demonstrate in Section VIB.9 the complete subtraction of logarithm s to all orders in the OPE (70). Appendix C addresses certain details referring to the footnote below (52) in Subsection IIIA.

#### II. CONFORMALFIELD THEORY AT C = 0

#### A. c! 0 catastrophe

Conform all eld theories (CFTs) with central charge c = 0 are very di erent from those with  $c \notin 0$ . Consider a CFT with central charge c and a prim ary scalar operator A (z;z) with left/right conform alweights (h;h), h = h, and nonvanishing [54] two-point function. We choose to consider operators whose two-point functions are norm alized to unity, [55]

The operator product expansion (OPE) of this operator with its conjugate is known [28] to be given by

where T (z), and T (z) are the holom orphic and antiholom orphic components of the stress-energy tensor of the theory. Here, bther primaries' denotes possible contributions to the OPE from primary operators other than the identity operator. From now on, in the rest of this paper, we will focus entirely, as is custom ary, on the holom orphic dependence, with the understanding that a suitable 'gluing' with the antiholom orphic dependence has to be perform ed at the end to obtain bulk correlation functions. W ith this understanding, we write the OPE (16) as

where A(z) denotes in the usual way the 'chiral (holom orphic) part' of the operator A(z;z).

This result, well known and general, cannot hold true in a CFT with vanishing central charge. Indeed, a direct limit c! 0 in (17) is not possible. We call the 1=c divergence in (17) a c! 0 catastrophe.

To understand one way [56] how this catastrophe can get resolved [29], let us rst consider the following example. Take a combination of two non-interacting CFTs, one with central charge b, and one with central charge b. We call their respective stress-energy tensors  $T_b(z)$  and  $T_b(z)$  which satisfy the well known OPEs

where prime denotes the derivative @=@z. The total stress-energy tensor is  $T(z) = T_b(z) + T_b(z)$  and the total central charge c = b + (b) = 0.

A prim ary operator A (z) of such a factorized theory would also be a product of two operators, one in the theory with positive central charge, and the other in the opposite theory. The OPE of such an operator with its conjugate can easily be found from (17),

The problem of c! 0 is now resolved, but the resolution did not come for free. We now have to introduce a new eld

with conform alweight = 2, which is di erent from the stress-energy tensor T (z) =  $T_b(z) + T_b(z)$  of the system. This eld will now always appear in such OPEs in the form

Continuing with our factorized theory, all OPEs between the elds T (z) and t(z) are easily computed from those of the factors given in (18),

Note that the rst equation rem inds us of the fact that at central charge c = 0 the stress tensor T (z) is a primary eld with vanishing two-point function.

W e would now like to generalize this analysis to theories which no longer factorize into two non-interacting theories with equal and opposite central charges. Based on our discussion to be given below, we suggest that in any c = 0 CFT a eld of conform alweight two, which we also denote again by t(z), appears and that it enters the OPEs of prim ary operators with nonvanishing two-point function as in (20), thus resolving the c! 0 catastrophe. It follows from (20) that  $L_2t = b$  (see e.g. (B 10) and (B 58) of Appendix B), which we sthe leading term in the OPE of T (z) with t(0) to be:

However, as far as the next order term s in this OPE are concerned, they m ay or m ay not coincide with the expansion given in (22). This is discussed in depth below in (34).

A relatively large class of nontrivial theories realizing the (hongeneralized') OPEs (20), (22), (23) are a ne (or: K ac{M oody) current algebras with supergroup (or: Lie superalgebra') sym metry, having central charge c = 0. One can show that a pair of chiral elds t(z;z) = t(z) and t(z;z) = t(z) with the properties discussed above, always appears in these theories[29]. These can be found as expressions quadratic in (N oether) currents, and transform under the supergroup sym metry as the 'top com ponent' of an indecom posable multiplet of stress-energy tensors (w e w ill discuss such multiplets in more detail in Section (V) below). The eld t(z) appears on the right-hand side of various OPEs such as e.g. (20), and obeys (22), (23). The number b' becomes a property of the particular a ne (K ac{M oody}) current algebra.

However observe that, if t(z) satis es Eqs. (20), (22), and (23), the algebra which T and t form becomes trivial, in the following sense. Indeed, by reversing the arguments given above, we can choose

to re-diagonalize these equations and bring them into the form of two independent (commuting) V irasoro algebras, with central charges b and b, respectively. From this point of view, a ne (K ac{M oody) Lie-superalgebras with c = 0 are nothing but tensor products of two non-interacting CFT s with equal and opposite central charges.

Quite remarkably, however, the OPEs (20), (22) and (23) are but a special case of a more general set of OPEs at c = 0, to be given in (30), (35) and (38) below. We will now proceed to study theories with this more general form of OPE.




FIG.1: Some of the rst few operators of the K actable at c = 0

#### B. Logarithm ic partner t(z) of the stress tensor T (z)

A special set of prim ary operators, the so-called K ac-degenerate operators, have conform alweights which lie on a two-dimensional grid, usually referred to as the K ac table. It is well known that in conventional CFTs chiral (= holomorphic) correlation functions involving at least one such K ac-degenerate' operator satisfy [57] certain di erential equations [1]. Solving such di erential equations for the (chiral) four-point functions (conform alblocks), provides a way to not the OPEs of prim ary operators. For further reference we provide in Fig.1 a list of the rst few operators of the K ac table at c = 0.

M oreover, it is well known [1] that, due to global conform al invariance, the (chiral) four-point function of a primary operator [58] can be expressed in terms of a single function F(x),

Consider the ordinary dimensial equation for the function F(x), associated with an operator A belonging to the K actable.

In conventional CFTs (which have  $c \in 0$ ), there is one solution of that equation which is of the form

(with some constant  $_0$ ) corresponding to the OPE (17). The function F (x) with this expansion is usually referred to as the identity conform alblock of the chiral four-point function given in (26).

The situation at c = 0 is farm one complex, however. By investigating the corresponding di erential equation, it can be directly veried that for all the operators from the rst two rows or from the rst column of the Kac table in Fig.1 (except for those with vanishing conform alweight, discussed separately below), the small-x behavior of the identity conform alblock is

in contrast to (28). It turns out that the other operators of the K ac table, which lie deeper in its interior (i.e. beyond the rst two rows or the rst column), have even m ore complicated identity conform alblocks [31]. W e will not consider them in this paper, how ever.

The appearance of logarithms in a correlation function at a critical point, as on the right-hand side of (29), is characteristic of theories with so-called logarithm ic operators [32]. In this particular case, the relevant logarithm ic operator has conform alweight two, the same weight as that of the stress tensor T (z). Based on these considerations

we are led to suggest the following contribution to the identity operator appearing in the OPE between any two primary operators with nonvanishing two-point function, [59]

where the ellipsis denotes higher descendants of the identity operator, and 'other prim aries' denotes contributions to this OPE from operators other than the identity. This OPE generalizes Eq. (20). (For more details about the structure of this OPE see Sections (VIB.1) and (VIB.6) of Appendix B.)

In order to understand why an OPE of this kind would give rise to the logarithms in the conform alblock (29), rst recall[32, 33] that, in general, two (quasiprimary[1]) operators C (z) and D (z) of conform alweight h are said to form a logarithm ic pair, if the dilation operator  $L_0$  does not act diagonally, but in Jordan block' form, i.e.

G lobal conform al invariance then enforces the following form of the two-point functions:

Once the normalization of the operator C is given, the normalization of the operator D has been xed by requiring the appearance of the same coe cient  $a_1$  in the second and in the third equation. The arbitrary constant  $a_0$  arises from the freedom to rede ne the operator D by addition of C with an arbitrary coe cient, without changing the OPE's above.

The (quasiprimary) operators T (z) and t(z) appearing in (30) form precisely such a logarithm ic pair, as we will see in (36) below. One now veries immediately, upon identifying C ! T; D ! t; h ! 2; a<sub>1</sub> ! b, that the OPE (30) leads to the logarithm in the small-x expansion (29) of the identity conform alblock of the chiral four-point function upon using (32) (here we consider  $A^{y} = A$  for simplicity). Furtherm ore, the coe cient in (29) is then xed to be

The operator t(z) we introduced in this manner in (30) fulls the same role as the operator t(z) in (20) of the previous section. It makes sure the limit c! = 0 in (17) makes sense. However at the same time, it is also responsible for the logarithm s in (29), and therefore it is a logarithm ic operator. An OPE between the c = 0 stress tensor T (z) and the new operator t(z), which generalizes (22), and which causes (T (z);t(z)) to become a logarithm ic pair', is (as we will see shortly)

where the parameter is arbitrary. = 0 corresponds to the previous, honlogarithm ic OPE' (22), which in plies (23), and this can be re-diagonalized as in the previous Section. On the other hand, nonzero corresponds to a new, logarithm ic OPE', as we now explain. First, when  $\notin$  0, we can rede net(z) and b by dividing by and arrive at [60]

This OPE generalizes the OPE (22) derived for the special (factorized) situation considered in the previous Section. The OPE (35) xes the following set of (holom orphic) two-point correlation functions (compare with (32), recalling

that the norm alization of the stress tensor T (z) is xed),

The rst of these equations comes from the OPE (21) which remains unchanged, independent of whether t(z) satis es the previously discussed hon-logarithm ic'OPE Eq. (22), or its logarithm ic' generalization (35) which we are currently considering. The second equation follows directly from the OPE (35), while the third equation can be computed by im posing global conform al invariance on ht(z)t(0) i (see Appendix A form ore details). Hence, the logarithm ic OPE' in (35) is directly responsible for the logarithm appearing in the third of (36), and thereby, for the logarithm in the conform alblock (29).

As mentioned above, the constant remains undetermined. The occurrence of such undetermined constants is comm on in the theory of logarithm ic operators [32, 33], and is related to the fact that t(z) can be rede ned as in

with an arbitrary coe cient . This rede nition does not a ect any of the OPEs discussed in this Section.

W ith a logarithm ic operator t(z) satisfying (35) the theory is no longer equivalent to two commuting V irasono algebras at  $c \in 0$  (the last of (36) is an obstruction to the diagonalization performed in (25)). On the other hand, (35) is the most general OPE which a conform alweight-two (quasiprimary) operator t(z) with  $L_2t = b$  can satisfy (recall the footnote preceding Eq. (35)). Therefore, we postulate that (35) is realized in all CFTs with central charge c = 0, except for those which simply factorize as in Subsection (IIA).

Finally, once the OPE (35) between t and T is known, it is possible to construct (the contribution of the identity operator to) the OPE of twith itself, which generalizes (23). We can do this by taking the most singular term of this OPE from the correlation function ht(z)t(0) i computed in (36). This function contains an ambiguity related to the possibility to rede net(z) according to (37). In what follows, we x this ambiguity by setting = 0 in (36). The most singular term entails all other terms of the OPE, which becomes

where the ellipsis denotes higher order term s, as well as contributions from prim ary operators other than the identity operator. The technique for reconstructing entire OPEs such as (38) from their most singular terms is well known and is described in Ref. [1], although its application to the theory with logarithm s has not often been discussed in the literature. Brie y, it consists of the following steps (m ore details can be found in Appendix B, especially Sections VIB.4 and VIB.8). First we have to derive the commutation relations between the V irasoro generators  $L_n$  and t, from (35). This yields

Then we apply  $L_n$  with n 0 to (38). On one hand,  $L_n$  can be applied to the right-hand side of (38) directly. On the other hand, we can use

on the left-hand side, substitute (39) into this expression, and use the OPEst(z)t(0) and T (z)t(0) to nd relationships between various terms in (38). Ultimately, this allows us to deduce, order by order in z, all the terms in (38) from its most singular term.

Equation (38) xes the OPE t(z)t(0) up to contributions of other prim ary operators. T (z) is a prim ary operator at c = 0 and, since it already appears in Eq. (38), we can expect on general grounds that there could be a 'stand alone' contribution of the conform alblock of the stress tensor to this OPE. This amounts to

being added to the right-hand side of Eq. (38) where a is an arbitrary coe cient. This was recently stressed by I. K ogan and A.N ichols [34]. A dditionally, one could im agine that in speci cc = 0 CFTs which realize the logarithm ic operator t(z), there could be contributions from other prim ary operators on the right-hand side of Eq. (38) (as already mentioned). These, how ever, will play no further role in this paper, until we arrive at Subsection (V B).

As we saw in the Introduction, in certain cases it is possible to think of a c = 0 CFT as a lim it of a continuous set of CFT s parametrized by a parameter n, de ned in an interval containing n = 0, where the central charge  $c(n) \notin 0$  if  $n \notin 0$ , and c(0) = 0. In that case, we could ask how a partner t(z) of the stress tensor can appear in the lim it n ! 0,

while it is de nitely not present in the theory at  $n \in 0$ . The answer to that question was given by J.L.Cardy in Ref. [30, 35].

W e sum marize by saying that the OPEs (35) and (38), together with the OPE of the stress tensor T (z) with itself (which is unmodi ed, and as in (21)) constitute the fundam ental equations of a CFT at central charge c = 0, which does not factorize as in Subsection (IIA).

# III. IM PLICATIONS OF THE LOGAR ITHM IC T (Z ) AND CORRESPONDING B ON C = 0 KAC-TABLE OPERATORS W ITH NONVANISHING TWO-POINT FUNCTIONS

In this section we study the implications of the 'anomaly' number b for null-vectors, associated with primary operators which have conform alweights listed in the c = 0 K ac table, and nonvanishing two-point functions.[61] For ordinary (e.g. unitary) CFTs there is no issue, because the null-vectors are known to vanish when inserted into any (chiral) correlation function with other operators[1]. This step is no longer guaranteed to be valid for the nonunitary theories discussed here. In the rst part, Subsection IIIA, we demonstrate how the 'anomaly' number b controls this issue, for primary operators with certain nonvanishing K ac-table weights (and non-vanishing two-point functions). In the second part, Subsection IIIB, we discuss sim ilar statements for K ac-table operators with vanishing conform al weight (and nonvanishing two-point functions). A convenient tool used in both subsections to address these questions in a purely algebraic way, is a (partial) extension of the V irasoro algebra by suitably de ned Laurent modes of the logarithm ic partner t(z) of the stress tensor.

A. Operators with nonvanishing dim ensions

In view of the relation (33)

$$=\frac{h^2}{b}$$

it may appear, at st sight, that a separate, and possibly di erent value of the parameter b could be associated with di erent c = 0 primary operators A (z). This would mean, that a given theory would contain two (or more) di erent values of b, say  $b \in b^0$ . But this would imply that there would exist two (or more) di erent operators t(z), say  $t_b(z)$  and  $t_{b^0}(z)$ , each obeying the OPE (35) with the coe cient of the corresponding  $1=z^4$  term equal to b and  $b^0$ , respectively. Then it is not di cult to see that the correlator  $ht_b(z)t_{b^0}(0)$  i violates global conform al invariance. (D etails are given in Appendix A.) This means that di erent values of b cannot coexist in the same theory, and that b is a characteristic of any c = 0 CFT. Therefore, the question arises what value the num ber b takes in a given theory, and what conditions b imposes on the properties of the c = 0 CFT. This is the question we address in this Section.

We begin by considering a c = 0 theory containing in its operator content one or more primary operators whose conform alweight appears in the Kac table. If we were to assume that the corresponding null-vector, implied by the Kac-table conform alweight, can be set itself to zero, [62] then any (chiral) four-point function (conform alblock) involving this operator would satisfy a di erential equation. For any primary operator with Kac-table conform al weight (and nonvanishing two-point function) it would hence be possible to extract the coe cient appearing in (29) from the solution of the corresponding di erential equations for F (x) (see (26)). Therefore, in view of (33), this associates a value of b with any such Kac-table operator.

In the following, we will obtain a purely algebraic way of associating a number b with operators in the c = 0 K actable which have nonvanishing two-point function, without explicitly referring to the corresponding di erential equation, or its solutions. Interestingly, we not that di erent values of b appear in the c = 0 K actable. For example, operators in the rst two rows of the K actable have b = +5=6, whereas operators in the rst column have b = -5=8 (see (55) below).

Since the value of the number b is unique in a given theory (as per our discussion at the beginning of this section), this implies that only those K ac-table operators which have a given xed value of b can give rise to di erential equations in a given theory.

In order to arrive at our algebraic determ ination of b for operators with conform alweights contained in the c = 0 K ac table, we will rst establish the OPE between t(z), and an arbitrary primary operator  $A_h$  (z) of conform alweight  $h \in 0$  and nonvanishing two-point function.

We start by determining the three-point correlation functions involving these operators. It is well known that the three-point correlation functions are completely determined by global conform al invariance. By imposing global conform al invariance on  $ht(z)A_h(w_1)A_h(w_2)$  i one readily nds

$$ht(z)A_{h}(w_{1})A_{h}(w_{2})i = \frac{h \log \frac{w_{1} w_{2}}{(z w_{1})(z w_{2})} +}{(z w_{1})^{2}(z w_{2})^{2}(w_{1} w_{2})^{2h-2}}:$$

The coe cient is arbitrary and is not xed by conform al invariance. In what follows we set = 0, which am ounts to rede ning t(z) as in (37) in a suitable way. (Notice that this would not be possible for operators  $A_h$  with vanishing conform alweight, h = 0. Therefore we consider for now only operators  $A_h$  with nonvanishing conform alweight.) Now consider expanding the three-point function (41) for sm all ( $z_1 w_1$ ). One immediately sees that the term multiplying log ( $z_1 w_1$ ) is precisely equal to  $< T(z)A_h(w_1)A_h(w_2) > .$  Moreover, an additional power series in ( $z w_1$ ) appears which does not multiply log ( $z_1 w_1$ ). All this is consistent with the following OPE,

$$t(z)A_{h}(0) = T(z)A_{h}(0)\log(z) + \sum_{n=0}^{X^{1}} A_{h}(0)z^{n-2} + \langle (z);$$
(42)

where potential noninteger powers of the variable z (but no logarithm s) are collected in a 'remainder' denoted by < (z). This can be viewed as a de nition of the operators '  ${}_{n}A_{h}$  (0). Furtherm ore, if the operator  $A_{h}$  is replaced by a more general (e.g. nonprim ary) operator, negative powers of the index n m ay appear in the OPE (42).

A lternatively, the action of the operators n on the operator  $A_h$  (0) can be computed as usual by contour integration from (42),

where  $\hat{P}_h$  is the projection operator on all states of the H ilbert space of the CFT whose conform alweights di er from the weight h of the operator  $A_h$  (0) by an integer (this projection operator commutes with the operator T (z); see e.g. (B.39)).

Form ula (43), together with the de nition of the conventional V irasoro generators

allow sus to nd the commutation relation  $[n;L_m]$  in the familiar manner from the OPE (35). The result is

It constitutes a (partial) generalization of the commutation relations of the V irasoro algebra, which are given at c = 0 by

for prim ary operators  $A_h$  with nonvanishing two-point function. First, it clearly follows from the OPE (42) that this is true for n > 0. Moreover, we can choose a denition of the operator t(z) so that  $O_A_h(0) = 0$ ; indeed, since t(z) is dened up to addition of T (z) as in (37), n is also dened up to addition of  $L_n$ , as in (37). By adding  $L_0$  to O with a suitable coecient, we can always [63] make  $O_A_h(0)$  vanish as long as  $h = L_0A_h(0) \in 0$ . From now on we assume that we have chosen t(z) in this way, while we consider the operator  $A_h(z)$ .

U sing the new ly derived com m utators (45), the ordinary V irasoro algebra (46), as well as (47), one nds that

Therefore,  $\begin{pmatrix} 1 & \frac{1}{2}L_1 \end{pmatrix}$  is an be called a null-vector, following Ref. [1]. Indeed, from now on we will set this null-vector to zero, i.e.

which is easily seen to be consistent with the correlation function (41). Moreover, this is also consistent with the general constraints of conform all symmetry in posed on the OPE (42) (see e.g. Section VIB.7 of Appendix B).

Any primary operator whose conformal weight appears in the K actable has descendants which are them selves null-vectors. Speci cally, this means that there exist states j i, constructed by applying V irasoro low ering operators L<sub>m</sub> (m > 0), to the primary state  $A_h$  jDi, so that  $L_n$  j i = 0, for all n > 0. However, now we have a (partial) extension of the V irasoro algebra in hand, generated by  $L_n$  and h. Hence it is natural to ask if the null-vectors are annihilated by  $h_n$  as well as by  $L_n$ . Consider for example the primary operators it conformal weight  $h_{(2;1)} = \frac{5}{8}$  which is contained in the c = 0 K actable. We assume it has nonvanishing two-point function. Its (V irasoro) null-vector is

which means that this expression is annihilated by  $L_n$  with n > 0. We are interested in knowing if we are allowed to set the operator appearing in (50) itself to zero, when it occurs in any correlation function with other operators. This is in portant to know, because if true it would give rise[1] to a di erential equation satis ed by any conform allowed involving the K ac-table operator  $A_{5=8}$ . In view of the nonunitarity of the present theory, it is not obvious that (50) itself can be set to zero. (See the paragraph below, containing (53), for a related example.) Now we observe that by applying the operator  $V_2$  to (50) and by using (45) one nds

which vanishes only if  $b = \frac{5}{6}$ . Furtherm ore, when applying the operator '1 to (50) we arrive, irrespective of the value of \b", at

which, as we have already established in (49), vanishes for all primary operators A(z) with nonvanishing conformal weight. (Applying 'n with n 3 is easily seen to always annihilate (50).)

Hence we arrive at the important conclusion that if the descendant (50) of a Kac-table operatorm ay be set to zero in any correlation function with other operators (which, we emphasize again, implies[1] the validity of the corresponding di erential equation involving this operator), then '2 and '1 applied to it must also vanish, [64] and this does not happen unless  $b = \frac{5}{6}$ . This is a necessary condition determ ining the value of b by simple algebra, without solving the di erential equations ensuing from the null-vector condition. On the other hand, if we took the route described at the beginning of this subsection, i.e. if we solved the di erential equation for the four-point function of the operator  $A_{\frac{5}{8}}(z)$  (assuming it had a nonvanishing two-point function), found the coe cient de ned in (29), and determ ined b via (33), it would also be  $\frac{5}{6}$ . Therefore, the above steps establish a purely algebraic way to determ ine for each Kac-table operator with nonvanishing two-point function a value of b, for which the null-vector (such as e.g. (50)) m ay be set to zero. This, in turn, gives rise to the ensuing di erential equation.

The notion of a nonvanishing null-vector m ay be unfamiliar. To illustrate it, let us give a related, but simpler example: at c = 0 the stress tensor, which is a descendant of the identity operator (e.g. (B.39)), is itself primary,

The stress tensor hence represents a null-vector of the identity operator at level two. But clearly, the stress tensor does not vanish, even though its two-point function does. And indeed, in analogy with (51), we obtain from (45)

which does not vanish (unless b = 0 in this case).

W hile we lack a general result for b based on the above m ethod for all operators in the c = 0 K ac table, we have repeated this procedure for m any of the operators of the K ac table and found the following pattern [36]:

for

Here A (m, n) denotes the operator located in position (m, n) of the K ac table of Fig.1.

In view of the uniqueness of the number b in any given theory, the appearance of di erent values for b in (55) has in portant consequences. It means that, in a given c = 0 theory, only certain subsets of primary operators with conform alw eights given by the K ac-table have null-vectors which vanish identically (im plying that the corresponding conform alblocks satisfy di erential equations). To be entirely clear, but at the risk of being repetitive, let us spell. this out once m ore in detail (all K ac-table operators m entioned below are assumed to have nonvanishing two-point function). Take for example the operator  $A_{(2,1)}$  of conform alweight  $\frac{5}{8}$ , which we previously denoted as  $A_{\frac{5}{2}}$ . Conform al blocks involving this operator satisfy the (second order) di erential equation associated with the null-vector of A (2,1) at the second level only if  $b = \frac{5}{6}$ . On the other hand, take the operator A (1,3) with conform alweight  $\frac{1}{3}$ . Conform al blocks involving this operator satisfy the (third order) di erential equation associated with the null-vector of A  $_{(1,3)}$ on the third level only if  $b = \frac{5}{8}$ . Therefore, these two operators cannot give rise to the corresponding di erential equations simultaneously in the same theory. That does not mean that primary operators with Wrong' conformal weights are necessarily forbidden in the same theory. But it means that for wrong' operators the null-vectors cannot be set to zero, which im plies that their correlation functions would not satisfy the di erential equations which would otherw is follow from these null-vectors (such as (50)) according to the nules of Ref. [1]. For example, if  $b = \frac{1}{6}$ , only the (second order) di erential equation associated with the null-vector of A (2;1) at the second level can be valid. But the (third order) di erential equation associated with the null-vector of A  $_{(1,3)}$  on the third level would not be valid. In other words, a conform alblock involving A (1,3) would not satisfy this di erential equation. Conversely, if b = only the (third order) di erential equation associated with the null-vector of  $A_{(1,3)}$  on the third level can be valid. But the (second order) di erential equation associated with the null-vector of A (2,1) at the second level would not be valid. In other words, a conform alblock involving A (2;1) would not satisfy this di erential equation. Finally, if b is not equal to either of these num bers, neither of these di erential equations will be satis ed by the conform alblocks involving these operators. (An explicit example illustrating these issues for the K ac-table operators  $A_{3,1}$  and  $A_{1,5}$  of conform alweight two can be found in (73) below.)

This concludes our discussion of the operators with nonvanishing conform alweights.

# B. Operators with vanishing dim ension

Let us concentrate now on the operator  $A_{(1;2)}$ , appearing in position (1;2) of the K ac table in Fig.1. A rem arkable feature of this operator is that its conform all weight vanishes at central charge c = 0, even though the operator itself is di erent from the identity operator. It is well known that this can happen in nonunitary theories, and the operator  $A_{(1;2)}$  plays a prom inent role in the theory of percolation [42].

Consider rst the correlation function on the left-hand side of (41) where A (z) is now the zero-dimensional operator with h = 0. In what follows, we denote this operator by O (z), and we assume that it has nonvanishing two-point function. The right-hand side of (41) has been obtained from global conform all invariance alone, and is therefore certainly also valid when the conform all weight h = 0. In this case it reduces to

A di erence between (56) and (41) for the operator with nonvanishing conform alweight is the absence of the logarithm s. A lso, it is no longer possible to set to zero by employing (37).

Now consider how the OPE (30) changes when h = 0. It becomes

(as one m ight have expected from (17)). Notice the logarithms no longer appear, and a contribution of the stressenergy tensor conform alblock appears, with an arbitrary one cient C. The associativity of the correlation function hO ( $z_1$ )O ( $z_2$ )A<sub>h</sub> ( $z_3$ )A<sub>h</sub> ( $z_4$ ) i, where A<sub>h</sub> is an arbitrary primary operator with conform alweight h, requires C =  $\frac{1}{b}$ .

Finally, consider how the OPE (42) changes. It becomes

where is a new constant which cannot be determined from conformal invariance alone.

It follows from (56) that  $_0O(0) = O(0)$ , in contrast to the case of operators with nonvanishing conform alweight A (z), for which we can arrange for  $_0A(0) = 0$  by a rede nition as in (37). From (58) something even more drastic

follows: the commutation relations of  $'_n$  and  $L_m$ , when they act on the zero-dimensional operator 0, change from (45) to [65]

Let us try to use the commutators (59) to determ ine if the vanishing of the null-vector of  $A_{(1,2)}$  at the second level in poses any constraints on the parameters b, and . In this case the null-vector is  $L_2 = \frac{3}{2}L_1L_1 A_{(1,2)}$ . By applying '2 and '1 (as before), we not that the following conditions need to be satistical, if the null-vector itself can be set to zero,

Quite independently, the di erential equation associated which the operator  $A_{(1,2)}$  allows us to determ ine . Indeed, let us calculate the (chiral) four-point correlation function  $A_{(1,2)}(z_1)A_{(1,2)}(z_2)A_h(z_3)A_h(z_4)$  where  $A_h$  is an arbitrary primary operator with conform alweight h. Writing the second order di erential equation which follows from setting to zero the null-vector of  $A_{(1,2)}$  at the second level, we nd an identity conform alblock of the following form,

where, as before,

M atching the coe cient  $\frac{1}{5}$  with the OPEs (30) and (57) we nd C =  $\frac{1}{5}$  and consequently =  $\frac{b}{5}$ . This is consistent with the purely algebraic results obtained above. The value of b cannot be determ ined in this way, however. This ends our discussion of operators with vanishing conform alweight.

#### IV. CRITICAL DISORDERED SYSTEM S

C onsider a generic disordered system where the disorder average can be perform ed using the supersymm etry (SUSY) method, resulting in an action such as that given in (9). A theory of this kind is always invariant with respect to isotopic supersymmetry ('supergroup') transformations. For example, the action given in (9) is invariant under superunitary rotations

where U is a superunitary matrix. According to Ref. [29] the stress tensor of such systems is always a member of a certain indecomposable SUSY multiplet. The number of elds in this multiplet depends on the symmetry group of the system. Any such theory must, however, at least be invariant under a minimal U (1jl) SUSY, giving rise to a 4-dimensional (indecomposable) multiplet of stress tensors denoted by T (z), t(z;z), (z;z), <sup>y</sup>(z;z) in Ref. [29]. All four elds must have conform alweights (h;h) = (2;0). This multiplet, together with the action of the U (1jl) generators denoted (as in [29]) by ; <sup>y</sup>; j; J, satisfying the relations




FIG.2: The multiplet of elds of conform alw eight-two for the supergroup U (1jl). and y are two ferm ionic generators of this group. (In the gure, y is denoted by , and y is denoted by .)

is depicted in Fig.2. (The operators (t; y; ;T) transform in the same way as (j; y; ;J).) If the SUSY is larger than this minimal U (1j), then this multiplet will in general contain more elds, but the above four will always be contained therein.

A special role is played by the 'top' eld t(z;z) of the multiplet, displayed in Fig. 2, whose OPE with the stress tensor T was argued in Ref. [29] to satisfy (cf. Eq. (24))

where the parameter b counted [66] the number of e ective degrees of freedom of the disordered system. Die erent disordered systems, all having central charge c = 0, can be distinguished by dierent values of b. It was further suggested in Ref. [29] that the eld t(z;z) together with the stress-tensor T (z) should generate a certain extension of the V irasoro algebra, via their OPE. However, the most general form of this OPE was not established.

At a critical point a disordered system will typically have, as mentioned, vanishing central charge c = 0. A coording to the analysis in Section IIA, this im plies the existence of an operator with holom orphic part t(z), designed to avoid the c! 0 catastrophe'. At this stage, upon comparing (65) with (24), we are forced to identify the holom orphic part of t(z;z) obtained in Ref. [29] by supersymmetry methods, with t(z) considered in Section IIA of this paper. Thus, at supersymmetric disordered critical points, a partner of the stress tensor is known to appear simply on grounds of (super-) symmetry.

An important remark has to be made at this point. We know from the analysis of Ref. [29] that in general, the operator t(z;z) does not have to be holom orphic, as indicated by the notation. A lthough there exist theories such as K ac{M oody super current algebras, where it is certainly holom orphic (but not logarithm ic, as discussed in Section IIA), t(z;z) will in general also have a nontrivial dependence on z. Quite analogously, the corresponding operator t(z;z), which is related to T (z) in the same way as t(z;z) is related to T (z), can depend on z.

From the point of view of its z dependence, t(z;z) must have dimension zero. Therefore, only two options are allowed for t. One is given by  $L_0t = 0$ . This means that either t does not depend on z, or, that its z-dependence arises from a weight-zero operator, di erent from the identity. The other option is given by

This was rst suggested in Ref. [44]. See also Ref. [30].

In this note we focus entirely on the z-dependence. The dependence of t on z would have to treated separately, and nally the holom orphic and antiholom orbpic parts will have to be put together. How ever, we do not address the issues of the z-dependence of t(z;z) here. This is an important problem which has not been properly investigated up until now, and should be a subject of future work.

#### V. EXTENDED STRESS TENSOR MULTIPLET

In this section we rst focus entirely on consequences of conform alsymmetry, without regard to SUSY. In particular, we will simply consider a general CFT at c = 0 which, as discussed in Subsection IIB above, possesses a stress energy tensor T as well as a logarithm ic partner t, satisfying the OPEs described in Eqs. (35) and (38). Such a theory may for example appear as the n ! 0 limit of a replicated theory of n interacting copies of elds, as discussed in the Introduction. We are going to show that the requirement that t(z) is logarithm ic automatically ensures the existence of extra primary conform alweight-two elds with nonvanishing two-point function. Moreover, if there are two such extra elds, (z) and <sup>y</sup>(z), which are anticom muting, then the OPEs between all four holom orphic weight-two elds T;t; ; <sup>y</sup> automatically transform covariantly under a global U (1jl) supersymmetry. In other words, we are going to show that the requirement of c = 0, and the OPE (35), together then imply invariance under

a global supersym m etry acting on the holom orphic parts of these elds. (W e em phasize that there was no m ention of SUSY at the outset.) W hether or not this will in fact translate into an actual global SUSY of the full c = 0 theory will depend on the speci c gluing of holom orphic and antiholom orphic sectors, an aspect that rem ains to be explored and which we are not addressing here.

# A. The multiplet of two dim ensional operators, and SUSY

So far, the operators with conform alweight two are t(z), which is not prim ary according to the OPE (35), and T (z), which is prim ary at c = 0, but has a vanishing two-point correlation function. It turns out, how ever, as we will now see, that these two elds do not exhaust all conform alweight-two operators we need to introduce for consistency of our theory. We also need to add conform alweight-two prim ary operators with nonvanishing correlation functions.

Consider, a (chiral) correlation function with insertions of several operators t(z). Such a correlation function will not be single-valued. In order to see how the additional weight-two operators appear, it is instructive to exam ine the OPE between two operators t(z), given in Eq. (38). Due to the presence of the logarithm, this OPE is clearly not single-valued as z goes around zero. A correlation function with a t(z)t(0) insertion will change under such a transform ation. A piece will be added to it whose small z behavior can be found by shifting all the logarithm s in (38) by 2 i.

It is possible to establish that this piece will contain a full OPE between two prim ary operators A with conform all weight two, and nonzero two-point correlation function. To be specic let us introduce the conform all weight-two prim ary eld  $A_2$  (z). Its OPE with itself has the following contribution from the identity operator

$$A_2(z)A_2(0) = T(z)T(0) + \frac{b}{2z^4} + \frac{t(0) + T(0)\log(z)}{z^2} + \dots;$$

in agreem ent with (30). Here we xed the normalization of  $A_2$  in a certain way which will become useful later. We also introduced a piece in the OPE proportional to the arbitrary coecient . It is allowed by conformal invariance and its utility will become obvious as we go along. In the previous sections we routinely set coecients such as to zero by employing the rede nition (37), as well as the OPE (21) of the stress tensor. However, at this stage we have already used this rede nition once, to x the OPE Eq. (38), so we cannot use it again. Notice that the three-point function (41) is now xed to

It follows that the OPE  $t(z)A_2$  (w) is xed to be

similar to the OPE (42), but again with the extra term proportional to . So far remains arbitrary.

Now it can be checked, by using (38) and (67), that the contribution of (the V irasoro representation of) the identity operator in the following combination of OPEs

no longer contains any logarithm s, to all orders in z. (A proof is presented in Subsection VIB.9 of Appendix B.) It therefore remains single-valued as a function of z, when inserted into any correlation function. This shows that indeed, an insertion of t(z)t(0) into any (chiral) correlation function with other operators, will analytically continue to a linear combination of t(z)t(0) and  $A_2(z)A_2(0)$  (and T(z)T(0)). This is how the conform alw eight-two primary elds  $A_2(z)$  will appear in any theory at c = 0 which contains the logarithm ic eld t(z).

We already established in the Section IIIA that (chiral) correlation functions containing the conform alweight-two prim ary operator  $A_2$  (z) (with nonvanishing two-point function) would satisfy the corresponding di erential equation, if b is either  $\frac{5}{6}$  or  $\frac{5}{8}$ . In the rst case, this would be the third order equation for the operator  $A_{(3;1)}$ , and in the second the flh order equation for the operator  $A_{(1;5)}$ . In fact, the solutions to these equations for the identity conform all block of the four-point function  $hA_2A_2A_2A_2$  i can be obtained in closed form. An important feature of these solutions is that the identity conform all block F (x) de ned as in (26), (27), if norm alized to 1 as x ! 0, goes to ( $x^4$ ) as x ! 1, and vanishes altogether when x ! 1 (or the opposite way around). This is only possible if there

exist two conform alweight-two operators which are in fact anticom muting operators. O focurse we could also consider com muting operators as far as the considerations leading to Eq. (70) are concerned, but their correlation functions would not satisfy the appropriate di erential equations at the appropriate values of b.

M otivated by these considerations let us consider, from now on, the case of two conjugate ferm ionic conformal weight-two operators (z) and y(z), but we no longer require that they be K ac-operators; in particular, the parameter b can now take on arbitrary values. (B esides the ferm ionic nature of and y we make no other assumptions but conformal symmetry.) Their OPE can be copied from (67),

It is remarkable that the identity conform alblock of the four-point function of these operators,

$$G = (z_1)^{y} (z_2)^{y} (z_3) (z_4) ; \qquad (72)$$

can be obtained in closed form for arbitrary values of the parameter b by a generalization of the conform al W ard identity. (Note that unless b = 5=6 or b = 5=8, this function no longer satis are corresponding dimential equation.) In order to see this, consider the linear combination

This combination is a rational function of the coordinates, as can be checked by employing the OPEs. Therefore, it can be reconstructed from its poles, as in the standard conformal W and identity [1]. This allows us to nd the correlation function G for arbitrary values of b. This correlation function m ust of course vanish as  $z_1$  approaches  $z_4$ , due to the ferm ionic nature of the operators . It turns out that it vanishes only if the parameter in (71) is chosen to be  $=\frac{1}{8}$ . This explains why the parameter was introduced in (71) in the rst place. Setting = 1=8, we obtain the explicit result,

$$G = \frac{b}{(z_1 \quad z_2)^4 (z_3 \quad z_4)^4} \quad \frac{(x+1)(2x^2+b(x-1)^2(1+x^2))}{4(x-1)}$$

We can check by direct substitution that (the function of the cross-ratio x, associated as in (26) with the function) G satis as the third order equation for the operator A  $_{(3;1)}$  if  $b = \frac{5}{6}$ , and that it satis as the find order equation for the operator A  $_{(3;1)}$  if  $b = \frac{5}{8}$ . It is not completely obvious from (73) that G ! 0 when  $z_1 ! z_4$  (which implies x ! 1), but it can be easily checked with the help of straightforward algebra.

Let us sum marize brie y. We have established that c = 0 conform altheories with a logarithm ic operator t(z) must contain, in addition to the stress tensor T (z) and t(z), extra operators with conform alweight two but nonvanishing two-point function. For  $b = \frac{5}{6}$  or  $b = -\frac{5}{8}$ , two anticommuting operators and <sup>y</sup> are required, if the latter are to satisfy the corresponding K ac-table null-vector conditions (in plying that the identity conform alblock of (72) satis es the 3rd-, or the 5th-order di erential equation, corresponding to their respective K ac-table positions). In general, as long as these two conform alweight-two operator and <sup>y</sup> are ferm ionic, the full identity conform alblock of the function (72) can be obtained in closed form for any value of the 'anom aly' number b, with the result given in (73) above.

These operators will then have the following OPEs

(z)

and sim ilarly for  $^{\rm y}$ .

Consider now the OPEs given by Eqs. (21), (35), (38), (74) and (75). They were derived using CFT techniques alone, and the only assumption was the existence of the OPE (35), and the ferm ionic nature of the operators and y. Nevertheless, it can easily be veried that these OPEs are in fact covariant under the application of a global

SUSY transform ation according to Fig.2, acting only on the chiral operators appearing in them . (Interestingly, these OPEs would not have been covariant if  $\oint \frac{1}{8}$ .) Thus we arrive at a remarkable conclusion: if a partner of stress energy tensor t (which always exists at c = 0 to avoid the c ! 0 catastrophe) is logarithm ic, these chiral OPEs are autom atically supersymmetric. This would have to be true even when the eld theory was constructed in terms of replicas as opposed to supersymmetry, as long as there are two weight-two primary operators ; <sup>Y</sup> with nonvanishing two-point function which are ferm ionic. (We know from (70) that there exists at least one such weight-two operator.)

#### B. Comments on an Extended Algebra'

In Section III we used the logarithm ic `algebra' form ed [67] by the coe cients of the mode expansion of T and t, which we called  $L_n$  and `m . Speci cally, we derived the commutation relation  $[L_n; `m]$ , given by (45). It was enough to consider only this commutation relation, besides the V irasoro algebra (46), to arrive at the results obtained in that Section.

It may be natural to ask if there could exist a suitable consistent (full) extension of the V irasoro algebra, involving the modes m. For example, one could consider, in addition to V irasoro descendants L n Å i, also 'extended V irasoro descendants' such as e.g. ' n Å i. One may also ask about a possible generalization of null states, degenerate with respect to a suitably extended V irasoro algebra, involving now also the modes  $'_{n}$ .

Unfortunately, proposals along these lines have been di cult to implement. In order to have a closed algebra, one would also need the commutation relations [n; m], which would have to be obtained from the OPE (38). Similarly, since we now see that the full set of weight-two elds involves not only the elds T and t, but also additional elds such as e.g. the fermionic elds and y, it seems natural at this point to try to establish the anticommutation relations f n; mg' g as well. One of the di culties with these commutators is the nonholom orphic aspect of these elds. Furtherm ore, regarding the second commutator (but in view of (70) this is also relevant for the rst), the operator , when acting primary operators, may generate other primary operators with di erent conform al weights. For example, for the speci c values of b when the K ac null-vector of vanishes, its OPE with other primary elds can be

read o from the K ac table, and it obviously generates prim aries with weights not related by integers. For arbitrary values of b when the K ac table is not available, it is not even clear how to nd such an OPE. In any case, it would be interesting if a suitable extension of the V irasoro algebra, based on the additional structures presented in this paper could be developed, in one way or the other. This, how ever, would certainly have to be reserved for future work.

#### VI. CONCLUSIONS

In this paper we exam ined the structure of conform allel theories (CFTs) with central charge c = 0.W e focussed entirely on the holom orphic sector, leaving the gluing of holom orphic and antiholom orphic sectors for future work. 0 ne of the main features distinguishing these CFTs from those with c 6 0 is the appearance of a logarithm ic partner of the stress tensor' which is in general not holom orphic. It has a holom orphic part of conform alweight two, which we denoted by t(z) (Section II). The latter leads to a novel anom aly number b, distinguishing di erent CFTs with central charge c = 0. The number b is a unique characteristic of any given c = 0 CFT. (Basically, b plays the role of the 'e ective central charge' (@c(n)=@n)  $_{n=0}$  of replica theories [27, 30]; recall the footnote below (65).) Interestingly, we saw in Section III that in theories with 'logarithm ic' t(z) the number b controls the question of whether certain Kac-table null-vectors do indeed vanish identically or whether they represent nonvanishing states with zero norm (like the c = 0 stress tensor). We found that the null-vectors indeed vanish for primary operators with nonvanishing two-point function (i) in the rst two rows of the Kac table when b = +5=6, or (ii) in the rst column of the Kac table with nonzero weight when b = 5=8.0 nly those (chiral) four-point functions which contain a Kac-table operator with vanishing null-vector will satisfy the fam iliar[1] di erential equations. These results were obtained by considering suitably de ned Laurent modes  $'_n$  of the logarithm ic partner t(z) of the stress tensor, and by considering their commutation relations (45) with the ordinary V irasoro generators  $L_n$ . (This represents a partial extension' of the Virasoro algebra.) We showed in Section V that on grounds of consistency there must exist, besides the stress tensor and its partnert(z), additional elds whose holom orphic parts have weight two, and nonvanishing two-point functions, when t(z) is logarithm ic. Remarkably, the simple assumption of a ferm ionic pair of such additional elds in plies that the full set of chiral OPEs between all these weight-two elds is autom atically covariant under the action of a global U (1jl) supersymmetry. No SUSY was required at the outset. (Then, also, the full identity conform al block of these ferm ionic weight-two elds can be computed exactly for any value of b, with the result given in (73).) Indeed, a U (1 1) multiplet of Stress tensors' transform ing in the same indecom posable representation occurs in any CFT which is known to possess a global U (1jl) SUSY, the actual stress tensor being the singlet (see Section IV). Our results show that, at least at the purely holom orphic level, such a global SU SY is already a hidden symmetry in any c = 0 CFT possessing a logarithm ic partner of the stress tensor t(z), given there are two ferm ionic weight-two

elds ; <sup>y</sup> with nonvanishing two-point function. We close by saying that it is tem pting to speculate about a possible extension of the V irasoro algebra by the Laurent m odes n of the logarithm ic partner t(z) of the stress tensor, and by the corresponding m odes of the other m em bers of the 'stress tensor multiplet' m entioned above. Future work will have to show if such an extension can be constructed (Section V B).

# Appendix A: Uniqueness of the `anom aly' num ber b

In this appendix we will show that the OPE (35), which expresses the action of (in nitesim al) conform altransform ations on the operator t, does not allow for two di erent operators  $t_1$  (z) and  $t_2$  (z), characterized by two di erent values of their respective 'anom aly' numbers  $b_1 \in b_2$ , to coexist in a given theory.

The proof is simple. If both,  $t_1(z)$  and  $t_2(z)$ , were present in the same theory, then we would be able to construct the (holom orphic) two-point function  $ht_1(z_1)t_2(z_2)i$ . As in any CFT, this function must satisfy the constraints of global conform al invariance (there are no others for a two-point function). We will show that these constraints (ordinary di erential equations) do not possess a solution, unless  $b_1 = b_2$ .

- [59] We do not suggest that (30) is necessarily an appropriate OPE for Kac-table operators. Indeed, arguments given in Ref.[30] would indicate that bulk Kac-table operators for percolation and for self-avoiding polymers have vanishing twopoint functions, and this would not lead to the OPE (30).
- [60] The various terms are easy to understand. The leading term is xed by the considerations of (24), recalling that both OPEs, (20) and (30), im ply  $L_2t = b$  (Appendix B, (B.10) and (B.58)). There is no  $1=z^3$  term because t is quasiprimary. The next order,  $1=z^2$ -term is xed by the 'logarithm ic' condition (31), and by the conform alweight h = 2 of t(z).
