Enlarged Galilean symmetry of anyons and the Halle ect

A bstract

Enlarged planar Galilean symmetry, built of both space-time and eld variables and also incorporating the \exotic" central extension is introduced. It is used to describe non-relativistic anyons coupled to an electrom agnetic eld. Our theory exhibits an anomalous velocity relation of the type used to explain the Anomalous Hall E ect. The Hall motions, characterized by a Casimir of the enlarged algebra, become mandatory for some critical value(s) of the magnetic eld. The extension of our scheme yields the semiclassicale ective model of the Bloch electron.

1 Introduction

The planar Galilei group adm its a two-fold \exotic" central extension, labeled with m (the mass) and a second, \exotic" parameter [1]. Models which provide a physical realization of this \exotic" symmetry have been presented in [2, 3]. Below, we focus our attention on the theory of [3], since that of [2] is in fact an extended version of the latter. Minimal (symplectic) coupling of the particle to an external electromagnetic eld yields the rst-order phase space Lagrangian

where = = m^2 is the non-commutative parameter. The Euler-Lagrange equations are

where E_i and B are the electric and magnetic eld, respectively, and m = m (1 e B) is an e ective mass. These equations can also be obtained in a Hamiltonian framework, using the usual Hamiltonian H = P^2 =2m eA₀ and the modiled Poisson-brackets

The most dramatic prediction of the model is that when m = 0 i. e., when the magnetic eld takes the critical value

the system becomes singular, and the only allowed motions follow the Hall law β]. The Poisson-brackets (1.4) are changed for new ones in a reduced phase-space (see β].

Requiring $B = B_{crit}^{0}$ amounts to a restriction to the lowest Landau level, and quantization allowed us to recover the \Laughlin" wave functions [3].

In this Letter we generalize this model, and indicate its relation to models used in solid state physics [4, 5].

2 Enlarged Galilean sym m etry

A dapting the idea of [6] to planar physics, we consider a hom ogeneous electric eld $E_i(t)$ and a constant magnetic eld B, and view E_i and its canonical conjugate momentum, i, as additional variables on an enlarged phase space. This latter is endowed with the enlarged Lagrangian $L^{enl} = L + iE_i$: The i are Lagrange multipliers and one of the equations of motion is $E_i = 0$; i.e., the electric eld should actually be constant.

The Galilean symmetry of combined particle+homogeneous eld system is readily established: the enlarged Lagrangian is (quasi-)invariant w.r.t. enlarged space translations, rotations and boosts, implemented as

Now we consider the enlarged Ham iltonian structure. Then the equations of motion (1.2)-(1.3), augmented with $_{i}$ = eX $_{i}$ are Ham iltonian, Y= fY;H g, with the usual Ham iltonian H = P^{2} =2m eE $_{i}$ X $_{i}$; and the fundamental Poisson brackets (1.4), supplemented with fE $_{i}$; $_{j}$ g = $_{ij}$. Then conserved quantities are readily constructed. Integration of the equation of motion (1.3) shows that

are conserved and generate enlarged rotations and boosts, respectively. Note that anyonic spin, represented by the real number s_0 , has also been included. The generators satisfy the enlarged Poisson relations

A closed algebra is obtained, therefore, if the electrom agnetic elds E_i and B_i are considered as additional elements of an enlarged G_i alilei algebra G_i , cf. [6]. The (constant) magnetic eld, B_i , belongs, together with m and E_i magnetic eld, E_i to the center of G_i . The additional nonzero brackets are

Our enlarged Galilei group has two independent Casim irs, namely

In the representation of the enlarged Galilei algebra given in terms of phase-space variables,

C⁰ generalizes one of the two Casim irs of the planar Galilei group, namely the internal energy [7]. C + C⁰ is in turn proportional to the second Casim ir identied as the spin; these two quantities are linked, just like for the model of [2]. The relation of the enlarged and ordinary Galilean algebras can be claried by a subtle group contraction. Though constants of the motion, our Casim irs are not xed constant: the representation of our enlarged Galilei group is, in general reducible. If the elds become non-dynamical, those transformations which are consistent with the constant elds remain symmetries. For example, (2.2) becomes the familiar magnetic translation.

3 A lgebraic construction of the coupled anyon plus electrom agnetic eld system and Halle ects

Having established our enlarged planar Galilei algebra, now we build a new theory of anyons interacting with (constant) external elds. Generalizing a formula of Bacry [8] who argued that the Hamiltonian should be constructed from generators of the symmetry group, we consider

where that last term is dictated by boost invariance. H 0 is indeed H 0 = H+ C 0 : Choosing a real param eter g, H 0 can be further generalized as

where $= ges_0=2m$. The kinetic term gets hence a eld-dependent factor; our Ham iltonian contains, together with the usual magnetic moment term B [which is here a constant], also an anomalous term proportional to P E.

Such a theory is still symmetric w.r.t. the enlarged Galilei group by construction. The equation of motion, rem iniscent to Eq. (5.3) of [9], is

When g = 2 and $e B \in 1$, $m X_{-i} = P_i$, so that our equations describe an ordinary charged particle in an electromagnetic eld. For g = 2 and e B = 1, Eq. (3.3) is identically satistically satisfied.

We assume henceforth that $g \in 2$. Then Eq. (3.3) describes an \exotic" particle with anomalous moment coupling with gyromagnetic ratio g, cf. [9], which generalizes the g = 0 theory of Ref. [3].

Let us now consider Hallm otions, i.e. such that

this is a solution of the equations of motion (3.3-1.3) when the momentum satis es

The constraint (3.6) is clearly equivalent to the vanishing of the Casim ir, C = 0: Conversely, from (3.6) we infer that $P_1 = 0$, so that the Lorentz force on the rhs. of (1.3) is necessarily zero and the motion follows the Hall law. Thus, when $B \in B_{crit}^{(0)}$, the Hall motions are characterized by the constraint (3.6), in turn equivalent to C = 0. The condition (3.6) is invariant w.r.t. the enlarged Galilei transform ations and, when restricted to such motions, the representation of the enlarged Galilei algebra becomes irreducible.

The generic motions have the familiar cycloidal form, made of the Hall drift of the guiding center, composed with uniform rotations with frequency

For g=2 this reduces to the usualLarm or frequency eB=m. The C asim ir C m easures the extent the actual motion fails to be a Hall motion. For m=0, i. e. for $B=B_{crit}^0=(e)^1$; (3.3) implies (3.6), and hence the only allowed motions are the Hall motions [3, 9].

Interestingly, this is also what happens for $B = B_{crit}^{0}$ (which plainly requires $g \in 0$). Then the momentum drops out from (3.3). For g = 2 (3.3) holds identically, but for $g \in 2$ it becomes

which is once again the Hall law (3.4) with $B = B_{crit}^{0}$ [9]. Now the constraint (3.6) is not enforced: by (1.3), the momentum is an arbitrary constant.

The two critical values correspond to the frequencies = 1 and = 0, respectively. In the rst case m = 0, only those initial conditions are consistent which satisfy (3.6). The system is singular and requires reduction [3]. In the second case the initial m om entum can be arbitrary, since it has no in whence on the m otion. The system acquires an extra translational sym m etry in m om entum space.

4 Planar Bloch electron in external elds

While our theory may seem to be rather speculative, it has interesting analogies in solid state physics, namely in the theory of a Bloch electron in a crystal. Restricting ourselves to a single band, the band energy and the background elds provide in fact electron terms for the semiclassical dynamics of the electronic wave packet [5]. The mean Bloch wave vector (quasimom entum) we denote here by P varies in a Brillouin zone. In terms of P and the mean band position coordinates, X i, the system is described by the electrone Lagrangian [5]

with $A_i = \frac{1}{2} ijB X_j$; $A_0 = E X : The expression E(P) = E_0(P) M(P)B$; [where $E_0(P)$ is the energy of the band and M(P) is the mean magnetic moment] yields a kinetic energy term for the elective dynamics.

The (e ective) vector potential A_i is the Berry connection; it can arise, e. g., in a crystal with no spatial inversion symmetry as in GaAs [5]. The last term in (4.1) is indeed analogous to our \exotic" term (=2) $_{ij}P_iP_j$ in (1.1), to which it would reduce if the Berry curvature,

Eq. (4.3) has the same structure as our original (g = 0) velocity relation (1.2). The Berry curvature provides us with a momentum dependent elective non-commutative parameter (P), which yields in turn P-dependent elective mass m = m (1 - e (P)B) and anomalous velocity terms, cf. [5, 10].

In a H am iltonian fram ework, the system is described by the B loch H am iltonian H $^{\rm B \ loch}$ = E (P) $_{\rm i}$ X $_{\rm i}$, and by formally the same Poisson brackets (1.4), except for the m omentum dependence of . In particular, the m ean band position coordinates do not commute, as it had been observed a long time ago [10]. The P dependence is consistent with the Jacobi identity, [11], even for a position-dependent B [3].

Once again, we can consider the enlarged fram ework of Section 2. This yields the previous equations of motion and commutation relations, supplemented with $E_1=0$ and fE_1 ; ig=ij, respectively. The P-dependence of NC parameter breaks the Galilean symmetry down to the magnetic translations (times time translation) alone. Assuming and Eonly depend on P^2 , rotational symmetry is restored, though. It is generated by J in (2.4), with $\frac{1}{2}$ (P^2) replacing the \exotic" contribution $P^2=2$. Hence, we are left with a residual symmetry with generators P_1 ; H; J; E_1 and E_2 and E_3 and the innite tower E_3 0 and E_3 1; E_3 2 and the innite tower E_3 3 and E_3 4.

Let us now inquire about the Hall motions. Inserting the Hall law into the equation of motion (4.3) generalizes the condition (3.6) as

where P_0 is a solution of the equation $P_0^2 (E^0(P_0^2))^2 = (E=2B)^2$: That C=0 is equivalent to (4.4) can be proved, e. g., in the generalized parabolic case $E=(P^2)$, 1=2<<3=2. It appears, however, that the vanishing of C is a mere coincidence, and (4.4) is better interpreted as the extrem um condition $Q_{P_1}C=0$ for the C asim ir. (For (2.10) we obviously have a minim um). Eq. (4.4) can have Q one than just one solution. This happens, e. g., for the energy expression $E=a^2P^2+b^2$ $1+c^2P^2$ considered by C ulcer et al. in Ref. [4] for the Anomalous Hall E ect. Then the vanishing of C is clearly irrelevant, but the extrem um property is still valid.

If the e ective non-commutative parameter = P is genuinely momentum-dependent as it happens in Ref. [4, 5], the magnetic eld cannot be tuned to either of the critical values B $_{\rm crit}^0$ or B $_{\rm crit}^0$. Hence, the Hallm otions can not be made mandatory.

Writing either (1.2) or (4.3) as

we recognize the anomalous velocity used in the description of the Anomalous Hall E ect in ferromagnetics [4]. The additional contribution (g=2)em $_{ij}E_{j}$ in eqn. (3.3) comes from the anomalous term (g=2) E' P' in the Hamiltonian (3.2). This latter can be viewed as the \Jackiw-Nair" [12] lim it of the spin-orbit coupling

advocated by K arplus and Luttinger half a century ago [4]. Putting $\sim = s_3$, $= s=c^2m^2$ (4.7) becomes indeed proportional to our anom alous term. Such a term also arises in the non-relativistic limit of charged D irac particle in a constant electric eld [13].

Adding (ge =2)C to $H^{B \text{ loch}}$ yields an anomalous extension of the sem iclassical B loch model with (4.3) generalized to

[= \mathfrak{P})], supplemented with the Lorentz equation (1.3). For a Hallmotion the momentum is constant, $\mathfrak{P} = \mathfrak{P}^0$. Putting $^0 = (\mathfrak{P}^0)$ and inserting into the equation of motion

Let us assume that $@_{P_i} \in 0$. Although (4.9) has more general solutions, we observe that if the Hall condition (4.4) holds, then we have again C = 0. At last, $1 (g=2)e^{-0}B = 0$ can also yield Hall motions of the second type for some particular value of the momentum.

5 Conclusion

In this Letter we presented, following Ref. [6], a fram ework which unies phase space and eld variables, and used it to introduce \enlarged Galilean symmetry". Then we built a theory along the lines put forward by Bacry [8]. Adding a Casim ir to the Ham iltonian, our theory

can accom odate anom alous m om ent coupling cf. [9]. We derived an algebraic characterization of the Hall motions and have shown that for $B = B_{crit}^{0}$ or B_{crit}^{0} the Hall motions become mandatory. The physical interpretation is provided by the semiclassical theory of a Bloch electron, where a momentum-dependent electron on-commutative parameter is derived by a Berry phase calculation [5,11].
