# Enlarged G alilean sym m etry of anyons and the H alle ect

#### Abstract

Enlarged planar Galiean sym metry, built of both space-time and eld variables and also incorporating the \exotic" central extension is introduced. It is used to describe nonrelativistic anyons coupled to an electrom agnetic eld. O ur theory exhibits an anom alous velocity relation of the type used to explain the A nom alous H alle ect. The Hallm otions, characterized by a C asim ir of the enlarged algebra, becom e mandatory for some critical value(s) of the $m$ agnetic eld. The extension of our schem eyields the sem iclassicale ective $m$ odel of the $B$ loch electron.


## 1 Introduction

The planar Galiei group adm its a two-fold \exotic" central extension, labeled with $m$ (the m ass) and a second, \exotic" param eter [il]. M odels which provide a physical realization of this \exotic" sym m etry have been presented in ther, theory of $\overline{[ }]$, since that of $\overline{[ }]$ is in fact an extended version of the latter. M in im al (sym plectic) coupling of the particle to an extemal electrom agnetic eld yields the rst-order phase space Lagrangian

Requiring $B=B_{c r i t}^{0}$ am ounts to a restriction to the low est Landau level, and quantization allow ed us to recover the \Laughlin" wave functions [ $\overline{3}$ ] $]$.

In this Letter we generalize this m odel, and indicate its relation to m odels used in solid state physics [-4

## 2 Enlarged G alilean sym m etry

A dapting the idea of $\left.{ }_{[1-1}^{-1}\right]$ to planar physics, we consider a hom ogeneous electric eld $\mathrm{E}_{\mathrm{i}}$ (t) and a constant $m$ agnetic eld $B$, and view $\mathrm{E}_{\mathrm{i}}$ and its canonicalconjugatemomentum, i, as additional variables on an enlarged phase space. This latter is endowed w th the enlarged Lagrangian $L^{e n l}=L+{ }_{i} E_{i}: T$ he $i$ are Lagrange $m$ ultipliens and one of the equations of $m$ otion is $E_{i}=0$; i.e., the electric eld should actually be constant.
$T$ he $G$ alilean sym $m$ etry of combined particle+ hom ogeneous eld system is readily established: the enlarged Lagrangian is (quasi-)invariant w. r. t. en larged space translations, rotations and boosts, im plem ented as

$C^{0}$ generalizes one of the two $C$ asm irs of the planar $G$ alilei group, nam ely the intemal energy [ [ $] .1 . C+C^{0}$ is in tum proportional to the second $C$ asim ir identi ed as the spin; these two quantities are linked, just like for the $m$ odel of [2]. The relation of the en larged and ordinary G alilean algebras can be clari ed by a subtle group contraction. Though constants of the $m$ otion, our C asim irs are not xed constant : the representation of our en larged $G$ alilei group is, in general reducible. If the elds becom e non-dynam ical, those transform ations which are consistent w th the constant elds rem ain sym $m$ etries. For exam ple, (2-2) becom es the fam iliar $m$ agnetic translation.

## 3 A lgeb raic construction of the coupled anyon plus electrom agnetic eld system and H alle ects

H aving established our enlarged planar G alilei algebra, now we build a new theory of anyons interacting w ith (constant) extemal elds. G eneralizing a form ula ofB acry [îl who argued that the $H$ am iltonian should be constructed from generators of the sym $m$ etry group, we consider

$T$ he tw o critical values corresp ond to the frequencies $=1$ and $=0$, respectively. In the rst case $m=0$, only those in itial conditions are consistent which satisfy ( $\overline{3}-6)$. $T$ he system is singular and requires reduction [-3, In the second case the in itialm om entum can be arbitrary, since it has no in uence on the $m$ otion. The system acquires an extra translational sym $m$ etry in m om entum space.

## 4 P lanar B loch electron in external elds

W hile our theory $m$ ay seem to be rather speculative, it has interesting analogies in solid state physics, nam ely in the theory of a $B$ loch electron in a crystal. Restricting ourselves to a single band, the band energy and the background elds provide in fact e ective term $s$ for the

## 5 C onclusion

In this Letter we presented, follow ing Ref. [日], a fram ew ork which uni es phase space and eld variables, and used it to introduce \enlarged $G$ alilean sym $m$ etry". Then we built a theory along the lines put forw ard by B acry 面. Adding a C asim ir to the Ham ittonian, our theory
