#### A bstract

W e study the \paperclip" m odel of boundary interaction with the topological angle equal to . We propose exact expression for the disk partition function in terms of solutions of certain ordinary di erential equation. Large distance asymptotic form of the partition function which follows from this proposal makes it possible to identify the infrared xed point of the paperclip boundary ow at =.

Field theory models where interactions emerge as a consequence of geometric constrains imposed on the elds are much interest. They are esthetically attractive, and they often have rich content and important applications. Typical models of this class are nonlinear sigm a models where the constraints are imposed in the bulk of the space-time. Lately the other type of models, where the constraints are imposed only on a boundary, attracts much attention. Two-dimensional models of this type emerge naturally in string theories and in some condensed matter problem s. In string theories they provide the world-sheet description of \branes", while in condensed matter theory they describe either quantum impurities or \quantum dots".

In this paper we study one model of this type. It is the so-called paperchip model introduced in [1]. This two-dimensional model of quantum edd theory involves two-component Bose edd X ( $z_iz$ ) = X ( $z_iz$ ); Y ( $z_iz$ ) living on the disk of radius R. In the bulk, i.e. at jzj < R, the edd X ( $z_iz$ ) is a free massless edd, as described by the bulk action

while the boundary values X  $_B$  of this eld, X  $_B$  = X  $j_{z \not \models R}$  , are subjected to a nonlinear constraint

Here n and r are real and positive parameters (despite the notation, n is not necessarily integer). The renorm alization does not a ect the parameter n, which is thus a scale-independent constant, while  $r \setminus ow s$ " under the RG transform ations; up to two loops, the ow is described by the equation

where  $=\frac{E}{E}$  is inversely proportional to the RG energy scale E. Here E is the integration constant of the RG equation, which sets up the \physical scale" in the model. As in [1], we will always choose E equal to R<sup>-1</sup>, the inverse radius of the disk, so that




Figure 1: The paperclip shape for r = 2 10<sup>3</sup>.

The equation (2) de nes a closed curve in the (X  $_{\rm B}$ ;Y $_{\rm B}$ ) plane, which at su ciently smallr has a paperclip shape (see Fig.1), hence the name of the model.

W hen n goes to in nity and simultaneously r goes to 1 as r = 1  $\frac{1}{2(n+1)g}$  with nite g, the paperclip curve becomes a circle

The boundary constraint (5) de nes the \circular brane" m odel [2].

The \circular brane" m odel has in portant application in condensed m atter physics. It is equivalent to the model of dissipative quantum mechanics known as Ambegaokar-Eckern-Schon model [3]. The latter is used to describe the low -energy sector of the model of a \weakly blockaded" quantum dot introduced in [4,5] (see also the review article [6]). That model describes an almost open dot which has a large number of energy levels and a large charging energy. The dot is connected to the bulk via n degenerate channels, and the Ambegaokar-Eckern-Schonm odel applies when the number of channels is very large. In this application the circum ference 2 R of the disk in (1) has obvious interpretation as the inverse tem perature 1=T, while the large charging energy provides explicit ultraviolet cut-o for the model, and the topological angle of the circular brane (introduced later in the text) is related to the gate voltage. A lthough the Am begaokar-E dkem-Schon m odel appears only in the n! 1 lim it of the model (2) when the paperclip becom es the circle (5), we have reasons to believe that the paperclip m odel with nite integer n has certain relation to the quantum dot model with n open degenerate channels. We intend to explore this possible relation in separate work.

The prim ary object of interest is the boundary state jB i, in particular its overlap with the Fock vacuum jP i characterized by the zero-m ode m om entum P = (P;Q) of the free eld X = (X;Y). The overlap

can be expressed through the disk one-point function

where the functional integration is over all elds X (z;z) obeying the boundary constraint (2).

Let us repeat again that Eq. (3), as well as the paperclip equation (2), was obtained perturbatively, in the two-loop approximation. Therefore it provides useful description of the boundary condition only in the weak coupling regime, where the curvature of the paperclip curve (2) is small everywhere; this requires n to be large, n 1, and r to be su ciently small (so that  $r^n$  1); according to (3), the last condition is fulled at su ciently small (so that r, therefore Eqs. (2), (3) provide ultraviolet (UV) description of the boundary condition. At large distances (large R) and at n 1 the higher loops and non-perturbative corrections are in portant. G enerally, one expects that at R ! 1 the paperclip boundary theory \ ow s" to some infrared (IR) xed point, and so the R = 1 lim it of the boundary state jB i is described in terms of conform alboundary theory associated with the IR xed point.

In regard to the non-perturbative e ects, it is important to realize that under general de nition the paperclip model may involve an additional parameter, the topological angle . Since topologically the paperclip curve (2) is a circle, the conguration space for the eld X (z;z) consists of topological sectors, each characterized by integer w which is the number of times the boundary value X  $_{\rm B}$  winds around the paperclip curve when one goes around the disk boundary jz j = R. This allows one to add the weight factors e<sup>iw</sup> to all contributions to the functional integral coming from the sectors with the winding number w. Thus, in general

where Z  $^{(w)}$  receives contributions from the topological sector w only. Of course, the contributions of the instanton sectors w  $\notin$  0 are invisible in the

perturbation theory, and therefore the UV  $\lim it R ! 0$  of the theory is insensitive to the topological angle (this statem ent is not  $\lim ited$  to the case n = 1; the instanton contributions are suppressed by the powers of at any n, see [1]). However, the IR behavior of the theory can depend on in a signi cant way.

The paperclip m odel is in a close analogy with the so called \sausage" sigm a m odel proposed and studied in [7] (perhaps better known is the sym - m etric lim it of the sausage m odel, that O (3) nonlinear sigm a m odel; its counterpart is the circular brane m odel (5)). The IR physics of the sausage (and its O (3) lim it) sigm a m odel strongly depends on its topological angle

[8,9]. The sausage sign a model is believed to be integrable at two values of the topological angle, = 0 and = . The arguments were given in [7], where exact solutions of the sausage model at these two values of

were proposed. A coording to this proposal, the sausage model at = 0 is massive and its solution is described in terms of factorizable S-matrix of three massive particles. On the contrary, the sausage model at  $= \$  ow s" in the IR limit to a critical xed point, which is the c = 1 CFT of a compacti ed free boson; the  $\$  ow " is described in terms of certain massless Therm odynamic Bethe Ansatz (TBA) system [7]. Solutions for the O (3) sigm a model at = 0 and = were previously proposed in [10] and [11]. By the analogy, one may expect that the paperclip model is also integrable in two cases = 0 and =.

There is more then just this analogy to suspect that the paperclip model might be integrable at least at some values of . In [1] a set of commuting local integrals of motion f  $I_{21 \ 1} g_{l=1}^1$  of the free Bose theory (1) was displayed which has all symmetries of the paperclip (2), and moreover it was found that given the symmetries the set is essentially unique. The idea that this series has something to do with the paperclip model can be supported by the analysis of the UV properties of the model. In the UV lim it R ! 0 the parameter r in (2) becomes small, and the paperclip grows long in the X direction; in this lim it the paperclip can be regarded as the composition of left and right \hairpins" (see Fig.2).



Figure 2: The paperchip form ed by a junction of two hairpins.

By the \hairpins" we understand the curves

where the sign plus (m inus) has to be taken for the left (right) hairpin. If any one of the curves (10) is taken as the boundary constraint, the associated left and right \hairpin m odels" are conform ally invariant, and m oreover each has extended conform al sym m etry with respect to certain W -algebra [1]. A lthough the W -algebras of the right and left hairpin m odels are isom orphic, the generators of W  $^{()}$  and W  $^{()}$  are realized by di erent operators in the space of states of the free boson theory (1). How ever, the sets of operators W  $^{()}$  and W  $^{()}$  have nontrivial intersection, which is exactly the set of com m uting integrals  $\mathrm{fI}_{21}$  1g [1]. For these reasons we refer to the set  $\mathrm{fI}_{21}$  1g as the \paperclip series" of local M .

In [1] an exact expression for the amplitude  $Z_{=0}$  (P j ) was proposed in terms of solutions of certain linear di erential equation. The proposal was inspired by remarkable observation of D orey and Tateo [12] who found that in somewhat simpler integrable model of boundary interaction (the minimal CFT with non-conform alboundary perturbation) the overlap am – plitude analogous to (7) is related to certain monodrom y coe cients of the Schroedinger equation with the potential  $jx j^2$ . Since [12], this noting was con rm ed and extended to several other integrable models of boundary interaction [13{15]. A lthough it is fair to say that true roots of this relation remain mysterious to us, the exam ples suggest that the relation may be rather general. G iven a model of boundary interaction suspect of being integrable, it is worth trying to identify associated ordinary di erential equation. The proposal of [1] was made according to this strategy. Let us brie y sum marize it here.

The main ingredient is the ordinary di erential equation

where P and Q are the X and Y components of the zero-m ode m on entum P, and is the same as in (4); according to the denition (4) we assume for the m on ent that is real and positive.

Eq.(11) has a form of a stationary zero energy Schroedinger equation with specic potential V (x) given by the last three terms in (11). The potential V (x) is positive and grows fast at large positive x, therefore (11) has a solution (x) decaying at x + 1; this condition species (x)

uniquely up to norm alization<sup>2</sup>. To x the norm alization, we assume that

as x + 1. On the other hand, V (x) approaches positive constant <sup>2</sup> at large negative x. Hence Eq.(11) has a solution which decays at large negative x; we denote this solution  $_+$  (x). The condition,

Here and below  $g_D = 2^{1=4}$  is the g-factor [16] of the D irichlet boundary, and W F;G denotes the W ronskian  $F(x)G^0(x) = F^0(x)G(x)$ . Eq.(14) is the proposal of [1].

It was shown in [1] that (14) exhibits the UV (i.e. ! 0) behavior com - p letely consistent with what one expects from the \haipin decom position" of the paperclip at R ! 0. At small the expression (14) can be written as (here we write explicitly the com ponents of P = (P;Q))

with  $f_{0;0} = 1$ . From (14), the powers  $\frac{2}{n}$  appear from the ! 0 expansion of the solution (x), while the integer powers of come from the expansion of + (x).

The expansion (15) is in good agreem ent with expected form of (8) in the 1. Recall that according to (4) and (3) this dom ain corresponds dom ain to the UV limit of the paperclip model, where the paperclip (2) can be regarded as the composition of two hairpins, as in Fig.2. Roughly speaking, the two terms in (15) correspond to contributions from the right and the left hairpins, respectively. More precisely, at small and  $= m P \in 0$  the saddle points of the functional integral (8) correspond to the eld con gurations where the boundary values (X  $_{\rm B}$ ;Y $_{\rm B}$ ) are mostly concentrated near the left or the right end of the paperclip (2). The factors B (P;Q) and B (P;Q) are precisely the boundary overlap amplitudes of the right and left hairpin models (10), respectively. The powers of  $\frac{2}{n}$  in (17) are associated with the perturbative corrections, due to \sm all uctuations around the saddle points, which feel only the small deviations of the shape of the paperclip (2) from the respective hairpin, while the integer powers of are associated with the contributions of the w for 0 topological sectors in (9) (see Ref. [1] for m ore detailed discussion, which also includes the explanation of the factor  $^2$  in (14) and (17) as the e ect of sm all instantons).

On the other hand, when ! 1 (and P;Q are xed) the potential term in (11) becomes large at all real x, and therefore the W ronskian in (14) can be found by straightforward application of W KB technique. This results in the asymptotic ! 1 series

where  $I_{21 1}(P) = I_{21 1}(P;Q)$  are certain polynomials in  $P^2$ ; and  $Q^2$  of the degree 1, with coe cients which depend only on n. It turns out that these polynomials are exactly the vacuum eigenvalues of the local IM of the \paperclip series"  $fI_{21 1}g$ ,

(see [1] for details). This form of IR expansion suggests that at = 0 the IR xed point is just the D irichlet boundary condition for the free eld X = (X;Y):

According to (18) the RG  $\,$  ow approaches the Dirichlet  $\,$  xed point along irrelevant direction which is a combination of densities of the paperclip IM fI<sub>21 1</sub>g.

In this paper we extend the proposal of [1] to the case = . The starting point is the same di erential equation (11), but now instead of + in (14), we take another solution which grows as  $e^{-x}$  at large negative x. O f course, this condition alone does not de ne the solution uniquely since, besides overall norm alization, one can always add any amount of + (x). U sually it is di cult to make unambiguous de nition of a growing solution, but in our case the following property of (11) helps. Let us consider x as a complex variable. The potential V (x) is analytic function of x with the branching-point singularities at all points where  $e^x$  turns to 1. Let us make brunch cuts from each of the points x = i(2N + 1), N = 0; 1; 2;::: to +1 parallel to the real axis, and choose the branch of V (x) on which  $(1 + e^x)^n$  is real and positive on the real axis of the x-plane. Now, restricting attention to the dom ain < ex < 0 one nds that the potential V (x) has the periodicity property

Consequently, the equation (11) has two B loch-wave solutions (2 Z ):

where the B loch factors are found by taking the lim it < ex ! 1. At this point we assume that 2 is not an integer, so that the conditions (22) specify the two independent solutions (x) uniquely, up to their normalizations. O fcourse, the solution  $_{+}$  (x) de ned this way decays as  $e^{x}$  at < ex ! 1, and the asymptotic condition (13) also xes its normalization. The solution

(x) grows at large negative < ex, and its norm alization can be xed by specifying the leading asymptotic in this dom ain. Thus we de ne</li>(x) by the conditions

The ! 0 form of the W ronskian in (26) can be derived through the perturbative evaluation of the solutions (x) and (x), as it was done in [1] for the W ronskian in (14). This leads to the expansion similar to (15),

with exactly the same coe cients f  $_{ij}(P;Q)$  as in (17). This form follows from the fact that integer powers of in (28) come from perturbative expansion of the solution (x); in view of (24) they are related to corresponding integer powers in (17) by the change of the sign, ! . At the same time, the powers of  $\frac{2}{n}$  appear as the result of expansion of (x), and hence they remain unchanged in (28) as compared to (17). Since the powers of  $\frac{2}{n}$  are interpreted as the perturbative contributions to the functional integral (8), while the integer powers of are due to the instanton contributions, the form (27), (28) is exactly what one expects to have from the de nition (9) at = . This property of the UV expansion was the main motivation of our proposal (26).

A compting (26), we can address the problem of the IR behavior of the paperclip model at = . One has to nd the ! 1 asymptotic of the W ronskian in (26). Unlike the case = 0, Eq. (14), this turns out to be rather subtle problem . W hile at ! 1 the W KB approximation still form ally applies to (11), the problem is analogous to the problem of nding the \over-the-barrier" relation amplitude in quantum mechanics which in the sem iclassical approximation requires identifying appropriate \turning points" (the zeroes of the potential V (x)) in the complex x-plane [17]. In

our case, at large all the complex turning points approach the singular points  $e^{x} = 1$  where the sem iclassical approximation for (11) breaks down. Finding correct ! 1 expansion of (26) requires analysis of the solutions of (11) in the vicinities of the singular points  $e^{x} = 1$ . The calculations are rather involved, and will be present them elsewhere. The result is the asymptotic ! 1 expansion

where a is a constant <sup>3</sup>,  $I_{21 1}$  (P) are the same eigenvalues of the \paperclip IM "  $I_{21 1}$  as in (18), and T (P j) is the asymptotic series in inverse powers of  $\frac{2}{n+2}$ ,

Here again P and Q are the X and Y components of the zero-m ode m om entum, i.e. P = P;Q), and the coe cients  $t_1(P;Q)$  are in principle com putable through perturbative solution of (11) in the vicinity of the singular points  $e^x = 1$ . The rst two coe cients can be evaluated in closed form. W e have

while the expression for  $t_2 \ (P \ ; Q \ )$  is somewhat cumbersome, and we present it in Appendix.

The most important di erence of (29) from (18) is in the factor (30) which involves the powers of  $\frac{2}{n+2}$ ; its presence indicates that in this case the IR xed point di ers from the trivialD inichlet boundary constraint (20). The series (30) starts with the term  $2\cos\frac{pQ}{n+2}$  which suggests that in the limit ! 1 the boundary values of X are constrained to two points,

Eq. (32) characterizes the IR xed point of the paperclip boundary ow at = . At large but nite the boundary value  $X_B$ ;  $Y_B$  is allowed to jump between the two points (32), the possibility of such jumps being responsible for the higher-order terms in the series (30). In other words, the RG ow arrives at the IR xed point (32) along certain irrelevant boundary elds which generate such jumps. O by ious candidates are the boundary vertex operators

where is natural coordinate along the boundary (we write  $z=R = e^{\frac{+i}{R}}$ , so that the boundary jzj=R is at = 0),  $[0 \ X ]_{B} = (0 \ X (;) j_{=0})$  is the norm alderivative of the eld X at the boundary, and  $\Upsilon_{B}$  () is the boundary value of  $\Upsilon$ , the T-dual of Y<sup>4</sup>. Note that the dimensions of the elds (33) equal to  $1 + \frac{1}{n+2}$ , which is in exact agreement with the fractional power  $\frac{2}{n+2}$  appearing in the expansion (30). A coording to these arguments, it seems a likely that the full asymptotic series (30) can be generated by expanding the following expression

Here  $jB_D$  i is the boundary state of the free theory (1) with the D irichlet boundary condition (20) which is the superposition  $jB_D$  i =  $d^2P$   $jI_P$  i of the D irichlet Ishibashi states  $jI_P$  i. In what follows we assume that the exponentials in (33) are normalized in such a way that

The relations  $^2 = 0$  guarantee that the boundary values of Y are limited to two points indicated in (32). With this understood, two eigenstates of  $_z$ with the eigenvalues 1 appear to be in correspondence with two possible boundary values  $Y_B = \frac{P_{m+2}}{n+2}$ . At the same time, the -m atrices in (34) can be regarded as operators representing an additional boundary degree of freedom; then the expression in the exponential in (34) is interpreted as the boundary action describing perturbation of the D irichlet boundary condition. Anyhow, the g-factor at the IR xed point (i.e. (29) evaluated at = 1 and P = 0) is  $2g_D^2$ , not  $g_D^2$  as it was in the case of the = 0 IR xed point (20).

A swasm entioned above, the dimensions of the vertex operators (33) are greater than one. As the result, the integrals appearing in the expansion (36) generally diverge when -separations between the insertions V () become small. O ne has to specify some regularization to make the expression (34) meaningful. We assume here the \analytic regularization" common in conform al perturbation theory. The prescription is to consider n as an arbitrary complex number and to evaluate the integrals in the domain of n where they converge (speci cally, at < en < 4), and then to continue in n to the results for all integrals involved in the expansion (36). Thus, the <sup>2</sup> term explicitly written in (36) is readily evaluated in analytic form . Rem arkably, its dependence of the momenta (P;Q) appears exactly the same as in (31), and upon identi cation

it coincides with the rst (l = 1) term  $t_1(P;Q) = \frac{1}{n+2}$  of the expansion (30). We believe that under the identi cation (37), and with the analytic regularization described above, the expression (34) reproduces all terms of the asymptotic series (30), i.e. it plays the role of the \e ective IR theory" describing the approach of the = paperclip ow to its IR xed point (32). Note that the elective theory (34) is expected to capture only the \perturbative" part (30) of the full IR expansion (29), and it does not seem to have any control over the \nonperturbative" terms due to the local IM in (29).

The relation (37) is singular at n = 1. Correspondingly, obtaining correct n ! 1 limit from the elective theory (34) is not exactly straightforward. At n = 1 alternative form of the IR elective theory is more

convenient. It is written as

where again  $[0 X]_{B}$  and  $[0 Y]_{B}$  are the normal derivatives of the elds X and Y at the boundary, and x, y are coupling constants. Form ally, (38) can be brought to the form (34) by eld-dependent gauge transform ation

with obvious relabeling of the -m atrices to m atch the notations in (34). The subtlety in this transform ation is in the renorm alization of the parameters. Perturbation theory in the couplings  $_{\rm X}$ ,  $_{\rm Y}$  in (38) has logarithm ic UV divergences which lead to renorm alization of these parameters. In view of the X \$ Y symmetry the corresponding RG ow equations can be written as

where E is the RG energy scale, and  $g_x = \frac{2}{x}$ ,  $g_y = \frac{2}{y}$ . The model (38) was studied in [19], where the leading (one-loop) term of the beta-function is presented,

The higher loop term s depend on the renorm alization scheme. One can note that (34) is easily evaluated in the limit when  $g_x ! 0$  with  $g_y$  kept nite (or when  $g_y ! 0$  with nite  $g_x$ ). It follows from this solution that a class of \natural" schemes exists in which

where the constant b is scheme independent. Explicit two-loop calculation yields b = 4. The terms  $d^4$  and higher still depend on the scheme. It looks likely that any RG ow equation of the form (40) with the -function

satisfying (42) and having the expansion (43) with b = 4 can be brought, order by order in g, to the follow ing convenient form

The RG ow (44) conserves the dimense  $= \hat{g}_y \quad \hat{g}_t$ . In the coordinates  $\hat{g}_x; \hat{g}_y$  the RG trajectories are straight lines which end at the IR xed points  $g_x = 0$  if > 0, or  $g_y = 0$  if < 0. Let us assume here 0. The RG invariant can be related to the parameter n in (34),

Indeed, at the IR xed point  $g_x = 0$  while  $g_y = \frac{1}{1+1}$ ; the last quantity must coincide with the dimension of the coupling constant in (34). Integrating (44) one nds

where  $E_0$  is the integration constant; one can set  $E_0 = C E$  with an arbitrary constant C. The equations (46), (47) de ne a family of E-dependent renormalized coupling constants  $\hat{g}_x$ ;  $\hat{g}_y$ . It is clear that (38) admits perturbative expansion in these coupling constants, and if one chooses  $E = R^{-1}$  the coe cients of this series are undependent of R.

Let us consider the case n = 1 which is of special interest because it corresponds to the circular brane m odel [2] at =, and hence is equivalent to the Am begaokar-Eckern-Schon m odel [3] of quantum dot at the degeneracy point. Obviously, in this limit the form (30) of the IR asymptotic expansion of the boundary am plitude is no longer meaningful. Instead, in this case the factor T (P j ) in (29) rather expands in powers the \running coupling constant"  $\hat{g}$  related to by the equation

The same relation is obtained by integrating the RG equation (44) with  $\hat{g}_x = \hat{g}_y = \hat{g}$ . It is possible to show that at n = 1 the factor T (P j ) in (29) expands as

which is in perfect agreem ent with the results of renorm alized perturbation theory in (38).

The di erential equation (11) can be integrated numerically, thus providing high precision numerical data for the disk partition functions (14) and (26). To handle the circular-brane case n = 1 an appropriate limit of the di erential equation (11) has to be taken. Making shift of the variable x = y logn and then sending n to in nity, one obtains the di erential equation (124) of Ref. [1], while the asymptotic condition for the solution is also suitably modiled, see Eq. (126) of Ref. [1].

In Table 1 we compare data for the boundary entropy [16,20] of the circular brane (Ambegaokar-Eckern-Schon) model




Figure 3: The boundary entropy  $S = S \log(g^2)$  (51) for the circular brane model, as a function of the dimensionless inverse temperature for = 0; , derived from (14) and (26).

where S S  $\log(q_{f}^{2})$ . The boundary entropy for = 0; as a function of the dimensionless inverse temperature =  $\frac{E}{2T}$  is plotted in Fig.3.

Om itting details, we would like to mention here that using methods developed in [21] (see also [13,23]) one can reduce the calculation of the W ronskians (14), (26) at special values of the parameters to solution of certain system of nonlinear integral equations, the  $\TBA$  system ". For example, for integer n and




Figure 4: Incidence diagram for the TBA system in the case of the paperclip brane with an integer n 3 and P = 0; Q =  $\frac{1}{P_{n+2}}$ . The source term indicated near the corresponding node.

the amplitude Z (P j) (7) is expressed through solution of the D<sub>n</sub>-type TBA system, associated with the diagram in Fig.4. It is remarkable that this system coincides exactly with the system of TBA equations for the Toulose limit of the n-channelK ondo model [22], while the entropy S<sub>j</sub><sup>(K ondo)</sup> of the impurity spin  $j = \frac{n-1}{2}$  is given by

where P = 0;  $\frac{p}{n+2}$  and E is identified with the K ondo temperature. Notice that at this choice of P;Q the coe cient  $t_1$  in the low-temperature expansion of the partition function (30) vanishes and the expansion starts with  $t_2$  (see Table 2 in Appendix). Also, this TBA system (see Fig.4) differs

only in the structure of the \source term s" from the TBA system associated with the H $_n^{~(0)}$ ; H $_n^{~()}$  m odels [24], which are certain integrable perturbations of the m inim al Z $_n$ -paraferm ionic CFT.

To summ marize, we have proposed exact partition function of a nontrivial model of boundary interaction { the paperclip model. There are parallels between this model on one side, and the bulk sigm a-models such as the O (3) nonlinear sigm a model and the \sausage" model [7] on the other. In particular, according to our proposal, the addition of the topological term with = in the paperclip model leads to a non-trivial IR xed point. In the lim it when the parameter n goes to in nity the paperclip model reduces to the \circular brane", which is equivalent to the Am begaokar-E ckem-Schon model of a quantum dot. At nite integer n our proposal suggests intriguing form al relation to the n-channel K ondo model in the Toulose lim it.

The above representation is very useful in num erical evaluation of this coe cient because of the fast convergency of the integral in (61). In Table 2 we present the num erical values of the coe cient  $t_2$  at some integer n and P; Q given by Eq.(53). These numbers were also con rm ed by num erical integration of the TBA system depicted in Fig.4.
