Generic chiral super eld model on nonanticom mutative $N = \frac{1}{2} \text{ superspace}$

A bstract

We consider the generic nonanticom mutative model of chiral-antichiral super elds on $N=\frac{1}{2}$ superspace. The model is formulated in terms of an arbitrary Kahlerian potential, chiral and antichiral superpotentials and can include the nonanticom mutative supersym metric sigma-model as a partial case. We study a component structure of the model and derive the component Lagrangian in an explicit form with all auxiliary elds contributions. We show that the in nite series in the classical action for generic nonanticom mutative model of chiral-antichiral super elds in D=4 dimensions can be resumed in a compact expression which can be written as a deformation of standard Zumino's lagrangian and chiral superpotential. Problem of eliminating the auxiliary elds in the generic model is discussed and the rest perturbative correction to the ective scalar potential is obtained.

Supersymmetric eld theories on deformed superspaces with nonanticommuting coordinates possess the interesting properties in classical and quantum domains. Remarkable class of such theories based on special deformation of N=1 supersymmetry was proposed by Seiberg [1]. Seiberg's type of superspace deformation introduces the nonanticommutativity both even and odd coordinates but preserves anticommutativity in the chiral sector. As a result, the corresponding deformed superspace breaks the supersymmetry in the antichiral sector and therefore it is called $N=\frac{1}{2}$ superspace. Formulation of analogous deformation in N=2, N=4 superspace was given in [2]. Studying of various aspects of $N=\frac{1}{2}$ supersymmetric theories has been carried out in a number of recent papers (see e.g. [3], [4], [5] for N=4 models and [6], [7] for N=2 models). It is worth pointing out that the most general deformation of N=1 superspace was constructed in work [8].

To interpret the $N=\frac{1}{2}$ supersym metric theories as conventional eld models and to clarify their dynam ics it is necessary to rewrite such super eld theories in the component form. Finding the component structure of the nonanticom mutative theories is a highly non-trivial technical problem because of the very complicated superspace structure and therefore it demands a special study. Component form of actions for nonanticom mutative theories in addition to standard terms always will contain the terms dependent on the superspace deformation parameter. Since a half of supersym metries is broken down a symmetry between chiral and antichiral superspace coordinates is absent and some component elds can enter in the action in very cumbersome combinations.

In the papers [1], the component structure of D=4, $N=\frac{1}{2}$ supersymmetric models Yang-Mills theory and the Wess-Zumino was studied. For this case it was shown that the deformed theory is renormalizable [4], [5] in spite of the presence of higher dimensional terms in the Lagrangian and preserves locality. However the generic D=4, $N=\frac{1}{2}$ supersymmetric chiral-antichiral theories in four dimensions, which formulated in terms of an arbitrary Kahlerian potential K (;) and arbitrary chiral and antichiral superpotentials W (), W (), have not been considered in the literature 1. W ewill call such theories the generic chiral super eld models. It is worth pointing out that just generic chiral super eld models (with W = 1 supersymmetry) emerges in the low-energy limit of the superstring theory (see e.g. [9]) and widely used in the superstring phenomenology (see e.g. [10]).

In this paper we study the D = 4 generic chiral super eld model in N = $\frac{1}{2}$ superspace and derive its component structure. Explicit expressions for the Kahlerian, chiral and antichiral superpotentials are not xed. We show that the component action is represented as an in nite

¹Though there is a well known connection between D=4, N=1 and D=2, N=2 superspaces (for recent review see Refs. [6],[7] and reference therein) a distinct feature appears in two dimensional models in comparison to four dimensional models. Such theories in two dimensions appear as a result of nontrivial reduction from D=4 chiral and vector multiplet. Particularly in addition to the chiral multiplet it is also possible twisted multiplets. Two-dimensional models have additional remarkable feature (like conformal and mirror symmetries) and other special properties. Therefore one can expect that the various reductions from D=4 nonanticommutative generic chiral-antichiral super eld model to D=2 will lead to various D=2 models and structure of D=4 model can not be restored on the base of the known structure of D=2 model. This circum stance justi es necessity for independent study of D=4 nonanticommutative models.

series in nonanticom mutativity parameter with one cients depending on the derivatives of above potentials. Despite this fact, it is possible to write down the action in a closed form via smoothing integrals of the Kahlerian K and chiral W superpotential around the bosonic component of the chiral supereld on a scale dependent on the deformation parameter and the auxiliary eld $\frac{1}{1}$ det CF. This e ect is in an agreem ent with an observations of Ref. [14] for D = 2. For N = 2 sigm a model nonanticom mutativity induces simple deform ations of the Zum ino Lagrangian along with the holom orphic superpotential. This phenomena is interpreted as a fuzziness in target space controlled by the vacuum expectation value of the auxiliary eld.

For D = 4 sigm a-m odel with a pure Kahler potential we demonstrate that like in D = 2sigm a-m odel [15] one can rede ne the target space m etric by such a way that the sym m etry between the the holomorphic and anti-holomorphic terms in the action became formally restored. We also discuss a problem of eliminating the auxiliary elds for the case of constant physical elds. We think this allows to exam inate classical structure of vacua for the deformed theory.

We begin with consideration of the N = $\frac{1}{2}$ deformed superspace. A coording to Seiberg, the coordinates of this superspace are de ned such a way that G rassm annian coordinates are not complex conjugate to one another (() θ -) and the anticommuting coordinates form a Cli ord algebra

In contrast to the spacetime coordinates x^{m} , the chiral coordinates $y^{m}=x^{m}+\frac{i}{2}$ $^{m}_{-}$ - can be taken commuting, while the antichiral coordinates $y^m = y^m$ i m - do not com m ute. B ecause the anticom m utation relation remains undeformed, is not the complex conjugate of, that is possible only in the Euclidean space. The generators Q induce the transform ations corresponding to unbroken N = $\frac{1}{2}$ supersym m etry.

where = $\frac{1}{2}$ C C . The star-product (5) is invariant under the action of Q but is not invariant under action of Q .

Described deform ation preserves the half of N=1 supersymmetry and has interesting properties in the eld theory viewpoint. Replacing all ordinary products with the above ?-product, one can proceed studying a supersymmetric eld theory in this nonanticom—muting superspace taking into account that this deformed supersymmetry algebra admits well-de ned representations. Namely, the chiral super eld—is de ned by the standard relation $D_{-}=0$, which means $(y;)=(y)+(y)^{-2}F(y)$. Antichiral super eld is also de ned by the standard relation $D_{-}=0$, which means $(y;)=(y)+(y)^{-2}F(y)$. As it has been demonstrated in Ref. [1], the ?-product (5) of the chiral super elds is again a chiral super eld; likewise, the ?-product of the antichiral super elds is again an antichiral super eld. This observation allows to extend well-studied anticommutative theories on nonanticommutative versions by simple replacement the point product with the star-product.

The action of the generic chiral super eld model on N=1=2 superspace is 3

where K(;);W();W() are the arbitrary K ahlerian potential, chiral and antichiral superpotentials respectively and the super eld multiplication is denied in terms of the star-product (5).

Since the star-product (5) always begins with the point product A?B=A B+ it is easy to understand that the action (6) can be written as a sum of the action for the general chiral super eld model on undeformed N=1 superspace (see for example [11]) and some contributions higher dimensions resulting from deformation of the superspace. But the action is local. Further we will write the action (6) in component elds and study its structure.

We consider the chiral superpotential component form and write it as a Taylor series:

where the expansion coe cients W_1 ; W_2 were de ned above. As one can see the great di erence between forms of chiral and antichiral superpotentials appears. Obviously the action doesn't have Herm iticity properties.

The most nontrivial calculation is related to the Kahler potential decomposition. We will suppose that its expansion is fully symmetrical in powers of f and f, i.e.

Since the general chiral super eld model on $N = \frac{1}{2}$ superspace includes the action (29) we expect that the potential (33) for the model under consideration should be modified by dependent on deform ation parameter terms.

The Lagrangian (30) presents all terms independent on (which survive at = 0 in (27)), while the new term L is conditioned by the superspace deformation and depends on

The relations (28, 30, 34) give the component structure for the considered deformed generic chiral super eld model.

The obtained representation for the action (27) is complicated and inaccessible even in the classical domain. Now we show that the in nite series (27) can be resummed in a compact expression similar to the standard Zumino's Lagrangian [12] with the deformed Kahler potential and the chiral superpotential plus a nite number of higher dimensional terms with eld-dependent couplings. In the analogy with the trick used in the papers [13, 14] we introduce "fuzzy elds" controlled by the auxiliary elds + F on interval 1:

It is quite remarkable that the deformation encoded by new geometric quantities which look like the "metric" $K_{11}^{(0)}$, "connection" $K_{21}^{(0)}$ and the "curvature" $K_{22}^{(0)}$ in the smearing target space. But there is no any certainty that this quantities are really consistent among them selves and correspond to some geometrical structure of the target space manifold.

It is easy to see that the rst and the third terms in the second line of (36) up to space-time derivatives of the auxiliary eld F can be written as $\frac{1}{2}$ @ - @ _ K $_{11}^{(1)}$. This is quite natural because though the initial Lagrangian (6) has the Kahlerian form the $N=\frac{1}{2}$ superspace is not a Kahlerian manifold (is not the complex conjugate of). This property was rstly noted in the recent work [14] for N=2, D=2 nonanticommutative sigm a model.

Now consider generic nonanticom muting supersymmetric sigma-model (i.e. the model without superpotential W but with arbitrary Kahlerian potential K). It was shown in Ref. [15] that for D = 2, N = 2 nonanticom muting sigma-model the component action in nite series can be resummed to a very simple and clear form. Let's consider such possibility for D = 4, N = $\frac{1}{2}$ nonanticom muting sigma-model. In the linear approximation on the Lagrangian (27) after introducing a new metric $g = g + \frac{1}{6}F^2K_{31}$ can be rewritten as follows

and at that time two last terms 4 that vanish. This allows to note that the expression $(g + \frac{1}{2}F^2K_{31} + \frac{1}{3}F^2K_{41})$ become equal g. Thus we see that Lagrangian (39) in the 1st order on is one to one correspond to the Zum ino Lagrangian with the metric g. We point out that such a consideration is true only W = 0 and for a singlet ferm ionic eld. In accord with Ref. [15] one can verify that the action given by Eq. (27) at W = 0 and W = 0 in all orders on can be rewritten in the form Eq. (39).

Next we discuss elim ination of the auxiliary elds F; F from the component Lagrangian (27) keep in mind the task investigate the structure of classical vacua. The Lagrangian (27) is linear in F but strongly nonlinear in F. Therefore it is dicult to expect that we obtain the exact solution on F and F but we can perturbatively not several rst corrections to the scalar potential and to the scalar – ferm ion interaction terms. In particular, the scalar potential is the most important object for study the possible vacua of the theory and a symmetry breaking mechanism studying. Let's consider only space-time independent vacuum expectation values for the scalar and ferm ionic physical elds. We suppose that

where F_0 and F_0 are the solutions for auxiliary elds equations of motion presented by the Eq. (31), F_n , F_n are the corrections. Substituting (41) into the Lagrangian (27) and keeping only linear in terms without derivatives we obtain rst corrections to the auxiliary elds

This gives us, in addition to the ordinary potential U presented by (33), a linearly dependent on correction

where F_0 ; F_0 and F_1 ; F_1 are given in Eqs. (31, 42) respectively. As a result, we nally get that the potential U given by Eq.(32) and a series of additional terms dependent on . Considering the expressions (33, 42, 43) one can see that the full potential as a function of the scalar elds and fermionic condensate h^2 i can be as positive as negative dened depending on concrete forms of the Kahlerian and chiral superpotentials. It means, in general, that at nonvanishing the potential possesses a possibility to get a minimum, though the initial potential (33) has none minimum. Therefore one can expect some kind of symmetry breaking

in the model under consideration. This very interesting aspect is out of this paper subject and deserves a separate study.

To sum marize, we have considered the supersym metric generic chiral super eld model on $N=\frac{1}{2}$ nonanticom mutative superspace. This model is given in terms of arbitrary Kahlerian potential, chiral and antichiral superpotentials. We have developed a general procedure for deriving the component structure of the model and obtained the component action in the explicit form as a in nite series in the nonanticom mutativity parameter. This series is sum med up into compact expression using the species integral representations. It was shown that the additional "deformed" part of the action allows a perturbative translation invariant solution for the auxiliary elds equations of motion. Leading corrections to nondeformed potential are calculated. The results obtained can be applied to studying a wide class of various $N=\frac{1}{2}$ chiral super eld models including supersymmetric sigma-models and models with different chiral and antichiral superpotentials.

A first we had put this work in the hep-th ArX iv, the work [13] appeared, where the component structure for chiral superpotential (12, 18) has been obtained. A first that two papers [14] and [15] related to studying the component structure of N=2, D=2 nonanticommuting sigm a models appeared.
