# Plane wave lim it of local conserved charges

#### A bstract

We study the plane wave lim it of the Backlund transform ations for the classical string in AdS space times a sphere and obtain an explicit expression for the local conserved charges. We show that the Pohlm eyer charges become in the plane wave lim it the local integrals of motion of the free massive eld. This xes the coe cients in the expansion of the anomalous dimension as the sum of the Pohlm eyer charges.

#### 1 Introduction.

AdS/CFT correspondence is a strong/weak coupling duality. It maps the strongly coupled N = 4 Yang-M ills theory to the Type IIB superstring theory on  $AdS_5$   $S^5$ . It is a useful tool for studying the dynam ics of the strongly coupled Yang-M ills theory, but it would be even more important to use this duality to learn more about the string theory. AdS/CFT correspondence relates the string theory to the gauge eld theory which at this time is understood much better then the string theory. It would be useful to learn how to rewrite the gauge theory in stringy degrees of freedom.

Recently the classical strings in  $AdS_5$   $S^5$  were identied on the gauge theory side as coherent states in the sector of single-trace operators with the large R-charge [1, 2, 3, 4, 5, 6, 7]. The dynam ics of such states is essentially classical because they are composed of the large number of partons (a large number of degrees of freedom).

It was conjectured that the number of partons is in the classical lim it a conserved quantity [8]. We have argued in [9] (using the results of [10, 11, 12]) that this conserved quantity corresponds to a hidden symmetry of the classical string theory in  $AdS_5$   $S^5$ . Classical string in  $AdS_5$   $S^5$  is an integrable system [13, 14, 15, 16, 17, 18]. An in nite family of local conserved charges was found by Pohlm eyer [19]. The hidden symmetry corresponding to the length of the operator is generated by an action variable; it is an in nite linear combination of the Pohlm eyer charges.

In this paper we will x the coe cients of this in nite linear combination by considering the plane wave  $\lim$  it [20]. In the plane wave  $\lim$  it the world-sheet theory becomes the theory of free massive elds. Our action variable in this  $\lim$  it counts the total number of oscillators in the excited state. We will apply the Backlund transform ation in the plane wave  $\lim$  it and obtain in this  $\lim$  it an explicit expression for the generating function of the local conserved charges. We will not that the Pohlm eyer charges become the local conserved charges of the free massive elds, and that the oscillator number is indeed an in nite linear combination of them.

The explicit expression for the action variable and the arguments of [22] allow us to answer the following question: given the classical string world-sheet in  $AdS_5$   $S^5$ , how to compute the anomalous dimension of the corre-

sponding eld theory operator? The answer is given by Eq. (45).

Integrability is a very useful feature of the AdS/CFT correspondence, and the plane wave  $\lim$  it provides an interesting tool for understanding the integrable structures. The worldsheet sigm a-m odel can be understood in some regime as an integrable perturbation of the free massive theory. Integrable structure of the worldsheet theory was studied from this point of view in [23, 24, 25]. In particular, the plane wave  $\lim$  it of the commuting conserved charges (and the  $1=R^2$  corrections) was studied on the classical and quantum level in [24, 25]. The way we use the plane wave  $\lim$  it here is somewhat  $\lim$  illar to considerations in Sections 2 and 3 of [26].

# 2 $AdS_5$ $S^5$ and the plane wave.

# 2.1 A special choice of coordinates in $AdS_5$ $S^5$ .

Let us consider the embeddings of  $AdS_5$  as the hyperboloid  $AdS_5$   $R^{2+4}$  and  $S^5$  as the sphere  $S^5$   $R^6$ . Let  $X_1; X_0; \ldots; X_4$  denote the coordinates of  $R^{2+4}$  and  $Y_1; \ldots; Y_6$  the coordinates of  $R^6$ . The hyperboloid and the sphere are given by the equations

W e will consider the string localized near the equator of the sphere. The following parametrization of A dS $_5$  S $^5$  is useful:

Here is a small parameter which is usually chosen to be of the order 1=R. We will use the conformal coordinates on the worldsheet. This means that the embedding x(;) satisfies the constraints:

In the plane wave perturbation theory the embedding x(;) has a regular expansion in powers of . Let us describe the rst approximation.

### 2.2 An approximate solution for the classical string.

Let be a constant parameter. There is an approximate solution for which the eight \transverse" coordinates  $x_1; ...; x_4; y_1; ...; y_4$  satisfy the plane wave equations of motion

To describe this solution we have to de ne  $x_+$  ( ; ) and x ( ; ). Let us introduce the functions  $x_A$  ( ; ) and  $x_S$  ( ; ) de ned by the equations:

where is an arbitrary function of ; satisfying ( $Q^2 Q^2$ ) = 0. The results of the calculations in this paper do not depend on the choice of . We will use = c with a constant<sup>3</sup> c. We put:

This solves (4) approxim ately, the right hand side of (4) is of the order  $^3$ . It is possible to modify the de nition of x  $_{;A}$  and x  $_{;S}$  by the term s of the order  $^2$ , so that the modi ed solution solves the constraints (3) exactly. These corrections will not spoil the equations of motion (4) in the order  $^2$ ; we will not need the explicit formula for these correcting terms in this paper.

#### 2.3 Relation between and angular momentum.

The string worldsheet action in the plane wave region is:

Here ::: denotes the term s which do not contain time derivatives and the term s of the higher order in  $^2$ . We will write  $y^2$  or (y;y) instead of  $_{_{i=1}}^{p^4}y_jy_j$ .

The vector eld  $\frac{\ell}{\ell x}$  is a Killing vector. The corresponding momentum up to the term s of the order o(2) is

- 3 Backlund transform ations and Pohlm eyer charges.
- 3.1 Backlund transform ations.

We will restrict ourselves to the case when  $x_1 = :::= x_4 = 0$ , which means that the string uctuates only in  $S^5$ ; the projection of the worldsheet to  $A dS_5$  is a xed timelike geodesic. We will discuss the general case  $x_i \in 0$  at the end of the paper. Consider the Backlund transformation which does not change the AdS part of the worldsheet X but changes the  $S^5$  part Y! Y°:

Here is a constant parameter. We will also use the notation Y ( ) =  $Y^0$ . Notice that

Let us apply the transform ation Y ! Y  $^{0}$  in the plane wave  $\lim$  it. At the zeroth order in  $^{2}$  we get:

The parameter  $^{1}$  is the small parameter of the null-surface perturbation theory. In the leading order in 1= we have  $\ell_{+}$   $^{1}$   $\ell_{2}$  and the Backlund transform ation is just a time shift:

This formula follows directly from (14). We have used that  $\ell^2 Y = 2Y$  in the limit! 1. Therefore we should consider  $1\ell^2$  to be of the order 1 in the 1= -expansion. We can de ne the Backlund transform ations in the null-surface perturbation theory as perturbative solutions of (14) which are power series in  $1\ell^2$ , the rst approximation given by (18). The corrections to (18) by the higher powers of  $1\ell^2$  involve higher derivatives in and and depend on as rational functions. When is small we can expand these corrections in powers of  $1\ell^2$ , and when is large in powers of  $1\ell^2$ . Therefore the denition of the Backlund transformation as a power series in  $1\ell^2$  agrees with the usual denition as a power series in  $1\ell^2$ .

#### 3.2 Pohlmeyer charges.

The generating function for the conserved charges is given by:

This is the generating function for the \left" Pohlmeyer charges. In the generating function for the \right" charges we replace  $\hat{E_+}$  () with  $\hat{E}$  () which is obtained from  $\hat{E_+}$  () by replacing n! n. We can also consider the average of the left and right generating functions:

#### 3.3 A relation between $E_+$ and E.

It is usually understood that E ( ) is the generating function of the conserved charges; it is de ned as a power series in . But we see from (29) that the expansion in powers of  $\sin^2 = \frac{2}{1+2}$  is in fact the expansion in powers of the expression  $\frac{(!-n)^2}{2}$  1 which is small in the null-surface limit! 1. Therefore we can analytically continue E ( ) to nite values of . It follows from  $!^2 - n^2 = 2$  that

This identity follows from the de nitions (14), (19). Eq. (14) de nes the left Backlund transform ation Y ! Y  $^{0}$ . The de nition of the right Backlund transform ation Y ! Y  $^{0}$  di ers from (14) by  $^{0}$  . W ith this de nition Y  $^{0}$  ( ) = Y  $^{0}$  (  $^{1}$ ). Now (30) follows from the formula (19) for the generating function.

- An action variable in the plane wave lim it. 4
- 4.1 A ction variable and local conserved charges of the free m assive theory.

The Ham iltonian of the plane wave theory is:

This quantity is conserved and generates periodic trajectories. In the oscillator language:

In this section we will show that  $I_k$  descend from the Pohlm eyer charges of the sigm a model on  $S^5$ . We will argue that Eq.(36) provides an expression for the action variable in terms of the local conserved charges (which is valid not only in the plane wave lim it).

#### 4.2 Integral form ula.

There is an integral formula:

This is an integral representation for the action variable in terms of the conserved charges. We derived this formula in the plane wave  $\lim$  it, but we conjecture that it is valid also outside of the plane wave  $\lim$  it. In other words, the right hand side of (38) should generate periodic trajectories on the phase space of the classical string in  $AdS_5$   $S^5$ .

# 4.3 Expansion in powers of $\frac{n}{2}$ .

Let us rewrite (28) in the following way:

These equations agree with the results of [10, 11] (see the discussion in [9]). In the next order we have:

# 4.4 An in nite linear combination of local conserved charges.

Instead of expanding E in powers of  $\mbox{ let us now expand it in powers of } (\sin 2 )^2 = \frac{4^2}{(1+\ ^2)^2}$  . De ne  $G_k$  as follows:

Indeed, the density of the k-th improved current is proportional to  $\dot{p}_S$   $\dot{j}^{-2k}$  where  $p_S=0$   $x_S$  is the push-forward of  $\frac{0}{0}$  by the embedding of the string worldsheet in the  $S^5$ ; it is assumed that and are conformal coordinates on the worldsheet and is periodic with the period  $2_R$ . The plane wave  $\lim_{n\to\infty} it$  keeps the terms quadratic in y. The typical term is  $d\dot{p}_S()\dot{j}^{-2k}(0^kY;0^kY)$ . In the plane wave  $\lim_{n\to\infty} it$   $\dot{p}_S\dot{j}'$  and Y' y. Therefore in the plane wave  $\lim_{n\to\infty} it$  this quadratic term will be of the form  $d^2(0^kY;0^kY)$  which is in agreement with (42) and (35).

Eqs. (26) and (39) in ply that the action variable is an in nite sum of  $G_k$ :

$$J + \sum_{n=1}^{x^{1}} \frac{x^{4}}{n} = \sum_{k=0}^{x^{1}} \frac{1}{2^{2k}} \frac{(2k)!}{(k!)^{2}} G_{k}$$

We have so far considered only the S $^5$  part of the string worldsheet. Therefore the Pohlm eyer charges  $G_k$  which we considered should be really denoted  $G_k^S$ . The index S tells us that these charges came from the S $^5$  sigm a model. One

can introduce in the same way the Pohlm eyer charges  $G_k^A$  in the  $A\,dS_5$  sigm a model. We would get:

$$E = \sum_{\substack{n=1 \ i=1}}^{x^{i}} \frac{X^{4}}{n} = \sum_{\substack{k=0}}^{x^{i}} \frac{1}{2^{2k}} \frac{(2k)!}{(k!)^{2}} G_{k}^{A}$$

Here  $_{n}^{i}$  are the Fourier modes of  $x^{i}$  ( ; ). A rgum ents of 22] show that the anom alous dimension has the following expansion in these charges:

$$\frac{1}{2} \log c^2 = \sum_{k=0}^{x^{\frac{1}{2}}} \frac{1}{2^{2k}} \frac{(2k)!}{(k!)^2} (G_k^S - G_k^A)$$
 (45)

We derived this expression from the plane wave  $\lim$  it, but it should be valid for all classical strings in  $AdS_5$   $S^5$ , at least in the perturbative expansion around the null-surfaces [9, 12, 22]. Eq. (45) agrees with the usual denition of the anom abusdimension in the plane wave  $\lim$  it as E  $\int_{n=1}^{p} \frac{P^4}{n-1} \left(\frac{i}{n} - \frac{i}{n} + \frac{i}{n} - \frac{i}{n}\right)$ .
