On the uniqueness of solutions to gauge covariant Poisson equations with com pact Lie algebras

ABSTRACT

It is shown, under rather general sm oothness conditions on the gauge potential, which takes values in an arbitrary sem i-simple compact Lie algebra g, that if a (g-valued) solution to the gauge covariant Laplace equation exists, which vanishes at spatial in nity, in the cases of 1,2,3,... space dimensions, then the solution is identically zero. This result is also valid if the Lie algebra ism erely compact. C onsequently, a solution to the gauge covariant Poisson equation is uniquely determ ined by its asymptotic radial limit at spatial in nity. In the cases of one or two space dimensions a related result is proved, namely that if a solution to the gauge covariant Laplace equation exists, which is unbounded at spatial in nity, but with a certain dimension-dependent condition on the asymptotic growth of its norm, then the solution in question is a covariant constant.

1 Introduction

Let g denote a sem i-sim ple com pact Lie algebra and let and F denote two g-valued functions on an n-dimensional Euclidean space \mathbb{R}^n . Points in \mathbb{R}^n are denoted by $\mathbf{x} \coloneqq (\mathbf{x}^1; \mathbf{x}^2; \ldots; \mathbf{x}^n)$. The covariant Poisson equation is then the following,

where r $_{\rm k}$ (A) denotes the following gauge-covariant gradient,

In the de nition 2 above, the symbol $A = (A_1(x); A_2(x); ...; A_n(x))$ is a g-valued gauge potential [1], and the symbol [;] stands for the commutator of g-valued quantities. The covariant gradient with an upper index k, $r^k(A)$, is de ned as follows,

O ther quantities with upper space indices are de ned sim ilarly; viz. if V_k is any quantity with a lower (subscript) space index then its counterpart with an upper (superscript) space index V^k is given as follows,

The covariant Poisson equation (1) is a second order elliptic system of partial di erential equations which together with appropriate boundary conditions is supposed to determ ine the quantity (x), when the inhom ogeneous term F (x) and gauge potential A (x), respectively, are given. These quantities are supposed to satisfy appropriate regularity conditions. W e will return to the question of regularity conditions subsequently.

The Lie algebra g is speci ed by the (real-valued) structure constants f_{ab}^{c} in the commutation relations of the Lie algebra generators T_{a} , a = 1;2; ...; dim g,

Here and in what follows, summation of repeated Lie algebra indices, i.e. letters from the beginning of the latin alphabet, over the range 1;2; ...; dim g is im plied, unless otherwise stated.

From now on we will identify the Lie algebra generators with some speci c Herm itean matrix representatives. For the purposes in this paper it does not matter which representation is chosen; in physical applications the choice of representations is related to the question of what types of other elds are coupled to the gauge elds, a question which is not our concern here.

Any g-valued quantity is in the linear span of the generators T_a , thus

where all the components $\ ^{a}$, F a and A $_{k}^{a}$ are real.

The covariant Poisson equation (1) can naturally be written as a system of partial di erential equations for the real-valued components a. U sing the commutator algebra (5) one readily obtains the following system of equations,

In the equation above sum m ation over repeated space indices, one lower and one upper, is also im plied.

For our purposes the compact matrix notation in Eq. (1) is preferable, and this will be used in what follows.

W e will state and prove our main uniqueness theorems in detail for the equation (1) in Sections 3 and 4 below. However before that we collect in the next section a number of facts related to gauge transform ations and innerproducts for sem i-simple compact Lie algebras which we need in the proofs.

2 On gauge transform ations and Lie algebra inner products

Let G denote the Lie group corresponding to the compact or sem i-simple compact Lie algebra de ned by the equations 5) and let ! denote a mapping from Rⁿ to G. In the vicinity of the unit element in G any such G-valued element ! can be obtained by exponentiating the Lie algebra, i.e.

where the parameters a(x); a = 1; 2; ...; dim g are su ciently smooth real-valued functions which vary over a nite range.

A gauge transform ation of a gauge potential A ! A ! is then de ned as follows for any su ciently sm ooth G-valued function ! (x),

Let U (x) be any dimensional equation of the function of the function of the function of the function. Using Eq. (9) one readily shows that

Applying the transform ation (10) to the gauge covariant Poisson equation (1) one obtains

a result which will be used later.

If our Lie algebra is sem i-simple and compact we use the following quantities h_{ab} as our Lie algebra metric. The quantities h_{ab} are dened in terms of the structure constants $f_{ab}^{\ c}$ as follows,

This is the so-called K illing form multiplied with 1 for convenience. It is known [2], that the form (12) is non-degenerate, and furtherm ore positive de nite, if and only if the Lie algebra is sem i-sim ple and compact. The form (12) thus has an inverse, which we denote by h^{ab},

The form h_{ab} (h^{ab}) is used to lower (raise) Lie algebra indices.

For any two g-valued quantities $U = U^a T_a$ and $V = V^a T_a$ we thus de ne their inner product (U;V) as follows,

The inner product (14) is invariant under the adjoint action of the of the group, i.e.,

The norm jj jj, of any Lie algebra valued quantity U is de ned in term s of the inner product,

We also need the fact that for any three g-valued quantities U;V and W the quantity (U; [V;W]) is cyclically symmetric,

The equations (17) follow directly from the fact that the quantities f_{abc} are antisymm etric under the interchange of any indices.

An immediate consequence of Eqs. (17) is the following useful identity,

This identity is valid for any two di erentiable g-valued quantities U and V and a smooth gauge potential A.

We nally note that one may drop the condition of sem i-sim plicity above and require only the condition of compactness of the Lie algebra. One is still then guaranteed the existence of an inner product (;) in the Lie algebra which is positive de nite and satis as the condition (17) of cyclic symmetry [3]. In the considerations below one only needs these properties of the Lie algebra inner product. The results derived below are therefore also valid for the case of only compact Lie algebras, and not only for the case of both sem i-sim ple and compact Lie algebras.

3 Uniqueness theorem s in the cases n = 1 and n = 2

3.1 The one-dim ensional case

In the case of one space dimension, the gauge-covariant Poisson equation (1) is fairly trivial. W e nevertheless give a brief analysis also of this case for completeness. In one space dimension Eq. (1) becomes the following,

where we now use the notation x in stead of x^1 for simplicity.

We then choose a G-valued quantity ! such that

For any smooth gauge potential $A_1(x)$, the (matrix) dimension equation (21) has a G-valued solution, determined apart from a constant initial value at some appropriate point in \mathbb{R}^1 . Then, applying a transform of the type given in Eq. (11) to Eq. (19), with the quantity ! determined by Eq. (21), one obtains,

The question of uniqueness of the solution (s) to Eq. (22) is related to the number of solutions of the hom ogeneous equation corresponding to Eq. (22) under appropriate boundary conditions. The hom ogeneous equation in question,

where and are arbitrary constant g-valued quantities.

If it is required to nd solutions (x) to Eq. (19), which is equivalent to Eq.(22), which grow less rapidly than linearly with x for large x, then the following boundary condition at in nity must hold,

Hence the di erence of any two such solutions, which satis es the hom ogeneous equation 23), and which is of the form $_{\rm h}$ given in Eq. (24) above, must satisfy the condition

Thus one must set = 0 in Eq. (24). Hence, if a solution to Eq. (19) exists, which satis es the condition (25), then the solution is unique apart from an additive covariant constant, i.e. a solution to the hom ogeneous equation of the form

Likewise, if one requires solutions which vanish at in nity, i.e. which satisfy the conditions

then one must have = 0 in Eq. (24). Thus, if a solution to Eq. (19) exists, which satis es the condition 29, then the solution is unique.

W e can sum m arise the discussion above as follows:

Theorem 3.1

A ssume that the gauge-covariant Poisson equation in one space dimension, Eq. (19), has a solution in the classic sense, i.e. a solution which is twice continuously di erentiable in any

nite interval in \mathbb{R}^1 , for a given sm ooth gauge potential $A_1(x)$ and for a given inhom ogeneous term F (x), satisfying appropriate sm oothness and asymptotic conditions in \mathbb{R}^1 . If such a solution grows less rapidly than linearly with increasing x, i.e. satis as the condition 25), then the solution is unique apart from an additive covariant constant. Furtherm ore, if such a solution vanishes asymptotically in the sense of condition (29) then the solution is unique.

3.2 The two-dim ensional case

W e will now consider the gauge covariant Poisson equation (1) in two-dimensional space \mathbb{R}^2 . We assume that this equation has solutions which are twice continuously dimensional space \mathbb{R}^2 . We domain in \mathbb{R}^2 , for a given smooth gauge potential ($\mathbb{A}_1(x^1;x^2);\mathbb{A}_2(x^1;x^2)$) and a given inhom ogeneous term F ($x^1;x^2$), which is supposed to satisfy appropriate smoothness and asymptotic conditions. Let there be two such solutions \mathbb{A} and \mathbb{B} , say. Then their dimensional space

satis es the gauge covariant Laplace equation, i.e. the hom ogeneous equation,

where sum m ation over the space-index k in the range (1;2) is implied here and in what follows. We then consider the quantity

W e then express the r²-operator in terms of polar coordinates (r;) in the plane R^2 ,

Integrating the equation (33) over the variable in the range (0;2) one obtains,

We now consider the equation (35) above as an ordinary dimension for the quantity $^{R}_{R}$ d ($_{C}$; $_{C}$) as if the right hand side of the equation were a known quantity. The general solution to this equation is then the following,

where and are real constants.

In view of the assumed sm oothness of the gauge potential A and assumed regularity of the solution $_{\rm C}$ to the original equation (31), in particular in the vicinity of the origin r = 0 in R², one readily concludes that the term s involving integrals in the expression (36) can not generate logarithm ic singularities at r = 0 which could cancel the term $\log r$ in that expression. The logarithm ic singularity in (36) must be expelled, and this can then only be achieved by setting

= 0. Hence, the general solution to the equation (35) when the regularity conditions at r = 0 are taken into account, is

The vanishing of the integral (40) in the lim it r ! 1 implies that the integrand must vanish, since the integrand is non-positive (for r > 1) in view of convention (3) and the positive de niteness of the Lie algebra inner product. But then, necessarily,

ie. _c is a covariant constant.

We can thus infer from the result above, that if the gauge covariant Poisson equation in R^2 has a twice continuously di erentiable solution , such that (;) is dominated by log r for large values of r, or m ore precisely, if the solution satis es an asymptotic condition of the form (39), then the solution is unique apart from an additive covariant constant. Let us note how ever, that the existence of a non-zero covariant constant in two (orm ore) dimensions places certain restrictions on the gauge potential A, which are related to the internal holonom y group [4].

If one requires a m ore stringent asymptotic condition on the solutions to the gauge covariant Laplace equation than condition (39), namely the condition

We have now demonstrated that the only solution to the gauge covariant Laplace equation in two dimensions which vanishes at spatial in nity in the sense given by Eq. (42), is the identically vanishing solution. This gives rise to a uniqueness theorem for such solutions to the inhom ogeneous gauge covariant Poisson equation, which have a given asymptotic behaviour ^{as} at spatial in nity, ormore precisely, which satisfy a boundary condition of the form

N am ely, suppose that there exist two solutions, $_{\rm A}$ and $_{\rm B}$, say, to the gauge covariant Poisson equation in two dimensions, which satisfy a boundary condition of the form (45) with some appropriate given asymptotic function $^{\rm as}$. Then their dimension $_{\rm C}$ satisfy a boundary condition of the gauge covariant Laplace equation (31) and the following boundary condition,

But then, in accordance with the reasoning above, Eq. (44) must be in force, i.e. $_{\rm A}$ $_{\rm B}$. Thus, if a solution to the gauge covariant Poisson equation in R² exists which has a given asymptotic limit in the sense given in Eq. (45), then the solution is unique.

W e sum marise the results obtained above on the gauge covariant Poisson equation on R^2 as Theorem 3.2. below.

Theorem 3.2

A sum e that the gauge-covariant Poisson equation in two space dimensions has a solution in the classic sense, i.e. a solution which is twice continuously dimensions has a mite domain in R^2 , for a given smooth gauge potential ($A_1(x^1;x^2); A_2(x^1;x^2)$) and for a given inhomogeneous term F ($x^1; x^2$), satisfying appropriate smoothness and asymptotic conditions in R^2 .

If the squared norm $jj = j_{j}^{2}$ of such a solution grows less rapidly than logarithm ically with increasing distance from the origin in \mathbb{R}^{2} , i.e. satis es the condition 39), then the solution is unique apart from an additive covariant constant.

Furtherm ore, if such a solution has a given asymptotic radial limit as in the sense of condition (45), then the solution is unique.

4 Uniqueness theorem in the cases n 3

The analysis of the uniqueness of solutions to the gauge covariant Poisson equation (1) in the cases n 3 proceeds much in the same way as in the two-dimensional case considered in the previous subsection. Thus we assume that the equation (1) has at least two solutions $_{A}$ (x) and

 $_{B}$ (x), say, which are twice continuously di erentiable in any nite domain in \mathbb{R} , for any given su ciently smooth gauge potential (A₁(x);A₂(x);:::;A_n(x)) and given inhom ogeneous term F (x), which satis appropriate smoothness and asymptotic conditions in \mathbb{R}^{n} . We consider the di erence _c (x) of these solutions,

as well as such regularity and asymptotic conditions which follow from those conditions of a similar nature which are supposed to be valid for the solutions $_{A}(x)$ and $_{B}(x)$. In the equation (48) we have for clarity reinstated the explicit sum mation over the space index k and continue to use this notation below.

Again, using the previously established formula (18) and the equation (48) above, one obtains

W e still need the invariant (norm alised) measure d $_n$ on the sphere S^{n 1} in terms of the spherical coordinates above,

Let us emphasize that the equation (61) is a relation which is valid for any twice di erentiable solution $_{\rm C}$ to the gauge covariant Laplace equation (48) with a sm ooth gauge potential A.

We have thus shown that the only twice dimensible solution $_{\rm C}$ to the gauge covariant Laplace equation (48) with a smooth gauge potential A, which vanishes at spatial in nity in the sense of the condition (62), is the identically vanishing solution (65).

The result above gives rise to a uniqueness theorem for the solutions to the gauge covariant Poisson equation (1) in a space R^n of n 3 dimensions, just as in the two-dimensional case. Namely, consider the following boundary conditions,

W e sum m arise the result above as the following theorem of uniqueness:

Theorem 4.

A sum e that the gauge-covariant Poisson equation (1) in n 3 space dimensions has a solution in the classic sense, i.e. a solution which is twice continuously dimensions has a solution domain in \mathbb{R}^n , for a given smooth gauge potential $(A_1(x);A_2(x);:::;A_n(x))$ and for a given inhom ogeneous term F (x), satisfying appropriate smoothness and asymptotic conditions in \mathbb{R}^n . If, furthermore, such a solution has a given asymptotic limit as in the sense of condition (66), then the solution is unique.

5 Summary and discussion

In this paper a uniqueness theorem has been proved for the gauge covariant Poisson equation in n-dimensional space \mathbb{R}^n . The theorem has been obtained by considering the homogeneous counterpart of the Poisson equation in question, i.e. the gauge covariant Laplace equation. It has been shown that the only solution to the gauge covariant Laplace equation, which is twice continuously dimensional in any nite domain in \mathbb{R} , and which vanishes at in nity is the zero solution. This then proves the uniqueness of that solution of the corresponding Poisson equation, which satis appropriate conditions of regularity and has a given asymptotic radial lim it.

In one- or two dimensions the asymptotic conditions can be relaxed; it has been shown that in these cases the solutions, which may be unbounded at in nity, are unique apart from an additive covariant constant, even if one does not specify the asymptotic behaviour of the solutions, but merely imposes certain specific limitations on the asymptotic growth of the solutions.

We have not touched upon the question of existence of solutions in this paper. Such questions have been analysed in depth in the three-dimensional case in a recent paper by Salm ela [6], who uses modern functional analytic methods in his study. This paper also contains references to physical applications of the gauge covariant Poissson equations in \mathbb{R}^3 .
