Five dim ensional 2-branes from special Lagrangian wrapped M 5-branes

A bstract

We present an ansatz for black 2-branes in vedimensional N = 2 supergravity theory that carry magnetic charge with respect to general hypermultiplet scalars. We not explicit solutions in certain special cases and examine the constraints on the general case. These branes may be thought of as arising from M-branes by wrapping eleven dimensional supergravity over special Lagrangian calibrated cycles of a Calabi-Yau 3-fold.

1 Introduction

In this paper, we study black 2-branes in the context of ungauged D = 5 N = 2 supergravity theory that arise from dimensionally reducing D = 11 supergravity on a Calabi-Yau 3-fold M [1]. These branes carry magnetic charge with respect to the hypermultiplet scalars and are dual to the electrically charged instantons discussed in [2, 3]. From a higher dimensional view point they correspond to M-branes wrapping special Lagrangian (SLAG) cycles of M.

In recent years, interest in nonperturbative solutions to N=2 supersymmetric theories has increased due to their relevance to the conjectured equivalence between string theory on anti-de Sitter space and certain superconformal gauge theories living on the boundary of the space (the AdS/CFT duality) [4]. In N=2 supergravity (SUGRA), however, an abundance of studies of solitonic solutions coupled to the vector multiplets exist (for example [5, 6] and other sources cited below), while very little work on the hypermultiplets sector has been produced (for example [3]). It then becomes of particular importance to 11 in this gap, and this paper presents a step in this direction.

A notherm otivation for this work is to extend recent analysis of supergravity solutions for branes w rapping K ahler calibrated cycles to the SLAG case: D=11 Bogom olnyi-P rasad-Som mereld (BPS) spacetimes, known as Fayyazuddin-Smith (FS) spacetimes [7], that describe M2 and M5-branes w rapping K ahler calibrated cycles of C alabi-Y au manifolds have been discussed in [7, 8, 9, 10, 11, 12, 13, 14, 15]. FS spacetimes [7] are specified entirely in terms of a Hermitian metric g_{mn} on the Calabi-Y au space M, which varies as a function of the non-compact coordinates transverse to the wrapped brane. Far from the brane in the transverse space, the Hermitian metric g_{mn} asymptotes to a xed Ricci- at Kahler metric describing the Calabi-Y au vacuum. Moving closer to the brane, variation of g_{mn} describes how the wrapped brane distorts the shape of the Calabi-Y au space. Near the brane, the metric g_{mn} at a xed transverse position is not even approximately Ricci- at (see, for example, [12]).

Supersym m etry requires that the H erm itian m etric $g_{m\,n}$ satisfy certain additional properties that depend on the precise case under consideration. For example, for M 2-branes w rapping 2-cycles of C alabi-Y au N -folds w ith N = 2;3;4;5, it was shown in [13] that the K ahler form $J=ig_{m\,n}\,dz^m \wedge dz^n$ at a xed transverse position satis es the condition

The metric also satis es a nonlinear equation of motion, the precise form of which again depends on the dimensions of the Calabi-Yau and on the dimensions of the brane and the wrapped cycles. Explicit solutions to the FS equations of motion are discult to 10^{2} . On the other hand, one can gain intuition by studying approximate solutions that hold far away from the wrapped brane and correspond to black brane solutions of the dimensionally reduced theory. If we focus on Calabi-Yau 3-folds, for example, then M2-branes wrapping 2-cycles are black holes of the corresponding D = 5 N = 2 supergravity theory, and M5-branes wrapping 4-cycles are black strings [21]. Such black hole and black string spacetimes have been studied [5, 6, 22, 23, 24] in the context of the attractor phenomenon of D = 4;5 N = 2 supergravity discovered in [25, 26, 27, 28].

Recently, an ansatz for D = 11 FS spacetimes corresponding to M 5-branes wrapping SLAG cycles of a Calabi-Yau 3-fold has been constructed [29] using the G-structures approach [30, 31, 32, 33, 34]. The Calabi-Yau metric in this case also satis es a nonlinear equation that is dicult to solve exactly. The black 2-branes introduced here are the dimensionally reduced counterparts of these D = 11 spacetimes. In future work we plan to analyze the relation between these results.

The paper is structured as follows: Section two begins with a review of D = 5 N = 2 SUGRA theory coupled to the universal hypermultiplet. We then proceed to discuss our solutions (section 2.2) representing D = 5 black 2-branes coupled to the universal hypermultiplet. There are two such special cases, corresponding to the dimensional reduction of M 2 and M 5 branes over a six dimensional torus. Section 3 considers the theory with the full hypermultiplets spectrum. For this, we review the special geometry that arises in the space of moduli of the complex structures of the Calabi-Yau space, following the notation of [3]. We construct the form of the general ansatz in section 4, representing a two brane coupled to the full set of hypermultiplets, and not the dimensions constraining the solution. These depend on the explicit form of the underlying compact Calabi-Yau space. Finally, we conclude and motivate further investigation.

2 The universal hypermultiplet solutions

D im ensionally reducing D = 11 supergravity on a Calabi-Yau 3-fold M yields D = 5 N = 2 supergravity coupled to $(h_{1;1} - 1)$ vector multiplets and $(h_{2;1} + 1)$ hypermultiplets [1]; the h's being the H odge numbers of M . M -branes wrapping K ahler calibrated cycles of M deform the K ahler structure of M and reduce to congurations in which the vector multiplets are excited. SLAG

w rapped M -branes, on the other hand, our focus in this paper, deform the complex structure of M and reduce to con gurations carrying charge under the hypermultiplet scalars. The two sectors of the theory decouple and we only keep the hypermultiplets in our presentation. The universal hypermultiplet is present even if $h_{2;1}$ vanishes, and in this section we present D = 5 2-branes for which only the scalar elds of the universal hypermultiplet are excited. We will see that these solutions are easily obtained by compactifying known M -brane solutions of D = 11 supergravity on a 6-torus.

We will use the following notation: The volume form is related to the totally antisymmetric Levi-C ivita symbol by " $_{1\ 2}$ $_{\rm D}$ = e" $_{1\ 2}$ $_{\rm D}$, where e = $\frac{\rm q}{\rm det}$ (g) and " $_{012}$ = +1.

2.1 D = 5 N = 2 supergravity coupled to the universal hyperm ultiplet

We briefy sketch the derivation of the D = 5 Lagrangian following the discussion in [2]. The bosonic elds of D = 11 supergravity theory are the metric and the 3-form gauge potential A. The action is given by

The D = 5 couplings of gravity to the universal hypermultiplet follow from D = 11 elds of the form

where ds_{CY}^2 is a xed Ricci at metric on the Calabi-Yau space M and is the holomorphic 3-form on M with norm k k. The D = 5 elds of the universal hypermultiplet are the real overall volume modulus of the the Calabi-Yau space, the D = 5 3-form gauge potential A and the complex scalar. The D = 5 action is given by ($\frac{2}{5} = \frac{2}{11} = V_{CY}$):

The full action is invariant under the set of supersym metry (SUSY) transform ations:

where and are the gravitini and hyperini ferm ions respectively, the 's are the N = 2 SUSY spinors,! is the spin connection and the hatted indices are frame indices in a at tangent space.

2.2 The solutions

We not explicit solutions with only the universal hypermultiplet elds excited. The rst one may be thought of as a direct reduction of the M 2-brane (i.e. without wrapping) to D = 5. The D = 11 M 2-brane solution is given by

where for the direct reduction to D = 5 we take $f = f(x_3; x_4)$ with $(\theta_3^2 + \theta_4^2)f = 0$. If we let x^5 ;:::; x^{10} be coordinates on a at 6-torus, then putting this into the form of the ansatz for the universal hypermultiplet we nd

This satistic esboth the D = 5 equations of motion (5) and the SUSY equations (6) in a straightforward way, as can be easily checked.

A nother more interesting solution we nd is one which may be thought of as the wrapping of a M 5-brane on a particular SLAG cycle of the 6-torus. Exciting only the universal hypermultiplet

requires a con guration of 4 sets of intersecting M 5-branes as follows

The D = 11 m etric and 6-form gauge potential can then be constructed as follows

where $= dz^1 \wedge dz^2 \wedge dz^3$ is the holomorphic 3-form associated with the complex coordinates $z^1 = x^5 + ix^8$, $z^2 = x^6 + ix^9$ and $z^3 = x^7 + ix^{10}$ on the 6-torus. This satisfies the D = 11 equations of motion and SUSY variation equations provided that the supersymmetry parameters satisfy $= h^{1=3}$ 0, where 0 is a constant spinor.

The corresponding D = 5 elds are then found to be

where the equations of motion are satis ed provided that the function h is harm onic in the transverse space. The SUSY equations are also satis ed provided the constant spinors are simply related by $_1 = i_2$.

3 Special geometry of the complex structure moduli space

The D = 5 N = 2 supergravity Langrangian including the full set of $(h_{2;1}+1)$ hypermultiplets can be written in terms of geometric quantities on the moduli space of the complex structures on the Calabi-Yau manifold M. These structures are discussed in detail in [35] and we will give a brief review here. Start by taking a basis of the homology 3-cycles $(A^{I};B_{J})$ with $I;J=0;1;\dots;h_{2;1}$ and a dual cohomology basis of 3-form s (I;I) such that

De ne the periods of the holom orphic 3-form on M by

The periods Z $^{\rm I}$ can be regarded as coordinates on the complex structure moduli space. Since can be multiplied by an arbitrary complex number without changing the complex structure, the Z $^{\rm I}$ are projective coordinates. The remaining periods F $_{\rm I}$ can then be regarded as functions F $_{\rm I}$ (Z). One can further show that F $_{\rm I}$ is the gradient of a function F (Z), known as the prepotential, that is hom ogeneous of degree two in the coordinates, i.e. F $_{\rm I}$ = $\theta_{\rm I}$ F (Z) with F (Z) = 2 F (Z). The quantity F $_{\rm IJ}$ (Z) = $\theta_{\rm I}\theta_{\rm J}$ F (Z) will also play an important role. Non-projective coordinates can then be given by taking e.g. $z^{\rm i}$ = $z^{\rm i}$ = $z^{\rm i}$ with i = 1;:::;h_{2;1}. The Kahler potential of the complex structure moduli space is K = $z^{\rm i}$ 0 with i = 1;:::;h_{2;1}. The Kahler potential of the periods

An important ingredient in carrying out the dimensional reduction is the expression for the H odge-K ahler duals of the cohom ology basis ($_{\rm I}$; $^{\rm J}$) expressed in terms of the basis itself. This is given by

4 The general case

The derivation of the Lagrangian for the bosonic elds of the D=5 theory is sketched in [3], where Euclidean instantons carrying electric charge with respect to the hypermultiplet scalars are constructed. We follow the notation of [3], with the exception that we will be working in Lorentzian signature. The reduction of the D=11 action is done over the metric (3), and the D=11 3-form is now expanded in terms of the cohom ology basis as follows

where we have de ned:

The scalar elds z^i , z^i with $i=1; \ldots; h_{2;1}$ are complex coordinates on the complex structure moduli space with metric G_{ij} . The scalar elds I ; $^{\sim}_I$ with $I=0;1; \ldots; h_{2;1}$ arise from the dimensional reduction of the D=11 3-form gauge potential. The scalar eld is the overall volume scalar of the Calabi-Yau M and F is the D=5 4-form eld strength. Each hypermultiplet has 4 scalar elds. The scalar elds $(z^i;z^i;^{i};^{\sim}_i)$ make up $h_{2;1}$ of the hypermultiplets. The additional universal hypermultiplet is comprised of the elds $(a;^{\circ};^{\circ})$, where the axion a is the scalar dual of the 3-form gauge potential A .

Further study of the structure of the theory (see [3] and the references within) reveals that the hypermultiplets de ne a $(h_{2;1} + 1)$ dimensional quaternionic space. This structure, in vedimensions, is dual to the special Kahler geometry of the D = 4 vector multiplets sector via the

so called c-m ap (e.g. [36]). This duality justi es the use of the special geometry de ned in x3 as opposed to the explicit quaternionic form.

Furtherm ore, one inds that the theory is invariant under the symplectic group $Sp(2h_{2;1};\mathbb{R})$, i.e. (19) actually de nes a family of Lagrangians that dier from each other only by a rotation in symplectic space that has no election the physics. In fact, if we define

4.1 Constructing the ansatz

Solitonic solutions coupled to the N=2 hypermultiplets are quite rare in the literature. On the other hand, there is an abundance of solutions coupled to the vector multiplets. D=4;5 black holes coupled to vector multiplets, for example, have been extensively studied. In what follows, we are only interested in the case A=0 representing the wrapping of a M 5-brane.

For the scalar elds, we expect that their most general form will be an expansion in terms of more than one harmonic function. In the previous simpler cases, a single function, harmonic in

the transverse space, so ced. We now need to generalize this by introducing a number 2 (h $_{2;1}$ + 1) electric charges q_I and a similar number of magnetic charges q_I , dended by harmonic functions corresponding to each homology cycle on the Calabi-Yau submanifold as follows:

where h and \tilde{h} are constants and r is the radial coordinate in the two dimensional space transverse to the brane. We note that the BPS 2-brane metric is given by

The details of how this does indeed satisfy (39) are very similar to those in Sabra's paper and will not be reproduced here. Finally, one can easily check that these equations immediately yield the universal hypermultiplet solution (11) by setting $(h_{2,1} = 0)$ and integrating (39).

C on clusion

We have discussed the coupling of BPS black 2-branes to the hypermultiplets of ve dimensional N=2 supergravity theory and found explicit solutions in the special case of the universal hypermultiplet. In analyzing the general case, we have used the fact that the quaternionic structure of the theory can be mapped to the special geometry of the four dimensional vector multiplets sector, allowing us to use the more familiar symplectically invariant form of the action for the vedimensional hypermultiplets, following the work of β .

Those 2-branes can be seen as various types of M -branes w rapped over supersymmetric cycles of C alabi-Y au m anifolds. We have particularly focused on the case of w rapped M 5-branes. Further analysis is left for future work.
