M irror e ect induced by the dilaton eld on the H aw king radiation

We discuss the string creation in the near-extrem alNS1 black string solution. The string creation is described by an elective eld equation derived from a fundam ental string action coupled to the dilaton eld in a conform ally invariant manner. In the non-critical string model the dilaton eld causes a timelike mirror surface outside the horizon when the size of the black string is comparable to the Planck scale. Since the fundam ental strings are rejected by the mirror surface, the negative energy ux does not propagate across the surface. This means that the evaporation stops just before the naked singularity of the extrem al black string appears even though the surface gravity is non-zero in the extrem al limit.

I. IN TRODUCTION

It is generically agreed that quantum gravity m ight rem ove pathological objects in classical general relativity like singularity. One of the di culties in quantizing gravity is the non-renormalizability of itself. So, we expect that string theory is the best of candidates for consistent quantum gravity theory since string theory is free of the ultraviolet divergences. It was shown that the rst-quantized string is well de ned on orbifold and weak curvature singularities [1,2]. However, every curvature singularity is not resolved at the rst-quantization level (See ref. [2]) since m assofthe rst-quantized string gets excited in nitely for strong curvature singularities. Such a problem could be resolved by constructing string eld theory describing pair creation of strings.

Law rence and M artinec β] derived an elective string eld equation from the fundam ental string action in which the coupling tem ⁰R between curvature of the world-sheet R and the dilaton eld is absent. Based on the equation the pair creation rate was calculated on various cosm ological models β {5]. W hen the dilaton eld is almost constant, this coupling term is negligibly sm all as this is 0 (⁰). The coupling term, however, could be dom inant near singularity where the dilaton eld diverges. In this paper we investigate the elect of the dilaton eld on the string creation in near-extrem all black strings. The elective eld equation describing the string creation is derived from a string action conform ally coupled to the dilaton eld. To simplify the equation, we dimensionally reduce the fundam ental string to a particle by om itting the string excitations and by com pactic cation.

In E instein G ravity charged black holes are described by R eissner-N ordstrom solution, where the tem perature approaches zero in the extrem all limit. So, the extrem all black hole in E instein G ravity is stable against the H awking radiation. In string theory there are black branes which have nite tem perature and a singular horizon in the extrem all limit. This leads physicists to imagine that the singular horizon, or naked singularity appears by evaporation. This expectation was partially veri ed in [6] by investigating dilatonic black holes.

We investigate the evaporation process of ve-dimensional NS1 black string with Kaluza-K lein charge (W -charge) by the string creation. When the W -charge is zero, the temperature of the black string becomes in nite in the extremal limit and hence the quasi-adiabatic approximation breaks down. When the W -charge is non-zero, the temperature is non-zero but nite in the limit. So, we can test whether the naked singularity appears within the quasi-adiabatic approximation.

For the non-critical string model, we not that the elective eld equation becomes singular at a timelike surface outside the horizon when the black string is comparable to the string scale p_{-0}^{-0} .

We show that the elective eld equation has a unique solution for the initial data with nite energy so that the natural function space of initial data is the Sobolev space H¹. The well-posedness of massive scalar eld was shown in some interesting spacetimes for the eld in the Sobolev space [7]. Since the string current passing through the timelike surface is zero for each mode in the Sobolev space, this surface plays a role of a mirror surface. So, the negative energy ux does not propagate across the surface, implying that the evaporation by the string creation stops before the occurrence of the naked singularity. For the critical string model, we nd that the eldek string continues to evaporate. In Sec.IV, we will argue that the occurrence of the naked singularity could be prevented if we consider the time dependence of the dilaton eld.

For completeness, we also investigate the stability of near-extrem al NS1 black string in which temperature is zero in the extrem allim it. In general it is possible for the zero temperature black hole to evaporate by the spontaneous discharge process, as shown in [8]. We show that the evaporation continues unless the W-charge vanishes. Since the mass-loss rate is smaller than the charge-loss rate, it leaves the extrem al state. So, the naked singularity does not occur.

This paper is organized as follows. In the next section, we form ulate string creation based on the particle picture. In section III, we discuss the evaporation process and superradiance by the string creation. Section IV is devoted to conclusion and discussions.

II. FORM ULATION OF STRING CREATION BASED ON PARTICLE PICTURE

We study the string creation problem in the particle picture, which is obtained by dimensionally reducing the string action with the dilaton coupling term ${}^{0}R$ to the particle one. If we dimensionally reduce the action with the coupling term ${}^{0}R$ directly, then we are faced with a bit technical di culty. It comes from the breaking of the Weyl invariance by the coupling term ${}^{0}R$ at the classical level. Indeed, in the conform algauge $h_{ab} = e^{2}$ ab, the coupling term produces

The interaction term shows that the eld to be unphysical gauge mode becomes dynamical degrees of freedom. Of course, the reason is that we do not incorporate quantum corrections. In order to overcome this diculty by incorporating the quantum corrections, we translate the Polyakov-type action with 0 R term into the action with W eyl invariant dilaton coupling term which gives the same partition function as the original Polyakov-type action. In the appendix A, we explain it in detail.

The Lorentzian action of a test string propagating in D -dimensional target space, which corresponds to the Euclidean action (A 13) is given by

A.Kaluza-K lein reduction of the test string

Hereafter, we would like to consider a test string in (d + 1)-dimensional spacetimes obtained by toroidal compactication. And then, we assume that the (d + 1)-dimensional spacetimes have one K illing direction and a test string extends along the direction only.

Concretely, we consider the background elds as follows;

From the canonical form $P_M X_{-}^M = p \underline{z} + P_d \underline{y}$, we know that P_d is the canonically conjugate momentum of y. Furthermore, the variable y becomes cyclic coordinate, since X^d is the Killing direction.

In the ansatz, we can take the gauge conditions for the world sheet reparam etrization,

From the form er equation in Eq.(II.12), we know that this KK -com pacti ed test string carries the Kalb-Ram ond charge m and the W -charge q.

B.Quantization

Hereafter, we denote the string position coordinates by x. In order to quantize the system, we should make Ham iltonian formulation. Following the standard procedure, we have a Ham iltonian constraint

III. THE EVAPORATION PROCESS ON NS1-W SOLUTION

The metric of the target spacetime and the dilation eld for the NS1-W solution [9] are given by

We denote the charges related to the Kalb-Ram ond eld A and to the KKU(1) eld \hat{A} by Q and Q, respectively. The extremal limit is that the horizon position $r_0 ! 0$, ; ! 1 keeping Q;Q xed. The ADM mass M is bounded below M Q + Q.

The Hawking tem perature and the entropy in the extrem al lim it are given by

so that, in the extrem allimit, the temperature approaches a nite value $T_H = 1 = \frac{p}{Q} = \frac{Q}{Q}$ for d = 4 and the zero temperature for d = 5. Therefore, it is very interesting to consider the evaporation process of near extrem all ve dimensional (d = 4) N S1-W solution.

In the background (III23)-(III24), the metric g appeared on the rst quantization of the fundamental string is given by

As shown in the previous section, the only di erence between usual complex scalar eld equation and our eld equation (II.14) derived from the rst quantization is the di erence between g and g appeared in the kinetic term s. Since p - 0 is the string scale, the corrections from the dilaton eld are negligibly sm all when the the size of the black hole r_0 is much larger than the string scale. How ever, they are important when the horizon becomes comparable to the string scale.

A nyway, since the background is static and spherically symmetric, for simplicity, we consider spherically symmetric solution (S-wave solution) = $e^{i!t}$ (r)= $r^{(d 2)=2}$, and then, Eq.(II.14) reduces to the radial equation

A . evaporation of near extrem alblack string with nite tem perature

We shall consider the evaporation of the ve-dimensionalNS1-W solution, which has nite tem - perature in the extrem allimit.

First we investigate the process by the non-critical string model, $< 0^{z}$. As the black string approaches the extrem al state, H and f can be approximated as

near the horizon. W hen the size of the black hole becom es $r_0 = (1=3)^p \overline{j j} = 3$, the e ective eld equation (III.30) is singular at $r_1 = (1=2)^p \overline{j j} = 3$, since f diverges at r_1 as f $1=(r r_1)^2$.

Let us consider a boundary condition on it. As a physically reasonable condition, we shall in pose that the total energy E is nite:

 $^{^{}z}$ Strictly speaking, we need to use a non-critical black string solution instead of the NS1-W solution for consistency with the non-critical string model. For our best know ledge, the non-critical black string solution is not yet obtained. So, we simply use the NS1-W solution to investigate the creation of the non-critical strings.

So, the surface at $r = r_1$ plays a role of a relective mirror. This means that the evaporation process ceases when the horizon reaches the string scale and that no naked singularity appears for the non-critical string case ^x.

It is worthwhile to comment another meaning of the condition (III.34). Because h; i _{Sob} < (const.) E < 1, the condition (III.34) in poses that the allowed states belong to the Sobolev space H¹ with the inner product (II.21). It is easy to check that $_1 2$ H¹ and $_2 \ge$ H¹. This means that the operator K is essentially self-adjoint in the Sobolev space, so that the initial value problem of is well-posed [10] . E ssential self-adjointness of K is proved by showing that we have no solution in H¹ to the each eigenvalue equation K = i [11], which is reduced to the similar equation to Eq.(III.30),

Due to the singular behavior of the last term of U near r r_1 , both equations become Eq.(III.36) and the solutions behave as Eq.(III.37), so that the solutions in H¹ of Eq.(III.39) should satisfy the boundary condition $(r = r_1) = (r = 0) = 0$ and also (r = 1) = 0. We will have no solution of the eigenvalue equation (III.39) satisfying the above boundary condition, because we have no room to adjust the eigenvalues. Thus, the operator K will be essentially self-adjoint in the Sobolev space.

Secondly, we consider the evaporation process by the critical string model, > 0. As easily checked, the elective potential U in Eq. (III.31) is bounded above by the charges Q and Q as

in the extrem al lim it, in plying that the evaporation continues until naked singularity appears in the extrem al lim it. W hat has to be noticed is that we in plicitly assumed that the NS1-W black

^xW hen the size of the black string becomes $r_0 < (1=3)^p$ j j $^{0}=3$, f can be negative in the region r 2 (r^0 ; r^0) outside the horizon, where $r_0 < r^0 < r_1 < r^0$. So, we have \two time" g_{tt} ; $g_{rr} < 0$ in the region. However, by the same argument in the main text, we can show that the surface at $r = r^0$ also plays a role of a rective m incorowing to the behavior of f at $r = r^0$ as f $1=(r r^0)$ and it makes the \two time" region separate from the asymptotic region $r^0 < r$.

On the other hand, by the m ethod sim ilar to that noted below, we can show that the operator K is not essentially self-adjoint in the linear function space with the square integrability L^2 , so that the evolution is not unique.

string eventually evaporates and then the quasi-adiabatic approximation is valid for all time. We will argue that this condition is violated at the nal stage of the evaporation and that a timelike mirror surface would be formed even in the critical string model in section IV.

B. evaporation of the near extrem alblack string solution with zero tem perature

In this subsection, we discuss whether or not the black string solution in which temperature is zero in the extrem allim it is stable against the string creations. Since the string creation caused by gravitationale ect is negligibly sm all compared with the superradiance or the spontaneous discharge near the extrem allim it, the stability is determined by the spontaneous discharge process only.

The condition for the spontaneous discharge is that there exist the m odes w ith negative phase velocity. From the wave equation (III.30) near the horizon

So, provided that this condition (III.45) holds, the extrem alblack string solution with zero tem perature is stable against the string creation.

In the extrem al limit ; ! 1, the condition (III.45) is automatically broken unless q = 0, so that the black string solution with the W -charge is unstable. By the standard procedure [8], the

This means that the near-extrem alblack string has more discharge rate than mass-loss one. Therefore provided that the quasi-adiabatic approximation is valid, the over-charge process does not occur even for the black string solution with the W -charge, so that the naked singularity at the extrem al state does not appear for the black string solution with zero temperature in both the critical and non-critical string models.

IV.CONCLUSION AND DISCUSSIONS

We investigated the e ect of dilaton eld on string creation in near-extrem alN S1-W black string solutions. For a sim plicity we assumed that the string extends along one K illing direction only. So, it is reduced to a charged particle whose motion is derived from the elective action (II.10) in the lower dimensional spacetime.

As shown in Sec.IIIA the determ inant of the ective m etric" g becomes zero at a timelikesurface outside the horizon when the horizon size is close to the P lanck scale in the non-critical stringm odel. It follows that the eld equation describing the particle creation becomes singular at thesurface. A ssum ing that all the states belong to the Sobolev space H¹, we showed that the evolutionis uniquely de ned for all time and that there is no particle ux propagating across the surface. Inother words, the black string at the P lanck scale is completely enclosed by the timelike <math>m irror" surface and hence the evaporation by the H awking radiation stops. Of course, this conclusion is based on perturbative treatment of strings and the quasi-adiabatic approximation. A libough we need any non-perturbative treatment of string theories for a complete understanding of the whole evaporation process due to the form ation of the mirror surface at the P lanck regime, it is beyond our scope.

It is worth noting that we used a ve-dimensional NS1 black string solution as a background spacetime instead of a non-critical solution simply because no analytical black hole solution is found

in the non-critical string theory. We expect, however, that the determ inant of the \e ective metric"g becomes zero near curvature singularity even in the non-critical solution unless the dilaton eld is nite there.

Finally we comment on the case for the critical string model in a ve-dimensional NS1 black string solution under the quasi-adiabatic approximation. Since the timelike mirror surface is not produced in this case, the evaporation by the Hawking radiation seems continue until the naked singularity appears. Let us consider if the surface is produced or not when we take into account the time-dependence of the dilaton eld. As easily seen in Eq. (III.24), the dilaton eld diverges at the extrem al state. So, the time derivative would also diverge at the extrem al state if the evaporation is completed within a nite time. Since the time component of the metric g changes as

it would become zero at the last stage (note that > 0 in the critical string model). This implies that the a mirror surface preventing the formation of the naked singularity is produced provided that the time dependence is taken into account. This will be discussed in more detail in [12].
