# $F$ in ite-tem perature form factors in the free M a jorana theory

#### Abstract

W e study the large distance expansion of correlation functions in the free $m$ assive $M$ ajorana theory at nite tem perature, alias the Ising eld theory at zero $m$ agnetic eld on a cylinder. $W$ e develop a $m$ ethod that $m$ im ics the spectral decom position, or form factor expansion, of zerotem perature correlation functions, introducing the concept of $\backslash$ nite-tem perature form factors" . O ur techniques are di erent from those of previous attem pts in this sub ject. W e show that an appropriate analyticalcontinuation of nite-tem perature form factors gives form factors in the quantization schem $e$ on the circle. $W$ e show that nite-tem perature form factor expansions are able to reproduce expansions in form factors on the circle. W e calculate nite-tem perature form factors of non-interacting elds (elds that are localw ith respect to the fundam ental ferm ion eld). W e observe that they are given by a $m$ ixing of their zero-tem perature form factors and of those of other elds of lower scaling dim ension. W e then calculate nite-tem perature form factors of order and disorder elds. For this punpose, we derive the $R$ iem ann $H$ ibert problem that com pletely speci es the set of nite-tem perature form factors of general tw ist elds (order and disorder elds and their descendants). This R iem ann $H$ ilbert problem is di erent from the zero-tem perature one, and so are its solutions. O ur results agree w ith the known form factors on the circle of order and disorder elds.


## 1 Introduction

Q uantum eld theory (QFT) at nite tem perature is a sub ject of great interest which has been studied from $m$ any view points (see, for instance, [in $[1]$ ). The $m$ ain goal of QFT is the reconstruction of a set of correlation functions in which the physical inform ation provided by the theory is em bedded. For instance, two-point correlation functions are related to response functions, which can be $m$ easured and which provide precise inform ation about the dynam ics of a physical system at them odynam ic equilibrium. For the purpose of com parison $w$ ith experim ent, it is im portant to know the in uence of a non-zero tem perature on correlation functions. In particular, both static (equal-tim e) and dynam icaltwo-point correlation functions at nite tem perature still need $m$ ore accurate study.

In recent years, thanks to advances in experim ental techniques allow ing the identi cation and study of quasi-one-dim ensional system s (see for instance 恼, 'ī-1]), there has been an increased interest in calculating correlation functions in 1+1-dim ensional integrable m odels of QFT (for applications of integrable $m$ odels to condensed $m$ atter system $s$, see for instance the recent review [ elds in eigenstates of the H am iltonian, or form factors, can be evaluated exactly by solving an
 correlation functions are vacuum expectation values in the $H$ ibert space ofquantization on the line. A usefiul representation of zero-tem perature correlation fiunctions is then provided by their form factor expansion (or spectral decom position):
where is the Euclidean time and $r=\mathrm{P} \overline{\mathrm{x}^{2}+{ }^{2}}$. This expansion is obtained by inserting the resolution of the identity in term $s$ of a basis of com $m$ on eigenstates of the $m$ om entum operator and of the Ham iltonian, param eterized by the rapidity variables j's and by the particle types ${ }^{j}$ 's. Here M () is the mass of a particle of type (and we took the basis of in-states). U sing $m$ any of such insertions, form factor expansions can be obtained formultipoint correlation functions as well. This is a useful representation because it is a large-distance expansion, which is hardly accessible by perturbation theory, and which is often the region of interest in condensed $m$ atter applications. A lso, form factor expansions in integrable $m$ odels at zero tem perature have proven to provide a good num erical accuracy for evaluating correlation functions in a wide range of energies, and combined to conform al perturbation theory give correlation functions at allenergy scales (an early work on this is [ī10]).

In this paper we study the large-distance expansion of correlation functions in the free $m$ assive M ajorana eld theory on a line at nite tem perature. This m odelof 1+ 1-dim ensionalquantum eld theory occurs, for instance, as the o-critical scaling lim it of the nite-tem perature Ising quantum chain (w ith an in nite number of sites) in a transverse magnetic eld, near to its quantum critical point. It also occurs as the o -critical scaling lim it of the statistical Ising m odel on a cylinder, near to its them al critical point; the circum ference of the cylinder is the inverse tem perature of the M a jorana theory. For an exposition on these scaling lim its and
for references of early works，see，for instance，the book［1］픔］．In particular，in both of these exam ples，the elds ofm ost interest are the tw ist elds associated to the $Z_{2}$ sym $m$ etry of the M a jorana theory $[\underline{1} \overline{2}, 1 \overline{1} \overline{3}]$ ．These elds are the scaling lim it of the spin operator in the Ising chain（the Paulim atrix that en joys a nearest－neighbor interaction）and of the spin variables in the statistical Ising $m$ odel．There are tw o of these tw ist elds：the order eld and the disorder eld．They can be seen as representing the scaling lim it of the sam e operator，but in di erent regim es（ordered and disordered）aw ay from the critical point．W hen the $m$ ass is set to zero （at critically），the theory reduces to the well－known Ising conform al eld theory．

The correlation functions of tw ist elds exhibit non－trivial，\non－free＂behaviors，and can be obtained as appropriate solutions to non－linear di erentialequations［1］M1］．At nite tem perature， or on the cylinder，these equations are partial di erential equations in the coordinates on the
 functions，neither for analyzing their large－distance behavior（short－distance behaviors，on the other hand，can alw ays be analyzed by conform alperturbation theory［1］［1］）．Hence it is w orth studying in m ore detail the large－distance expansion of correlation functions of tw ist elds． T his study constitutes a rst step tow ards generalizations to interacting integrable models．In particular，we w illpresent a m ethod that parallels the zero－tem perature form factor expansion．

## 1．1 C orrelation functions at $n$ ite tem perature

At nite tem perature，correlation functions are obtained by taking a statistical average of quantum averages，w ith B oltzm ann weights $e^{L E}$ where $E$ is the energy of the quantum state：

Here， L is the inverse tem perature and H is the H am ittonian．A consequence of the im aginary－

$w$ here $f$ is the statistics of $O$（it is 1 for ferm ionic operators and 0 for bosinic operators），and where the dots（ ）represent local elds at time and at positions di erent from x．Then， nite－tem perature correlation functions can be seen as vacuum expectation values in the sam e m odel of Q FT，but this tim e quantized on a circle of circum ference L ：

where $s$ is the spin of $O$ ．The operator $O_{L}(; x)$ is the corresponding operator acting on the H ilbert space on the circle，w ith space variable（param eterizing the circle of circum ference L）and Euclidean tim e variable x（going along the cylinder）．The vector jvaci ${ }_{L}$ is the vacuum in the $H$ ilbert space on the circle．There are two sectors in the quantization on the circle： N eveu－Schw artz（NS）and Ram ond（R），where the ferm ion elds are anti－periodic and periodic， respectively，around the circle．The trace（ 1 respect to the ferm ion elds naturally corresponds to the N S sector due to the KM S identity．

W ith insertion oftw ist elds, how ever, the sector $m$ ay be changed to $R$ or to a m ixed sector by an appropriate choice of the associated branch cuts. The phase factor in ( $\left(1, \mathbf{N}_{1}\right)$ is in agreem ent $w$ ith the fact that the operator $O_{I}$ is $H$ erm itian on the $H$ ilbert space on the circle, if the corresponding operator $O$ is $H$ erm itian on the $H$ ilbert space on the line.

### 1.2 Previous w orks

A straightforw ard application of the zero-tem perature ideas would suggest a form factor expansion of the vacuum expectation values on the circle ( $1 \mathbf{1}=-3)$ :

where the eigenstates of the $m$ om entum operator and of the $H$ am iltonian on the circle are param etrized by discrete variables $n_{j}$ 's. This form is valid for any integrable $m$ odels on the circle; it can also obviously be generalized to other m ulti-point correlation fiunctions. In general integrable $m$ odels, the energy levels $\mathrm{E}_{\mathrm{n}_{1} ;: \ldots, i n_{k}}$ are not known in closed form (although exact $m$ ethods exist to obtain non-linear integral equations that de ne them : from them odynam ic Bethe ansatz techniques, from calculations a la D estri-de Vega and from the so-called BLZ program ). A lso the $m$ atrix elem ents of local elds L hvac $\mathrm{D}_{\mathrm{L}}(0 ; 0) \mathrm{n}_{1} ;::: ; \mathrm{n}_{\mathrm{k}} \mathrm{i}$ (form factors on
 does not seem to be applicable in general yet. N evertheless, in the $M$ ajorana ferm ion theory $w$ ith $m$ ass $m$, the energy levels are sim ply given by

The form factor expansion on the circle can then be used to obtain the leading exponentially decreasing behavior of static correlation functions in the quantum Ising chain, and, with slightly more work, to obtain the large-tim e dynam ical correlation functions in the sem i-classical regim e tiol. This reproduces early results of $[\underline{2} \overline{\underline{q}} \overline{1}]$ and $[\underline{3} \overline{0} \overline{0}]$.
 from the representation (1ָ. $\overline{1} \mathbf{I})$. By partly perform ing the trace and by using general properties of $m$ atrix elem ents of local elds, the follow ing representation for two-point functions in the

M ajorana theory ofm ass $m$ was obtained:

This expression is better adapted to study dynam ical correlation functions in realtime it than the form factor expansion on the circle. A nother advantage of this idea is that, follow ing
 nant representation for nite-tem perature two-point functions, which can be useful for further
 non-linear partial di erential equations for the two-point function of tw ist elds. This lead to the know $n$ equations plus, in partioular, an additionalequation involving tem perature derivatives. H ow ever, this additionalequation does not follow from any of the other m ethods used in


This idea also seem sto allow m ore easily generalizations to interacting integrable m odels. Such a generalization was con jectured by Leclair and M ussardo in out that this generalization $m$ ight not be correct [3] $\overline{4}]$, and the num erical calculation of $C$ astroA lvaredo and Fring in the scaling Lee-Y ang $m$ odel tended to agree $w$ th this incorrectness [
$N$ ote that veri cations of the results of [13ini] were $m$ ade for som e elds in the com plex (Dirac) free ferm ion and in the Federbush $m$ odel in results in various lim its. Leclair and M ussardo also proposed in th3̄3], along sim ilar lines, a form ula for one-point functions of local operators in interacting integrable m odels, which, after



In the works mentioned above, very little was said conceming nite-tem perature correlation functions $w$ th $m$ ore than two operators.

### 1.3 O urwork

In the follow ing, we w ill develop a schem e for obtaining large-distance representations of nitetem perature correlation functions in the M a jorana theory of the form :

w th appropriate generically L -dependent functions $\mathrm{f}_{1 ;:: ;_{k}}^{0}\left(1 ;::: ;{ }_{k} ; \mathrm{L}\right) . \mathrm{W} \mathrm{ew}$ ill see that this form ula is valid:
w ith both $\mathrm{O}_{1} ; \mathrm{O}_{2}$ elds that are localw ith respect to the ferm ion elds, in the N S sector;
w th one of $\mathrm{O}_{1}$ or $\mathrm{O}_{2}$ a tw ist eld, in a m ixed R-NS or NSR sector;
w th both $\mathrm{O}_{1} ; \mathrm{O}_{2}$ tw ist elds, in the R sector.

This schem e does not say anything new about one-point functions; in particular, the functions $f^{\circ}$ are evaluated up to norm alization using analytic properties in rapidity space. W ew ill only analyze two-point correlation functions, but the techniques and ideas introduced can be easily generalized to $m$ ulti-point correlation functions.

A though our expansion ( $\overline{1} \mathbf{I} . \overline{6})$ for two-point functions is of the same form as the expansion

 this form rst appeared) are in fact incorrect_I. It is a sim ple $m$ atter to check that the positive veri cations of the results of $\left[\begin{array}{l}101,]\end{array} \mathrm{m}\right.$ ade in the w orks described in the previous subsection, being only for simple elds or in particular lim its, can still be m ade on the form ulas that we propose. W ew ill not do that explicitly here, since we have a m uch stronger veri cation of the correctness of our results through their relation with the uncontroversial form factors on the circle. O ur $m$ ain results can be grouped into 4 points that exhibit the di erenœes betw een our approach and results, and those of previous works. They are:

1. De nition of $n$ ite-tem perature form factors. The objects $f_{1 ;:!: ; j_{k}}^{0}\left(1 ;::: ;{ }_{k} ; \mathrm{L}\right)$ in-
 $m$ atrix elem ents $F^{0}$ of $O$ in the $H$ ibert space on the line as was suggested in the proposal [了ె국]. They are rather given by appropriate traces of multiple com mutators ([ ; ]) and anticom mutators ( $f$; $g$ ) on the $H$ ilbert space of the $M$ ajorana theory on the line:
where $a^{+}() \quad a^{y}()$ is a creation operator for a particle of rapidity, and a () a() is an annihilation operator for a particle of rapidity. Simple calculations w ith norm al-ordered products of ferm ion elds, for instance, $m$ ake it clear that generically, these ob jects are not equal to zero-tem perature form factors. The di erence will be explained in Point 3 below .

The techniques we use to derive such a representation are related to the physical theory of particle and hole excitations above a \therm al vacuum ", which was initially proposed m ore than thirty years ago and which developed into a mature theory under the nam e of therm o-
 (İ.71) can be seen as m atrix elem ents betw een a them al vacuum (on the left) and a state w ith particle and hole excitations (on the right), and how the representation (1.. $\mathbf{1}$ ) com es from a resolution of the identity on the space of N S-sector them al states. In fact, there are still very

[^0]few applications of the ideas of integrable quantum eld theory (like the form factor program ) to therm o-eld dynam ics (see, how ever, the recent study $\left.\operatorname{li}_{1}^{1} \frac{1}{1}\right]$ of bosonization in therm o- eld dynam ics). O ur study constitutes a step in this direction.
2. Relation betw een form factors on the circle and $n$ ite-tem perature form factors. W ew ill show that an appropriate analytical continuation in rapidity space of the nitetem perature form factors reproduces form factors on the circle. This links the two sets of ideas m entioned above, and, as we w ill see below, gives an \analytical" way of calculating form factors on the circle. The precise correspondence is given by

where there are $k$ positive charges and 1 negative charges in the indices of $f^{\circ}$, and where $n$ are de ned by

This form ula is valid for any excited states in the NS sector. W hen $O$ is a tw ist eld, form ula ( $1 . \bar{l}_{1}^{\prime}$ ) can then be applied only if one of the bra or the ket is the vacuum, and if the branch associated to this tw ist eld is chosen so that this vacuum is in the $R$ sector and the excited state is in the NS sector. U sing this form ula, we will show that the form factor expansion on the circle and the nite-tem perature form factor expansion give the sam e result.
3. Evaluation of $n$ ite-tem perature form factors. W ewill evaluate explicitly the nitetem perature form factors $f_{1 ;:: \% j_{k}}^{0}\left(1 ;::: ;{ }_{k} ; L\right)$ for some elds. $W$ e nd:

1. M ixing. For any local non-interacting eld $O$ (a eld that is localw ith respect to the fundam ental fem ion eld), they are equal to $m$ atrix elem ents in the $H$ ibert space on the line of a sum of a nite number of local elds, including $O$ as well as operators of low er scaling dim ensions and of equal or lower conform al dim ensions. We will present a procedure for calculating the associated $m$ ixing $m$ atrix. This $m$ ixing can ultim ately be seen as com ing from the di erence between the nom al-ordering on the line and the norm al-ordering on the circle. $N$ ote that in the proposal [3]in기, only the energy eld, am ong non-interacting elds, was studied, and them ixing was treated by adding to this eld the identity operator in such a way that it have zero therm al expectation value. For other elds, such a sim ple prescription would not be enough.
2. Leg factors. For the order and disorder elds, they are given by their matrix elem ents in the $H$ ibert space on the line tim es functions depending on the individual rapidities ( $\backslash \mathrm{leg}$ factors"). These factors w ere absent in thenī1].
$N$ ote that, consistently with (1. $\left.{ }^{-} \mathbf{d}\right)$, both the $m$ ixing phenom enon and the appearance of leg factors are observed in form factors on the circle. In particular, we were able to reproduce from our results the known form factors on the circle.

W e evaluate the nite-tem perature form factors of order and disorder elds by deriving and solving a Riem ann $H$ ibert problem that com pletely xes the set of nite-tem perature form factors of all localtw ist elds (order and disorder elds and their descendants) in the M ajorana eld theory. The R iem ann H ibert problem depends explicitly on the tem perature. For descendant of order and disorder elds, we present a con jecture for the structure in whidh the mixing phenom enon can be described (w ithout, though, calculating the associated $m$ ixing $m$ atrix).

It is im portant to note that since the ect oftem perature on the nite-tem perature form factor of order and disorder elds is only in the leg factors, a Fredholm detem inant representation can straightforw ardly be obtained from the nite-tem perature form factor expansion, as it was
 leg factors. H ow ever, because of these factors, follow ing the derivation of [ī1in] it is clear that the equation involving tem perature derivatives is incorrect, in accordance w ith the suggestion of $\left[1 \overline{1} \bar{n}_{1}\right]$.
4. R esolution of the divergencies. Because of the poles in nite-tem perature form factors of $t w$ ist elds, the representation ( $\left(1 . \mathbf{C}_{1}\right)$, as it stands, su ers from divergencies at colliding rapidities, when they are associated to opposite values of . U sing the link, provided by (1.. Z ), between this representation and the form factor expansion on the circle, we will describe the correct prescription that $m$ akes the integrals in (1.) nite. This point was left slightly unclear in the proposal $\left[\begin{array}{l}\text { NTj } \\ i\end{array}\right]$, were a sim ilar problem arose. Such divergencies at colliding rapidities, how ever, were studied $m$ ore carefully, in a related context, in the recent paper [2̄ $\overline{-1}]$ using ideas sim ilar to those presented here.

Som e of the ideas that we will present have an easy generalization to interacting integrable m odels; this raises hopes that nite-tem perature form factors can also be evaluated in such m odels. W ork in this direction is in progress.

The paper is organized as follows. In Section 2, we recall the quantization of the M ajorana theory on the line and on the circle. In Section 3, we introduce the space of $\backslash$ nite-tem perature state" and explain how nite-tem perature form factors give large-distance expansions of correlation functions. In Section 4, we give an argum ent from basic principles justifying the relation between nite-tem perature form factors and form factors on the circle. In Section 5, we study nite-tem perature form factors of non-interacting elds. In Section 6 , we derive the $R$ iem annH ilbert problem for nite-tem perature form factors of tw ist elds. In Section 7, we calculate these nite-tem perature form factors. Finally, we conclude with a series of open problem s.

## 2 Q uantization of the $M$ ajorana theory on the line and on the circle

In the free $M$ ajorana theory $w$ ith $m$ ass $m$ quantized on the line, ferm ion operators evolved in Euclidean time are given by:

## 3 The space of \ nite-tem perature states" and largedistance expansion of correlation functions

W e are interested in calculating correlation functions in the theory with Ham iltonian $H$ at nite tem perature $1=\mathrm{L}$. They are given by ratios of traces on H as in (1.1.). In particular, the relation (1]. elds and of their space derivatives), the operator $O_{I}$ can be de ned by rst writing the regularization ofo in term sofa product of ferm ion operators ; at di erent points (w thout norm al ordering), then by replacing all ferm ion operators by their corresponding form s on the circle: 7 L; 7 L.

The space of \nite-tem perature states" that we will use is in fact well-known in the literature: it is the Liouville space [4] 4 ], or the space of operators of the theory, End (H ). A s recalled in the introduction, the study of nite-tem perature quantum eld theory using the Liouville space goes under the nam e of them o- eld dynam ics. It is not our intention to go into any detail of this eld of study; we w ill recall only basic principles, in a slightly di erent, but equivalent, form ulation, then develop certain parts for our purposes.

W e will denote by L the (com pletion of the) in nite-dim ensional subspace of End (H) spanned by products of any nite number of $m$ ode operators $a() ; a^{y}()$ at di erent rapidities. This subspace contains local non-interacting elds of the $M$ ajorana theory. The vacuum in $L$ is de ned by the identity on H :

Let us $m$ ake two com $m$ ents. $F$ irst, note that expression (ī), as it stands, is not a practical large-distance expansion. It is $m$ ore convenient, as in the zero-tem perature case, to analyti${ }_{\mathrm{P}}^{\mathrm{P}}{ }^{\text {lly }} \mathrm{l}$ continue to complex values of $j$ 's, in such a way that the argum ent of the exponential, $i^{\mathrm{C}} \underset{j=1}{k}{ }_{j} \mathrm{p}_{\mathrm{j}} \mathrm{x}$, acquires a realpart that becom es large and negative at large $j_{j} j$ for any $j$. This is optim al, if $x>0$, at $j_{j}+i_{j}=2$. However, in contrast to the zero-tem perature case, the theory is not invariant under rotation, hence this shift of rapidities does not keep the form factors invariant. W e will see how this shift is related to a form factor expansion on the circle.

Second, the integrals in the expansion (ī. I ) m ay su er from singularities at colliding rapidities in their integrands. A s we will see, such singularities arise in nite-tem perature form factors of interacting elds when rapidity variables are associated to opposite charges. W e need a prescription to de ne properly the nite-tem perature form factor expansion in such a case. The correct prescription is the follow ing: C onsider the di erence x betw een the positions of the rst and of the second operator involved to be positive; then, we sim ply shift slightly the integration lines tow ards the positive or negative im aginary direction in rapidity planes, in such a way that the integration stays convergent at $=0$ and that the poles are avoided. M ore precisely, the
 W e verify that this prescription is correct, by show ing independently, in A ppendices 'AAA'. and 'B̄',' the form ula ( 1.8 ), and the fact that our prescription $m$ akes the nite-tem perature form factor expansion ( 1

A note on R am ond and N eveu-Schw artz sectors.
Because of the relation ( $(\overline{1}-2)$, ferm ion operators satisfy anti-periodic conditions in Euclidean
 correlation functions on the cylinder $w$ th anti-periodic conditions for the ferm ion elds around the cylinder, that is, in the NS sector in the language of the quantization on the circle.

W hen tw ist elds are inserted inside the trace, the situation is slightly di erent. Twist elds are end-points ofbranch cuts (or line defects), and on the cylinder, a sem i-in nite branch cut can be in two directions. The de nition of operators corresponding to tw ist elds is recalled in A ppendix ' $\bar{C}_{1}^{\prime}$ : we denote two types of operators corresponding to any tw ist eld O by $\mathrm{O}_{+}$ and O , w ith branch cut tow ards the positive and negative x direction along the cylinder, respectively. W e call these operators \right-tw ist" and \left-tw ist" operators, respectively.
$F$ in ite-tem perature correlation functions (İI) w ith insertion of only one tw ist elds (and any
number of ferm ion elds) correspond then to correlation functions on the cylinder in a m ixed sector, the precise $m$ ixed sector depending on which operator (right-tw ist or left-tw ist) is taken. $T$ he ferm ion elds have periodic conditions around the cylinder ( $R$ sector) where the branch cut stands, and anti-periodic conditions (N S sector) elsew here. T his property is essential in deriving the $R$ iem ann $H$ iblert problem for nite-tem perature form factors in Section ' $\mathrm{G}_{1}$. C orrespondingly, our form ula (in. 1.1 ) can be used w th any one of $\mathrm{O}_{1}$ and $\mathrm{O}_{2}$ a tw ist eld, and in both cases, the branch cut can be in either direction.
$F$ in ite-tem perature correlation functions with insertion of two tw ist elds can correspond to correlation functions on the cylinder in a pure NS sector or in a pure R sector, again depending on which operators are taken under the trace. O ur form ula ( $\overline{1} . \overline{\mathrm{G}})$, how ever, can only be used, in this case, to give an expansion of correlation functions in the $R$ sector. T his can be interpreted by the fact that in each nite-tem perature $m$ atrix elem ent of a tw ist eld, there is no other tw ist eld to provide another end-point of the branch cut, so that it must go to in nity along the cylinder, hence it changes the naturalNS sector of the trace to an $R$ sector at in nity. $T$ his can be seen technically by analyzing our $R$ iem ann $H$ ilbert problem given in Section' ${ }^{-}, \overline{\text { or }}$, and by doing a contour-deform ation analysis of the expansion ( 1.0 ), sim ilarly to what is done in
 elds, only when they have branch cuts in opposite directions.

In the sam e spirit, note that form ula ( $\overline{1} . \mathrm{d}$ ) for calculating form factors on the circle from nitetem perature form factors, explained in the next section, can only be used w ith the vacuum (in the quantization on the circle) in the R sector, and excited states in the NS sector.

H ow ever, it can be useful to note that one could \tw ist" the construction of this section by de ning the inner product as traces w ith periodic conditions on the ferm ion elds:

The resulting nite-tem perature correlation functions of ferm ion elds $w$ ill be in the $R$ sector. W ith such a de nition, the formula (i- $\overline{-1}=1$ ) is still valid, but the norm alization factors ${ }_{j=1}^{k} 1+e^{j^{L E}}{ }_{j}$ introduced above should be replaced by ${ }_{j=1} 1 \quad e^{j^{L E}}{ }_{j}$, and a sim ilar replacem ent should be $m$ ade in the nitetem perature form factor expansion (1, (G). Follow ing a sim ilar reasoning as above, the resulting expansion for the two-point function of tw ist elds will be valid, in this construction, only in the NS sector. The nite-tem perature form factors obtained in this construction can then be used to calculate form factors on the circle w ith excited states in the $R$ sector and vacuum in the NS sector, with a formula sim ilar to ( $(\overline{1} . \mathrm{d})$. N ote that starting from the form factor expansion on the circle, a representation sim ilar to (1. $\mathbf{1}$ ) ( $m$ ore precisely, after som e approxi-

 paragraph explains this phenom enon. In the rest of the paper, though, we will not consider this construction.

## 4 From nite-tem perature form factors to form factors on the circle

### 4.1 G eneral idea

 tem perature, or on a cylinder, result from two di erent quantization schem es for the sam e theory: in the rst, the equal-tim e slices are lines along the cylinder, whereas in the second, they are circles around it.

O bserve also that the nite-tem perature form factor expansion of two-point functions (1]. could be $m$ ade into a form factor expansion on the circle ( $\overline{1} \mathbf{I}, \mathbf{I})$, if nite-tem perature form factors have appropriate properties, by deform ing the contours in rapidity space and taking the residues of the poles of the $m$ easure.

There are $m$ ore precise observations that allow us to infer that form factors on the circle can be obtained from nite-tem perature form factors. Let us develop two of them below.
$F$ irst, consider a m assive free theory on the Poincare disk (the D irac theory on the Poincare disk was studied in [45], and we present here ideas exposed there), and consider a quantization schem e where equal-tim e slices are the orbits of one of its non-com pact isom etry (that is, the m om entum operator generates isom etry transform ations I and its spectrum is continuous). In this quantization schem $e$, consider the set of states $\mathcal{P}$ i that diagonalize the m om entum operator, $w$ ith real continuous eigenvalues $P$. In fact, the states can be described by a set of $m$ om enta fpg and a set of discrete variables (particle $m$ om enta and particle types).
$N$ ow consider $m$ atrix elem ents of local spinless operators in this set of states, of the form hvac $\dagger \mathrm{D}$ fipgi, and see them as analytically continued functions of $m$ om enta fpg. Choose a norm alization of the states in such a way that these $m$ atrix elem ents are entire fiunctions of the $m$ ompenta ${ }^{2}$ fpg's. $W$ ith this choice, there is a $m$ easure involved in the resolution of the identity: $1=\quad k \quad[\mathrm{dp]} \quad(\mathrm{fpg})$ fifgihfpgjw here $k$ is the num ber of particles. The singularity structure of
(fpg) then describes the energy spectrum of the theory in the quantization schem e where the roles of the $m$ om entum and the $H$ am iltonian are exchanged: the isom etry $I$ is generated by the Ham ittonian. In particular, poles at purely im aginary values $p=i E$ correspond to singleparticle discrete eigenvalues E of the H am iltonian in that schem e . A lso, the m atrix elem ents of $O$ in the \exchanged" quantization pshem e, of the form ${ }^{9}$ hvac ${ }^{\circ} \mathrm{IEE} g i^{0}$ where $\mathbb{I E} g i^{0}$ is an energy eigenvalue, are proportional to $\operatorname{Res}((f p g))$ hvacjo fipgi at the values $\mathrm{fp}=$ iEg.

The second observation is a sim ilar one, but this tim e for interacting relativistic models on at space. C onsider for sim plicity such a m odelw th only one particle type (onem ass). C onsider a set ofm om entum eigenstates, param etrized by rapidity variables f g . C hoose a nom alization of the states such that the form factors of any local eld are entire functions of the total rapidity when rapiditypdi erences are xed, and such that the $m$ easure involved in the resolution of the identity $1=k \quad[d]$ (f $g$ ) jf gihf $g j$ where $k$ is the num ber of particles, factorizes into a product ofm easures for the individual rapidities of each particle. This is the usual choioe: the

where $s$ is the spin of the eld; and them easure is ( $f \mathrm{~g}$ ) = 1. To clarify the idea, the resolution of the identity can be written as integration over $m$ om entum variables $w$ ith an appropriate relativistically invariant m easure: $1={ }^{P}{ }_{k}^{R} p \frac{d p}{p^{2}+m^{2}}$ if gihf $g j$. The measure has branch cuts from $p=i m$ towards il : these describe, again, the energy spectrum of the theory where the roles of the $m$ om entum and of the $H$ am iltonian are exchanged. Of course here, by relativistic invariance, this exchange gives the sam e H ilbert spac. It can be im plem ented by the shift $7 \quad+i=2$ of rapidity variables, and the form factors are invariant, up to a phase due to the spin, under such a shift of rapidities.

Sim ilarly, it is not hard to relate analytical continuation of special traces in angular quantization to the spectrum and $m$ atrix elem ents of local operators in radial quantization. A dapting these observations to the case of the cylinder, the $m$ ain idea for obtaining form factors on the circle from nite-tem perature form factors in the free $M$ a jorana theory can be expressed in the follow ing (schem atic) steps:

In the last step, $n$ are de ned in (1-.1.). In the second step, the requirem ent that the elds be localw th respect to the fundam ental eld com es from the fact that rotation is not a sym $m$ etry on the cylinder. F inite-tem perature form factors of tw ist elds (w hich are essentially the end-point of linear defects) can be expected to have a m ore com plicated pole structure.
$M$ ore than relating nite-tem perature form factors to form factors on the circle, the steps above tell us that an appropriate choice of the $m$ easure is related to a sim ple analytical structure of nite-tem perature form factors.

It is hopefully possible to generalize som e of these requirem ents to interacting integrablem odels, but this will not be pursued further here.

### 4.2 Im plem entation of the general idea

For the m assive M ajorana theory, the rst step was described in the previous section.
W e now show that the second step is realized by the de nition ( $\overline{3} \cdot \overline{1} \overline{2})$, due to the representation ( $\overline{1}, \overline{1}, 1)$. C onsider a com plete basis $f \quad j g$ of local operators that are also localw ith respect to the fundam ental eld ; these are non-interacting operators, for instance norm al-ordered products of ferm ion operators and of their space derivatives, $w$ ith coe cients that $m$ ay contain integer powers of the $m$ ass $m$ (the $m$ ass $m$ has scaling dim ension 1 and spin 0 ). W e consider the basis f $j g$ to be for the linear space of operators on the eld of com plex num bersw thout dependence on $m$. We can take the operators $j$ to have well-de ned spins $s_{j}$ and scaling dim ensions $d_{j}$. W ith the ferm ion operators and , they satisfy simple equal-tim e commutation (or anticom m utation) relations:

## 5 F in ite-tem perature form factors ofnon-interacting elds

### 5.1 G eneral properties and particular cases

In general, elds that are norm al-ordered products of $k$ ferm ion elds have $k$-particle nite-tem perature form factors independent of tem perature, but generically have non-zero, tem perature-dependent j-particle form factors for $j<k$ ( $j$ and $k$ being of the sam e parity). In order to describe this, we introduce the concept ofm ixing, which is a sim ple generalization of the description " 7 " + hh" $\mathrm{ii}_{\mathrm{L}} 1$ of nite-tem perature form factors of the energy eld in term $s$ of its zero-tem perature form factors.

### 5.2 M ixing

C onsider a com plete basis $f$ ag of local non-interacting operators on the eld of polynom ials in $m$ \{ we will use indices a;b to label all elem ents of this set, instead of the indices i; j used in the previous section to label elem ents of a di erent basis. The elem ents of this set of operators can be taken to be in one to one correspondence with a basis of non-zero operators in the free $m$ assless $M$ ajorana conform al eld theory. A convenient basis $f a g$ is obtained by considering norm al-ordered products of ferm ion operators and and of their holom onphic or anti-holom orphic derivatives, $@^{k}$; $@^{1}$, with coe cients that are independent of the $m$ ass $m$. ## 6 R iem ann H ilbert problem for n ite-tem perature form factors

### 6.1 N on-interacting elds

In Section 点, we described nite-tem perature form factors of non-interacting elds. They are all given by entire functions of the rapidity variables $i_{i}$ 's, as are zero-tem perature form factors of non-interacting elds; the $m$ ain non-trivial phenom enon is that of $m$ ixing between a eld and its ascendants.

In fact one can verify that the linear space of functions $f$ of the variables $; i=1 ;::: ; k$ w th the properties:

1. f acquires a sign under exchange of any two of the rapidity variables;
2. f has the quasi-periodicity property ( 5 (5') ;
3. $f$ is an entire functions of all its variables;
 of non-interacting operators. This constitutes a very sim ple $R$ iem ann $H$ ilbert problem. Of course, the solution to this $R$ iem ann $H$ ilbert problem also reproduces the set of zerotem perature form factors; in order to disentangle the nite-tem perature form factors, one needs the additional inform ation about the $m$ ixing $m$ atrix.

### 6.2 R iem annHilbert problem associated to right-tw ist operators

A s recalled in A ppendix ' $\bar{C}_{\mathbf{C}}^{\prime}$, there are tw o types of operators associated to each tw ist eld: those w ith branch cut on their right ( $\backslash$ right-tw ist operators"), and those w ith branch cut on their left
( $\backslash$ left-tw ist operators"'). A s explained in Section ' of the branch cuts, one can obtain two-point fiunctions of tw ist elds in the NS sector and in the R sector. In this subsection, we w ill consider right-tw ist operators only.

O ne can expect a description for the nite-tem perature form factors of tw ist elds (which are \interacting" elds) in the sam e spirit as the one in the previous sub-section for non-interacting elds.

## 6.3 $M$ ixing for tw ist elds

It is natural to suppose that, like in the case of non-interacting elds, som e $\backslash \mathrm{m}$ ixing" occurs betw een a tw ist eld $O$ and its ascendants \{ elds of low er dim ension and w ith the sam e locality index and statistics as those of $O$ \{ in calculating the nite-tem perature form factors. $W$ e describe here a con jecture for the way $m$ ixing should occur. W ew illuse right-tw ist operators for this description, but we expect that the sam em ixing should occur am ongst left-tw ist operators.

1 , since they are prim ary elds of spin 0 . $N$ ote that the $m$ ethod of com puting one-particle nite-tem perature form factors by solving the $R$ iem ann $H$ ibert problem w ith this asym ptotic behavior is very sim ilar to the $m$ ethod used by Fonseca and Zam olodchikov hē form factors on the circle.

A lso, it is a sim ple $m$ atter to obtain a Fredholm determ inant representation for the two-point function of tw ist elds in the R sector. This is derived in A ppendix $E_{i}^{\prime}$.
$T$ he zero-tem perature form factors of descendant tw ist elds in the M ajorana theory were analyzed in $\left[\begin{array}{l}{[\overline{4} \overline{1}]}\end{array}\right]$, as solutions to the form factor equations. It was found that the set of form factors of descendant elds of a given spin $s$ is described by $m$ ultiplying form factors of prim ary tw ist elds by sym $m$ etric polynom ials in $e^{j} ; j=1 ;::: ; k$ (where $j$ are the rapidities of the form factor) hom ogeneous of degree s. Sim ilarly, we expect that nite-tem perature form factors of descendant tw ist elds are obtained by $m$ ultiplying those of prim ary tw ist elds by sym $m$ etric polynom ials. It is easy to check that the requirem ents of the R iem ann H ilbert problem s of Sections' 1 previous section, since rotation is no longer a sym $m$ etry on the cylinder, we cannot identify the spin of a descendant w ith the hom ogeneous degree of sym $m$ etric polynom ials. Instead, we $m$ ust rely on the con jecture in sub-section ' $\overline{6}$-an in order to describe how to com bine appropriate sym $m$ etric polynom ials. Unfortunately, we have not yet calculated the $m$ ixing $m$ atrix for $t w$ ist elds, hence we cannot derive $m$ ore explicit form ulas here for descendants.

## 8 C onclusions

We have derived a method for writing large-distance expansions of nite-tem perature correlation functions. For this punpose, we introduced the space of operators $L$ on whidh nitetem perature quantum averages are vacuum expectation values, and we obtained the expansion of two-point functions by inserting a resolution of the identity between the two operators. We de ned nite-tem perature form factors, which are appropriately nom alized $m$ atrix elem ents on

L oflocaloperators, and we described at length their properties. T hey are related, by analytical continuation in rapidity space, to form factors in the quantization schem e on the circle. A ny nite-tem perature form factor of a non-interacting eld can be seen as the zero-tem perature form factor of a sum of non-interacting elds, including itself and elds of lower dim ension. The coe cients in this sum are independent of the $m$ atrix elem ent evaluated. W e described this phenom enon by constructing the associated $m$ ixing $m$ atrix; note that this was overlooked
 nite-tem perature form factors of tw ist elds, and calculated nite-tem perature form factors of order and disorder elds.

There are still m any open questions:
W e have only im plicitly described how to obtain large-distance expansion of correlation functions w ith m ore than tw o operators: one should insert the resolution of the identity betw een every pairs of ad jacent operators. T he resulting expression involves $m$ atrix elem ents w here both vectors in $L$ correspond to excited states. For non-interacting elds this does not cause any di culties, but for tw ist elds, one $m$ ust be m ore careful. W e evaluated such $m$ atrix elem ents of tw ist elds, as distributions w ith term $s$ supported at colliding rapidities (which vanish at zero tem perature) and others supported at separated rapidities. U sing these distributions, all integrals over rapidity variables are well-de ned, and it would be nige to explicitly observe the agreem ent of the resulting expression for m ulti-point correlation functions w ith a form factor expansion on the circle. In particular, from the results presented here, it should be possible to calculate $m$ atrix elem ents of tw ist elds in the quantization on the circle where both vectors correspond to excited states.

W e have described how to obtain form factors on the circle from nite-tem perature form factors only for excited states in the N S sector, where ferm ion elds have anti-periodic condition around the cylinder. It w ould be interesting to describe $m$ atrix elem ents in a sim ilar way with excited states in the R sector. A s we m entioned, this can be done by de ning the inner product on $L$ as a trace w ith a tw ist operator at, say, position $x=1$ and having a branch cut on its right.

W e have explained how to obtain the $m$ ixing $m$ atrix associated to non-interacting elds. In particular, we have obtained an operator $U$ that describes the action of this $m$ atrix on the non-interacting elds seen as vectors in $L$. The existence of such an operator is well-known in conform al eld theory: there, the space of operators is isom orphic to the Hilbert space in radial quantization (which is isom onphic to the Hilbert space in any quantization on closed lines), and the $m$ ixing operator is described by an operator on the $H$ ilbert space perform ing a transform ation to the cylinder. It would be interesting to relate m ore explicitly the operator U that we w rote w ith a transform ation to the cylinder.

W e obtain nitetem perature form factors of order and disorder elds. It is im portant to note that form factors for the right-and left-operators both specialize to the zero-tem perature form factors only in the region $j \mathrm{~m}$ ( $) j<=2$ of the complex plane of rapidity variables . In connection to this, observe that the quasi-periodicity relation does not agree w ith the one satis ed by zero-tem perature form factors. At nite tem perature, this quasi-periodicity relation does not seem to contain any inform ation about the mutual locality of the tw ist eld w ith respect to the fundam ental ferm ion elds. This sem i-locality is included in the therm alpoles
and zeroes and in the particular form of the kinem atical residue. It would be interesting to generalize this to other sem i-locality index, by deriving the $R$ iem ann $H$ ilbert problem in the free D irac theory for scaling tw ist elds associated to the $U$ (1) sym $m$ etry (in this connection, see the recent results [ $[4]$ iq]). B ut the them al poles and zeroes $m$ ight not be sole consequences of sem i-locality; they $m$ ight be interpreted as com ing from self-interaction of the eld around the cylinder as well, hence could be present also for elds with zero sem i-locality index in interacting theories.

It could interesting to obtain the non-linear di erential equations describing the two-point function oftw ist elds from the Fredholm determ inant representation resulting from the nitetem perature form factor expansion. This would m odify som e of the results of $\left.{ }_{\text {个 }}^{3} \overline{1} 1\right] ;$ in particular, it is easy to see that the equation evolving tem perature derivatives would not hold due to the non-trivial leg factors, and it is not clear if there is an equation replacing it.

F inally, probably the $m$ ost im portant future developm ent from the ideas presented here is the de nition and calculation of nite-tem perature form factors in interacting integrable models, and the identi cation of the associated $m$ easure of integration in the resolution of the identity. A $n$ im portant new idea presented here is the relation between nite-tem perature form factors, seen as $m$ atrix elem ents on the $H$ ibert space of operators, and form factors on the circle; in particular, the relation between the $m$ easure of integration and the spectrum on the circle. If, for elds that arem utually localw th respect to fundam ental elds, the nite-tem perature form factors equations are the sam e as the well-known zero-tem perature form factor equations, as was assum ed in previous approaches, then the only non-trivialelem ent is the m easure of integration in the resolution of the identity. This m easure was indeed sub ject of controversy O ur ideas give a guideline for de ning this m easure of integration. N ote, how ever, that in view of the works $[\overline{2} \overline{1}, 1,12 \overline{2}]$, the rapidity variables $m$ ight tum out not be the $m$ ost appropriate ones for de ning nite-tem perature form factors.

The nite-tem perature correlation functions of ferm ion elds with insertion of these spin elds are functions on coverings of the cylinder.
