The phase diagram of the massive G ross-N eveu model, revisited

The massive G ross-N even model is solved in the large N limit at nite temperature and chemical potential. The phase diagram features a kink-antikink crystal phase which was missed in previous works. Translated into the framework of condensed matter physics our results generalize the bipolaron lattice in non-degenerate conducting polymers to nite temperature.

In its original form, the G ross-N eveu m odel [1] is a relativistic, renorm alizable quantum eld theory of N species of self-interacting ferm ions in 1+1 dimensions with Lagrangian

The bare mass term m $_0$ explicitly breaks the discrete 5 of the massless model. As chiral sym m etry ! far as the phase diagram is concerned, the 't H ooff lim it N ! 1, g^2 1=N is most interesting since it allows one to bypass som e of the lim itations of low dimensions, while justifying a sem i-classical approach. Interest from the particle physics side stem s from the fact that the simple Lagrangian (1) shares non-trivial properties with strong interaction physics, notably asymptotic freedom, dim ensional transmutation, meson and baryon bound states, chiral symmetry breaking in the vacuum as well as its restoration at high temperature and density (for a review, see e.g. [2]). It also has played some role as a testing ground for ferm ion algorithm s on the lattice [3]. Perhaps even m ore surprising and less widely appreciated is the fact that G ross-N even type m odels have en pyed considerable success in describing a variety of quasi-onedim ensional condensed matter system s, ranging from the Peierls-Frohlich model [4] over ferrom agnetic superconductors [5] to conducting polymers, e.g. doped transpolyacetylene [6]. By way of example, the kink and kinkantikink baryons ist derived in eld theory in the chiral $\lim it (m_0 = 0)$ [7] have been in portant for understanding the role of solitons and polarons in electrical conductivity properties of doped polymers [6]. Likewise, one can show that baryons in the massive G ross-N eveu model $(m_0 \in 0)$ are closely related to polarons and bipolarons in polymers with non-degenerate ground states. e.g. cispolyacetylene [8, 9]. Finally, Gross-Neveu models with nite N have been found useful for describing electrons in carbon nanotubes and fullerenes [10].

The claim that a relativistic theory is relevant for condensed matter physics is at rst sight very provocative [11]. A closer inspection show sthat a continuum approxim ation to a discrete system, a (nearly) half-lled band and a linearized dispersion relation of the electrons at the Ferm i surface are the crucial ingredients leading to a D irac-type theory. The Ferm i velocity plays the role of the velocity of light and the band w idth the role of the UV cuto . In some cases the correspondence is so close that results can be taken over from one eld into the other. This was illustrated in [17] where we borrowed results from the theory of non-degenerate conducting polymers, in particular the bipolaron lattice, for solving the zero tem perature limit of the massive G ross-N eveu m odel.

The Lagrangian (1) has two bare parameters, g^2 and m_0 . In the process of regularization and renormalization all observables can be expressed in terms of two physical parameters m and the uv cuto is given by the vacuum gap equation

W hereas m merely provides the overall mass scale and can be set equal to 1, the renorm alized ferm ion mass ratio (called \con nem ent param eter" in condensed matter physics) param etrizes di erent physical theories. It measures the amount of explicit chiral symmetry breaking and vanishes in the massless (m₀ = 0) case. The phase diagram of the model (1) was proposed in 1995 [12], but recent ndings showed that the result is awed. A related problem in the massless G ross-N eveu model was pointed out and subsequently cured by us in previous works [13, 14, 15]. W e will recover these ndings below as special case = 0 of the present work.

Let us rst recall the original analysis [12] which is still valid in a certain region of the phase diagram. In the large N limit, a saddle point approximation to the functional integralor, equivalently, a (thermal) Hartree-Fock approach becomes exact. One nds that the fermions condense to form a scalar potential S (x). The authors proceed along similar lines as the 1985 work at = 0[16] and tacitly assume that S is spatially constant leading to a (;T)-dependent dynamical fermion mass M. This elective mass is determined via self-consistency by the thermal expectation value of the fermion condensate,

For a translationally invariant system, this in turn is tantam ount to m inim izing the renorm alized grand canonical potentialdensity




FIG.1: Phase diagram of the massive G ross-N eveu model as a function of ; ;T, (incorrectly) assuming unbroken translational invariance. The various phase boundaries are explained in the main text.

 $(m = 1; E = \frac{E}{2} P q^2 + M^2)$ with respect to M. Depending on the parameters (;T;), there may be one or two local minima with the possibility of a rst order phase transition. The phase diagram depending on ;T; is plotted in Fig. 1. In the chiral limit (= 0), the mas-

sive phase at low (;T) is separated from the chirally restored, massless phase at high (;T) by a critical line (AP_tB) [16]. The upper part of this line (AP_t) is 2nd order, the lower part (PtB) rst order, with a tricriticalpoint $P_{\rm t}$ separating the two. As the parameter is switched on, the 2nd order line disappears in favour of a cross-over where the ferm ion mass changes rapidly, but sm oothly. The rst order line on the other hand survives, ending at a critical point. If plotted against , these critical points lie on the third curve (P_tC) em anating from the tricritical point shown in Fig. 1. For > 0 the e ective ferm ion m ass M is dierent from zero everywhere. If one crosses the shaded critical \sheet" in Fig. 1, the m ass changes discontinuously, dropping with increasing chem ical potential. M ore details on the therm odynam ic implications of such a phase diagram are given in [12].

In the m eantime, evidence has accumulated that this picture cannot be correct. This has so far only been claried in the two coordinate planes = 0 [15] and T = 0 [17] of Fig. 1, and we propose to complete the phase diagram here. Brie y, what has been m issing is a proper treatment of the baryons which can give rise to a kink-antikink crystal phase in certain regions of temperature and chemical potential. A ctually, this phenomenon has been known in condensed matter physics for a long time: It refeats the Peierls instability, a general phenomenon in one-dimensional system s. In order to lower the energy

or the therm odynam ic potential, a periodic m odulation of the lattice is induced, thereby opening a gap at the Ferm i surface. In the relativistic G ross-N eveu m odel it turns out that the scalar condensate h i (the - eld) plays the role of the ion displacement.

To incorporate this kind of physics into the Gross-Neveu model, one has to solve the D irac equation selfconsistently (including the negative energy sea) with a spatially varying, periodic scalar potential S (x), in general a highly non-trivial task even in one space dim ension. Fortunately, in the special cases considered so far (namely = 0 and T = 0), this has turned out to be exactly feasible due to a number of lucky circum stances. The self-consistent potentials are such that the Dirac equation can be mapped onto a 2nd order Schrodinger type equation with the Lam e potential of order 1. The single particle eigenspinors are known in terms of theta functions. This enables one to perform an exact calculation of both the ground state and the phase diagram, including an analytical proof of self-consistency. At = 0, such a calculation was done independently in condensed matter physics [4] and relativistic eld theory [15]. During the last two decades, interest in non-degenerate conducting polymers has fostered a lot of theoretical work on the polymer side. As a result, analytical bipolaron lattice solutions at zero tem perature were found by several groups [18, 19, 20, 21, 22]. We have recently shown that the x-dependent gap parameter of the bipolaron lattice is adequate for solving the T = 0, massive G ross-N eveu m odel [17].

We have extended this calculation to nite tem perature and again found exact self-consistency. We can therefore now present a revised phase diagram in the 3-dimensional (;T;)-space which supersedes the old, translationally invariant phase diagram of Fig. 1. Whereas the solution dem ands some m athem atics (sim ilar but more com plex than the = 0 solution presented in [15]) the outcome can be visualized in a single graph. Thism ade us decide to present in this Letter ourm ain results without derivation. The detailed form alism and further results on the revised therm odynam ics of the m assive G ross-N eveu m odel will be given elsew here.

The crucial observation is that the scalar potential at $T \notin 0$ has the same general functional form as at T = 0. It can be written in term s of three parameters A;b; and Jacobi elliptic functions of the modulus (suppressed here) as

This form equals the more complicated expression employed in the literature on the bipolaron lattice and in our T = 0 paper [17]. As mentioned above, the Dirac equation with potential (5) is equivalent to the single gap Lame equation. Using the known spectrum and density of states of the Lame potential, one can construct the grand canonical potential and minimize it with respect to (A;b;). Due to the speci c structure of the equations

obtained, this possible to reduce the solution to basically solving a transcendental equation in one variable containing a one-dimensional numerical integration. The proof of the self-consistency condition which replaces Eq. (3),

establishes that the minimum of the grand canonical po-

tential is an exact solution of the large N G ross-N even model. Comparison with the translationally invariant solution shows that the crystal is therm odynam ically favourable whenever it exists.




FIG. 2: Revised phase diagram of the massive Gross-Neveu model. The shaded surfaces I;II separate the kink-antikink crystal from a massive Fermigas and correspond to 2nd order phase transitions.

We now turn to the results, focussing on the phase boundaries as depicted in Fig. 2.

= 0 plane, the result for the revised phase di-In the agram including the kink-antikink crystal is known [15]: The 2nd order line (APt) of the old phase diagram is una ected. The rst order line (P_tB) of Fig. 1 is replaced by two 2nd order lines delim iting the kink-antikink crystal phase. The tricritical point is turned into another kind of multicritical point at the same (;T) values. As we turn on , the second order line separating massive (M > 0) and massless (M = 0) phases disappears as a consequence of the explicit breaking of chiral symmetry. The crystal phase survives at all values of , but is con ned to decreasing tem peratures with increasing . For xed , it is bounded by two 2nd order lines pining in a cusp. The cusp coincides with the critical point of the old phase diagram but has a signi cantly di erent character. The crystalphase exists and is therm odynam ically stable inside the tent-like structure form ed out of two sheets denoted as I and II. These sheets are dened by = 0 (I) and = 1 (II), respectively. The line where they join corresponds to b = 0 and coincides with line (P_tC) in Fig.1. The baseline of sheet II in the (;)-plane has a simple physical interpretation: It reects the -dependence of the baryon m ass in the massive G ross-N eveu m odel, or equivalently the critical chem ical potential at T = 0. The chiral lim it ! 0 can be identi ed with b ! K (). In this way, one can recover the simpler 2-param eter ansatz for the self-consistent potential used in [15] from the 3-param eter ansatz Eq. (5).

In order to further illustrate the nature of the phase transitions between inhom ogeneous and hom ogeneous phases, let us remark that outside the tent the scalar potential is x-independent, i.e. a dynam ical mass. If one crosses the tent from side I to side II on some curve, the parameter varies continuously from 0 to 1. By way of example consider the straight line = 0.5; T = 0.05 which pierces sheet I at = 1:1 and sheet II at = 0.85.




FIG. 3: Evolution of self-consistent S (x) as one crosses the crystal region on a straight path. As decreases from 1.1 to 0.85, the elliptic m odulus varies between 0 and 1.

Just outside of the crystal phase, the dynam icalm ass values we nd are 0.4 (I) and 1.0 (II). A coording to the old phase diagram, the m ass jumps suddenly from 0.54 to 1.0 upon crossing the rst order sheet at = 0.87. By contrast, Fig. 3 shows the continuous evolution of S(x) in the

exact calculation. At = 0, an instability occurs with respect to oscillations of a nite wavenumber. As increases, the amplitude of these oscillations become larger whereas the period rst grows rather modestly. When approaches the value 1 the period grows rapidly and, save for small dents representing widely spaced baryons, S (x) reaches a constant value connecting to the translationally invariant phase. At = 1 the system is instable against single baryon form ation. This subtle interpolation of S (x) between two constants caused by the Peierls instability is only crudely modeled by the translationally invariant scenario.

Concluding, we nd it gratifying that the simple Lagrangian (1) gives rise to such a rich phase diagram. We emphasize that we would not have been able to solve this problem without the works on the bipolaron lattice in conducting polymers. We hope that our extension to nite temperature will in turn lead to new results in condensed m atter system s.
