# Defect Structures in Field Theory

This work contains a set of lectures on defect structures, mainly in models described by scalar elds in diverse dimensions.

#### I. IN TRODUCTION

This work describes a set of lectures on Defect Structures in Field Theory. Although we focus mainly on issues concerning scalar elds, we also deal a little with other topics. We work mainly in (1;1) dimensions, in at space-time with metric such that diag ( ) = (1; 1); and we set the Planck constant  $\sim$  and the speed of light c to unit, and we use dimensionless elds and coordinates.

The interested reader can nd motivations and general investigations in the books [1{3], where the authors explore several aspects of defect structures such as kinks, vortices and monopoles. There is another book, Ref. [4], in which the reader may read important original articles in the subject until 1984.

# II. ONE-FIELD MODELS

W e start with

$$L = \frac{1}{2} e \quad e \quad V ()$$
 (1)

where V ( ) is the potential, which speci es the model under consideration.

We are working in (1;1) dimensions, and so the equation of motion which follows from the above model is

$$\frac{\theta^2}{\theta t^2} \qquad \frac{\theta^2}{\theta x^2} + \frac{dV}{d} = 0 \tag{2}$$

If the eld is constant we get dV=d=0: However, for static eld con guration we have

$$\frac{d^2}{dx^2} = \frac{dV}{d} \tag{3}$$

We are interested in solutions with nite energy. For the trivial constant solutions we have

$$E_{0} = \int_{1}^{Z_{1}} dx V ( )$$
 (4)

and for static solutions

$$E = \int_{1}^{Z_{1}} dx \frac{1}{2} \frac{d}{dx}^{2} + V(1)$$
 (5)

In this last expression, the two terms identify the gradient and potential portions of the total energy, respectively. The trivial constant solution is represented by : It obeys  $V^0() = 0$  and we should also in pose that V() = 0; to make to describe a null energy solution. On the other hand, static solutions must obey the boundary conditions

$$\lim_{\mathbf{x} \,! \, \mathbf{1}} \, \frac{\mathbf{d}}{\mathbf{d}\mathbf{x}} \,! \quad 0 \tag{6}$$

and

$$\lim_{x \to 1} (x)! \tag{7}$$

These conditions are necessary to make both the gradient and potential energies nite, independently. This behavior can be veriled with the equation of motion: we rewrite Eq. (3) to get

$$\frac{d}{dx} = \frac{p}{2V}$$
 (8)

which also shows that the potential for a static solution cannot be negative.

The behavior of the solution in the  $\lim i x ! 1$  may be equal to the form er case, that is, (x ! 1) ! ; or it may be dierent, giving (x ! 1) ! '; for 'being another trivial solution that obeys  $V^0(') = 0;$  with V(') = 0: These two possibilities can be described by the topological current

$$\dot{J}_{T} = \frac{1}{2} \mathbf{"} \quad \mathbf{0} \tag{9}$$

which is conserved, that is, which obeys 0  $j_T = 0$ : For static solutions the topological charge is given by

$$Q_{T} = \frac{1}{2} (x ! 1) \frac{1}{2} (x ! 1)$$
 (10)

This charge sees the asymptotic bahavior of the static solutions, and it speci es two distinct cases: topological solutions, for which  $(x ! 1) \in (x ! 1)$ ; and non-topological solutions, for which (x ! 1) = (x ! 1): Thus, in general we can have topological or kink-like solutions, and non-topological or lump-like solutions. We can also have ribbons, which are kinks embedded in (2;1) dimensions, and walls, which are kinks embedded in (3;1) dimensions.

We notice that there are several distinct ways to de ne the topological current, and this can be used to de ne the topological charge appropriately.

In the case of a single real scalar eld we can de ne the standard model, which engenders spontaneous symmetry breaking, with the potential

$$V() = \frac{1}{2} (1 \quad ^{2})^{2} \tag{11}$$




FIG. 1: Potential for the 4 m odel

This is the 4 m odel, and it is plotted in Fig. 1.

The equation of motion is

$$\frac{\theta^2}{\theta t^2} = \frac{\theta^2}{\theta x^2} + 2 \quad (^2 \quad 1) = 0$$
 (12)

and for static solutions we get

$$\frac{d^2}{dx^2} = 2 \ (^2 \ 1) \tag{13}$$

We are searching for extended but localized solutions, with nite energy. The equation above has two trivial solutions, given by = 1; which have zero energy and identify the classical vacua on the model. There are static solutions, given by

$$(x) = \tanh(x) \tag{14}$$

They identify the kink (+) and anti-kink (-), with center at the origin, x=0. In fact, the center of a static solution is arbitrary, because the model has translational invariance.

The kink above has am plitude and width equal to unit. However, if we write the potential in the form

$$V() = \frac{1}{2}^{2} (a^{2} - a^{2})^{2}$$
 (15)

the kink would be  $(x) = a \tanh(ax)$ ; and it would have am plitude a and width inversely proportional to a:

The energy for static solutions has the form

$$E = \int_{1}^{Z_{1}} dx ''(x)$$
 (16)

where "(x) is the energy density, which can be written as

$$"(x) = \frac{1}{2} \frac{d}{dx}^{2} + V(x)$$
 (17)

We see that for the trivial solution; which satisfies V() = 0; the energy is zero. For the kink or anti-kink the energy is E = 4=3, and the energy density is

$$"(x) = \operatorname{sech}^{4}(x) \tag{18}$$

W e notice that the gradient and potential portions of energy are given by

$$E_g = \frac{1}{2} \int_{1}^{Z_1} dx \frac{d}{dx}$$
 (19)

and

$$E_p = \frac{Z_1}{dx V ()}$$
 (20)

They vanish for the trivial solutions = 1: For the kink we get

$$"_{p}(x) = "_{g}(x) = \frac{1}{2} \operatorname{sech}^{4}(x)$$
 (21)

which shows that  $E_g = E_p$ :

W e can consider another model, described by the potential




FIG. 2: Potential for the inverted 4 m odel.

$$V() = \frac{1}{2} \quad \frac{1}{2} \quad \frac{1}{2} \quad 4 \tag{22}$$

which is plotted in Fig. 2. We see that this new potential is similar to the former one, but inverted; thus we name it the inverted  $^4$  m odel.

In this case, the equation of motion for static solutions is

$$\frac{d^2}{dx^2} = 2^{-3}$$
 (23)

There is a single trivial solution, = 0; for which V() = 0: And there are static solutions, given by

$$(x) = \operatorname{sech}(x) \tag{24}$$

They are lumps, and they have energy density in the form

$$"(x) = \operatorname{sech}^{2}(x) \tanh^{2}(x)$$
 (25)




FIG. 3: Plots of the solutions for kinks and lumps.

In Fig. 3 we plot kink and lump, to compare their pro le.




FIG . 4: Energy density for kinks and lumps, depicted as solid and dashed lines, respectively.

This last result shows that the energy density of the lump vanishes at the origin, the center of the lump, and is maxim ized at the points  $x = \operatorname{arctanh}(2=2)$  0.88: This suggests that lumps may have internal structure. In Fig. 4 we plot the energy density of both kink and lump, as given by Eq. (18) and (25). There we see that the energy density of the kink gets concentrated at the origin, but this is not the case for lumps.

A. BPS States

There is an alternative way to search for defect solutions. It is due to Bogom ol'nyi [5] and P rasad and Sommer eld [6]. The point is that for non-negative potentials we can write

$$V () = \frac{1}{2}W^{2}$$
 (26)

where W = W ( ) is a smooth function of the scalar eld, and W = dW = d: In this case the equation of motion for static solutions is

$$\frac{d^2}{dx^2} = W \quad W \tag{27}$$

It is possible to see that solutions of the rst-order equations

$$\frac{d}{dx} = W \tag{28}$$

solve the second-order equation of motion. The solutions of the rst-order equations are named BPS states, and it is possible to show that they are stable, minimum energy static solutions. In the present case, it is possible to show that the model only supports BPS states [7, 8].

To see how the BPS states appear, let us investigate the energy of the static solutions. We have

$$E = \frac{1}{2} \int_{1}^{Z_{1}} dx \frac{d}{dx} + W^{2}$$
 (29)

W e can write

$$E = E_{BPS} + \frac{1}{2} \int_{1}^{Z_{1}} dx \frac{d}{dx} W$$
 (30)

w here

$$E_{BPS} = jjW [(1)] W [(1)]jj$$
 (31)

is the bound in energy, which is attained for solutions that obey the rst-order Eqs. (28).

The BPS states present interesting properties. First, they are solutions of rst-order equations, and their energies are easily obtained, since they only depend on the W ( ); and on the asymptotic behavior of the eld con guration. Second, the gradient and potential portions of their energies are equal, that is  $E_g = E_p = (1=2)E_{BPS}$ : A nother fact is that the BPS states appear very naturally in the supersym m etric environment, and there they partially preserve the supersym m etry. In the presence of supersym m etry, W is named superpotential; see Refs. [9{14] for m ore details on the subject.

There are di erent motivations to investigate models which support BPS states. In particular, in Ref. [15] one investigates elastic deformations in liquid crystals, and there the decomposition in terms of BPS states has led to wide class of solutions. A nother interesting work was recently done in supersymmetric quantum mechanics [16]. In this case, it was shown how to understand shape invariance in terms of the BPS structure of the system.

### B. Linear Stability

Linear or classical stability of static solutions are investigated as follows: for = (x) being static solution, we can write

$$(x;t) = (x) + (x;t) \tag{32}$$

where (x;t) describes uctuations around the solution (x): We suppose that the uctuations are small, and we only consider linear contributions in : We then use the above con guration and the equation of motion (2) to get, up to rst-order in ;

$$\frac{\theta^2}{dt^2} \quad \frac{\theta^2}{\theta x^2} + \frac{d^2V}{d^2} = 0 \tag{33}$$

Since the static solution only depend on x; we can consider

$$(x;t) = \begin{cases} X \\ n (x) \cos(w_n t) \end{cases}$$
 (34)

to obtain the Schrodinger-like equation

$$H_{n}(x) = w_{n}^{2}(x)$$
 (35)

w here

$$H = \frac{d^2}{dx^2} + \frac{d^2V}{d^2}$$
 (36)

In the Schrodinger-like equation, we notice that the presence of negative eigenvalue transforms the cos factor in (34) into a cosh, and this would violate the supposition that we are dealing with small uctuations. Thus, we need that the associated quantum -m echanical problem have no negative eigenvalue, to make the solution stable.

An interesting fact is that the associated quantum -m echanical problem always contains a zero-m ode, that is, an eigenfunction with zero eigenvalue. We prove this assertion by noting that if (x) is a static solution, we use the equation of motion and 0 = d = dx to obtain

$$\frac{d^2}{dx^2} + \frac{d^2V}{d^2} = 0 ag{37}$$

which is a Schrodinger-like equation with zero eigenvalue. Thus, we identify the zero-mode with the derivative of the classical solution itself. The presence of the zero mode is a general fact, which appear in decorrence of the translational invariance of the model under investigation [17]. For instance, for the  $^4$  model the kinks are  $(x) = \tanh(x)$ : They are stable, and the zero-modes are  $^0$   $(x) = \mathrm{sech}^2(x)$ ; as we are going to show below. For the inverted  $^4$  model, the lumps are  $(x) = \mathrm{sech}(x)$ : They are unstable, with zero-modes as  $^0$   $(x) = \tanh(x)$  sech (x): Their instabilities appear from the fact that such zero-modes cross zero at the origin, so they have nodes and cannot represent lowest bound states [18].

In the case of the non-negative potentials described in (26), there are BPS states, which obey rst-order equations. They are all stable, and this can be shown as follows: the Hamiltonian for BPS states are given by

$$H = \frac{d^2}{dx^2} + W^2 + W^W$$
 (38)

and now we can introduce the st-order operators

$$S = \frac{d}{dx} \quad W \tag{39}$$

and they allow introducing the Hamiltonians

$$H = S^{Y}S \tag{40}$$

which can be written in the general form

$$H = \frac{d^2}{dx^2} + W^2 \quad W \quad W \tag{41}$$

These H am iltonians are supersymmetric partners [19, 20] in quantum mechanics. Now, since  $H_{+}$  is the H am iltonian of equation (38), we see that it is non-negative, thus it has no negative eigenvalue, and this ensure linear stability for the BPS states. We can also see that the zero-mode  $_{0}$  (x) obeys

$$\frac{\mathrm{d}_{0}(\mathbf{x})}{\mathrm{d}\mathbf{x}} = \mathbf{W}_{0}(\mathbf{x}) \tag{42}$$

and it can be written as

$$_{0}\left( x\right) =Ae^{R}^{dxW} \tag{43}$$

where = (x) stands for the static solution. The constant A is used to normalize the wave function, but this only occurs for one of the two signs of the exponential. There is another way to write the zero-mode; it is

$$_{0} = AW \tag{44}$$

where = (x) is the static solution, the BPS state. The zero-m ode  $_0(x)$  is also known as the bosonic zero-m ode, since the inclusion of ferm ions in the model will also lead to ferm ionic zero-m odes [21].

We consider the  $^4$  m odel. The topological solutions are  $(x) = \tanh(x)$  and the potential for the corresponding quantum -m echanical problem has the form

$$U(x) = \frac{d^2V}{d^2} = 4 - 6 \operatorname{sech}^2(x)$$
 (45)

This is the modi ed Poschl-Teller potential, which was investigated long ago [22, 23]. We consider the potential

$$U(x) = a + b \tanh(x) \quad c \operatorname{sech}^{2}(x)$$
 (46)

with a;b;c real and positive parameters. For a > b and a < c; the continuum spectrum presents rejecting states, for energies in between a = b + a + b; and other states for energies higher than a + b: If b is zero, the continuum does not contain rejecting states. For a > b and a < c; the discrete spectrum may contain the zero-mode and other states, with positive and negative eigenvalues. In fact, the bound states present eigenvalues given by

$$_{n} = a A_{n}^{2} \frac{b^{2}}{4A^{2}}$$
 (47)

w here

$$A_{n} = c + \frac{1}{4} \quad n \quad \frac{1}{2}$$
 (48)

and n = 0;1; :::; is such that

$$n < \frac{r}{c + \frac{1}{4}} \frac{1}{2} \frac{b}{2}$$

$$(49)$$

In Ref. [22] there is a m isprint: the last term of the result for the bound states there obtained has to be multiplied by the factor 1=4:

The above results can be used to show that for the  $^4$  m odel, the potential (45) leads to two bound states, one being the zero m ode, and the other having eigenvalue 3: For the inverted  $^4$  m odel, the potential for the quantum -m echanical problem is

$$U(x) = 1 \quad 6 \operatorname{sech}^{2}(x) \tag{50}$$

It has the very same form of the potential for the <sup>4</sup> model, but it plots dierently, in a way such that its zero mode corresponds to the higher bound state, thus introducing a negative eigenvalue, 3; which makes the lump unstable.

# C. Examples

We now consider some examples, to illustrate the above results. The rst example is the sine-Gordon model, which is described by the potential

$$V() = \frac{1}{2}\sin^2()$$
 (51)

Here we can write W () = cos(): The rst-order equations are

$$\frac{\mathrm{d}}{\mathrm{dx}} = \sin(t) \tag{52}$$

The m in im a of the potential are given by  $_0 = 0$ ;  $_1 = _$ ; etc. There is an in nity of topological sectors. They are all equivalent, and in the sectors  $_1 \$  0 and  $_0 \$  1 the solutions can be written as

$$(x) = 2\arctan(e^{-x})$$
 (53)

The energy is  $E = E_{BPS} = 2$ :

Stability investigations lead us to the quantum mechanical potential

$$U(x) = 1 2 \operatorname{sech}^{2}(x)$$
 (54)

which has just one bound state, the zero mode, with normalized eigenfunction given by

$$r = \frac{1}{2} \operatorname{sech}(x)$$
 (55)

There are other sectors, and there are other solutions; see, e.g., Ref. [1, 4].

A nother example is the double sine-Gordon model. It may be described by the potential

$$V() = \frac{2}{1+r} (r + \cos())^2$$
 (56)

where r is a real param eter. This model was recently investigated in [24]. It can be described by the superpotential

$$W () = \frac{2}{1+r} (r + \sin())$$
 (57)




FIG. 5: Potential for the double sine-Gordon model, for r = 1=3; r = 2=3; and r = 1; depicted with dot-dashed, dashed and solid lines, respectively.

We consider r(0;1) and the singular points, dW = d = 0; identify the minima of the potential. They are periodic and, in the interval 2 < < 2; we can identify  $= \arccos(r)$ : We see that the maxima in and the minima in  $\arccos(r)$  collapse to two minima in in the limit r(1:1): This fact is illustrated in Fig. 5, where we plot the double sine-G ordon potential for the values r(1:1): r

This model contains two topological sectors, one large and the other small, with energies

$$E_{BPS}^{1} = 4^{p} \frac{}{1 + r} + 4r \frac{arccos(r)}{1 + r}$$
 (58)

and

$$E_{BPS}^{s} = 4^{p} \frac{1}{1 - r} \quad 4r \frac{\arccos(r)}{1 + r}$$

$$(59)$$

We notice that  $E_{BPS}^1 = E_{BPS}^s + 4 \stackrel{p}{r=} \frac{}{1+r}$ ; and in the lim it r! 1 we get  $E_{PBS}^1!$  2  $\frac{p}{2}$  e  $E_{BPS}^s!$  0: Stable solutions which solve the rst-order equations are given by

$$g(x) = 2 \arctan \frac{r}{1+r} \tanh \left(\frac{p}{1-rx}\right)$$
 (60)

and

$$\frac{r}{1+r} \tanh \left(\frac{p}{1-rx}\right) \tag{61}$$

It is interesting to see that the double sine-G ordon model can be used to map special cmagnetic materials, like the one studied in Ref. [25]; there one identials three distinct phases: anti-ferromagnetic, canted, and weakly ferromagnetic. These phases can be described by the above model, in the cases r = 0; 0 < r < 1 and r = 1; respectively. Moreover, in the canted phase, there also appear two distinct defect structures, the large and small solutions.

A nother example is described by the 6 m odel. Here the potential has the form

$$V() = \frac{1}{2}^{2} (1 - 2)^{2}$$
 (62)

We have W () =  $(1=2)^2$  (1=4) <sup>4</sup>; and the minima are  $_0$  = 0 and = 1: There are two topological sectors, equivalent. The solutions are

$$(x) = \frac{1}{2} [1 \quad \tanh(x)]$$
 (63)

and they identify the kinks and anti-kinks in the two sectors. Their energies are given by  $E = E_{BPS} = 1=4$ : Stability leads us to the quantum -m echanical potentials

U 
$$(x) = \frac{5}{2} \frac{3}{2} \tanh(x) \frac{15}{4} \operatorname{sech}^{2}(x)$$
 (64)

The term s which contain the hyperbolic tangent make the potentials asymmetric. This introduces rejection states into the continuum, although there is only one bound state, the zero-mode; see Ref. [26] for more details.

A nother model is given by [27]

$$V() = \frac{1}{2}(1 + j)^{2}$$
 (65)

It is similar to the  $^4$  model. It has minima in = 1; and we can write W () = (1=2)jj: The rst-order equations are

$$\frac{\mathrm{d}}{\mathrm{dx}} = (1 \quad j \quad j) \tag{66}$$

The solutions are

$$(x) = 2 \frac{\tanh(x=2)}{1 + \tanh(\dot{x} = 2)}$$
 (67)




FIG. 6: The potential of Eq. (65), depicted with dashed line, and the potential of the  $^4$  m odel.




FIG. 7: The kink of Eq. (67), depicted with dashed line, and the kink of the  $^4$  m odel.

Their energies are given by  $E = E_{BPS} = 1$ : In Figs. 6 and 7 we plot potentials and kinks, for the above m odel, and for the  $^4$  m odel, for comparison.

Stability investigations lead us to the potential

$$U(x) = 1 2(x)$$
 (68)

which is attractive. There is just one bound state, the zero mode. To see this explicitly, note that the H am iltonian can be written as

$$\frac{d^2}{dx^2} + 1 \quad 2 \quad (x) = \quad \frac{d}{dx} + \frac{jxj}{x} \quad \frac{d}{dx} + \frac{jxj}{x}$$
 (69)

Thus, we see that the zero-mode obeys

$$\frac{\mathrm{d}}{\mathrm{d}x} + \frac{\dot{x}\dot{y}}{x} \quad _{0}(x) = 0 \tag{70}$$

This equation can be solved easily, given the normalized zero-mode

$$_{0}\left( \mathbf{x}\right) =\exp \left( \right. \left. \dot{\mathbf{x}}\right) \tag{71}$$

The above model was investigated in [27, 28], leading to exact solutions for a model described by coupled linear chains. More recently, it was studied in [29, 30] with other motivations. In particular, in [30] we have introduced




FIG. 8: The potential of the Eq. (72), depicted with dashed line, and the potential of the  $^{6}$  m odel.




FIG. 9: The kink of the Eq. (73), depicted with dashed line, and the kink of the  $^{6}$  m odel.

another m odel, inspired in the above m odel and in the  $^6$  m odel. It is described by

$$V() = \frac{1}{2}^{2} (1 \quad j \quad j^{2}$$
 (72)

There are m in im a in = 0 and = 1; and we have W ( ) =  $(1=2)^2$  (1=3)j j<sup>2</sup>: There are two topological sectors, equivalent, with energies given by E = E<sub>BPS</sub> = 1=6: The solutions are

$$^{+}$$
 (x) =  $\frac{1}{2}$  [1 + tanh (x=2)] (73)

$$(x) = \frac{1}{2} [1 \quad \tanh(x=2)]$$
 (74)

They are  $\sin$  ilar to the solutions of the  $^6$  m odel; see Figs. 8 and 9 for a comparison.

An interesting feature of this new model is that the topological sectors are symmetric, related to the local maxima they have. This makes the topological solutions uniform, leading to a symmetric quantum-mechanical potential which contains no rejection states, as it appeared in the  $^6$  model. This model is of direct interest to study in rst-order phase transition, and we believe that it may be of some use in applications to Condensed Matter.

W e investigate stability of the solutions of the above model. W e get to the potential

$$U(x) = 1 \frac{3}{2} \operatorname{sech}^{2}(x=2)$$
 (75)

The Ham iltonian can be factorized as

$$\frac{d}{dx} + \tanh(x=2) \qquad \frac{d}{dx} + \tanh(x=2) \tag{76}$$

Thus, the zero-mode should obey

$$\frac{d}{dx}$$
 + tanh (x=2)  $_{0}$  (x) = 0 (77)

W e integrate this equation to obtain the normalized zero-mode

$$_{0}(\mathbf{x}) = \frac{1}{2} \frac{1}{2} \frac{3}{2} \operatorname{sech}^{2}(\mathbf{x}=2)$$
 (78)

There is another bound state, with eigenvalue 3=4; and no rejection state appears in the continuum. A nother example is given by the potential [31]

$$V() = \frac{1}{2} \operatorname{sech}^2()$$
 (79)

The novelty here is that the potential has no m in im um, but it supports topological defects, as shown in Refs. [31, 32]. Our participation in this problem started with [33], where we have shown that this model engenders rst-order equations given in terms of the superpotential

$$W () = \arctan[\sinh()]$$
(80)

The rst-order equations are

$$\frac{d}{dx} = \operatorname{sech}() \tag{81}$$

They are solved by

$$(x) = \arcsin(x)$$
 (82)

These defects are dierent: they are very diuse, as we see from the energy density

$$"(x) = \frac{1}{1 + x^2} \tag{83}$$

However, the energy is nite, given by  $E = E_{BPS} = :$ 

It is interesting to see that if we write the topological current in the usual form j = (1=2)" @; we would have problem to calculate the topological charge. However, since the topological current is not unique, we can write

$$j = " @ W ()$$
 (84)

In this case, we are relating the topological charge with the energy of the solution, which seems to be appropriate, since the energy should be well-de ned.

W e investigate stability of the above solutions to get to

$$U(x) = \frac{1+2x^2}{(1+x^2)^2}$$
 (85)




FIG. 10: The volcano-like potential.

This is a volcano-like potential, as we show in Fig. 10. It has a single bound state, the zero-mode, with normalized eigenfunction given by

$$_{0}(\mathbf{x}) = \frac{r}{\frac{1}{1}} \frac{1}{1+x^{2}} \tag{86}$$

In this case, there is no gap between the zero-mode and the continuum.

A nother model is described by the potential [34]

$$V() = \frac{1}{2}(1 - 2)^3$$
 (87)

The novelty here is that this potential is unbounded from below, and it has two in ection points, at the values = 1 such that V () = 0: However, there are topological solutions connecting these in ection points. They are given by

The appearance of topological solutions connecting in ection points was rst shown in [34]. We investigate stability to get to the potential

which is also volcano-like. It has only one bound state, the zero-mode, and there is no gap between the zero-mode and the continuum. The zero-mode is given by

In the last two examples, there is no gap between the zero-mode and the continuum, and so we should investigate how the quantum corrections should appear, to see if there are subtleties, as it occurs in models where a gap is present; see, e.g., Refs  $[12\{14]$  for more information on this issue.

A nother model is described by the potential [35]

where p is a real parameter. For simplicity, here we consider p odd integer, p = 1; 3; 5; ... This model can be seen as a generalization of the <sup>4</sup> model, which is obtained for <math>p = 1:

In this case we can write




FIG. 11: The 2-kink solution for p = 3 and 5; depicted with solid and dashed lines, respectively.

The energies are given by  $E_{BPS}^p = 4p = (4p^2 - 1)$ . In Fig. 11 we plot some solutions, and there we see that they connect the minim a 1; passing through the minim um at zero with vanishing derivative.

As far as we can see, this is the rst time that topological solutions connect non-adjacent minima, passing through an intermediate minimum. This fact is only possible because the minimum at zero is not a true minimum, that is, it is not good for quantization because it cannot be used as a perturbative ground state, since the mass squared at = 0 is divergent. For this reason, the above solutions are named 2-kink solutions.

The above solutions present normalized zero-mode, described by

III. TW O-FIELD M ODELS

Let us now consider models described by two real scalar elds, given by

where V (; ) is the potential, which speci es the model to be studied. In (1;1) dimensions, the equations of motion are

N on-linearity makes it hard to deal with these equations on general grounds. Some investigations were done in Refs. [36{38]. In particular, in [36] one illustrates the di culties to solve Eqs. (99) and (100). This problem was further considered in [39] and there it was proposed a method, named trial orbit method, which could perhaps be of som e use to solve the above equations. In 1995 we started our investigations on models described by two real scalar elds. We started with the potential [40]

This procedure shows that the energy is minimized to  $E = E_{BPS}$ ; for eld congurations which obey the rst-order equations

On the other hand, if we di erentiate these equations with respect to x; we can see that their solutions also solve the second-order equations of motion for W = W; which is the condition for W to present second derivative, as the potential (101) asks im plicitly.

It is interesting to see that solutions of the storder equations have the same portion of gradient and potential energies. The rst-order equations can be seen as a dynamical system, and so we can use all the mathematical tools available for dynam ical systems to deal with these equations. In particular, the algebraic equations W = 0 and W = 0 can be solved to give the set of singular points of the respective dynamical system. In the eld theoretical m odel, this set of singular points constitute the absolute minim a of the model. We can characterize the absolute m in im a w ith  $v_i = (i; i); i = 1; 2; ::: Thus, each pair of m in im a <math>v_i e v_j$  m ay represent a topological sector, which m ay

A given sector ij is BPS if the energy  $E^{(ij)}$  is not zero, that is, if  $W_i = W_i$  ( i; i) is distinct from  $W_j = W_i$  ( j; j); to make the energy  $E_{BPS}^{(ij)} = jW_{ij}j = jW_{i}$  W j j non-vanishing. On the other hand, if  $W_{i} = W_{i}$  ( i; i) is equal to W  $_{j}$  = W (  $_{j}$ ;  $_{j}$ ); there is no BPS energy available, and this shows that there is no BPS solution connecting the m inim a that identify the sector. In this case, however, the sector m ay have con gurations which solve the equations of motion. These sectors are usually named non-BPS, because the eld con gurations do not solve the rst-order equations.

In the BPS limit, models described by two real scalar elds are simpler, because we have to deal with pairs of rst-order equations. We then focus on the equations (108) and (109). We can write

This equation is easily solved when W (; ) is harm onic. In this case, the solutions describe an orbit in the (; ) plane, given by F (; ) = 0; which is obtained with

In Refs. [7,8] we have shown that when W is harm onic, all the solutions are BPS solutions.

When W (; ) is not harm onic, we have to search for the integrating factor I (; ). This factor is needed to make another function,  $F^{\mathbb{R}}$  (; ); harm onic, such that

The main problem with the integrating factor is that we do not know how to get it in general, and so the trial orbit method is yet of good use to not solutions in speci c models.

The trial orbit method is very elective when it is applied to rst-order equations. This was shown in Ref. [41], and the main steps can be sum marized as follows:

First step. Choose a BPS sector. This is done with two minima,  $v_i = (i; i)$  and  $v_j = (j; j)$ ; such that  $W_i = W_i (i; i) \notin W_j = W_i (j; j)$ :

Second step. Choose an orbit. This is done with a given function  $F_{ij}(;) = 0$ ; which is compatible with the minima that specify the sector, which satis es  $F_{ij}(_{i};_{i}) = 0$  and  $F_{ij}(_{j};_{j}) = 0$ .

Third step. Try the chosen orbit. This is done taking the derivative of the chosen orbit to get

If this new expression is compatible with the chosen orbit, it is a good orbit and can be used to decouple the rst-order equations.

These three steps are very e cient to solve the rst-order equations, to nd BPS solutions, as we illustrate below.

# A. Linear Stability

We can investigate linear stability of the BPS solutions in a general way. We write = (x;t) and = (x;t) as

In Ref. [42] we have shown how to introduce rst-order operators such that

Now, in (117) we see that H is just  $H_+$ ; the partner of H : The H am iltonians  $H_+$  e H can be seen as supersymm etric partners in quantum mechanics. The factorization of H implies that it is non-negative, and this proves stability of the BPS solutions in general. M oreover, the zero-m ode solves the equation

B. Example

W e illustrate the above investigations with an example. W e consider the function

This model was rst studied in Ref. [40]. See also Refs. [11, 43 [52] for related investigations.




FIG. 12: Potential for the two-eld model of Eq. (127).

The potential (127) is plotted in Fig. 12. For static solutions the equations of motion are given by

The m inim a of the potential are (1;0) for r < 0, or (1;0) and (0; 1 = r) for r > 0: We consider the picher case, for r > 0: Here there are four m inim a, given by  $v_1 = (1;0)$ ;  $v_2 = (1;0)$ ;  $v_3 = (0;1 = r)$  and  $v_4 = (0;1 = r)$ : There are six topological sectors: sector 1, which connects the m inim a  $v_1$  and  $v_2$ ; sector 2, which connect the m inim a  $v_3$  and  $v_4$ ; sector 3, which connect the m inim a  $v_1$  and  $v_2$ ; sector 5, which connect the m inim a  $v_2$  and  $v_3$ ; and, nally, sector 6, which connect the m inim a  $v_2$  and  $v_4$ :

The value of W at the m in in a are given by: W  $_1$  = W (1;0) = 2=3; W  $_2$  = W (1;0) = 2=3; W  $_3$  = W  $(0;1=\frac{p}{r})$  = 0; and W  $_3$  = W  $(0;1=\frac{p}{r})$  = 0: Thus, there are ve sectors which are BPS, one with energy E  $_{BPS}^1$  = 4=3 and the other four with the same energy E  $_{BPS}^3$  = E  $_{BPS}^4$  = E  $_{BPS}^5$  = E  $_{BPS}^6$  = 2=3: There is one sector which is non-BPS; it has energy E  $_{nBPS}^2$ ; which can only be obtained when one shows the corresponding topological solution explicitly.

To nd explicit solutions, let us rst consider solutions which depend only on a single eld. We rst set = 0 in the equations of motion. We get

which is the equation for the  $^4$  m odel, which has the solutions  $(x) = \tanh(x)$ ; with energy 4=3: Thus, the pair of solutions

are solutions for the above two-eld model. In eld space, these solutions describe a straight line connecting the minima  $v_1$  and  $v_2$ ; which identify the topological sector 1. We also see that the imposition = 0 reduces the rst-order equations to the equation

which have the same solutions, showing that they are BPS solutions.

represent straight line orbit which connects the m in im a  $v_3$  and  $v_4$ . In this case, however, the solutions are non-BPS, because they do not satisfy the rst-order equations. We notice that the energy of the non-BPS solutions depend on r; for r 2 (0;1) it is higher than the energy of the BPS states in sector 1:

The above model has an interesting feature. For r=1; we can notate the (;) plane to  $_1=+$  and  $_2=$ ; to see that  $_1$  and  $_2$  decouple, describing two single eld models, instead of a single model of two elds. See Ref. [52] for other details on the issue.

In order to illustrate the trial orbit m ethod, let us investigate solutions in the several BPS sectors of the m odel. First, we consider sector 1; identi ed by the m inim a  $v_1=(1;0)$  and  $v_2=(1;0)$ : We consider an elliptic orbit, described by a  $^2+b^2=c$ ; with a; b; c being real parameters which identify the orbit. This orbit m ust contain the two m inim a which identify the sector 1; these conditions elim inates two parameters, and we get to the m ore species orbit  $^2+b^2=1$ : We now derivate this orbit and use the rst-order equations to get to  $^2+r(1+2b)^2=1$ ; which is compatible with our orbit for b=r=(1-2r): Thus, the orbit

$${}^{2} + \frac{1}{\frac{1}{r}} {}^{2} = 1 \tag{138}$$

is a good orbit for r 2 (0;1=2); and can be used to solve the problem . We use this orbit to write

We use this into the rst-order equation for to obtain

which are solved by




FIG. 13: A pair of solutions for the two-eld model. The solid and dashed lines describe the and elds, respectively.

There are four solutions for the pair (;); and in Fig. 13 we plot a pair of solutions for r = 1=6: It is interesting to notice that the above solutions can be used to describe solitons in ferroelectric materials, as we have pointed in Ref. [53]. These solutions are BPS states. Their energies have the value 4=3, and they change to the solutions that describe the straight line orbit in the limit r : 1=2; as it should be expected.

There are other orbits, in the other sectors, and they can be obtained as we did above. Orbits in the other sectors were rst obtained in Ref. [46]. Also, an interesting investigation done in Ref. [47] obtained the integrating factor for the pair of rst-order equations, solving completely the problem of nding BPS solutions for the model.

We can study stability of the solutions explicitly. We illustrate this point investigating the simplest case, concerning stability of the solutions for the straight line orbit in sector 1. In this case, the uctuations in the elds and obey the equations H  $_n$  (x) =  $w_n^2$   $_n$  (x) and  $H^2$   $_n$  (x) =  $w_n^2$   $_n$  (x); respectively. The H am illustrates are given by

The pst problem is the modi ed Poschl-Teller problem. It supports two bound states, the zero-mode  $w_0 = 0$  and  $w_1 = 3$ : The second problem is also of the modi ed Poschl-Teller type, but now the number of bound states depends on r; the parameter that controls the form of the potential. We have




FIG. 14: Potentials for r = 1=2; 1; e 3=2; depicted with solid, dashed and dot-dashed lines, respectively.

where n=0;1;2;:::;<2r: Thus, if r=2 (0;1=2]; only the zero-m ode appears. For r=2 (1=2;1]; there are two bound states, the zero-m ode and another one, with eigenvalue  $we_1=4r-1:$  We illustrate this in Fig. 14, in which we plot the potential of Eq. (144) for the values r=1=2; r=1 e r=3=2: We notice that for r=0; the investigations for solutions reduce to that of the r=1 model; however, stability is very different, and this will certainly show up at the quantum level.

#### C. Junction of defects

In two-eld models, in general the potential depends on the two elds, and so the minima are in the (;) plane. Thus, we can not situations where the minima constitute a non-collinear set of points, which is not possible for models described by a single eld. For this reason, two-eld models may give rise to junctions of defects, which are regions where two or more defects intersect, and this lead us to more general situations that describe junctions of defects, and the tiling of the plane with a network of defects. Some investigations on this subject can be found in Refs. [50, 51, 54{58}] and also in the more recent Refs. [7, 8].

An interesting way to describe junctions of defects is with a complex eld. We consider models described by the Lagrange density

The m in im a of the potential are given by W  $^{0}(') = 0$ : W e suppose that there is a nite number of m in im a, given by  $v_{k}$ ; k = 1; 2; ...; N; where N is an integer. We are interested in solutions which obey the boundary conditions

where  $v_i$  is one in the set of N m in im a.

We can show that solutions of the rst-order equation

The above model is special, since the equation of motion is equivalent to the set of rst-order equations parametrized by the phase : To show this we use the rst-order equation to write

However, in the lim it x! 1 the eld should become '!  $v_i$ ; and d'=dx! 0 and W  $^0$ (')! 0: Thus, S (') is shown to vanish, and this in plies that R (') is constant. Besides, since S (') vanishes, we can obtain d'=dx = W  $^0$ ('): Thus, we can write  $\Re$  (') j= 1; and so R (') =  $e^i$ ; with being real and constant. The last result is nothing more than an alternative way to write the rst-order equation. This is general, and it shows that in this model all the static solutions are BPS solutions. A direct consequence of this result is that for models described by two real scalar elds, if W = W (;) is harm onic, then the model cannot support non-topological solutions.

W e can consider the model [7,8]

The models engender discrete symmetry,  $Z_N$ ; for every n; and they can be used to generate defect junctions, of intrinsic interest, and for tiling the plane with regular polygons.

The case n = 0 is special. It has

which were already studied in [59], with other motivations.

The generalm odelhasm in im a at  $v_k^N = \exp(i \frac{k}{N})$ ; for k = 2 (k=N); k = 1;2; ...; N; independently of n; and also in  $v_0 = 0$  for k = 0. There are N m in im a in the unit circle, and the origin is also a m in im um for k = 0; with multiplicity n: For the topological sectors, for k = 0 there appear N radial sectors. The energies of the radial sectors are given by

for n = 1; 2; ... and N = 2; 3; ... The energies of the other sectors are

We notice that if the pair n and N obeys n = N 1; the energies  $E_N^n$ ; wanish for every k = 1;2; ...; N: In this case the model can only support radial sectors, with energies  $E_N^{N-1} = 1$ =2N.

As one knows, to tile the plane with regular polygons [60, 61], we only have three possibilities: using equilateral triangles, squares, or regular hexagons. Now, if we ask for the most e cient way of tiling the plane, we see that it is given by the hexagonal tiling. E ciency here in plies the greater relation area/perimeter for the three regular polygonal tilings. Since the use of hexagons requires the presence of triple junctions, we then focus attention on the above model, for the case n = 0 and N = 3: This case can also be of interest to nanotubes and fullerenes, as explored in [62, 63]; see also R efs. [64 [67].

W = use n = 0 and N = 3 to get

$$W (') = ' \frac{1}{4}'^{4}$$
 (162)

The three m in im a are  $v_1 = 1$ ; and  $v_{2;3} = 1 = 2$  if  $\overline{3} = 2$ : The energy of the defects are given by  $E_3^0 = 3^{\overline{5}} = 4$ ; and this should be the energy density of the junction in the regions far away from the junction. However, if we neglect the energy density related to the junction itself, we can write the total energy of the triple junction as  $E = 3LE_3^0 = 9^{\overline{5}} = 3L=4$ ; approximately, for L being the size of each junction leg.

#### IV. DEFORM ED DEFECTS

In the case ofm odels described by a single eld, recently we have been able [34, 68] to introduce a procedure, which we call deform ation procedure, where we start with a given model, that support defect structures, and we deform it, to write a new model, which also support defects that can be written in terms of the defects of the given, starting model. To make this idea practical, let us start with a model de ned by the potential V(); which support static solutions, given by (x): To deform this model we get a function f = f(); which is well-behaved, invertible, which we name deform ation function, and we write another potential, as follows

$$\Re (') = \frac{V (! f ('))}{\operatorname{ld} f (') = d' ?}$$
(163)

We have two distinct models, given by

$$L = \frac{1}{2} Q Q V ()$$
 (164)

$$\mathbb{P} = \frac{1}{2} @ ' @ ' & \mathbb{P} (')$$
 (165)

However, if V and  $\forall$  are related by Eq. (163), and if (x) are defects of the rst model, then the new model has defect solutions given by

' 
$$(x) = f^{-1}((x))$$
 (166)

written in terms of the inverse of the deformation function.

To prove the above result, let us consider the equation of motion for static solutions in the two models

$$\frac{d^2}{dx^2} = \frac{dV}{d} \tag{167}$$

$$\frac{d^2'}{dx^2} = \frac{d^2}{d'} \tag{168}$$

We require that the energies are nite, and that the solutions obey boundary conditions as before, in Sec. II. Thus, we can write

$$\frac{d}{dx}^2 = 2V \tag{169}$$

$$\frac{d'}{dx} = 2 \Re \tag{170}$$

In the rst case, the energy density has the form

"(x) = 
$$\frac{1}{2} \frac{d}{dx}^2 + V = \frac{d}{dx}^2$$

In the other case, we get

$$\mathbf{E}(\mathbf{x}) = \frac{1}{2} \cdot \frac{\mathbf{d'}}{\mathbf{dx}}^2 + \mathbf{\hat{y}} = \frac{\mathbf{d'}}{\mathbf{dx}}^2$$

W e can use the last expression to relate both densities

$$e = \frac{1}{(df = d)^2} "(x)$$
 (171)

On the other hand, we can use = f(') to obtain

$$\frac{d^2}{dx^2} = \frac{d}{dx} \frac{df}{dx} \frac{d'}{dx}$$

$$= \frac{df}{d'} \frac{d^2 f}{dx^2} + \frac{d^2 f}{d'^2} \frac{d'}{dx}$$
(172)

Thus, we use  $d^2$ ' = $dx^2$  and d' =dx from the equation of motion to get

$$\frac{d^2}{dx^2} = \frac{df}{d'}\frac{d\vec{v}}{d'} + 2\vec{v}\frac{d^2f}{d'^2}$$
 (173)

However, since  $\forall$  (') = V ()=(df=d')<sup>2</sup>; we can write


$$\frac{d\nabla}{d'} = 2V () \frac{1}{(df = d')^3} \frac{d^2 f}{d'^2} + \frac{1}{(df = d')} \frac{dV}{d}$$
 (174)

and so we get

$$\frac{d^2}{dx^2} = \frac{dV}{d} \tag{175}$$

which is the equation of motion for the rst model. This result shows that solutions of the second model are related to solutions of the rst model. To complete the proof, we need to show the contrary, but this is similar and straightforward.

It is interesting to realize that we can deform the deform ed model once again, etc, and this procedure lead us with an in nity of models, as we illustrate in the diagram below.



We notice that the deform ation procedure works for models that support topological, kink-like, or non-topological, lump-like, solutions. However, for models which support BPS states, the deformation procedure is simpler, since now we can investigate the rst-order equations. We have

$$\frac{d}{dx} = \frac{dW}{d} \tag{176}$$

and

$$\frac{d'}{dx} = \frac{1}{df = d'} \frac{dW}{df}$$
 (177)

The last equations can be written as

$$\frac{df}{dx} = \frac{dW}{df} \tag{178}$$

and now they are like the equations for the rst model, with the change! f. Thus, their solutions obey f(') = ; and so we get'  $(x) = f^{-1}[(x)]$ ; in accordance with Eq. (166).

We illustrate the procedure with an example. We take the standard  $^4$  model, and the function f() =  $\sinh$ (): In this case the potential

$$V() = \frac{1}{2} (1 ^{2})^{2} (179)$$

changes to

It is not hard to verify explicitly that the static solutions of this new model are given by

$$e (x) = \operatorname{arcsinh} [\tanh (x)]$$
 (181)

Besides, the energy density of these solutions are

$$e(x) = \cosh^2 [\tanh (x)] \operatorname{sech}^4 (x)$$




FIG. 15: Defect solutions for the 4 m odel, and for the deformed model, depicted with solid and dashed lines, respectively.




FIG. 16: Energy densities for the 4 m odel, and for the deformed model, depicted with solid and dashed lines, respectively.

(182)

where "(x) =  ${\rm sech}^4(x)$  is the energy density for the  $^4$  m odel. In Figs. 15 and 16 we plot defects and energy densities in both models, for comparison.

A nother example can be given; we consider the 4 model, but now we use the function

$$f_p(') = '^{1=p}$$
 (183)

where p is a real parameter. We consider podd integer, p = 1;3;5; ... The case <math>p = 1 is trivial, but in general the new potential has the form

$$\Re (') = \frac{1}{2} p^2 ('^{1} 1=p '^{1+1=p})^2$$
(184)

This potential was already investigated in Sec. II. The rst-order equations are

$$\frac{d'}{dx} = p('^{1} = p ('^{1} = p))$$
 (185)

and their solutions can be written as

$$'(x) = \tanh^p(x)$$
 (186)

as it can be shown directly.

A nother example is given by the potential

$$V () = \frac{1}{2} (1 )^{3}$$
 (187)

We can use the deformation! tanh () to obtain

$$V() = \frac{1}{2} \operatorname{sech}^2()$$
 (188)

Both models were investigated in Sec. II. In the second case, the solutions  $(x) = \arcsin(x)$  can be deformed to give

$$(x) = \frac{x}{1+x^2} \tag{189}$$

which solve the rst model.

It is interesting to notice that the potential (187) has no m inim a, and their topological solutions connect in ection points. A similar result was presented in Ref. [69], where the authors and topological solutions which connect an in ection point to a minimum of the potential there considered.

#### V. DEFECTS IN HIGHER SPATIAL DIMENSIONS

There is an old result [70, 71], which informs that models described by a single real scalar eld cannot support stable solutions in space dimensions higher than 1: This result is known as the Derrick theorem, but we call it the Derrick-Hobart theorem, since it was also obtained by Hobart in Ref. [70]. We can show this result as follows: in (D;1) space-time dimensions, let us suppose that there is a model described by some non-negative potential, in the form

$$L = \frac{1}{2} Q Q V ()$$
 (190)

We also suppose that (x) is static solution, with energy

$$E = E_g + E_p = \frac{Z}{dx} \frac{1}{2}r + V()$$
 (191)

Now, for (x) = (x) we have

$$E = \frac{Z}{dx} \frac{1}{2}r \qquad r + V ( )$$

$$= E_{q} + E_{p} = \frac{Z}{D} E_{g} + \frac{D}{D} E_{p}$$
(192)

Thus, we can write

$$\frac{dE}{d} = (2 D)E_g DE_p$$
 (193)

$$\frac{d^{2}E}{d^{2}} = (2 D)(1 D)E_{g} + D(1 + D)E_{p}$$
 (194)

and so, for E to have a m in im um at = 1; we have to have (2 D)  $E_g = D E_p$  and (2 D) (1 D)  $E_g + D$  (1+D)  $E_p > 0$ ; and this requires that D = 1:

In spite of this result, in a recent work we have been able to circum vent the standard situation, to show how to construct stable defect solutions for D arbitrary [35]. To make this possible, we work with the model

$$L = \frac{1}{2} \theta \quad \theta \quad U(x; )$$
 (195)

w here

$$U(x; ) = F(x \times )V()$$
 (196)

and V ( ) is some standard potential, and F (x x ) is a new function, which depends only on the space-time coordinates in (D;1) dimensions. See Ref. [72] for other investigations concerning higher dimensional defect structures.

In the case of static solutions we can choose an appropriate F; to write the equation of motion in the form

$$r^{2} = \frac{1}{r^{2D-2}} \frac{dV}{d}$$
 (197)

Thus, for  $V = (1=2)W^2$  and for radial solutions, = (r) should obey

$$r^{D} \stackrel{1}{=} \frac{d}{dr} \quad r^{D} \stackrel{1}{=} \frac{d}{dr} = W \quad W \tag{198}$$

W e can write

$$r^{D} \frac{1}{dr} = \frac{d}{dy}$$
 (199)

to change the equation of motion to

$$\frac{d^2}{dv^2} = W \quad W \tag{200}$$

This equation has the form of the equation of motion for static solutions in the case of two-dimensional models. Thus, it can be written as rst-order equations

$$\frac{d}{dv} = W \tag{201}$$

or better

$$\frac{d}{dr} = \frac{1}{r^{D-1}}W$$
 (202)

This result can also be obtained from the energy of static, radially symmetric solutions. If we work with the energy, we can write

$$E = \frac{1}{2} \int_{0}^{Z_{1}} r^{D-1} dr \frac{d}{dr} + \frac{1}{r^{2D-2}} W^{2}$$

$$= \int_{0}^{Z_{1}} dr \frac{dW}{dr} + \frac{1}{r^{D-1}} W^{2}$$

$$= \frac{1}{2} \int_{0}^{Z_{1}} r^{D-1} dr \frac{d}{dr} \frac{1}{r^{D-1}} W^{2}$$
(203)

where  $_{D}$  = 2  $^{D=2}$ = (D=2) stands for the angular factor, which depends on D:W e see that the energy is m in imized to the value  $E_{BPS}$  =  $_{D}$  W; where

$$W = W [(r! 1)] W [(r! 0)]$$
 (204)

if the static, radial solution (r) obeys one of the two rst-order equations (202).

A swe have shown in Ref. [35], other results can also be obtained. For instance, we can show that the radial solutions are stable against radial uctuations. Also, we can introduce ferm ions, with the standard Yukawa coupling changed to Y () =  $r^{1-D}W$ ; to include the radial modi cation we have introduced in the scalar potential.

On the other hand, in the case D = 2; the transform ation which maps the problem into a one-dimensional problem has the form  $y = \ln(r)$ , which very much reminds us of the Cole-Hopf transform ation, used to transform the Burgers equation into a linear, exactly solved equation [73, 74] { see also Refs. [75, 76].

To illustrate the general situation, let us consider the model

$$U(x; ) = \frac{1}{2} \frac{1}{r^2} \sin^2()$$
 (205)

in D = 2: This is the sine-Gordon model, but here it is modiled to incorporate the spatial dependence introduced above.

In this case, the equation of motion which describes static and radial solutions gets to the modi ed form

$$\frac{d^2}{dr^2} + \frac{1}{r}\frac{d}{dr} = \frac{1}{r^2}\sin(1)\cos(1)$$
 (206)

It adm its scale invariance, and it can be written as

$$r\frac{d}{dr} r\frac{d}{dr} = \sin(1)\cos(1)$$
 (207)




FIG. 17: Topological soliton in D = 2; which appears in an isotropic uniaxial ferrom agnetic system.

Thus, we take  $y = \ln(r)$  to obtain

$$\frac{d^2}{dy^2} = \sin(0)\cos(0) \tag{208}$$

This problem was already solved in Sec. II. We can write

$$\frac{d}{dy} = \sin(t) \tag{209}$$

and the solutions are

$$(y) = 2 \arctan(e^{-y})$$
 (210)

We use the radial coordinate to get

$$(r) = 2\arctan(r^{-1})$$
 (211)

These solutions are topological solutions [35]. They can be used to describe solitons in bidim ensional, isotropic, uniaxial ferrom agnetic [77], and they were rst described in Ref. [78]. In Fig. 17 we plot one of the solutions, to show the topological structure explicitly; see Ref. [25] for related investigations.

# VI. WARPED GEOMETRY WITH AN EXTRA DIMENSION

We can couple scalar elds with gravity. We get [79, 80]

$$S = \frac{Z}{dtdx} \frac{p}{jgj} \frac{1}{4}R \frac{1}{2}g \quad @ \quad V ()$$
 (212)

Here we are working in arbitrary (D;1) space-timed imensions, using dimensionless elds and variables with 4 G = 1:
g is the metric tensor and R is the curvature scalar, given by

$$R = R \tag{213}$$

where R is the Ricci tensor, which can be written as

$$R = R (214)$$

in terms of the Riem ann tensor R; which can be written in terms of the Christo elsymbols, in the form

$$R = 0 + (215)$$

with

$$= \frac{1}{2}g \quad (0 g + 0 g \quad 0 g) \tag{216}$$

E instein equation is given by

$$G = R \frac{1}{2}R g = 2T$$
 (217)

and G is the E instein tensor.

Our interest on scalar elds coupled to gravity is motivated by String Theory. As one knows, superstrings need 10 space-time dimensions [81, 82]. In Ref. [83], Polchinski has shown how to construct soliton-like brane solutions which appear under the factorization of the (9;1) space-time into  $AdS_5$   $S^5$ : In this case, the interesting structure of space-time is  $AdS_5$ ; and we can work with an extra dimension, following the Randall-Sundrum [84] or Karch-Randall [85] scenarios, as we have done in Refs. [86{88}].

We illustrate the investigations working with the  $AdS_5$ ; in (4;1) space-time dimensions, in the Randall-Sundrum scenario. The metric for such warped geometry with an extra dimension is given by

$$ds^2 = e^{2A}$$
  $dx dx + dy^2$  (218)

where = (1;1;1;1); and y is the spatial coordinate which describes the extra dimension.  $e^{2A}$  is known as the warp factor, since it modi es the standard four dimensional M inkowsky metric, described by : The matter contents of the model is described by real scalar elds. We consider the action

where we consider a single real scalar eld. For more elds, we modify the scalar Lagrangean accordingly.

We suppose that A = A(y) and that the scalar eld is also static, and only depends on the extra coordinate, = (y); in this case the equations of motion are

$$^{\circ}$$
 + 4A $^{\circ}$   $^{\circ}$  =  $\frac{dV}{d}$  (220)

$$A^{0} + \frac{2}{3}^{0} = 0$$
 (221)

and

$$A^{\otimes} = \frac{1}{6} {}^{\otimes} + \frac{1}{3} V () = 0$$
 (222)

which is a consistence equation. In the above equations, we are using that  $A^0 = dA = dy$ ; etc.

In the Randall-Sundrum scenario [84], M inkowsky space M  $_4$  is embedded in anti-de Sitter space A dS $_5$ : In Refs. [89] 91] the authors introduce very interesting investigations on the subject. For instance, if we consider the potential in the form

$$V() = \frac{1}{8} \frac{dW}{d}^{2} \frac{1}{3}W^{2}$$
 (223)

we can write the rst-order equations

$$^{\circ} = \frac{1}{2} \frac{dW}{d} \tag{224}$$

and

$$A^{0} = \frac{1}{3} W$$
 (225)

which solve the equations of motion; see also Refs. [92, 93] for other details on this. We notice that the rst-order equation for the scalar eld is very much like the rst-order equation that we get for models described by a single real scalar eld in (1;1) dimensions in at spacetime; see Sec. II. Thus, we can use those models to describe brane solutions in scenarios involving one extra dimension.

An example was considered in [86], where we have used the model described by

$$W_{p}() = \frac{p}{2p-1} (2p-1)=p \frac{p}{2p+1} (2p+1)=p$$
 (226)




FIG. 18: The kink-like solutions for p = 1;3;5: The thickness of the line increases for increasing p:




FIG. 19: The warp factor for p = 1;3;5. The thickness of the line increases for increasing p:




FIG. 20: The matter energy density for p = 1;3;5. The thickness of the line increases for increasing p:

There we have shown that the parameter p gives rise to an interesting e ect, leading to thick brane with internal structure, as we show in Figs. 18, 19 and 20 for p = 1;3;5. We notice that the thickness of the brane increases for increasing p; and that the matter energy density opens a gap in its center, suggesting the appearance of internal structure, as we show in Ref. [86]. We also notice that p works like the temperature, as it is shown in the model considered in Ref. [94].

In another work, we considered another model, described by [87]

$$W (;) = \frac{1}{3}^{3} r^{2}$$
 (227)

This model gives rise to Bloch branes, in analogy with the Bloch walls that it generates in at space-time. The interested reader should see Refs. [95{97] for other investigations.

# A. Other Scenarios

We can work with other scenarios, involving two or more extra dimensions. In the case of two extra dimensions, the important defect structures are vortices, which are planar topological solutions that appear in models de ned in (2;1) space-time dimensions, describing interactions between gauge and charged Higgs elds.

A model under investigation is described by [98]

$$L = \frac{1}{2}$$

In this case, the C herm-S im ons term presents higher-order derivative, and we are considering  $D=\emptyset$  ie  $\emptyset$  A; which describes speci c non-m in im alcoupling between the vector and scalar elds.

In this case, the equations of motion are

The energy density for static con gurations can be written in the form

$$" = \mathfrak{P} ' \mathring{f} + \frac{2}{4e^2} \frac{(r^2 A_0)^2}{\mathring{f} \mathring{f}} + V (\mathring{J} \mathring{f})$$
 (232)

where  $D = \tilde{r} + ien$   $\tilde{r} A_0$ : This result appears after elim inating the constraint

$$B = \frac{r^2 A_0}{2e^2} \frac{r^2 A_0}{r^2}$$
 (233)

The energy gets the form

$$E = 2 \quad \text{rdr } j(D_1 \quad iD_2)' \hat{j} + \frac{r^2 A_0}{2e} \cdot \frac{e^2}{\prime} (1 \quad \hat{j} \hat{j})^2$$

$$Z \quad \text{rdrr } ^2 A_0$$
(234)

where we have set

$$V(JJ) = \frac{e^4}{2}JJ(1-JJ)^2$$
 (235)

The energy can be minimized to

$$E_{BPS} = 2 \quad rdrr^{2}A_{0}$$
 (236)

It is obtained for elds that obey the rst-order equations

$$D_1' = iD_2' \tag{237}$$

$$B = \frac{e}{-}(1 + j j) \tag{238}$$

We choose the elds in the form

Thus, the rst-order equations change to

The energy is quantized, in the form  $E_{BPS} = 2$  jnj:

This models contains the Chem-Sim ons term; thus,  $J^0 = 2e^2JJB$  shows that the electric charge is given by Q = 2 ( =e)n:On the other hand, the magnetic ux is given by  $B = (-e^3)(n^2 + j_1)M$  oreover, if we introduce the topological current  $J_T = -(-e^3)(n^2 + j_1)M$ ; which can be identified with the magnetic ux. This identification also appears in the standard Chem-Sim ons model, but there the values are different [99, 100]:  $B = Q_T = (2 - e^3)n$ :

Here, however, we can introduce another topological current, dual to the above one. It has the form  $\mathfrak{F}_T$  = " @  $J_T$ : In the standard Chem-Sim ons model, the corresponding topological charge vanishes. But in the model under investigation, it is given by  $\mathfrak{F}_T$  = 2 ( =e)n; which is exactly the electric charge of the solution.

Our interest in vortices is related to the interest in braneworld scenarios with two or more extra dimensions, but this is another story.
