Abstract

We study a possibly integrable model of abelian gauge elds on a two-dimensional surface M, with volume form . It has the same phase space as ideal hydrodynam ics, a coadjoint orbit of the volume preserving dieomorphism group of M. Gauge eld Poisson brackets dier from the Heisenberg algebra, but are reminiscent of Yang-M ills theory on a null surface. Enstrophy invariants are Casim irs of the Poisson algebra of gauge invariant observables. Som e symplectic leaves of the Poisson manifold are identied. The Ham iltonian is a magnetic energy, similar to that of electrodynamics, and depends on a metric whose volume element is not a multiple of

. The magnetic eld evolves by a quadratically non-linear Euler' equation, which may also be regarded as describing geodesic ow on SD i (M;). Static solutions are obtained. For uniform , an in nite sequence of local conserved charges beginning with the ham iltonian are found. The charges are shown to be in involution, suggesting integrability. Besides being a theory of a novel kind of ideal ow, this is a toy-m odel for Yang-M ills theory and matrix eld theories, whose gauge-invariant phase space is conjectured to be a coadjoint orbit of the di com orphism group of a non-com mutative space.

1 Introduction and Summary

The classical theory of gauge $elds^1 A_1(x^1;x^2;t)$ and $A_2(x^1;x^2;t)$ we study in this paper, may be sum marized in four equations. The ham iltonian is a gauge-invariant magnetic energy,

where $B = Q_1A_2$ Q_2A_1 is the magnetic eld. is a given volume element and g_{ij} a xed metric on a two dimensional surface M such that $= {}^2=g$ is not a constant ($g = detg_{ij}$). The Poisson bracket between gauge elds is a Lie algebra (independent of the metric)

H am ilton's equation for time evolution of gauge-invariant observables, f-= fH; fg im plies that the magnetic eld evolves according to a non-linear Euler' equation

V is well as a rigid body for the group of volum e preserving di eom orphism s of M , the inverse of the inertia tensor is a twisted version of the Laplace operator

This theory has the same phase space and Poisson brackets as 2 + 1 ideal(inviscid and volum e preserving) hydrodynamics, but a di erent ham iltonian. It may be integrable, since we nd an in nite num ber of conserved quantities $H_n = (B =)^n$ d'x as well as an in nite num ber of C asim irs $I_n = (B =)^n$ d'x for uniform . It is remarkable that one can make this modi cation to 2 + 1 ideal ow, which is sometimes studied as a toy-model for turbulence, to get a potentially integrable system. However, our original motivation for studying this model was di erent. We argue below that it is the simplest gauge theory' that shares some quite deep, though unfamiliar, mathem atical features of Yang-M ills theory.

The form ulation of Y ang-M ills theory in terms of gauge-invariant observables, and the developm ent of m ethods for its solution are important and challenging problems of theoretical physics, since all the experimentally observed asymptotic states of the strong interactions are color-singlets. This problem has a long history stretching at least as far back as the work of M andelstam [1]. W ilson loops are a natural choice for gauge-invariant variables, but they have trivial Poisson brackets on a spatial initial value surface, since the gauge eld is canonically conjugate to the electric eld on such a surface. M ore recently, it has been shown by R a jeev and Turgut[2, 3], that W ilson Loops of 3 + 1 dimensional Y ang-M ills theory on a null initial value hypersurface satisfy a quadratic Poisson algebra with no need for electric eld insertions. This is because the transverse components of the gauge eld satisfy a non-trivial Poisson algebra of W ilson loops is degenerate due to M andelstam -like constraints. The gauge invariant phase space of Y ang-M ills theory is conjectured to be a coadjoint orbit of this Poisson algebra. It is

still a challenge to write the ham iltonian in terms of these variables. However, this has been possible in dimensionally reduced versions² such as adjoint scalar eld theories coupled to quarks in 1 + 1 dimensions, as shown by Lee and Rajeev [5, 6]. In conjunction with 't Hooff's large N approximation [7], viewed as an alternative classical limit, this is an approach to better understand the non-perturbative dynamics, especially of non-supersymmetric gauge theories. In such an approach to 1 + 1 QCD, the phase space of gauge-invariant meson variables is an in nite G rassmannian, a coadjoint orbit of an in nite dimensional unitary group [8]. This allows one to understand baryons as well as mesons in the large N limit, going beyond the early work of 't Hooft [9, 8, 10, 11].

However, the groups and Lie algebras whose coad joint orbits are relevant to matrix eld theories and Yang-M ills theory are poorly understood non-commutative versions of dieom orphism groups³. In the case of a multim atrix model, the group is, roughly speaking, an autom orphism group of a tensor algebra. The Lie algebra is a Cuntz-type algebra which can be thought of as an algebra of vector elds on a non-commutative space[12, 5, 6, 13, 14]. However, it is still very challenging to nd the proper mathematical framework for these theories and develop approximation methods to solve them even in the large N limit. To develop the necessary tools, it becomes worth while to practice on simpler theories whose gauge invariant phase space is the coadjoint orbit of a less form idable group. Here, we take a step in this direction by studying an abelian gauge theory whose phase space is a coadjoint orbit of the volume preserving di eom orphism group of a two dimensional surface.

To put these remarks in perspective, recall the common classical formulation of Eulerian rigid body dynam ics, ideal hydrodynam ics, the K dV equation [15, 16, 17] and the large N limit of two dimensional QCD [8]. The phase space of each of these theories is a symplectic leaf of a degenerate Poisson manifold, which is the dual G of a Lie algebra. G always carries a natural Poisson structure. Symplectic leaves are coadpint orbits of a group G acting on the dual of its Lie algebra G . On any leaf, the symplectic structure is given by the Kirillov form. The appropriate groups in these exam ples are SO (3), the volum e preserving di eom orphism group of the manifold upon which the uid ows, and the central extensions of D i (S 1) and of an in nite dim ensional unitary group, respectively. The coad pint orbits for the rigid body and 2d Q C D are well-known symplectic manifolds: concentric spheres and the in nite dimensional Grassmannian manifold. The observables in each case are real-valued functions on G. The Poisson algebra of observables is degenerate, i.e. has a center consisting of Casim irs. The symplectic leaves can also be characterized as the level sets of a complete set of Casimirs. In each case, the ham iltonian is a quadratic function on the phase space and classical time evolution is given by Ham ilton's equations. Ham ilton's equations are non-linear despite a quadratic ham iltonian, since the Poisson brackets of observables are more complicated than the Heisenberg algebra. In exceptional cases such as the rigid body and the K dV equation, these non-linear equations are exactly integrable. In other cases, it is useful to develop approximation methods to solve them, that are adapted to the geometry of the phase space.

Our earlier remarks indicate that it may be fuitful to regard Yang-M ills theory and matrix eld theories as Ham iltonian dynamical systems along the lines of the more well known ones listed in the last paragraph. As a toy-model in this direction, we seek a gauge theory where

the gauge elds satisfy a closed Poisson algebra, without any need for electric elds. We want a theory whose phase space is a coadjoint orbit of an ordinary dieomorphism group, which is simpler than its non-commutative cousins. We would also like to understand in more detail the structure of the Poisson algebra of gauge-invariant observables, work out the equations of motion and try to solve them.

In this paper, we identify a classical theory of abelian gauge elds in two spatial dimensions, di erent from M axwell theory. In particular, it is not Lorentz covariant, indeed, time plays the same role as in N ewtonian relativity. The theory is dened by a two dimensional manifold M, a volume form and a metric g_{ij} whose volume element $_g$ is not a multiple of . The ham iltonian is a gauge-invariant magnetic energy, much like that of M axwell theory. Unlike in electrodynamics, the gauge eld is a 1-form on space, rather than on space-time. Thus, even before any gauge xing, the gauge eld has no time component. There is a magnetic eld B, but no electric eld, so to speak. A fler gauge xing, there remains only one dynamical component of the gauge eld. In this sense, the theory has the same number of degrees of freedom as 2+1 electrodynamics. However, though the ham iltonian is quadratic in the gauge elds. Equations of motion are non-linear and comparable to those of a 2+1 dimensional non-abelian gauge theory or ideal hydrodynamics.

The phase space of the theory is a coad pint orbit of the volum e preserving di ecm orphism group SD i (M;) of the spatial two-dimensional manifold. Roughly speaking, this means that SD i (M;) is a symmetry group of the Poisson algebra of observables. The gauge group (structure group) of the theory is U (1). The inspiration for this lies in ideal hydrodynam ics. Indeed, even before the di eom orphism group of a manifold appeared in general relativity, it was relevant as the conguration space of a uid. The theory we study is not the same as, but is motivated by 2+1 dimensional ideal hydrodynamics, regarded as a ham iltonian system [18, 19, 15, 20, 21, 22]. Though we arrived at it as a toy model for Yang-M ills theory, it turns out to have a nice geom etric and possibly even integrable structure. We nd two in nite sequences of conserved charges. The rst set are Casim irs, analogues of the enstrophy invariants of ideal hydrodynam ics. In addition, we nd another in nite set of conserved charges which are not Casim irs but are in involution. The theory we study here can also be regarded as a theory of geodesics of a rightinvariant metric on the volume preserving die om orphism group of a two dimensional manifold. However, the right invariant metric on SDi (M;) implied by our ham iltonian is di erent from that arising in ideal hydrodynamics (the L^2 metric leading to ideal Euler ow) as well as the H^{1} m etric leading to averaged Euler ow [23].

A nother way to view the current work is to recall that adding supersymmetry usually gives greater analytical control over gauge theories. But there may be other modi cations of gauge theories that also lead to interesting toy-models or enhanced solvability. Our investigation concerns one such novelmodi cation of gauge eld Poisson brackets.

In Sec.2 we introduce the space of abelian gauge elds $A_i dx^i$ on a two dimensional surface M as the dual of the Lie algebra SVect M;) of vector elds preserving a volume element

= d²x. This duality' is known in hydrodynam ics[15]. The di erentials dfⁱ = $1 \frac{f}{A_i}$ of di erentiable gauge-invariant observables f (A) are shown to be volum e preserving vector elds. In Sec. 3 we give the Poisson structure on gauge-invariant observables

turning the space of gauge elds into a Poisson manifold. The Poisson brackets of gauge elds are obtained explicitly (35) and compared with those of Yang-M ills theory on a spatial and null initial value hypersurface.

In Sec.4 we give the coadjoint action of SD i (M;) and its Lie algebra SVect (M;) on the Poisson manifold of gauge elds SVect (M;), and show that the action is canonical i.e. preserves the Poisson structure. The moment maps generate the coadjoint action. The sym plectic leaves of the Poisson manifold are coadjoint orbits. The enstrophy invariants of hydrodynamics $I_n = \binom{R}{M} (dA =)^n$ are an in nite sequence of C asim irs of the Poisson algebra. The coadjoint orbits for simply connected M are found. We argue that all other orbits are in nite dimensional and try to characterize their isotropy subalgebras as well as tangent spaces.

In Sec. 5 we rst review the choice of ham iltonian leading to ideal Eulerian hydrodynam ics in 2+1 dimensions. Then we propose a di erent gauge-invariant ham iltonian depending on both and a metric g_{ij}, by analogy with the magnetic energy of Maxwell theory.

where F = dA is the eld strength, F is its Hodge dual, and g is the volum e element of the metric g_{ij} . Here $= (=_g)^2 = = 2 = g$, $g = det g_{ij}$ and is the density associated to . H is shown to determ ine a non-negative inner product on the dual of the Lie algebra SVect (M;) and an inverse 'inertia tensor' by analogy with the rigid body. If M is simply connected, the inverse inertia operator is non-degenerate and could be inverted to get an inner product on the Lie algebra SVect (M;). This could be extended to the di eom orphism group SD i (M;) by right translations. Thus, the magnetic energy should de ne geodesic ow on SD i (M;) with respect to a right-invariant metric di erent from that coming from Eulerian hydrodynam ics.

In Sec. 6 we not the equation of motion for the magnetic eld $B = "^{ij}@_{i}A_{j}, B_{-} = r (B =)$ r (B =g). This simple quadratically non-linear evolution equation is strikingly similar to the Euler equation of a rigid body L = L; L = I. It can be regarded as the Euler equation' for the group SD i (M;) with ham iltonian given above. Rem arkably, for a uniform measure

we nd an in nite sequence H $_n$ of conserved charges in involution, which are not Casim irs. The ham iltonian is $\frac{H_2}{2}$.

In Sec. 7 we nd some static solutions of the equations of motion. We show that for circularly symmetric and g, every circularly symmetric magnetic eld is a static solution. We generalize this to the non-symmetric case as well. We also nd a one parameter family of static solutions that are local extrem a of energy even with respect to variations that are not restricted to the symplectic leaf on which the extrem um lies. Some ideas for further study are given in Sec. 8.

Volum e preserving di eom orphism s and gauge theories have appeared together previously in the literature (see for example Ref. [24, 25]). Our investigation seem s quite di erent, since SD i (M;) is not the gauge group of our theory but rather a sym m etry of the Poisson algebra.

2 Volum e Preserving Vector Fields to Gauge Invariant Observables

2.1 Lie Algebra of Volum e Preserving Vector Fields

Let M be a surface with local coordinates x^i , to be thought of as the space on which a uid ows. A vector eld on M is regarded as the velocity eld of a uid at a particular time. The space of all vector elds on M form s a Lie algebra Vect (M) with Lie bracket

Vect(M) is the Lie algebra of the dieom orphism group Di(M). Conservation of the mass of the uid during its ow implies the continuity equation for its density (x;t)

We are interested in ows where the density at any point of space does not depend on time. U sing the continuity equation, this becomes r (u) = 0. We call such a ow volume preserving. Geometrically, we are considering a ow that generates dieomorphisms of M that preserve a given volume form⁴ $L_u = 0$. The density is constant along integral curves of u. To see the equivalence of this with the continuity equation for a volume preserving ow, recall that

where i_u is the contraction with u. Here d = 0 since is a volume form. In local coordinates = $\frac{1}{2} i_j dx^i \wedge dx^j$ where $i_j = j_i$ is and i_j is antisymmetric with $i_2 = 1$. So = (x) d²x where $dx^1 \wedge dx^2$ d²x. Then $i_u = \frac{1}{2} i_j (u^i dx^j dx^i u^j) = i_j u^i dx^j$, so that

Thus $L_u = 0$ becomes r (u) = 0. We will use the terms volume preserving and area preserving interchangeably since M is a two dimensional surface. Some of what we say has a generalization to higher (especially even) dimensional M.

The properties $L_{u+v} = L_u + L_v$ and $L_{[u,v]} = L_u L_v - L_v L_u$ ensure that the space of volume preserving vector elds G = SVect(M;) forms a Lie subalgebra of Vect(M). It is the Lie algebra of the group of volume preserving dieom orphisms G = SDi(M;).

Volum e preserving ow is a mathematical implementation of the physical concept of incom – pressible ow, which occurs when the uid speed is small compared to the speed of sound⁵. In particular, shock waves cannot form in incompressible ow, since shock waves involve super-sonic ow. Under ordinary conditions, air ow in the atmosphere is incompressible. Volum e preserving ow is sometimes referred to as divergence-free ow.

If M is simply connected, the volume preserving condition $@_i(u^i) = 0$ may be solved in terms of a stream function satisfying $i_u = d$. is a scalar function on M that serves as a 'potential' for the velocity eld. In local coordinates

Since is non-degenerate (\notin 0), it can be inverted ¹ m^{ij}_{jk} = $\frac{i}{k}$ where ^{mij} is a constant antisymmetric tensor with ^{m12} = 1, ^{mij}_{jk} = $\frac{i}{k}$. This does not require a metric on M. Then

u determines up to an additive constant, which can be xed by a boundary condition. If M is simply connected, then SVect (M;) may be identiated with the space of stream functions. Suppose two volume preserving vector elds u; v have stream functions u and v,

2.2 A belian G auge Fields as the D ual of SVect (M;)

The Lie algebra SVect (M;) is akin to the Lie algebra of angular velocities of a rigid body. The angular m om enta are in the dual space to angular velocities, and satisfy the angular m om entum Poisson algebra. As explained in A, the dual of any Lie algebra is a Poisson manifold. This is interesting because the observables of a classical dynam ical system are real-valued functions on a Poisson manifold. The dual of the Lie algebra G = SVect(M;) is the space of abelian gauge elds m odulo gauge transform ations,

This fact is well-known in hydrodynam ics (see Ref. [15]), though it is usually not thought of in term s of gauge elds. To see this duality, we de ne the pairing (A;u) between gauge elds and volum e preserving vector elds by integrating the scalar A (u) with respect to

The pairing $_{u}(A)$ is also called the moment map. It is a gauge-invariant pairing. Under a gauge transformation A ? $A^{0} = A + d$ for any scalar (x)

since u is volume preserving. We assume that gauge elds and gauge transform ations vanish on the boundary QM or at in nity. We make no such assumption about the vector elds.

Gauge Fixing: It is occasionally convenient to 'gauge-x', i.e. pick a coset representative for 1 (M)=d 0 (M). Under a gauge transform ation, $A_{i}^{0} = A_{i} + \theta_{i}$. We can pick such that

 $A_1^0 = A_1 + e_1 = 0$, so that we are left with only one component of the gauge eld A_2^0 . We can still make an x^1 -independent 'residual' gauge transform ation, $A_2^0 = A_2^0 + e_2^-(x^2)$ to eliminate any additive term in A_2^0 depending on x^2 alone. Suppose we have gauge xed on a particular spatial initial value surface at time t = 0. Unlike in Yang-M ills theory, the equations of motion of our theory are purely dynamical. They only evolve the gauge-xed elds forward in time, and do not contain any further constraints. In elect, after gauge xing, we will be left with one propagating eld degree of freedom.

2.3 Dierentials of Gauge Invariant Charges are Volum e Preserving Vector Fields

We should regard SVect (M;), the space of gauge elds modulo gauge transform ations, as the Poisson manifold of some dynamical system. Real-valued functions on this space (i.e. gauge-invariant functions f (A)) are the observables. G iven such an f (A), we can de ne its di erential df (A)

For each equivalence class of gauge elds [A] = fA jA A + dg, the dimension of denses a vector eld df ${}^{i}Q_{i}$ on M. If f(A) is non-linear, the vector eld (df (A)) ${}^{i}(x)$ changes as A 2 G changes. Suppose f(A) is gauge invariant and dimensionale. Then we can show that its dimensional df i is a volume preserving vector eld on M: $Q_{i}(df^{i}) = 0$. To see this, note that gauge invariance implies that the change in f under any gauge transformation $A_{i} = Q_{i}$ must vanish

Since (x) is arbitrary, it must follow that $@_i(f = A_i) = 0$. So the dimension of a gauge invariant function can be regarded as an element of the Lie algebra G = SVect(M;).

The simplest gauge-invariant observable is the eld strength 2-form

⁶ The di erential (df (A))ⁱ is regarded as a vector eld on M for each A and should not be confused with the closely related exterior derivative df, which is a 1-form on G. However, as we will see later (Sec. 4, A), on any sym plectic leaf of SVect (M;) with sym plectic form !, the 1-form df determines the canonical vector eld V_f via ! (V_f;:) = df (:). V_f is a vector eld on the leaf, and its relation to the di erential is V_f (A) = ad_{df} A.

Other gauge invariant observables f(A) we will be interested in are 'charges': integrals over M with respect to , of a local gauge-invariant scalar function F. F can depend on A only through the eld strength two form F = dA. The analogue of the Chern-Sim ons 3-form, vanishes identically since A is a 1-form on space, not space-time. The quotient of dA and the non-degenerate volume 2-form (dA =) is a scalar function on M. Then

Due to the anti-sym m etry of "^{ij}, it follows that df is volume preserving θ_i (dfⁱ) = 0. M oreover, if f is gauge-invariant and of the form assumed above, then its dimensional is also gauge-invariant.

 $T\,w\,o$ fam ilies of gauge invariant charges which play an important role in our theory are I_n and H $_n$ de ned below . Let

These are similar to the I_n , except that we multiply by before integrating over M

G auge-invariant observables depending on the volum e form and a metric g_{ij} on M will play an important role in determining the dynamics of our theory. They are given in Sec. 5.2.

There are other interesting gauge invariant observables such as the circulation C (A) = $R_1 a_i \frac{d^{-1}(s)}{ds} ds$ and its exponential, the W ilson bop. Since these observables are concentrated on one dimensional curves on M, they may fail to be dimensional curves and their dimensional curves on M, they may fail to be dimensional curves and are not considered in this paper. Henceforth, when we say observable, we will mean gauge invariant observables that are dimensional curves, their dimensional curves are guaranteed to be volume preserving vector elds on M.

3 Poisson Brackets

3.1 De nition of Poisson Bracket on G = SVect(M;)

The Lie algebra structure of volume preserving vector elds G = SVect(M;) can be used to de ne a Poisson structure on its dual (see A, Ref. [26, 27, 31]). The dual space $G = \text{SVect}(M;) = {}^{1}(M) = d {}^{0}(M)$ of gauge eld 1-form s then becomes a Poisson manifold. Observables are real-valued functions on it. The Poisson bracket (p.b.) between gauge-invariant observables f (A) and g (A) with volume preserving di erentials df and dg, is de ned using the pairing (A; u) between G and G and the Lie algebra bracket [df;dg]:

The p.b.(31) preserves the class of gauge-invariant functions. Suppose f;g are gauge-invariant. Then df;dg 2 SVect(M;). Recall (Sec. 2.3) that if f and g are gauge-invariant, then so are their di erentials dfⁱ and dgⁱ. It follows that $[df;dg]^i$ is also gauge-invariant. A gauge-invariant observable f(A) de nes canonical transform ations on the Poisson m anifold G via the p b. Suppose g(A) is any observable, then its Lie derivative under the ow generated by f is $L_{V_f}g(A) = ff;gg(A) = (A;[df;dg])$ (see Sec. 4).

3.2 Poisson Brackets of Gauge Fields

Equivalence classes of gauge elds are coordinates on our Poisson manifold G = SVect (M;). Thus, an explicit formula for the 'fundamental' p.b. between components of the gauge eld $A_i(x)$ is useful. This will also facilitate a comparison with electrodynamics. We will show that the p.b. between gauge eld components is

where the derivatives act on everything to their right. Though this form ula for $fA_i(x); A_j(y)g$ looks a bit complicated, the rhs is linear in gauge elds. Thus, our Poisson algebra is actually a Lie algebra like the Lie algebra of angular momenta $fL_i; L_jg = _{ijk}L_k$.

Recall that electrodynam ics is based on the Heisenberg algebra between the spatial com ponents of the gauge eld and the spatial com ponents of the electric eld. In two spatial dimensions we have (before any gauge xing)

W hile in electrodynamics the electric eld is canonically conjugate to the gauge eld, this is not the case in our theory. The components of the gauge eld in our theory obey p.b. relations with each other, without being canonically conjugate. This is not unusual. For instance, the components of angular momentum form a closed Poisson algebra though none of them is canonically conjugate to another. This is a generic feature of degenerate Poisson manifolds where canonically conjugate variables can only be chosen on individual symplectic leaves (the concentric spheres in the case of angular momenta).

Gauge elds obeying pb. not involving the electric eld are not alien to conventional Yang-M ills theory. For example, in a coordinate system where initial values of elds are specied on a null cone at past time-like in nity, the transverse components of gauge elds satisfy pb. am ong them selves as shown by Rajeev and Turgut [2, 3]

where z^i are transverse angular coordinates, q_{ij} is the round metric on S^2 , R is a radial coordinate and a; b are color indices. In fact, our original motivation for studying the dynam ical system in this paper was to nd a toy-model that shared this feature with Y ang-M ills theory.

Now we will establish (35) using (31) and the relation between the p.b. of functions and those between the 'coordinates' $A_i(x)$

4 Structure of Poisson A lgebra of Observables

In this section we give the canonical action of SDi (M;) (generated via p.b.) on the Poisson manifold G = SVect(M;) (see also A, Ref. [15]). Symplectic leaves are coadjoint orbits of SDi (M;). The Poisson algebra of gauge invariant observables is degenerate. The enstrophy invariants I_n of hydrodynam ics are an in nite number of C asim irs. They are constant on the coadjoint orbits. Then we try to identify some of the simpler coadjoint orbits. We show that there is always at least one single-point orbit, that of the pure gauge con guration. If M has non-vanishing rst cohom ology, then we show that there are nite dimensional symplectic leaves lying inside H¹(M) n f0g. This also shows that I_n could not be a complete set of coadjoint orbit invariants. If M is simply connected, we show that the only single-point orbits consist of the con gurations for which dA = is not constant. For simply connected M, we also argue that the orbit of [A] 2 G for which dA = is not constant, is in nite dimensional. We identify the isotropy sub-algebra and tangent space of such an orbit and give an example where dA = is circularly symmetric. However, this analysis is far from complete. It would be useful to nd a nice coordinate system on these orbits and get the sym plectic structure in explicit form so as to study ham iltonian reduction.

4.1 Coadjoint Action of SDi (M;) on Poisson Algebra

The Poisson manifold $G = {}^{1}(M) = d {}^{0}(M) = fA 2 {}^{1}(M) fA$ A + d g carries the coadjoint action of SD i (M;). For example, on a simply connected region M, G may be identied with the space of scalar functions f = (dA =) = (B =) on M. The coadjoint action is the pullback action of volume preserving dieomorphisms 2 SD i (M;) on functions f = f. The action on equivalence classes of gauge elds is also the pull back Ad [A] = [A]. For in nitesimal (t) = 1 + ut we get the Lie algebra coadjoint action of u 2 SVect (M;) on G

This action of SD i (M;) on G is canonical i.e. there is a function on G (a gauge-invariant observable) that generates the coadjoint action via the p.b. The generating function is the moment map $_{\rm u}$ (A). To see this, suppose u is a volume preserving vector eld, then

4.2 Center of Poisson Algebra

From Sec. 4.1, the symplectic leaves of SVect (M;) are hom ogeneous symplectic manifolds, identied with coadjoint orbits of SD i (M;). Is the Poisson algebra of functions on SVect (M;) degenerate? W hat are the Casim irs that constitute its center? Casim irs are unchanged under canonical transformations. So they are constant on symplectic leaves. A complete set of such Casim irs would allow us to distinguish between distinct leaves. Since the symplectic leaves are coadjoint orbits of SD i (M;), it su ces to not observables that commute with the moment maps $_{\rm u}$ (A), which generate the coadjoint action.

We rst observe that the center of the Poisson subalgebra of linear observables $_{u}(A)$ is trivial. f $_{u}$; $_{v}g(A)$ vanishes for all A i [u;v] = 0. But the center of SVect (M;) is trivial. This is seen by writing u and v in terms of their stream functions $_{u}$; $_{v}$. Taking some simple choices for $_{v}$ in the condition [u;v] = 0 will imply that $_{u} = 0$. Thus none of the $_{u}(A)$ lie in the center of the Poisson algebra of gauge-invariant functions, since they do not even commute with each other. Thus we need to bok elsewhere to nd the Casim irs of our Poisson algebra. It turns out that the charges $I_n = (dA =)^n$ are central observables. The monom ials $(dA =)^n$ can be replaced by any scalar function of (dA =). We found that I_n are Casim irs by showing that they Poisson commute with the moment maps. However, this involves lengthy calculations. For eg., in B we show that I_n commute with each other and in C we show that I_2 commutes with $_{u}(A)$ for uniform .

However, we found that I_n are closely related to the enstrophy invariants of hydrodynam ics, which are known to be conserved quantities in Eulerian hydrodynam ics. There is a simple argument in Ref. [15] based on earlier work [21, 20, 22] that leads to the conclusion that I_n are constant on coadjoint orbits. The argument is that the action of SD i (M;) is merely to change coordinates in the integral de ning I_n . Since this integral is independent of the choice of coordinates, I_n must be invariant under the coadjoint action. Though I_n for n = 1;2;3;::: are all C asim irs, they are not a complete set of orbit invariants. Their level sets do not necessarily

distinguish the coadjoint orbits (see Sec. 4.3). For some remarks on additional invariants, see Sec. 9 of Ref. [15]. Our explicit calculations of fI_n ; ug given in B and C suggested to us how I_n could be modiled in order to get an independent in nite sequence of conserved quantities (not C asim ir invariants) for our choice of ham iltonian; see Sec. 6.3.

4.3 Finite D in ensional Symplectic Leaves in $H^{1}(M)$

The simplest symplectic leaf in the dual of the Lie algebra of the rotation group is the origin of angular momentum space $fL_i = 0g$. It consists of a single point. Of course, one can also characterize the orbit $fL_i = 0g$ as the zero set of the Casim ir $L^2 = 0$. Can we get a similar explicit characterization of the simplest symplectic leaves of SVect M;)?

O rbits of C losed O ne Form s and Zero Set of C asim irs ${\rm I}_n$

The simplest symplectic leaf in SVect(M;) should be the orbit of exact 1-forms. Suppose A = d is an exact 1-form. Then under the coadjoint action of u 2 SVect(M;) it goes to $A^0 = A + ad_uA$

W e see that a pure gauge ism apped to a pure gauge under the Lie algebra coadjoint action. Thus the tangent space to the orbit of exact 1-form s is trivial. So pure gauges form a single-point orbit.

A fler the pure gauges, the next simplest con gurations are closed but inexact 1-form s dA = 0, A \leftarrow d. Suppose M is a manifold with non-vanishing rst cohom ology. W hat is the orbit of an element of H¹(M)? In particular, is the orbit a nite dimensional manifold? Does the orbit lie within H¹(M)? The answers to both these questions is a mative. Suppose A is an exact 1-form, F = dA = 0. Under the Lie algebra coad joint action, $A^0 = A + ad_uA = A$ LuA.

The tangent space to the orbit of a closed 1-form contains only closed 1-form s. Since the space of closed 1-form s on a two-dimensional manifold is nite dimensional, the tangent space to the orbit must be nite dimensional. Moreover, we have shown that the exact 1-form s form a single point orbit by them selves. Thus, at the in nitesim al level, the orbit of a non-trivial element of H¹(M) must lie within H¹(M) n fOg. This view will be reinforced by considering the zero set of Casim irs

 I_n are constant on coadjoint orbits. Thus, the orbits must be contained in their level sets. I_{2n} is the integral of a positive quantity and therefore vanishes i $\,dA=0$. If dA=0 then I_{2n+1} is also zero. Thus the level set $I_n=0$ is the space of closed 1-forms on M. Thus, the coadjoint orbit of a closed one form must lie in H $^1\,(M$). Since we already established that the pure gauges form a single-point orbit, this means I_n cannot be a complete set of C asim irs if H $^1\,(M$) is non-trivial.

For example, if M is the plane, then H¹ (R²) consists only of the equivalence class of pure gauge con gurations and the zero set of I_n contains only one single-point orbit [A] = 0. The same is true of the 2-sphere S² which has trivial rst cohom ology. For the 2-torus H¹ (T²) ' R². For T², there must be symplectic leaves which are submanifolds of R² nf0g. It is interesting to nd the orbits of cohom ologically non-trivial gauge elds more explicitly as well as the induced symplectic structure. However, we do not investigate this further since the Ham iltonian we pick (66) vanishes on closed 1-form s. There is no interesting dynamics on the nite dimensional symplectic leaves we have described above. Therefore, we turn to the case where M is simply connected and try to characterize the orbits of gauge elds that are not closed.

4.4 Sym plectic Leaves when M is Sim ply Connected

In the case of the rigid body, sym plectic leaves other than $L_i=0$ are concentric spheres of non-zero radius, all two dimensional sym plectic manifolds. These leaves may also be characterized as non-zero level sets of L^2 . By analogy, we would like to not the orbits in SVect (M ;) of 1-form s that are not closed. They must lie within non-zero level sets of I_n . C an we say something more about them, such as whether they are nite dimensional? We address these questions below, assuming M is simply connected.

By Poincare's lemma, all the information in a gauge eld on a simply connected M can be stored in the 2-form eld strength, F = dA. Then, the dual of the Lie algebra SVect (M;) may be identied with the space of scalar functions on M

The picture that emerges from our analysis below, is that there are two types of orbits when M is simply connected. Orbits of the rst type contain only a single point, namely a constant function f = dA = = c. In the case of the plane with the uniform measure, the only one-point orbit is ff = (dA =) = 0g, consisting of the pure gauge con guration. The orbits of the second type are all in nite dimensional. They are the orbits of non-constant functions f. In the case of the plane with uniform measure, we expect an in nite number of such orbits of the second type, each contained within a level set of fI_n ; n = 1;2;3;:::g, though we do not rule out the existence of more than one such orbit in any one level set of the I_n .

Single Point Orbits

We show that constant functions f = (dA =) = c are the only single point coadjoint orbits in the dual of the Lie algebra SVect (M;) when M is simply connected. They lie within the level sets $I_n = Vol(M;) c^n$ where $Vol(M;) = \frac{R}{M}$.

Suppose f is a constant. Then $L_u f = 0$. So the constant functions form single point orbits. The case f = 0 corresponds to the closed and exact 1-forms A which we already identied as a single point leaf if M is simply connected. Non-zero constant functions are not admissible elements of SVect(M;) if $M = R^2$ and is the uniform measure. But they are allowed if M is compact or if ! 0 at in nity on non-compact M. Note that $I_n = {n = Vol(M;) c^n}$ if f = c. So the constant functions lie in the level sets with $I_n = Vol(M;) c^n$.

We can go one step further and show that constant functions are the only single point orbits if M is simply connected. Suppose f is a single point orbit. Then $L_u f$ must vanish for all volume preserving vector elds u. Since M is simply connected, any such vector eld can be written in terms of a stream function $u^i = 1$ "^{ij}Q₁. Then denoting derivatives by subscripts,

This must be true for all stream functions . Taking = x and = y successively tells us that f must be independent of both x and y and hence a constant. We conclude that the only single point orbits in G = SVect (M;) are the constant functions f = (dA =) = c when M is simply connected.

The stabilizer algebra Stab(f) or isotropy subalgebra of a function f is the set of all volume preserving vector elds u^i which leave it xed under the coadjoint action. The coset space SVect(M;)=Stab(f) then has the same dimension as the tangent space to the orbit containing f. For u to be in Stab(f) we need $L_u f = 0$. Since M is simply connected we can express u in term s of its stream function $u^i = {}^1 u^{ij} e_j$. The condition $L_u f = 0$ becomes

Colloquially, the gradient of must be everywhere parallel to the gradient of f. = cf is clearly a solution for any real number c, so the isotropy subalgebra is at least one dimensional, provided f is not a constant. The product of two solutions as well as real linear combinations of solutions are again solutions to this linear PDE. To better understand the general solution of this PDE, let us rst consider the speci c example of a function f(r;) that is circularly symmetric.

Exam ple: Stabilizer and O rbit of C ircularly Sym m etric Function

For example, let f = (dA =) be a non-constant function depending only on the radial coordinate $r = \frac{P}{x^2 + y^2}$. Let us call its orbit by the name O_f . The gradient r f points radially, so to

To sum m arize, the isotropy subalgebra of a non-constant circularly sym m etric function consists of all stream functions that are circularly sym m etric. M oreover, the tangent space to the orbit m ay be identied with the coset space in which two stream functions are identied if they dier by one depending on r alone.

N on-constant Functions have In nite D im ensional O rbits

U sing the circularly symmetric example as a guide, we can characterize the isotropy subalgebra of a general non-constant function. The condition for to be in the isotropy subalgebra is $f_{x \ y} \quad f_{y \ x} = 0$. We will describe the set of all solutions to this linear PDE in a region of M where df is never the zero 2-form. Such a region is guaranteed to exist by an analogue of the inverse function theorem, since we assumed that f was not a constant. Our answer is that the isotropy subalgebra of f consists of all stream functions which are constant along level sets of f. The level sets of f are necessarily one dimensional curves in such a region.

To see this, we argue as follows. In a region where f(x;y) has no local extrem a, the level sets of f are one dimensional. These level curves foliate the region. Pick a coordinate (x;y) along the level curves. Then (f = f = 0. A) has pick a coordinate R transversal' to the level curves of f. W hat this means is that (R_R) and (R_R) should be linearly independent at each point (R;). There is a lot of arbitrariness in the choice of these coordinates, and one certainly does not require any metric to de ne them. The volume form is non-degenerate, so the volume enclosed by the mini-parallelogram determined by the tangent vectors (R_R) and (R_R) is non-zero. D enoting partial derivatives by subscripts, we get

It is clear that the space of such stream functions is closed under linear combinations and also under multiplication, as we observed earlier. The tangent space to the orbit at f is then identied with the coset space

Both the stabilizer and the orbit are in nite dimensional, provided f is not constant, for the same reason as given in the example where f was circularly symmetric. Thus, non-constant f = dA = have in nite dimensional orbits.

5 H am iltonian

Having specified observables (gauge-invariant functions), their p.b. and phase space (coadjoint orbit of SD i (M;)), we need to pick a gauge invariant ham iltonian.

5.1 Ham iltonian Leading to Ideal Hydrodynam ics

There is more than one interesting way to pick a ham iltonian. The classic choice leading to ideal hydrodynamics, requires a positive metric g_{ij} on M which de ness a positive, symmetric, inner product on G = SVect (M;)

There is no a priori relation between the metric g and the volum e form $g = \frac{p}{detg} dx^{1} dx^{2}$ need not equal . If g = g, the theory is particularly natural as well as non-trivial. The ham iltonian de nes an inertia operator I (generalization of the inertia tensor of a rigid body, see A, Ref. [15]) from the Lie algebra G = SVect(M;) to its dual $G = {}^{1}(M) = d {}^{0}(M)$. Suppose u;v are volum e preserving vector elds. Then the inertia operator is de ned by the equation (Iu;v) = hu;vi_{G}. In other words,

We see that the metric does not determ ine the 1-form Iu uniquely, but rather up to an exact 1-form. Thus, the image Iu of a volum e preserving vector eld u 2 G is an equivalence class in G = gauge elds modulo gauge transform ations. A coset representative is given by the 1-form $A_i = g_{ij}u^j$. The equation of motion is the well-known Euler equation

Here r_uu is the covariant derivative (with respect to g_{ij}) of u along itself. The two equations x the pressure p(x;t) up to an additive constant. The Euler equations of hydrodynam ics have a geom etric interpretation [15]. The con guration space of a volum e preserving uid owing on the manifold M is the group of volum e preserving di eom orphism s SD i (M;). The inner product (61) on the Lie algebra of this group can be extended to a right-invariant metric on the whole group by right translations by group elements. Then, by the least action principle, the tim e evolution of the uid is given by geodesics on SD i (M;) with respect to this metric.

5.2 Ham iltonian as M agnetic Energy

Now we propose a ham iltonian di erent from that of Eulerian hydrodynam ics. It is a magnetic energy, natural from the point of view of Yang-M ills theory. The result will still be a theory of geodesics on SD i (M;), but with respect to a di erent right-invariant metric on this group than that in plied by ideal hydrodynam ics. Suppose M is a 2-dimensional surface with volume form and metric g_{ij} . The metric did not play any role so far since the phase space and poisson structure are independent of it. But to specify the dynam ics, we need the metric. Any two dimensional manifold is conform ally at, so the information in g_{ij} is encoded in its volume form $g = {}^{p} \overline{g} dx^{1} \wedge dx^{2}$, where $g = det g_{ij}$. We do not assume that is equal to g. Indeed, if that is the case, the dynam ics is trivial. By analogy with Yang-M ills theory, we pick the manifestly gauge-invariant magnetic energy

W e will see that for the dynam ics to be non-trivial, must not be constant. The ham iltonian in (66) is the simplest choice that is gauge-invariant, quadratic in gauge elds and involves two derivatives. The ham iltonian (66) involves only the spatial components of the eld strength since there is no time component for the gauge eld in our theory. So there is no analogue of electric energy. Moreover, our theory is not relativistically covariant unlike electrodynamics. The dynamics determined by (66) is not equivalent to Eulerian hydrodynamics, though both theories share the same phase space. To see this, note that if $_g =$, then (66) reduces to the Casim ir I₂ and has trivial dynamics while the ham iltonian (62) continues to have non-trivial dynamics.

At each tangent space $T_{[A(x)]}O$ to an orbit, V_H ([A]) is given by the coadjoint action of the Lie algebra element dH (A), $V_H = ad_{dH(A)}$. The change in an observable f under such an in nitesim al canonical transform ation is the Lie derivative with respect to V_H

5.3 Inertia Operator and Inner Product on G from H am iltonian

Recall (Sec. 5.1) that the ham iltonian of ideal hydrodynamics (62) de nes an inner product on the Lie algebra of volume preserving vector elds via the inertia operator. Here, the magnetic energy de nes a positive inner product h;; i_G on the dual of the Lie algebra, $G = {}^1 (M) = d {}^0 (M)$, via an inverse inertia operator h, obtained below. This inner product is degenerate if M has non-vanishing rst cohom ology. Away from degeneracies, one can in principle invert h to obtain an inertia operator and an inner product h;; i_G on the Lie algebra G = SVect(M;). It should be possible to extended h;; i_G to a metric on the group G = SD i (M;) by means of right translations. The equations of motion in G = SVect(M;) determ ined by H should be the projection of the geodesic ow on G = SDi(M;) with respect to this right-invariant metric. In this sense, the dynamics determ ined by the magnetic energy describes geodesics on SDi(M;). Eulerian hydrodynamics also describes geodesics on SDi(M;), but with respect to a di erent right-invariant metric[15]. Here, we obtain the inverse of the inertia operator and the inner product on SVect(M;) explicitly. Let us begin by writing the ham iltonian as a quadratic form on gauge elds. The result is

Innerproduct (77) is degenerate precisely on gauge elds in the rst cohom ology of M, H¹(M) = $fB = 0; A \notin dg$. If M is simply connected, (77) is a non-degenerate inner product on G = SVect(M;). Inverting it gives an inner product on G which may be extended by right translation to a right invariant metric on SD i (M;).

6 Equations of M otion

Before working out the equations of motion in detail, it would be prudent to convince ourselves that unlike the Casim ir I_2 , the magnetic energy H does not lie in the center of the Poisson algebra for non-constant . We show this in D by exhibiting a moment map that has non-vanishing p.b. with H.

6.1 Time Evolution of Magnetic Field

The time evolution of the magnetic eld is given by the equation

The 'interactions' are partly encoded in the Poisson structure and partly in the ham iltonian, so to speak. (80) is an analogue of the Euler equation L = L ; L = I for the rigid body, (see A). Indeed, the equation of motion for the magnetic eld can be regarded as the Euler equation for the group SD i (M;) with respect to the metric (77) de ned by the ham iltonian (66). The time evolution of the magnetic eld can also be written as an equation of motion for the eld strength F = dA de ned in (21)

6.2 Time Evolution of M om ent M aps

We have already argued that the Casim ins $I_n = {R \atop dA = }^{n} (dA =)^n$ are constant on symplectic leaves. Thus, they are conserved under time evolution ${dI_n \atop dt} = fH$; $I_n g = 0$, independent of the choice of ham iltonian. As for the moment maps $_u$, we can show using (31) that

The ham iltonian of ideal hydrodynam ics (62) is not known nor expected to have any conserved quantities besides the I_n and their close relatives, which are constant on coadjoint orbits. W hat is remarkable about H_n is that they are not constant on coadjoint orbits but still conserved quantities for the magnetic energy ham iltonian (66). To establish this we investigate the time evolution of H_n.

generates new conserved quantities. In our case, we discovered (again for = 1), that the conserved quantities H_n are in involution, i.e. they mutually Poisson commute fH_m; H_ng = 0. The proof of this is somewhat lengthy and is relegated to E.

Intuitively, H_n are independent of each other since they are like average values of di erent powers of B. Furtherm ore, H_n are independent of the Casim irs I_m . I_m contain no information about the metric g_{ij} while H_n depend on the metric via . For example, we show in D that H₂ is not a Casim ir. M ore generally, it would be nice to prove that I_n and H_m are functionally independent by showing that on every tangent space to an orbit, the cross product of their gradients is non-vanishing.

7 Static Solutions

7.1 Zero Energy Con gurations

A ny such closed gauge eld is a static solution to the equations of motion (irrespective of and g_{ij})

A solicussed in Sec. 4.3, the closed gauge elds constitute one orm ore (according as M is simply connected or not)_R symplectic leaves of the Poisson manifold. They correspond to the zero set of C asim irs $I_n = (dA =)^n = 0$. Thus, the ham iltonian vanishes on all the symplectic leaves with $I_n = 0$ and there is no interesting dynam ics to speak of. If M is the plane, then the pure gauges are the only ones with zero energy. The leaf/leaves with $I_n = 0$ are the analogue of the $L^2 = 0$ point at the origin $L_i = 0$ of the angular momentum Poisson manifold. At that point, the energy $E = \begin{bmatrix} P \\ i \end{bmatrix} L_i^2 = 2I_i$ of the rigid body vanishes as well.

It is interesting to nd m inim a of energy on m ore interesting symplectic leaves. Initial conditions determ inewhich symplectic leaf is the phase space of the theory. The general problem of nding the m inimum of energy on a given symplectic leaf (perhaps specified through values of invariants such as I_n) is potentially quite interesting and di cult. One would inst have to nd which gauge elds or magnetic eld con gurations satisfy the constraints and lie on the specified leaf. This is similar to the problem we solved in the large N limit of 2d QCD where we found the minimum of energy on the symplectic leaf with baryon number equal to one[11, 10]. Here we do the opposite, nd a few static solutions and then determ ine which orbit they lie on.

7.2 Circularly Sym m etric Static Solutions

Suppose $M = R^2$. If both the volume forms and g are circularly symmetric, then any circularly symmetric initial magnetic eld will remain unchanged with time. To see this, note that $= 2^2$ -g depends only on the radial coordinate r. Suppose that at t = 0, B (r; t = 0)

D ue to circular symmetry, both the gradients point radially and their cross product vanishes. Thus $B_{-}= 0$ and we have a static solution B (r)!

We already met the B (r) = 0 static solution before, it lies on a one point symplectic leaf of pure gauge con gurations. However, the static solutions corresponding to non-constant B (r) lie on in nite dimensional symplectic leaves which we found previously (Sec. 7). The values of C asim irs on the orbit containing a circularly symmetric static solution B (r) are

M ore generally, by an argument similar to the one given in Sec. 7, we see that magnetic elds for which (B =) and (B =) have common 1-dimensional level sets, are static solutions of (80).

7.3 Som e O ther Local Extrem a of Energy

For a gauge eld to be an extrem um of energy on a given symplectic leaf, the variation of energy in directions tangential to the leaf must vanish. There is no need for variations in other, let alone all, directions to vanish. However, though it is not necessary, if [A] is such that all variations of the ham iltonian H (A) vanish, then, A must be a local extrem um of energy. Such an extrem um $\frac{H}{A_k} = 0$ is autom atically a static solution to the equations of motion for any gauge-invariant observable f

8 D iscussion

A sum mary of the paper was given in the introduction Sec.1. Here, we mention a few directions for further study. We would like to know whether there is a deeper integrable structure that would explain the presence of an in nite number of conserved charges in involution for the uniform volumemeasure . The extension to an arbitrary volume form seems likely. A re there any time-dependent exact solutions of the non-linear evolution equation? W hat is the Poisson algebra of loop observables and can the Ham iltonian be written in terms of them? Can this model be quantized and is there a non-abelian extension? An extension to 3 + 1 dimensions is possible, though the Poisson algebra has only one analytically known Casimir, the Hopfor link invariant. Is there a Lorentz covariant theory along these lines? Can the idea that gauge elds be thought of as dual to volume preserving vector elds be exploited in any other context?

How is our gauge theory related to hydrodynam ics and turbulence? Recently, Jackiw, et. al.[28] have studied perfect uids and certain non-abelian extensions. Our gauge theory shares the same phase space as ideal hydrodynam ics, but the two theories have dimensional theories is an ethods may be useful in the study of both theories. For example, Iyer and Rajeev [29] (see also Sec.11D of Ref. [15]) have proposed a statistical approach to 2 dimensional turbulence, based on a matrix regularization of the phase space. It may be possible to use a similar regularization for our gauge theory. For an N N matrix regularization to be integrable, it would appear that we need O (N²) conserved quantities, while I_n and H_m furnish only 2N conserved quantities. It is unclear what this implies for the integrability of the continuum theory we have proposed in this paper. On the other hand, Polyakov has proposed a theory of turbulence in 2+1 dimensions based on conform al invariance [30]. Since the group of conform al transform ations and area preserving transform ations are disjoint except for isom etries, it appears unlikely that there is any direct relation of our work to Polyakov's.

A Poisson M anifolds and Coad pint O rbits

We collect a few facts about classical mechanics [31, 15] that we use, to make the paper selfcontained and x notation.

A.1 Poisson M anifolds and Sym plectic Leaves

The basic playground of classical mechanics is a Poisson manifold. It is a manifold M with a product f; g : F(M) F(M) ! F(M) (the Poisson bracket p.b.) on the algebra of observables. f; g is bilinear, skew symmetric and satis es the Jacobi identity and Leibnitz rule. F(M) is a class of real-valued functions (say, C¹(M)). Any such function f:M ! R generates canonical transform ations on M . A canonical transform ation is a ow on M , associated to the

canonical vector eld V_f . The Lie derivative of any function g(A) along the ow is given by the p b. $L_{V_f}g(A) = ff;gg(A); A 2 M : F low lines of the canonical transform ation generated by f are integral curves of <math>V_f$.

O ften, Poisson algebras of observables are degenerate. They have a center (C asim ins) which have zero p.b. with all observables. In such a situation, the Poisson manifold as a whole cannot serve as the phase space of a physical system, since it would not be a sym plectic manifold. Rather, it is the sym plectic leaves of a Poisson manifold that can serve as phase spaces. The sym plectic leaf of a point A 2 M is the set of all points of M reachable from A along integral curves of canonical vector elds. On a sym plectic leaf, the Poisson structure is non-degenerate and can be inverted to de ne a sym plectic structure, a non-degenerate closed 2-form !. Indeed, if ; are tangent vectors at A to a sym plectic leaf, then the sym plectic form at A is !(;) = ff;gg(A) where f and g are any two functions whose canonical vector elds at A coincide with and ; i.e. $= \forall j_A; = V_g j_A$. Moreover, on any sym plectic leaf, $!(V_f;:) = df(:)$ where df

is the exterior derivative of f.

The ham iltonian vector eld V_H is the canonical vector eld of the ham iltonian H : M ! R. V_H generates time evolution $\frac{df}{dt} = fH$; fg = $L_{V_H} f$. Irrespective of the ham iltonian, time evolution always stays on the same symplectic leaf.

A.2 Coadjoint Orbits in the Dual of a Lie Algebra

A natural example of a Poisson manifold, that occurs in many areas of physics, is the dual of a Lie algebra. The symplectic leaves of the dual of a Lie algebra are the coadjoint orbits of the group. To understand this, suppose G is a group, G its Lie algebra and G the dual of the Lie algebra. Then we have a bilinear pairing between dual spaces (A;u) 2 R for A 2 G and u 2 G. Suppose f;g are two real-valued functions on G. Then their p.b. is de ned using the di erential df (A) 2 G

There is a natural symplectic structure on coadjoint orbits, which turns them into hom ogeneous symplectic leaves of G. The symplectic form (K irillov form) ! acting on a pair of tangent vectors to the orbit O_A at A is given by ! (;) = (A; [u;v]) where u;v 2 G are any two Lie algebra elements such that = ad A and = ad A. Thus, the coadjoint orbits are symplectic manifolds which foliate G in such a way as to recover the Poisson structure on the whole of G. The di erent coadjoint orbits in G are not necessarily of the same dimension, but are always even dimensional if their dimension is nite.

The canonical vector eld V_f of an observable f:G ! R at a point A 2 G is given by the Lie algebra coadjoint action of the di erential df (A), V_f (A) = $ad_{af}A$

O bærvables in the center of the Poisson algebra (C asim irs) are constant on coadjoint orbits. They are invariant under the group and Lie algebra coadjoint actions. To show that an obærvable is a C asim ir, it su ces to check that it com mutes with the moment maps which generate the coadjoint action.

E xam ple: E ulerian R igid B ody Let ⁱ be the components of angular velocity of a rigid body in the co-rotating frame. The components of angular velocity lie in the Lie algebra G of the rotation group G = SO (3). The dual space to angular velocities consists of angular m om enta L_i with the pairing (or m om ent m ap) (L;) = L_i ⁱ. The space of angular m om enta is the dual SO (3) = R³. The latter carries a Poisson structure fL_i ; $L_jg = _{ijk}L_k$. Observables are real-valued functions of angular m om entum f (L) and satisfy the p b.

The space of angular momenta R³ must be a degenerate Poisson manifold, since it is not even dimensional. Indeed, the symplectic leaves are concentric spheres centered at the point $L_i = 0$ as well as the point $L_i = 0$. These symplectic leaves are the coadjoint orbits of SO (3) acting on the space R³ of angular momenta. The symplectic form on a sphere of radius r is given by rsin d ^d. The Casim irs are functions of $L^2 = \begin{bmatrix} P \\ i \end{bmatrix} L_i^2$ and are constant on the symplectic leaves, they are invariant under the coadjoint action of the rotation group on R³. Since the ham iltonian is half the second charge, $H = \frac{1}{2}H_2$, we have shown that H_n for n = 1; 2; 3; ::: are an in nite number of conserved quantities, which moreover, are in involution!
