# Superm agnets and Sigm a m odels

#### Abstract

$W$ e discuss new $m$ ethods for non-com pact sigm a m odels $w$ ith and $w$ thout $R R \quad u x e s . T$ he $m$ ethods include reduction to one dim ensional superm agnets,supercoset constructions and supertw istors.T his work is a rst step towards the solution of these $m$ odels,w hich are im portant in several areas of physics. I dedicate it to the mem ory of Volodya G ribov.

## 1 Introduction

N onlinear sigm a m odels describe low energy interaction of $G$ oldstone particles and are im portant in $m$ any parts ofm odem physics. The m odels in two dim ensions are especially interesting since the infrared e ects in this case are highly nontrivial. Such models are relevant in string theory, quantum H all e ect, spin chains, disordered system s etc.

It has been shown long ago that in general the models $w$ ith the nonabelian symmetry groups acquire a non-perturbative $m$ ass gap [ 1]. This result contradicted to the well known fact that in the $H$ eisenberg antiferro$m$ agnet (which has O (3) sym $m$ etry) spin waves are gapless. The puzzle was resolved seven years later [2,3] when it w as argued that the $H$ eisenberg $m$ odel $w$ ith the half integer spin $m$ ust be described by the sigm a $m$ odel $w$ ith the ne tuned topological term, which $m$ akes it gapless. In the case of integer spin, the gap found in [1] is expected to appear (and does so experim entally). At the sam e tim e, even for the integer spins, there are special form s of the interaction leading to a com pletely integrable gapless antiferrom agnets. So, the $G$ oldstone particles can rem ain $m$ assless when they want to.

In this paper I w illbegin developing new $m$ ethods for analysis and interpretation of the $m$ assless sigm a $m$ odels. $M$ y refreshed interest in the old toy is related to the gauge/strings duality, the key elem ents ofwhich are the supersym $m$ etric sigm a $m$ odels. Existing $m$ ethods are painfully inadequate for getting physical inform ation in this case as well as in the other areas. The purpose of this paper is to outline new ways and hopes for their solution.

Let us begin w ith a brief sum $m$ ary of the $H$ aldane-A eck approach. O ne considers a H eisenberg antiferrom agnet. Its ham iltonian has the form

where $S$ are spin one half $m$ atrioes. They can be expressed in term $s$ of free ferm ions, $a_{x}$; $=1 ; 2$ as

where are the Paulim atrioes and the constraint (3) ensures that there is exactly one ferm ion at each site (half- lled band). O ne then can give a plausible argum ent that in the continuous lim it the ferm ions becom e relativistic,
left and right $m$ oving $D$ irac particles $w$ ith isotopic spin, $L^{(x)}$ and ${ }_{R}(x)$. $T$ his doubling of the ferm ions occurs since the continuous lim it enforces the continuity of the even and odd sites separately. The Lagrangian for these elds has the standard D irac form

H ere the U (1) gauge eld A is a Lagrange multiplier ensuring the constraint (3). The spin eld $S_{k}$ has the follow ing behavior in the continuos lim it (re ecting its antiferrom agnetic nature)

 which are holom orphic and antinolom orphic and the $U$ (1) current. The latter is killed by the A integration. The resulting system is equivalent to the W ZNW action (non-abelian bosonization [4]). For higher spins one considers several avors of ferm ions and gauge out the avor currents.

In order to relate these facts to the $O$ (3) sigm a m odel one needs another representation of the spin operators, com ing from the geom etrical (K irillov) quantization. It is based on the form ula

O $n$ the right side of this form ula we have a trace of the spin $m$ atrices in a representation with the spin $S$, while on the left side we have an integral over the unit sphere, which is an orbit of the rotation group. T he action has the form

$w$ th $A(n)$ being a vector potential of the $m$ agnetic $m$ onopole and $k=2 S$. The key feature of this action which ensures (7) is its variation under the group transform ation

$W$ ith these form ulae the geom etric quantization follow s from the standard W ard identities, as we w ill discuss later in the general case. W e can now replace the quantum spins by the classical orbit. D ue to the antiferrom agnetic order, we expect in the continuum lim it

In the continuous lim it we should keep only such term $s$ that the sign factor ( 1) disappears, otherw ise the oscillations w ould kill the sum. That m eans that only the term s linear in $l(x)$ m ust appear in the rst term of (12). $U$ sing the variation form ula (10) we get

Integrating out the eld $l(x)$ we obtain the result of $[2,3]$ - the $n$ - eld sigm a m odel w th the theta term at \# = 2 S :

The reason why we need an antiferrom agnet to describe a relativistic theory is the follow ing. Spin changes sign under the tim e reversal. H ence for a ferrom agnet the presence of the spontaneous $m$ agnetization im plies breaking ofthe CP T-sym m etry and the spectrum ofthe G oldstone particles is non-relativistic, ! = $\mathrm{k}^{2}$ : In antiferrom agnets we can combine CPT re ection w th the shift x to $\mathrm{x}+1$ :This sym $m$ etry !) ! is not broken and im plies the relativistic spectrum $!^{2}=\mathrm{k}^{2}$ in the long wave lim it. T he sigm a m odel is simply the $m$ ost generale ective lagrangian describing relativistic, $O$ (3) invariant spin waves.

## 2 Generalgroups

Let us now generalize these considerations for arbitrary groups and supergroups. T he rst step is well known -it is K irillov's theory. T his theory allow s to replace traces in a certain representation by integration over a particular
orbit. To set the stage I rederive it by using rather pedestrian $m$ ethods. T he action has the form

where everything is in the adjoint representation. The $m$ atrix $K$ depends on the representation which we eventually want to describe. If this representation has the highest weight $=\left({ }_{1}::{ }_{r}\right)$ ( $r$ is the rank of the group) and ifwe have C artan's generators $H_{k}$, then $K=\left({ }_{k} H_{k}\right)$ :Ifwe consider the variation of by right multiplication, $="$;where $"={ }^{A}{ }^{\mathrm{A}} \mathrm{w}$ ith ${ }^{\mathrm{A}}$ the set of adjoint generators, it follow s from (14) that

The last equation explicitly show s dependence of the stability group on the highest weight. Indeed, if we look at the in nitesim al transform ations then a generator de ned by a root belongs to the gauge group if ( ) = 0 \{N hen is a fundam entalw eight there are non-trivial solutions of this equation, som e of which will be discussed below. For a generic weight the stability group is generated by the C artan subalgebra.

In order to derive the $W$ ard identities we notioe that under the above right $m$ ultiplication we have a transform ation law for $T^{A}$

This is precisely the equation satis ed by the trace of the tim e-ordered product ofm atrices of a given representation, and hence the characters are given by the functional integrals $w$ th the action $W$ : In other words, the $m$ atrioes of representation can be replaced by the classical quantities $T^{A}$ de ning the orbit. So far we described the well known results in a slightly unusual way. Now we pass to som ething new .

## 3 C ollectivization

W e use this infam ous word to describe form ation of spin waves out of uctuations of individual spins.

C onsider a m agnet w ith the H am iltonian (1), except this tim e $\mathrm{S}_{\mathrm{x}}^{\mathrm{A}}$ are the $m$ atrices in a given representation of a given group. By the sam e logic as above we can w rite the action in the form

The factor ( 1 ) tells us that the representations we use for the even/odd sites $m$ ust be conjugate to each other.

It $m$ ust be notioed that in general this action is deform ed by renorm alization, since nothing prevents functions of $T$ to appear under the trace (since $T$ has classical dim ension zero and is invariant under the gauge group). A lso, they $m$ ay and should be present in the original ham iltonian. How ever, from the de nition of $T$ it follows that it satis es polynom ial relations, de ning the orbit of the form $\operatorname{Tr} T^{k}=C_{k}()$, where $C_{k}()$ is related to the value of the C asim ir operators in the given representation. That reduces or elim inates the num ber of possible structures. A general invariant Lagrangian should have the form

The second, parity violating tem, is not in general a topological invariant. H ow ever, in som e cases it is. For exam ple, for the O (3) m odel, the constraint is $\mathrm{T}^{2}=$ const and thusb(T) $\quad \mathrm{T}$; it is easy to check that we get the standard theta term this way. H ow ever, for a generalconstraint the second term in (32 ) is parity violating but not topological. The parity violating term $s$ (which
we w ill call " term s) can be easily written in term $s$ of the left-invariant connections (in a way invariant under the gauge group H )

In $m$ any instances this structure degenerates into a topological term, but in som e im portant cases it doesn't.

Let us give a few less trivial exam ples of the sigm a m odels related to antiferrom agnets. Take rst a vector representation of $S O$ (D) , $D=2 n$; which is described by the fundam entalw eight corresponding to the rst node of the D ynkin diagram. If we denote the generators by M , for this representation $K=M_{12}: T$ he generators com $m u t i n g w$ th $K$ are $M_{12}$ itself, as well as those of rem aining SO (D) 2): H ence T $2 \frac{\mathrm{SO}(\mathrm{D})}{\mathrm{SO}(\mathrm{D}}$ 2) SO (2) which is the G rass$m$ an $m$ anifold. It is conveniently described by the eld of the antisym $m$ etric tensort ; satisfying conditions

The claim is that this $m$ odel describes low energy properties of the quantum O (D) antiferrom agnet in the vector representation. W e will see below that ,while being asym ptotically free, it has a conform al xed point described by free ferm ions.

A nother interesting case is the spinor representation of $O(2 n)$ For this representation $K=\frac{1}{2}\left(M_{12}+M_{34}+:: M_{2 n} 1 ; 2 n\right)$ :T he stability group is $U(n)$ and we are dealing $w$ th the coset $\frac{S O(2 n)}{U(n)}: T$ his is the orbit of pure spinors ,which are the $W$ eyl spinors $w$ ith the constraints, analogous to (34), 1::: $^{p}=0$ for $p<n$ : A gain, the conform al point is described by the Lagrangian for pure spinors and their con jugates and is closely related to the description of the Berkovits string.
$F$ inally let us discuss supergroups, beginning w ith the $O S p(1-2)$ :Its generators are obtained by adding to SL (2) two spinorial supercharges Q .The $m$ atrix can be conveniently written as $=e^{(\# Q)} g$;where $g$ is the $m$ atrix of SL (2) and \# s are two G rassm an variables. It is quite easy to nd the
action $W$ ( $n$; \#) For that we notice that

## 4 N on-com pact superm agnet

Let us describe the $m$ agnet and the sigm a $m$ odel of the last exam ple. The resulting theory is a closed cousin of the A dS /CFT sigm a m odels. T here are two com plications to be overcom e. The rst is non-com pactness of the onbit and the second is the presence of the grassm an dim ensions. Let us discuss the rst problem rst. $N$ on-com pact $m$ agnets have been considered before in the im portant work [5],but we need a som ew hat di erent perspective.

W e are looking for a m agnet, the ham iltonian ofw hich acts in the $H$ ilbert (positive norm ) space. This is possible if the spin operator at each site acts in a unitary representation of SL (2) $=\mathrm{Sp}(2)$ :Such representations are necessarily in nite dim ensignal. If we perform the geom etric quantization with the phase factor exp i $A(n) d t w$ ith real the unitarity is to be expected and we have to identify the representation. Param etrizing the unit vector n as $\mathrm{n}=\left(\mathrm{cosh}_{\mathrm{R}} ; \sinh \mathrm{cos}^{\prime} ; \sinh \sin { }^{\prime}\right)$;we nd that the phase factor is equal to ${ }_{R} \times \mathrm{xp}$ i cosh $\frac{d^{\prime}}{d t} d t$ (in the Poincare coordinates it is even simpler, $\left.\exp i \frac{d x}{d t} \frac{d t}{y}\right)$. This corresponds to the unitary representations $w$ ith the low est (highest) weights, described by the upper (low er) sheet hyperboloids. If is an integer, this is a discrete series of representation. O therw ise, this is
a representation of the covering group of SL (2): :It is useful for our purposes to construct these representations explicitly as the Verm a m odulus. N am ely, consider the $V$ irasoro generators ( $\mathrm{L}_{1}$; $\mathrm{L}_{0}$ ) which form the $S \mathrm{~L}$ (2) subalgebra. The representation in question is de ned by the lowest weight vector $j$ i satisfying $L_{1} j i=0$ and $L_{0} j i=j i A l l$ other states in the representation
 nite dim ensional $S U$ (2) representations by $m$ eans of analytic continuation, setting the spin $S=$ All these facts are easy to check by solving the Schrodinger equation for a particle on a hyperboloid w th the phase factor and concentrating on the low est energy level. The w ave function in this case is proportional to the Jacobifunction $P_{m}$ (cosh ); and the lim it ofgeom etric quantization, when only the phase factor is left in the lagrangian, corresponds to taking $l=k ; m \quad$ :

It is well know $n$ that the spin chains of arbitrary integer spin can be m ade com pletely integrable by the special choioe of the ham iltonian $[6,7]$, which has the form

where the function $f$ is expressed in term $s$ of the derivative of the gam $m$ a function. In our case it should require a special consideration. T he reason is that as a result of the factor ( 1 ) in (20), representations at the even and odd points are conjugate (denoted by tilde) to each other. The conjugate representation is generated from the highest weight state jei satisfying $\mathrm{L}{ }_{1} \dot{\mathrm{e}} \mathrm{i}=0$ and $\mathrm{L}_{0} \dot{\mathrm{e}} \mathrm{i}=\quad \dot{\mathrm{j}} \mathrm{i}$ : Integrability is not a ected by the above analytic continuation to negative spins. Indeed the Lax operator has the standard form

where are the Pauli $m$ atrices and $S$ are the spin operators in any representation. The fact that at the even points we have the low est weight representation and at the odd ones the highest weight, doesn't prevent us from constructing integrals of $m$ otion generated by the $\operatorname{Tr} L_{x}()$. But constructing the ham iltonian, the B ethe ansatz and nding the physical vacuum, the excitation spectrum and the central charge rem ains an open problem. The technical di culty is that the product of representations in (42) has netther highest nor low est weight. Because of that we will discuss an altemative approach to $B$ ethe ansatz below .

There is no guarantee that this system has a relativistic lim it, but if it does, this $m$ agnet describes (in the infrared lim it ) conform al points of the non-com pact $n-$ eld. These conform alpoints (ifthey exist ) m ust be unusual. In the com pact case of $S U(2)$ we know that such points are described by the W ZNW action and contain holom orphic and antiholom onphic SU (2) SU (2) currents. This can't be the case in the above model since the non-com pact version of current algebra contains negative norm states, while the lattioe m odel is unitary. M oreover, in the perturbation theory this hyperbolic $n$ - eld is obtained from the standard spherical n- eld by changing the sign of the coupling constant. T hat reverses the asym ptotic freedom to the "zero charge" ( $\mathbb{R}$ xed point at zero coupling). That $m$ eans that the non-trivial $\mathbb{R} \lim$ it can arise only as a result of ne tuning of higher relevant operators.

Let us generalize these considerations for the $\operatorname{OSp}(12)$ group. A gain it is convenient to consider it as a subgroup of the super-V irasoro algebra. O nce again the $R$ m atrix for the $\operatorname{OSp}(12)$ system has been found long ago [8], but the spectrum of the above (non-com pact) antiferrom agnet is not known. Let us nd the corresponding sigm a m odel. As clear from the above discussion, it contains a hyperbolic unit vector $n$ and its supenpartner \#: It is convenient to write it rst in term $s$ of connections. The corresponding coset space is $O \operatorname{Sp}(12)=O(2)$ :The connections of $O \operatorname{Sp}(12)$ can be written down as $f B^{a} ; A$; $g$ where $a=1 ; 2$ is the "vertical" index, $A$ is the SO (2) connection and are the two spinor connections. They satisfy the standard $M$ aurer $-C$ artan equations. T he lagrangian m ust have $S O$ (2) gauge sym $m$ etry. The $m$ ost general form of it is

In order to have conform alsym $m$ etries it is necessary to adjust the couplings $C_{1}$ and $c_{2}$. These conform alpoints are com pletely integrable, at least classically. For the action (45) the Lax representation is as follow ing [11]

 was checked in [11] the equations of $m$ otion follow ing from $\left.\mathbb{4}_{+} ; \mathrm{L}\right]=0$ correspond to the lagrangian (45) w ith $\mathrm{c}_{1}=0$ and $\mathrm{c}_{2}=1 \mathrm{Am}$ azingly, at the sam e point the sym $m$ etry appears and the perturbative beta function is zero. W e can add to this an assum ption that at the sam e point the sigm a $m$ odelbecom es equivalent to the superm agnet (44). The Lax representation for the last of the above cosets hasbeen found in [12]. A n interesting di erent class of cosets was found in [20]. It deals with the di erent manifolds, but $m$ ore im portantly $w$ ith the cases $c_{1}=c_{2}=1$. Perhaps the $c_{1}$ term, together w ith the added pure spinor lagrangian, can be looked at as xing of the gauge sym $m$ etry, w th the pure spinors playing the role of the corresponding ghosts.

## $5 \mathrm{~N} u l l$ vectors and linear sigm a m odels

The above approach used the discretized theory. It is possible to avoid it. Let us again consider the n - eld rst. It is equivalent to the W ZNW modelat level one. On the other hand, the sam e conform al point $m$ ust appear in the linear sigm a $m$ odel of the vector eld ', satisfying the equation of m otion [12]

where is a coupling constant and the physicalm ass of the eld is tuned to zero. The reason for this "linearization" is that the constraint $n^{2}=1$ is relaxed by the infrared uctuations. W hether this relaxation is relevant , depends on the infrared dynam ics.

Let us "solve" this equation using the OPE of theW ZNW m odel ( sim ilar approach was used in [13] for the Ising and other m inim almodels). It is based on the fact, understood at the very beginning of conform al eld theory, that the equations ofm otion $m$ ust be read from the right to the left, replacing the products of elds by their OPE .

From the linear sigm a m odel point of view, this critical point requires netuning of two param eters, the $m$ ass term (tem perature) and the theta term.

W hat happens at higher values of $k$ and for other groups ? Let us give som e non-trivial exam ples. C onsider rst $k=2$ and the $m$ atrix $g$ in the vector representation, $g \quad(1 ; 1) \quad(0 \quad 1 \quad 2)$ : The current descendant transform sas

First, if we want to describe a linear sigm a modelw ith the vector eld by W ZNW action with $k=2$; we obtain the equation of $m$ otion $w$ ith the non-vanishing $K a c M$ oody descendent com ing from $(1 ; 0)+(0 ; 1): G$ enerally this doesn't describe the conform alpoint of the n eld. But, ifwe ne tune the param eters to elim inate this term, we do get
a conform al sigm a m odel. This conclusion is consistent w the well know n fact that while generally spin 1 antiferrom agnet has a $m$ ass gap, there is a special, com pletely integrable multicritical point, at which it is conform al (see [15] for a review).

This is not all, how ever. C onsider a linear sigm a m odelw th the eld of spin 2, described by a traceless sym m etric tensor ij ${ }_{\mathrm{I}} \mathrm{IN}$ e from the (54) that in this case spin zero descendents do not appear. H ence we arrive at the conclusion that spin 2 order param eter leads to a conform al theory w ithout extra ne tuning. The equations of $m$ otion in this case are

It is easy to generalize these considerations for other order param eters and sym $m$ etry groups. It $m$ ight seem puzzling that we nd conform al regim es in cases, like CP ${ }^{\mathrm{N}} \mathrm{m}$ odels, in which the large N expansion tells us that they don't exist. The resolution of the paradox lies in the fact that to reach the above xed points one has to add to the action operators containing higher powers the elds and their derivatives. Such operators ( neglected and intractable in the large N expansion) m ight seem hopelessly irrelevant. H ow ever, an old com putation of their dim ensions in [17] indicates that the one loop correction tends to com pensate the grow th of the naive dim ension. For exam ple, in the $O$ (3) case the operators in question have the form

This is just as well, since a m odel like that w ould have larger sym m etry O Sp (3₹2) (re ecting the absence of the spin-orbit interaction) which we certainly don't need. In order to get a conform al theory we have to com bine the ${ }^{4}$ and ${ }^{3}$ term $s$ in such a way as to cancl the unit operator in the equations ofm otion. T he general structure
of these cubic term $s$ is

## 6 U sing connections

Let us describe yet another approach to the sam e class of problem s. Let us look again at the $O$ (3) invariant $n$ - eld, describing it this tim e in term $s$ of the $S U(2)$ connections , which we denote as ( $B^{a}{ }^{a} A$ ) where $a=1 ; 2$ and the direction 3 is selected for the gauge group $U(1): T$ hese connections satisfy the $M$ aurer- $C$ artan equations (the zero eld strength condition)

The second set consists of the " altemative currents" (AC), which are $K_{+}=g @_{+} g^{1}$ and $K=g^{1} @ g$ : For a generalW ZNW theory the altemative currents do not conserve and acquire the anom alous dim ension $=1+\frac{b}{k+b}$; where b is the dual C oxeter num ber ( adjoint C asim ir). $N$ otioe that $K_{+}=g^{1} J_{+} g: T$ hat im plies that AC are the current descendants of the adjoint operator $g^{1} \mathrm{~g}$ :
$T$ he crucial point for $u$ is that in the equation (79) the $A_{+}$and $B_{+}$are the com ponents of the direct current while the $B$ is an AC. A s we already discussed in the last section, at $k=1$ the adjjint operator decouples from the OPE. Henœ, at this value of $k$ the $B$ eld can be set to zero and the W ZNW equations becom e identical to the $n$ eld equations! Thus, as expected, the n - eld theory has a conform al xed point equivalent to the W ZNW xed point at $k=1$. Now, let us take $k>1: T$ his time the $B$ term $s$ don't disappear by them selves. They $m$ ust be foroed out by adding the higher derivative operators (56) and ne-tuning their couplings. This explains why the integrable antiferrom agnets of higher spin $S$ are described by the $\mathrm{k}=2 \mathrm{~S}$ theory. It is straightforw ard to generalize this m ethod for the general case $\mathrm{G}=\mathrm{H}$ : It requires, how ever a carefiul analysis of the null vectors.

M ore conform al points arise when we use gauged W ZNW to solve the coset theory, " cosets for cosets". Let us describe the general idea, leaving the details for the future. A s is well know $n$, gauging of ZNW refers to the diagonal group, $g \quad h{ }^{1} g h$; while the cosets we are interested in are alw ays g gh: Surprisingly there is a connection between the two. In general we should com pare the diagonal coset $\mathrm{G}=\mathrm{F}$ w ith the right coset $\mathrm{G}=\mathrm{H}$; but here we restrict ourselves w ith the sim plest case of U (2)=U (1) iN e w illalso w rite the gauged action in a som ew hat non-standard form

where $W$-s are the $W$ ZNW actions for the groups $G$ and $H$ as functionals of the left-invariant connections. N otice that in this de nition both A and B are de ned for the group $G$ (and this A is substituted to the action for the group H ). By the use of the standard variation form ulae [19] it is easy to obtain the equations ofm otion

where $r=@+A$ and $E=@+A$ with the de nition $@$ R $A_{+}=0: T$ hese equations have obvious $H$ gauge invariance. In the gauge $A_{+}=0$ they coincide w ith the standard gauged $W$ ZNW in the gauge $a_{+}=0$ (where $a$ is a gauge eld). Indeed in the latter case we have an action

Integration over a enforoes $A_{+}=0$ condition and the extra term leads to the above equationswith $\mathcal{A}=a$ :

## 7 Supertw istors and zero curvature

In the ordinary sigm a m odels one of the ways of nding the Bethe ansatz is to reform ulate the $m$ odel in term $s$ of the $m$ ulti- avored ferm ions [19]. It uses the fact that as the number of avors go to in nity, the ferm ions in the extemal gauge elds im pose the condition that the eld strength is zero. For the lagrangians quadratic in the gauge elds they can be integrated out, giving the four-ferm ion interaction. For such models the Bethe ansatz is know $n$ and all one had to do to describe the sigm a m odel was to take the lim it of in nite avors in the Bethe equations. In this section we will outline the rst part of this procedure - reduction to the four-particle interaction.

Let us discuss again the case of $\frac{0 \mathrm{Sp}(1-2)}{0(2)}$ (other cases are sim ilar). The sim plest representation which we shall use is a supertw istor $=(\quad ; \quad)$ which consists of the bosonic spinor (w th two $M$ a jorana com ponents) and
ferm ionic scalar ; which are spinors on the w orld sheet. The free lagrangian has the form

 N otioe that the inverted statistics of these elds is a must - otherw ise the lagrangian is a total derivative. There are ve currents of $\operatorname{Opp}\left(1 \mathcal{l}_{2}\right)$-three of SL (2) ; ${ }^{\text {i }}$ and two spinor currents :They couple to the ve gauge elds $\left(A ; B^{a} ;\right)$ :T he covariant derivatives have the form

W hen we consider an in nite num ber of copies of these tw istors and integrate them out, we get, aswas shown in [19] a delta function of the eld strength. H ence, ifwe add the lagrangian (85) to (45), in the in nite avour lim itwe obtain the desired sigm a m odel. On the other hand we can integrate out the connections rst and get the $m$ odelw ith quartic interaction of supertw istors which has the form

This interaction is presum ably com pletely integrable and should produce the $R \mathrm{~m}$ atrix for supertw istors satisfying the $Y$ ang- $B$ axter equations. This $m$ atrix should be ofXXZ (trigonom etric) type and perhaps coincide w ith the already known ones [8]. Ifso, nding the B ethe equations should be relatively straightforw ard. There is a slight complication because of the $O$ (2) gauge sym $m$ etry. In the bosonic case this di culty can be overcom e by adding the term $A^{2}$ to the action (thus getting the X X Z model) and then sending its coe cient to zero. The sam e should work in the present case.

## 8 C onclusions

The present work is a rst step towards nding CFT-s describing sigm a models. I think that it will require a work of $m$ any people to com plete this task. I also believe that if we want to understand fundam ental physics, there is no way avoiding it. The nature of space- tim e at large curvature
is determ ined by gauge /strings correspondence and it, to the large extent, boils down to the sigm a m odels, sim ilar to the ones we discussed. It is possible that when better understood these ideas will in uence our picture of the early universe.

O ther im portant physical problem sinvolving sigm a m odels are the quantum Halle ect and the theory of 2d turbulence (im portant form eteorology). In both cases we have to dealw th a non-com pact CFT. In the case ofturbulence there are general considerations [21] and recent interesting num erical data [22], supporting this view .

On the other hand it should be said that the problem is very di cult. It w ill require considerable am pli cation of the already esoteric technics of Bethe ansatz and/or som e intricate analysis of the CFT algebras. A lso, it is possible that som e im portant xed points are of the di erent nature than the ones described in this paper. Still I am hopeful that these di culties w illbe resolved.
