IN TRODUCTION TO MODIFIED GRAVITY AND GRAVITATIONAL ALTERNATIVE FOR DARK ENERGY

We review various modi ed gravities considered as gravitational alternative for dark energy. Speci cally, we consider the versions of f(R), f(G) or f(R;G) gravity, model with non-linear gravitational coupling or string-inspired model with G auss-B onnet-dilaton coupling in the late universe where they lead to cosm ic speed-up. It is shown that some of such theories may pass the Solar System tests. On the same time, it is demonstrated that they have quite rich cosm obgical structure: they may naturally describe the elective (cosm obgical constant, quintessence or phantom) late-time era with a possible transition from decceleration to acceleration thanks to gravitational terms which increase with scalar curvature decrease. The possibility to explain the coincidence problem as the manifestation of the universe expansion in such models is mentioned. The late (phantom or quintessence) universe led with dark uid with inhom ogeneous equation of state (where inhom ogeneous terms are originated from the modi ed gravity) is also described.

I. IN TRODUCTION

The dark energy problem (for recent review see [1, 2]) or, why current universe is expanding with the acceleration, is considered to be the one of the most fundam ental theoretical problem s of X X I century. There are various directions aim ed to construct the acceptable dark energy model. Speci cally, one can mention scalar (quintessence or phantom) models, dark uid with complicated equation of state (EoS), more complicated eld theories with fermions, abelian or non-abelian vector eld, string/M -theory, higher dimensions, etc. Nevertheless, despite the number of attempts still there is no any satisfactory explanation of dark energy origin. This is understandable having in m ind that even current values of cosm obgical parameters are not yet de ned with precise accuracy, and even less is known about their evolution.

The modi ed gravity approach is extremely attractive in the applications for late accelerating universe and dark energy. Indeed,

1. M odi ed gravity provides the very natural gravitational alternative for dark energy. The cosm ic speed-up is explained simply by the fact of the universe expansion where some sub-dom inant terms (like 1=R) m ay become essential at sm all curvature.

2. M odi ed gravity presents very natural uni cation of the early-time in ation and late-time acceleration thanks to di erent role of gravitational terms relevant at sm all and at large curvature. M oreover, som e m odels of m odi ed gravity are predicted by string/M -theory considerations.

3. It may serve as the basis for uni ed explanation of dark energy and dark matter. Som e cosm obgicale ects (like galaxies rotation curves) may be explained in fram es of modi ed gravity.

4. A ssum ing that universe is entering the phantom phase, modi ed gravity may naturally describe the transition from non-phantom phase to phantom one without necessity to introduce the exotic matter (like the scalar with wrong sign kinetic term or ideal uid with EoS parameter less than 1). In addition, often the phantom phase in modi ed gravity is transient. Hence, no future Big Rip is usually expected there.

5. M odi ed gravity quite naturally describes the transition from decceleration to acceleration in the universe evolution.6. The e ective dark energy dom inance may be assisted by the modi cation of gravity. Hence, the coincidence problem is solved there simply by the fact of the universe expansion.

7. Modi ed gravity is expected to be useful in high energy physics (for instance, for the explanation of hierarchy problem or unication of GUTs with gravity).

8. Despite quite stringent constraints from Solar System tests, there are versions of modi ed gravity which may be viable theories competing with General Relativity at current epoch. Nevertheless, more serious check of such theories

is necessary to them with various observational data and precise Solar System tests.

These lectures are devoted to the review of som e m odi ed gravities with above m entioned attractive features and their cosm ological properties at late universe. W e do not discuss here m odi ed gravities related with brane-world approach as well as Palatini form ulation of m odi ed gravities.

The paper is organized as follows. In sect.II we start from general f (R) gravity in accelerating FRW universe. It is shown how this theory may be rewritten as scalar-tensor gravity (Einstein frame). Two specic models: the one with 1=R and R^m terms, and another with $\ln R$ terms are considered. It is shown that both models may lead to the (cosm ological constant or quintessence) acceleration of the universe as well as an early time in ation. M oreover, the rst model seems to pass the Solar System tests, i.e. it has the acceptable new tonian limit, no instabilities and no Brans-Dicke problem (decoupling of scalar) in scalar-tensor version. The coupling of such modi ed gravity with usual matter is considered. It is shown the occurence of transient phantom era in this case. General conditions to f (R) gravity admitting phantom divide crossing are derived. Finally, it is demonstrated how scalar-tensor theory may be rewritten as som e version of modi ed gravity. Sect.III is devoted to the study of FRW cosm ology in string-inspired dilaton gravity containing scalar-G auss-B onnet coupling. The occurence of acceleration is again m entioned. In sect.IV the non-linear coupling of gravity with matter is considered. It is shown that some form s of such coupling may help to solve the coincidence problem simply by the fact of the universe expansion. From another point, such modied gravity m ay also predict (cosm ological constant, quintessence or phantom) accelerating epoch. It is interesting that the model with such non-linear coupling may serve for quite interesting dynam ical solution of cosm obgical constant problem. The possible applications of modi ed gravity for solution of hierarchy problem of high energy physics are described.

In sect.V we consider f(G) and f(R;G) theories where G is G auss-B onnet invariant. It is shown the possibility of cosm ic speed-up for various choices of function f, as well as possibility of decceleration-acceleration transition. Sect.V I is devoted to the study of late-time cosm ology for the universe lled with dark uid with inhom ogeneous E oS.At rst, the structure of future singularities is classified for dark uid with hom ogeneous E oS:p = + A. Next, the impact of the inhom ogeneous terms to future singularities structure is analyzed for the same (e ectively, phantom) dark uid. As the motivation for inhom ogeneous E oS dark uid, the possible origin of the inhom ogeneous terms from scalar-tensor or modi ed gravity is indicated. Some outbok and discussion are given in the last section.

II. THE MODIFIED f(R) GRAVITY

In the present section f (R) gravity in FRW universe is considered. Special attention is paid to the versions of such theory which m ay describe cosm ic speed-up at late universe. Let us start from the rather general 4-dim ensional action:

Here R is the scalar curvature, f (R) is an arbitrary function and L_m is a matter Lagrangian density. The equation of the motion is given by

W ith no matter and for the Ricci tensor R being covariantly constant, the equation of motion corresponding to the action (1) is:

which is the algebraic equation with respect to R. If the solution of Eq.(3) is positive, it expresses desitter universe and if negative, anti-desitter universe. In the following, the metric is assumed to be in the FRW form :

Here we assume that the spatial part is at as suggested by the observation of the Cosm ic M icrowave Background (CMB) radiation.W ithout the matter and in FRW background, Eq.(2) gives

Here R is given by $R = 12H^2 + 6H_{-}$. Our main purpose is to look for accelerating cosm obgical solutions of the following form : de Sitter (dS) space, where H is constant and a (t) / e^{Ht} , quintessence and phantom like cosm obgies:

The cosm ologies of above type in various modi ed gravity models will be offen discussed in this work.

Introducing the auxiliary elds, A and B, one can rewrite the action (1) as follows:

The action (8) is called the Jordan-frame action. In the Einstein-frame action, the matter couples with the scalar eld . Due to the scale transform ation, there is a di erence in time interval between the Einstein and Jordan frames. Of course, we usually use clock to measure time. The clock could be based essentially on electrom agnetism. In the Jordan frame, where the scalar eld does not couple with matter, especially with electrom agnetic elds, the time measured by the clock is proportional to the cosm obgical time in the FRW metric. On the other hand, in the Einstein frame where the scalar eld couples with matter, the time measured by the clock is not always proportional to the cosm obgical time, due to the coupling of the scalar eld with electrom agnetic eld. The di erence, of course, comes from the factor of the scale transform ation, which includes the scalar eld . Since is time-dependent in general, the time measured by the clock becomes, say, slower than the cosm ological time in the Einstein frame. It is estimated the acceleration of the universe started about we billion years ago. The we billion years are measured by using the electrom agnetism. Hence, these we billion years could be identied with we billion years in the Jordan frame e but not with those in the Einstein frame (for further discussion of the relation between Einstein and Jordan fram es in cosm ology, see review [3]).

One may de ne the e ective EoS parameter w $_{\rm e}$ in Jordan frame as

The scale factor in Einstein frame (when the two frames appear) is denoted as a (t). Note that if we dont make transform ation from one frame to another one, then scale factor will be always denoted without hat.

A. M odi ed gravity with negative and positive powers of the curvature

As the rst gravitational alternative for dark energy we consider the following action [4]

Here we assume the coe cients n, m, c, b > 0 but n, m may be fractional. Let us show that above model leads to acceptable cosm ic speed-up and is consistent with Solar System tests.

For the action (12), Eq.(3) has the following form :

Especially when n = 1 and m = 2, one gets

If c > 0, one solution corresponds to deSitter space and another to anti-deSitter. If $\frac{1}{12} < c < 0$ and $_1 > 0$, both of solutions express the deSitter space. Hence, the natural possibility for the uni cation of early-time in ation with late-time acceleration appears (compare with proposal [5]). Here, higher derivative terms act in favour of early-time in ation while 1=R term supports cosm is speed-up.

By assuming the FRW universe metric (4), one may dene the Hubble rate by H = 4=4. The contribution from matter may be neglected. Especially when n = 1, m = 2, and $_1 = _2 = 0$ in (12) and the curvature is small, we obtain the following solution of (2): $4 / t^2$, which is consistent with the result in [6]. If the present universe expands with above power law, the curvature of the present universe should be small compared with that of the deSitter universe solution in (14) with $_1 = 0$. As the Hubble rate in the present universe is 10³³ eV⁻¹, the parameter c, which corresponds to ⁴ in [6], should be much larger than 10³³ eV⁻⁴.

We now consider the more general case that f (R) is given by (12) when the curvature is small. Neglecting the contribution from the matter again, solving (2), we obtain $a / t^{\frac{(n+1)(2n+1)}{n+2}}$. It is quite remarkable that actually any negative power of the curvature supports the cosm is acceleration. This gives the freedom in modi cation of the model to achieve the consistency with experimental tests of new tonian gravity.

On the other hand, when the scalar curvature R is large, one obtains $a^{(m-1)(2m-1)}$. When $\frac{(m-1)(2m-1)}{m-2}$. When $\frac{(m-1)(2m-1)}{m-2} > 0$, the universe is shrinking but if we change the arrow of time by t! t_s t, the in ation occurs with the inverse power law and at $t = t_s$, the size of the universe diverges. It is remarkable that when m is fractional (or irrational) and 1 < m < 2, the expression of a is still valid and the power becomes positive, the universe evolves with the (fractional) power law expansion.

It is interesting that the model of this section seems to be more consistent than the one of ref. [6] (for discussion of new tonian limit in 1=R theory see [7]) as it may pass Solar System tests. Indeed, in [8], small gravitational object like the Earth or the Sun in the model [6] is considered. It has been shown that the system becomes instable. This may cause the unacceptable force between distant G alaxies [9]. As shown in [4], however, by adding the positive power (higher than 1) of the scalar curvature to the action, the instability could be significally improved. Moreover, the account of quantum elects in modified gravity also acts against instability [10].

It has been also mentioned in [11] that 1=R model [6] which is equivalent to some scalar-tensor gravity is ruled out as realistic theory due to the constraints to such Brans-Dicke type theories. In [4], it was shown that by adding the scalar curvature squared term to the action, the mass of the scalar eld can be adjusted to be very large and the scalar eld can decouple. Hence, the modi ed gravity theory of this section (after some ne-tuning [4]) passes the Solar System tests. In addition, at precisely the same values of parameters the above modi ed gravity has the new tonian limit which does not deviate signi cally from the one in General Relativity.

B. ln R gravity

O ther gravitational alternatives for dark energy may be suggested along the same line. As an extension of the theory of the previous section, one may consider the model [12] containing the logarithm of the scalar curvature R:

We should note that m = 2 choice simpli es the model. A sum ing the scalar curvature is constant and the Ricci tensor is also covariantly constant, the equations (3) are:

If $^{0} > 0$, f'(R) is monotonically increasing function and $\lim_{R! 0} f'(R) = 1$ and $\lim_{R! + 1} f'(R) = +1$. There is one and only one solution of (16). This solution may correspond to the in ation. On the other hand, if $^{0} < 0$,

 $\lim_{R \to 0} f(R) = 1$ and $\lim_{R \to 1} = +1$. Since $f^0(R) = 1 + \frac{0}{R}$, the minimum of f(R), where $f^0(R) = 0$, is given by $R = 2^{-0}$. If $f(2^{-0}) > 0$, there is no solution of (16). If $f'(2^{-0}) = 0$, there is only one solution and if $f(2^{-0}) < 0$, there are two solutions. Since $f'(2^{-0}) = 2^{-0} + 1 + \frac{2^{-0}}{2}$, there are two solutions if $\frac{2^{-0}}{2} > e$. Since the square root of the curvature R corresponds to the rate of the expansion of the universe, the larger solution in two solutions might correspond to the in ation in the early universe and the smaller one to the present accelerating universe.

We can consider late FRW cosm ology when the scalar curvature R is small. Solving (2), it follows that the power law in ation could occur: $a / t^{\frac{1}{2}}$. Since a > 0 but a < 0, the deccelerated expansion occurs.

One may discuss further generalizations like [12] (see also [13])

Here n is rectricted by n > 1 (m is an arbitrary) in order that the second term could be more dominant than the Einstein term when R is small. For this model, we nd

This does not depend on m . The logarithm ic factor is alm ost irrelevant. The electric we $_{\rm e}$ is given by

C learly, the e ective EoS parameter w may be within the existing bounds.

C. M odi ed gravity coupled with m atter

In this subsection we will show that the modi ed gravity may lead to the elective phantom or quintessence dark energy without necessity to introduce the (negative kinetic energy) phantom scalar or negative pressure ideal uid. In fact, the matter is taken to be the usual ideal uid.

The ideal uid is taken as the matter with the constant w: p = w. Then from the energy conservation law it follows $= {}_{0}a^{3(1+w)}$. In a some limit, strong cuvature or weak one, f(R) may behave as f(R) f_0R , with constant f_0 and . An exact solution of the equation of motion is found to be [14]

When = 1, the result $h_0 = \frac{2}{3(1+w)}$ in the Einstein gravity is reproduced. The elective w_e may be defined by $h_0 = \frac{2}{3(1+w_{eff})}$. By using (22), one nds the elective w_e (11) is given by

Hence, if w is greater than 1 (e ective quintessence or even usual ideal uid with positive w), when is negative, we obtain the elective phantom phase where w_e is less than 1. This is dilerent from the case of pure modil ed gravity. Moreover, when > w + 1 (it can be even positive), w_e could be negative (for negative w). Hence, it follows that

m odi ed gravity m inim ally coupled with usual (or quintessence) m atter m ay reproduce quintessence (or phantom) evolution phase for dark energy universe in an easier way than without such coupling.

When the cuvature is small, the second term becomes dominant and one may identify $f_0 = -\frac{1}{2}$ and = n. Then from (23), it follows $w_e = 1$ $\frac{1+w}{n}$. Hence, if n > 0, an elective phantom era occurs even if w > 1. U sually the phantom era generates the future B ig R ip singularity [15]. (Note that there may occur diment types of future singularities, say, sudden ones [16, 17, 18, 19], etc. The complete classication of B ig R ip singularities is given in [18].) However, near the B ig R ip singularity, the curvature becomes large and the last term becomes dominant. In this case = 2 and $w_e = -\frac{1+w}{2}$. Then if w > 1, it follows $w_e > 1$, which prevents the B ig R ip singularity (it makes the phantom phase transient). To conclude, it books quite promising that modest modi cation of G eneral Relativity coupled to ideal uid matter leads to an elective dark energy universe in the very natural way.

D. The equivalence with scalar-tensor theory

It is very interesting that f (R) gravity is in some sense equivalent to the scalar-tensor theory with the action:

Then, as it has been demonstrated in ref.[20], any cosmology de ned by H = h(t) in (26) can be realized by (25). Indeed, if one de nes a new eld ' as

The sign in front of the kinetic term depends on the sign of ! (). If the sign of ! and therefore the sign of H- is positive (negative), the sign of the kinetic term is (+). Therefore, in the phantom phase, the sign is always + and in the non-phantom phase, always . One assumes can be solved with respect to ': = ('). Then the potential ∇ (') is given by ∇ (') ∇ ((')). Since ∇ (') could be uniquely determ ined, there is one-to-one correspondence between H and ∇ (').

In case the sign in front of the kinetic term of ' in (28) is , we can use the conform all transformation g ! e $\int_{\frac{2}{3}}^{\frac{2}{3}} g$, and make the kinetic term of ' vanish. Hence, one obtains

The action (29) may be called as Jordan frame action and the action (28) as the Einstein frame action. Since ' becomes the auxiliary eld, one may delete ' by using an equation of motion:

Note that one can rewrite the scalar-tensor theory (25) or equivalently (28), only when the sign in front of the kinetic term is in (28), that is, ! () is positive. In the phantom phase, ! () is negative. In this case, the above trick to rewrite the phantom scalar-tensor theory as f (R) gravity does not work. We should note, how ever, as the metric is conform ally transformed, even if the universe in the original metric (corresponding to the Einstein frame) is in the phantom phase, the universe in the rescaled metric (corresponding to the Jordan frame) can be in non-phantom phase in general. In addition, one should bear in m ind that the same FRW dynamics (same scale factor) m ay be obtained from one of these two mathematically equivalent descriptions. Nevertheless, the properties of such FRW cosm ology in both models may be quite di erent (for instance, more FRW solutions may exist, say, for scalar-tensor theory, new ton law may be di erent, stability of such equivalent solutions may be di erent, etc).

E. Transition from phantom to non-phantom phase

A ssum ing that our universe is entering into the phantom phase recently, and having in m ind the occurence of (cosm ologically recent) decoeleration-acceleration transition, the question appears: what are the conditions for phantom – non-phantom transition in m odi ed f (R) gravity? For instance, the conditions for the existence of deSitter universe solution in f (R) gravity m ay be derived in the form of algebraic equation [21]. The stability of deSitter universe solution was established in ref.[21] where one-loop quantization of f (R) was done. (The sam e stability criteria was also found in ref.[22] using perturbations analysis.)

The e ective EoS parameter is de ned by (11). We now de ne a time-dependent parameter F (t) by

that is, F (t) = $1 + w_e$. Note that F = 0 at the transition point between non-phantom ($w_e > 1 \text{ or } F > 0$) and phantom ($w_e < 1 \text{ or } F < 0$) phases.

W e now consider the region near the transition point between non-phantom and phantom phases and assume F is small. Then Eq.(5) reduces to

III. STRING-INSPIRED GAUSS-BONNET GRAVITY AS DARK ENERGY

The successful dark energy theory may be searched in string/M -theory. Indeed, it is quite possible that some unusual gravity-matter couplings predicted by the fundamental theory may become important at current, low-curvature universe (being not essential in intermediate epoch from strong to low curvature). For instance, in the study of stringinduced gravity near to initial singularity the role of G auss-B onnet (GB) coupling with scalar was quite important for ocurrence of non-singular cosm ology [24, 25]. M oreover, string/M -theory naturally predicts the appearence of the term s with inverse powers of curvature invariants in compacti ed, low -energy elective action [26].

The present section is devoted to the study of the role of GB coupling with the scalar eld (which naturally appears in low energy elective action) to the late-time universe [27]. It is explicitly demonstrated that such term itself cannot induce the elective phantom late-time universe if the scalar is canonical in the absence of potential term. It may produce the elective quintessence (or phantom) era, explaining the current acceleration only when the scalar is phantom or when the scalar is canonical with non-zero potential. It is interesting that it may also have the important impact to the Big R ip singularity, similarly to quantum elects [17, 18, 28], preventing it. Note that we concentrate mainly on the exponential scalar-GB coupling and exponential scalar potential, while the consideration of other types of such functions and their role in late time cosm ology may be considered too [29].

We consider a model of the scalar eld coupled with gravity. As a stringy correction, the term proportional to the GB invariant $G = R^2 4R R + R R$ is added. The starting action is given by

Even if = 1, there appear the solutions describing non-phantom cosm ology corresponding the quintessence or matter. As an example, we consider the case that $h_0 = \frac{80}{3} < 1$, which gives $w_e = 1.025$. Simple tuning gives other acceptable values of the elective w in the range close to 1. This is consistent with the observational bounds for elective w (for recent discussion and complete list of refs., see [30]). Then from (40), one obtains

Therefore even starting from the canonical scalar theory with positive potential, we may obtain a solution which reproduces the observed value of w.

Therefore in order for the solution to exist, the condition is $f_0 < 0$. In (42), \prime_0 can be arbitrary. Hence, the Hubble rate $H = H_0$ m ight be determined by an initial condition.

In [27], the stability of the above (and related) solutions was checked and it was found that the case corresponding to phantom cosm ology with $h_0 < 0$ is always stable but the case corresponding to non-phantom cosm ology with $h_0 > 0$ is always unstable. Also in [31], by taking into account the higher-order string corrections to E instein-H ilbert action, the evolution of (phantom) dark energy universe was studied. When xed dilaton, while the presence of a cosm ological constant gives stable de-Sitter xed points in the cases of heterotic and bosonic strings, no stable de-Sitter solutions exist when a phantom uid is present. It was found that the universe can exhibit a B ig C runch singularity with a nite time for type II string, whereas it reaches a B ig R ip singularity for heterotic and bosonic strings. Thus the fate of dark energy universe crucially depends upon the type of string theory under consideration. Furtherm ore, a barotropic perfect uid coupled to the scalar eld (dilaton or com pacti cation m odulus) was also considered and phase space analysis and the stability of asym ptotic solutions are perform ed for a num ber ofm odels which include (i) xed scalar eld, (ii) linear dilaton in string frame, and (iii) logarithm ic m odulus in E instein frame. It was also shown that dilaton G auss-B onnet gravity (with no m atter) m ay not explain the current acceleration of the universe. It was also studied the future evolution of the universe using the G B param etrization and found that B ig R ip singularities can be avoided even in the presence of a phantom uid because of the balance between the uid and curvature corrections. A non-m inim al coupling between the uid and the modulus eld also opens up the interesting possibility to avoid B ig

R ip regardless of the details of the uid equation of state. Note also that above action has interesting applications in early time string cosmology (for recent discussion and list of references, see [32]). De nitely, dilaton Gauss-Bonnet gravity (perhaps, also with account of higher order terms like Euler invariant) deserves very deep investigation as possible candidate for dark energy.

IV. MODIFIED GRAVITY:NON-LINEAR COUPLING,COSM IC ACCELERATION AND HIERARCHY PROBLEM

A. Gravitational solution of coincidence problem

It is interesting to investigate the role of non-m inim all coupling of modil ed gravity with dark energy to cosm ic acceleration epoch. The corresponding, quite general theory has been suggested in ref.[33] (see also [34]). As an example of such theory, the following action is considered:

Here L_d is matter-like action (dark energy). The choice of parameter may keep away the unwanted instabilities which often occur in higher derivative theories. The second term in above action describes the non-linear coupling of matter with gravity (in parallel with R² term which is usually required by renormalizability condition [35]). Similarly, such term may be induced by quantum elects as non-local elective action. Hence, it is natural to consider that it belongs to matter sector. (Standard matter is not included for simplicity).

By the variation over g , the equation of m otion follows:

Here q is a constant of the integration. Hence R $L_d = \frac{q^2}{2a^6R}$, which becomes dominant when R is small (large) compared with the Einstein term $\frac{1}{2}$ R if > 1 (< 1). Thus, one arrives at the remarkable possibility [33] that dark energy grows to asymptotic dominance over the usual matter with decrease of the curvature. At current universe, this solves the coincidence problem (the equality of the energy density for dark energy and form atter) simply by the fact of the universe expansion.

Substituting (48) into (44), the (;) = (t;t) component of equation of motion has the following form:

Eq.(50) tells that the universe accelerates, that is, a > 0 if > 2. If < 1, the solution (50) describes shrinking universe if t > 0. If the time is shifted as $t ! t t_s$ (t_s is a constant), the accelerating and expanding universe occurs when $t < t_s$. In the solution with < 1 there appears a Big R ip singularity at $t = t_s$. For the matter with the relation p = w, where p is the pressure and is the energy density, from the usual FRW equation, one has $a / t^{\frac{2}{3(w+1)}}$. For a / t^{h_0} it follows $w = 1 + \frac{2}{3h_0}$, and the accelerating expansion ($h_0 > 1$) of the universe occurs if $1 < w < \frac{1}{3}$. For the case of (50), one nds

Then if < 1, we have w < 1, which is an elective phantom. For the general matter with the relation p = w with constant w, the energy E and the energy density behave as E a ^{3w} and a ^{3(w+1)}. Thus, for the standard phantom with w < 1, the density becomes large with time and might generate the Big Rip. Hence, it is demonstrated that non-linear coupling of gravity with matter may produce the accelerated cosm ology with the elective E oS parameter being close (above, equal or below) to 1. More complicated couplings [33] may be considered in the same fashion.

B. Dynam ical cosm ological constant theory: an exact exam ple

There are many proposals to solve the cosm obgical constant problem dynam ically. One of the possible solutions of the cosm ological constant problem is pointed out by Mukohyam a and Randall [36] (see also [37]). In [36], the following action similar to the one under consideration has been proposed:

Here V_0 and '_c are constants. If q > 1=2, the factor in front of the kinetic term of ' in (52) becomes large. This makes the time development of the scalar eld ' very slow and it is expected that ' does not reach '_c. This model may explain the acceleration of the present universe. The model (52) is also expected to be stable under the radiative corrections. In fact, when the curvature is small and the time development of the curvature can be neglected, if we rescale the scalar eld ' as' ! $R^{m(2q-1)=q}$, the curvature in the kinetic term can be absorbed into the rede nition of ' and there appear factors including $R^{m(2q-1)=q}$. Therefore if m (2q-1)=q > 0, the interactions could be suppressed when the curvature is small and there will not appear the radiative correction to the vacuum energy except the one-loop corrections.

There is an exactly solvable model [38], which realizes the above scenario. Let us choose

It is interesting that the value of w_e is consistent with the observed bounds. (Note that recently the above model has been reconsidered in ref.[39]).

For $h_0 > 0$ case, since $R = 6H + 12H^2$, the curvature R decreases as t^2 with time t and ' approaches to ' c but does not arrive at ' c in a nite time, as expected in [36].

As H behaves as h_0 =t or h_0 =(t_s t) for (6) in sect.II, if we substitute the value of the age of the present universe 10^{10} years (10^{-33} eV) 1 into t or t_s t, the observed value of H could be reproduced, which could explain the smallness of the elective cosm obgical constant H². Note that even if there is no potential term, that is, $V_0 = 0$, when < 0, there is a solution

C. Hierarchy problem in modi ed gravity

Hierarchy problem is known to be the fundamental one in high energy physics. It is interesting to understand if modi ed gravity approach may help in resolution of hierarchy problem? Recently the hierarchy problem has been investigated, in [40], in frames of scalar-tensor theory. Here, sim ilar proposal will be discussed in the modi ed gravity. In [40], in order to generate the hierarchy, a small scale, which is the vacuum decay rate vac, was considered. Instead of vac, we here use the age of the universe 10³³ eV, as the small mass scale.

We now start from the action form odi ed gravity coupled with matter (1) in sect.II. Let us assume that the matter Lagrangian density L_{matter} contains a Higgs-like scalar eld '

Therefore there is a quite natural possibility that the hierarchy problem can be solved by above version of modi ed gravity (sim ilar solution of hierarchy problem may be found in two scalar-tensor gravity of ref.[41] as it has been shown in [42].)

Nevertheless, note that the cosm obgical time variables in two frames could be different due to the scale transformation (68) as dt ! dt = $e^{-\frac{1}{2}}$ dt. Therefore the time-intervals are different in the two frames. The units of time and the length are now defined by the electrom agnetism. Then the frame where the electrom agnetic fields do not couple with the scalar eld could be physically more preferrable. Since the electrom agnetic interaction is a part of the electro-weak interaction, the Jordan frame in (66) could be more preferrable from the point of view of the solution of hierarchy problem.

V. LATE-TIME COSMOLOGY IN MODIFIED GAUSS-BONNET GRAVITY

A. f(G) gravity

Our next example is modi ed Gauss-Bonnet gravity. Let us start from the action [42, 44]:

In the phantom phase, there might seem to occur the Big R ip at t = t_s [15]. Near this Big R ip , however, the curvature becomes dominant and then the Einstein term dominates, so that the f (G) term can be neglected. Therefore, the universe behaves as $a = a_0 t^{2=3 (w+1)}$ and as a consequence the Big R ip does not eventually occur. The phantom era is transient.

The case when 0 < 1=2 m ay be also considered. As is positive, the universe does not reach here the phantom phase. When the curvature is strong, the f(G) term in the action (71) can be neglected and we can work with E instein gravity. Then if w is positive, the matter energy density m should behave as m t², but f(G) goes as f(G) t⁴. Then, for late times (large t), the f(G) term may become dominant as compared with the matter one. If we neglect the contribution from matter, Eq. (73) has a deSitter universe solution where H, and therefore G, are constant. If H = H₀ with constant H₀, Eq. (73) boks as (74). As a consequence, even if we start from the deceleration phase with w > 1=3, we may also reach an asymptotically deSitter universe, which is an accelerated universe. Correspondingly, also here there could be a transition from acceleration to deceleration of the universe.

Now, we consider the case when the contributions coming from the Einstein and matter terms can be neglected. Then, Eq. (73) reduces to

If f (G) behaves as (75), from assumption (6) in sect.II, we obtain

Therefore, if > 0, the universe is accelerating ($w_e < 1=3$) and if > 1=4, the universe is in a phantom phase ($w_e < 1$). Thus, we are led to consider the following model:

Then, when the curvature is large, as in the prim ordial universe, the st term dom inates, compared with the second one and the Einstein term, and gives

On the other hand, when the curvature is small, as is the case in the present universe, the second term in (82) dominates, compared with the rst one and the Einstein term, and yields

Therefore, theory (82) can in fact produce a model which is able to describe in ation and the late-time acceleration of the universe in the uni ed way.

Instead of (83), one may also choose $_1$ as

Then, what we obtain is an elective quintessence. Moreover, by properly adjusting the couplings f_i and f_l in (82), one can obtain a period where the Einstein term dominates and the universe is in a deceleration phase. A fler that, there would come a transition from deceleration to acceleration, when the GB term becomes the dominant one. More choices of f (G) may be studied with the purpose of the construction of natural accelerating universes.

Let us address the issue of the correction to N ew ton law. Let $g_{(0)}$ be a solution of (72) and represent the perturbation of the metric as $g = g_{(0)} + h$. First, we consider the perturbation around the deSitter background which is a solution of (74). We write the deSitter space metric as $g_{(0)}$, which gives the following R iem ann tensor:

The at background corresponds to the lim it of H₀ ! 0. For simplicity, the following gauge condition is chosen: $g_{(0)}h = r_{(0)}h = 0$. Then Eq. (72) gives

The GB term contribution does not appear except in the length parameter $1=H_0$ of the deSitter space, which is determined with account to the GB term. This may occur due to the special structure of GB invariant. Eq. (89) tells us that there is no correction to Newton's law in deSitter and even in the at background corresponding to H_0 ! 0, whatever is the form of f (at least, with above gauge condition). Note that the study of newtonian limit in 1=R gravity (where signi cant corrections to new ton law may appear) and its extensions has been done in [4, 7]. Form ost 1=R m odels the corrections to New ton law do not comply with solar system tests.

By introducing two auxilliary elds, A and B, one can rewrite the action (71) as

Varying over B, it follows that A = G. Using this in (90), the action (71) is recovered. On the other hand, varying over A in (90), one gets $B = f^{0}(A)$, and hence

By varying over A, the relation A = G is obtained again. The scalar is not dynam ical as it has no kinetic term . We may add, however, a kinetic term to the action by hand

Then one obtains a dynamical scalar theory coupled with the Gauss-Bonnet invariant and with a potential. It is known that a theory of this kind has no ghosts and it is stable, in general. A ctually, it is related with string-inspired dilaton gravity proposed as alternative for dark energy [27, 31]. Then, in case that the lim it ! 0 can be obtained sm oothly, the corresponding f (G) theory has no ghost and could actually be stable. It may be of interest to study the cosm obgy of such theory in the lim it ! 0.

B. f(G;R) gravity

It is interesting to study late-tim e cosm ology in generalized theories, which include both the functional dependence from curvature as well as from the Gauss-Bonnet term [42]:

Then, for example, if ${}^{2}f_{0} < 3$, there is a solution describing a phantom with $h_{0} < 1 \stackrel{p}{-} 2$ and a solution describing the elective matter with $h_{0} > 1 + \frac{1}{2}$. Late-time cosm obgy in other versions of such theory may be constructed.

VI. IN HOM OGENEOUS EQUATION OF STATE OF THE UNIVERSE DARK FLUID

Let us rem ind several simple facts about the universe lled with ideal uid. By using the energy conservation law $0 = _+ 3H$ (p+), when and p satisfy the following simple EOS p = w with constant w, we nd = $_0a^{-3(1+w)}$. Then by using the rst FRW equation $(3=^2)H^2 = _p$, the well-known solution follows $a = a_0$ (t $t_1)^{\frac{2}{3(w+1)}}$ (w > 1) or a_0 (t₂ t)^{$\frac{2}{3(w+1)}$} w for 1 (w < 1) and $a = a_0e^{t}^{\frac{1}{3}}$ when w = 1, which is the deSitter universe. Here t_1 and t_2 are constants of the integration. When w < 1, there appears a Big Rip singularity in a nite time at $t = t_2$. In general, the singularities in dark energy universe may behave in a dimension way. One may classify the future

singularities as follows [18]:

Type I (\Big Rip"): Fort! \$,a! 1, ! 1 and pj! 1 Type II (\sudden"): Fort! \$,a! a_s, ! s or 0 and pj! 1 Type III: Fort! \$,a! a_s, ! 1 and pj! 1 Type IV: Fort! \$,a! a_s, ! 0, pj! 0 and higher derivatives of H diverge. This also includes the case when (p) or both of them tend to some nite values while higher derivatives of H diverge.

Here t_s , a_s and s_s are constants with $a_s \notin 0$. The type I m ay correspond to the B ig R ip singularity, which emerges when constant w is less than 1. The type II corresponds to the sudden future singularity [16] at which a and are nite but p diverges. The type III appears for the model with p = A [19, 28], which is di erent from the sudden future singularity in the sense that diverges. Now, let us discuss the universe lled with ideal uid with inhom ogeneous EoS. (It is assumed that GR is valid). E ectively, this approach overlaps with m odi ed gravity one as inhom ogeneous contribution m ay be considered as one coming from new gravitational terms. M oreover, it m ay be an extrem ely useful in the situation when m odi ed gravity represents highly non-linear theory where only som e features (but not the whole Lagrangian) are known like is currently the case with M -theory.

A. The singularities in the inhom ogeneous EoS dark uid universe

One may start from the dark uid with the following EOS:

where f() can be an arbitrary function in general. The choice f() / w ith a constant was proposed in Ref.[28] and was investigated in detail in Ref.[18, 19]. Then the scale factor is given by

In case > 1, when t! to the energy density behaves as ! 1 and therefore pj! 1. Then the scale factor a is nite even if ! 1. Therefore > 1 case corresponds to type III singularity.

In = 1 case, if A > 0, there occurs the B ig R ip or type I singularity but if A = 0, there does not appear future singularity.

In case 1=2 < < 1, when t! b, all of , pj and a diverge if A > 0 then this corresponds to type I singularity.

In case 0 < < 1=2, when t! to, we nd , jpj! 0 and a! a₀ but

Since the exponent (1)=(1=2) is not always an integer, even if a is nite, the higher derivatives of H diverge in general. Therefore this case corresponds to type IV singularity.

In case < 0, when t ! t, we nd ! 0, a ! a_0 but $j_0 j_1 l$. Therefore this case corresponds to type II singularity.

Hence, the brief review of dark uid FRW cosm ology with specic hom ogeneous EOS as well as its late-time behaviour (singularities) is given (see [18] for more detail).

At the next step, we consider the inhom ogeneous EOS for dark uid, so that the dependence from Hubble param eter is included in EOS. This new terms may origin from string/M -theory, braneworld or modi ed gravity. One more motivation for such EOS comes from including of time-dependent bulk viscosity in dark uid EOS [45] or from the modi cation of gravity. Hence, we suggest the following EOS [46]

where G (H) is some function.

As an example, one may consider the case

In case > 1, for most values of , there occurs type III singularity. In addition to the type III singularity, when 0 < < 1=2, there occurs type IV singularity and when < 0, there occurs type II singularity.

= 1 case, if > 1, the singularity becomes type III. If < 1 and A > 0, there occurs the B ig R ip or type I singularity. In addition to the type I singularity, we have type IV singularity when 0 < < 1=2 and type II when < 1.

In case 1=2 < < 1, one sees singularity of type III for > 1, type I for 1=2 < 1 (even for = 1=2) or = 1 and B⁰ > 0 (B > 0) case. In addition to type I, type IV case occurs for 0 < < 1=2, and type II for < 0.

In case = 1=2, we have singularity of type III for > 1, type I for 1=2 < < 1 or = 1 and $B^0 > 0$ (B > 0), type IV for 0 < < 1=2, and type II for < 0.W hen = 1=2 or = 0, there does not appear any singularity.

In case 0 < < 1=2, we determine the singularity of type II for 0 < < 1=2, and type II for < 0. In addition to type IV singularity, there occurs singularity of type III for > 1, type I for 1=2 < 1 or = 1 and $B^0 > 0$ (B > 0) case.

In case < 0, there will always occur type II singularity. In addition to type II singularity, we have a singularity of type III for > 1, type I for 1=2 < 1 or = 1 and B⁰ > 0 (B > 0) case.

Thus, we demonstrated how the modi cation of EOS by Hubble dependent, inhomogeneous term changes the structure of singularities in late-time dark energy universe.

In general, EOS needs to be double-valued in order for the transition (crossing of phantom divide) to occur between the region w < 1 and the region w > 1. Then there could not be one-to-one correspondence between p and . In such a case, instead of (101), we may suggest the implicit, inhom ogeneous equation of the state

Here C_0 and H_0 are positive constants. Hence, the Hubble rate looks as

In (105), since $t < t_0 < t_+$, as long as $t < t < t_+$, the Hubble rate H is positive. The Hubble rate H has a minimum H = H₀ when t = t₀ = (t + t₊)=2 and diverges when t! t. Then one may regard t! t as a Big Bang singularity and t! t₊ as a Big R ip one. As clear from (106), the parameter w = p= is larger than 1 when t < t < t₀ and smaller than 1 when t₀ < t < t₊. Therefore there occurs the crossing of phantom divide w = 1 when t = t₀ thanks to the e ect of inhom ogeneous term in EOS.

In principle, the more general EOS may contain the derivatives of H, like H, H, ... More general EOS than (103) may have the following form :

Trivial example is that

By using the rst and second FRW equations = $(3=^{2})H^{2}$ and p = $(2=^{2})H^{-}$, Eq.(108) becomes an identity, which means that any FRW cosm ology can be a solution if EOS (108) is assumed.

B. Origin of the inhom ogeneous term s

In order to give the support for an inhom ogeneous $E \circ S$ dark uid [47] we will indicate how the extra term s m ay appear from the modi cations of G eneral R elativity. Let us start with the action of the scalar-tensor theory (25) in sect.II. The energy density and the pressure p for the scalar eld are given by

Then we obtain dark uid with hom ogeneous $E \circ S w$ ith $w = 1 + 2 = 3f_0$. Note that despite the fact that speci c scalartensor theory and dark uid m ay predict the same FRW dynamics, their physical properties m ay be di erent. For instance, New ton law, number of FRW solutions, their stability properties m ay signi cally di er in two form ulations.

Another possibility to obtain the inhomogeneous EOS dark uid is related with the modi ed gravity. As an illustrative example, the following action is considered:

In the FRW universe, the gravitational equations are:

Here and p are the energy density and the pressure coming from $L_{m atter}$. They may satisfy the equation of state like p = w. One may now dense the electric energy density ~ and p by

Thus, FRW dynam ics (here, the same FRW equations) of some modiled gravity may be equivalent to FRW dynam ics in GR coupled with the inhomogeneous EoS dark uid. Of course, the physics of two equivalent FRW descriptions (New ton law, perturbations structure, stability of FRW solution, number of FRW solutions, etc.) may be quite di erent [20]. In this respect, one should note that di erent modiled gravities may also lead to the same FRW equations (see an explicit example in [48]). Nevertheless, the details of FRW dynam ics will be again di erent as modiled gravity predictions should be compared with observations (for some attempts in this direction, see [47, 49, 50]).

VII. DISCUSSION

In sum m ary, we presented the introduction to some classes of modi ed gravities considered as gravitational alternative for dark energy. Speci cally, the models which include f(R), f(G), f(R;G) term s or string-inspired GB-dilaton term s are considered (for recent review of higher derivative gravities, see [54] and for discussion of their experimental manifestations, see [55]). Special attention is paid to their versions where the action grows with decrease of the scalar curvature. In addition, the FRW universe lled with dark uid with inhom ogeneous EoS which m ay be induced by m odi ed gravity is discussed. As it has been stressed in the introduction and as it has been explicitly demonstrated above, m odi ed gravity is endowed with a quite rich cosm ological structure: it m ay naturally lead to an elective cosm ological constant, quintessence or phantom era in the late universe with a possible transition from deceleration to acceleration or (if necessary) the crossing of phantom divide. Moreover, some versions of modi ed gravity m ay pass the Solar System tests quite successfully.

N evertheless, we are still issing the modi ed gravity theory which, from one side, is as good as G eneral R elativity in Solar System tests and from another side contains the fully consistent explanation for current cosm ic acceleration. (N ote that if universe is currently entering to phantom phase, then some deviations from G eneral R elativity are quite expectable at large distances). It is quite possible that other versions of modi ed gravity: string-inspired gravity with fourth-order (or higher) in R corrections, theories which contain Traces of inverse R iem ann tensor [51] or negative powers of squared R iem ann and R icci tensors [52] or even non-local R iem ann and R icci tensor terms (for instance, of the sort induced by Q uantum Field T heory [53] with term s like R = R R, R R = R R, etc) or some combination of the above m odels with the ones under discussion should be considered as dark energy candidates as well. From another point, the next generation of precise observations should de ne the evolution of the cosm ological param eters, and, perhaps, to rule out some of possible gravitational dark energy m odels leading to viable explanation of dark energy problem.
