A bstract

W ightman function, the vacuum expectation values of the eld square and the energymomentum tensor are investigated for a massive scalar eld with general curvature coupling parameter in the region between two coaxial cylindrical boundaries. It is assumed that the eld obeys general Robin boundary conditions on bounding surfaces. The application of a uprime of the general Robin boundary conditions on bounding surfaces.

variant of the generalized A belP lana form ula allows to extract from the expectation values the contribution from single shells and to present the interference part in terms of exponentially convergent integrals. The vacuum forces acting on the boundaries are presented as the sum of self{action and interaction terms. The rst one contains well-known surface divergences and needs a further renorm alization. The interaction forces between the cylindrical boundaries are nite and are attractive for special cases of D irichlet and N eum ann scalars. For the generalR obin case the interaction forces can be both attractive or repulsive depending on the coe cients in the boundary conditions. The totalC asim ir energy is evaluated by using the zeta function regularization technique. It is shown that it contains a part which is located on bounding surfaces. The form ula for the interference part of the surface energy is derived and the energy balance is discussed.

1 Introduction

The Casim ir e ect is one of the most interesting macroscopic manifestations of the nontrivial structure of the vacuum state in quantum eld theory. The e ect is a phenomenon common to all systems characterized by uctuating quantities and results from changes in the vacuum uctuations of a quantum eld that occur because of the imposition of boundary conditions or the choice of topology. It may have important implications on all scales, from cosm ological to subnuclear, and has become in recent decades an increasingly popular topic in quantum eld theory. In addition to its fundamental interest the Casim ir e ect also plays an important role in the fabrication and operation of nano- and micro-scale mechanical systems. The imposition

of boundary conditions on a quantum eld leads to the modi cation of the spectrum for the zero-point uctuations and results in the shift in the vacuum expectation values for physical quantities such as the energy density and stresses. In particular, the con nement of quantum uctuations causes forces that act on constraining boundaries. The particular features of the resulting vacuum forces depend on the nature of the quantum eld, the type of spacetime manifold, the boundary geometries and the speci c boundary conditions in posed on the eld. Since the original work by C asim ir [1] many theoretical and experimental works have been done on this problem (see, e.g., [2, 3, 4, 5] and references therein). Many di erent approaches have been used: mode sum mation method with combination of the zeta function regularization technique, G reen function form alism, multiple scattering expansions, heat-kernel series, etc. A dvanced eld-theoretical methods have been developed for C asim ir calculations during the past years [6].

An interesting property of the Casim ir e ect has always been the geometry dependence. Straightforward computations of geometry dependencies are conceptually complicated, since relevant inform ation is subtly encoded in the uctuations spectrum. A nalytic solutions can usually be found only for highly sym m etric geom etries including planar, spherically and cylindrically symm etric boundaries. A side from their own theoretical and experim ental interest, the problem s with this type of boundaries are useful for testing the validity of various approximations used to deal with m ore complicated geom etries. In particular, a great deal of attention received the investigations of quantum e ects for cylindrical boundaries. In addition to traditional problem s of quantum electrodynamics under the presence of material boundaries, the Casimir e ect for cylindrical geometries can also be important to the ux tube models of con nem ent [7, 8] and for determ ining the structure of the vacuum state in interacting eld theories [9]. The calculation of the vacuum energy of electrom agnetic eld with boundary conditions de ned on a cylinder turned out to be technically a more involved problem than the analogous one for a sphere. First the Casim ir energy of an in nite perfectly conducting cylindrical shell has been calculated in Ref. [10] by introducing ultraviolet cuto and later the corresponding result was derived by zeta function technique [11, 12, 13]. The local characteristics of the corresponding electrom agnetic vacuum such as energy density and vacuum stresses are considered in [14] for the interior and exterior regions of a conducting cylindrical shell, and in [15] for the region between two coaxial shells (see also [16]). The vacuum forces acting on the boundaries in the geometry of two cylinders are also considered in Refs. [17]. Less symmetric con gurations of a semi-circular in nite cylinder and of a wedge with a coaxial cylindrical boundary are investigated in Refs. [18, 19]. A large number of papers is devoted to the investigation of the various aspects of the C asim ir e ect for a dielectric cylinder (see, for instance, [20] and references therein). From another perspective, the in uence of a dielectric cylinder on the radiation process from a charged particle has been discussed in [21].

An interesting topic in the investigations of the C asim ir e ect is the dependence of the vacuum characteristics on the nature of boundary conditions imposed. In Ref. [22] scalar vacuum densities and the zero-point energy for general R obin condition on a cylindrical surface in arbitrary number of spacetime dimensions are studied for massive scalar eld with general curvature coupling parameter. The R obin boundary conditions are an extension of the ones imposed on perfectly conducting boundaries and may, in some geometries, be useful for depicting the nite penetration of the eld into the boundary with the 'skin-depth' parameter related to the R obin condition on the boundary of a cavity violates the B ekenstein's entropy-to-energy bound near certain points in the space of the parameter de ning the boundary condition [25]. This type of conditions also appear in considerations of the vacuum e ects for a con ned charged scalar eld in external elds [26] and in quantum gravity [27, 28, 29]. M ixed boundary conditions

naturally arise for scalar and fem ion bulk elds in branew orld models [30]. For scalar elds with R obin boundary conditions, in R ef. [31] it has been shown that in the discussion of the relation between the mode-sum energy, evaluated as the sum of the zero-point energies for each norm al mode of frequency, and the volume integral of the renormalized energy density for the R obin parallel plates geometry it is necessary to include in the energy a surface term concentrated on the boundary (for the discussion of the relation between the local and global characteristics of the vacuum see also R ef. [32, 33, 34, 22, 35]). An expression for the surface energy-m om entum tensor for a scalar eld with a general curvature coupling parameter in the general case of bulk and boundary geometries is derived in R ef. [36]. R elated cosm ological constant induced on the brane by quantum uctuations of a bulk eld in braneworld scenarios has been considered in [37].

In the present paper, we consider the C asim ir densities in the region between two coaxial cylindrical shells on background of the (D + 1)-dimensional M inkowski spacetime. The positive frequency W ightman function, the vacuum expectation values of the eld square and the energy-momentum tensor are investigated for a massive scalar eld with general curvature coupling parameter. In addition to describing the physical structure of the quantum eld at a given point, the energy-momentum tensor acts as the source of gravity in the Einstein equations. It therefore plays an important role in modelling a self-consistent dynamics involving the gravitational eld [38]. For the general case of R obin boundary conditions with di erent coe cients for the inner and outer boundaries, we derive form ulae for the forces acting on the boundaries due to the modi cation of the spectrum of the zero-point uctuations by the presence of the second boundary. The C asim ir energy and the surface energy are investigated as well and the energy balance is discussed.

The plan of the paper is as follows. In the next section we derive a formula for the W ightm an function in the region between two cylindrical surfaces. The reason for our choice of the W ightm an function is that this function also determ ines the response of the particle detectors in a given state of m otion. To evaluate the bilinear eld products we use the m ode-sum m ethod in combination with the sum mation form ula from [16, 34]. These form ula allows (i) to extract from vacuum expectation values the parts due to a single cylindrical boundary, and (ii) to present the interference parts in terms of exponentially convergent integrals involving the modi ed Bessel functions. The vacuum expectation values of the eld square and the energy-m om entum tensor are obtained from the W ightm an function and are investigated in section 3. The vacuum forces acting on the bounding surfaces are considered in section 4. They are presented as the sum of self(action and interaction terms. The formulae are derived for the interaction forces between the cylinders. Section 5 is devoted to the total vacuum energy evaluated as a sum of zero-point energies of elementary oscillators. We show that this energy in addition to the volume part contains a part located on the bounding surfaces. The form ula for the interaction part of the surface energy is derived. Further we discuss the relation between the vacuum energies and forces acting on the boundaries. Section 6 concludes the main results of the paper.

2 Wightman function

Consider a real scalar eld ' with curvature coupling parameter satisfying the eld equation

where R is the curvature scalar for a (D + 1)-dimensional background spacetime, r_i is the covariant derivative operator. For special cases of m inimally and conformally coupled scalars one has = 0 and = $_D$ (D 1)=4D, respectively. Our main interest in this paper will be

one-loop quantum vacuum e ects induced by two in nitely long coaxial cylindrical surfaces with radii a and b, a < b, in the M inkow ski spacetime. For this problem the background spacetime is at and in Eq. (1) we have R = 0. As a result the eigenmodes are independent on the curvature coupling parameter. However, the local characteristics of the vacuum such as energy density and vacuum stresses depend on this parameter. In accordance with the problem symmetry we will use cylindrical coordinates (r; ;z₁;:::;z_N), N = D 2, and will assume that the eld obeys R obin boundary conditions on bounding surfaces:

with A_j and B_j being constants, $n_{(j)}^i$ is the inward-pointing norm alto the bounding surface r = j. For the region between the surfaces, a 6 r 6 b, one has $n_{(j)}^i = n_j \frac{i}{1}$ with the notations $n_a = 1$ and $n_b = 1$. The imposition of boundary conditions on the quantum eld modiles the spectrum for zero-point uctuations and leads to the modilection of the vacuum expectation values (VEVs) for physical quantities compared with the case without boundaries. First we consider the positive frequency W ightman function. The VEVs of the eld square and the energy-momentum tensor can be evaluated on the base of this function. By the same method described below any other two-point function can be evaluated.

Let f'(x); '(x)g is a complete orthonorm also of positive and negative frequency solutions to the eld equation, specified by a set of quantum numbers and satisfying the boundary conditions (2). By expanding the eld operator and using the standard commutation relations, the positive frequency W ightman function is presented as the mode-sum

where j is the amplitude for the corresponding vacuum state. For the region a 6 r 6 b the eigenfunctions are specified by the set of quantum numbers = (n; ;k), n = 0; 1; 2;:::, and have the form

In Eq. (5), $J_n(z)$ and $Y_n(z)$ are the Bessel and Neum ann functions and for a given function f(z) we use the notation

with $j = a_ib$. The eigenfunctions (4) with the radial part (5) satisfy the boundary condition on the inner surface. The eigenvalues for the quantum number are quantized by the boundary condition (2) on the surface r = b. From this condition it follows that the possible values of are solutions to the equation (= b=a)

In the discussion below the corresponding positive roots we will denote by $a = n_{jl}$, l = 1; 2; ..., assuming that they are arranged in the ascending order, $n_{jl} < n_{jl+1}$.

The coe cient in (4) is determined from the orthonormality condition for the eigenfunctions

where the prime on the sum m ation sign m eans that the sum m and with n = 0 should be halved. As the expressions for the eigenmodes $_{n,1}$ are not explicitly known, the form (11) for the W ightm an function is inconvenient. For the further evaluation of this VEV we apply to the sum over 1 the sum m ation form ula [16, 34]

In case of existence of purely in aginary zeros we have to include additional residue terms on the left of form ula (12) (see [34]). In the limit b! 1 the second term in gure braces on the right of (15) vanishes, whereas the rst term does not depend on b. It follows from here that the part with the rst term presents the W ightm an function in the region outside of a single cylindrical shell with radius a (of course, this may also be seen by direct evaluation of the corresponding W ightm an function). To simplify this part we use the identity

3 VEVs of the eld square and the energy-m om entum tensor

Having the W ightm an function we can evaluate the VEVs of the eld square and the energym om entum tensor. These VEVs in the regions r < a and r > b are the same as those for a single cylindrical surface with radius a and b respectively and are investigated in [22]. For this reason in the discussion below we will be concerned on the region a < r < b. By making use of form ulae (19) and (23) for the W ightm an function and taking the coincidence lim it of the arguments, for the VEV of the eld square one nds

For points away from the boundaries the last two terms on the right of form ula (26) are nite and, hence, the subtraction of the M inkowskian part without boundaries is su cient to obtain the renormalized value for the VEV: $h'^{2}i_{ren} = h0 j'^{2} ji$ $h'^{2}i^{(0)}$. In form ula (26) the part $h'^{2}i^{(j)}$ is induced by a single cylindrical surface with radius j when the second surface is absent. The form ulae for these terms are obtained from (20) and (24) in the coincidence limit. For j = a one has

and the form ula for h'²i^(b) is obtained from here by the replacements a ! b, I K. The last term on the right of form ula (26) is induced by the presence of the second cylindrical surface. The surface divergences in the boundary induced parts in the VEV of the eld square are the same as those for single surfaces and are investigated in [22]. In particular, the last term on the right of (26) is nite for r = j. It follows from here that if we present the renorm alized VEV of the eld square in the form

then the interference part h'²i^(ab) is nite on both boundaries. In the limit a ! 0 this part vanishes as a for R obin boundary condition on the inner shell ($A_a; B_a \notin 0$), as a^2 for N eum ann boundary condition ($A_a = 0$), and like 1=ln a for D inichlet boundary condition ($B_a = 0$). In the limit b ! 1 and for a massless eld the interference part vanishes as $\ln b=b^{D-1}$ for R obin boundary condition on the inner shell, as $\ln b=b^{D+1}$ for N eum ann boundary condition, and like $1=b^{D-1}$ for D inichlet boundary condition. In the same limit under the condition mb 1 the interference part is exponentially suppressed.

In form ula (32) the term $hT_i^k i^{(j)}$ is induced by a single cylindrical surface with radius j. These parts for both interior and exterior regions are investigated in [22]. The form ula for the case j = a is obtained from (29) by the replacement K_n^2 (ru) ! $u^2 F_n^{(i)} K_n$ (ru)]. As in the case of the eld square, the renormalized VEV of the energy-momentum tensor can be presented in the form

where the surface divergences are contained in the single boundary parts only and interference part is nite on the boundaries. The explicit formula for the latter is obtained by subtracting from the last term on the right (32) the corresponding single surface part. Two equivalent representations are obtained by taking in (32) j = a or j = b. Due to the presence of boundaries the vacuum stresses in radial, azim uthal and axial directions are an isotropic. For the axial stress and the energy density we have standard relation for the unbounded vacuum. It can be easily checked that the separate term s in formulae (26) and (32) satisfy the standard trace relation

In particular, this means that the r-dependence of the radial pressure leads to the anisotropy of the vacuum stresses. For a conform ally coupled massless scalar the vacuum energy-momentum

tensor is traceless. In the lim it a; b! 1 with xed b a from the formulae above the results for the geometry of two parallel plates with Robin boundary conditions are obtained. In the lim it a! 0 and for $A_a \in 0$ the main contribution into the interference part of the vacuum energymomentum tensor comes from n = 0 term and this part behaves like a in the case $B_a \in 0$ and like 1= ln (a=b) in the case $B_a = 0$. In the same lim it and for $A_a = 0$ the interference part behaves as a^2 . For a massless scalar eld in the lim it b! 1 and for A_a ; $B_a \notin 0$ the main contribution comes, again, from n = 0 term. The corresponding energy density behaves as $b^{1 D}$, while the vacuum stresses behave like ln b- b^{D-1} . For a massive scalar eld under the condition m b 1 the interference part of the energy-momentum tensor is exponentially suppressed.

The interference part of the vacuum energy-momentum tensor gives nite contribution into the vacuum energy in the region a 6 r 6 b. To evaluate this contribution we note that the function $G_n^{(j)}$ (ju;ru) is a modi ed cylindrical function with respect to the argument r. By using the formula for the integral involving the square of a modi ed cylindrical function (see, for instance, [39]) and noting that for these functions

Of course, due to the surface divergences these single shell parts cannot be obtained directly by the integration of the corresponding densities and need additional renorm alization. A swe will see below in section 5, the total vacuum energy in addition to the volum e part contains the contribution located on the boundaries.

4 Interaction forces

Now we turn to the vacuum forces acting on the cylindrical surfaces. The vacuum force per unit surface of the cylinder at r = j is determined by the $\frac{1}{1}$ { component of the vacuum energy-momentum tensor at this point. For the region between two surfaces the corresponding elective pressures can be presented as the sum of two terms:

The rst term on the right is the pressure for a single cylindrical surface at r = j when the second surface is absent. This term is divergent due to the surface divergences in the vacuum expectation values and needs further renorm alization. This can be done, for example, by applying the generalized zeta function technique to the corresponding mode-sum. This procedure is similar to that used in R ef. [22] for the evaluation of the total C as in ir energy for a single cylindrical shell. This calculation lies on the same line with the evaluation of the surface C as in ir densities and will be presented in the forthcom ing paper [40]. Here we note that the corresponding quantities will depend on the renorm alization scale and can be xed by in posing suitable renorm alization conditions which relates it to observables. The second term on the right of Eq. (42) is the pressure induced by the presence of the second cylinder, and can be term ed as an interaction force. Unlike to the single shell parts, this term is free from renorm alization am biguities and is determined by the last term on the right of form ula (32). Substituting into this term r = j and using the relations

The expression on the right of this formula is nite for all non-zero distances between the shells. By taking into account the inequalities $K_n(u)I_n(v) = K_n(v)I_n(u) > 0$ and $K_n^0(u)I_n^0(v)$ K_n^0 (v) I_n^0 (u) < 0 for u < v, it can be seen that the vacuum e ective pressures are negative for both D irichlet and Neum ann scalars and, hence, the corresponding interaction forces are attractive. For the general R ob in case the interaction force can be either attractive or repulsive in dependence on the coe cients in the boundary conditions (see the num erical example presented below in gure 2). The quantity $p_{(int)}^{(j)}$ determ ines the force by which the scalar vacuum acts on the cylindrical shell due to the modi cation of the spectrum for the zero-point uctuations by the presence of the second cylinder. As the vacuum properties depend on the radial coordinate, there is no a priori reason for the interaction term s (and also for the total pressures $p^{(j)}$) to be the same for j = a and j = b, and the corresponding forces in general are di erent. Note that the interaction parts act on the surfaces r = a + 0 and r = b = 0. The vacuum forces acting on the sides r = a = 0 and r = b + 0 are the sam e as those for single surfaces. In combination with the parts $p_1^{(j)}$ from (42), the latter give the total vacuum forces acting on a single cylindrical shell. For D irichlet and Neum ann boundary conditions these forces can be obtained by di erentiation of the corresponding Casim ir energy (see below section 5). For D = 3 massless scalar these forces are repulsive for D irichlet case and are attractive for N eum ann case [12].

Using the W ronskian for the Besselm odi ed functions, it can be seen that for $j = a_i b$ one has

This form will be used in the next section in the discussion of the relation between the vacuum forces and the C asim ir energy. Note that for D irich let and N eum ann scalars the second term on the square brackets vanish and the interaction forces do not depend on the curvature coupling parameter.

Now we turn to the investigation of the vacuum interaction forces in various limiting cases. First of all let us consider the case when the radii of cylindrical surfaces are close to each other: b=a 1 1. Noting that in the limit b! a the vacuum forces diverge and in the limit under consideration the main contribution comes from large values n, we can use the uniform asymptotic expansions for the Bessel modi ed functions (see, for instance, [41]). The latter form ula coincides with that for the interaction forces between two parallel plates with R obin boundary conditions (2) on them [31]. In this case the interaction forces are the same for both plates and do not depend on the curvature coupling parameter. Note that in the lim it a ! b with xed values of the boundary coe cients and the shell radii, the renorm alized single surface parts $p_1^{(j)}$ remain nite while the interaction part goes to in nity. This means that for su ciently small distances between the boundaries the interaction term on the right of form ula (42) will dom inate.

For sm all values of the ratio a=b we introduce in (44) a new integration variable bu = x and expand the integrand by using the form ulae for the Besselm odi ed functions for sm all values of the argument. For A_a ; $B_a \in 0$ in the leading order the main contribution comes from n = 0 term and we have

In gure 1 we have plotted the dependence of the interaction forces per unit surface on the ratio of the radii for the cylindrical shells, a=b, for the cases of D = 3 D irichlet (left panel) and N eum ann (right panel) massless scalars. A swe have mentioned before, the interaction forces in these cases are attractive. In gure 2 we present the same graphs for the R obin boundary




Figure 1: Vacuum interaction forces acting per unit surfaces of the cylindrical shells as functions of a=b. The left panel corresponds to the case of D = 3 m assless D irichlet scalar and the right one is for Neum ann scalar.

conditions with the coe cients $B_a = 0$, $B_b = (A_b b) = 0.2$. The left panel corresponds to the minimally coupled scalar and the right one is for a conform ally coupled scalar. A swe see, for the considered example the interaction force are repulsive for small distances between the surfaces and are attractive for large distances. This provides a possibility for the stabilization of the radii by the vacuum forces. However, it should be noted that to make reliable predictions regarding quantum stabilization, the renormalized single shellparts $p_1^{(j)}$ also should be taken into account.

5 Casim ir energy

In this section we consider the total vacuum energy for the con guration of two coaxial cylindrical boundaries. In the region between the boundaries the total vacuum energy per unit hypersurface in the axial direction is the sum of the zero-point energies of elementary oscillators:




Figure 2: The same as in gure 1 form in in ally (left panel) and conform ally (right panel) coupled Robin scalars with $B_a = 0$, $B_b = (A_bb) = 02$.

The interaction part of the vacuum energy (61) is negative for D irichlet or N eum ann boundary conditions and positive for D irichlet boundary condition on one shell and N eum ann boundary condition on the another. By the way sim ilar to that used before for the case of the interaction forces it can be seen that in the lim it a; b ! 1 for xed b a the corresponding result is obtained for parallel plates. In the lim it a ! 0 for $A_a; B_a \in 0$ the main contribution into the interaction part of the vacuum energy com es from n = 0 term. By using the expansions for the Bessel m odi ed functions for sm all values of the argument to the leading order one nds

In the same limit and for D irichlet boundary condition on the inner cylinder, $B_a = 0$, the leading behavior for E is obtained from (62) by the replacement $A_a = B_a !$ ln (a=b). In the case of

Neumann boundary condition on r = a, the main contribution comes from n = 0 and n = 1 term s and E vanishes as a ²:

In the limit b ! 1 and for a massless scalar eld we have an asymptotic behavior with the leading term coming from n = 0 summand:

assuming that $A_a; A_b \in 0$. For $A_a = 0$ and $A_b \in 0$ the main contribution into the interaction part of the vacuum energy comes from n = 0 and n = 1 term s:

For the Neum ann boundary condition on the outer cylinder, $A_b = 0$, in the integrands of (63) and (64) instead of ratio of the Bessel m odi ed functions the ratio of their derivatives stands. For a massive eld and large values for the radius of the outer cylinder, under the condition m b 1 the main contribution into the integral over u in Eq. (61) com es from the lower lim it of the integral. By using the asymptotic form use for the Besselm odi ed function for large values of the argument, to the leading order we nd

and the interaction part of the vacuum energy is exponentially suppressed. In gure 3 we have plotted the dependence of the interaction parts (full curves) in the total vacuum energy on the ratio a=b for D = 3 m assless scalar elds with D irichlet, N eum ann and R obin boundary conditions. For the R obin case we have chosen the parameters in the boundary conditions as $B_a = 0, B_b = (A_bb) = 02$.

To obtain the total C asim ir energy, E, we need to add to the energy in the region between the shells, given by Eq. (61), the energies com ing from the regions r 6 a and r > b. As a result one receives

where E ^(j) is the C asim ir energy for a single cylindrical shell with the radius j. The latter is investigated in R ef. [22] as a function on the ratio of coe cients in R obin boundary condition. In particular, for D irichlet and N eum ann m assless scalars one has the C asim ir energies $E_D^{(j)} = 6.15 \quad 10^{\circ} j^2$ and $E_N^{(j)} = 1.42 \quad 10^{\circ} j^2$ (see [12]). Note that in the total vacuum energy single boundary parts dom inate for sm all values of the ratio a=b and the interaction part is dom inatt for a=b. 1. In particular, com bining the results for the single surface energies with the graphs from gure 3, we see that the total C asim ir energy for a m assless D irichlet scalar in the geom etry of two cylindrical shells is positive for sm all values a=b and has a maximum for some interm ediate value of this ratio.




Figure 3: Interaction parts of the total and surface energies as functions of a=b. The graphs are plotted for D = 3 massless scalar elds with Dirichlet (D) and Neumann (D) boundary conditions and in the case of Robin (R) boundary condition with $B_a = 0$, $B_b = (A_bb) = 0.2$.

The total volume energy in the region a 6 r 6 b is derived by the integration of $_0^0$ -component of the volume energy-momentum tensor over this region:

Substituting mode-sum expansion (11) into formula (31), after the integration for the volume part of the vacuum energy we obtain

A swe see this energy di ers from the total C asim ir energy (53) (see R ef. [36] for the discussion in general case of bulk and boundary geom etries). This di erence is due to the presence of the surface energy located on the bounding surfaces. By using the standard variational procedure, in R ef. [36] it has been shown that the energy-m om entum tensor for a scalar eld on m anifolds with boundaries in addition to the bulk part contains a contribution located on the boundary. For an arbitrary sm ooth boundary M_s with the inward-pointing unit norm al vector n^1 , the surface part of the energy-m om entum tensor is given by the form ula

and the 'one-sided' delta-function $(x; @M_s)$ boates this tensor on $@M_s$. In Eq. (70), K_{ik} is the extrinsic curvature tensor of the boundary $@M_s$ and h_{ik} is the corresponding induced metric. In the region between the cylindrical surfaces for separate boundaries one has K_{ik}^(j) = $jn_j \frac{2}{i} \frac{2}{k}$, j = a; b. Now substituting the eigenfunctions into the corresponding mode-sum formula and using the boundary conditions, for the surface energy-momentum tensor on the boundary r = j one nds

for $i_i k = 0; 1; \dots; D$, and $h 0 j_1^{(j)1} D i = 0$. From (71) for the surface energy we obtain the form ula

which, in accordance with (68), exactly coincides with the di erence between the total and volum e energies. Of course, the VEVs of the eld square on the right of this form ula and, hence, the surface energy-m om entum tensor diverge and need som e regularization with further renorm alization. Note that due to the surface divergences the subtraction of the boundary-free part is not su cient to obtain the nite result and additional renorm alization procedure is needed. In particular, the generalized zeta function m ethod is in general very powerful to give physical m eaning to the divergent quantities. However, in this paper we will not go into the details of the renorm alization for the surface energy-m om entum tensor for a single cylindrical boundary. This investigation will be presented in the forthcom ing paper [40]. Here we note that after the subtraction of the boundary-free part the remained divergences in the surface is absent. The additional parts induced by the presence of the second surface are nite and can be obtained by using the representation of the VEV for the eld square given by form ula (26). By taking into account the relation (43), the surface energy on the boundary r = j is presented in the form

where $E_{1j}^{(surf)}$ is the surface energy for a single cylindrical boundary with radius j when the second boundary is absent and the term

is induced by the presence of the second boundary. The latter is nite for all non-zero intersurface distances. Note that on the base of relation (45) it can also be written in the form

where $B_{jn}(u)$ is de ned by Eq. (46). Now, by using form ulae (40), (61), (75) it can be explicitly checked the relation

for the interaction parts of the separate energies. In gure 3 we have plotted the interaction part of the surface energy (dashed curve) for the case of D = 3 m assless Robin scalar with $B_a = 0, B_b = (A_b b) = 0.2$ as a function on the ratio a=b. For the considered example this energy is located on the surface r = b = 0 of the outer cylinder. The surface energies for D irichlet and N eum ann scalars vanish.

Now let us explicitly check that for the interaction parts the standard energy balance equation is satis ed. We expect that in the presence of the surface energy this equation will be in the form

where $V = (b^2 \quad a^2)$ and $S^{(j)} = 2$ j are the volum e and surface area per unit hypersurface in the axial direction. In Eq. (77), p is the perpendicular vacuum stress on the boundary and is determined by the vacuum expectation value of the $\frac{1}{1}$ -component of the bulk energy-momentum tensor: $p = h0 f_1^{-1}$ (Di. From equation (77) one obtains

with $p^{(j)}$ being the perpendicular vacuum stress on the boundary r = j. A sum ing that relation (78) is satisfied for the single boundary parts, for the interference parts we nd

Now by taking into account expressions (47), (61), (75) for the separate terms in this form ula and integrating by part in (61), we see that this relation indeed takes place. Hence, we have explicitly checked that the vacuum energies and elective pressures on the boundaries obey the standard energy balance equation. Note that here the role of the surface energy is crucial and the vacuum forces acting on the boundary evaluated from the bulk stress tensor [determ ined by $p_{(int)}^{(j)}$], in general, can not be obtained by a simple dilerentiation of the total vacuum energy. The second term on the right of form ula (79) corresponds to the additional pressure acting on the boundary evaluated from ula. The total pressure on the boundary evaluated as the sum of bulk and surface parts is related to the total vacuum energy by standard form ula and does not depend on the curvature coupling param eter.

6 Conclusion

In the present paper, we have investigated the one-loop quantum vacuum e ects produced by two coaxial cylindrical shells in the (D + 1)-dim ensional M inkow ski spacetime. The case of a massive scalar eld with general curvature coupling parameter and satisfying the R obin boundary conditions on the boundaries is considered. To derive form use for the VEVs of the eld operator squared and the energy-momentum tensor, we rst construct the positive frequency W ightman function. This function is also in portant in considerations of the response of a particle detector at a given state of motion through the vacuum under consideration [38]. The application of a variant of the generalized A bel-P lana form use to the mode-sum over zeros of the combinations of the cylindrical functions allowed us to extract the parts due to a single cylindrical boundary and to present the second boundary induced parts in terms of the exponentially convergent integrals. For the exterior and interior regions of a single cylindrical shell the W ightman functions are given by form use (20) and (24) respectively. The second boundary induced parts are presented by the last term s on the right of form use (19) and (23). The VEVs of the eld square and the energy-momentum tensor are obtained by the evaluation of the W ightman function and the combinations of its derivatives in the coincidence lim it of arguments. In both cases the

expectation values are presented as the sum of single boundary induced and interference term s. The surface divergences in the VEVs of the local observables are contained in the single boundary parts and the interference parts are nite on both boundaries. In particular, the integrals in the corresponding form ulae are exponentially convergent and they are useful for num erical evaluations. Due to the presence of boundaries the vacuum stresses in radial, azim uthal and axial directions are anisotropic. For the axial stress and the energy density we have standard relation for the unbounded vacuum. We have considered various limiting cases of the form ulae for the interference parts. In particular, in the limit a; b! 1 for a xed value b a, we recover the result for the geometry of two parallel Robin plates on the M inkow ski background. The vacuum forces acting on boundaries are considered in section 4. These forces contain two terms. The rst ones are the forces acting on a single surface then the second boundary is absent. Due to the well-known surface divergences in the VEVs of the energy-m om entum tensor these forces are in nite and need an additional regularization with further renorm alization. The another terms in the vacuum forces are nite and are induced by the presence of the second boundary. They correspond to the interaction forces between the boundaries and are determined by formula (44) or equivalently by formula (47). For the Dirichlet and Neumann scalars these forces are always attractive and they are repulsive for the mixed D irichlet-N eum ann case. In the case of general R obin scalar the interaction forces can be both attractive or repulsive in dependence of the coe cients in the boundary conditions and the distance between the boundaries. As an illustration, in qure 2 we present an example when the interaction forces are repulsive for small distances and are attractive for large distances. This provides a possibility for the stabilization of the radii by vacuum forces. However, it should be noted that for the reliable predictions regarding quantum stabilization, the renorm alized single shell parts also should be taken into account. In section 5 we consider the total vacuum energy in the region between the cylindrical surfaces, evaluated as the sum of the zero-point energies for elementary oscillators. It is argued that this energy di ers from the energy, obtained by the integration of the volum e energy density over the region between the boundaries. We show that this di erence is due to the presence of the surface energy located on the bounding surfaces. Further for the evaluation of the total and surface energies we use the zeta function technique. They are presented as the sum of single boundary and interaction parts. The latter are given by form ula (61) for the total vacuum energy and by form ula (75) for the surface energy and are nite for all nonzero values of the intersurface separation. In the total vacuum energy single boundary parts dom inate for sm all values of the ratio a=b and the interaction part is dom inant for a=b . 1. For an arbitrary num ber of spatial dimensions and independent on the value of the mass, the interaction part of the vacuum energy is negative for D irichlet or N eum ann boundary conditions and is positive for D irichlet boundary condition on one shell and Neum ann boundary condition on the another. Further, we have shown that the induced vacuum densities and vacuum e ective pressures on the cylindrical surfaces satisfy the energy balance equation (77) with the inclusion of the surface terms, which can also be written in the form (79).
