A strongly perturbed quantum system is a sem iclassical system

We show that a strongly perturbed quantum system, being a sem iclassical system characterized by the W igner-K inkwood expansion for the propagator, has the same expansion for the eigenvalues as for the W KB series. The perturbation series is rederived by the duality principle in perturbation theory.

Recently we proposed a strongly coupled quantum eld theory [1]. This approach is based on the duality principle in perturbation theory as exposed in [2] and applied in quantum mechanics. In this latter paper we showed that the dual perturbation series to the D yson series, that applies to weak perturbations, is obtained through the adiabatic expansion when reinterpreted as done in [3]. This expansion grants a strong coupling expansion having a developm ent parameter form ally being the inverse of the parameter of the D yson series and then holding just in the opposite lim it of the perturbation going to in nity.

Due to the relevance of this approach for quantum eld theory, it is of param ount in portance to show how this method is able to perform with an anharm onic oscillator as this example has been set as a fundam ental playground by Bender and W u [4] in their pioneering works. Besides, it would be helpful to trace the way the eigenvalues are obtained in this case in view of methods, as the one of Janke and K leinert [5], providing excellent com putational tools to this aim s.

Indeed, in this paper we show that our method provides a sound solution to the strong coupling computation of the ground state energy of the anham onic oscillator, being this given by the well known sem iclassical series for the eigenvalues in the W KB approximation. The relevance of the result relies on the fact that we obtain this result from the W igner-K irkwood (W K) expansion that our method yields. This provides an important conceptual result as, besides showing that the two approaches W KB and W K are equivalent in the strong coupling limit, we will be able to rederive the fact that [6] a strongly perturbed quantum system is a sem iclassical system from the duality principle in perturbation theory granting in this way the soundness of the approach. This fact may be interesting e.g. in the problem of the measure in quantum mechanics as we already pointed out in [7, 8] for QED.

The result is obtained by exploiting the link between the W igner-K inkwood expansion and the Thom as-Ferm i approximation [9]. So, one has that a sem iclassical approximation relies at the foundation of a many-body approach and is equivalent to the W KB approximation in the strong coupling limit giving the same results for the eigenvalues. Indeed, the Thom as-Ferm i approximation is a sem iclassical approximation too and this fact is well-known having been proved by Lieb and Sim on [10, 11]. The interesting aspect here is that such a many-body approach gives back the Bohr-Sommerfeld quantization rule and we obtain also the higher order corrections.

In order to start our proof, we consider the simple case of a free particle undergoing the e ect of a perturbation V(x) in a one dimensional setting. So, the Schrödinger equation for the propagator U can be written down as

being an ordering parameter and $U(t_0;t_0) = I$. The Dyson series for the propagator can straightforwardly be obtained when the lim it ! 0 is considered giving back the well known solution series

being U_0 the solution of the equation

given by

We recognize the interaction picture working here. At this point it is interesting to note that the choice of a perturbation is completely arbitrary and one may ask what meaning could be attached to a series, with = 1, where we take $\frac{h^2}{2m}\frac{\theta^2}{\theta x^2}$ instead of V (x) as a perturbation giving the series

being now K $_{0}$ the solution of the equation

The answer can be immediately obtained when, after reinserting the ordering parameter , we recognize that with a rescaling of time t ! t and taking the series

we recover the series (5) that is a strong coupling expansion. Setting = twe can write it as

We easily recognize that this series is dual to the D yson series in the sense of Ref.[2] having a developm ent parameter that is form ally the inverse with respect to that of the D yson series. For this reason we call this dual representation the free picture. This series is the 1+0 dimensional solution of the quantum eld theory we presented in Ref.[1] and our aim is to get from this the ground state energy showing that, in this case, we are working with a sem iclassical expansion.

For our aim s, we need to exploit this strong coupling series to unveil its nature. We already see from the leading order solution (7) that it coincides with the leading order of the well-known sem iclassical W igner-K inkwood series [5, 9, 12] as should be expected [6]. We need to prove this also for higher orders. Indeed, the computation is straightforward and gives, at least for the rst correction,

that is what one should expect for the W K expansion. So, we have obtained the sem iclassicalW igner-K inkwodd series out of a dual strong coupling expansion for a quantum mechanical system by the duality principle in perturbation theory. This in turn means, as already known [6], that a strongly perturbed quantum system is a sem iclassical system. This is in agreement with the fact that a large mass expansion in quantum mechanics gives rise to a W K expansion out of the W K B expansion [13]. We just point out that a wide application of the W K expansion is seen in statistical mechanics [12] and in this case is obtained with the standard substitution t ! in that we will use in the follow ing.

The W K series appears rather singular depending on ascending power of and having terms proportional to gradients of the potential making the dependence on anom abus at best for such an expansion. But as we will se below, the series for the ground state energy is well de ned and in agreem ent with the corresponding expression for a

W KB series in spite of the very singular nature of this expansion. This is easy to prove using techniques of m any-body physics that will perm it us to show that the leading order of the W K expansion is the well known Thom as Ferm i approximation.

The next step is to recognize that we can resum all the term s with $p^2=2m$ giving nally, after projecting on the momentum eigenstates with a W igner transform ation of the propagator,

The density matrix can be obtained by inverse Laplace transforming the series (11) divided by [9], that is

with c > 0, giving the expression

and the leading order is just the Thom as Ferm i approximation. This series has not a clear dependence on but this is a strong coupling series that has meaning in the sense of distributions.

W e now impose the norm alization condition

being n = 0;1;2;:::, and this gives the W KB energy levels and their higher orders corrections as we will see in a while. Indeed, we can substitute eq.(14) into the above norm alization condition giving the series [14]

being x_{T1} and x_{T2} the solutions of the equation E = V(x) that determ ine the region where the integral is meaningful. Use has been made of the fact that $e_x V p^0 E = \frac{p^2}{2m} V(x)$ dpdx = 0. We recognize here the WKB quantization condition and its higher order corrections as promised.

Our aim now is to apply the above expansion to the computation of the ground state energy of a pure quartic oscillator $H = p^2 = 2m + x^4 = 4$. From [5] we know that at the leading order one should have $E = 0.667986259155777 ::: (=4)^{\frac{1}{3}}$. We know also from [14] that this value can be obtained by pushing the series (16) to the higher orders. In order to have an idea of what we get, for our example we get the series

being K and E the elliptic integrals of rst and second kind respectively, and $\vec{E}_n = E_n = (=4)^{\frac{1}{3}}$. The num erical

solution is rather satisfactory as we get from the Bohr-Sommerfeld term that $E'_0 = 0.5462673253$ that, as is well known, has an error of about 20%, while with the rst order correction one has $E'_0 = 0.7496932075$ that in proves to 10% already at this order. But, as already shown in [14], we know that the sem iclassical approach is able to produce the exact value by going to higher orders.

So, we can conclude that the W igner-K inkwood series produces eigenvalues through the Bohr-Som m erfeld rule and its higher order corrections. Besides, our result has been obtained by considering the duality principle in perturbation theory and applying it to the D yson series rederiving by this means the equivalence between strong coupling perturbation theory and sem iclassical expansion, making sound the main result of this paper.
