# E ective $W$ ess-Zum ino-W itten A ction for Edge States of Q uantum $H$ all System $s$ on B ergm an Ball

A bstract
Using a group theory approach, we investigate the basic features of the Landau problem on the Bergm an ball ${ }^{k}$. This can be done by considering a system of particles living on $B^{k}$ in the presence of an uniform $m$ agnetic eld $B$ and realizing the ball as the coset space $S U(k ; 1)=U(k)$. In quantizing the theory on $B^{k}$, we de ne the wavefunctions as the $W$ igner $D$-functions satisfying a set of suitable constraints. The corresponding $H$ am ittonian is $m$ apped in term $s$ of the right translation generators. In the lowest Landau level, we obtain the wavefunctions as the $S U(k ; 1)$ coherent states. This are used to de ne the star product, density $m$ atrix and excitation potential in higher dim ensions. $W$ ith these ingredients, we construct a generalized e ective $W$ ess-Zum ino-w itten action for the edge states and discuss their nature.

## 1 Introduction and m otivations

Very recently, the quantum H all e ect (Q HE) [1] in higher dim ensional spaces has attracted much attention [2,5]. The interest on this topic is mainly motivated by its well-known signi cance to the condensed $m$ atter physics [2]. A lso its relationships to other theories like non-com $m$ utative geom etry and string theory. In fact, a relation betw een $Q H E$ on the complex projective spaces C $P^{k}$ [3] and the fuzzy spaces [4] is established. M oreover, the string theory is realized in term s of the Q H E ingredients in higher dim ensions [6]

The rst results on the sub ject have been reported by Zhang and Hu [2] in analyzing Q HE on four-sphere $S^{4}$ subm itted to the $S U$ (2) background eld. This analysis is m otivated by the fact that the edge excitations $m$ ight provide an approach to a quantum form ulation of graviton in fourdim ension. Q HE in higher dim ensions inherent many properties of its two-dim ension counterpart. In the conventionalQ HE a droplet of ferm ions, occupying a certain volum e, behaves as an incom pressible uid. T he low -energy excitations being area-preserving deform ations and behave as massless chiral bosons $[13,14]$ described by an e ective $W$ ess-Zum ino-N itten (W ZW ) action in ( $1+1$ )-dim ensions.

The derivation of the e ective action for the edge states for any quantum $H$ all droplet can be perform ed according to the $m$ ethod used by Sakita [12] in tw o-dim ension Euclidean space and generalized to $C P^{k}$ by $K$ arabali and $N$ air [3]. Two ingredients are necessary to perform this derivation : (i) a density of states which must be constant over the phase volum e occupied by the droplet and (ii) the com mutators between operators tend, in a suitable lim it (strong $m$ agnetic eld), to Poisson brackets associated to the considered m anifold. M ore precisely, K arabali and N air [3], in considering Q HE on C $P^{k}$, gave the energy and the Landau w avefunctions using a purely group theory approach. Furtherm ore, they have show $n$, in an elegant way, that for a strong magnetic eld, the quantum system is described by a constant density of states over the phase space. T hey have derived the e ective action of excitations on the C $P^{k}$ boundaries. The obtained action is a generalized W ZW action that describes the bosonized theory of ferm ions in ( $1+1$ )-dim ensions [12]. O urm otivation is based on [3] and the analytic $m$ ethod used by one [9] of the present authors to dealw th QHE on the Bergm an ball ${ }^{k}$.

W e algebraically investigate a system of particles living on the $m$ anifold $B^{k}$ in the presence of an uniform $m$ agnetic eld $B$. A fter realizing $B^{k}$ as the coset space $S U(k ; 1)=U(1)$, we construct the wavefunctions as the $W$ igner $D$-fiunctions verifying a set of suitable constraints. The corresponding Ham iltonian $H$ can be written in term $S$ of the $S U(k ; 1)$ generators. This will be used to de ne $H$ as a second order di erential operator in the com plex coordinates, which coincides w ith the M aass Laplacian [7] on the Bergm an ball. To get the energy levels, we use the correspondence betw een the Landau problem on twomanifolds C $P^{k}$ and $B^{k}$. W e introduce an excitation potential to rem ove the degeneracy of the ground state. For this, we consider a potential expressed in term $S$ of the $S U(k ; 1)$ left actions. For a strong $m$ agnetic eld, we show that the excitations of the lowest landau level (LLL) are govemed by a generalized e ective $W$ ess-Zum ino-w itten (W ZW ) action. It tum out that this action for $k=1$, i.e. disc, coincides $w$ ith one-chiralbosonic action for Q HE at the lling factor
$=1[13,14]$. W e nally discuss the nature of the edge excitations and in particular show that the eld describing the edge excitations on the disc $B^{1}$ is a supenposition of oscillating on the boundary $S^{1}$ of the quantum H all droplet.

The present paper is organized as follows. In section 2 , we present a group theory approach to analysis the Landau problem on the Bergm an ball. W e build the wavefunctions and give the corresponding $H$ am iltonian as well as its energy levels. In section 3, we restrict our attention to LLL to write down the corresponding star product and de ning the relevant density matrix. A lso we consider the excitation potential and get the associate sym bol to exam ine the excited states. W e determ ine the generalized e ective W ZW action for the edge states for a strong magnetic eld as well as discuss their nature and give the disc as exam ple, in section 4. We conclude and give som e perspectives in the last section.

## 2 Q uantization and H ilbert space

$W$ e start by de ning the Bergm an ball $B^{k}$, which is realized as the coset spaces $S U(k ; 1)=U(k)$. In analyzing the $B^{k}$ geom etry, we derive the $U(1)$ gauge potential generating an uniform $m$ agnetic eld. In quantizing the theory, we get w avefunctions as the $W$ igner D -fiunctions sub jected to a suitable set of constraints. Im posing the polarization condition, we obtain the LLL w avefiunctions. The latter tum out to be the $S U(k ; 1)$ coherent states constructed from the highest weight state of the com pletely sym $m$ etric representation.

### 2.1 Introducing the $m$ anifold $B^{k}$

The $k$-dim ensional com plex ballofunit radius is de ned via $(k+1)$ hom ogeneous com plex coordinates u ( = 1;2; ;k+1) satisfying

To m ake contact w th the group theory, we note that the $m$ anifold $B^{k}$ can be view ed as the coset space $S U(k ; 1)=U(k)$. This provides us w ith the algebraic tools to dealw ith Q HE on the Bergm an ball ${ }^{k}$.

Let be $g$ the $(k+1)(k+1) m$ atrices of a fiundam ental representation of the group $S U(k ; 1)$, with g 2 SU (k;1). They obey the relations

This form ula agrees with (10) because it is easy to see that! = d . N ote that, (20) will play an im portant role in quantizing the theory describing a system living on the $m$ anifold $B{ }^{k}$. Indeed, as we are interested to analysis Q HE on the higher dim ensionalball, it is necessary to identify the m agnetic eld behind this phenom ena. This eld is proportional to the $K$ ahler two-form (10) and since! is closed, the components of the $m$ agnetic eld expressed in term $s$ of the fram e elds de ned by the $m$ etric are constants.

### 2.2 Q uantization

A basis of functions on $S U(k ; 1)$ is given by the $W$ igner D-functions

The Hilbert space corresponding to the quantum system living on the $m$ anifold $B{ }^{k}$ can be deter$m$ ined by reducing the degrees of freedom of the system on $S U(k ; 1)$ to the coset space $S U(k ; 1)=U(k)$. $T$ his reduction can be realized by im posing a set of suitable constraints. To nd the constraints arising in the quantization of the theory, let us consider the $U(1)$ gauge eld, i.e. the vector potential associated to the eld strength $F$, as

Because of this, in the decom position of $S U(k+1)$ irreducible representations into $S U(k)$ ones, we should consider the representations satisfying (29-30).

It is im portant to note that, (29-31) are sim ilar to those obtained by K arabali and N air [3] by considering the quantization of the com plex projective spaces C $P^{k}=S U(k+1)=U(k)$. C onsequently, we apply the representation theory analysis developed in [3] to the ball $\mathrm{B}^{k}$ case. T his can be done by using the standard procedure associating a com pact group with his non-com pact analogue. We w ill retum to this $m$ atter in deriving the spectrum of the system.

### 2.3 Low est Landau levels

To nd the low est Landau levels, we should require the condition

T he answer can be given by de ning the relevant H am iltonian that describes the quantum system living on the ball $\mathrm{B}^{\mathrm{k}}$.

## 3 H am iltonian and spectrum

A fter quantizing the theory, we have obtained the wavefunctions of the quantum system on $\mathrm{B}^{\mathrm{k}}$. The derivation of the energy eigenvalues of the H am iltonian (64) is based on the correspondence between the Landau problem on two manifolds C $P^{k}$ and $B^{k}$. Indeed, as we claim ed before, the constraints (29-30) together w th the relation (31) are sim ilar to those obtained in analyzing the Landau system on C $P^{k}$ [3]. ## 4 Low est Landau level analysis

Restricting to LLL, described by thew avefunctions LLL given in (44) offiundam entalenergy $\mathrm{E}_{0}=\frac{\mathrm{nk}}{2}$, we develop som e tools needed in studying the edge excitations of the quantum H all droplets on $\mathrm{B}^{\mathrm{k}}$. T hese concem the star product, density of states and excitation potential.

## 5 Edge excitations and generalized W ZW action

W e now derive the e ective $W$ ess-Zum ino-W ilten action for the edge states. The derivation is based on the LLL analysis given in the previous section. A smentioned above, the dynam ical inform ation, related to degrees of freedom of the edge states, is contained in the unitary operator $U$.

### 5.1 W ZW A ction

The action, describing the edge excitations in the $H$ artree Fock approxim ation, can be writing as [12]

$T$ his action involves only the tim e derivative of and the tangential derivative $L$. It is sim ilar to that derived by $K$ arabali and $N$ air [3] on $C P^{k}$. (128) show $s$ that how a generalized chiral abelian W ZW theory can be constructed on the Bergm an ball ${ }^{k}$. For $k=1$, we recover the $W$ ZW action for the edge states of hyperbolic quantum H all system s [10].

### 5.2 N ature of excitations

It w ill be interesting to investigate the nature of edge states. Indeed, from (128), the equation of $m$ otion of the eld is given by

where the coe cients a pq are tim e-independent. This shows that the eld is a superposition of oscillating $m$ odes on the boundary $S^{1}$ of the quantum $H$ all droplet.

C onclusion
By considering a system ofparticles living on the B ergm an ballB ${ }^{k}$ in the presence ofa $U$ (1) badkground eld, we have algebraically investigated Q HE.Thiswasbased on the fact that ${ }^{k}$ can be view ed as the coset space $S U(k ; 1)=U(1)$. This was used to get w avefiunctions as the $W$ igner $D$-fiunctions subm itted to a set of suitable constraints. A lso to $m$ ap the corresponding $H$ am iltonian in term $s$ of the $S U(k ; 1)$ right generators. This latter is showed to coincide $w$ ith the generalized $M$ aass Lapalacian in the com plex coordinates. The Landau levels on $B^{k}$ are obtained by using the correspondence of two $m$ anifolds C $P^{k}$ and $B^{k}$. M ore precisely, we have used a m apping betw een the $S U(k ; 1)$ and $S U(k+1)$ generators. In the lowest Landau levels (LLL), the obtained wavefunctions were nothing but the SU (k;1) coherent states.

Restricting to LLL, w e have derived a generalized e ective W ZW action that describes the quantum $H$ all droplet of radius proportional to $\bar{M} \bar{M}$, with $M$ is the num ber of particles in LLL. In order to obtain the boundary excitation action, we have de ned the star product and the density of states. A lso we have introduced the perturbation potential responsible of the degeneracy lifting in term $s$ of the $m$ agnetic translations of $S U(k ; 1)$. Finally, we have discussed the nature of the edge excitations and illustrated this discussion by giving the disc as exam ple.

The present analysis gives an idea how to deal with QHE on higher dim ensional non-com pact spaces, i.e. the B ergm an ball ${ }^{k}$. It w ill be interesting to apply the obtained results in order to deal w ith other issues [16].
