# A nalytic Solutions for Tachyon C ondensation w ith General Projectors

## A bstract

The tachyon vacuum solution of Schnabl is based on the wedge states, which close under the star product and interpolate between the identity state and the sliver projector. W e use reparam eterizations to solve the long-standing problem of nding an analogous fam ily of states for arbitrary projectors and to construct analytic solutions based on them. The solutions sim plify for special pro jectors and allow explicit caloulations in the level expansion. W e test the solutions in detail for a one-param eter fam ily of special pro jectors that includes the sliver and the butter $y$. Reparam eterizations further allow a one-param eter deform ation of the solution for a given projector, and in a certain lim it the solution takes the form of an operator insertion on the projector. W e discuss im plications of our work for vacuum string eld theory.

## 1 Introduction

The rst analytic solution ofopen string eld theory (O SF T) [1], corresponding to condensation of the open string tachyon, was recently constructed by Schnabl [2] and further studied in
$[3,4,[5,6,[7,8]$. The starting point of [2] is a clever gauge- xing condition, which $m$ akes the in nite system of equations ofm otion am enable to a recursive analysis. Schnabl's gauge choice for the open string eld is

The sliver state $W_{1}$ is a nontrivial pro jector of the open string star algebra, i.e., a string eld di erent from the identity that squares to itself [9, 10, [11, [12]. The wedge states $W$ w ith 0 are a fam ily of states which interpolate between the sliver $W_{1}$ and the identity $W_{0} \quad I$, and they obey the abelian relation:

Schnabl's solution is constructed in term s of a state , with 0 , which is the wedge state W +1 W ith suitable operator insertions. O ne de nes the derivative state

A simple description of the states was presented in [3] using the CFT form ulation of SFT [13].

W hile the sliver was historically the rst exam ple of a projector, it was soon realized that in nitely $m$ any pro jectors exist [14]. Let us restrict attention to the subset of string elds known as surface states. A surface state is speci ed by a local coordinate $m$ ap $z=f()$ from the canonical half-disk $D^{+} f \quad j=0 ; j j 1 g$ to a region in the upper-halfplane (UHP) H $\quad f z j=z \quad 0 g$. The surface state $\mathrm{j} i \mathrm{i}$ is de ned by its inner product

[^0]$w$ ith any state in the Fock space. The condition that fit is a projector is $f(i)=1$ [14], nam ely, the local coordinate curve goes to the boundary of $H$ at the open string $m$ idpoint
= i. (I hroughout this paper, we w ill restrict our considerations to \single-split" pro jectors, i.e., surface states whose coordinate curve goes to in nity only at the open string m idpoint.) The associated open string functional f 区 ( ) ] is split, nam ely, it is the product of functionalofthe left halfofthe string tim es a functionalofthe right halfofthe string, $f \mathbb{X}]=\underset{f}{L}\left(X_{L}\right) \underset{f}{R}\left(X_{R}\right)$. In the half-string form alism of O SF T [15, 16], where string elds are regarded as operators acting on the space of half-string functionals, surface state pro jectors are interpreted as rankone pro jectors [14]. From this view point, all surface state pro jectors should be equivalent. This is the intuition provided by nite dim ensional vector spaces, where all rank-one pro jectors are related by sim ilarity transform ations.

These observations raise the natural question of whether Schnabl's solution, based on the sliver projector, can be generalized to solutions based on a generic surface state projector. In this paper we nd that this is indeed the case. We also nd, however, that the solution technically simpli es for the subclass of special pro jectors [5], which includes the sliver as its canonical representative. W hile we give a geom etric description of the solution associated w ith a general pro jector, w ith the technology currently available we are able to evaluate its explicit Fock space expansion only when the projector is special.

It is usefulat this point to recallsom e facts about specialpro jectors [5]. The cnucialalgebraic property of a special pro jector is that the zero $m$ ode $L_{0}$ of the energy $m$ om entum tensor in the fram e of the projecto $\sqrt[3]{3}$,

The sliver is a special pro jector with $s=1$ and the butter $y$ is a special projector $w$ ith $s=2$. The sliver and the butter y $t$ into an in nite \hypergeom etric" collection of special pro jectors | one projector $\mathrm{P}_{1}{ }^{(s)}$ for each real s 1 | which was brie $y$ described in [5]. W e believe that the hypergeom etric collection contains all the single-split special pro jectors. For special pro jectors, we shall use the notations

For any special pro jector $P_{1}$ a fam ily of states $P$ with $\quad 0$ analogous to the wedge state fam ily of the sliver is described by the follow ing sim ple expression:

The states in the fam ily interpolate between the projector $P_{1}$ and the identity $P_{0} \quad I$, and they obey the relation:

W e are now in the position to outline our strategy. O ur starting point is the fact that all single-split, tw ist-invariant projectors can be related to one another by a reparam eterization of the open string coordinate. Reparam eterizations are generated in nitesim ally by the staralgebra derivations $K_{n}=L_{n} \quad()^{n} L_{n}$ and are fam iliar gauge sym m etries of OSFT [17, 18]. $G$ iven a generic projector $P_{1}$, there exists a nite reparam eterization that relates it to the sliver, form ally im plem ented by an operator $e^{H}$, w ith $H$ a linear com bination of $K_{n}$ 's:

By construction, $P_{1}$ is gauge equivalent to $W_{1}$. The idea of using reparam eterizations as a solution-generating technique was already noted in [3]. The solution $P_{1}$ will take the form (1.5) , w th the replacem ent of all the elem ents associated $w$ ith the sliver by the corresponding elem ents associated w th $P_{1}$. In particular, we can de ne an abelian fam ily of states interpolating between the identity and a generic projector $P_{1}$ sim ply by taking $P \quad e^{H} W$. If we w rite

The operators $L$ and $L^{?}$ are BPZ conjugates of each other since $H^{?}=H$, and they obey the canonical algebra (1.10). If the pro jector $P_{1}$ is special, the de nition (1.18) tums out to coincide w ith (1.9), but for general pro jectors the operator $L$ is not proportional to $L_{0}$.

It is in practice prohibitively di cult to determ ine the operator $H$. The construction, while motivated by the above considerations, $m$ ust be realized di erently. The $m$ ain result of this paper is to give a geom etric description of the reparam eterization procedure and a concrete im plem entation using the CFT language ofO SF T. In particularwe provide a geom etric description for the fam ily of intenpolating states $P$ associated $w$ ith an arbitrary pro jector that $m$ akes the abelian relation (1.12) obvious.

The description sim pli es further for the case of a specialpro jector. It should be em phasized that the geom etrical construction of the fam ily of states has been a long-standing question | there have been several attem pts for the butter $y$. In this paper we nd out that the answer is quite simple if one uses the conform al fram e of the pro jector itself.

It is rem arkable that pro jectors play a centralrole in the construction of the analytic tachyon solution. P rojectors have been intensively studied in the context of vacuum string eld theory (V.SFT) [19, 20]. In its sim plest incamation, VSFT is the con jecture that the OSFT action expanded around the tachyon vacuum has a kinetic operator $Q$ of the form [20]:

Taking a m atter/ghost factorized ansatz for classical solutions, $=\mathrm{g} \quad \mathrm{m}$, the VSFT equations of $m$ otion reduce to projector equations for the $m$ atter part $m$. VSFT correctly describes the classical dynam ics of $D$-branes [11, [12, 21], but it is som ew hat singular. For exam ple, the overallconstant in front of the V SF T action $m$ ust be taken to be form ally in nite. It is believed that V SF T arises from O SF T , expanded around the tachyon vacuum , by a singular eld rede nition. M oreover, the operator (1.19) is expected to be the leading term of a m ore com plicated kinetic operator that involves the $m$ atter energy-m om entum tensor as well, as discussed in more detail in [22]. O ne speci c exam ple of such a eld rede nition given in [20] was the reparam eterization that $m$ aps wedge states to one another, which in a singular lim it form ally m aps all wedge states to the sliver. Interestingly, this reparam eterization em erges naturally in the context of this paper. Indeed, it tums out that for each pro jector $\mathrm{P}_{1}$ there is a reparam eterization that leaves the pro jector invariant but $m$ aps the states in the interpolating fam ily to one another. It takes $P$ to $P_{e^{2}}$,where is an arbitrary realnumber. Ifwe im plem ent
this reparam eterization on the sliver-based solution and take the large lim it, allwedge states approach the sliver and the solution takes the form of an operator insertion on the sliver. A closely related approach in constructing a solution in a series expansion was proposed som e tim e ago in [23] and investigated further in [24]. It would be interesting to nd a system atic way to derive the kinetic operator ofV SF T starting from a suitably reparam eterized version of the tachyon vacuum solution.

W e begin in section 2 w ith a general introduction to reparam eterizations. A fter review ing basic de nitions and algebraic properties, we explain why any tw o regulartw ist-invariant surface states can be related by a reparam eterization. The geom etrical reason is sim ple. A surface state can be de ned by what we call the reduced surface: it is the surface $H$ for the inner product in (1.6) m inus the local coordinate patch. In this picture the open string is a param eterized boundary curve created by rem oving the patch. The two string endpoints and the string $m$ idpoint de ne three special points on the boundary of the reduced surface. $G$ iven two surface states, the $R$ iem ann $m$ apping theorem ensures that there is a conform al $m$ ap between the reduced surfaces that $m$ aps the tw o endpoints and the $m$ idpoint of one string into those of the other. This map de nes a relationship between the param eterizations of the two open strings; this is the induced reparam eterization. W hen the surface state is a projector, the reduced surface is split in two at the point where the open string $m$ idpoint reaches the boundary of the fiull surface. W hen we $m$ ap the reduced surfaces of two projectors to each other, each of the split surfaces of one reduced surface is m apped to a split surface of the other reduced surface. Since each split surface has only two special points (a string m idpoint and a string endpoint), the conform alm ap has a one-param eter am biguity 4

In section 3 we use the above insights to give the geom etric construction of the abelian fam ily P associated w th a generic pro jector. In fact, once we choose a m ap R that relates the sliver to the chosen pro jector, the surface states $P$ are obtained from the wedge states by a reparam eterization naturally induced by $R$. This construction represents the surface states $P$ using the conform al fram e of the pro jector: the local coordinate patch is that of the pro jector but the surface only covers part of the U H P. T he geom etric description of the surface states P simpli es in this conform al fram e| a fact that was $m$ issed in the earlier attem pts to describe them. In x3 2 we specialize to special projectors, for which we nd rem arkable sim pli cation. $T$ he reparam eterization $m$ ap that relates the sliver to the specialpro jector in the hypergeom etric collection $w$ th the param eter $s$ can be chosen to be sim ply $R(z)=z^{s}$, where $z$ is the coordinate in the UHP. For any xed s, the regions of the UHP needed to represent states $P$ w ith di erent

[^2]values of are related to one another by rescaling. This is related to the fact that for special pro jectors the operator $L$ de ned in (1.18) is proportional to $L_{0}$, which is the dilation operator in the conform al fram e of the pro jector.

In section 4 we begin by discussing the algebraic fram ew ork of the tachyon vacuum solution. W e then present ourm ain result, the CFT construction of the solution using reparam eterizations. W e also present a detailed analysis of various operator insertions in the CFT description and derive usefiul form ulas. In section 5 we use the operator form alism to derive an expression for the solutions associated w th special projectors. The solution is written as a sequence of norm al-ordered operators acting on the vacuum and can be readily expanded in level. O ur expression has two param eters, s 2 [1;1) labeling the special projectors and 2 ( 1 ;1) labeling the reparam eterizations of the solution that leave the pro jector invariant.

In section 6 we give the level expansion of the solutions for special pro jectors up to level four. W e rst set $=0$ and exam ine the dependence of the energy on s to level zero, two, and four. $W e$ nd that as the level is increased the energy density approaches the expected value that cancels the D forane tension. The solutions constructed by our m ethod can be written in term s of even $-m$ oded total $V$ irasoro operators and even $-m$ oded antighost operators in addition to the $m$ odes of $c$ ghost. $T$ his structure im poses additional constraints, and thus the solutions belong to a resticted sector of the universal subspace of the CFT. W e then exam ine the m ost accurate expression for the solution in the Siegel gauge com puted in [25] and nd evidence that it does not belong to the restricted universal subspace at level four. W e thus conclude that the solution in the Siegel gauge cannot be obtained by our construction. In x6.4 we exam ine the solution for a xed value of $s$ and in the lim it as becom es large. The leading term in the solution takes the form of an insertion of the c ghost in $P$ multiplied by $e^{2=s}$ and by a nite, calculable coe cient. W e o er som e concluding rem arks in section 7.

## 2 R eparam eterizations

In this section we describe som e general facts about reparam eterizations. The rst three subsectionsare fora review ofwell-knownmaterial. In $x 2.1$ we de ne the notion ofm idpoint-preserving reparam eterization' of the open string coordinate, $t$ ! $t^{0}=^{\prime}(t)$, with $t=e^{i}$. Corresponding to ' there is an operator $U$, acting on the space ofstring elds that obeys a num ber ofalgebraic properties, as explained in x2 2. The transform ation ! $U$, is a gauge transform ation of OSFT w ith a vanishing inhom ogeneous term, as we review in $x 23$. Finally, in x 2.4 we explain the key idea: any two regular tw ist-invariant surface states can be related to one another by a unique reparam eterization. For surface states that correspond to single-split pro jectors, an
interesting and usefiulam biguity arises.
In the rest of the paper we shalluse these facts to nd solutions of SF T corresponding to a generalpro jector, starting from Schnabl's solution corresponding to the sliver. By construction, all these solutions will be gauge equivalent.

### 2.1 Denitions

Let us start by recalling the de nition ofm idpoint-preserving reparam eterizations (henceforth, sim ply reparam eterizations) [17]. A reparam eterization of the open string coordinate is a m ap ! ${ }^{0}=()$ (w th $\left.;{ }^{0} 2[0 ; ~]\right)$ that obeys

$N$ ote that this is a much stronger condition on than just xing the midpoint $=2$ : it im plies that points at equal param eter distance from the $m$ idpoint rem ain at equal param eter distance after the $m$ ap. $W$ e will use the coordinate $t \quad \exp (i)$ de ned on the unit sem icircle in the upper half plane. It follows from (2.1) that a map $t!t^{0}={ }^{\prime}(t)$ (with $\mathrm{fj}=\mathrm{t}^{0} \mathrm{j}=1$, <t $\left.0 ;<t^{0} \quad 0\right)$ is a reparam eterization if

A nite reparam eterization ' ( $t$ ) can be obtained by exponentiation of a vector $v(t)$ of the form (2.5):

Indeed, the condition (2.4) implies that' (t) satis es (2.2). M oreover, (2.6) im plies that' ( $t$ ) has unit norm. In general' ( $($ ) is de ned only on the unit sem icircle with $\mathrm{jj}=1$ and cannot be extended to a holom onphic function inside the localcoordinate half-disk $\mathrm{D}^{+}$. If v is a nite linear com bination of $\mathrm{v}_{\mathrm{K}_{\mathrm{n}}}$ vectors,' ( t ) can be extended to a nite annulus in the upper-half plane H containing the unit sem icircle.

### 2.2 The operator $U$,

$W$ e now consider the operator $U$, that im plem ents a nite reparam eterization. The operator is de ned to act on any operator $O$ ( $t$ ) in the CFT as

$T$ his is the sam e relation one has for operators that realize the conform alm aps used for surface states, the di erence being that here the action on O is only de ned for $\mathrm{Jj}=1$ and typically does not extend to the origin. We write

The properties (2.14) \{ (2.17) can also be understood from the view point of OSFT w thout reference to the operator $H$. For exam ple, since points at equal param eter distance from the $m$ idpoint rem ain at equal param eter distance after reparam eterizations, (2.17) follow $s$ at once from the picture of the star product as gluing of half open string functionals. Sim ilarly, (2.16) follow S , at least form ally, from the understanding of the identity string eld as the functional that identi es the left and the the right halves of the open string. In [5] it was found that the property (220) m ay fail to hold for certain singular BPZ odd operators H. The nite reparam eterizations that we explicitly consider in this paper appear to be perfectly sm ooth, and we believe that they obey all the form alproperties (2.14) \{ (2.17) . Follow ing the discussion of [5], we note that a regular $H$ should adm it a left/right decom position $H=H_{L}+H_{R}$ that is non-anom alous:

### 2.4 R eparam eterizations of surface states

W e now explain how reparam eterizations can be used to relate surface states. C onsider a tw istinvariant surface states fir, speci ed as usual by a local coordinate $m$ ap $z=f()$ from the canonical half-disk $D^{+}$to a region in the upper half plane $H$. (B oth $D^{+}$and $H$ are de ned above (1.6).) W e denote by $\mathrm{V}^{(f)}$ the reduced surface corresponding to the surface state $\mathcal{f} i$. $T$ he reduced surface is de ned as the com plem ent of the local coordinate half-disk in H :

It is vital for us to consider pro jectors, forw hich the coordinate curve does reach in nity at the open string $m$ idpoint: $f(i)=1$. If we assum $e$ that the $m$ idpoint is the only point forwhich $f(t)$ is in nite then the reduced surface $V^{(f)}$ splits into two disks $V^{(f)}$ and $V^{(f)+}$, with $<z<0$ and $<z>0$, respectively, joined at the point at in nity. The claim (2.36) still holds in this case: any two such tw ist-invariant projectors jfi and jgi can be related by a reparam eterization '. We de ne the $m$ ap $\mathbb{R}^{\text {for }} V^{(f)+}$ and, as before, we extend it to $V^{(f)}$. A gain, the $m$ ap $\mathbb{R}^{(f)} V^{(f)+}!V^{(g)+}$, is guaranteed to exist by the $R$ iem ann $m$ apping theorem, but this tim $e$ it is not unique. W hile before $f$ (i) and 1 provided two di erent points whose $m$ aps could be constrained, now they are the sam e one. $W$ e partially $x$ the $S L(2 ; R)$ sym $m$ etry by requiring that $f(1)$ and $f(i)=1$ are $m$ apped to $g(1)$ and $g(i)=1$, respectively. There is one degree of freedom left un xed, so there exists a one param eter fam ily of analytic $m$ aps from $V^{(f)+}$ to $V^{(g)+}$. This redundancy willplay an im portant role in the follow ing.

Finally, we note that we can never hope to relate regular surface states to pro jectors using reparam eterizations, since the topologies of the reduced surfaces $V^{(f)}$ are di erent in the two classes.

## 3 A belian fam ilies for gen eral projectors

The basic building block of Schnabl's solution is the state, which is constructed from the wedge state $\mathrm{W}+1$ by adding suitable operator insertions. In this section we generalize the wedge states $W$, associated $w$ th the sliver $W_{1}$, to states $P$ associated $w$ ith a generic tw ist-invariant pro jector $\mathrm{P}_{1}$. In the next section we shall deal w ith the operator insertions and construct the analog of the state for a generic pro jector.

A swe have explained in $x 2.4$, given a pro jector $P_{1}$, there exists a reparam eterization' that relates it to the sliver:

In x3.1 we give a geom etric construction of $P$ by determ ining the shape of the associated one-punctured disk $P$ in the presentation where the local coordinate patch is that of the projector $\mathrm{P}_{1}$. In x32 we focus on special projectors, for which the construction simpli es considerably and the reparam eterization to the sliver can be given in closed form. For a special pro jector the corresponding abelian fam ily obeys a rem arkable geom etric property: the surfaces $P$ w ith di erent values of are related to one another by overall conform al scaling.

### 3.1 A belian fam ilies by reparam eterizations

G iven a single-split, tw ist-invariant projector fif we wish to nd a reparam eterization that relates it to the sliver. In the notations of x 2.4 , we write the sliver as $\mathrm{fv}_{1} \mathrm{i} \quad \dot{g} \mathrm{i} w$ ith $z^{0}=g()=\underline{2} \arctan ()$ and look fora one-param eter fam ily ofconform alm apsR $: V^{(f)}!V^{(g)}$. From now on we shall drop the superscript in $V^{(£)}$ ! $V$, and we renam e the sliver's coordinate $z^{0}!z_{S}$ and the sliver's region $V^{(g)}$ ! $U$.

To describe the conform almaps ${ }^{\circledR}$ ( $z$ ) we need to de ne a set of curves and regions in the conform al plane. W e denote by $\mathrm{C}_{0}^{+}$and $\mathrm{C}_{0}$ the right and left parts, respectively, of the coordinate curve $\mathrm{C}_{0}$ of the projector fif. It is convenient to extend $\mathrm{C}_{0}^{+}$and $\mathrm{C}_{0}$ by complex

conjugation to curves on the full plane, $m$ aking the extended curves invariant under com plex con jugation. For tw ist invariance of the pro jectors, the curve $\mathrm{C}_{0}$ is determ ined by $\mathrm{C}_{0}^{+}: \mathrm{z}_{2} \mathrm{C}_{0}$ if $z_{2} \mathrm{C}_{0}^{+}$. The curve $\mathrm{C}_{0}$ is the m irror im age of $\mathrm{C}_{0}^{+}$across the im aginary axis. (See F igure 1 .)

Let $\mathrm{V}^{+}$denote the region of the z -plane to the right of $\mathrm{C}_{0}^{+}$and let V denote the region of the $z-p l a n e$ to the left of $C_{0}$. Since the coordinate curves reach the point at in nity, both $V^{+}$and $V$ are conform ally equivalent to the $U H P$, with the role of the real axis in the UHP played by the curves $C_{0}$. The union of $V^{+}$and $V$ is $V$, the surface of the pro jector $m$ inus its coordinate disk. Let us de ne analogous regions $U$ for the sliver as follow S :

2. The point at in nity on $\mathrm{C}_{0}^{+}$is m apped to the point at in nity on $\mathrm{V}_{0}^{+}$.

The $m$ ap $R$ com $m$ utes $w$ th the operation of com plex conjugation: $R(z)=(R(z))$. Thus the portion of the real axis contained in $\mathrm{V}^{+}$is m apped to the portion of the real axis contained in $U^{+}$. $W$ e can then de ne the $m$ ap that $m$ aps the whole $V$ to the whole $U$ as follow $s$ :

A s we have already rem arked, the reparam eterization $\bigotimes^{\ell}(z)$ is not unique: we only speci ed two out of the three conditions needed to determ ine a map H ! H uniquely. The rem aining am biguity is that of post-com position $w$ ith the self $m$ aps of $U^{+}$that leave the points $z_{S}=1=2$ and $z_{S}=1$ invariant. $G$ iven a function $R_{0}(z)$ that realizes the $m$ ap in (3.6) with the conditions listed above, we can generate a one-param eter fam ily $R(z)$ of $m$ aps that satisfy the sam $e$ conditions as follow s:

Let us continue our analysis, assum ing that a choice of ${ }^{p}$ has been $m$ ade for the pro jector under consideration. Since the function $\mathfrak{P}(z)$ is invertible we can de ne the curves $C$ as the im age under the inverse function $\mathbb{R}^{1}$ of the vertical lines $V$ :

It follows that the com plem ent of the coordinate disk in W is $m$ apped by $\mathbb{R}^{1}$ to the com plem ent of the coordinate disk in $P$. W e have thus related the states $P$ and $W$ by a reparam eterization. $U \operatorname{sing} z$ for coordinates on $C$, the identi cation (3.14) becom es

In fact, the curves to be identi ed are going to in nity, and the identi cation becom es im $m$ aterialbecause in nity is a single point in the UHP.W e thus obtain the UHP with the coordinate patch of the projector $\mid$ this is the surface for the pro jector.

In order to describe star products of wedge states it is convenient to use an altemative presentation of the region (3.12). W e use the transition function (3.14) to m ove the region $\left(\mathrm{V} ; \mathrm{V}_{0}\right)$ to the right of $\mathrm{V}^{+}$. Since the im age of $\mathrm{z}_{\mathrm{S}}=1=2$ is $\mathrm{z}_{\mathrm{S}}^{+}=(1+2)=2$, we have

The gluing for the star product of wedge states is perform ed sim ply by translation with a real param eter in the sliver fram e . U sing the representation (3.18), the two vertical lines to be glued are always in $\mathrm{U}^{+}$. This induces the identi cation between two $\mathrm{C}^{+}$curves in $\mathrm{V}^{+}$for the star product of the states $P$. If the curve $C^{+}$described with a coordinate $z_{<}$is to be glued to $\mathrm{C}^{+}+\mathrm{w}$ ith a coordinate $\mathrm{z}_{>}$, then $\mathrm{z}_{<}$and $\mathrm{z}_{>}$are related by

W e now dem onstrate the abelian relation $\mathrm{P} \quad \mathrm{P}=\mathrm{P}+$ geom etrically. W e present P as the region ( $C_{0} ; C_{2}^{+}$) and $P$ as the region ( $C_{0} ; C_{2}^{+}$), as shown in $F$ igure 4. The surface for $\mathrm{P} \quad \mathrm{P}$ is obtained by m apping the region $\left(\mathrm{C}_{0}^{+} ; \mathrm{C}_{2}^{+}\right)$in P to the $\mathrm{m} m$ ediate right of $\mathrm{C}_{2}^{+} 2 \mathrm{P}$ and by gluing together $\mathrm{C}_{2}^{+} 2 \mathrm{P}$ and $\mathrm{C}_{0}^{+} 2 \mathrm{P}$. U sing coordinates z 2 P and $\mathrm{z}^{0} 2 \mathrm{P}$, the gluing identi cation that follow s from (320) is

### 3.2 A belian fam ilies for special projectors

For single-split special projectors, the $m$ aps $R(z)$ that relate them to the sliver are explicitly given by

The fillm ap from the com plem ent of the coordinate disk in the projector to the com plem ent of the coordinate disk of the sliver given by (3.7) is

It follows from (327) that the coordinate curve $\mathrm{C}_{0}^{+}$is the s -th root of the sliver line $\mathrm{V}_{0}^{+}$. Sim ilarly $\mathrm{C}^{+}$is the s -th root of $\mathrm{V}^{+}$. The surface $P$ associated $w$ th a special projector $w$ th param eter $s$ is show $n$ in $F$ igure5.

A nother key feature of special projectors is that we can write the $m$ ap from $P$ to $H$ in term $s$ of the $m a p z=f()$ that de nes the projector. Recall that $f() m$ aps the upper-half disk of to the region $\left(C_{0} ; C_{0}^{+}\right) \mid$this is $P_{0} w$ thout the identi cation $T$ hemap $f()$ is know $n$ explicitly for special pro jectors, as we shall review in x5.1.

The rst step in constructing the $m$ ap from $P$ to $H$ is relating the curves $C^{+}$to the curve $\mathrm{C}_{0}^{+}$. From the relation (3.11) we have

relation $\mathrm{P} \quad \mathrm{P}=\mathrm{P}+\mathrm{was}$ not provided. The above results w ill be usefiul later in our calculations on the tachyon vacuum solutions. For a general projector, the calculation of $f$ is com plicated because the $m$ ap from $P$ to $P_{0}$ is nontrivial.

W e conclude this section w th an exam ple. A side from the sliver, the sim plest and m ost fam iliar pro jector is the butter y state. The butter $y$ is a special pro jector $w$ ith $s=2 . R$ ecall that the conform al fram e of the butter $y$ is de ned by

If we w rite $\mathrm{z}=\mathrm{x}+i \mathrm{y}$, w ith x and y real, it follow s from the real part of (3.41) that the butter $y$ coordinate curve is part of the hyperbola given by

W e can use the identi cation (3.46) to m ove the region ( $\mathrm{C} ; \mathrm{C}_{0}$ ) to the right of $\mathrm{C}^{+}$. Since points z $2 C_{0}$ satisfy $<\left(z^{2}\right)=1=2$, (3.46) show $s$ that under the identi cation they becom e

## 4 Solutions from reparam eterizations

In this section we construct the tachyon vacuum solution associated with a general tw istinvariant pro jector. W e begin x4.1 w ith a review ofthe algebraic structure of Schnabl's solution. W e then give a form al construction of the solution associated with a general pro jector using reparam eterizations. In $x 42$ we present the CFT description of the states and ${ }^{0}$ for a general projector. In the last subsection we analyze the various operator insertions in $m$ ore detail and geom etrically con $m$ that they obey the expected algebraic properties.

The contour $\mathrm{V}^{+}$is oriented in the direction of increasing im aginary $z_{S}$, and by $V^{+}$we denote the sam e contourw ith opposite orientation. The expression (4.34) is the direct geom etric translation of the algebraic expression (4.10), as explained in detail in [3]. Recall the change in the nom alization of $f_{S}$.

The argum ent of $C$ denotes the label of the line $C^{+}$ that contains the insertion. The surface and insertions for the correlator indicated in (4.35) are shown in F igure 8 .

### 4.3 O perator insertions in the geom etric language

The expressions of $n$ and ${ }_{n}^{0}$ in (4.35), (4.40), and (4.43) are the central results of this section. W hile the solution constructed from these states are guaranteed to satisfy the equation ofm otion because it is related to Schnabl's solution by a reparam eterization, it is also possible to con $m$ this directly without referring to the reparam eterization. In this subsection we o er a m ore detailed analysis of how various operator insertions are presented in the CFT form ulation. It is then straightforw ard to con $m$ that the equation ofm otion is satis ed using the form ulas in this subsection. The techniques developed in this subsection w illbe useful in handling operator insertions in the conform al fram e of a general pro jector.

Let us begin w ith the operator $L$. ## 5 O perator construction of the solution

In this section we give an explicit operator construction of the solution for the $m$ ost general single-split special projector for anbitrary value of the reparam eterization param eter introduced in (3.9) . W e begin in $\times 5.1 \mathrm{w}$ th a discussion of single-split special pro jectors. They form a \hypergeom etric collection," indexed by a param eters 1. Then in $\times 52$ we derive an operator expression for the state $n$, the key ingredient of in (1.5). The result, given in (5.50), takes the form of norm al-ordered operators acting on the $S L(2 ; R)$-invariant vacuum. It holds for any pro jector in the hypergeom etric collection.

### 5.1 T he hypergeom etric collection

In a previous paper [5], a fam ily of special pro jectors with a param eter s 1 was introduced. It was dem anded that the vector eld $\mathrm{v}_{\mathrm{L}}$ s associated $w$ th the $V$ irasoro operator L s in the frame $\mathrm{z}=\mathrm{f}(\mathrm{)}$ take the form

It seem s to usplausible that the hypergeom etric collection contains all the single-split special pro jectors. It was shown in [5] (section 72) that for a conform alfram e to be special the function $z_{S}=F(), 0 \quad=2$, needs to be piecew ise linear in the $3-p l a n e . O n$ the other hand we also saw in [5] (section 7.3) that comers in $\mathrm{F}_{0}$ seem to lead to operators K that fail to kill the identity, thus violating one of the conditions required to have a special pro jector. If comers are not allow ed anyw here, the intersection of $\mathrm{F}_{0}$ w ith the real line $m$ ust be orthogonal and then $\mathrm{F}_{0}=\mathrm{V}_{0}^{+}$, up to a real scaling constant. This would im ply that all single-split pro jectors are in the hypergeom etric collection.

## 6 Level and other expansions

In this section we will expand and analyze the operator form (5.50) of the solution. W e set up the level expansion com putation for arbitrary s and in 66.1 . W e proceed up to level four, but give the ingredients necessary to carry the com putations to arbitrary order, if so desired.

In 462 we consider the special case $=0$ and com pute the vacuum expectation values of elds up to level four for arbitrary values of $s$. This allow s us to com pute the level zero, tw o, and four vacuum energies as functions of s. Fors 1 we nd num erical evidence consistent $w$ ith convergence of the vacuum energy to the expected value ofm inus the $D$ forane tension.

Recall that fors < 1 the special fram es are not pro jectors. The string eld which provides a solution fors 1 is therefore not expected to provide a solution for $s<1$. Indeed, for $s<1$ we nd num ericalevidence consistent w th the energy failing to converge to the expected value.

In 46.3 we show that the tachyon vacuum solution in the Siegel gauge cannot be obtained in the present fram ew ork. The fram ew ork im poses constraints on expectation values that we show are not satis ed in the $m$ ost accurate version of the Siegel gauge solution known to date.

F inally, in $\times 6.4$ we consider the lim it ! 1 of the solution. This lim it is of som e interest because the surface states used to build the solution approach the surface state of the pro jector. For large the solution provides an analytic expression closely related to the altemative level expansion schem e introduced in [23] and explored further in [24]. In this schem e, the string
eld solution is written in term sof operators of increasing level inserted at the $m$ idpoint of a regulated projector. Our solution is given in term s of exponentials of and has a leading divergent term as well as term $s$ that vanish as ! 1 .

### 6.1 Level expansion prelim inaries

We now set up the level expansion of the solution (5.50). W e begin by level expanding the operators $U_{f_{n}}^{?}$ and $B$. We then write out the level four string eld and com pute the expectation values of the various com ponents. The results are given in term $s$ of in nite sum $s$ that we evaluate num erically.

The rst line contains the level-zero tachyon, the second line contains the three level-tw o elds, and the last tw o lines contain the eight level-four elds. In this expansion the V irasoro operators include $m$ atter and ghost contributions and have zero central charge.

### 6.2 Level Expansion for $=0$

In this subsection we set $=0$ and explore the solution for various values of $s$. W e calculate explicitly the expectation values of level four elds and use them evaluate the approxim ate energy of the solution. We nd num erical evidence consistent w ith the energy converging to the expected value of 1 (in units of the $D$ brane tension) fors $\quad 1$. Fors $<1$ we can still use (5.50) to calculate a string eld but given that the $s$ < 1 surface states are not projectors, we have no reason to believe that the constructed eld is a solution. Indeed, a level com putation of the energy in those cases suggests that it does not converge to $m$ inus one.

Since B only has even-m oded oscillators, that state arises from (5.50) only after expanding the total $V$ irasoro operators in $U_{\tilde{f}_{n}}^{?}$ into $m$ atter and ghost parts. $N$ ote also that the state $L^{m} c_{3} C_{0} \mathrm{jOi}$ does not arise in the expansion. The expansion in ghost and $m$ atter parts cannot generate odd-m oded V irasoro operators, only odd-m oded antighost operators.

We can now consider some num erical work. For $s=1$ we nd the expectation value $\mathrm{t}=0: 553466, \mathrm{u}=0: 0436719, \mathrm{v}=0: 137646$, and $\mathrm{w}=0: 131082$. In $F$ igure 10 we plot energies as a function of $s 2[0: 6 ; 2: 0]$. There are three curves: the level-zero energy $\mathrm{E}_{0}(\mathrm{~s})$, the level-two energy $\mathrm{E}_{2}(\mathrm{~s})$, and the level-four energy $\mathrm{E}_{4}(\mathrm{~s})$. At each level the energy w as com puted using the exact num erical values for all the elds. For s 1 the various curves are consistent w ith an energy that approaches the correct value. For s $<1$ the plot suggests that the energy will not approach the correct value. Som e particular values are also tabulated in Table 2. N ote how e cient the convergence is for $s=2$, while for $s=0: 6$ it appears that the energy w ill not $m$ ove $m$ uch beyond the value $0: 91$.

### 6.3 N o Siegel gauge in the fam ily

The solution for the tachyon vacuum in the Siegel gauge is a state in the universal subspace of the total CFT : the ghost num ber one subspace spanned by all states built on the vacuum by acting w ith nite num bers of ghost and antighost oscillators as well as nite num ber ofm atter $V$ irasoro operators. A part from an $S U(1 ; 1)$ sym $m$ etry that relates certain expectation values no additional relations are know n.

It is clear from the form of $n$ that the solution belongs to a constrained universal space where states are buitt acting on the vacuum with arbitrary ghost oscillators, even $-m$ oded antighost oscillators, and even-m oded total V irasoro operators. Before im posing any gauge condition, the level four universal subspace contains 10 states, while the level four constrained space has only 8 states.

A swe show now, at level four the Siegelgauge expectation valuesm ust satisfy an additional relation if it is to lie on the constrained universal space. This condition is not satis ed.

In the Siegel gauge we can use the expansion (620) of the string eld. The question is whether the values of the prim ed elds in the Siegel gauge are consistent with expectation values for the unprim ed elds. C an we solve for the unprim ed elds using 621)? There is a constraint, how ever. W e readily nd that

### 6.4 Pro jector expansion

In [23] a variant of level expansion w as proposed in which the string eld solution is w ritten in term $s$ of operators of increasing level inserted at the $m$ idpoint of a regulated pro jector surface state. The original discussion used the butter y state but this was extended to large classes of projectors in [24]. In this section we show how to obtain a possibly related expansion using the param eter in the lim it of large .

W ew ill not attem pt the calculation of the subleading term $s$ in the solution. In the work of [23] the leading term of the solution is a divergent coe cient that multiplies a ghost insertion on a regulated projector. T he regulation param eter and the divergent coe cient are related, and this helps produce nite energy. W hile the expansion of the solution around the sliver in this subsection is well de ned in calculating coe cients in front of states in the Fock space, it is not well de ned in calculating the energy of the solution. It would be interesting to nd a m ore system atic way to expand the solution for large , in particular, in the context of VSF T .

## 7 C oncluding Rem arks

W e nd it tantalizing that projectors play a signi cant role in the construction of solutions of OSFT.Projectors are essentially the solutions of vacuum string eld theory (VSFT), so this fact should help relate OSFT to VSFT and, w ith som e luck, to obtain a regular form ofV SF T . In addition to nding new solutions of O SFT, the developm ent of V SF T m ay pave the way for further progress in this eld.

The role of pro jectors was som ew hat hidden in the tachyon vacuum solution of Schnabl [2].
 and necessary ingredient. In [5] it was found that the $L_{0}, L_{i}^{?}$ structure is not unique to the wedge states. Including other conditions required by solvability, one is led to special pro jectors.

In this work we have used reparam eterizations to show that any tw ist-invariant, single-split projector fumishes a solution. It is not required to have a special pro jector, but the form of the solution simpli es considerably for that case. This is a satisfying conclusion: each single-split pro jector fumishes a solution in a di erent gauge, and all single-split pro jectors are allow ed.

O ur m ethods using reparam eterizations do not im m ediately apply to multiple-split pro jectors, i.e., conform al fram es where the coordinate curve goes to in nity at other points besides the string $m$ idpoint. These projectors are not related by regular reparam eterizations to the sliver. Exam ples of multiple-sply special projectors were given in [5]. It is not di cult to construct form alsolutions for a certain class ofm ultiple-split specialpro jectors by inserting operators analogous to those in section 4, but it is not obvious if the calculation of their energies is well de ned.

W hile the idea of using reparam eterizations is certainly not new, it was generally felt that concrete com putations would be di cult since the operators that perform reparam eterizations are extrem ely di cult to construct. W e found a way to im plem ent the necessary reparam eterizations w ithout constructing the operators.

O ne particularly interesting by-product is the construction of an abelian algebra of states for any projector. The surface states interpolate between the identity and the projector. For the sliver this is the fam iliar algebra of w edge states. W e believe, although we have not proven, that the wedge states are the unique states that intenpolate betw een the identity and the sliver and starm ultiply am ong them selves. If this is the case, the possibility of reparam eterizations im plies that the interpolating fam ily $m$ ust be a canonical unique ob ject for any projector. In this sense there is no preferred projector and our use of the sliver is recognized to be just a technical tool.
