# On the SU (2ך) W ZNW m odel and its statistical $m$ echan ics applications

A bstract
M otivated by a carefulanalysis of the Laplacian on the supergroup $S U$ (211) we form ulate a proposal for the state space of the SU (2j1) W ZNW model. W e then use properties of $\operatorname{sl}(2 \boldsymbol{j})$ characters to com pute the partition function of the theory. In the special case of level $k=1$ the latter is found to agree w ith the properly regularized partition function for the continuum lim it of the integrable sl(211) 3 super-spin chain. Som e general conclusions applicable to other W ZNW models (in particular the case $k=1=2$ ) are also draw $n$.

## 1 Introduction

The SU (2기) W ZNW m odel is a key exam ple of the sigm a m odels $w$ ith supergroup targets that appear in the supersym $m$ etric description ofnon interacting disordered system $s$ in low dim ensional statisticalm echanics. The rst occurrence of this m odel probably arose via a supersym $m$ etrization of the path integral for two copies of the two dim ensional critical Ising $m$ odel. It was show in [1] how a system ( w ith centralcharge $\mathrm{c}=1$ ) could be introduced to cancel out the pair of free $M$ ajorana ferm ions (regrouped for convenience into a $D$ irac ferm ion) path integrals

The theory w thout random $m$ assm $(x)=0$ is obviously a free 0 SP (2 2 ) theory, which can be considered as a SU (2 1 ) W ZNW m odel at levelk $=1=21$. A veraging over disorder produces a m arginally irrelevant current current perturbation ofthisW ZNW model. This is crucial to understanding the (logarithm ic) corrections to pure Ising m odel scaling. The deep infrared ( $\mathbb{R}$ ) behavior how ever is not changed by the disorder, which corresponds to the fact that (12) is a sim ple free theory, w ith pure ferm ionic correlators identical to those of the usual Ising $m$ odel.

The second occurrence of the $S U$ (2 11 ) m odel is $m$ ore involved. It arises in the study of $2+1$ dim ensional spin-fiull electrons in the presence of a random (non abelian) gauge potential. The supersym metrization of the path integral for two copies of the D irac ferm ions produces a free O SP (4j4) theory which has been argued to ow to the SU (2 1 l) W ZNW m odelat levelone under the action of the disorder [Z]. The nature of the spectrum and correlation functions play an im portant role in the description of the electronic w ave functions at that xed point.

[^0]Previous works on the $S U(271) \mathrm{m}$ odelhave focused on som e correlation functions [3], [4] and on the construction of som e characters [5], but a com plete picture of the theory has been $m$ issing.

Indeed, the analysis of W ZNW on supergroups is notoriously di cult, even for the sim plest case of G L (1 1 1) [6]. In a recent paper [7], we have show how a careful study of the particle lim it (in particular, of the sim ultaneous left and right invariant actions on the space of functions on the group) could provide considerable insight into this problem . C om bining this insight w ith som e additional input from the representation theory of the current algebras allowed us to form ulate a com plete proposal for the state space of the theory in the case of $G L$ ( 1 j1). The latter involves a rather intricate $m$ ixing of left and right $m$ overs that is intim ately related to the representation theory of Lie superalgebras, in particular to the im portance of indecom posable representations. W e were then able to check this proposal through an exact construction of the theory in the continuum form ulation.

The aim of this work is to extend the lessons we have leamed in [7] to a non-abelian setup, using $S U$ ( $2 \lambda 1$ ) as the simplest non-trivial exam ple 2 O nce more, the analysis of the particle lim it (section 2) along w ith som e input from the representation theory of the sl(2j1) current algebra (section 3) shall provide all the necessary ingredients for the construction of the eld theory state space (section 4), in close analogy to our previous investigation of the $\mathrm{GL}(1 \mathrm{ll}) \mathrm{m}$ odel. In the present case we shall not attem pt to verify the structure of the state space through calculations of correlators, though this would be possible as well (see [8]). Instead we shall use results on an integrable sl(2기) spin chain to test our continuum constructions. Such a spin chain was rst investigated in [9] as a discrete version of the SU (2ㄱll) W ZNW model We shall see that both approaches are consistent. The com parison, how ever, is a bit subtle, $m$ ainly due to the fact that the supergroup $S U$ (2jl) has an inde nite $m$ etric. $W$ hile this poses no problem for the (algebraic) conform al eld theory analysis, the com putation of the partition function on the lattice su ers from divergencies which need to be regularized. We shall do this through som e appropriate analytic continuation. In this sense, our analysis also supports a particular prescription for extracting inform ation from spin chains $w$ ith an inde nite $m$ etric.

## 2 The m in isuperspace analysis

The am of this section is to decom pose the space of functions on the supergroup SU (2j1) into (generalized) eigenfunctions of the quadratic C asim ir elem ent in the regular representations. Since the C asim ir com $m$ utes $w$ th the generator, the eigenspaces $m$ ay be decom posed into representation of the Lie superalgebra sl(2ㄱ). It is therefore usefiul to have som e background on the representation theory of sl(2 1 ). W e shall review a few known facts below before addressing the harm onic analysis. M ore details can be found e.g. in [10, 11].

### 2.1 The Lie superalgebra sl(2 1 )

In this subsection we provide a short overview on nite dim ensional representations of sl(2 1 l$)$. R ather than reproducing a com plete list of such representations we shall focus on those that are relevant below, nam ely on Kac m odules and the projective covers of atypicals.

### 2.1.1 The de ning relations of $\operatorname{sl}(2 \mathrm{j})$

The even part $g^{(0)}=g l(1) \quad s l(2)$ of the Lie superalgebra $g=s l(2 \boldsymbol{j})$ is generated by four bosonic elem ents $\mathrm{H}, \mathrm{E}$ and B which obey the com mutation relations

In addition, there exist two ferm ionic multiplets ( $\mathrm{F}^{+} ; \mathrm{F}$ ) and ( $\mathrm{F}^{+}$; F ) which generate the odd part $g^{(1)}$. They transform as $\left(\frac{1}{2} ; \frac{1}{2}\right)$ w ith respect to the even subalgebra, ie.

am ong each other. Form ulas (2.1) to (2.3) provide a com plete list of relations in the Lie superalgebra sl(2ㄱ).

### 2.1.2 K ac m odules and irreducible representations

K ac m odules [12] are the basic tool in the construction of irreducible representations. In the case of $g=\operatorname{sl}(2 j 1)$, these form a 2 -param eter fam ily fb; jg of $8 j$-dim ensional representations. Wemay induce them from the $2 j$-dim ensional representations (b $\frac{1}{2} ; j \frac{1}{2}$ ) of the bosonic subalgebra $\mathrm{g}^{(0)}$ by applying the pair F of ferm ionic elem ents. O ur label b 2 C denotes a $\mathrm{gl}(1)$-charge and spins of sl(2) are labeled by $j=\frac{1}{2} ; 1 ;:::$. The dual construction which prom otes the ferm ionic generators F to creation operators, yields anti-K ac m odules fib; jg (b and $j$ take the sam e values as above). The bosonic content of (anti-)K ac m odules $m$ ay be read o rather easily from their construction,

For generic values ofb and j, them odules fb; jg and fib; jg are irreducible and isom onphic. At the points $b=j$, how ever, they degenerate, i.e. the representations are indecom posable and no longer isom onphic. In fact, K ac and anti-K ac m odules are then easily seen to possess di erent invariant subspaces. To be more precise the (anti-)K ac modules $f$ j; jg and $f \overline{j ; j g}$ are built from two atypical representations such that

The atypical irreducible representations fjg that appear in these sm all diagram s are $4 j+1$ dim ensional. $W$ th respect to the even subalgebra they decom pose according to

For $j=0$, only the trivial representation (0) occurs. It is also useful to introduce the characters of these representations. By de nition, these are obtained as

where the super-trace extends over all states in the representation $R$ of sl(2 1 l). For $K$ ac $m$ odules the character is rather sim ple. In fact, it factorizes

The characters of atypical representations can be obtained easily form their decom position form ulas (2.6). W e would like to pursue a rather di erent route here that uses the decom position (2.5) of K acm odules into atypicals. The rst form ula im plies that

W e can solve these equations for the characters of atypical rep resentations by the follow ing in nite sum $s$

F igure 1: A graphical ilhustration of how characters for an atypical representation can be obtained as an in nite sum of characters of $K$ ac $m$ odules. Here the one dim ensional atypical identity 0 appears as a sum over $f 1=2 ; 1=2 \mathrm{~g}$ (thin lines and dots), $f 1 ; 1 \mathrm{~g}$ ( $m$ edium lines and dots), $£ 3=2 ; 3=2 \mathrm{~g}$ (thick lines and dots) etc. All spurious contributions (that is, the whole tow er but the origin) appear tw ice, and they disappear by cancellations of bosonic and ferm ionic degrees of freedom. The diagram corresponds to the choice of plus sign in form ula (2.8).

O nem ay check by explicit com putation that the contributions from allbut tw o bosonic multiplets cancel each other in the in nite sum through a m echanism that is visualized in $F$ igure 1. The rem aining two term scrtainly agree w ith the decom position form ulas (2.6). O ur derivation here $m$ ay seem like a rather com plicated path for such a simple result, but we shall see later that the sam e trick works for characters of atypical a ne representations whid are otherw ise di cult to obtain.

### 2.1.3 P ro jective covers of atypical irreducible m odules

By de nition, the pro jective cover of a representation fjg is the largest indecom posable representation $P$ (j) which has fjg as a subrepresentation (its socle). W e do not want to construct these representations explicitly here. Instead, we shall display how they are com posed from atypicals. The projective cover of the trivial representation is an 8-dim ensionalm odule of the form

These representation spaces are $16 j+4$-dim ensional. Let us agree to absorb the superscript on $P$ into the argum ent, ie. $P \quad(j)=P(j)$, wherever this is convenient.

### 2.2 Functions on the supergroup SU (211)

N ow we are prepared to analyze the space of functions on the supergroup SU (2j1). For this purpose, let us introduce coordinates through the follow ing explicit decom position of elem ents U 2 SU (2ㄱ),

Here, the bosonic base $S U(2) R$ is param etrized by an elem ent $g 2 S U(2)=S^{3}$ along $w$ ith the tim e-like variable $z$. In these coordinates, the generators of the right regular

$M$ atrix elem ents with $j=1=2$ appear as coe cients in the di erential operators $R_{F}$ and their behavior under the action of $R_{X}^{0}$ plays an im portant role in checking that the above generators of the right regular representation obey the de ning relations of sl(2]). Form ulas for the left regular representation $m$ ay be obtained sim ilarly,

It is probably not necessary to stress that left and right generators (anti-) com $m$ ute $w$ ith respect to each other.

By construction (see how ever [8]), the generators of the left and right regular representation act on the space of all $G$ rassm ann valued functions w ith square integrable coe cients on the bosonic base, i.e. on the space

Here, the sum $m$ ation runs over $j=0 ; 1=2 ; 1 ;:::, f b ; j g$ denotes the typical representations of $\operatorname{sl}(2 \boldsymbol{\eta})$ and $P_{j}$ are the projective covers of the atypical representations fjg . M ost of our conventions can be found e.g. in [10]. A prim $e^{0}$ on a representation $m$ eans that the degree is inverted, i.e. that ferm ionic vectors becom e bosonic and vioe versa. The result is a special case of the general observation $m$ ade in [13] and it generalizes a sim ilar decom position we described in [7] for the left regular action of $g l(1) 1)$. The interested reader can nd an explicit proof in A ppendix A. Let us com $m$ ent that the decom position of the left regular action displays the sam e violation of the P eter-w eyl theorem as in the case of GL (1 1 ). In particular, since the quadratic $C$ asim ir is not diagonalizable in the pro jective covers $\mathrm{P}_{\mathrm{j}}$, the Laplacian on the supergroup SU (2기) can only be brought into Jordan norm al form. The blocks can reach a rank up to three.

The functions on our supergroup carry another (anti-)commuting action of the Lie superalgebra $g$ by left derivations. There is a corresponding decom position which is certainly identical to the decom position above. A m ore interesting problem is to decom pose the space of functions w ith respect to the graded product $g \quad g$ in which the rst factor acts through the left regular action while for the second factor we use the right regular action. In the typical sector, the 4jj4j-dim ensionalm ultiplicity spaces in the rst line of eq. (2.17) get prom oted to typical representations of the right regular action, i.e.

$w$ here $J$ is a single indecom posable, containing all the atypical building blocks. Its structure $m$ ay be sum $m$ arized by the follow ing picture


This diagram is the natural extension of the corresponding picture for GL(1j). It extends to in nity in both directions and com bines all the atypical sectors into a single
indecom posable representation. N ote that by construction, each pro jective cover in the decom position of the right regular representation appears with the correct multiplicity. W e shall see below how this picture is modi ed in the full quantum theory.

## 3 Representation theory of the a ne algebra

The previous analysis of the particle lim it applies to all sigm a m odels on SU (2 $\mathfrak{j}$ ) , but the inform ation it provides is usually not su cient in order to reconstruct the entire eld theory from it. This is very di erent for the W ZNW model in which the entire spectrum can be generated from particle wave functions through current algebra sym m etries. We need some facts on the representation theory of the sl(2j1) current algebra and shall provide them in the follow ing section. All the results we collect here are well known
 we shall use a sim ple, but highly e cient prescription to construct characters of atypical representations of $\$ 1(2 \boldsymbol{j})$ through in nite sum s over typicals. This extends the form ula (2.8) we have discussed in section 2 to an in nite dim ensionalsetting, thereby generalizing a tridk that has rst been proposed in the context of the $g l(1 \boldsymbol{j})$ current algebra 18].

### 3.1 Som e basic ingredients

Irreducible representations of the a ne $\operatorname{sl}(2 \mathfrak{l})$ algebra can be built over the irreducible typical representations fb; jg w th $j=1=2 ;::: ; k=2$ as well as over the atypicals fjg with $j=0 ; 1=2 ; 1 ;::: ; k=2$. Ground states in the form er set of representations possess conform aldim ension

while the conform al dim ension for ground states in the latter set vanishes. Follow ing the work [14] of B ow cock et al. we shall divide these representations into three di erent classes. The generic class I representations occur for fb; jg with b $j_{n}$ where we de ned

of irreducible representations. The results we describe have rst appeared in [14].
Before we start our discussion of characters let us quidkly recall that it is possible to construct $\operatorname{sl}(2 \boldsymbol{j})$ currents in term s of decoupled bosonic and ferm ionic variables. To be more precise, we introduce a set of bosonic currents e $(z) ; h(z) ; b(z)$ and assum e them to satisfy the operator product expansions of an a ne sl(2) algebra at level $k \quad 1$. In addition, let us introduce two sets of ferm ionic elds $p^{a}$ and ${ }^{\text {a }}$ obeying the canonical relations

Since the ferm ionic elds ${ }^{a}$ and $p^{a}$ are supposed to com mute with the bosonic elds $e(z) ; h(z)$ and $b(z)$, the characters of typical representations factorize $w$ th the factors $1(y ; q)$ arising from the ferm ionic pairs. The shift $j!j 1=2$ in the bosonic contribution $m$ ay be traced back to a sim ilar shift in the labeling of typical sl(2j) representations, see eq. (2.4) .

### 3.2 Typical (class I) representations

The generic class I representations have no singular vectors except from the ones that arise through the representations of a bosonic su (2) current algebra at level k 1. In this sense, they $m$ ay be considered the typical representations of the a ne sl(2j) algebra.

The statem ent im plies a precise expression for the characters of class I representations
and $\mathrm{b} j_{\mathrm{m}}$ and $1=2$ j $\mathrm{k}=2$. W e also recall that the su (2) characters are given by

W e shall use the sym bol fb; jg^ for these irreducible representations of the a ne algebra. The form ulas are easy to understand: they follow directly from the representation (3.1) of the $\operatorname{sl}(2 \boldsymbol{j})$ current algebra. In fact, each pair of ferm ionic elds contributes a factor ${ }_{1}=\mathrm{while}$ the bosonic sl(2) and $u(1)$ current algebras are responsible for the characters ${ }^{k} 1$ and an additional factor ${ }^{1}$, respectively.

### 3.3 A typical (class II) representations

$N$ othing prevents us from evaluating the previous character form ulas at the points $b=j_{m}$. But the resulting fiunctions tum out to be the characters of indecom posable representations $f j_{n} ; j g^{\wedge}$ which contain one ferm ionic singular multiplet. In order to state this $m$ ore precisely, let us consider in $m$ ore detail the set of atypical labels,

$T$ he set A is visualized in $F$ igure 2. O ur picture show s clearly that the pro jection to the b-coordinate of each elem ent in A is in jective and hence it can be used to enum erate our atypical labels. N ote, how ever, that values b $2(k+1)=2 \mathrm{Z}$ are om itted. This m otivates to introduce an im proved enum eration $m$ ap ^ from A to non-zero half-integers which is de ned by

Even though the $\operatorname{sl}(2)$ spin $j$ is cuto at $j=k=2$, there exist in nitely many atypical labels (black dots) which are in one to one correspondence $w$ ith the atypical labels of the nite dim ensional algebra sl(2기) (central black and pink dots). At rst sight, the enum eration of atypical labels for our sl(2ך) current algebra may seem like a rather technical device. B ut there is more to it. W e recall that atypical labels f $\quad j \quad j g$ can also be enum erated by non-zero half-integers, ie. (f jijg) = j. O ur claim now is that the atypical class I representation with label fjijg behaves very sim ilarly to its nite dim ensional counterpart ${ }^{1} \wedge$ ( $f_{r p} ; j g$ ) in the sense that

This form ula is a rather central result for the representation theory of our current algebra. Let us stress that it is the a ne version of a corresponding equality (2.7) between
characters of sl(2 1 l) representations. A s in the nite dim ensional setup, eq. (3.4) em erges from the existence of ferm ionic singular vectors in atypical class I representations. In the case $m=0$, it claim $s$ that the only such singular vectors are those that appear in the atypical K acm odule spanned by the ground states. W hen $m \in 0$, however, the ground states form a typical representation and the singular vectors appear only on the in fh level of the class I m odule.

At rst it $m$ ay seem a bit surprising that a ne representations $f j_{m} ; j g$ and $m \xi$ 0 behave so sim ilarly to the Kac modules of sl(2j1). In the next subsection we shall understand this behavior in term sofspectral ow sym $m$ etries in the representation theory ofthe current algebra. Before any study ofspectral ow autom orphism s, itm ight be useful to illustrate the sim ilarity betw een atypical representations of the current algebra and their nite dim ensionalcountenpart m ore explicitly, at least for one exam ple. To this end, let us focus on the representation $\mathrm{fk}=2+1 ; \mathrm{k}=29^{\wedge}$ which we claim to be a close cousin ofthe sl(2j1) representation $\mathrm{fk}=2+1=2 ; \mathrm{k}=2+1=2 \mathrm{~g}$. By construction, the ground states of the current algebra representation transform in the typicalm ultiplet $f k=2+1 ; k=2 g$ and they possess conform al weight $h=1$. From these vectors we can generate states with vanishing conform alw eight w ith the help ofm odes in the current algebra. Such m odes transform in the 8 -dim ensional adjoint representation $10 ; 1 \mathrm{~g}$ of $\operatorname{sl}(2 \mathfrak{j})$. Through decom position of the tensor product between $\mathrm{fk}=2+1 ; \mathrm{k}=2 \mathrm{~g}$ and $\mathrm{f0} ; 1 \mathrm{~g}$ one nds that the Verm a m odule over $\mathrm{fk}=2+1=2 ; \mathrm{k}=2+1=2 \mathrm{~g}$ contains an atypicalsl(2j1) multiplet w ith conform alw eight $\mathrm{h}=0$. In fact, the results of [11] im ply that the latter transform s according to the pro jective coverP ( $k=2+1=2$ ), see eq. (2.10). N ot allofthese states survive when we descend from the Verm a m odule to the class I representation. This step involves rem oving bosonic singular vectors and am om ent of re ections show sthat such vectors with $h=0$ exist and that they transform in the subm odule $f k=2+1 ; k=2+1 g$ ofP $(k=2+1=2)$. H ence, the states with $h=0$ in our class I representation decom pose into the K acm odule $\mathrm{fk}=2+1=2 ; \mathrm{k}=2+1=2 \mathrm{~g}$ plus a bunch oftypical representations. The ferm ionic singular vectors that are responsible for eq. (3.4) transform in the subrepresentation $f k=2 ; \mathrm{k}=2 \mathrm{~g}$ of $\mathrm{fk}=2+1=2 ; \mathrm{k}=2+1=2 \mathrm{~g}$, giving rise to the identity (3.4) w ith $j_{1}=k=2+1$ and $j=k=2$.

Before we draw som e conclusions from eq. (3.4), let us quidkly com $m$ ent on our nota-
 a representation which has a som ew hat special status. In fact, it cannot be obtained as quotient of one of the indecom posable representations $f j_{n} ; j g^{\wedge}$, unlike the representations
w ith characters ${ }_{f n=2 g}^{I I} ; n$; . Instead, it arises as a subm odule of the representations f $1=2 ; 1=2 g^{\wedge}$. O ur discussion suggest that ${ }_{f 0 g}^{I I} m$ ust be the character of the vacuum representation. In the term inology of $B$ ow cock et al. the latter is a class IV representation. Thus, we shall also w rite ${ }_{\text {fog }}^{\text {IV }}$ for this quantity.

Even though equation (3.4) is not a closed form ula for the characters of class II representations, we can now use the sam e trick as in section 2.12 and write characters of class II representations as an in nite sum of class I characters,

C haracter form ulas of this type have to be used w ith som e care: B efore the denom inators are expanded, one should spit the summ ation over a into two parts. The one arising from positive values of a can be converted into a power series right aw ay. In all term $s$ w ith non-negative a, how ever, one must rst reduce the fraction by $q^{a}$ such that the subsequent expansion contains only non-negative powers of $q$. In the end, we recover the known results on the representation theory of the a ne sl(271) algebra [ [5, 17]. O ur derivation was based on three ingredients: the decoupling form ulas (3.1) for bosonic and ferm ionic generators, the structure (2.5) of atypical K ac m odules for sl(2j) and the fact that atypical class I representations w ith $m \in 0$ decom pose in the sam $e w$ ay as in the case of $m=0$. We shall argue now that the last ingredient em erges from spectral ow sym $m$ etries in the representation theory of a ne sl(2ㄱㄱ).

### 3.4 Spectral ow sym m etries

The a ne sl(2j1) algebra adm its several interesting autom onphism s . W e shall be mainly concemed w th two such spectral ow autom orphisms. By construction, are de ned
on the entire current algebra, but for our punposes it is su cient to know how they act on the generators $\mathrm{B}_{0} ; \mathrm{H}_{0} ; \mathrm{L}_{0}$,

The third line, for exam ple, tells us that the im age of the irreducible representation generated from the atypical representation fjg. under the action of + is an irreducible representation whose ground states transform in the typical representation fj+k=2+ $\frac{1}{2} ; k=2+\frac{1}{2} \quad j g$. The latter $m$ ay be obtained from the corresponding Verm a m odule by rem oving singular vectors on som e excited levels.

W e also want to spell out analogous form ulas for the autom onphism $=+{ }^{1}$. In the com pact notation, its action is given by

Hence, the existence of the spectral ow sym metries explains why the representations $f j_{m}$; jg behave like atypical representations of the a ne sl(2기) algebra: they are simply related to the sectors erected over atypical sl(2 1 1) representations by an autom onphism .

### 3.5 M odular transform ation and $S-m$ atrix

W e would like to conclude this section on the representation theory of the sl(2j) current algebra $w$ ith a few com $m$ ents on $m$ odular properties of the characters. In the follow ing we shall consider the characters as functions of ; and . They are related to the variables we used above through $q=\exp 2$ i $; z=\exp 2 i$ and $=\exp 2 i$, as usual. From
our explicit form ula (32) for characters of class I representations it is easy to infer the auxiliary form ula

M odular transform ations of the type II and IV characters are a bit m ore cum bersom e to work out. It can be attacked rathere ciently using our representations (3.5) as in nite sum s of class I characters. H ere we shall content ourselves $w$ th the exam ple of the class IV representation at $\mathrm{k}=1$. If we also set $==0$ we nd that

W e thus recover by this very elem entary $m$ eans the results of [5] obtained through use of the M ordell integral [19]. The construction ofm odular invariants using these transform ation form ulas is a com plex problem, which we shall address later in the case $\mathrm{k}=1$.

## 4 The state space and partition functions

O ur aim now is to form ulate a proposal for the states space of the sl(271) W ZNW model. W e shall then verify our claim in the special case $\mathrm{k}=1$ through a free eld representation of the m odel. The third subsection is devoted to the partition function of the theory. The latter forgets all in form ation about the com plicated way in which irreducible blocks are glued together to build $J . W$ e then specialize once $m$ ore to $k=1$ and com $m$ ent on the global topology of the target space.

### 4.1 The proposal for integer level k

It is now rather straightforw ard to come up with a proposal for the state space of the W ZNW m odelon SU (2 1 l). In fact, we can sim ply depart from form ula (2.18) and make it sym $m$ etric $w$ ith respect to the action ofour spectral ow sym $m$ etry. The invariance under the action of should be considered as an additionalinput. In principle, the spectral ow sym $m$ etry of the $s l(271)$ current algebra could be broken by the physical couplings of the theory. Since this did not happen for the GL (1 j1) W ZNW m odel, it seem s natural to propose
$w$ here $J^{\wedge}$ is a single indecom posable representation of the two (anti-)com $m$ uting super current algebras that contains all the atypical contributions. It is com posed from the atypicalbuilding blocks $\mathrm{fl}_{1} g \quad \mathrm{fl}_{2} g$ in the sam $e w a y$ as in the $m$ in isuperspace theory. To obtain the corresponding diagram one simply has to replace $f j g=f j g w$ ith $f j g^{\wedge}$.

By construction, all the sl(2 1 ) currents act on the state space 4.1) and they obey periodic boundary conditions. This applies in partioular to the ferm ionic elds. O ne can nd a second, closely related theory in which only bosonic elds are periodic. In order to construct its state space, we need to revisit our discussion of spectral ow sym m etries. A s we have m entioned above, the autom onphism swe have investigated in the previous section all extend to the entire current algebra. In particular, they $m$ ap ferm ionic $m$ odes $w$ ith integer $m$ ode num bers onto each other, i.e. they respect periodic boundary conditions on the ferm ionic currents. There exists yet another im portant isom onphism that intertw ines between integer and half-integer $m$ ode num bers for the ferm ionic generators. It can be considered as the square root of the autom orphism . On the bosonic zero modes, the
new isom onphism \# is given by

\# extends to the fill current algebra such that it acts trivially on the bosonic sl(2) currents and it shifts $m$ odes of the ferm ionic currents by $1=2$, as usual.

O ur isom onphism \# induces a m ap between representations of the current algebra w ith integer ferm ionic $m$ odes and a new type of representations in which ferm ionic generators have half integer m ode num bers. A ccording to the usual term inology, the form er class of representations form the $R$ sector while the latter belong to the N S sector of the theory. The theory w ith state space (4.1) includes exclusively $R$ sector representations in which all currents obey periodic boundary conditions. A nother option is to consider a theory that encom passes both $R$ and NS sector $w$ ith the state space given by

In the follow ing we shall refer to both models as W ZNW m odel on SU (2j1). Even though it seem s natural to include the N S sector, it is not required by all applications.

### 4.2 Free eld representation at $k=1$

So far, the $m$ ain $m$ otivation for our proposal (4.1) cam e from the harm onic analysis on SU (2 1 l). By construction, we are guaranteed to recover the correct state space of the particle lim it when we send the level k to in nity. O ur formula 4.1) applies to nite $k$ and it suggest that eld theory e ects would merely truncate the spin $j$ to an value j $k=2$ and then $m$ ake the whole theory sym $m$ etric $w$ ith respect to spectral ow. W e are now going to test this proposal in the extrem equantum case, nam ely at $k=1$. At this point, the W ZNW m odel adm its a free eld representation that we are going to spell out m om entarily. It involves a pair of sym plectic ferm ions $1_{1}$; 2 , and a pair of bosons ; ${ }^{0}$. W hile the boson com es with the usualm etric, ${ }^{0}$ is assum ed to be tim e-like. For their propagators this $m$ eans

W e shall begin our discussion of the W ZNW modelw ith explicit form ulas for the currents. In order to construct the four bosonic currents, we need to split the space-like bosonic eld $(z ; z)={ }^{\prime}(z)+{ }^{\prime}(z)$ into its chiral com ponents. O ur bosonic currents then read,

Let us note that the free eld representation we consider in this section has to be distinguished clearly from the K ac-W akim oto type construction (3.1) we have used earlier to construct the characters at integer levels $k$. W e shallcom $m$ ent on this a bit m ore later on.

It is possible to check that elds of dim ension zero can be organized exactly as it is suggested by our diagram (2.19). W e shall just sketch the relevant argum ents because a full proof is rather laborious to write down. Let us consider the left part of the diagram only and identify the elds that $m$ ake up the various blocks of the com position series. $C$ learly, the $f 0 g \mathrm{fOg}$ representation at the top corresponds to the eld 12 . From here we can act $w$ th the ferm ionic currents $W$;V and arrive at expressions for the two blocks on the interm ediate level of the diagram,

A cting w ith the holom onphic ferm ionic currents $V \quad(z)$ we arrive at the follow ing form ulas for elds that belong to the multiplet
on the interm ediate level of the diagram. O ur notation $m$ eans that every product of the three holom onphic elds on the left hand side w the three anti-holom orphic elds on the right hand side is part of this 9 -dim ensionalblock. Sim ilarly, we can now desoend to the bottom of the diagram,

Finally, the representation $f 0 \mathrm{~g} \quad \mathrm{f0g}$ in center bottom position is represented by the identity eld. It is easy but laborious to check that the di erent representations are connected by the action of the left and right generators as indicated in the diagram. There are a number of interesting further com $m$ ents and observations that we would like to $m$ ake. Let us begin $w$ th a brief com $m$ ent on the relation $w$ ith $K$ ac-w akim oto like representations of the form (3.1). As discussed in [8], a naive evaluation of the action of the latter on vertex operators leads to a m uch sim pler picture in which the atypical sector is a sm ooth deform ation of the typical part. In particular, there is no m ixing between left-and right $m$ overs as in the case of the representation $J^{\wedge}$. In order to see the latter, the screening charge of the K ac-W akim oto representation $m$ ust be taken into account (see [8] for details). The free eld representation we have em ployed in this subsection is m uch sim pler to use, but it is restricted to $\mathrm{k}=1$.

The free eld representation also allows us to illustrate very explicitly how atypical elds of dim ension $h=0$ are em bedded into sectors $w$ ith ground states in typicalm ultiplets once their spin exceeds $\mathrm{k}=2$. Take, for instance, the eld $\mathrm{O}=\mathrm{e}^{\mathrm{p} \frac{1}{2}\left(,{ }^{\prime}\right)^{\prime}}{ }_{2}$ from the
f1g representation and observe that

This eld belongs to the typical representation $f 3=2 ; 1=2 g$ in the sector $f 1 g$ with a ne highest weight $Q=e^{\left.\mathrm{i} \prime^{\prime} \quad 3^{\prime}\right)^{\prime}=} \overline{\mathrm{p}}^{\mathrm{p}}{ }_{2} @_{2}$. O nem ay easily generalize these observations to all representations in the com plex, hence con m ing our analysis based on spectral ow.

Let us nally com e to them ost im portant point, which concems the possible construction of consistent theoried that are realized on a subspace of our state space (4.1). N ote that $H$ does contain a large num ber of ferm ionic singular vectors that we decided not do decouple, partly because the $m$ inisuperspace analysis suggested that it was unnatural to do so. But to a certain extend one should consider (4.1) as som e kind ofm axim al choige from which other m odels can be obtained by consistent decoupling of singular vectors. In general there can be several such reduced theories. O nœe $m$ ore we $m$ ay use our free eld representation for the $\mathrm{k}=1 \mathrm{~m}$ odel to ilhustrate nicely how this works. N ote that the expressions (4.4) for the currents only contain derivatives of the ferm ionic elds. Hence, we do not spoil the sl(2 1 ) current algebra sym $m$ etry if we decide to work $w$ ith a m odel in which the fiundam ental elds are e.g. ; ${ }^{0}{ }_{2}$ and @ ${ }_{1}$. Since ${ }_{1}$ is not part of this model, som e of the sectors we discussed above do no longer appear. This concems the sectors $f 0 g \quad f 0 g$ and $f 1=2 g \quad f 1=2 g_{+}$on the top oor of $J^{\wedge}$ and the sector $f 0 g \quad f 1=2 g_{+}$on the interm ediate oor. In the resulting $m$ odel, there is still a single atypical sector that com prises all the irreducible atypicals, but it is reduced to tw o oors and has the shape of a saw blade. Obviously, a sim ilar analysis applies to the theory that contains @ 2 instead of 2 . But we can even go one step further and drop both 1 and 2 so that only ferm ionic derivatives rem ain. W hat results is a m odel whose atypical sector decom poses into an in nite sum of irreducibles. T he latter are the sectors that appear on the bottom oor of $J^{\wedge}$, i.e. $f 0 g \quad f 0 g$ and $f 1=2 g \quad f 1=2 g_{+}$from our list above. All others need either 1 or 2 . Sim ilar phenom ena are possible at other levels. W e shall see another explicit exam ple in section 52. Let us stress, how ever, that the free eld construction at $k=1$ does not include the \de ning" $f 0 ; 1=2 g$ eld of the $W$ ZNW m odel. A careful study of

the Knizhnik-Zam olodchikov equations [3, 2] shows that consistency in the presence of the $f 0 ; 1=2 g$ sector requires the identity eld to be embedded into an indecom posable sector. In this sense, the fiully truncated atypical sector we have just described cannot be em bedded into the sl(2j1) W ZNW m odel.

### 4.3 Partition functions

W e now go back to the full theory based on our proposal (4.1). W e would like to com pute the partition function of the m odel, w th and w thout inclusion of the NS sector. Since partition functions are obtained by taking the trace over the state space, the details of the action of ferm ionic generators in the atypical sector $J^{\wedge}$ do not show up in the result. In other words, the contribution from the indecom posable $J^{\wedge}$ is the sam e as if we would take the trace over a sum of its irreducible com ponents. The latter can be resum ed as follow S ,

In the last step we have inserted the relation (3.4) between characters of class I and class II representations and we used the isom orphism ^ to convert the sum over non-zero half-integers into a sum over $m$ and $j$. O ur result show $s$ that the contribution from the atypical representations agrees exactly $w$ th the part that we om itted from the typical sector of the theory. H ence, the fiull partition function becom es

Let us also brie y discuss how the partition fiunctions ism odi ed when wewant to include the NS sector. In that case, the trace extends over both $H_{\text {CFT }}$ and its im age under the spectral ow \#. Them odular invariant partition function $Z(q)$ of this theory contains four di erent term s , tw o in which $(1)^{\mathrm{F}}$ is inserted and two in which it is not. It is custom ary to label the corresponding contributions with $R, s R, N S$ and $s N S$ where the sm all $s$ signals the insertion of $(1)^{F}$. W ith these notations, the standard super-characters we have discussed throughout the previous section should allcarry a superscript sR. It is easy to nd explicit form ulas for the other three sets of (super-)characters using the relation

to convert $s R$ characters into $s N$ S super-characters. The sam e prescription is used when we construct N S characters from the $R$ sector, only that we have to replace the $R$ supercharacters by ordinary characters. The partition function $Z(q)$, nally, has the same form as eq. (4.9) with an additional sum $m$ ation over all four types of term $s$.

Let us illustrate the previous results in the case of $k=1$ again. The (sR) characters of this theory take a particularly simple form, as was rst observed by Bow oock et al. in [5],
where 0 and ${ }_{1=2}$ are $\operatorname{SU}(2)$ level one characters for spin 0 and $1=2$ respectively. This expression allows us to determ ine the $m$ odular invariant physical partition function $Z$ involving periodic or antiperiodic boundary conditions for the ferm ions along both periods of the tonus. The doubly periodic sector ( ${ }^{\text {sR }}$ ) gives a vanishing contribution for characters $f b ; 1=2 g$ since the super-dim ension of the horizontal K ac m odules vanishes. W e are left w ith three contributions, which read respectively

O bviously, the dependence of these form ulas originates in the $1=$ term in the characters, and has to be com pensated by a sim ilar factor com ing from the b sum in order to obtain a m odular invariant quantily.

The question we want to ask now is what kind of sum over $b$ one should consider. It seem $s$ at rst sight that, since we are dealing $w$ ith $S U(2 j 1)$, the $b$ num ber should be discrete, in agreem ent w ith the im aginary exponential appearing in section 22 (note that this is also com patible w ith invariance under action of the spectral ow ). It is likely that such a theory would $m$ ake sense in genus zero. D i culties arise, how ever, when we try to establish $m$ odular invariance of the partition fiunction, i.e. consider the theory in genus one. Indeed, even ifb is discretized, there is no reason to truncate its range, and thus the naive spectrum of conform al weights is unbounded from below, and exhibits arbitrarily large negative dim ensions. This should not come as a sunprise since the $m$ etric on the group is not positive de nite, and thus the naive functional integral in the W ZNW m odel is divergent. $W$ hat is required to obtain a physical partition function on the torus - one that could be com pared w ith the spectrum of som e lattioe $H$ am iltonian say - is som e sort of analytic continuation.

This raises som e interesting questions on which we would like to digress brie y. For a com pacti ed tim e-like boson, partition functions would involve sum s of the form

This sum is obviously divergent, but one could be tem pted to give it a meaning by analyticalcontinuation from a sim ilar sum with $\mathrm{Re}<0$. A $n$ equivalent problem arises when we try to continue a theta function such as

It is known that this continuation is not possible, since the function has singularities which are dense on the real axis (a quidk proof is obtained by rst observing that is singular for an even integer, and then using $m$ odular transform ations). Theta functions have a naturalboundary, and are sim ple exam ples of lacunary functions, i.e. \alm ost all" their Fourier coe cients are zero [20]. The partition function of a com pacti ed tim e-like boson is thus a form al ob ject from which it is hard to extract physicalm eaning. On the other hand, w ithout com pacti cation, the partition function can easily be analytically continued. Indeed, replacing the discrete sum by an integralwe have

hence com pensating the factors com ing from the functions in the characters. W e note that the spectrum of conform al weights in the periodic sector is a continuum starting at $h=1=8$. The eld $w$ th $h=0$ does not appear.

In conclusion, the requirem ent for our theory to possess a \physical partition function" has forced us to let b be continuous. Geom etrically, this am ounts to a decom pacti cation of the tim e-like circle. Hence we are led to consider the universal cover of SU (2 1 1) so that we can perform an analytical continuation on the number b. O ne may interpret the prescription that leads to the physical partition function as an e ective change of the
target space along the lines advocated in [21]. Let us also stress that, while our argum ents were based on the $k=1$ theory, it is clear that a sim ilar reasoning can be carried out for other levels.

The argum ent leading to $b$ being continuous also seem $s$ to exclude the sm aller theories where part of the com plex $J$ is dropped, at least for general values of $k$. $W$ e shall see an exception in the case $\mathrm{k}=1=2$ later.

## 5 Som e selected applications

This follow ing section contains som e selected applications of our general analysis. In the rst subsection we shall com pare our results $w$ ith studies of the continuum lim it of the integrable sl(271) 33 spin chain [9]. The agreem ent we nd supports a new intenpretation of lattice results. The second subsection is devoted to the $k=1=2$ theory which was not included above, but we shall see that it shares $m$ any of the structures we uncovered throughout the last few sections.

### 5.1 The 3 super-sp in chain revisited.

In [9] an integrable sl(2j) invariant super-spin chain was studied using both analytical and num erical techniques. Its $H$ am iltonian acts on the tensor product (3 3$)^{\text {L }}$ where 3 and 3 stand for the representations $f 1=2 g$ in our previous term inology. It was argued that in the continuum lim it this chain ows to a SU (2j) W ZNW m odel at levelk $=1$. At the tim e, the W ZNW m odel on the supergroup SU (2j) had not been constructed and it seem s instructive to revisit the issue now on the basis of our im proved understanding of the continuum eld theory. W e shall see that the suggested identi cation with the continuum lim it of the spin chain can be $m$ aintained, but som e of the lattioe results receive an interesting reinterpretation.

Let usbegin by review ing brie y som e results on the spectrum of the lattioe model. In [9] it was found analytically that this spectrum exhibits a unique ground state at $\mathrm{h}=\mathrm{h}=$ 0, which lies in the single \true singlet" of the m odel, i.e. it is a sl(2 7 l) invariant state that is not part ofa larger indecom posable representation. This ground state corresponds to an extrem ely degenerate solution of the B ethe ansatz equations w here all roots collapse to the origin. Besides the ground state, $m$ any excited states were also found. The low est lying state above the ground state corresponds to a lled sea of som e (non com plex con jugate)
string com plexes. The rest of the spectrum is given by excitations obeying the usual pattem of holes and shifts of the sea. The scaled energies of these excitations over the ground state were found analytically to be

Here, N ; D are quantum numbers characterizing the Bethe ansatz solution. In the continuum lim it, the quantity (5.1) is expected to converge to $\mathrm{x}=\mathrm{h}+\mathrm{h}$ (allweights in the $\mathrm{c}=0$ theory), as usual. Form ula (5.1) indicates an in nite degeneracy of the level $\mathrm{h}=\mathrm{h}=1=8$ (obtained with $\mathrm{N}_{+}=\mathrm{N}=\mathrm{D}_{+}=\mathrm{D}=0$ say) in the lim it L! 1 . $N$ um erical studies con $m$ this behavior: Indeed, they show that that an in nite number of levels converges to $\mathrm{h}=\mathrm{h}=1=8$ as L increases. T his was already interpreted in [9] as indicating the existence of a continuum of conform alweights starting at $\mathrm{h}=\mathrm{h}=1=8 \mathrm{in}$ the therm odynam ic lim it.

A theough an analytical study of the asym ptotic corrections to (5.1) seem s still out of reach, num erical studies in a closely related $m$ odel suggest that the leading contributions to $C_{N}$ and $C_{L}$ can be well tted by the formulas

for large num ber 2L of lattice sites. W hen these leading term s are plugged back into the formula (5.1) for the spectrum of the lattice $m$ odel, we see that the second line resem bles very $m$ uch the spectrum of a free boson which has been com pacti ed to a circle $w$ th radius square of the order ln L . In other words, if we assum e that eqs. (52) are correct, the contribution from the \antisym $m$ etric sector" (ie. form excitations for which $\mathrm{N}+\mathrm{N}$ or $\mathrm{D}_{+} \mathrm{D}$ are non zero) to the partition function can be estim ated as

where ( $q$ ) is D edekind's eta function, as before. The divergence is proportional to $R$, i.e. to the size of the target space, as expected. W e conclude that in the lattioe m odel, the contribution from the antisym $m$ etric sector to the partition function $m$ ultiplies the contribution from the sym $m$ etric sector in eq. (5.1) by a term of the order of $p \overline{\ln L}$. The ground state $m$ eanwhile, being a very degenerate Bethe ansatz solution, does not com e w ith such an extra factor. T he generating function of levels in the periodic sector will therefore have the form

$w$ here the dots represent excitations from the sym $m$ etric sector in (5.1).
The rst conclusion we draw is that the contribution of the continuum com pletely overrides the one from the discrete state (as would be the case in any quantum $m$ echanics problem with discrete states and a continuum with delta function norm alizable states), and that a properly nom alized partition function does not see the singlet $w$ ith $h=h=0$. $T$ he resulting ob ject is in good agreem ent w ith our con jectured partition function (4.17).

Reference [9] contained various failed attem pts to build a conform al eld theory containing both the continuum of representations fb; $j=1=2 g$ and a single identity eld associated w ith the representation $f 0 \mathrm{~g}$. G iven our new insight into the continuum m odel, the problem $s$ to incorporate the singlet state $m$ ay not come as a com plete surprise. A $1-$ though the free eld construction at k = 1 suggests the possibility of sm aller theories, the study ofm odular invariants (as well as of four point functions, as we m entioned above) seem s to prechude the appearance of the singlet representation on its own-ie. without being part of a big indecom posable w ith vanishing super-dim ension. In addition all the states we found in the continuum approach were non norm alizable. B oth observations lead us to speculate that eq. (4.17) represents the full operator content of the continuum lim it, and that there is no discrete state associated with a true singlet. P ut di erently, the new investigation suggests that the true singlet observed on the lattioe is an artifact of the regularization and does not belong to the continuum lim it. O ur new interpretation of the lattice results receives additional support from the very singular nature of the Bethe ansatz solution that corresponds to the singlet state. It would be interesting to check further the decoupling of the true singlet by studying the scaling behavior ofm atrix elem ents of lattice regularized current algebra generators.

There is one $m$ ore potential ob jection one $m$ ight raise. $N$ ote that in our continuum theory ferm ionic and bosonic states are perfectly paired so that the $W$ itten index of the SU (2 71 ) W ZNW m odel is guaranteed to vanish. M eanwhile, for our lattice spin chain on the space (3 3) L one nds an excess by one for the num ber of bosonic states over the num ber of ferm ionic ones. H ence, the $W$ itten index is non-zero on the lattice and one w ould naively expect the sam e to be true for the continuum lim it, in con ict w ith what we have proposed above. In order to resolve this issue, we suggest that there exist di erent spin chains which give rise to the same continuum lim it while possessing an excess of ferm ionic states over bosonic. M ore concretely, while we do not understand the whole structure yet, we have found 4 that the ground states of integrable chains of the type (3 3 ( $)^{\text {L }} 3$ and 3 (3 3$)^{\text {L }}$ scale to conform alw eight $h=0$ as well (in fact the ground state energy is given exactly by $\mathrm{E}_{0}=$ length $\quad e_{0}$ where $e_{0}$ has no nite size correction and is the sam e for all chains), but this tim e they com e in the representation 3 (resp. 3). O nce we sum over the various lattice $m$ odels, the balance between bosonic and ferm ionic states $m$ ay be restored even before taking the continuum lim it.

### 5.2 The W ZNW m odelat $k=1=2$

O ur investigation above w as restricted to integer levelk. But as w e have m entioned before, these are som e fractional values of $k$, in particular $k=1=2$, which play an im portant role for applications. W hile we are not prepared to give a system atic account on fractional level theories, we would like to discuss brie y a modelwith $\mathrm{k}=1=2$. O ur analysis will lead to the rem arkable conclusion that the basic structure of this m odel is essentially the sam e as for integer $k$, only that there exist several com ponents $w$ ithin the atypical sector, each of them being $m$ odeled after $J$.

In this case $k=1=2$, the relevant representation theory of the sl(2j) current algebra is particularly simple. In fact, all relevant representations can be obtained from the vacuum sector $f 0 g^{\wedge}$ through application of spectral ow symmetries. It is not di cult to show that at $k=1=2$ the autom onphism ${ }^{2}$ is inner, ie. ${ }^{2} \quad$ id. This m eans that application of ${ }^{2}$ does not lead to any new representations. The rem aining nontrivial autom orphism s are of the form $\stackrel{n}{+}$ with $n 2 \mathrm{Z}$ and $=0 ; 1$. W e shall denote the

By construction, this set closes under fusion. In fact, the fiusion product sim ply am ounts to a com position of the associated autom onphism .
$W$ th the exception of the sectors labeled by $n=0 ; 1$, the representations $f(n ;) g$ do not contain a highest or low est weight. The representation $f(0 ; 0) g$ is to be identied w ith the vacuum representation. $f(0 ; 1) g=f 0 ; 1=2 g^{\wedge}$ is the only other adm issible representation at $\mathrm{k}=1=2$. It is generated from the 4 -dim ensional typical multiplet $f 0 ; 1=2 g$ of ground states $w$ th conform al weight $h=1=2$. In addition, there are four $m$ ore highest/low est weight weight representations which are erected over the atypical discrete series representations $f(1 ;) g=f(; 1=4) g^{\wedge}$ and $f\left(1 ; g=f(+; 1=4) g^{\wedge}\right.$ corresponding to a negative spin $j=1=4$. The choige of the sign in the rst argum ent of the bracket determ ines on whether the representation is highest ( ) or low est (+ ) weight. $T$ he subscript, on the other hand corresponds to the tw o di erent choices of the param eter $b$ that $m$ ake these representations atypical. All four representations possess ground states of conform al weight $h=0$. In all other representations $f(n ;) g$ with jij 2 , the conform alweight is unbounded from below.

Since we can generate every representations from $f 0{ }^{\wedge}$, is su ces to display the character of the vacuum representation,

To derive the above character form ula and for the subsequent discussion we note that the $\operatorname{sl}(2 \mathrm{j} 1)$ current algebra at level $\mathrm{k}=1=2$ possesses a free eld representation which em ploys the sam e free elds as in the case of the $k=1$ theory, i.e. tw ofree bosonic elds
and 0 w th space-like and tim e-like signature, respectively, and a pair of sym plectic ferm ions ${ }_{1} ;{ }_{2}$. The bosonic sl(2j1) currents read

A sin the case of the $k=1$ theory, the free eld construction determ ines a consistent m odel $w$ ith a sl(2j1) current algebra symmetry. If we do not include the sym plectic ferm ions (note that onœ m ore the currents only involve derivatives), but only their derivatives then the state space reads

The space $H_{k=} \quad 1=2$ contains $R$ sector representations only, but it is certainly possible to include the NS sector by adding the im age under the spectral ow \#. Since this works just in the sam e way as above, we shall not repeat the discussion here.

Even though all the representations we are working with are atypical, the state space decom poses into irreducible building blocks. This is quite di erent from the structure of the atypical sectors $J$ ^ we described above. On the other hand, is is very sim ilar to one of the consistent theories w ith $k=1$ that we described at the end of section 42 . In the $k=1$ theory, the singular vectors of the indecom posable block $J^{\wedge}$ were decoupled by restricting to a theory that contained only derivatives of the ferm ionic elds. C onversely, the experience from $k=1$ suggest that in the $k=1=2$ case wem ay be able to construct a theory w ith a m ore com plicated atypical sector by including one or both of the sym plectic ferm ion elds 1 and 2 [22].

W e claim that in case we include both ferm ionic zero $m$ odes we end up $w$ ith an atypical structure that decom poses into four di erent blocks, each of them being built in the sam e
way as our sector $J$ ^. W e shall present the analysis only for the block that contains the vacuum sector $f 0 g^{\wedge}$. The other three sectors are obtained by acting with ; and + . Let us start our discussion w th the eld 12 . Any action w th V ; W and E will rem ove one of the two ferm ionic zero $m$ odes and hence 12 sits at the top of a sector $f 0 g^{\wedge}$. The action of $\mathrm{V}^{+} ; \mathrm{W}^{+}$and $\mathrm{E}^{+}$takes us from here into a set of elds which all contain a factor ${ }_{1}$. These elds can be shown to belong to a sector that is isom onphic to $\mathrm{f}(2 ; 0) \mathrm{g}={ }_{+}^{2} \mathrm{f} 0 \mathrm{~g}^{\wedge}$. Further application of $V$; W and E bring us to a set of elds that contain only derivatives of ferm ions. These form a subrepresentation $f 0 g^{\wedge}$ at the bottom of our atypical representation. A sim ilar analysis applies if we act with $V$; W and E
rst. This tim e, we descend to $f 0 g^{\wedge}$ via the sector $f(2 ; 0) g=+{ }^{2} f 0 g^{\wedge}$. C ontinuing along this line of thoughts, one can see that the sectors $f(2 n ; 0) g ; n 2 Z$; form the com position series for an indecom posable representation $J^{\wedge} w$ th $f(2 n ; 0) g$ in place of $f n=2 g$. The state space of the $m$ axim al theory therefore decom poses into four indecom posable blocks. O nce m ore, there are tw o interm ediate theories, each of which has four saw -blade shaped atypical sectors. They are obtained if we om it either 1 or 2 (but not their derivatives, of course) from the above $m$ axim al theory.

Even though we are not prepared to analyze W ZNW models for generic fractional levels, it is rem arkable that the structure we have rst uncovered in our m inisuperspace lim it, re-appears even for $k=1=2$. It seem $s$ very likely that the sam $e$ is true for a generic choice of the level.

## 6 C onclusions and O utlook

An obvious conclusion of our study is that W ZNW m odels on supergroups are interesting exam ples of logarithm ic CFT s, m uch richer than it has been anticipated in earlier works. G urarie (see [23] and references therein), for instance, argued that super W ZNW m odels with $\mathrm{c}=0$ could be considered as m ade of two \decoupled" com ponent theories w ith opposite values of the central charge, an observation justi ed in part by the fact that in the GL(1 1 ) W ZNW m odel, the stress energy tensor belongs naturally to a four dim ensional GL ( 1 ll ) multiplet in which $\mathrm{L}_{0}$ is diagonalizable, and hence $T$ has no \non trivial logarithm ic partner". The SU (2 1 ) W ZNW clearly does not obey any such decoupling. In fact, restricting to the right $m$ oving current algebra as in [23] we see that the identity eld belongs to a pro jective representation of the zero m ode algebra on which the C asim ir

- and hence $L_{0}$ - is not diagonalizable. Applying $L_{2}$ to this representation produces a V irasoro Jordan cell at level h = 2 and a non trivial logarithm ic partner of the stress energy tensor. This can be seen quite explicitely in the case $k=1$ where, with in the free eld representation (and sim ilarly to the case of sym plectic ferm ions), the eld

N ote that the whole structure of indecom posables is in fact $m u c h ~ m$ ore com plicated than envisioned in [23] when the interplay of left and right current algebras is taken into account.

Even though the structure of the state space is rather di cult when analyzed with respect to the com bined left and right action, it is surprisingly sim ple once we restrict to either the left or the right action alone. N ote that the Lie superalgebra sl(2j1) has a large num ber of indecom posables (see e.g. [11]) from which only a very distinguished sub-class does actually occur within the state space of our model. In fact, we have seen above that all states (both in the $m$ inisuperspace theory and the full eld theory) transform according to the so-called projective representations of sl(2j), ie. either in typicals and pro jective covers of atypicals. This is not to say, how ever, that other representations of sl(2jl) have no relevance for sigm a m odels on supergroups. In addition to the left and right regular representation there is yet one $m$ ore im portant sym $m$ etry that arises from the adjoint action of $\operatorname{sl}(2 \mathrm{jl})$ on the state space. W ith respect to the latter, states can transform in other indecom posables. The underlying $m$ athem atical structure tums out to be quite intriguing and will be described elsew here. Since the adjoint action is left unbroken by $m$ axim ally sym $m$ etric boundary conditions, the resulting decom position should have applications, in particular to the study of boundary conditions for sigm a $m$ odels on supergroups.

As a nal comm ent let us point out one generic feature we have encountered in both GL (1기) and SU (2기), nam ely that the contribution of the indecom posable sector J sim ply $m$ akes up for the subtractions in the atypical sectors of the theory, so that the partition function sees only contributions from K acm odules, and has a sim ple factorized form. This behavior is su cient for a m odular invariant partition function but it is not necessary.

The potentialexistence of di erent versions of the theory where only parts of the com plex $J$ appear, requires $m$ ore study. $W$ e note that som e hints in this direction are provided by the study of four point functions. In the case $k=1$, the four point function of the elds in the $f 0 ; 1=2 \mathrm{~g}$ representation has been studied in detail. It tums out that the K Z equations factorize, and that it is possible to decouple one conform alblock. Two blocks rem ain, leading to logarithm ic dependence, and indicating that the identity eld rem ains part of an indecom posable representation. This suggests that the sm allest theory, where the com plex $J$ is reduced to an in nite sum of irreducibles, cannot appear in the sl(2 11$)$ W ZNW model. In the case $\mathrm{k}=1=2 \mathrm{~m}$ eanwhile it is possible to decouple tw o conform al blocks, leaving only the identity eld, and indicating that the sm allest theory does make sense this tim e-a feature consistent w th the free eld representation and the modular invariant. The sl(2ㄱㄱ) W ZNW m odel at fractional level and the explicit construction of consistent theories w ith a truncated atypical sector certainly deserve a m ore system atic investigation.

## 7 A ppendix A : The right regular representation

In this appendix we would like to prove the decom position form ula for the right regular representation. We shall use the same notations that were introduced in section 22. In order to analyze the decom position of the space of functions under the right regular action of sl(2j1), we shall rst study its restriction to the Lie sub-superalgebra $\mathrm{gl}(1 \mathrm{jl})$. M ore precisely, we shallm ake use of the follow ing em bedding

To begin $w$ ith, let us recall from [11] that an sl(2j1) representation descends on a pro jective representation of the em bedded $g l(1 \mathrm{j} 1)$ algebra if and only if is projective. O ur lemm a claim s that the gl(1 1 l) action on H contains only pro jectives. Hence, the sam e m ust be true for the right regular action of sl(2기).
