On the SU (2jl) W ZNW model and its statisticalm echanics applications

Abstract

M otivated by a careful analysis of the Laplacian on the supergroup SU (2j) we form ulate a proposal for the state space of the SU (2j) W ZNW model. We then use properties of \$l(2j) characters to compute the partition function of the theory. In the special case of level k = 1 the latter is found to agree with the properly regularized partition function for the continuum limit of the integrable \$l(2j) 3 super-spin chain. Some general conclusions applicable to other W ZNW models (in particular the case k = 1=2) are also drawn.

1 Introduction

The SU (2jl) W ZNW model is a key example of the sigm a models with supergroup targets that appear in the supersymmetric description of non-interacting disordered systems in low dimensional statistical mechanics. The rst occurrence of this model probably arose via a supersymmetrization of the path-integral for two copies of the two dimensional critical Ising model. It was shown in [1] how a system (with central charge c = 1) could be introduced to cancel out the pair of free M a prana fermions (regrouped for convenience into a D irac fermion) path-integrals

The theory without random m assm (x) = 0 is obviously a free O SP (2;2) theory, which can be considered as a SU (2;1) W ZNW m odel at level $k = 1=2^{1}$. A veraging over disorder produces a marginally irrelevant current current perturbation of this W ZNW m odel. This is crucial to understanding the (logarithm ic) corrections to pure Ising m odel scaling. The deep infrared (IR) behavior however is not changed by the disorder, which corresponds to the fact that (1.2) is a simple free theory, with pure ferm ionic correlators identical to those of the usual Ising m odel.

The second occurrence of the SU (2jl) model is more involved. It arises in the study of 2 + 1 dimensional spin-full electrons in the presence of a random (non abelian) gauge potential. The supersymmetrization of the path integral for two copies of the D irac ferm ions produces a free O SP (4j4) theory which has been argued to ow to the SU (2jl) W ZNW model at level one under the action of the disorder [2]. The nature of the spectrum and correlation functions play an important role in the description of the electronic wave functions at that xed point.

P revious works on the SU (2jl) m odel have focused on some correlation functions [3], [4]and on the construction of some characters [5], but a complete picture of the theory has been m issing.

Indeed, the analysis of W ZNW on supergroups is notoriously di cult, even for the sim plest case of GL (1jl) [6]. In a recent paper [7], we have shown how a careful study of the particle lim it (in particular, of the sim ultaneous left and right invariant actions on the space of functions on the group) could provide considerable insight into this problem. C om bining this insight with som e additional input from the representation theory of the current algebras allowed us to form ulate a com plete proposal for the state space of the theory in the case of GL (1jl). The latter involves a rather intricate m ixing of left and right m overs that is intim ately related to the representation theory of L is superalgebras, in particular to the importance of indecom posable representations. W e were then able to check this proposal through an exact construction of the theory in the continuum form ulation.

The aim of this work is to extend the lessons we have learned in [7] to a non-abelian setup, using SU (21) as the simplest non-trivial example.² Once more, the analysis of the particle limit (section 2) along with some input from the representation theory of the sl(21) current algebra (section 3) shall provide all the necessary ingredients for the construction of the eld theory state space (section 4), in close analogy to our previous investigation of the GL (1jl) model. In the present case we shall not attempt to verify the structure of the state space through calculations of correlators, though this would be possible as well (see [8]). Instead we shall use results on an integrable sl(2]1) spin chain to test our continuum constructions. Such a spin chain was rst investigated in [9] as a discrete version of the SU (2jl) W ZNW model. We shall see that both approaches are consistent. The comparison, however, is a bit subtle, mainly due to the fact that the supergroup SU (21) has an inde nite metric. W hile this poses no problem for the (algebraic) conformal eld theory analysis, the computation of the partition function on the lattice su ers from divergencies which need to be regularized. We shall do this through som e appropriate analytic continuation. In this sense, our analysis also supports a particular prescription for extracting information from spin chains with an inde nite metric.

 $^{^{2}}$ To be more precise, we shall consider the universal cover of SU (2jl) in which the abelian, time-like circle is replaced by the real line. We shall comment on this in much more detail in section 4.

2 The minisuperspace analysis

The aim of this section is to decompose the space of functions on the supergroup SU (2jl) into (generalized) eigenfunctions of the quadratic Casim ir element in the regular representations. Since the Casim ir commutes with the generator, the eigenspaces may be decomposed into representation of the Lie superalgebra sl(2jl). It is therefore useful to have some background on the representation theory of sl(2jl). We shall review a few known facts below before addressing the harmonic analysis. More details can be found e.g. in [10, 11].

2.1 The Lie superalgebra sl(2jl)

In this subsection we provide a short overview on nite dimensional representations of sl(2jl). Rather than reproducing a complete list of such representations we shall focus on those that are relevant below, namely on K ac modules and the projective covers of atypicals.

2.1.1 The de ning relations of sl(2jl)

The even part $g^{(0)} = gl(1)$ sl(2) of the Lie superalgebra g = sl(2jl) is generated by four bosonic elements H, E and B which obey the commutation relations

In addition, there exist two ferm ionic multiplets (F^+ ; F^-) and (F^+ ; F^-) which generate the odd part $g^{(1)}$. They transform as $(\frac{1}{2};\frac{1}{2})$ with respect to the even subalgebra, i.e.

F inally, the ferm ionic elements possess the following simple anti-commutation relations

among each other. Formulas (2.1) to (2.3) provide a complete list of relations in the Lie
superalgebra $sl(21)$.

2.1.2 K ac m odules and irreducible representations

K ac m odules [12] are the basic tool in the construction of irreducible representations. In the case of g = sl(2jl), these form a 2-parameter family fb; jg of 8j-dimensional representations. We may induce them from the 2j-dimensional representations (b $\frac{1}{2}$; j $\frac{1}{2}$) of the bosonic subalgebra $g^{(0)}$ by applying the pair F of fermionic elements. Our label b 2 C denotes a gl(1)-charge and spins of sl(2) are labeled by $j = \frac{1}{2}$; 1; :::. The dual construction which promotes the fermionic generators F to creation operators, yields anti-K ac m odules fb; jg (b and j take the sam e values as above). The bosonic content of (anti-)K ac m odules may be read or rather easily from their construction,

For generic values of b and j, the m odules fb; jg and fb; jg are irreducible and isom orphic. At the points b = j, however, they degenerate, i.e. the representations are indecom posable and no longer isom orphic. In fact, K ac and anti-K ac m odules are then easily seen to possess di erent invariant subspaces. To be m ore precise the (anti-)K ac m odules f j; jg and f j; jg are built from two atypical representations such that

The atypical irreducible representations fig that appear in these small diagrams are 4j + 1 dimensional. With respect to the even subalgebra they decompose according to

For j = 0, only the trivial representation (0) occurs. It is also useful to introduce the characters of these representations. By de nition, these are obtained as

where the super-trace extends over all states in the representation R of sl(2jl). For K ac modules the character is rather simple. In fact, it factorizes

The characters of atypical representations can be obtained easily form their decomposition formulas (2.6). We would like to pursue a rather dierent route here that uses the decomposition (2.5) of Kacmodules into atypicals. The rst formula implies that

F igure 1: A graphical illustration of how characters for an atypical representation can be obtained as an in nite sum of characters of K ac modules. Here the one dimensional atypical identity 0 appears as a sum over f1=2;1=2g (thin lines and dots), f1;1g (medium lines and dots), f3=2;3=2g (thick lines and dots) etc. All spurious contributions (that is, the whole tower but the origin) appear twice, and they disappear by cancellations of bosonic and ferm ionic degrees of freedom. The diagram corresponds to the choice of plus sign in form ula (2.8).

O nem ay check by explicit computation that the contributions from allbut two bosonic multiplets cancel each other in the in nite sum through a mechanism that is visualized in Figure 1. The remaining two terms certainly agree with the decomposition formulas (2.6). Our derivation here may seem like a rather complicated path for such a simple result, but we shall see later that the same trick works for characters of atypical a ne representations which are otherwise di cult to obtain.

2.1.3 Projective covers of atypical irreducible modules

By de nition, the projective cover of a representation fig is the largest indecom posable representation P (j) which has fig as a subrepresentation (its socle). We do not want to construct these representations explicitly here. Instead, we shall display how they are composed from atypicals. The projective cover of the trivial representation is an 8-dimensionalm odule of the form

These representation spaces are 16j + 4-dimensional. Let us agree to absorb the superscript on P into the argument, i.e. P (j) = P (j), wherever this is convenient.

2.2 Functions on the supergroup SU (2])

Now we are prepared to analyze the space of functions on the supergroup SU (2jl). For this purpose, let us introduce coordinates through the following explicit decomposition of elements U 2 SU (2jl),

Here, the bosonic base SU (2) R is parametrized by an element g = 2 SU (2) = S^3 along with the time-like variable z. In these coordinates, the generators of the right regular

M atrix elements with j = 1=2 appear as coe cients in the dimensional operators R _F and their behavior under the action of R⁰_X plays an important role in checking that the above generators of the right regular representation obey the dening relations of sl(2jl). Form ulas for the left regular representation may be obtained similarly,

It is probably not necessary to stress that left and right generators (anti-)commute with respect to each other.

By construction (see however [8]), the generators of the left and right regular representation act on the space of all G rassm ann valued functions with square integrable coe cients on the bosonic base, i.e. on the space

where (;) denotes the G rassm ann algebra that is generated by our four ferm ionic coordinates and . W ith respect to the left regular action, the space of square integrable functions can be shown to decom pose as follows,

Here, the sum mation runs over $j = 0; 1=2; 1; \ldots$, fb; jg denotes the typical representations of sl(2jL) and P_j are the projective covers of the atypical representations fjg. Most of our conventions can be found e.g. in [10]. A prime ⁰ on a representation means that the degree is inverted, i.e. that ferm ionic vectors become bosonic and vice versa. The result is a special case of the general observation made in [13] and it generalizes a similar decomposition we described in [7] for the left regular action of gl(1jL). The interested reader can ind an explicit proof in Appendix A. Let us comment that the decomposition of the left regular action of the projective covers P_j, the Laplacian on the supergroup SU (2jL) can only be brought into Jordan norm al form. The blocks can reach a rank up to three.

The functions on our supergroup carry another (anti-)commuting action of the Lie superalgebra g by left derivations. There is a corresponding decomposition which is certainly identical to the decomposition above. A more interesting problem is to decompose the space of functions with respect to the graded product g g in which the rst factor acts through the left regular action while for the second factor we use the right regular action. In the typical sector, the 4jj4j-dimensionalmultiplicity spaces in the rst line of eq. (2.17) get promoted to typical representations of the right regular action, i.e.

where J is a single indecomposable, containing all the atypical building blocks. Its structure may be summarized by the following picture



This diagram is the natural extension of the corresponding picture for GL(1jl). It extends to in nity in both directions and combines all the atypical sectors into a single indecom possible representation. Note that by construction, each projective cover in the decom position of the right regular representation appears with the correct multiplicity. W e shall see below how this picture is modiled in the full quantum theory.

3 Representation theory of the a ne algebra

The previous analysis of the particle lim it applies to all sigm a models on SU (2jl), but the information it provides is usually not su cient in order to reconstruct the entire eld theory from it. This is very dierent for the W ZNW model in which the entire spectrum can be generated from particle wave functions through current algebra symmetries. We need some facts on the representation theory of the sl(2jl) current algebra and shall provide them in the following section. All the results we collect here are well known from [14, 5, 15, 16, 17]. Their derivation, however, is somewhat original. In particular, we shall use a simple, but highly e cient prescription to construct characters of atypical representations of sl(2jl) through in nite sums over typicals. This extends the form ula (2.8) we have discussed in section 2 to an in nite dimensional setting, thereby generalizing a trick that has insticent proposed in the context of the gl(1jl) current algebra [18].

3.1 Som e basic ingredients

Irreducible representations of the a ne sl(2jl) algebra can be built over the irreducible typical representations fb; jg with j = 1=2; ...; k=2 as well as over the atypicals f jg with j = 0; 1=2; 1; ...; k=2. G round states in the form er set of representations possess conform aldimension

while the conform aldimension for ground states in the latter set vanishes. Following the work [14] of Bow cock et al. we shall divide these representations into three di erent classes. The generic class I representations occur for fb; jg with $b \notin j_m$ where we de ned

C lass II representations include those erected over fb; jg with $b = j_n$; $m \in 0$; along with the sectors generated from atypicals fjg; j $\in 0$. The vacuum representation that is generated from the atypical f0g is the only member of the nalclass, which we denote as class IV for historical reasons. Our aim is to describe the singular vectors in the corresponding Verm a modules and to provide the associated formulas for the super-characters

of irreducible representations. The results we describe have stappeared in [14].

Before we start our discussion of characters let us quickly recall that it is possible to construct sl(2jl) currents in terms of decoupled bosonic and ferm ionic variables. To be more precise, we introduce a set of bosonic currents e (z);h(z);b(z) and assume them to satisfy the operator product expansions of an a ne sl(2) algebra at level k 1. In addition, let us introduce two sets of ferm ionic elds p^a and a obeying the canonical relations

Then we can construct an sl(2jl) current algebra at level k through the following prescription,

Since the fermionic elds ^a and p^a are supposed to commute with the bosonic elds e (z); h(z) and b(z), the characters of typical representations factorize with the factors $_1$ (y; q) arising from the fermionic pairs. The shift j ! j 1=2 in the bosonic contribution m ay be traced back to a similar shift in the labeling of typical sl(2jl) representations, see eq. (2.4).

3.2 Typical (class I) representations

The generic class I representations have no singular vectors except from the ones that arise through the representations of a bosonic su(2) current algebra at level k 1. In this sense, they may be considered the typical representations of the a ne sl(2j) algebra.

The statem ent implies a precise expression for the characters of class I representations

We shall use the symbol fb; jg^{\circ} for these irreducible representations of the a ne algebra. The form ulas are easy to understand: they follow directly from the representation (3.1) of the sl(2jl) current algebra. In fact, each pair of ferm ionic elds contributes a factor ₁= while the bosonic sl(2) and u (1) current algebras are responsible for the characters ^{k 1} and an additional factor ¹, respectively.

3.3 A typical (class II) representations

N othing prevents us from evaluating the previous character form ulas at the points $b = j_n$. But the resulting functions turn out to be the characters of indecom possible representations fj_n ; jg^n which contain one ferm ionic singular multiplet. In order to state this more precisely, let us consider in more detail the set of atypical labels,

The set A is visualized in Figure 2.0 ur picture shows clearly that the projection to the b-coordinate of each element in A is injective and hence it can be used to enumerate our atypical labels. Note, however, that values b 2 (k + 1)=22 are om itted. This motivates to introduce an improved enumeration map ^ from A to non-zero half-integers which is de ned by

By construction, $\hat{}$ is not only an injection but its image now also consists of all nonzero half-integers. We may view $\hat{}$ as an a neversion of the enumeration map $(f_{j_n}^+;jg) = j$ for representations of sl(2j1).



Figure 2: The set A of atypical labels for the a ne sl(2jl) algebra. Even though the sl(2) spin j is cut o at j = k=2, there exist in nitely many atypical labels (black dots) which are in one to one correspondence with the atypical labels of the nite dimensional algebra sl(2jl) (central black and pink dots). This correspondence is form alized by our map ^.

At rst sight, the enumeration of atypical labels for our sl(2jl) current algebra m ay seem like a rather technical device. But there is more to it. We recall that atypical labels f j; jg can also be enumerated by non-zero half-integers, i.e. (f j; jg) = j. 0 ur claim now is that the atypical class I representation with label fj_m ; jg behaves very similarly to its nite dimensional counterpart $1 - (f_m j; jg)$ in the sense that

This formula is a rather central result for the representation theory of our current algebra. Let us stress that it is the a ne version of a corresponding equality (2.7) between characters of sl(2j) representations. As in the nite dimensional setup, eq. (3.4) emerges from the existence of ferm ionic singular vectors in atypical class I representations. In the case m = 0, it claims that the only such singular vectors are those that appear in the atypical K ac-m odule spanned by the ground states. When $m \in 0$, however, the ground states form a typical representation and the singular vectors appear only on the jm f^{h} level of the class I m odule.

At rst it may seem a bit surprising that a ne representations fj $_{m}$; jg and m ϵ 0 behave so similarly to the Kac modules of sl(2jl). In the next subsection we shall understand this behavior in term s of spectral ow sym m etries in the representation theory of the current algebra. Before any study of spectral ow autom orphism s, it m ight be useful to illustrate the sin illustry between atypical representations of the current algebra and their nite dim ensional counterpart m ore explicitly, at least for one example. To this end, let us focus on the representation fk=2+1; $k=2g^w$ high we claim to be a close cousin of the sl(21)representation fk=2 + 1=2; k=2 + 1=2 By construction, the ground states of the current algebra representation transform in the typical multiplet fk=2+1; k=2g and they possess 1. From these vectors we can generate states with vanishing conform al weight h =conform alweight with the help of modes in the current algebra. Such modes transform in the 8-dimensional adjoint representation $f0;1g ext{ of sl}(21)$. Through decomposition of the tensor product between fk=2+1; k=2g and f0; 1g one nds that the Verm a module over fk=2+1=2;k=2+1=2g contains an atypical sl(2j) multiplet with conform alweight h=0. In fact, the results of [11] in ply that the latter transforms according to the projective cover P (k=2+1=2), see eq. (2.10). Not all of these states survive when we descend from the Verm a module to the class I representation. This step involves removing bosonic singular vectors and a m om ent of re ections show s that such vectors with h = 0 exist and that they transform in the submodule fk=2+1; k=2+1; gofP(k=2+1=2). Hence, the states with h=0in our class I representation decompose into the K acm odule fk=2 + 1=2;k=2 + 1=2g plus a bunch of typical representations. The ferm ionic singular vectors that are responsible for eq. (3.4) transform in the subrepresentation fk=2;k=2g of fk=2+1=2;k=2+1=2g, giving rise to the identity (3.4) with $j_1 = k=2+1$ and j = k=2.

Before we draw some conclusions from eq. (3.4), let us quickly comment on our notations. Note that for j = 1=2 and m = 0 the above formula involves the character I_{fog}^{II} of a representation which has a somewhat special status. In fact, it cannot be obtained as quotient of one of the indecom posable representations f_{j_n} ; jg², unlike the representations with characters $\prod_{fn=2g}^{II}$; $n \in 0$; Instead, it arises as a submodule of the representations $f = 1 = 2; 1 = 2g^{\circ}$. Our discussion suggest that \prod_{fog}^{II} must be the character of the vacuum representation. In the term inology of Bow cock et al. the latter is a class IV representation. Thus, we shall also write \prod_{fog}^{IV} for this quantity.

Even though equation (3.4) is not a closed form ula for the characters of class II representations, we can now use the same trick as in section 2.1.2 and write characters of class II representations as an in nite sum of class I characters,

Character form ulas of this type have to be used with some care: Before the denom inators are expanded, one should spit the summation over a into two parts. The one arising from positive values of a can be converted into a power series right away. In all terms with non-negative a, however, one must rst reduce the fraction by q^a such that the subsequent expansion contains only non-negative powers of q. In the end, we recover the known results on the representation theory of the a ne sl(2jl) algebra [5, 17]. Our derivation was based on three ingredients: the decoupling form ulas (3.1) for bosonic and ferm ionic generators, the structure (2.5) of atypical K ac m odules for sl(2jl) and the fact that atypical class I representations with m \notin 0 decompose in the same way as in the case of m = 0. We shall argue now that the last ingredient emerges from spectral ow symmetries in the representation theory of a ne sl(2jl).

3.4 Spectral ow symmetries

The a ne sl(2jl) algebra admits several interesting automorphism s. We shall be mainly concerned with two such spectral ow automorphism s .By construction, are dened

The latter m ay be obtained from the corresponding Verm a module by removing singular vectors on som e excited levels.

Hence, the existence of the spectral ow symmetries explains why the representations fj_n ; jg behave like atypical representations of the a ne sl(2jl) algebra: they are simply related to the sectors erected over atypical sl(2jl) representations by an automorphism.

3.5 M odular transform ation and S-m atrix

We would like to conclude this section on the representation theory of the sl(2jl) current algebra with a few comments on modular properties of the characters. In the following we shall consider the characters as functions of ; and . They are related to the variables we used above through q = exp 2 i; z = exp 2 i and = exp 2 i, as usual. From our explicit formula (3.2) for characters of class I representations it is easy to infer the auxiliary formula

We thus recover by this very elementary means the results of [5] obtained through use of the M ordell integral [19]. The construction of modular invariants using these transform a-tion form ulas is a complex problem, which we shall address later in the case k = 1.

4 The state space and partition functions

O ur aim now is to form ulate a proposal for the states space of the $sl(2jl) \le 2N \le m$ odel. We shall then verify our claim in the special case k = 1 through a free eld representation of the model. The third subsection is devoted to the partition function of the theory. The latter forgets all information about the complicated way in which irreducible blocks are glued together to build J. We then specialize once more to k = 1 and comment on the global topology of the target space.

4.1 The proposal for integer level k

It is now rather straightforward to come up with a proposal for the state space of the W ZNW modelon SU (2jl). In fact, we can simply depart from formula (2.18) and make it symmetric with respect to the action of our spectral ow symmetry. The invariance under the action of should be considered as an additional input. In principle, the spectral ow symmetry of the sl(2jl) current algebra could be broken by the physical couplings of the theory. Since this did not happen for the GL (1jl) W ZNW model, it seems natural to propose

where J° is a single indecomposable representation of the two (anti-)commuting super current algebras that contains all the atypical contributions. It is composed from the atypical building blocks fl_1g fl_2g in the same way as in the minisuperspace theory. To obtain the corresponding diagram one simply has to replace fjg = f jg with f jg².

By construction, all the sl(2jL) currents act on the state space (4.1) and they obey periodic boundary conditions. This applies in particular to the ferm ionic elds. One can nd a second, closely related theory in which only bosonic elds are periodic. In order to construct its state space, we need to revisit our discussion of spectral ow symmetries. As we have mentioned above, the autom orphism swe have investigated in the previous section all extend to the entire current algebra. In particular, they map ferm ionic modes with integer mode numbers onto each other, i.e. they respect periodic boundary conditions on the ferm ionic currents. There exists yet another in portant isom orphism that intertwines between integer and half-integer mode numbers for the ferm ionic generators. It can be considered as the square root of the autom orphism in the ferm ionic zero modes, the new isom orphism # is given by

extends to the full current algebra such that it acts trivially on the bosonic sl(2) currents and it shifts modes of the ferm ionic currents by 1=2, as usual.

O ur isom orphism # induces a m ap between representations of the current algebra with integer ferm ionic m odes and a new type of representations in which ferm ionic generators have half integer m ode numbers. A coording to the usual term inology, the form er class of representations form the R sector while the latter belong to the NS sector of the theory. The theory with state space (4.1) includes exclusively R sector representations in which all currents obey periodic boundary conditions. A nother option is to consider a theory that encom passes both R and NS sector with the state space given by

Note that the NS sector has exactly the same intricate structure as the R sector since the form er is the in age of the latter under the action of . In the following we shall refer to both models as W ZNW model on SU (2jl). Even though it seems natural to include the NS sector, it is not required by all applications.

4.2 Free eld representation at k = 1

So far, the main motivation for our proposal (4.1) came from the harmonic analysis on SU (2jl). By construction, we are guaranteed to recover the correct state space of the particle lim it when we send the level k to in nity. Our formula (4.1) applies to nite k and it suggest that eld theory e ects would merely truncate the spin j to an value j k=2 and then make the whole theory symmetric with respect to spectral ow. We are now going to test this proposal in the extrem e quantum case, namely at k = 1. At this point, the W ZNW model admits a free eld representation that we are going to spell out momentarily. It involves a pair of symplectic fermions $_1$; $_2$, and a pair of bosons ; 0 . W hile the boson comes with the usual metric, 0 is assumed to be time-like. For their propagators this means

Note that the central charge of this free eld theory is c = 2 + 1 + 1 = 0 and hence it agrees with the central charge of SU (2jl) W ZNW models. We shall begin our discussion of the W ZNW model with explicit formulas for the currents. In order to construct the four bosonic currents, we need to split the space-like bosonic eld (z;z) = '(z) + '(z) into its chiral components. Our bosonic currents then read,

W e shall com m ent on this a bit m ore later on.

It is possible to check that elds of dimension zero can be organized exactly as it is suggested by our diagram (2.19). We shall just sketch the relevant arguments because a full proof is rather laborious to write down. Let us consider the left part of the diagram only and identify the elds that make up the various blocks of the composition series. Clearly, the fOg fOg representation at the top corresponds to the eld $_{1\ 2}$. There are a number of interesting further comments and observations that we would like to make. Let us begin with a brief comment on the relation with K ac-W akim oto like representations of the form (3.1). As discussed in [8], a naive evaluation of the action of the latter on vertex operators leads to a much simpler picture in which the atypical sector is a smooth deform ation of the typical part. In particular, there is no mixing between left- and right movers as in the case of the representation J[^]. In order to see the latter, the screening charge of the K ac-W akim oto representation must be taken into account (see [8] for details). The free eld representation we have employed in this subsection is much simpler to use, but it is restricted to k = 1.

The free eld representation also allows us to illustrate very explicitly how atypical elds of dimension h = 0 are embedded into sectors with ground states in typical multiplets once their spin exceeds k=2. Take, for instance, the eld $0 = e^{i^{p} \overline{2}(' - '^{0})}_{2}$ from the

flg representation and observe that

This eld belongs to the typical representation f 3=2;1=2g in the sector flg with a ne highest weight $Q = e^{i('-3')}_{2} = 2 \cdot 0$ nem ay easily generalize these observations to all representations in the complex, hence con m ing our analysis based on spectral ow.

Let us nally come to the most in portant point, which concerns the possible construction of consistent theories³ that are realized on a subspace of our state space (4.1). Note that H does contain a large number of ferm ionic singular vectors that we decided not do decouple, partly because the minisuperspace analysis suggested that it was unnatural to do so. But to a certain extend one should consider (4.1) as som e kind of maxim al choice from which other models can be obtained by consistent decoupling of singular vectors. In general there can be several such reduced theories. Once more we may use our free eld representation for the k = 1 m odel to illustrate nicely how this works. Note that the expressions (4.4) for the currents only contain derivatives of the ferm ionic elds. Hence, we do not spoil the sl(2] ourrent algebra sym metry if we decide to work with a model in which the fundamental elds are e.g.; 0 ; ${}_{2}$ and 0 ${}_{1}$. Since ${}_{1}$ is not part of this model, som e of the sectors we discussed above do no longer appear. This concerns the sectors f0g and f1=2g f1=2g₊ on the top oor of $J^{\hat{}}$ and the sector f0g f1=2q₊ on f0q the interm ediate oor. In the resulting model, there is still a single atypical sector that com prises all the irreducible atypicals, but it is reduced to two oors and has the shape of a saw blade. O by jourshy, a similar analysis applies to the theory that contains @ 2 instead of $_2$. But we can even go one step further and drop both $_1$ and $_2$ so that only ferm ionic derivatives remain. W hat results is a model whose atypical sector decomposes into an in nite sum of irreducibles. The latter are the sectors that appear on the bottom oor of J[,], i.e. f0g f0g and f1=2g f1=2g₊ from our list above. All others need either $_1$ or $_2$. Similar phenomena are possible at other levels. We shall see another explicit example in section 5.2. Let us stress, however, that the free eld construction at k = 1does not include the \de ning" f0;1=2q eld of the W ZNW model. A careful study of

the Knizhnik-Zam olodchikov equations [3, 2] shows that consistency in the presence of the f0;1=2g sector requires the identity eld to be embedded into an indecom posable sector. In this sense, the fully truncated atypical sector we have just described cannot be embedded into the sl(2]) W ZNW model.

4.3 Partition functions

W e now go back to the full theory based on our proposal (4.1). W e would like to compute the partition function of the model, with and without inclusion of the NS sector. Since partition functions are obtained by taking the trace over the state space, the details of the action of ferm ionic generators in the atypical sector J^{-} do not show up in the result. In other words, the contribution from the indecom posable J^{-} is the sam e as if we would take the trace over a sum of its irreducible components. The latter can be resum ed as follows,

In the last step we have inserted the relation (3.4) between characters of class I and class II representations and we used the isom orphism ^ to convert the sum over non-zero half-integers into a sum over m and j. Our result shows that the contribution from the atypical representations agrees exactly with the part that we om itted from the typical sector of the theory. Hence, the full partition function becomes

Let us also brie y discuss how the partition functions is modiled when we want to include the NS sector. In that case, the trace extends over both H_{CFT} and its in age under the spectral ow #. The modular invariant partition function Z'(q) of this theory contains four di erent terms, two in which $(1)^F$ is inserted and two in which it is not. It is custom any to label the corresponding contributions with R, sR, NS and sNS where the small s signals the insertion of $(1)^F$. W ith these notations, the standard super-characters we have discussed throughout the previous section should all carry a superscript sR. It is easy to not explicit form ulas for the other three sets of (super-)characters using the relation

The same prescription is used when we construct N S characters from the R sector, only that we have to replace the R supercharacters by ordinary characters. The partition function Z'(q), nally, has the same form as eq. (4.9) with an additional summation over all four types of term s.

Let us illustrate the previous results in the case of k = 1 again. The (sR) characters of this theory take a particularly simple form, as was rst observed by Bow cock et al. in [5],

This expression allows us to determ ine the modular invariant physical partition function Z'involving periodic or antiperiodic boundary conditions for the ferm ions along both periods of the torus. The doubly periodic sector (SR) gives a vanishing contribution for characters $_{fb;1=2g}$ since the super-dimension of the horizontal K ac modules vanishes. We are left with three contributions, which read respectively

O by iously, the dependence of these form ulas originates in the 1 = term in the characters, and has to be compensated by a similar factor coming from the b sum in order to obtain a modular invariant quantity.

The question we want to ask now is what kind of sum over b one should consider. It seems at ist sight that, since we are dealing with SU (2jl), the b number should be discrete, in agreement with the imaginary exponential appearing in section 2.2 (note that this is also compatible with invariance under action of the spectral ow). It is likely that such a theory would make sense in genus zero. D i culties arise, how ever, when we try to establish modular invariance of the partition function, i.e. consider the theory in genus one. Indeed, even if b is discretized, there is no reason to truncate its range, and thus the naive spectrum of conform alweights is unbounded from below, and exhibits arbitrarily large negative dimensions. This should not come as a surprise since the metric on the group is not positive de nite, and thus the naive functional integral in the W ZNW model is divergent. W hat is required to obtain a physical partition function on the torus – one that could be compared with the spectrum of some lattice H am iltonian say – is some sort of analytic continuation.

This raises some interesting questions on which we would like to digress brie y. For a compacti ed time-like boson, partition functions would involve sum s of the form

This sum is obviously divergent, but one could be tempted to give it a meaning by analytical continuation from a similar sum with Re < 0. An equivalent problem arises when we try to continue a theta function such as

It is known that this continuation is not possible, since the function has singularities which are dense on the real axis (a quick proof is obtained by rst observing that is singular for an even integer, and then using modular transform ations). Theta functions have a natural boundary, and are simple examples of lacunary functions, i.e. \alm ost all" their Fourier coe cients are zero [20]. The partition function of a compacti ed time-like boson is thus a form allobject from which it is hard to extract physical meaning. On the other hand, without compacti cation, the partition function can easily be analytically continued. Indeed, replacing the discrete sum by an integral we have Z_1

hence compensating the factors coming from the functions in the characters. We note that the spectrum of conform alweights in the periodic sector is a continuum starting at h = 1=8. The eld with h = 0 does not appear.

In conclusion, the requirement for our theory to possess a \physical partition function" has forced us to let b be continuous. Geometrically, this amounts to a decompactication of the time-like circle. Hence we are led to consider the universal cover of SU (2jl) so that we can perform an analytical continuation on the number b. One may interpret the prescription that leads to the physical partition function as an elective change of the

target space along the lines advocated in [21]. Let us also stress that, while our arguments were based on the k = 1 theory, it is clear that a similar reasoning can be carried out for other levels.

The argument leading to b being continuous also seems to exclude the smaller theories where part of the complex J is dropped, at least for general values of k. We shall see an exception in the case k = 1=2 later.

5 Som e selected applications

This following section contains some selected applications of our general analysis. In the rst subsection we shall compare our results with studies of the continuum limit of the integrable sl(2jl) = 3 spin chain [9]. The agreement we not supports a new interpretation of lattice results. The second subsection is devoted to the k = 1=2 theory which was not included above, but we shall see that it shares many of the structures we uncovered throughout the last few sections.

5.1 The 3 3 super-spin chain revisited.

In [9] an integrable sl(2jl) invariant super-spin chain was studied using both analytical and num erical techniques. Its H am iltonian acts on the tensor product $(3 \quad 3)^{-L}$ where 3 and 3 stand for the representations f1=2g in our previous term inology. It was argued that in the continuum limit this chain ows to a SU (2jl) W ZNW model at level k = 1. At the time, the W ZNW model on the supergroup SU (2jl) had not been constructed and it seems instructive to revisit the issue now on the basis of our improved understanding of the continuum limit of the spin chain can be maintained, but some of the lattice results receive an interesting reinterpretation.

Let us begin by review ing brie y som e results on the spectrum of the lattice m odel. In [9] it was found analytically that this spectrum exhibits a unique ground state at h = h = 0, which lies in the single \true singlet" of the m odel, i.e. it is a sl(2jl) invariant state that is not part of a larger indecom possible representation. This ground state corresponds to an extrem ely degenerate solution of the B ethe ansatz equations where all roots collapse to the origin. B esides the ground state, m any excited states were also found. The lowest lying state above the ground state corresponds to a lied sea of som e (non com plex conjugate) string complexes. The rest of the spectrum is given by excitations obeying the usual pattern of holes and shifts of the sea. The scaled energies of these excitations over the ground state were found analytically to be

Here, N ;D are quantum numbers characterizing the Bethe ansatz solution. In the continuum limit, the quantity (5.1) is expected to converge to x = h + h (all weights in the c = 0 theory), as usual. Form ula (5.1) indicates an in nite degeneracy of the level h = h = 1=8 (obtained with $N_{+} = N_{-} = D_{+} = D_{-} = 0$ say) in the limit L ! 1. Numerical studies con m this behavior: Indeed, they show that that an in nite number of levels converges to h = h = 1=8 as L increases. This was already interpreted in [9] as indicating the existence of a continuum of conform alweights starting at h = h = 1=8 in the therm odynam ic limit.

A lthough an analytical study of the asymptotic corrections to (5.1) seems still out of reach, num erical studies in a closely related model suggest that the leading contributions to C_N and C_L can be well tted by the form ulas

for large number 2L of lattice sites. When these leading terms are plugged back into the formula (5.1) for the spectrum of the lattice model, we see that the second line resembles very much the spectrum of a free boson which has been compactiled to a circle with radius square of the order $\ln L$. In other words, if we assume that eqs. (5.2) are correct, the contribution from the \antisymmetric sector" (i.e. form excitations for which N_+ N or D_+ D are non zero) to the partition function can be estimated as

where (q) is D edekind's eta function, as before. The divergence is proportional to R, i.e. to the size of the target space, as expected. We conclude that in the lattice model, the contribution from the antisymmetric sector to the partition function multiplies the contribution from the symmetric sector in eq. (5.1) by a term of the order of $p = \frac{p}{\ln L}$. The ground state meanwhile, being a very degenerate Bethe ansatz solution, does not come with such an extra factor. The generating function of levels in the periodic sector will therefore have the form

where the dots represent excitations from the symmetric sector in (5.1).

The rst conclusion we draw is that the contribution of the continuum completely overrides the one from the discrete state (as would be the case in any quantum mechanics problem with discrete states and a continuum with delta function normalizable states), and that a properly normalized partition function does not see the singlet with h = h = 0. The resulting object is in good agreement with our conjectured partition function (4.17).

Reference [9] contained various failed attempts to build a conformal eld theory containing both the continuum of representations fb; j = 1=2g and a single identity eld associated with the representation flog. G iven our new insight into the continuum m odel, the problem s to incorporate the singlet state m ay not com e as a complete surprise. A L though the fire eld construction at k = 1 suggests the possibility of sm aller theories, the study of modular invariants (as well as of four point functions, as we mentioned above) seems to preclude the appearance of the singlet representation on its own - i.e. without being part of a big indecomposable with vanishing super-dimension. In addition all the states we found in the continuum approach were non normalizable. Both observations lead us to speculate that eq. (4.17) represents the full operator content of the continuum limit, and that there is no discrete state associated with a true singlet. Put di erently, the new investigation suggests that the true singlet observed on the lattice is an artifact of the regularization and does not belong to the continuum limit. Our new interpretation of the lattice results receives additional support from the very singular nature of the Bethe ansatz solution that corresponds to the singlet state. It would be interesting to check further the decoupling of the true singlet by studying the scaling behavior of m atrix elem ents of lattice regularized current algebra generators.

There is one more potential objection one might raise. Note that in our continuum theory ferm ionic and bosonic states are perfectly paired so that the W itten index of the SU (2jl) W ZNW model is guaranteed to vanish. Meanwhile, for our lattice spin chain on the space (3 3) ^L one nds an excess by one for the number of bosonic states over the number of ferm ionic ones. Hence, the W itten index is non-zero on the lattice and one would naively expect the same to be true for the continuum limit, in conict with what we have proposed above. In order to resolve this issue, we suggest that there exist di erent spin chains which give rise to the same continuum limit while possessing an excess of ferm ionic states over bosonic. More concretely, while we do not understand the whole structure yet, we have found ⁴ that the ground states of integrable chains of the type (3 3) ^L 3 and 3 (3 3) ^L scale to conform alweight h = 0 as well (in fact the ground state energy is given exactly by E₀ = length e₀ where e₀ has no nite size correction and is the same for all chains), but this time they come in the representation 3 (resp. 3). O nce we sum over the various lattice models, the balance between bosonic and ferm ionic states may be restored even before taking the continuum limit.

5.2 The W ZNW model at k = 1=2

O ur investigation above was restricted to integer level k. But as we have mentioned before, these are some fractional values of k, in particular k = 1=2, which play an important role for applications. While we are not prepared to give a system atic account on fractional level theories, we would like to discuss brie y a model with k = 1=2. O ur analysis will lead to the remarkable conclusion that the basic structure of this model is essentially the same as for integer k, only that there exist several components within the atypical sector, each of them being modeled after J.

In this case k = 1=2, the relevant representation theory of the sl(2jl) current algebra is particularly simple. In fact, all relevant representations can be obtained from the vacuum sector f0g[^] through application of spectral ow symmetries. It is not di cult to show that at k = 1=2 the automorphism ² is inner, i.e. ² id. This means that application of ² does not lead to any new representations. The remaining nontrivial autom orphisms are of the form $\frac{n}{4}$ with n 2 Z and = 0;1. We shall denote the

corresponding irreducible representations of the sl(2jl) current algebra by

By construction, this set closes under fusion. In fact, the fusion product simply amounts to a composition of the associated automorphism.

W ith the exception of the sectors labeled by n = 0; 1, the representations f(n;) g do not contain a highest or lowest weight. The representation f(0;0)g is to be identied with the vacuum representation. $f(0;1)g = f0;1=2g^{\circ}$ is the only other admissible representation at k = 1=2. It is generated from the 4-dimensional typical multiplet f0;1=2g of ground states with conform all weight h = 1=2. In addition, there are four more highest/lowest weight weight representations which are erected over the atypical discrete series representations $f(1;)g = f(; 1=4)g^{\circ}$ and $f(1; g = f(+; 1=4)g^{\circ}$ corresponding to a negative spin j = 1=4. The choice of the sign in the rst argument of the bracket determ ines on whether the representation is highest () or lowest (+) weight. The subscript, on the other hand corresponds to the two di erent choices of the parameter b that m ake these representations atypical. All four representations possess ground states of conform alweight h = 0. In all other representations f(n;)g with jnj 2, the conform alweight is unbounded from below.

Since we can generate every representations from $f0g^{2}$, is su ces to display the character of the vacuum representation,

As in the case of the k = 1 theory, the free eld construction determ ines a consistent m odel with a sl(2jl) current algebra symmetry. If we do not include the symplectic fermions (note that once more the currents only involve derivatives), but only their derivatives then the state space reads

The space $H_{k=1=2}$ contains R sector representations only, but it is certainly possible to include the NS sector by adding the image under the spectral ow #. Since this works just in the same way as above, we shall not repeat the discussion here.

Even though all the representations we are working with are atypical, the state space decomposes into irreducible building blocks. This is quite different from the structure of the atypical sectors J^{-} we described above. On the other hand, is is very similar to one of the consistent theories with k = 1 that we described at the end of section 4.2. In the k = 1 theory, the singular vectors of the indecomposable block J^{-} were decoupled by restricting to a theory that contained only derivatives of the ferm ionic from the symplectic theory with a more complicated atypical sector by including one or both of the symplectic ferm ion for elds $_1$ and $_2$ [22].

We claim that in case we include both ferm ionic zero modes we end up with an atypical structure that decomposes into four di erent blocks, each of them being built in the same

way as our sector J[^]. We shall present the analysis only for the block that contains the vacuum sector fOq° . The other three sectors are obtained by acting with ; + and + . Let us start our discussion with the eld $_{12}$. Any action with V; W and E will remove one of the two ferm ionic zero modes and hence $\frac{1}{2}$ sits at the top of a sector $f0g^{-}$. The action of V⁺; W⁺ and E⁺ takes us from here into a set of elds which all contain a factor 1. These elds can be shown to belong to a sector that is isom orphic to $f(2;0)g = \frac{2}{4}f0g$. Further application of V; W and E bring us to a set of elds that contain only derivatives of ferm ions. These form a subrepresentation flog at the bottom of our atypical representation. A similar analysis applies if we act with V ;W and E rst. This time, we descend to flog via the sector f $(2;0)g = \frac{2}{2}flog$. Continuing along this line of thoughts, one can see that the sectors f(2n;0)g;n 2 Z; form the composition series for an indecomposable representation $J^{\hat{}}$ with f(2n;0)g in place of fn=2g. The state space of the maxim altheory therefore decom poses into four indecom posable blocks. Once more, there are two intermediate theories, each of which has four saw blade shaped atypical sectors. They are obtained if we om it either $_1$ or $_2$ (but not their derivatives, of course) from the above maxim altheory.

Even though we are not prepared to analyze W ZNW models for generic fractional levels, it is remarkable that the structure we have not uncovered in our minisuperspace limit, re-appears even for k = 1=2. It seems very likely that the same is true for a generic choice of the level.

6 Conclusions and Outlook

An obvious conclusion of our study is that $W \ ZNW$ models on supergroups are interesting examples of logarithm ic CFTs, much richer than it has been anticipated in earlier works. G urarie (see [23] and references therein), for instance, argued that super $W \ ZNW$ models with c = 0 could be considered as made of two \decoupled" component theories with opposite values of the central charge, an observation justiled in part by the fact that in the GL (1jl) $W \ ZNW$ model, the stress energy tensor belongs naturally to a four dimensional GL (1jl) multiplet in which L_0 is diagonalizable, and hence T has no \non trivial logarithm ic partner". The SU (2jl) $W \ ZNW$ clearly does not obey any such decoupling. In fact, restricting to the right moving current algebra as in [23] we see that the identity eld belongs to a projective representation of the zero mode algebra on which the C asim ir - and hence L_0 - is not diagonalizable. Applying L_2 to this representation produces a V irasoro Jordan cell at level h = 2 and a non trivial logarithm ic partner of the stress energy tensor. This can be seen quite explicitly in the case k = 1 where, within the free eld representation (and sim ilarly to the case of sym plectic ferm ions), the eld

Note that the whole structure of indecom possibles is in fact much more complicated than envisioned in [23] when the interplay of left and right current algebras is taken into account.

Even though the structure of the state space is rather di cult when analyzed with respect to the combined left and right action, it is surprisingly simple once we restrict to either the left or the right action alone. Note that the Lie superalgebra sl(2jl) has a large num ber of indecom posables (see e.g. [11]) from which only a very distinguished sub-class does actually occur within the state space of our model. In fact, we have seen above that all states (both in the minisuperspace theory and the full eld theory) transform according to the so-called projective representations of sl(2]), i.e. either in typicals and projective covers of atypicals. This is not to say, however, that other representations of sl(2jl) have no relevance for sign a models on supergroups. In addition to the left and right regular representation there is yet one more in portant symmetry that arises from the adjoint action of sl(21) on the state space. W ith respect to the latter, states can transform in other indecom posables. The underlying mathematical structure turns out to be quite intriguing and will be described elsewhere. Since the adjoint action is left unbroken by maxim ally symmetric boundary conditions, the resulting decomposition should have applications, in particular to the study of boundary conditions for sign a models on supergroups.

As a nalcomment let us point out one generic feature we have encountered in both GL (1jl) and SU (2jl), namely that the contribution of the indecom possible sector J simply makes up for the subtractions in the atypical sectors of the theory, so that the partition function sees only contributions from K acm odules, and has a simple factorized form. This behavior is su cient for a modular invariant partition function but it is not necessary.

The potential existence of di erent versions of the theory where only parts of the com plex J appear, requires more study. We note that some hints in this direction are provided by the study of four point functions. In the case k = 1, the four point function of the elds in the f0;1=2g representation has been studied in detail. It turns out that the KZ equations factorize, and that it is possible to decouple one conform all block. Two blocks remain, leading to logarithm ic dependence, and indicating that the identity eld remains part of an indecom posable representation. This suggests that the smallest theory, where the com plex J is reduced to an in nite sum of irreducibles, cannot appear in the sl(2jl) W ZNW m odel. In the case k = 1=2 meanwhile it is possible to decouple two conform all blocks, leaving only the identity eld, and indicating that the smallest theory does make sense this tim e - a feature consistent with the free eld representation and the modular invariant. The sl(2jl) W ZNW m odel at fractional level and the explicit construction of consistent theories with a truncated atypical sector certainly deserve a more system atic investigation.

7 Appendix A: The right regular representation

In this appendix we would like to prove the decomposition formula for the right regular representation. We shall use the same notations that were introduced in section 2.2. In order to analyze the decomposition of the space of functions under the right regular action of sl(2jl), we shall not study its restriction to the Lie sub-superalgebra gl(1jl). More precisely, we shall make use of the following embedding

The main technical Lemma of this section implies that under the action of gl(1jl), the space H of functions on the supergroup SU (2jl) decomposes into projectives only.

Lem m a: Under the action of $R_X = R_{(X)}$ of the generators X 2 gl(1jl), the space H of functions of SU (2jl) decomposes according to

Here, T is a direct sum of typical gl(1jl) representations and P (a) denotes the projective cover of the atypical irreducible hai.

Before we prove this statement, let us formulate two consequences for the right regular representation of sl(2jl). To begin with, let us recall from [11] that an sl(2jl) representation descends on a projective representation of the embedded gl(1jl) algebra if and only if is projective. Our lemma claims that the gl(1jl) action on H contains only projectives. Hence, the same must be true for the right regular action of sl(2jl).

Proof of Lemma: For the proof it will be useful to introduce the following odd functions

It is not di cult to see that the space H is spanned by functions of the form
