## Therm odynam ical Properties of H all System s

#### A bstract

We study quantum Halle ect within the fram ework of a new ly proposed approach, which captures the principal results of some proposals. This can be established by considering a system of particles living on the non-commutative plane in the presence of an electrom agnetic eld and quantum statistical mechanically investigate its basic features. Solving the eigenvalue equation, we analytically derive the energy levels and the corresponding wavefunctions. These will be used, at low temperature and weak electric eld, to determ ine the therm odynam ical potential <sup>nc</sup> and related physical quantities. Varying <sup>nc</sup> with respect to the non-commutativity parameter , we de ne a new function that can be interpreted as a <sup>nc</sup> density. Evaluating the particle number, we show that the Hall conductivity of the system is -dependent. This allow s us to make contact with quantum Halle ect by o ering di erent interpretations. We study the high temperature regime and discuss the magnetism of the system . We nally show that at  $= 2\frac{1}{6}$ , the system is sharing some common features with the Laughlin theory.

### 1 Introduction

The quantum H alle ect (Q H E) [1] is a physical phenom enon that appears in two-dimensional electrons at low temperature and in the presence of a strong uniform magnetic eld. It is an interesting subject, not only because of its precise quantized plateaus of the H all conductivity [2], but also of its relationship to di erent theories and m athem atical form alism . N on-commutative (NC) geometry [3] is one of the m ost successful tools that has been used to deal with the basic features of Q H E. This is not surprising because this phenomena itself is of the non-commutative nature [4, 5]. In fact, to glue the system in the low est Landau level, the conming potential energy should be strong enough. Therefore particles can not jump to the next level because of the large gap energy. M athem atically this elect can be traduced by a non-commuting spatial variables.

There are several works have been reported on the subject by quantum mechanically studying spinlessparticles. A mong them, we quote the authors in [8] who analyzed electrons in uniform external magnetic and electric elds, which move in a plane whose coordinates are non-commuting. They tuned on the non-commutativity parameter such that electrons moving in the non-commutative coordinates are interpreted as either leading to the fractional Q H E or composite fermions in the usual coordinates. In fact, these results will be discussed in terms of our main idea that will be analyzed in the present paper.

M otivated by the intrinsic relation between the NC geometry and QHE, we develop an approach to investigate the basic features of QHE.Based on the statistical mechanics technical, we analyze the therm odynam ical properties of particles on the NC plane R<sup>2</sup>. In this analysis, we involve the spin as an additional degree of freedom. M ore precisely, we consider particles of spin  $\frac{1}{2}$  living on R<sup>2</sup> in the presence of an uniform electrom agnetic eld and study its therm odynam ical properties. Indeed, to characterize the system behaviour at low temperature as well as weak electric eld, we determ ine the therm odynam ic potential (TPO). This can be done by evaluating the corresponding physical quantities. G etting the particle number, we derive the H all conductivity  $_{\rm H}^{\rm nc}$  in term s of . It allows us to de ne the widths of di erent plateaus entering in the game as -function. M oreover by using some data, we show that can experimentally be xed. G iving di erent values to , we di erently interpret  $_{\rm H}^{\rm nc}$ . Taking advantage of the non-commutativity, we obtain a general results those can be used to explain fractional QHE, com posites fermions and multilayer H all system s. W e analyze with the non-commutativity form alism the high tem perature regime. In fact, the magnetism of our system will be discussed by writing down the critical point. In the end, we show that at the point =  $2\frac{2}{2}$  our system behaves like Laughlin one for the lling factor = 1.

The present paper is organized as follows. In section 2, the H am iltonian describing the system under consideration on the ordinary plane  $R^2$  will be given as well as its spectrum. This will be generalized by adopting the star product and therefore will o er for us a mathematical tools to deal with our proposal. In section 3, basing on the Ferm i{D irac statistics, we determ ine the corresponding partition function that leads to TPO. This will be used to de ne particle number, magnetization and

a TPO density. In section 4, using the standard de nition, we obtain a general form for the Hall conductivity. A fler getting the lling factor, we o er di erent interpretations and establish some links with other results related to QHE, in section 5. The high temperature analysis and the magnetism of the system will be considered in section 6. Section 7 will devoted to discuss the critical point, i.e.  $= 2\frac{2}{5}$ . We conclude and give some perspectives in the last section.

### 2 Ham iltonian and spectrum

To deal with our task, we need to x some m athem atical tools. Firstly, we de ne the H am iltonian system on R<sup>2</sup> and give its spectrum. Secondly, by adopting the NC geometry we show how the obtained results on R<sup>2</sup> can be generalized to those on R<sup>2</sup>.

# 2.1 Ordinary plane $R^2$

W e consider one particle of spin  $\frac{1}{2}$  and m ass m<sub>0</sub> living on R<sup>2</sup> in the presence of an magnetic  $B = B e_z$ and electric  $E = E e_y$  elds. Assuming that this system is conned in a nite surface such that  $S = L_x L_y$ . In the Landau gauge

the system is described by the Ham iltonian [6]

where m is the elective particle mass in a crystal lattice. In (2), the third term is resulting from the interaction between spin and B, the last is relecting the dipolar momentum and E interaction, g is the Lande factor and  $_{\rm B} = \frac{e^2}{2m_{\rm B}c}$  is the Bohr magneton.

The spectrum of H can analytically be obtained by solving the eigenvalue equation

for a weak electric eld. The wavefunctions corresponding to (4) are given by

where  $H_n$  are the Herm ite polynom ials and  $l_B = \frac{q}{\frac{\sim c}{eB}}$  is the magnetic length. This latter plays an important role in the QHE world. In fact, it do nes the area occupied by the quantum Hall droplet for particles in the lowest Landau level.

To close this part, we mention that the above results have been used to deal with the therm odynam ical properties for the H all particles of spin  $\frac{1}{2}$  on R<sup>2</sup> [7]. M ore precisely, integer Q H E as well as multilayer H all systems have been discussed. Later, we propose a new ly approach based on the NC geometry that captures the basic features of [7] and leads to di erent results.

# 2.2 N on-com m utative plane $R^2$

A swe claim ed before, to deal with our task we may proceed by using the NC geometry  $\beta$ ]. This can be done by introducing the commutator

where  $_{jk} = _{jk}$  is the non-commutativity parameter, is a real and free quantity. This relation can be realized by considering the star product de nition

where f and g are two arbitrary functions, supposed to be in nitely di erentiables. In what follows, we will use the standard commutation relations

supplemented by the relation (8), which together de ne a generalized quantum mechanics and leads to the standard case once is switched o.

Now we show how the above tools can be employed to de ne the non-commutative version of the Hamiltonian (2). In doing so, we start by noting that H acts on an arbitrary function (r;t) as

We have some remarks in order. First, comparing (2) with (12), one can see that (12) is including extra term s. O therw ise, it is clear that H <sup>nc</sup> is a generalized version of (2). Therefore, it is a good task to deeply investigate the consequences of H<sup>nc</sup> on the Halle ect. Second, according to (14) one can notice that there is a singularity at  $= 2\frac{2}{4}$  that should be taking into account. For this, we over a section to discuss how, at this point, the present system can be linked to the Laughlin theory. Third, without loss of generality, we assume that > 0 in the forthcoming study.

To fully establish ourm athem atical tools, we need to derive the spectrum of the non-commutative Ham iltonian (12). As usual, this can be achieved by solving the eigenvalue equation

As we will see later, this will be helpful in order to approximatively evaluate TPO on  $R^2$ . The wavefunctions can be obtained as U.

can be interpreted as an elective magnetic length. Moreover by analogy to  $l_B^2$ , (20) can be seen as an e ective area of the quantum Hall droplet on  $R^2$ . For = 1, we recover the spectrum of the system on R<sup>2</sup> given before.

At this point, we have settled all form alism needed to do our task. In fact, we will show it can be used to derive m ore general results those can be related to the real physical system s. In doing so, let us begin by evaluating di erent therm odynam ical quantities.

#### 3 Therm odynam ical properties

In dealing with QHE, we start by applying quantum statistical mechanics to derive di erent physical quantities. Indeed, we evaluate the partition function of our system in order to get the corresponding TPO. Subsequently, we introduce the Mellin transform ation to obtain a simplied form of TPO. Consequently, we end up with two di erent residues, which showing that TPO can be separated into two parts: monotonic and oscillating PTO's. Combing all to derive the particle number and related matters as well as discussing the magnetization.

#### 3.1 Therm odynam ic potential

Norm ally in statistical mechanics, TPO can be obtained by determining the partition function describing the system. In our case, it is de ned by

In the QHE world, it is well-known that N is an important quantity that should be determined. This comes from the fact that N is exactly the degeneracy of Landau levels, which denes the lling factor, see subsection (4.1).

To calculate (25), we need to introduce a relevant m ethod. This can be realized by m aking use of the M ellin transform ation. In general, it is de ned by

In conclusion, one has to distinguish two di erent cases. Firstly > 0, the sum of residues can be calculated at the negative poles in the real sem iaxis s = 0; 1; 2; 3; and in the in aginary sem iaxis at the poles  $s_1 = 2$  il—. Secondly < 0, the sum of residues can be calculated by closing the integration contour to the right, i.e. considering only the positive real sem iaxis, how ever the residues can be evaluated at the poles s = 1;2;3;.

It is not easy to directly evaluate <sup>nc</sup> in (30), but it can be achieved by introducing some approximations. For this, we consider the high and low temperature regimes as well as assume that the electric eld is weak. In doing so, we separate TPO into two parts: monotonic and oscillating.

#### 3.2 Low tem perature regime

To completely determ ine TPO, we consider two di erent cases those are low and high temperature regimes. Note that, the rst case is governed by the constraint . Since we have two poles, one can separate TPO into two parts, which are the monotonic  $m_0^{c}$  and oscillating  $m_0^{c}$  terms corresponding, respectively, to two poles s = 0 and  $s_1 = 2$  il-.

Now we evaluate each part separately. Indeed, using the residue m ethods, one can show that the m onotonic part is

Note that, in deriving  $_{os}^{nc}$  we have dropped the contributions resulting from other residues  $s \in 0$ , because they are exponentially small. On the other hand, the oscillating TPO can be evaluated by assuming that the condition - is holding. This implies that  $_{os}^{nc}$  can be written as

This function will play an important role in discussing QHE on  $R^2$ . In fact, we will see how it can be linked to the lling factor.

Statistical mechanics teaches us that the therm odynamical potential is the rst step that should be determined in order to study the system behaviour. This is because of its relationships to other physical quantities. To clarify this point, we start by evaluating the particles number:

which is depending to N and . In fact, this will be helpful in dening the Hall conductivity on R  $^2$  and thus getting its nalform .

It m ight be a good task to see how the m agnetization of the present system does look like. In doing so, we start by noticing that the m agnetic eld is along z-direction, then there is only one component follow ing the z axis of the m agnetic m om ent of particles on  $\mathbb{R}^2$ . It is given by

The obtained form of M  $_{b}^{nc}$  can deeply be investigated to m ake contact with early works on the m agnetization [9, 10, 11]. With this, one may have a full picture on the magnetism of the system at low tem perature.

We are not going to stop at this level in deriving physical quantities. In fact, since TPO is dependent, one may de ne a new function by making variation with respect to . This is equivalent to write

Because of has length square of dimension, thus  $\frac{nc}{b}$  can be interpreted as a TPO density of a system possessing as surface. This is the case for instance for a quantum H all droplet where its area is  $l_B^2 = \frac{-c}{eB}$ , which corresponds to  $= \frac{1}{2}$  in our case. Of course (45) goes to zero once we set = 1.

### 4 Hall conductivity

...

To make contact with the Hall e ect, we should determ ine the Hall conductivity in terms of our language. It can be done by adopting the usual de nition of the Hall current as well as using the Heisenberg equation for the particle velocity on R<sup>2</sup>. As we will see soon, these will o er for us a general form of the lling factor that can be used to show that our system is describing a real physics.

### 4.1 Filling factor on $R^2$

To establish di erent de nitions to deal with our issues on the generalized plane, let us sketch som e discussion about the Hall conductivity on  $R^2$ . We start from classical to quantum mechanics in order to emphasis the di erences.

Let us consider system of N particles living on the plane in the presence of magnetic  $\tilde{B} = B e_z$  and electric  $\tilde{E} = B e_y$  elds. Experimentally, the classical result is showing that the inverse of <sub>H</sub> is behaving like a straightforward line in terms of B, which has given birth to the Hall elect. Theoretically, this electric an be explained by studying Newton mechanically the motion of a Hall system. In the end, one can obtain the Hall conductivity

where the particle density  $=\frac{N}{S}$  is resulting from the Hall current de nition. This is showing how the conductivity is linked to the magnetic eld. Moreover, it is easily seen that (46) is actually re ecting the experiment result.

Now let us see how  $_{\rm H}$  does look like in quantum mechanics. Resorting the spectrum of the Hamiltonian describing the above system, without interactions, we can derive  $_{\rm H}$  in terms of the

fundam ental constants. This is

C learly, is actually m easuring di erent values of B for a xed density . Furtherm ore, to talk about QHE should be quantized over a large range of a strong m agnetic. This can be traduced by de ning as

where N represents also the degree of degeneracy of each Landau level. O therwise, is the ratio between particle number and number of the accessible states per Landau level. To get integer QHE or fractional QHE, should be, respectively, integrally or fractionally quantized.

In conclusion, we need to determ ine the analogue of on R<sup>2</sup> and see how can be used to o er di erent interpretations and establish som e links. To do this end, we assume that all de nitions above will be also valid on the non-commutative plane.

#### 4.2 E ective lling factor

A coording to the above analysis, it follows that the lling factor is a relevant quantity, which has to be determ ined in having the Halle ect. In doing so, we use (47) to write the non-commutative Hall conductivity as

where <sup>nc</sup> is its corresponding e ective lling factor. Using (49), <sup>nc</sup> can be seen as ratio between the particles number N  $_{b}^{nc}$  () and the degeneracy of the Landau levels N, i.e. quantum ux. O therwise, one may write <sup>nc</sup> as

This is more suggestive and thus one needs to look deeply for its interpretation. Moreover, we will see that the di erent intervals can be used to discuss a possible measurement of . These materials will be the subject of the next section.

W e still need di erent de nitions settled above for the Hall e ect on R<sup>2</sup>. Indeed, by comparing (48) with (58), it follows that one can de ne an e ective magnetic eld as

Equations (59) and (60) are interesting results in sense that they will be employed to clarify our motivation behind the present work. In fact, we use  $B_e$  and  $_e$  to o er some interpretations and also show di erent bridges between our proposal and some results related to QHE.

### 5 Interpretation

In the beginning, let us notice that particles of spin  $\frac{1}{2}$  living on R<sup>2</sup> when uniform external magnetic as well as electric elds are applied can be envisaged as the usual motion of particles experiencing an electric eld (59). This can be regarded as standard results, but let us go deeply to see what we can do with different values of .

#### 5.1 Measuring

It is a good job to look for an experiment realization of the non-commutativity parameter . For this, we over one possibility that can be used to identify our system to G aAs. In doing so, let us return to comment the lling factor (58).

It is clear that the widths of the plateaus coincide with di erent intervals appearing in di erent values of (58). For the second and third equations in (58), the widths, respectively, are given by

C onsequently, there are two critical points those should be discussed in order to get m ore inform ation about our system . These are

It turns out that  $g_{32}$  is important value because it is linked to the non-commutativity of the system. In fact, since is a free parameter one can get dierent  $g_{32}$  in order to link our system to dierent real physics systems. In what follows, we over an experiment measurement of by using some data. Indeed, according to [12] for the Hall system G aAs, we have

Thus, when  $64:6\frac{2}{8}$  lour system can be regarded as G aAs. In conclusion, this results is interesting in sense that one m ay use di erent experiment data to see how the non-commutativity parameter can experimentally be detected. Note that, one possibility has been realized by one of the present authors in [16].

### 5.2 Dayiand Jellal approach

D ayi and Jellal proposed an approach based on the NC geometry tools to describe the Halle ect of a system of electrons [8]. In fact, their corresponding lling factor is found to be

which is idential to the observed fractional values for FQHE. This approach also allowed to make a link with the composite ferm ion approach [14] by setting an elective magnetic eld

similar to that felt by the composite fermions, with  $l_B^0 = 2l_B$  and 0 is a non-commutativity parameter.

Now let see if the above approach has some overlapping with our analysis. We start by noting that the relations (67) and (68) have been obtained for a spinless electrons. The fact that of taking into account of spin as an additional degree of freedom plus the system con nement in rectangular area o ered for us a possibility to have plateaus and therefore an experiment measurement for . On the other hand, for zero spin, one may have the identication

This is showing that there is missing part of the lling factor, which is the odd values. Therefore, we have a partially integer QHE. To overcome this situation, we will show how to get a full picture of the integer QHE.

### 5.3 O ther approaches

We are looking for other explanations of our results. Indeed, by tuning on we over four di erent interpretations of  $_{\rm e}$ . These are related to integer QHE, fractional QHE, composite ferm ions and multilayer Hall system s.

Integer quantum Halle ect: it is corresponding to an integral quantized Hall conductivity, i.e. the lling factor is integer. To reproduce this e ect from our consideration, we simply set

which basically corresponds to is switched o. In this case our analysis coincide with that has been reported on the subject in [7]. Consequently, this result is showing that our approach is relevant for QHE and is general in sense that one can get other links.

Fractional quantum Halle ect: is one of the most interesting features of low-dimensional systems [13]. It is characterized by the observed Hall conductivity

where f is denoting the fractional quantized values of the lling factor : This e ect can be interpreted in terms of the Hall e ect on R<sup>2</sup>. More precisely, we identify the elective lling factor (60) with the observed value f by requiring that

This can be solved by considering dimentiplateau widths. A coording to (61), for W  $_{21}$  we get the rst critical value of

Therefore, when is xed to be  $f_i$ , with (i = 1;2), one can envisage the Halle ect on R<sup>2</sup> as the usual fractionalQHE on the plane.

Composite ferm ions: are new kind of particles appeared in condensed matter physics to provide an explanation of the behavior of particles moving in the plane when a strong magnetic eld B is present [14]. Particles possessing 2p, with p 2 N , ux quanta (vortices) can be thought of being composite ferm ions. One of the most important features of them is they feel e ectively a magnetic eld given by

To interpret particles of spin  $\frac{1}{2}$  living on R<sup>2</sup> in the magnetic eld B and electric eld E as the usual composite fermions we should tune on , such as

Therefore, composite fermions can be envisaged as particles living on  $R^2$  in the magnetic eld B and the electric eld E when we set =  $_{cf}$ .

Multilayers: structure form ed by several identical H all system s and its integral quantization of the total H all conductivity is given by [15]

where J is the number of the layers including in such structure and  $\frac{i}{H}$  corresponding the Hall conductivity in a single layer.

To describe the integer quantization of multilayers from the motion of particles of spin  $\frac{1}{2}$  on R<sup>2</sup> in the presence of B and E, one may quantize as

This is reacting that how this kind of Hall structures can be idential to our system living on the non-commutative plane.

In conclusion, by tuning on we got di erent interpretations. These concern integer QHE, fractionalQHE, CF as well as multy layer H all systems. Therefore, the above results are proving that our analysis is relevant for the H all e ect.

# 6 High tem perature analysis

To complete our analysis, we need to discuss the high temperature regime of the present system on the non-commutative plane. M athem atically, this regime is equivalent to have the limit . M oreover, our discussion will be achieved by requiring that the conditions 1 and < 0 are satisticed. These will be used to get the corresponding TPO and related matters. In particular, we analyze the magnetism by showing that there is a phase transition.

In getting TPO at high tem perature, we evaluate (30) by closing the contour to the right of the im aginary axis and taking the lower sign. This is

Similarly to low temperature case, we use (87) to derive some physical quantities. Indeed, from the standard de nition, we show that the particle number is

which is the general form that can be derived for particles of spin  $\frac{1}{2}$  living on R<sup>2</sup>. One may study its behaviour at dimension to see what make dimension with respect to low temperature case.

At this level, let us discuss the m agnetism that can be exhibited by our system at high tem perature. Indeed, we start by determ ining its m agnetization, which is

M ore precisely, this is showing that the system is behaving like a diam agnetic for  $g < \frac{1}{p_3}$ . However, it has a param agnetic nature if  $g > \frac{1}{p_3}$ . This is interesting in sense that one may dimensity x to get dimensional values and therefore dimensitions in real physical system s.

On the other hand, (92) can be employed to experimentally measure  $\$  . In doing so, let us solve (92) to nd

which is showing that the phase of our system is changing at this point. Therefore, it gives another way of making use of the evidently experiment of the non-commutativity parameter.

One can also de ne a TPO density at high temperature limit. A fler calculation, we end up with a new function as

W ith this we complete our analysis as concerning the high temperature regime. Of course, some questions related to the H all conductivity that should be investigated deeply.

# 7 Critical point

Finally, let us consider the critical point corresponding to the Ham iltonian describing the present system on the plane  $R^2$ . In fact, we show that the Laughlin theory can be recovered at this point. In doing so, let us return to (14) in order to notice

Indeed, it gives the Landau levels for the system con ned in LLL, since the term  $\frac{9}{8}mc^2 \frac{E}{B}^2$  can be dropped for a strong magnetic eld. Thus, one may write H <sup>nc</sup> j<sub>c</sub> as

corresponding to the lling factor  $=\frac{1}{m}$ , with m odd integer. These shown that the critical point leads to an interesting results and therefore needed to be investigated.

### 8 Conclusion

By considering a system of particles of spin  $\frac{1}{2}$  living on the non-commutative plane in the presence of a magnetic and a weak electric elds, we have investigated its basic features from quantum statistical mechanical point of view. After writing down the corresponding Hamiltonian, we have derived its

energy levels as well as the wavefunctions. They have been used to analyze the therm odynam ical properties of our system . M ore precisely, we have given the partition function that allowed us to get the associated therm odynam ical potential (TPO). Since a general form of TPO have been derived, we have introduced the M ellin transform ation to get a simplied TPO. To completely evaluate this latter, we have introduced some condition supplemented by separating two diment cases: low and high temperatures.

In the rst case, we have derived a general form of the Hall conductivity that lead to di erent results. Indeed, from our consideration and making using of the experiment data, we have given a way to measure the non-commutativity parameter . Subsequently, this has been tuned on to make contact with dierent results for QHE. In particular, we have obtained integer QHE simply by switching o . On the other hand, the observed fraction values, characterizing fractional QHE, have been recovered by xing . Moreover, we have shown that can be chosen to interpret our system as a collection of composite fermions or multilayer Hall systems on the ordinary plane.

In the second case, we have derived the particle number as well as the corresponding H all conductivity. To analyze the magnetism of our system, we have evaluated the magnetization. This allowed us to get a critical value in terms of  $\cdot$ . This has been used to discuss the phase transition between two sectors. In fact, they are obtained to be diam agnetic and param agnetic of nature. Furtherm ore, at the critical point, we have used the experiment data to  $\times$ .

Finally we have analyzed the critical point of our non-commutative Hamiltonian, i.e.  $= 2\frac{2}{B}$ . By making use of some rearrangement, we have ended up with one-dimensional harmonic oscillator. This latter is sharing many features with that corresponding to the lowest Landau level. Moreover, it has been used to make contact with the Laughlin theory.

Still som e questions to be addressed. At the critical point, one m ay think about m aking use the m atrix m odel theory to investigate therm odynam ical properties of the system in LLL.On the other hand, a link to the spin H alle ect deserves an attention. We hope to return to these issues and related m atter in forthcom ing works.
