Living on a dS brane: E ects of KK modes on in ation

We develop a form alism to study non-local higher-dimensional elects in braneworld scenarios from a four-dimensional elective theory point of view and check it against the wellknown Garriga-Tanaka result in the appropriate limit. We then use this form alism to study the spectrum of density perturbations during in ation as seen from the lower-dimensional elective theory. In particular, we not that the gravitational potential is greatly enhanced at short wavelengths. The consequences to the curvature perturbations are nonetheless very weak and will lead to no characteristic signatures on the power spectrum.

I. IN TRODUCTION

As an alternative to Planck-scale string compactications, braneworld models have recently received an increased interest from both cosm ologists and phenom enologists. One reason is because such theories generically predict consequences of quantum theories of gravity at an energy scale much lower than one would naively expect. As a consequence, this opens the possibility of probing for experimental signatures coming from IR/UV modications to the low-energy elective theory at upcoming experiments. Moreover, this also allows for model building, which can then attempt to unravel outstanding puzzles in both particle phenom enology (e.g. hierarchy problems), and cosm ology (e.g. the origin and nature of in ation and dark energy) by exploring consequences of the fundamental theory.

W ithin these models, the presence of extra-dimensions and the associated non-local terms are of particular interest. A common approach to treating such models is to utilize the low-energy e ective theory, which is expected to be valid at scales comparable or less than the Hubble scale today. In the context of the R and all-Sundrum model [1], this approach has been used extensively and the low-energy e ective theory, rst developed in [2], gives rise to a scalar-tensor theory of

gravity.

At higher energies, however, such as those occurring in the early universe, the gravitational behavior of braneworld scenarios is signi cantly di erent from any conventional scalar-tensor cosm ology. Understanding the behavior of these models during, for instance, in ation can then provide an opportunity to nd characteristic signatures of such higher-dim ensional models. Motivated by this possibility, e ective theories including characteristic high-energy corrections have been developed in [3, 4]. In these models, corrections to the e ective theory were considered arising from higher dim ensional K aluza-K lein (K K) modes in a M inkow skibackground. A lthough this approach gives an important insight into the higher-dim ensional e ects, it is more desirable to consider a brane which more closely resembles the observed universe, namely one of the Friedm ann-R obertson-W alker type. In this paper, we will develop such an elective theory, allowing us to understand the elect of the entire non-local K aluza-K lein (K K) continuum at the perturbed level around a single de Sitter (dS)/in ationary brane.

One common approach to brane in ation model building is to consider the in aton scalar responsible for in ation to result from one of the many moduli of the theory, such as the size or shape of the extra dimensions, or the relative position or orientation of the branes¹. However in this study, we take an alternative perspective and explore the possibility of having an in aton scalar eld con ned to the brane. This approach has been consider previously in [6], where it was argued that the usual constraints on slow-roll in ation models (e.g. slope of the potential) may be partially relaxed due to the modi cations of the ective gravity theory from the presence of extra dimensions.

Here we want to extend the analysis perform ed in [6] to incorporate the e ect of the entire KK continuum, which is often neglected in the literature. To this end, we rst recall how the KK tower of [7] can be derived using the G auss-C odacci form alism for the M inkow ski brane as shown in [8]. We then extend this analysis to the case of an in ationary brane and argue that within the slow-roll regime this theory remains a successful model of in ation even in the presence of the entire non-local KK tower. This result is certainly not surprising given the anticipated scaling of the corrections to the low-energy elective theory. In fact, we will not this scaling explicitly by noting the in uence of the KK tower on the initial state of the scalar perturbations. In particular, we not that the gravitational potential is greatly enhanced at short wavelengths, but explain why this enhancem ent is not signil cant enough to produce any noticeable signature during in ation (to

leading order in the slow-roll param eters.) We will also discuss how our approach can be used to study the spectrum of gravity waves and the e ect of higher dimensional anisotropy on the lower dimensional elective theory.

The paper is organized as follows. In Section II, we present the elective theory for an in ationary brane embedded in an AdS bulk and discuss them aim departures from the standard low energy elective theory. In the next section, we consider as an application the behavior of scalar metric perturbations during the modil ed gravity in ation. We will consider the short-wavelength modil – cation to both dynamics and initial conditions, showing that the resulting correction to the power spectrum is suppressed. This is ourmain result. We then conclude in Section IV. In the appendices we provide a more detailed derivation of the elective theory resulting from the inclusion of the KK tower. We inst consider the M inkowski case, followed by the case of a dS/in ationary brane. We then compare both results in the M inkowski limit and check the validity of our theory in Appendix B. The short-wavelength limit of this theory is then developed in Appendix C for the special case of scalar perturbations during in ation.

II. KK TOW ER ON A INFLATIONARY BRANE

In this section we rst develop a new form alism to make the problem of nding the low-energy e ective theory more technically tractable. We will then use the new form alism to study perturbations around an in ating brane.

A. Form alism

We want to consider the one-brane R and all-Sundrum II m odel [1], with a positive tension D 3 brane localized at the Z_2 xed point in a sem i-in nite A dS₅ bulk. The bulk cosm obgical constant is $_5 = -6 = \frac{2}{5} \frac{2}{A dS}$, where $A_{AdS} = M_{AdS}^{-1}$ is the A dS₅ curvature scale and $\frac{2}{5} = 8 G_5$ is the vedim ensional gravitational coupling constant (in what follows the index A dS is om itted.) We note that this was shown to be a consistent solution of the vedim ensional supergravity theory in [9, 10]. A librough for such a theory to have a UV completion in quantum gravity (string/M -theory) the presence of additional dimensions and m oduli are certainly of concern, for simplicity we will assume that such m oduli have been xed by uxes, or non-perturbative e ects, at a high scale so that they decouple from the vedim ensional scales that we will consider in what follows.

U sing di eom orphism (gauge) invariance we are free to choose coordinates to work in the fram e

where the metric takes the form

with the brane located at the orbifold xed point y 0.

The ve-dimensional action is

where K is the extrinsic curvature of a y = const hypersurface. In our frame, K is de ned by

For a brane with positive tension $= 6 = \frac{2}{5}$, and with stress-energy tensor T , the Israelm atching condition [11] in poses the extrinsic curvature on the brane to be

B. Embedding the in ationary brane

We now consider the stress-energy tensor for an in atom scalar eld ' con ned to the brane:

The modied Friedmann equation (Hamiltonian constraint) on the brane is then given by 2

where is the energy density on the brane. A ssum ing slow-roll in ation and working to lowest order we have T V, and the Friedmann equation becomes

We can now focus on the uctuations to the in ationary brane resulting from the e ects of both brane and bulk elds. The perturbed E instein equations are

where $z = \frac{p}{1 + \sqrt{2}H^2} = 1 + \frac{2}{6}V$, G is the perturbed E instein tensor, and E the perturbed W eyl tensor. This result is derived in detail in Appendix A. In particular, there it is shown that the induced value of the W eyl tensor on the brane is given by (A 24), i.e.

where Q is the modi ed Legendre function, $=\frac{1}{2}(1+\frac{1}{1+4}(4-\frac{1}{H^2}))$ and is the fourdimensional d'A ken bertian on de Sitter. A smentioned in the appendix, the source tensor is given by

and is transverse and traceless.

In the M inkow ski lim it, H ! 0, one should recover the result (A 10) obtained in [7], which has been rederived in appendix A. The comparison is performed in appendix B and represents a highly non-trivial check of this four-dimensional elective theory.

C . A nisotropy and an unusual trace coupling

We note that there are two main distinctions from standard four-dimensional E instein gravity arising in the model we have considered³. Firstly, the tensor presents a source of an isotropic stress which takes the form D D T and contributes as an elective shear. We note that this shear is completely gravitational in origin and will be present even in the absence of an isotropic matter on the brane. This elective an isotropy from the four-dimensional point of view could have potentially observable consequences, and will be considered in detail in a future publication [13].

In this paper we wish to concentrate on the second main distinction, namely the peculiar coupling to the trace. In any four-dimension theory, gravity (i.e. gravitons) couples directly to the stress-energy T , ensuring gravity to be massless. A line the zero mode graviton is still massless in this model, the coupling of matter to gravity in (8) and (9) is modiled by an additional term proportional to the trace. In the following section we will study the implications of this unusual trace coupling during in ation, but we rst study in what follows the asymptotic behavior of the extive theory at short and long wavelengths.

As already mentioned, the elective theory (8) is only valid at leading order in the slow-roll parameters. However, it is important to make the distinction between the time evolution of the background quantities and that of perturbations. The slow-roll approximation only requires the background to evolve smoothly and slow ly in time (dS approximation), however perturbations are not constrained by the same requirement and are free to oscillate very rapidly (such as at short wavelengths) without a ecting the validity of the theory.

At short wavelengths, perturbations evolve much more rapidly than the background and will therefore live on dS up to a very good approximation. In other words, small scales cannot feel the slow rolling of the background and the approximation that the background is dS will be a very good one. Fortunately, this will be precisely the regime we will be interested in, in what follows. The initial conditions for the curvature perturbation are indeed usually set by imposing the scalar eld to be in the Bunch-Davies vacuum [14] well inside the horizon. In the following section we will therefore study how the presence of the extra-dimension a ects the initial conditions.

Since at short wavelengths, the modes are expected to oscillate rapidly, we will therefore be interested in the limit where =H² 1. A good approximation for the operator r $\frac{Q(z)}{Q^0(z)}$ appearing in (9) is then

For completeness, one can also simplify the expression for r in the long wavelength regime. In this regime, spatial derivatives m ay be neglected. Furthermore, the modes are usually expected to freeze while crossing the horizon and their time evolution is also negligible. Note that since the time evolution of these modes is now comparable to that of the background, such modes will be much more sensitive to any slow-roll departure from dS.W e can thus expect the elective theory (8) to be less accurate in that regime, unless the departures from dS are negligible. In that regime, the action of the operator on the transverse and traceless tensor is thus simply '8H², i.e. $=\frac{1}{2}(1+\frac{p-15}{15})$.

U sing this value of , the elective theory can be simplied a step further in both limits H = 1and H = 1 using the relation

W e also note that r is always negative, even outside these two asymptotic regimes. As expected

the corrections will thus vanish as `H ! 0 which can either be seen as the M inkow skillim it H ! 0 (with no derivative term s), or as the small extra-dimension limit ('! 0). In both cases, the contribution of the K aluza-K lein tower should indeed vanish.

To sum marize, we have reached the important conclusion that if the energy scale of the bulk curvature is comparable or less than the Hubble scale (as can be the case during in ation), the Kaluza-K lein tower can give a contribution of the same order of magnitude as the zero mode and should thus be considered with care.

III. IM PLICATIONS FOR INFLATION

In this section we consider density uctuations on the dS brane to which the in atom scalar eld is con ned.

W e will work in longitudinal gauge where the metric for scalar metric perturbations is

where we will work using conform altime d² = a² dt². In the absence of an isotropic stress, the E instein equations imply = , so that there is one scalar degree of freedom associated to the metric. As mentioned previously, we do expect an isotropy contributions to be present in this scenario, how ever they are studied in detail in [13] and we focus in what follows in the other types of corrections arising from the W eyl tensor.

Following the usual four-dimensional prescription [15], it is useful to introduce the gauge invariant curvature perturbations on uniform density hypersurfaces as⁴

where a dot represents the derivative with respect to the conform altim e $\$.

In what follows, we will analyze how the evolution of the curvature perturbation diers from the standard four-dimensional case. In particular, we will show that the dynamics of and ' are both governed by the same set of coupled dierential equations as in the standard fourdimensional case. We will thus argue that the only possible departure from the usual result can

only arise from a modi cation of the initial conditions. We will then study in detail the initial conditions to be imposed at short wavelengths on the curvature perturbations. A lthough the gravitational potential is greatly enhanced by the higher curvature e ects at short wavelengths, the gravitational back reaction still remains negligible in this regime, una ecting the initial condition of and thus its time evolution.

A. Dynam ics

In what follows we study the dynam ics of the perturbations. G iven the isotropy of the model, there are only two independent variables, which we will take to be ' and . These two variables are coupled via the E instein equations. We is observe that because the scalar eld is conined to the brane, its equation of motion will remain una ected by the presence of the extra-dimension. Furthermore, the W eyl tensor de ned in (9) is traceless. The trace of the E instein equation (8) will therefore be similarly una ected by the extra-dimension, outside of \background e ects¹⁵ which have been studied extensively in the literature [6].

Both the scalar eld and the trace equations:

will thus provide two dynamical equations for ' and which are identical to their usual fourdimensional counterpart in standard in ation. These two dynamical equations govern the entire dynamics of the system and will provide two coupled equations for and '. In other words, the fact that the bulk is empty (implying that the W eyltensor is traceless) and that the scalar eld is con ned to the brane ensure that the equations of motion for the curvature perturbations and the scalar eld will be una ected by the extra dimension outside of \background e ects".

Thus, the only way the extra-dimension can interfere in the evolution of the perturbations is through the setting of the initial conditions. We have here a set of two coupled second order equations for and ', or equivalently a fourth order equation for . We will thus require four initial conditions to x entirely.

Two of these initial conditions can be xed by the usual requirement that the scalar eld is in the Bunch-Davies vacuum [14] well inside the horizon. But to x the two remaining ones, we should make use of the constraint equations. We emphasize that the constraint equations (the

Ham iltonian constraint G_0^0 and the momentum density constraint G_i^0) are a ected by the W eyl tensor and will thus give a di erent relation than in the standard case. In principle, we expect the initial conditions for the curvature perturbation to be a ected at short wavelengths, which m ight in turn a ect its evolution and the observed power spectrum. This possibility is explored in what follow s.

B. Constraints and Initial Conditions

1. Standard Chaotic In ation

We begin by analyzing the constraints and initial conditions for the case of standard chaotic in ation. As mentioned previously, two of the initial conditions are xed by imposing the scalar eld ' to be in the Bunch-D avies vacuum at short wavelength, i.e. for k 1,

In terms of the energy density perturbation, this implies, to leading order in the slow-roll param - eters,

where the second equality holds at short wavelengths.

In order to x the two remaining initial conditions, we use the constraints equations G 0_0 and G 0_i to express the metric perturbation in terms of '. This gives the following relation in the slow-roll regime

where $\frac{2}{4} = \frac{2}{5} = 1$ is the four-dimensional gravitational coupling constant. At short wavelengths, the contribution from the gravitational potential is thus completely negligible compared to the contribution of the scalar eld when setting the initial conditions for : $_{\rm k} / \frac{\prime_{\rm k}}{{\rm k}^2} = \frac{{\rm aH}}{{\rm V}^0} \prime_{\rm k}$, so that $_{\rm k} = \frac{{\rm aH}}{{\rm V}^0} \prime_{\rm k}$. This is a simple consequence of the nature of in ation for which the gravitational backreaction is very weak. On small scales, the perturbations are unable to distinguish between an expansion driven by a scalar eld or by a cosm ological constant. Since a cosm ological constant would have very little elects on scalar perturbations (beside \background elects"), it is no surprise that the gravitational potential plays little role in setting the initial conditions at small scales.

We now consider how this argument is modied in the context of brane in ation.

2. In ation on the Brane

As mentioned previously, the constraints equations G_0^0 and G_i^0 are a ected by the presence of the non-local corrections embedded in the W eyl tensor. They will therefore give rise to a slightly modi ed relation between and '. Using the Einstein equation (8) in the gauge (13), we indeed have the modi ed relation:

which holds at short wavelengths and in the slow -roll approximation. The derivation of this result is detailed in appendix C. For a scalar eld in the Bunch-Davies vacuum (17), the behaviour of the gravitational potential is thus modi ed to

The gravitational potential is thus enhanced by the non-local curvature corrections encoded in E. A priori this could imply signi cant changes in the initial conditions for , which will then propagate to late times and freeze out. However, at short wavelengths, $j j^2 = 4k$, so that using the relation (11) in the limit k = 1, r H = 2k (C f. appendix C).

Due to this overall factor, the contribution from is thus still negligible compared to that of the scalar eld in the denition of : $_{k} / '_{-k} = \frac{p}{k} \quad '_{-k}$, so that the initial conditions for will still be dominated by $_{k} = \frac{aH}{V^{0}} '_{-k}$, as was the case in the standard chaotic in ation scenario.

We can therefore conclude that despite the fact that the gravitational potential is modified at short wavelengths in this scenario, its overall contribution to the initial conditions for remains negligible. The initial conditions for and ' will thus remain una ected by the presence of the extra-dimension, and since their evolution is governed by a set of equations which is identical to that in four dimensions, we must conclude that no signature of the extra-dimension will be present in the power spectrum and the spectral index to leading order in the slow-roll parameters, except for the possibility of \background e ects".

Remarks on Anisotropy

In order to focus on the key point of the argument, anisotropy has been neglected in the previous development. It is however important to notice that the previous result is independent of this assumption and is completely generalizable to the case where ϵ . At long wavelengths, the anisotropic part of the W eyl tensor vanishes, so that one should recover ϵ . At short

wavelengths, however, the relation between the two gravitational potentials can be derived from the last constraint G_{j}^{i} (with $i \notin j$) to give

Despite this di erence, the relation between and ' remains unchanged and is still given by (20), (C f. appendix C). The contribution from the gravitational potential in the initial conditions for will therefore remain negligible.

Furtherm ore, as seen in the appendix C, at short wavelengths the equation for the scalar eld is sim ilarly una ected by the anisotropy (C11). Since the anisotropy disappears at long wavelengths, and the transition between the short-wavelength oscillating modes and the long wavelength frozen modes occurs alm ost instantaneously, the equation of motion for the scalar eld will be una ected by the extra-dimension (through the W eyl tensor) during its entire evolution. The argument given previously will therefore remain valid even in the presence of anisotropy and no signature to the power spectrum will be present to leading order in the slow-roll parameters, besides that of the background e ects.

IV. CONCLUSION

In this paper, we have developed a form alism capable of tracking non-local e ects of the K K continuum at the perturbed level on a single de Sitter brane while preserving general covariance on the brane. As a consistency check, this form alism was shown to reproduce the correct M inkow ski lim it developed in [7]. We argue that to leading order in the slow-roll parameters, this e ective theory provides a good fram ework to study m odels of braneworld in ation for which the in aton scalar eld is con ned to the brane.

In particular, we use this analysis to study the power spectrum of curvature perturbations. A lthough non-local term s typically present in branew orld scenarios can be very in portant at short scales, a close analysis to their elects during a standard model of in ation shows that the corrections to the power spectrum are completely negligible in the slow-approximation besides any possible background elect.

This is in complete agreement with the results of [16], which appeared during the latest stages of this work. Both studies use similar approximations (slow-roll) but dierent methods to derive very analogous results. We may point out that the present analysis does not rely on any numerical computations and is thus very easily reproducible. A nother advantage of our analysis resides in its covariant derivation. It can thus very easily be extended to the study of the tensor modes or to non-in ationary scenarios which left for a further study.

APPENDIX A : EFFECTIVE THEORY ON A M INKOW SKIAND DE SITTER BRANE

1. Four-dim ensional decom position

We consider the ve-dimensional theory (2), and work in the gauge (1) where the brane is xed at y = 0.

The electric part of the ve-dim ensional W eyltensor E is de ned as:

From the properties of the ve-dimensional W eyl tensor ${}^{(5)}C_{bcd}^{a}$, we can easily check that E is traceless with respect to q. In the frame (1), using the ve-dimensional Einstein equation $G_{ab} = \frac{2}{5} g_{ab}$, the expression for E is

It has been shown in the literature, that from a four-dimensional brane perspective, the projected W eyl tensor on the brane is the only quantity mediating between the brane and the bulk. Indeed, the projected R icci tensor on the brane can be expressed as

2. Linearized gravity on a M inkow skibrane

We now use this form alism to recover the well-know result of Garriga and Tanaka in ref. [7] that rst studied linearized gravity around a M inkow skibrane, expressing explicitly the KK tower and their e ect on the brane.

W e m ay notice at this point, that in this gauge, spatial in nity is reached at nite value of y, i.e. at $y = y_1 = v > 0$. The perturbations perceived on the brane will depend on the boundary conditions imposed at spatial in nity. The mode functions should be norm alized over the region $0 < y < y_1$, which will require them to fall as $y ! y_1$ or behave as plane waves. Note that at this point, the extrinsic curvature is in nite k(y) ! 1 as $y ! y_1$.

W eyltensor

As seen earlier, the key point in obtaining the KK tower at the perturbed level, is to nd the expression for the W eyl tensor. W e proceed as for the M inkowski brane, and the evolution equations (A 2, A 4) for the extrinsic curvature and the W eyl tensor at the perturbed level are:

APPENDIX B:M INKOW SKIVERSUS DE SITTER BRANE

The aim of this appendix is to show that the dS e ective theory reduces to that of M inkowski in the limit H ! 0. The main diculty in taking this limit resides in the fact that is then ill-de ned: $q = \frac{1}{H^2}$. We thus ist consider the limit $z = p \frac{1}{1 + \sqrt{2}H^2}$! 1, with xed.

But since this transition occurs very rapidly, one can to a very good approximation m atch both regimes directly.
