# Fusion Residues

We discuss when and how the Verlinde dimensions of a rational conformal eld theory can be expressed as correlation functions in a topological LG theory. It is seen that a necessary condition is that the RCFT fusion rules must exhibit an extra symmetry. We consider two particular perturbations of the G rassmannian superpotentials. The topological LG residues in one perturbation, introduced by Gepner, are shown to be a twisted version of the SU (N)<sub>k</sub> Verlinde dimensions. The residues in the other perturbation are the twisted Verlinde dimensions of another RCFT; these topological LG correlation functions are conjectured to be the correlation functions of the corresponding G rassmannian topological sigma model with a coupling in the action to instanton number.

## 1. Introduction

We can associate with any rational conform al eld theory a topological theory whose correlation functions are the dimensions of the Friedan-Shenker [1] vector bundles:

where H  $(g; i_1; :::; i_n)$  is the space of conform alb locks for the genus g surface with insertions of the primary elds  $i_1; i_n$  (we will consider a related,\twisted", version of these correlation functions, hence the superscript). These topological integers can be expressed in terms of the modular transform ation matrix S as:

where p runs over all primary elds [2,3]. This expression is of the expected topological form :

where h is the operator which m akes a handle [4]. The Verlinde dimensions (1.1) in  $G_k$  theories can be understood as Chern-Sim ons amplitudes on  $_g$  S<sup>1</sup> [5] or as amplitudes in G=G theory [6,7].

The expression (1.2) is similar to the residue expression for correlation functions in topological LG theories [8]. The correlation function at genus g of an arbitrary function F (X<sub>i</sub>) of the chiral super elds X<sub>i</sub> (i = 1;:::;N) in a topological LG theory with superpotential W (X<sub>i</sub>) is given by [8]

We have here modi ed the operator h from that obtained in [8] to include a convenient sign. This sign naturally arises in topological LG theory from the ferm ion zero mode integration upon ordering the terms in the G rassmann integrals so that the holom orphic pieces are all adjacent to each other. In this note we will study the connection between (1.2) and the residue expression (1.3) of topological LG theory.

The idea is to nd a topological LG superpotential W (X) with chiral primary elds  $_{i}(X)$  so that  $_{i}$  at the p-th critical point (the p-th solution of dW = 0) is  $_{i}(p) = S_{ip} = S_{op}$ . From [2],  $_{i}(p) = S_{ip} = S_{op}$  form diagonal representations of the fusion rules for every p. This basis is the basis of critical points of W where fusion is diagonal ring multiplication. The fusion rules are thus represented by multiplication in the ring with ideal generated by dW = 0. This was recently accomplished by Gepner [9] for the case of SU (N)<sub>k</sub> theories.

The polynom ial W (X) whose ideal dW = 0 gives fusion rule relations for some rational conform all eld theory must be a perturbed superpotential i.e. it can not be quasihom ogeneous. This is clear since a quasihom ogeneous superpotential has a conserved U (1) charge which is positive for all elements in the chiral primary ring, additive under ring multiplication, and no element in the ring has charge greater than c = c=3 [10]. Quasihom ogeneous superpotentials thus always have nilpotent ring relations whereas fusion rules in conform all eld theory, by duality, can never have zero on the RHS.Our fusion rule polynom ialW (X) is thus a perturbation of a quasihom ogeneous superpotential W°(X) in some of the chiral ring elements  $\frac{1}{10}$ . Under this perturbation,  $\frac{1}{10}$  i and the structure constants  $c_{11}^{0}$  for ring multiplication of the chiral primaries become the fusion rules N  $\frac{1}{10}$ .

We can now say something about the type of fusion rules which can be described as above as ring multiplication associated with some perturbed superpotential. As discussed in [11], the topological metric

is unchanged from that of the unperturbed theory. W e thus have

since  ${}^{\circ}_{c}$ , the unique chiral prim ary with the maximal U (1) charge of c (it generates one unit of spectral ow), is the only chiral prim ary with nonzero one point function on the sphere [8] (and we can choose our norm alizations to make its one point function one) and the same holds in the perturbed theory. In any unperturbed LG theory it is natural and always possible to choose our basis of  ${}^{\circ}_{i}$  so that  ${}^{\circ}_{ij}{}^{c} = {}_{ij}{}^{\circ}_{ij}$  where the chiral prim ary  ${}^{\circ}_{t}$  is given by applying  ${}_{c}$  (one unit of spectral ow) to the anti-chiral prim ary dual to  ${}^{\circ}_{i}$ , i.e.  ${}^{\circ}_{t} = {}^{\circ}_{c} {}^{\circ}_{t}$ . We thus naturally have N  ${}^{c}_{ij} = {}_{tj}$ . From this it follows that the fusion rule for the eld  ${}_{c}$  with any prim ary eld  ${}_{i}$  satis es

with only one term on the RHS. Such elds were considered in [12,13]. They indicate an extra symmetry in the theory above that of the chiral algebra [12]. We thus expect that only fusion rules with such elds (additional symmetries) can be represented as ring multiplication associated with some polynomial W. In  $G_k$  theories, the center of G is generated by elds that satisfy (1.6) [14]. The  $(E_8)_3$  fusion rules obtained in [15], for example, contain no such eld  $(E_8$  has no center) and, therefore, can not be naturally represented as multiplication in the ring of som e W.

Given a potential W and chiral primary elds  $_{i}$  with ring multiplication the fusion rules of some conformal eld theory, genus one correlation functions computed with the residue expression (1.3) of topological LG theory will coincide with the genus one Verlinde dimensions (1.2) since they both follow from just the fusion rules. The genus zero correlation functions computed with (1.3), on the other hand, di er slightly from the corresponding Verlinde dimensions. The residue form ula, for example, gives  $h_{i}i_{g=0} = i_{i,c}$  whereas (1.2) gives  $h_{i}i_{g=0}^{o} = i_{i,c}$  ( $_{o}$  denotes the identity). It is thus clear that the handle-making operator h of topological LG theory is a \twisted" version of that in the Verlinde form ula (1.2):

The untwisted Verlinde dimensions (1.1) can thus be computed as topological LG residues by soaking up 1 g units of the spectral ow primary eld <sub>c</sub> on the genus g surface:

where the correlation function on the right is computed in the corresponding topological LG theory using the residue expression (1.3) and where  $(_c)^{-1}$  is well de ned by (1.6) and equal to the dual to  $_c$ . The twisting (1.7) is fam iliar in twisted N = 2 theories; the twisting of the spins requires the handle-making operator to carry a unit of spectral ow. It would be interesting to understand this twisting in G<sub>k</sub> theory, where the twisting is by the center of G, in term s of Chem Sim ons or G = G theory.

We will apply these ideas to two particular perturbations of the G rassmannian superpotentials of [10]. The plan for this paper is as follows. In sect. 2 we discuss the cohom ology ring of the G rassmannian manifolds and the superpotential of [10] which gives this ring. We also discuss the perturbation of these G rassmannian superpotentials in an interesting subset of the chiral primary elds, generalizing som ewhat some results of [11]. In sect. 3 we consider the perturbed G rassmannian superpotentials found in [9] to give the SU (N)<sub>k</sub> fusion rules. We exam ine the residue expression and explicitly verify (1.7) in these theories. The Verlinde dimensions for SU (N)<sub>k</sub> can thus be expressed as residues, using

(1.3), as in (1.8). In Sect. 4 we write the Verlinde dimensions of the N = 0 unitary minimal models as TLG coset residues. In sect. 5 we consider another interesting perturbation of the G rassmannian superpotentials, the perturbation in only the most relevant operator (the K ahler form). The correlation functions (1.3) in this theory give the twisted Verlinde dimensions (1.8) for a RCFT. It is conjectured that these correlation functions are the correlation functions of a topological sigm a model on the G rassmannian manifold with a coupling in the action to instanton number. Sect. 6 is the conclusion. We comment there about an apparent connection between the integrability of a perturbed N = 2 LG theory and having the perturbed structure constants being the fusion rules of some rational conformal eld theory.

### 2. G rassm annian Superpotentials and Their Perturbations

The G rassmannian U (N + M )=U (N )U (M ) (with, say, N M ) is a N M complex dimensional compact complex manifold (a generalization of projective space) with a cohomology ring that is generated by the form s  $X_1$ ;:::; $X_N$  where  $X_r$  is a (r;r) form [16]. W riting

with  $X_0 = 1$ , the ideal of our G rassmannian's cohomology ring is obtained by the requirements [16] that

The G rassmannian cohomology elements are described in terms of the generating X<sub>i</sub> as follows [16]. For every formal, N dimensional vector  $= \frac{P_{N}}{l=1} n_{1}e_{1}$  with components  $n_{1}$  that satisfy

there is a (r();r()) form in the G rassmannian cohomology, where r() =  $P_{\substack{N \\ l=1}} \ln_{l}$ , given in terms of the generating X<sub>i</sub> by

where the  $a_i$  satisfy  $a_i = a_{i+1}$  with  $n_1$  of the  $a_i$  equal to 1 for each l = 1; :::; N, and  $X_r$  is de ned to be zero when r < 0 or r > N and  $X_0 = 1$ . The  $(N + M) \stackrel{!}{\mapsto} N \stackrel{!}{=} 1$  form s

with satisfying (2.3) are the G rassmannian cohomology elements. In particular, the  $e_i = X_i$  with  $e_1 = X_1$  the Kahler form, and  $M_{e_N} = X_N^M$  is the volume form. It is easily seen that the  $ne_1$  satisfy  $ne_1 = X_1 (n 1)e_1 X_2 (n 2)e_1 + ::: from which it follows$  $that <math>{}_{ne_1}^{(N)} = Y_n^{(N)} (X_i)$  as deneed by (2.1). From (2.3) it is clear that the G rassmannian Poincare polynomial is the generating function for the number of partitions of a number into no more than M parts with each part no greater than N:

We can represent the cohomology element with a Young tableaux containing  $n_1$  columns of lboxes for l = 1 ::: N. Condition (2.3) says that no tableaux has more than M columns. There is a duality under  $N \ M$ ,  $X_i \ Y_i$ , and in terms of the tableaux, row s\$ columns. In particular, de ne  $\hat{n}_1$  to be the number of rows in the tableaux with lboxes for l = 1;::: M. The elements (2.4) can be expressed as:

where  $\hat{n}()$  N and the  $\hat{a}_i$  are de ned in terms of the  $\hat{n}_1$  as in (2.4). Writing  $Y_r = re_1$  in terms of the X<sub>i</sub> as in (2.1), it can be veried that (2.6) is equivalent to (2.4).

The cohom ology ring is obtained by multiplication of the elements (2.4) subject to the ideal (2.2). Before in posing the relations of the ideal, the product of any two elements (2.4) can be expanded as a sum of term s of the same type with nonnegative integer coe cients. The ideal sets to zero those term s in the sum which don't satisfy the inequality (2.3). This ring structure is known as the Schubert calculus [16].

The ideal (2.2) of the G rassmannian cohomology ring can be written as the ideal generated by setting to zero the derivatives of a polynom ial in the X  $_{i}$  as follows. Following [9], we de ne

our G rassm annian ideal (2.2) is generated by the derivatives of W  $_{N+M+1}^{(N)}$  (X i). If we write

written in terms of the X<sub>i</sub>, the form obtained in [10]. Using  $W_{N+M+1}^{(N)}$  as a LG superpotential gives the C = C = 3 = N M = N + M + 1 K azam a SuzukiN = 2 coset theory SU (N + 1)<sub>M</sub> = SU (N )U (1). The chiral primary elds (2.4) have  $q = q = (N + M + 1)^{-1}r()$ . The operator h de ned in (1.3) is proportional to the top form  $c = M_{N} = X_{N}^{M}$ . The relation is

The residue expression (1.3) thus gives  $h_{ci_{q=0}} = 1$  with our normalizations.

We now consider deforming the G rassmannian superpotential in the chiral primary elds (2.4). As discussed in [8], only deformations in those with q < 1 are nice in that they don't change the number of critical points of W. Under the perturbation W (X<sub>i</sub>) ! where  $c_{1}^{3}(a)$  are the perturbed structure constants (the perturbed three point functions with an index raised using the (a independent) metric ) [11].

The form of W (X ;a) and  $_{ne_1}$  (X ;a) in the one variable case, N = 1, was obtained in [11]. We will generalize their results to the general N variable case when the G rassmannian superpotential is perturbed in only the chiral primary elds  $_{ne_1}^{(N)} = Y_n^{(N)}$  with n = 1;:::M (note that these all satisfy the q < 1 condition). >From (2.8) it is obvious that condition (2.11) for these perturbations:

For the one variable (N = 1) case these results are equivalent to those obtained in [11].

The perturbed cohomology ring (2.11) can be embedded in the unperturbed G rassmannian cohomology ring in N + M variables:

W hile 1 and 2 are of the form  $P_{\substack{1=1\\l=1}}^{P} n_{1}e_{1}$ , with components that satisfy (2.3), the term s on the right are of the form  $_{3} = P_{\substack{1=1\\l=1}}^{P} n_{1}e_{1}$  (since this is now the N + M variable Schubert calculus). It is easily seen from (2.4) that the new term swith  $n_{>N} \in 0$  go away when the perturbation is turned o . U sing (2.4) and the ideal of the ring, obtained by setting to zero the X<sub>i</sub> derivatives (i = 1;:::N) of the perturbed potential (2.13), all term s on the RHS can be expanded out in term s  $n_{>N} = 0$  basis  $(N) \times (X_{i};a)$  in (2.13) times powers of the perturbing parameters a. The perturbed ring structure in (2.11) is thus easily obtained.

The topological LG correlation functions in the perturbed theory can be calculated using (1.3). It is sometimes convenient to work in terms of the variables  $q_i$  dened in (2.9). The Jacobian between these variables is  $det(q_i=0X_j) = 1$  where is the Vandermonde determinant  $= \frac{Q}{i < j} (q_i q_j)$ . The critical points of W are the critical points of W in terms of the  $q_i$  other than those points  $q_i = q_j$  where () <sup>1</sup> blows up and modulo permutations of the  $q_i$  (this change of variables trick was used in [9] and [17]). The operator h in (1.3) can be written up to the equations of motion as  $h = (1)^{N} (N 1)^{-2} 2 \det(0^2 W = 0 q_i 0 q_j)$ .

In the next two sections we will consider two interesting special cases: perturbing in only the most relevant operator  $Y_1^{(N)} = {\binom{N}{e_1}} = X_1$ , and perturbing in only the least relevant operator of the type considered  $Y_M^{(N)} = {\binom{N}{e_1}} = X_1$ .

#### 3. SU (N)<sub>k</sub> Fusion Residues

In this section we consider a special perturbation of the G rassmannian potentials: perturbation in only the least relevant operator of the  $_{ne_1} = Y_n$  type. This perturbation was found by G epner to give the SU (N)<sub>k</sub> fusion rules. This perturbation is also special in that it is probably integrable [17,18] and its soliton structure is rather interesting [18]. It was also shown in [19] in the one variable case (the SU (2)<sub>k</sub> case) that the perturbed ring structure constants  $c_{ij}^k$  (a) are symmetric in i; j;k (as the N  $_{ij}^k$  of SU (2)<sub>k</sub> are so symmetric) at precisely this perturbation.

The polynom ial W (X ) found by Gepner [9] to give the fusion rules for SU (N )<sub>k</sub> is given by W (X ) = W  $_{N+k}^{(N)}$  (X  $_r$ ;X  $_N$  = 1), the G rassm annian polynom ial for U (N + k 1)=U (N )U (k 1) subject to the constraint X  $_N$  = 1. This is the perturbation (2.13) of the G rassm annian polynom ial W  $_{N+k}^{(N-1)}$  (X  $_1$ ;:::;X  $_N$   $_1$ ) for U (N + k 1)=U (N 1)U (k) in the chiral prim ary eld  $_{=ke_1}^{(N-1)}$  with the perturbing parameter set to one. The G rassm annian chiral prim aries  $_{=ke_1}^{(N-1)}$  with  $_{r=1}^{P} n_{r=1}^{N-1} n_r e_r$  are given at the perturbed point by (2.13),  $_{(N)}^{(N)}$  (X  $_r$ ;X  $_N$  = 1). This is precisely the polynom ial found by G epner [9] to represent the SU (N )<sub>k</sub> prim ary eld with highest weight  $_{=}^{P} n_{r=1}^{N-1} n_r r$ . The G rassm annian structure constants at this perturbed point are the SU (N )<sub>k</sub> fusion rules of [20]. The X  $_r$ , in particular, represent the fundamental weights  $_r$ , the fully antisymmetric representations. The j-th fully symmetric representation,  $_{=} j_{-1}$ , is represented by the polynom ial Y  $_j^{(N)}$  (X  $_r$ ;X  $_N = 1$ ) (2.1). The eld  $_c = _{-k - N-1}$  satis es the fusion rule (1.6). It generates the Z  $_N$  center of SU (N ).

W e will now consider the residue form ula (1.3) for topological amplitudes using the above superpotential. As discussed in the introduction we expect to get (1.7)

from which it follows that the residue expression of topological LG theory gives a twisted version of the Verlinde dimensions (where the twisting is by the center of the group). We will explicitly verify (3.1) by computing (1.3)

where, again,  $W_{N+k}^{(N-1)}(X_r;a) = W_{N+k}^{(N)}(X_r;X_N = 1)$ .

Following Gepner, we re-introduce the eld X  $_{\rm N}$  along with a Lagrange multiplier to set it to one:

The equation of motion of the polynomial (3.3) for sets  $X_N = 1$  and, using (2.7), the equation of motion for  $X_N$  gives,  $= (1)^{N+1}Y_k(X_r)$ . It is easily seen that (3.2) is given by  $h = (1)^{(N-1)(N-2)=2}$  detH, where detH is the Hessian of W ( $X_r; X_N;$ ). In terms of the  $q_i$ , we have detH = () <sup>2</sup> detK where  $K_{i;j} = 0^2 W = 0 q_i 0 q_j, K_{i;} = q_i$ ,  $K_i = 0$  for  $i; j = 1; \ldots; N$  and, recall, is the Vanderm onde determ inant Jacobian. Using the equations of motion  $q_i^{N+k} = (1)^{(N+1)}Y_k$  and  $\sum_{i=1}^{Q} q_i = 1$ , we obtain  $h = (1)^{N(N-1)=2} (Y_k)^{N-1} detA$ , where  $A_{i;j} = (N+k)_{i;j}, A_{i;} = 1, A_i = 0$  and, thus, detA = N (N + k)^{N-1} = W = (N+k)R j the index of (N + k) times the SU (N) root lattice in the SU (N) weight lattice. Since  $(Y_k)^{N-1} = k_{N-1}$  in the ring, we obtain

In [9] it was shown how to make the correspondence between weights of SU (N)<sub>k</sub> and the critical points X  $_{r}^{()}$  of W. It was also shown that the Vanderm onde determ inant at the critical point is given by

Thus, using the expression in [20] for the modular transform ation matrix S , we have

where, as usual,  $h^{\circ}(X_{r}^{()}) = 1=S_{\circ;}^{2}$ . Relation (3.4) is thus the expected (3.1). We have thus explicitly veri ed relation (1.7). The Verlinde dimensions are then expressed as TLG residues as in (1.8).

#### 4. Sim ple Cosets

We can give a LG description of the unitary N = 0 m inimal models SU (2)<sub>1</sub> SU (2)<sub>m 2</sub>=SU (2)<sub>m 1</sub>, constructing the coset along the lines of [21]. The LG potential for the coset is

$$W (x;y) = \frac{1}{\frac{p}{2}} (W_{m}(x) - W_{m+1}(y))$$

where  $W_{k+2}(x) = W_{k+2}(X_1 = x; X_2 = 1)$  is the LG potential for the SU (2)<sub>k</sub> fusion rules,  $W_{k+2}(2\cos 3) = (2=k+2)\cos(k+2)$ . The primary elds are given by

$$r_{r,s} = P_{r-1}(x)P_{s-1}(y) + s = even;$$
 (4.2)

for r = 1; :::;m 1 and s = 1; :::;m, where  $P_n(x) = \sum_{n=1}^{n} Y_n(x; X_2 = 1)$ ; they are the Chebyshev polynom ials  $P_n(2 \cos x) = \sin(n + 1) = \sin x$ . The eld identi cations from the common  $Z_2$  center of the coset has allowed us to write (4.1) without a eld for the SU (2)<sub>1</sub>. This center is generated by (x; y)! (x; y) so the elds (4.2) with r + s even are properly invariant. The Verlinde dimensions are given by

where the right side is computed using the topological LG residue form ula (1.3) with the potential (4.1) and the eld representations (4.2) with  $c = c^{-1} = m_{-1,m}$ . The factor of 1/2 in (4.3) is due to the center mentioned above; the sum over all critical points of W double counts. We properly obtain, for example,  $hli_{q=0}^{\circ} = 1$  and  $hli_{q=1}^{\circ} = m$  (m 1)=2.

#### 5. Counting Instantons with Fusion Residues

Consider perturbing our original theory  $W_{N+M+1}^{(N)}$  in X<sub>1</sub>, the most relevant operator. These perturbations were considered in [22] and were shown to be integrable; they describe a ne SU (N + M) Toda at an imaginary coupling. >From (2.13) the perturbed potential is (with a convenient sign, corresponding to X<sub>N+M</sub> = (1)<sup>M+1</sup>)

$$W_{N+M+1}^{(N)}(X_{i}) + (1)^{N} X_{1}$$

and the chiral primary elds (N) are unchanged by this perturbation. We will show that the topological LG correlation functions of the (N) in the perturbed theory (5.1), computed using (1.3), are the twisted Verlinde dimensions for a RCFT. We then discuss a conjectured connection between these correlation functions and intersections of surfaces in the moduli space of G rassmannian instantons.

The ideal dW = 0 of (5.1) gives the deform ed cohom ology relation  $X_N Y_M = .$  It is convenient to set = 1 (the factors of can be put back in at the end by charge (form) counting). From (2.4) it is seen that  $_{+e_N} = X_N$  when  $+e_N$  satisfies (2.3). In terms of Young tableaux,  $X_N$  acts on any cohom ology element with less than M columns to give an element with an extra column of N boxes. Likewise, using (2.6), it is easily seen that  $Y_M = X_N^{-1}$  acts on any cohomology element with less than N rows in its tableaux to give an element with an extra row of M boxes. We thus obtain for the product of the element  $X_N$  s with any element

where  $e_0 = 0$  and n () is the sum (2.3). The element  $s = X_N$ , under the ring multiplication, m aps any cohomology element to the cohomology element s de ned above. In this way, the cohomology elements can be grouped into orbits under the action of s. From (5.3) we have  $s^r = {}_{re_N}$  for r = 1 ::: M,  $s^r = {}_{M e_{N+M}} {}_{r}$  for r = M ::: M + N. In particular,  $s^{N+M} = 1$ . Since s has a  $Z_{N+M} = SU (N + M)_1$  action, the number of elements in the di erent s orbits will be divisors of N + M. This SU  $(N + M)_1$  symmetry of the fusion rules is connected with the a ne SU (N + M) description of this theory.

In each s orbit we can pick a convenient element [] to be the orbit base point, the other elements in the orbit are of the form  $s^r$  []. Since the cohom ology ring is commutative and associative, ring products of the elements [], one for each s orbit, su ce to give the ring multiplication of any two elements:

$$= s^{r+p} ( [] []):$$

It is convenient to choose our s orbit representatives [] to have  $n_N = 0$  (from (5.3) we can clearly make this choice).

If we were to mod out by the s action, we would set  $s = X_N = (Y_M)^{-1} = 1$ . Setting  $X_N = 1$  reduces this theory to the theory discussed in [9] and in the last section. The product of our  $n_N = 0$  orbit representatives, upon setting  $X_N = 1$ , thus satisfy the SU (N)<sub>M</sub> fusion rules. The ring structure without setting s = 1 is therefore a simple modi cation of the SU (N)<sub>M</sub> fusion rules. The product of any two elements, both with  $n_N = 0$ , is given by:

where N  $_{1}^{3}$  are the fusion rules of SU (N)<sub>M</sub>, r() is the form number of , r() =  $P_{1=1}^{N-1} \ln_{1}$ , the powers of s follow from form counting, and  $M_{e_{1}} = s^{-1}$ . In terms of SU (N)<sub>M</sub> Young tableaux multiplication, the idea is to replace each column of N boxes with a s rather than with a one, where  $s = (M_{e_{1}})^{-1}$ . It is thus seen that the deform ed cohom ology ring products of (5.1) are the fusion rules of a rational conform all eld theory. The s symmetry of the fusion rules is as discussed in [12]. The topological LG correlation functions (1.3) will give the twisted Verlinde dimensions for this RCFT.

For the  $CP^{1}$  case (N = M = 1), this ring deform ation is that shown in [4] to arise in topological sigm a models with target space  $CP^{1}$  where  $= e^{i}$  with the coupling in the action to instanton number. It is conjectured [23] that the deform ation (5.1) in the K ahler form generally gives the \quantum deform ation" of the G rassmannian cohomology ring that arises in topological sigm a models with target space the corresponding G rassmannian manifold and with a coupling as described above in the action to instanton number. The conjecture, in other words, is that correlation functions (1.3) in the perturbed topological LG theory (5.1) give inform ation about the intersections of surfaces in the moduli space of G rassmannian instantons (som e properties of this moduli space were discussed in [24]).

It is easy to see from charge counting that the correlation functions of the chiral ring elements (2.4) in the topological LG theory with potential (5.1) are given by

 if  $r_T = (N + M)k + (1 q)NM;$  (5:5)

and are zero if the condition on  $r_T$  is not satisfied, where  $r_T = \prod_{i=1}^{P} r(i)$  is the total form number. The conjecture is that the coe cients  $F(i_1:::n;g;k)$  in the above correlation function give the number of intersections of n surfaces in the moduli space of degree k instanton maps from genus g R iem ann surfaces into the G rassmannian space U(N + M) = U(N)U(M). The i-th surface is that obtained by requiring the instanton map

to satisfy  $(z_i) 2 \sim i_i$ , where  $z_i$  is the i-th arbitrary point on the Riemann surface and where  $\sim i_i$  is a xed cycle in the Grassmannian which is Poincare dual to  $i_i$  (e.g. if is the volume form, then  $\sim$  is a point in the Grassmannian). The codimension of the i-th surface is thus  $r(i_i)$ . The number of intersections of these surfaces counts the number of instanton m aps of a given degree which satisfy the above conditions; these are the observables in the topological sigm a m odel.

A check on the conjecture is that the relation for  $r_T$ , the sum of the codimensions of the intersected surfaces, as given by simple charge counting in (5.5) in terms of k and

g, is the correct moduli space dimension [24,25]. It is also encouraging that, since the F (g;k) are the twisted Verlinde dimensions for the RCFT discussed above, the F (g;k) are nonnegative integers.

The correlation functions (5.5) are calculated using (1.3). It is sometimes convenient, as discussed in sect. 2, to calculate in terms of the  $q_i$  variables. In these variables, the critical points are simply given by  $q_i = !^{n_i}$  where  $!^{N+M} = 1$  and  $^{N+M} = (1)^{N-1}$  with  $n_i = 1; ::: N + M$  and  $n_i < n_{i+1}$ , i = 1; ::: N. The  $Z_{N+M}$  structure obtained above is obvious in these variables. The operator h of (1.3) is  $h = (1)^{N-(N-1)=2} - {}^2(N+M)^{N-(M-1)}$ . As an example, the interested reader can easily verify our norm alization  $h_{c}i_{g=0} = 1$ .

W e now consider the N = 1, i.e.  $CP^{M}$ , case. The potential (5.1) is

$$W = \frac{x^{M+2}}{M+2} \qquad x:$$
(5:6)

The ring multiplication, setting = 1, are the expected  $Z_{M+1}$  rational torus (SU  $(M + 1)_1$ ) fusion rules for s = x. The operator h in (1.3) is given by h =  $(M + 1)x^M = h^0x^M$  and the correlation functions are the twisted SU  $(M + 1)_1$  Verlinde dimensions:

$$hx^{r_1} ::: x^{r_n} i_g = (M + 1)^{g k} \quad \text{if} \quad r_i = (M + 1)k + (1 g)M \quad (5:7)$$

and zero otherwise. We, again, interpret these numbers as representing the number of intersections of n surfaces in the moduli space of degree k instanton maps from the genus g R iem ann surface to  $CP^{M}$  where the i-th surface is obtained by requiring the map to take the i-th (arbitrary) point on the R iem ann surface to any point which lies in some xed cycle Poincare dual to  $x^{r_i}$ . The above result agrees with the analysis in [4] of  $CP^{1}$  instantons and with A xelrod's analysis of  $CP^{N}$  instantons [25].

As another example, consider U (5)=U (3)U (2), for which  $W = X_1^6 = 6 X_1^4 X_2 + 3=2X_1^2 X_2^2$  1=3X<sub>2</sub><sup>3</sup>+ X<sub>1</sub>. The = 1RCFT ring relations are given by  $e_1 e_1 = s + s^3 e_1$  with  $s^5 = 1$  ( $e_1 = X_1$  satisfies the SU (2)<sub>3</sub> fusion rules modified as discussed above and  $s = X_2$ ). The critical points of W are thus given by  $s = !^p$  and  $s^2 e_1 = (1 5)=2$  with  $p = 0; \ldots; 4$  and  $!^5 = 1$ . The operator h in (1.3) is as given in (1.7) with  $c = s^3$  and  $h^\circ = 10 + 5 s^2 e_1$ . Using (1.3) we easily calculate, for example,  $hX_1^rig = F(q;k)^k$  if r = 5k + 6(1 q) and zero otherwise with

$$F(q;k) = 5(5^{p}\overline{5})^{g-1} \quad \frac{p}{2}\overline{5+1} = 5(k-g+1) + (-1)^{k} \quad \frac{p}{2}\overline{5-1} = 5(k-g+1)$$

which is a nonnegative integer (note that F(g;k + 2) = 11F(g;k + 1) + F(g;k) and F(g + 2;k + 2) = 125F(g;k)). It would be interesting to check the conjecture by directly calculating the intersections in the moduli space of instantons for this space. It would also be interesting to connect this with the interpretation in terms of the twisted Verlinde dimensions.

# 6. C on clusions

We have seen that RCFT fusion rules which can be described as the chiral ring structure constants of some LG superpotential must have an extra symmetry (corresponding to spectral ow) and that the correlation functions in the corresponding topological LG theory give a twisted version of the RCFT's Verlinde dimensions. The symmetry (1.6) of the RCFT fusion rules also implies a symmetry of the deformed superpotential. In both of the perturbations considered here, this symmetry appears to be connected with the fact that the perturbed theories are integrable. It would be interesting to understand if there is a general connection between the integrability of a perturbed superpotential and having its ring give the fusion rules of a rational conform all eld theory.
