## STRING THEORY AND THE

### DONALDSON POLYNOM IAL

ABSTRACT: It is shown that the scattering of spacetime axions with vebrane solitons of heterotic string theory at zero momentum is proportional to the D onaldson polynom ial.

can be carried by a d p 4 brane. A straightforward generalization [1] of D irac's original argument implies that quantum mechanically the charges must obey a quantization condition of the form

just as for the special case of electric and m agnetic charges in d = 4. In particular, strings in ten dimensions are dual, in the D irac sense, to vebranes. Thus vebranes are the m agnetic m onopoles of string theory.

In [2,3] it was shown that heterotic string theory admits exact vebrane soliton solutions. The core of the vebrane consists of an ordinary Yang-M ills instanton. Thus heterotic strings are dual, in the D irac sense, to Yang-M ills instantons.

This simple connection between Yang-M ills instantons and heterotic string theory raises many possibilities. On the one hand, heterotic string theory might be used as a

tool to study the rich m athem atical structure of Y ang-M ills instantons, or to suggest interesting generalizations. On the other hand, the m athem atical results of D onaldson [4] and others on the construction of new sm ooth invariants for four-m anifolds m ay have direct im plications for non-perturbative sem i-classical heterotic string theory.

In this paper this connection is elucidated as follows. We consider N parallel vebranes on the manifold M<sup>6</sup> X where M<sup>6</sup> is six-dimensional M inkowski space and X is the fourmanifold transverse to the vebranes. (The consistency of string theory requires  $c_1(X) = 0$ , though this condition m ight conceivably be relaxed in the present context by allowing singularities along the divisor of  $c_1$ .) The quantum ground states of this system are found to be cohomology classes on the N-instanton m oduli space M<sub>N</sub> (X). Transitions among these ground states may be induced by scattering with a zero-momentum axion. Such axions are characterized by a harmonic two-form or an element of H<sup>2</sup>(X), and the Smatrix then de ness a map H<sup>2</sup>(X)! H<sup>2</sup>(M<sub>N</sub>). This map turns out to be precisely the D onaldson map. The fact that the scattering is a map between cohomology classes is ultimately a consequence of zero-momentum spacetime supersymmetry. Multiple axion scattering is given by the intersection numbers on M<sub>N</sub> of these elements of H<sup>2</sup>(M<sub>N</sub>), which is the D onaldson polynom ial.

This representation of the D onaldson m ap as a string S-m atrix element leads to an apparently new geometrical interpretation of D onaldson theory. For any K ahler m anifold X there is a K ahler geometry on H  $^2$  (X ; C) M  $_{\rm N}$  (X) with K ahler potential de ned by

E is an analog of the Chern-Sim ons form for Kahler geometry. The Donaldson map is

then given by a mixed component of the Christo el connection, computed as the third derivative of K .

It is noteworthy that the nal expressions we derive for the D onaldson m ap and polynom ialare similar to those given by W itten [5]. Indeed, the embedding of four-dimensional Yang-M ills instantons into ten-dimensional string theory given by vebrane solitons seems to produce a structure of zero-m om entumelds and symmetries similar, if not identical, to that of W itten's topological Yang-M ills theory. Though we have not done so, it is possible that the complete structure of topological Yang-M ills theory can be derived from zero-m om entumestring theory in the soliton sector. This is perhaps in contrast to the usual notion [5] that topological eld theory is relevant to a short-distance phase of string theory.

We work only to leading order in <sup>0</sup> in this paper. An interesting question, which we do not address, is whether or not higher-order or non-perturbative corrections provide a natural deform ation of the D onaldson polynom ial analogous to the deform ation of the cohom ology ring provided by string theory.

This paper is organized as follows. In Section II we establish our notation and review som e properties of instanton m oduli space. The collective coordinate expansion leading to the low-energy elective action is derived in some detail, and is then used to characterize the N - vebrane ground states. In Section IIIA the collective coordinate expansion is continued to reveal the D onaldson m ap as a subleading term in the low-energy elective action. Section IIIB gives an alternate derivation of the D onaldson m ap using supersymmetry and K ahler geometry, and derives (w hy). In Section IIIC we discuss the representation of the D onaldson m ap as a period of the second C hem class which m ay be relevant in the present context. In Section IIID the string scattering amplitude which measures the D onaldson polynom ial is described. We conclude with discussion in Section IV.

# II. IN STANTON MODULI SPACE AND THE COLLECTIVE COORD IN ATE EXPANSION

The derivation of the Donaldson map and polynomial from ten-dimensional string theory is straightforward though som ewhat involved. We begin with the action describing the low-energy limit of heterotic string theory:

The general solution of this form on X M  $^{6}$ , where X is a Kahlerm anifold with  $c_{1}$  0 and M  $^{6}$  is at six dimensional M inkow ski space, was found in [6]. The gauge eld m ay be any self-dual connection on X :

where a; b are tangent to M<sup>6</sup>. Special cases of this general solution are discussed in [2,7,3]. In [8] it was argued for X = R<sup>4</sup> that such solutions are in one to one correspondence with exact solutions of heterotic string theory. For  $c_2$  (F) = N, this may be viewed as a conguration of N vebranes transverse to X. (It may also be viewed as a \com pactication" to six dimensions, though X need not be compact.) Since (given the metric on X) there is one unique solution for every self-dual Yang-M ills connection (sdual), the space of static N vebrane solutions is identical to the moduli space M<sub>N</sub> of N -instanton congurations on X.

For  $c_1(X) = 0$  and  $c_2(R) = c_2(F)$ , the metrics g of (metax) are geodesically complete, but m ay be non-compact. If  $c_1(X) > 0$ , there are geodesically complete but non-compact R icci- at metrics with bounded curvature [9]. This may be viewed as a singular metric on X or a non-singular metric on X minus the divisor of  $c_1$ . There appears to be no special di culty in de ning string propagation on such geometries (though they would not be suitable for K aluza-K lein compactication). Singularities may also arise in solving (deom). If  $c_2(R) > c_2(F)$ , the singularities are of the type studied in [3] and again produce no di culties.

On the other hand if  $c_1 < 0$  or  $c_2(\mathbb{R}) < c_2(\mathbb{F})$ , the metric in (metax) may have real curvature singularities, which could potentially render string theory ill-de ned. More work

m ust be done before ourm ethods can be used to directly study these cases, but the validity of our nal form ulae for all K ahler X suggests that it m ay be possible to do so. Possible approaches would be to consider the m ore general case of time-dependent m etrics, or to consider the (eight-dimensional) cotangent bundle of X which has  $c_1 = 0$ .

The solutions of (sdual), (deom) have bosonic zero modes tangent to M<sub>N</sub>. To leading order in <sup>0</sup> these zero modes involve only the gauge eld and will be denoted <sub>i</sub>A (x), where i = 1;...;m; m dim (M<sub>N</sub>) and x is a coordinate on X. The zero modes obey the linearized self-duality equation

For gauge groups larger than SU (2) or for metrics on X which are not \generic" the gauge connection will in general be reducible (there exist non-trivial solutions of D = 0). This leads to orbifold singularities in M <sub>N</sub>. In what follows we will restrict ourselves to irreducible connections and ignore such subtleties.

If Z  $^{\rm i}$  is a coordinate on M  $_{\rm N}$  , and A  $^0$  (x;Z ) a fam ily of self-dual connections, the zero m odes are given by

Equation (fm ode) would appear to give m zero modes, where m is the dimension of M  $_{\rm N}$ , but we know from the index theorem that these are not linearly independent. U sing (ee) and (aa) one nds

The low-energy dynamics of N vebranes in X M  $^6$  is best described by an e ective action S<sub>e</sub> . This action can be derived by a (super) collective coordinate expansion which begins

where (x; ) is a coordinate on X M <sup>6</sup> and the bosonic (ferm ionic) collective coordinates  $Z^{i}(i)$  are dynamical elds on the soliton worldbrane.  $i = \frac{i}{4} + i$  is a doublet of six-dimensional W eyl ferm ions obeying  $j = iJ_{k}j^{k}$ . Under SO (5;1) worldbrane Lorentz transform ations, the <sup>i</sup>'s transform into one another. It is possible to assemble the <sup>i</sup>'s into  $\frac{m}{2}$  six-dimensional symplectic M a jorana-W eyl spinors transform ing covariantly under SO (5;1). However SO (5,1) covariance is not necessary for our purposes, and the supersymmetric SO (5;1) covariant form ulation introduces a number of extraneous complications which obscure the connection with D onaldson theory. O ur expressions will have manifest invariance under two-dimensional super-Poincare transform ations which we take to act in the <sup>0</sup>; <sup>1</sup> plane. The subscripts on <sup>i</sup> denote the corresponding two-dimensional chirality. In accord with this and as a further simplication, we henceforth restrict <sup>i</sup> and Z<sup>i</sup> to depend only on <sup>0</sup> and <sup>1</sup>.

The elective action  $S_e$  can be expanded in powers of inverse length. Taking Z<sup>i</sup> to be dimensionless and <sup>i</sup> to have dimensions of (length)  $\frac{1}{2}$  this is an expansion in the

parameter  $n = n_{0} + n_{f} = 2$  with  $n_{0}$  the number of derivatives and  $n_{f}$  the number of ferm ion elds. The expansion (exp) solves the spacetime equations of motion to order n = 0, while the leading terms in  $S_{e}$  are n = 2. To have a consistent action we must still solve the spacetime equations to order n = 1. This requires that the component of the gauge eld tangent to the worldbrane acquires the term

Including the ferm ionic terms gives the d = 6 supersymmetric sigma model with target space M  $_{\rm N}$  :

Because we have maintained only an SO (1;1) subgroup of SO (5;1) as a manifest symmetry of (swb), only two of the eight supersymmetries are manifest.

For values of  $Z^{i}$  corresponding to N widely separated instantons, (swb) is approximated by N separate terms describing the dynamics of each of the N vebranes. The full action (swb) includes additional vebrane interaction terms. C lassically, there is one static ground state for each point Z<sup>i</sup> M<sub>N</sub>. However quantum m echanical ground states involve a superposition over Z<sup>i</sup> eigenstates. A sexplained by W itten [11] the supercharges of the supersymmetric sigm a model (swb) act at zero momentum as the exterior derivative on the target space M<sub>N</sub>, and the general supersymmetric ground state can be written in the form

In sum m ary, the low -energy dynam ics of N - vebranes is described by a supersymmetric sign a-model with target space M  $_{\rm N}$  and the ground states of this system are cohomology classes on M  $_{\rm N}$ .

#### III.THE DONALDSON MAP AND POLYNOM IAL

In addition to the leading term (swb) in  $S_e$ , there are a number of term s representing interactions between spacetime elds which are not localized on the vebrane and the localized worldbrane elds appearing in  $S_e$ . This corresponds to the fact that the state of the vebrane can be perturbed by scattering with spacetime elds. For the special limiting case of zero-m om entum spacetime elds, energy conservation implies that scattering can only induce transitions among the groundstates. Zero m om entum spacetime axions are characterized by harm onic form s on X, so axion scattering is a map involving H (X) and H (M N (X)). This strongly suggests that the scattering should be given by the D onaldson

map. In the following two subsections we demonstrate that this is indeed the case by two separate methods. Subsection (A) contains a straightforward continuation of the collective coordinate expansion. In subsection (B), it is observed that the D onaldson map has a geometric interpretation as a certain connection coe cient derivable from a K ahler potential. It's form is then deduced in a few lines using supersymmetry.

A : D erivation by C ollective C oordinate E xpansion

Consider the interaction of a low-momentum spacetime axion with the worldbrane ferm ions. O ther spacetime elds can be treated in an analogous fashion. Spacetime axions are described by the potential

B: Derivation from Kahler Geometry.

In this subsection we will provide an alternate derivation of (coup) which is less direct, but shorter and provides som e geom etrical insight. For these purposes it is convenient to view the solution (sdual) { (m etax) not as N vebranes on X, but as a \com pactication" from ten to six dimensions. The low-energy action then contains, in addition to Z<sup>i</sup>, com plex m assless m oduli elds Y that parameterize the com plexied K ahler cone (a subset of H<sup>2</sup>(X;C)). The imaginary part of Y is the axion associated to the harm onic two form T on X (The index was suppressed in the previous subsection.). Six-dimensional supersymmetry then implies that the metric appearing in the kinetic term for the moduli elds is K ahler, or equivalently in complex coordinates

C: The D onaldson M ap as the Second C hern C lass

It is known [4, see also 13,14] that 0 can be written as integrals of trF<sup>2</sup> for a certain curvature F. The fact that 0 couples to axions then strongly suggests that the observations in this paper are connected with the structure of anom alies in string theory. W hile we do not understand this connection, in the hope that it m ight be understood later we record here this representation of 0. ## D: The Donaldson Polynom ial

A physical realization of the D onaldson polynom ialm ay be obtained by considering multiple axion scattering. Let jn i be the ground state corresponding to the top rank form on M  $_{\rm N}$ :

W hile our derivation from string theory of (m nal, poly) was only valid for  $c_1(X) = 0$ , it is known [4] that (m nal) and (poly) are representations of the D onaldson m ap and polynom ial for any algebraic X. It would be interesting to try to extend our derivation to the m ore general case. We have shown that the D onaldson m ap appears explicitly as a coupling in the lowenergy action for heterotic string theory in the soliton sector. This implies the D onaldson polynom ial can be measured by scattering massless elds and solitons. This realization leads to concrete formulae for the D onaldson m ap and polynom ial which are equivalent to, and provide a new perspective on, formulae derived by W itten in the fram ework of topological Y ang-M ills theory. It also led to an interpretation of the D onaldson m ap as a K ahler-Christo el connection on H  $^{2}$  (X ;C) M N (X).

The fact that this scattering is a map between cohomology classes was insured by zero-momentum worldbrane supersymmetry, which acts like the exterior derivative on  $M_N$ . This should be contrasted with topological Yang-M ills theory where the exterior derivative on the instanton moduli space is constructed in terms of a BRST operator.

O ur work suggests a num ber of generalizations and applications. Perhaps this connection can provide new insights into, or stringy interpretations of, the various theorem s on the structure of four-m anifolds which follow from D onaldson's work. A lternately, the rem arkable properties of the D onaldson polynom ialm ay translate into interesting properties of the vebrane-axion S-m atrix, or even have im plications for the closely related problem of instanton-induced supersymmetry breaking in string theory.
