A bstract

We extend Felder's construction of Fock space resolutions for the Virasoro minimal models to all irreducible modules with call in particular, we provide resolutions for the representations corresponding to the boundary and exterior of the Kactable.

1. Introduction

The problem we address in this letter arises quite naturally in the so-called free eld approach to conform all eld theories. The mathematical question one wants to answer within this fram ework is whether a given irreducible module L of the chiral algebra A has a resolution in term sofFock spaces. More precisely, one wants to construct a family of free eld Fock spaces $F^{(i)}$, which are A-modules, and a set of A-homomorphisms (intertwiners) $d^{(i)}:F^{(i)}!F^{(i+1)}$, such that these spaces with the maps between them form a complex whose (co)homology is isomorphic to L. The rst example of such a construction was given by Felder [1] for the class of representations of the Virasoro algebra corresponding to minimal models [2]. Later, this was extended to other conformal eld theories, in particular W ZNW and their coset models (for review see [3] and references therein).

Felder's construction relies on the complete classication of submodules of Fock spaces given by Feigin and Fuchs [4,5], and the explicit form of the intertwiners. The latter are dened, following Thom [6], asmultiple integrals of products of the screening currents. One may wonder whether the restriction to the representations in the fundamental range of the minimal series is important. The answer turns out to be negative, and already examples of similar resolutions outside this series have been discussed in [7]. In the following we will argue that a Fock space resolution can be explicitly constructed for any irreducible highest weight module of the Virasoro algebra provided one introduces additional intertwiners besides those considered in [1,7]. The existence of such intertwiners, and their properties needed in the computation of the cohomology, were demonstrated by T suchiya and K anie [8]. We will discuss some of their results within the Dotsenko-Fateev formalism [9], as used in [1,3], which may be more familiar. Not to make our presentation too long we will restrict to modules with c 1.

Our three main results, which cover the cases not analyzed previously, are sum marized in Theorems 5.2, 6.1 and 7.1. In particular, the rst gives the resolution for modules corresponding to the so-called boundary of the Kac table [10], whilst the last extends Felder's construction to modules outside the fundamental range.

This letter is organized as follows: In Section 2, as well as introducing some denitions and notation, we summarize the results of Feigin and Fuchs which will be used later. Then, in Sections 3 and 4, we introduce intertwiners and recall the construction of Felder's complex. After this review, we discuss the boundary case in detail in Sections 5 and 6, and in Section 7 describe the extension of the resolution for the irreducible modules beyond the fundamental range. We conclude in Section 8 with some remarks on possible applications of these results.

2. Feigin-Fuchs m odules

The generators of the Virasoro algebra, Vir, satisfy

In this letter we will consider three classes of highest weight modules of V ir: the irreducible modules $L_{h;c}$, the Verma modules M $_{h;c}$, and the Feigin-Fuchs modules $F_{p;Q}$. We recall that the central charge, c, and the conformal dimension, h, determine $L_{h;c}$ and M $_{h;c}$ completely, and that the latter is generated freely by L_{n} , n 1, acting on the vacuum $V_{h;c}$, $L_{0}V_{h;c} = hV_{h;c}$.

The Feigin-Fuchs module $F_{p;Q}$ is just the Fock space of a scalar eld, (z), with a background charge Q and momentum p such that

The Fock space $F_{p;Q}$ is generated from the vacuum v_p , $_0v_p = pv_p$, by the free action of the creation operators $_m$, $_m$ 1.

As can easily be seen from (2.5), $F_{p;Q}$ and $F_{p;Q}$ are isom orphic as V irasoro m odules. Choosing one solution for Q in (2.2) leaves us, for a given h and c, with two Fock spaces $F_{p;Q}$ and $F_{2Q}_{p;Q}$, dual to each other, i.e. $F_{p;Q}$ ' $F_{2Q}_{p;Q}$.

See, e.g. [11] for basic de nitions and [2,12] for a review of conformal eld theory techniques used throughout this letter.

The detailed structure of subm odules of all Verm a and Feigin-Fuchs modules of the Virasoro algebra has been obtained in [4,5]. There are three main types of modules, I, II and III, depending on whether the equation

has respectively zero, one or in nitely many integral solutions for x and y. Here we have introduced $_{+}$ and $_{+}$ $_{+}$ = 1, which also parametrize the background charge,

In the rst case (type I) the Vermam odule and the Fock space are isomorphic and irreducible [5], and obviously no resolution is needed. Thus we will assume that (2.7) has at least one integral solution, or, equivalently, that the momentum p can be parametrized by a pair of integers n and n^0 (i.e. there is exactly one such pair for type II, and for modules of type III in nitely many such),

For $p_{n;n^0}$ as in (2.9) we denote the corresponding conform aldimension, computed from (2.2), by $h_{n;n^0}$, and, for a xed Q (and c) write $F_{n;n^0}$ and $M_{n;n^0}$ instead of $F_{p_{n;n^0};Q}$ and $M_{n;n^0;C}$. Virasoro modules with the momentum given in (2.9) arise in the generalized D otsenko-Fateev minimal models [9,7].

In case III, in order to have in nitely many integral solutions to (2.7), there must exist (relatively prime) integers p, p^0 , $pp^0 \in 0$, such that $p_+ + p^0_- = 0$. We can then take $p_+ = p^0$ and $p_+ = p^0$. Clearly the central charge must be rational, and, depending on whether $pp^0 > 0$ or $pp^0 < 0$ we have $p_+ = p^0$. In the following we will restrict ourselves to $p_+ = p^0$ and take $p_+ = p^0$. In particular $p_+ = p^0$ corresponds to $p_+ = p^0$, and for $p_+ = p^0$, we must have $p_+ = p^0$. Using the freedom in the parametrization of the momentum, $p_+ = p_+ =$

we will say that the module belongs to the fundamental range of the minimal series [2], or to the interior of the Kac table [10]. The exterior of the table is dened by letting $n \in 0 \mod p$ to be outside the range (2.10). Finally, $n = 0 \mod p$ or $n^0 = 0 \mod p^0$ correspond to the boundary of the table.

In cases II and III, the detailed structure of F_{n,n^0} as a V irasoro m odule depends on the momentum p_{n,n^0} (2.9), and all possible subcases (in case III with c 1) are listed in the following theorem which sum marizes the results of Feigin and Fuchs.

Theorem 2.1. (5) In case II there are four subcases:

Case II (respectively II₀): If $nn^0 < 0$ (respectively $nn^0 = 0$) then $F_{n;n^0}$ and $M_{n;n^0}$ are isomorphic and irreducible.

Case II (): If $n; n^0 < 0$ then $F_{n;n^0}$ ' M $_{n;n^0}$ are reducible. The maximal submodule is isomorphic with $F_{n;n^0}$ ' M $_{n;n^0}$.

Case II (+): This case, where $n; n^0 > 0$, is dual to II+ (), e.g. $F_{n;n^0}$ ' M $_{n;n^0}$.

In case III for c 1 there are four subcases, in all of which the Fock space is a reducible module. In the rst three, III and III 0 () below, $p^0 > p > 1$ (i.e. c < 1), and m; m 0 denote labels in the fundamental range, 1 m p 1, 1 m 0 p 0 1. In III 00 we have p^0 p 1 (i.e. c 1). In all cases j 2 \mathbb{Z} .

C ase III: The submodules of $F_{m+jp,m} \circ$ are generated by the vectors u_i , v_i , and w_i given by the following diagram

In the diagram s (2.11), (2.13), and (2.15) vectors u_i correspond to singular vectors in the Fock space $F_{?;?}$ and generate the submodule, $F_{?;?}^0$, which is a direct sum of irreducible highest weight modules. In the quotient $F_{?;?}^0 = F_{?;?}^0$ vectors v_i become singular, and generate $F_{?;?}^{0}$ which is a direct sum of irreducible highest weight modules. Note that v_0 is special, since it is singular. Finally, w_i are singular in $F_{?;?}^0 = F_{?;?}^{0}$, and generate a direct sum of irreducible highest weight modules. The arrows, 1! 2, indicate that the second vector is in the submodule generated by the rst one.

There are also similar diagrams for the composition series of singular vectors of the Vermam odules, in which the singular vectors occur at precisely the same conformal weights as above. Moreover, some arrows must be reversed, so that all of them describe embeddings of the Verma submodules.

3. The intertw iners

Let us rst introduce a class of intertw iners between Fock spaces. They are constructed as products of the screening currents

In order that (3.3) be a well-de ned operator we must require that $_k$ is a closed contour [8], i.e. it is an element of H (M $_k$; S $_2$), the homology of M $_k$ with coe cients in the local system S $_2$ corresponding to (3.4) (this system depends only on $_2$).

In explicit computations one needs to have convenient representatives of these homology classes. We will construct them using the following two classes of multicontours (singular at a point) that have been used in [1,13,3]: In the rst class, which we denote k, the integration variables $z_1; :::; z_k$ are taken counterclockwise from 1 to 1 around 0, and nested according to $j_1 j > :::> j_k j$. In the second, b_k , the z_1 integration is along a contour surrounding 0, while $z_2; ::: z_k$ are integrated counterclockwise from the base point z_1 to z_1 around 0, and the nesting is the same as in k. The ambiguity in the phase of the integrand (3.3) is xed by analytic continuation from the positive real half-line (see [1,13]). Let us denote the resulting operators (3.2) by $Q_r^{(+)}$, $Q_r^{(-)}$ and $Q_r^{(+)}$, $Q_r^{(-)}$, respectively.

We will also consider multiple contours obtained by putting several of those together. For example $_k$ [$_{k^0}$ will denote a multiple contour z_1 ; ::: z_k ; ::: z_{k+k^0} in which the variables of $_{k^0}$ are nested inside those of $_k$.

We may now state the main result about the intertwiners between Feigin-Fuchs modules of type III due to Tsuchiya and Kanie [8].

Theorem 3.1.1) Consider F_{n,n^0} , where n=m+jp, 1 m p, j 2 \mathbb{Z} , and n^0 is arbitrary. Then for any non-negative integer k the operator

Here $v_{n;n^0}$ and $v_{n-2(m+kp);n^0}$ denote vacua of $F_{n;n^0}$ and $F_{n-2(m+kp);n^0}$, respectively.

The analogous result holds for the operators $Q_{?}^{()}$ [?].

4. The Fock space resolution for type II+ and III modules

We begin by constructing explicitly intertwiners using contours $_{r}$, $_{r^{0}}$, $_{r}^{b}$ and $_{r^{0}}$, $_{r}^{b}$ and $_{r^{0}}$, $_{r}^{b}$ and $_{r^{0}}$, introduced in the previous section.

Lem m a 4.1. Operators $Q_r^{(+)}$; $Q_r^{(+)}$: F_{n,m^0} ! F_{n,m^0} and $Q_{r^0}^{(-)}$; $Q_{r^0}^{(-)}$: F_{n,m^0} ! F_{n,m^0} are well de ned intertwiners between V irasoro modules if $r = n \mod p$ and $r^0 = n^0 \mod p^0$, respectively.

Proof: Operators $\phi_r^{(+)}$ and $\phi_r^{(-)}$ are well de ned and commute with the action of the V irasoro algebra i b is a closed cycle. This amounts to the z_1 -contour being closed. For the values of r and r^0 as in the lem m a this is easily verified using standard methods [1]. For $Q_r^{(+)}$ and $Q_{r^0}^{(-)}$ we use the following lem ma which can be proven by standard manipulations with the contours [1,13].

Lem m a 4.2. For 1 r p and 1 r^0 p^0 ,

Note that for positive r_1 , r_2 , r_1+r_2 pwe have $Q_{r_1}^{(+)}Q_{r_2}^{(+)}=Q_{r_1+r_2}^{(+)}$, provided $Q_{r_1}^{(+)}$ and $Q_{r_2}^{(+)}$ act on spaces on which they are well-deneed. In particular { after further investigation of the integral in $\mathcal{D}_p^{(+)}$ { (4.1) in plies

The same also holds for $Q_{m}^{()}$.

Lem m a 4.1 together with identity (4.2) is the basis for the construction of the com plex of Fock spaces when m , m 0 lie in the fundamental range (2.10). This com plex, (F;d) $f(F_{m,m}^{(i)});i2 \mathbb{Z}g$, is defined as follows

U sing the submodule structure of Fock spaces $F_{m,m}^{(i)}$ as summarized in Theorem 2.1, Felder [1] was able to compute the kernels and the images of all the intertwiners $d^{(i)}$, and prove the following important result

Theorem 4.3. Let 1 m p 1,1 m 0 p 0 1. Then the complex (F;d) de ned in (4.3) is a (two-sided) resolution of the irreducible module $L_{m,m}$, i.e.

In fact there are three more resolutions, one in terms of modules $F_{p\ m\ p^0\ m^0}^{(i)}$ (recall that $F_{m\ p^0\ m^0}$ for $F_{p\ m\ p^0\ m^0}$ and $L_{p\ m\ p^0\ m^0}$ for $L_{m\ p^0}$, and two others if we use operators $Q_2^{(i)}$ instead of $Q_2^{(i)}$.

It may be worth noting that Felder's proof also shows that the dierential in the complex is nilpotent without resorting to the computation in (4.2).

A similar construction for the modules of type II, () was carried out in [7].

Theorem 4.4. In the notation of Theorem 2.1, let $n; n^0 < 0$. Then the complex

5. Resolutions for the modules of type ${\rm III}^0$

U sing the results reviewed in the previous sections we will now construct resolutions for irreducible modules $L_{h;c}$ of type III^0 , for which $h=h_{m+jp;0}$, $1 m p 1 or <math>h=h_{0;m}$, $h=h_{0;m}$

Let us consider the Fock space $F_{0,m}$ $^{0}+jp^{0}$. A coording to Theorem 2.1 this space has type III^{0} () and its maximal submodule, $F_{0,m}$ $^{0}+jp^{0}$, is generated by vectors u_{i} , v_{i} , i=1. It also follows from (2.13) that the irreducible module is isomorphic to the quotient, namely

By comparing (2.14) and (2.15) we note that the weights of u_i and v_i in $F_{0,m}^0 \circ_{+jp^0}$ are precisely those of the vectors generating submodules of the Fock space $F_{0,m} \circ_{(j+2)p^0}$. Let us denote the latter vectors by u_i^0 , v_i^0 , i=1. This observation and (5.1) reduce the problem of constructing a resolution to that of noting a homomorphism of from $F_{0,m} \circ_{(j+2)p^0}$ into $F_{0,m} \circ_{+jp^0}$, such that $du_i^0 = u_i$ and $dv_i^0 = v_i$, i=1. Note that then dimust be injective, i.e. it is an embedding.

In a sense the problem is similar to the one in case II₊ (), except that the structure of submodules of Fock spaces is somewhat more complicated. Since $F_{0,m^{0}+jp^{0}}$ ' $F_{jp,m^{0}}$ and $F_{0,m^{0}-(j+2)p^{0}}$ ' $F_{(j+2)p,m^{0}}$, the intertwiner should involve (j+1)p currents s_{+} (z). By Theorem 3.1 we know it exists. To construct it explicitly we observe that, in view of Lemma 4.1 and (4.2), an obvious building block for such operators is $\Phi_{p}^{(+)}$. Its properties are summarized in the following technical lemma whose proof will be outlined at the end of the section.

Lem m a 5.1. Consider $\mathcal{D}_p^{(+)}: F_{0m} \circ_{+kp^0} ! F_{0m} \circ_{+(k+2)p^0}$, k 2 \mathbb{Z} . Depending on k there are four cases described by the diagram s i) (iv) below. O perator $\mathcal{D}_p^{(+)}$ m aps special vectors u_i^0 and v_i^0 from the rst Fock space onto u_i and v_i in the second space, as indicated by the downward arrows, i.e. $\mathcal{D}_p^{(+)}$ is nonzero along these arrows.

Theorem 5.2. The intertwiner $d=(\Phi_p^{(+)})^{j+1}$ is an embedding of $F_{0,m} \circ (j+2)p^0$ into $F_{0,m} \circ + jp^0$, i.e. the complex

Proof: Using Lemma 5.1 we can compute the image of F_{0m^0} $_{(j+2)p^0}$ when acting with subsequent $p_p^{(+)}$. The result is $d(F_{0m^0} (j+2)p^0) = F_{0m^0+jp^0}^0$. The second part of the theorem follows from $L_{0m^0+jp^0}$ $L_{0m^0+jp^0}$ and $p_p^{(+)} = p_p^{(+)}$.

C learly, for m odules $L_{m+jp;0}$ there are analogous resolutions in which the di erential is $\Phi_{p^0}^{(\cdot)}$.

Proof of Lem m a 5.1: The general idea of the proof is the same as that of parts of Theorem 4.3 (see [1]). Let us begin with case i). By Theorem 3.1.2.i) $\Phi_p^{(+)} u_1^0 \in 0$. To verify this we choose a covector $2 F_{0m^{0+}(k+2)p^0}$ (see [6] and Appendix in [1]) such that

Then a straightforward computation yields

We used here an explicit result for the Dotsenko-Fateev integral [9]

The rest of the lem m a in this case follows entirely from the embedding patterns of submodules in both Fock spaces and $\mathcal{D}_p^{(+)}$ being an intertwiner. Let us outline the rst few steps.

Normalize u_2 such that $u_2=\bigoplus_p^{(+)}u_1^0$. Since u_1^0 is in the submodule generated by v_1^0 we must have $\bigoplus_p^{(+)}v_1^0\in 0$. Note that the latter remains nonzero after we divide $F_{0,m}$ of $(k+2)p^0$ by the submodule generated by u_1 and u_2 . Indeed, suppose the opposite, i.e. that $\bigoplus_p^{(+)}v_1^0=P_1u_1+P_2u_2$, where $P_{1;2}$ are some polynomials in L_n , n-1. Since the submodule generated by u_1 and u_2 is a direct sum of two irreducible ones, we also have $u_1=P_1^0P_1u_1$ where P_1^0 is some element in the enveloping algebra of V in But if $P_1u_1\in 0$ then $u_1=\bigoplus_p^{(+)}P_1^0(v_1^0-P_2u_1^0)$, and a simple examinination of the weights in both Fock spaces shows the rhands of u_1^0 and u_2^0 is a contradiction. Thus we can at most have u_1^0 in u_1^0 but then u_2^0 in u_1^0 in u_2^0 in u_1^0 in u_2^0 in u_1^0 in the kernel of u_1^0 in u_1^0 . Case ii) is proven by exactly the samemethod. Cases iii) and iv) are dual to ii) and i), respectively. Since $\mathcal{D}_p^{(+)} = \mathcal{D}_p^{(+)}$, we deduce from coker $\mathcal{D}_p^{(+)}$ 'ker $\mathcal{D}_p^{(+)}$ that $\mathcal{D}_p^{(+)}$ must be onto. Because $\mathcal{D}_p^{(+)}$ commutes with Vir, u_i^0 are mapped onto u_i , and the maps indicated by the arrows are clearly nonzero. After we divide both sides by submodules generated by u_i^0 and u_i , respectively, $\mathcal{D}_p^{(+)}$ becomes a homomorphism from a direct sum of irreducible highest weight modules onto a direct sum of a subset of these modules, and the arrows between v_i^0 and v_i follow.

6. Resolutions for the modules of type ${ m III}^{00}$

The problem of obtaining a resolution for a module $L_{jp;0}$, j=0, is similar to the one discussed above. Given the Fock space $F_{jp;0}$ we must construct an embedding from $F_{(j+2)p;0}$ into $F_{jp;0}$. The result is

Theorem 6.1. Let p^0 p 1 and j 0. The operator $p^{(+)}$: $F_{(j+2)p;0}$! $F_{jp;0}$ is an embedding and $F_{(j+2)p;0}$? $F_{(j+2)p;0}$.

Proof: Since $F_{jp;0}$ and $F_{(j+2)p;0}$ are direct sums of irreducible highest weight modules, the proof essentially consists of verifying that $\oint_p^{(+)}$ does not annihilate any of the singular vectors in $F_{(j+2)p;0}$. For simplicity let us only consider the case $p=p^0=1$, i.e. c=1. Then $\oint_1^{(+)} = dz : exp(i-2)(z)$: is just a vertex operator. Using explicit formulae (in terms of Schur polynomials) for singular vectors in the Fock space $F_{kp;0}$, k=0 [14,15], it is easy to check that, up to normalization, they coincide with the vectors $(\oint_1^{(+)}) v_{kp+2}$, of 0, where v_{kp+2} , denotes the vacuum of F_{kp+2} , 0. The theorem is then obvious. The general case is similar.

7. Generalizations of Felder's construction

Consider an irreducible module, $L_{m+jpm} \circ$, of type III , where m;m 0 lie in the fundam ental range (2.10) and j is an arbitrary integer. The Fock space $F_{m+jpm} \circ$ appears in the complex (F;d) corresponding to the resolution of $L_{m,m} \circ$ for j even, and $L_{p,m,m} \circ$ for j odd, constructed as in Section 4. An important feature of (F;d) is that the vacuum of the 0-th Fock space has the highest weight with respect to all other states in the complex. In particular, this guarantees that the cohom ology contains at least the irreducible module. Let us now consider the collection of Fock spaces obtained by removing from (F;d) all Fock spaces whose weights are higher than $h_{m+jpm} \circ$; i.e. we delete the spaces $F_{m+2jpm} \circ$;:::; $F_{m-2jpm} \circ$ for j > 0, and the spaces $F_{m-jpm} \circ$;:::; $F_{m+(j+2)pm} \circ$ for j < 0. On both sides of the deleted segment the di-erential is de ned as before in terms of $Q_m^{(+)}$ and $Q_{p-m}^{(+)}$. In the middle we must use a new intertwiner of the form

$$Q_{m+kp}^{(+)} = [(s_{+})^{m+kp}]_{m+kp} \text{ or } Q_{(p-m)+kp}^{(+)} = [(s_{+})^{(p-m)+kp}]_{(p-m)+kp}; k 1;$$

where $m_{+}kp_{-}=m_{-}[b_{p}_{-}]:::[b_{p}_{-}]$ and $m_{(p-m_{-})+}kp_{-}=m_{-}[b_{p}_{-}]:::[b_{p}_{-}]$. The resulting extension of the Fock space resolution to modules outside the fundam ental range can be sum marized by the following theorem .

Theorem 7.1. Let 1 m p 1,1 m 0 p 0 1, and j 0. Then the complex of Fock spaces

$$Q_{m}^{(+)} = F_{m+(j+2)p,m} \circ Q_{p,m}^{(+)} = F_{m-jp,m} \circ Q_{m}^{(+)} = F_{m-jp,m} \circ Q_{m}^{(+)} = F_{m-jp,m} \circ Q_{p}^{(+)} = G_{m}^{(+)} = G_{m}^{(+)}$$

is a resolution of the irreducible module L_{m} $_{jp,m} \circ$, while

$$Q_{m}^{(+)}$$
 $F_{m+(j+2)p,m} \circ Q_{p}^{(+)}$ $F_{m+jp,m} \circ Q_{m}^{(+)}$ $F_{m}^{(+)}$ $F_{m}^{(+)}$

is a resolution of $L_{m+jp;m} \circ$.

Proof: Contours (p m)+kp and m+kp are nontrivial cycles in local hom ology. This can be verified by a computation similar to the one in the proof of Lemma 5.1. Thus the intertwiners $Q_{(p m)+jp}^{(+)}$ and $Q_{m+jp}^{(+)}$ are precisely those given in Theorem 3.1. In particular they satisfy i) and ii), respectively, which is precisely what one needs to extend the proof of Theorem 4.3 to the present case.

It is clear that the three other resolutions discussed in Section 4 { the dual, and the two others constructed with Q $_?^{(-)}$ instead of Q $_?^{(+)}$ { m ay be extended in the same way to m odules outside the fundamental range.

8. Concluding remarks

Form ally, the new intertwiners in Sections 5, 6 and 7 are proportional to operators of the form

$$\frac{[(s)^k]}{[k]_a!}; \qquad (8:1)$$

where $[n]_q$ denotes the usual q-number. As has been extensively discussed for free eld realizations during the past two years, the screening currents inside [[] satisfy the dening relations of generators of a quantum group U_q (n) (see e.g. [3] and references therein). It is worth noting that in the discussion of the general class of resolutions in this letter one is autom atically led to the \rescaled quantum group [16]1.

An interesting application of these resolutions is to extend the computation of the BRST cohomology of minimal models coupled to 2D quantum gravity [17] to generalized Dotsenko-Fateev models using methods discussed in [18]. This is elaborated in more detail in [19].
