ABSTRACT

U sing the nite-size e ects the scaling dimensions and correlation functions of the main operators in continuous and lattice models of 1d spinless B ose-gas with pairwise interaction of rather general form are obtained. The long-wave properties of these systems can be described by the G aussian model with central charge c = 1. The disorder operators of the extended G aussian model are found to correspond to some non-local operators in the XXZ H eisenberg antiferrom agnet. Just the same approach is applicable to ferm ionic systems. Scaling dimensions of operators and correlation functions in the systems of interacting Ferm iparticles are obtained. W e present a universal treatment for 1d system s of di erent kinds which is independent of the exact integrability and gives universal expressions for critical exponents through the therm odynam ic characteristics of the system.

1 Introduction

Recently the new elective method to investigate 1d quantum system susing the nite-size e ects in conformal eld theory (CFT) was proposed in a number of papers [1-6]. In 1d quantum systems there exist phase transition at zero temperature and corresponding long-distance conformal symmetry appears to be enough to determ ine the properties independent of the interaction at small scales. These properties are really of a great interest in the 1d systems. Am ong them the correlation functions, i.e. expectation values of operator products in di erent points are especially interesting. The correlations at large distances decrease as a power of the distance (at zero temperature) the criticalexponents" being continuously dependent on the coupling constant [7-9].

In 2d systems the conform al invariance is known to constrain the spectrum of scaling dimensions [10]. It does really determ ine the critical exponents in 1d quantum systems (i.e. in 2d models of the quantum eld theory with one space and one time directions). The essential point is that it is possible to calculate central charge and scaling dimensions of the eld theory using the so-called nite-size eld ects [1,2,11].

This paper is a review of applications of CFT m ethods to \real" physical 1d system s which, as they appear, are neither conform almor exactly integrable. We propose a united treatment of physically relevant 1d systems of dimensional treatment of a physically relevant 1d systems of dimensional treatment are continuous and lattice models of Bose or Ferm in ultiparticle systems with interaction of a quite general type and 1d lattice antiferrom agnetic spin chains. We shall study the long-wave behaviour of the correlation functions in these models. The corresponding critical exponents are determined from the leading mite-size corrections to the low energy spectrum. A remarkable point is that these leading corrections are in a sense universal: they are completely determined by general thermodynamic characteristics of the systems. So our expressions for the critical exponents through certain susceptibilities have a wide range of applicability. They include all previously known examples as particular cases.

This review is based mostly on our short publications [22,23,43]. Here we present the more detailed argum entation with new examples and discussions.

To begin with, let us rem ind the ideology and m ain form ulas of the nite-size approach in CFT [11]. Consider a CFT on an in nite strip of width L in space direction. Then each

(such that hvacj $j_{k,k}$ i \in 0). Here h + and s are scaling dimension and spin of the operator respectively, k;k 0 - are integers, E_L^{vac} is the ground state energy of the system in the \box" of length L. The momentum of the lowest state $j_{0,0}$ i j i of the tower at L ! 1 is denoted by P_1 . At last, the parameter v in (1) takes into account the di erence in units of the space and tem poral quantities, i.e. v is merely the velocity of sound excitations (group velocity at the Ferm i surface).

Thus, to nd the spectrum of primary operators it is su cient to calculate the energies of the lowest excitations $E_L(0;0) = E_L$ of each tower up to the terms of order L⁻¹

The states from -tower with k; $k \in 0$ correspond to the so-called descendants (or secondary elds) of [10]. They have the de nite scaling dimensions h + k + k (but they are not primary elds!) and give a contribution to correlators too. However, we shall see that the leading term of asymptotics of the correlators is determined only by the primary elds.

The long-wave asymptotics of two-point equal time correlator of the eld has the form

the oscillating factor $\cos(P_1 x)$ being determ ined by a gap P_1 into the momentum spectrum. For simplicity, throughout this paper we consider only the equal time correlators. Their asymptotics is completely determined by the scaling dimensions h of the eld . The generalization to the space-time correlators is straightforward. In this case one also should determ ine the value of spins:

Indeed, the nite-size approach allows one to nd out the central charge of the V irasoro algebra of the conform al sym m etry using the equation sim ilar to eqs.(1)-(3). Namely, the correction L^{-1} to the ground state energy of the system is proportional to the central charge c [1,2]. For example, for the theory with periodic boundary conditions one obtains:

Here $_0$ is the energy of the ground state per unit length in an in nite volume. The rst term in (5) depends on regularization, but the second does not. In other words, the rst (therm odynamic) term is determined by ultraviolet behaviour of the system; the leading corrections being given by the infrared properties.

U sually it is convenient to calculate the central charge by m eans of another form ula which is equivalent to (5). Due to the modular invariance the case of zero temperature (T = 0) and large L is equivalent to the case of the in nite volume (L = 1) and low temperature T. In the latter case (5) is rewritten as follows:

where f (T) is the density of the free energy as a function of the tem perature (at sm all T):

In the paper [3-6] the equations (1)-(3), (5)-(6) were used to calculate the critical exponents in 1d exactly solvable models. Namely, the low-lying excitation energies have been calculated within the Bethe-ansatz framework [12]. At present time there exist m any papers devoted to this topic (see, for example, [1-6,13-20] and references therein) and we would not repeat here the nite-size calculations in integrable theories. Instead, we shall concentrate on the following in portant but less familiar aspects. First, the method turns out to be applicable to the models with general interactions and leads to results of the same completeness as in the exact solvable models. Second, the results which have been obtained earlier are in fact valid only for bosonic systems. The critical exponents in fermionic systems di er, generally speaking, from the bosonic ones and can also be obtained by means of the nite-size method. At last, the nite-size e ects allow one to

calculate the asymptotics of vacuum expectation values of some non-local operators in the 1d system s. All these questions are the subject of the present paper.

We shall consider the following classes of 1d systems. The rst one contains the continuous models of the spinless Ferm i-or Bose-gas with interaction of a general form, the second quantized Hamiltonian being (the mass of particle is 1=2):

Here L is the length of the system, V (x) is some even pairwise (repulsive) potential of a rather general form, g > 0 is the coupling constant. The operators ; satisfy usual equal-time (anti)commutation relations (to indicate the statistics manifestly we sometimes use the notation $_{\rm B}$ or $_{\rm F}$). The number of particles in the system N is conserved; in the therm odynamic limit N ! 1, L ! 1 and = N=L is the equilibrium density. Note that the potential V (x) = (x) admits the exact solution [12]. In the rst quantized fram ework the Ham iltonian (7) has the form

The second case under consideration is the lattice version of (7)-(8):

Here we put the lattice spacing equal to 1, so x and L become dimensionless quantities now. If necessary, one can easily restore dependence of the lattice spacing in nalanswers.

At last, we shall deal with XXZ Heisenberg antiferrom agnet (or sim ply the spin chain) with the lattice Ham iltonian:

Here L is the number of sites of the lattice, ⁱ are usual Paulim atrices, is the anisotropy parameter. Isotropic (XXZ) Heisenberg antiferrom agnet corresponds to = 0. For the XXZ antiferrom agnet model there exists an exact solution. N amely, all eigenstates of the Hamiltonian (10) can be constructed explicitly by the Bethe's method [12]. The simplest eigenstate with all spins boking at the same direction (i.e. full spin is equal to L=2) is the bare (unphysical) vacuum. The physical vacuum of the antiferrom agnet has the minim al possible value of the full spin (0 or 1=2 depending on the parity of number of sites L) and corresponds to the led bare vacuum, the number of reversed spins being an analog of the number of particles in the models (7)–(9).

In fact, after the Jordan-W igner transform ation (that is, $(x) = \begin{pmatrix} 0 & x & 1 & 3 \\ j=1 & j \end{pmatrix}_{x}$, $y(x) = \begin{pmatrix} 0 & x & 1 & 3 \\ j=1 & j \end{pmatrix}$ (10) can be considered as a special case of (9). The simplest H am iltonian (10) is chosen to make possible a comparison with the Bethe ansatz results. We can also consider more general spin 1/2 chains with the exchange interaction corresponding to arbitrary potentials in (9).

All these models have a number of common physical properties. The most important property is the absence of a gap in the low-energy spectrum. In fact, such a general statement is not quite correct because one correctly can tune V (x) and to create a gap in the spectrum of the lattice system (9). We are convinced, however, that the generic case with spinless 1d systems is just the gapless spectrum with unique sound velocity¹. Som e comments on this point are contained in the Section 2.

A nother in portant property of m odels under consideration is that the central charge calculated from (4) in XXZ antiferrom agnet is equal to 1 [3,14] and just the same holds for the m odel (7)-(9). So all these m odels are described by the universality class of a G aussian m odel [21]. It is not very am using since the lowest excitations are nothing but free phonons.

Some comments on long-wave approximation are in order. The proper distance x_c when individual particles have sense is equal to x_c L=N = 1 = . At large distances (x x_c) there arises an elective theory describing the phonon excitations, the information

about interaction at small distances being contained in the only parameter v. Then the low-energy excitations corresponding to the linear dispersion law lead to e ective scaling and conform al invariance (the O (2)-invariance is trivially restored by the choice of units so that v = 1). Therefore, the deviations from the exact conform al theory can only be discovered at small L, so the series in L¹ are correct.

Now we brie y describe the content of the paper. In the Section 2 we calculate the energies of low-lying excitations for the continuous B oxe-gas model and obtain the spectrum of scaling dimensions for this system. The more complicated case of lattice systems is considered in the Section 3. Here the universal expressions for the "compactication radius" in the G aussian model through therm odynamic parameters of the system will be obtained. Then, using all these results, we write down the asymptotical series for correlation functions (Section 4). The most important examples (pair density correlator and one-particle density matrix) are discussed in detail. It turns out that a simple generalization of the nite-size method allows one to nd the asymptotics of vacuum expectation values of some non-local operators as it is demonstrated in Section 5. Here the main examples are some special non-local operators in the spin chain. At last, the Section 6 is devoted to the system s of Ferm i-particles. We show how the nite-size method may be used to calculate the exact critical exponents in this case.

The Appendix is devoted to a non-trivial example of 1d multi-particle systems with long-ranged interaction | the so-called Sutherland (or, Calogero) model [28]. First, we calculate the elective central charge from the low-temperature behaviour of the special heat. Second, we compare the exact results for correlation functions in this model with the asymptotical series obtained from the CFT-approach. This model has never been discussed in the literature from the conformal point of view. It seems to us that the detailed exposition of this example could be useful.

2 Scaling dimensions in the Bose-gasmodel

Let us consider the Bose-gas described by the Ham iltonian (5). To obtain the scaling dimensions of dimensions of dimensions it is necessary to classify the low -lying excitations having zero energy at L = 1. We imply periodic boundary conditions, i.e. the particles live on

a circle of the length L:

The typical excitation spectrum of the 1d spectrum is shown schematically in Fig1. O ne can learn that it is gapless with the energy tending to zero when the momentum is equal to 2 m (m is integer). These properties hold for rather large class of both long-range and short-range potentials V (x). Indeed, the cases of sm all and large constants g in (7)–(8) have been studied in the literature. In [24], where the case of sm all g in Ferm i system s was studied perturbatively, it was concluded that the correlators have a power-like behaviour and no gap em erges. The case of long-range V (x) and large g (strong repulsion) was considered in refs. [25,26,27]. In this case, the abænce of the gap becomes quite obvious. Indeed, independently from V (x), the particles form a regular \dynamical lattice" (the so-called W igner crystal) with sound-type low-energy excitations. From the other hand, there exist several exactly solvable models which possess a gapless spectrum. These are, for exam ple, the model with delta-shape potential and that with the potential V (x) = x² (the Sutherland m odel [28]). Evidently, the gap will not appear when perform ing sm all deform ations of the Sutherland potential which do not entail a qualitative rearrangem ent of the ground state.

We should investigate the spectrum when L is large but nite. Then the spectrum is quasi-discrete with the energy gap L^{-1} (see Fig.2). We are interested in the states with zero energy at L = 1. The states j i corresponding to the primary conform all operators have the minimal energies in comparison with that of the neighbouring states. So each gapless branch of the spectrum \gives rise" to a primary operator. The higher excitations are the states of the conform all tower with k > 0 or k > 0 in (1).

Certainly, we are able to calculate the energy E_L of the states j i when the physical states can be constructed explicitly. This is the case for the exactly solvable models [12], in particular, for the Bose-gas with -shape interaction. But it turns out that in general case all that inform ation in fact is not necessary and the energy E_L of a \prim ary" state j im ay be obtained using simple therm odynam ic reasoning.

Here we shalldem on strate this for the system (7)-(8). Let us begin with the excitations which conserve the number of particles. The simplest suitable excitation is the creation of a phonon. The minimal possible momentum is 2 = L (the dots A_0 ; A_0 in Fig.2). Evidently, the energy is equal to 2 = L, and the gap in the momentum spectrum is

absent: $P_1 = 0$. Then (1,2) imply h = s = 1. Let us denote ⁰ the corresponding primary operators. Then

A more interesting excitation has the momentum $P_1 = 2$ (A₁ in Fig.2). This excitation

is produced by the \rotation" of the whole system with minimal angular momentum (i.e. it can be described by the nst level of the \rotator"). In other words, this state can be produced from the ground state by transition to another inertial frame of reference. The periodic boundary conditions imply the quantization of the velocity of this new frame. More generally, one produces the family of the states $j_{0,m}$ i, m is an integer (A₂ and so on in Fig.2). The momenta of these states are equal to $2 \text{ m}: P_{0,m} = 2 \text{ m}$, and their energies can be obtained by considering the uniform motion of the whole system, the momentum of each particle being equal to 2 m = L:

C om paring (3) and (12) we nd the dimensions of the operators $_{0,m}$:

The above derivation m ay seem to be not quite correct since it neglects the quantum nature of the ground state. But m ore rigorous arguments lead to the same result. Indeed, let us turn to another inertial frame and use the rst quantized language for convenience. Then the full (N -particle) wave function is transformed as

This function should be single-valued, so the momentum q is quantized: q = 2 m = L, m 2 Z.Now acting to ~by the Schrödinger operator (8) one obtains (12).

The same result can be obtained also in the second quantization form alism. In this case one should work with the Ham iltonian (7) shifted by chem ical potential term

The states j^{0} i, $j_{0,m}$ i are excitations in the sector with the xed number of particles. Now let us consider the excitations which change the number of particles. Now one should work with the modi ed H am iltonian (15). In Bose case the adding of n particles results in the energy shift

Certainly, it is possible to combine the above excitations, i.e. to add n particles and then to \rotate" the system at the m th level. In this way we obtain the operators n_m with the dimensions

The dimensions $h_{0,1}$ and $h_{1,0}$ have been obtained rst in [3] (in this paper the case of V(x) = (x) was considered), where they were represented in terms of integrable systems theory. One can check that these dimensions coincide with ours, with the former being expressed through the sound velocity. It seems to us that the form of the answer given by (21)-(22) is more convenient, as it has sense for quite arbitrary potentials, and all the information about potential is contained in the unique parameter v (or R): In the next section we shall obtain a universal expression for R valid for lattice systems as well.

In exactly solvable models one can calculate the central charge using the form ula (2). Indeed, both the model with V (x) = (x) in (7)-(8) and XXZ-spin chain (10) provide c = 1 [3]. In the Sutherland-Calogero model (V (x) = x² [28]) the dependence f (T) at low temperature can be found using the results of [29], and (6) yields the answer c = 1 too (see the Appendix). A more general argument is the following. Since the scaling dimensions dependence a continuous parameter, the central charge should be not less than 1 [30]. Then one can always extract an \irreducible theory" having c = 1 from the initial theory [31]. On the other hand, the central charge greater than 1 in plies the number of degrees of freedom greater than 1. However, it is in possible for the system s under consideration since we have assumed the gapless spectrum with the only branch of phonon excitations. The result c = 1 seem s to be quite natural as just such a theory describes the phonon system in the long-wave lim it.

Note that the spectrum of scaling dimensions (21) also implies c = 1. Indeed, roughly speaking, alm ost all conform all theories with c = 1 are equivalent to the G aussian models with the spectrum of dimensions like (21) which can be parameterized by the unique continuous parameter (the whole classic cation of those theories would include the G aussian models with corresponding orbifold line and three isolated models in moduli space of the conform all theories [24]).

M ore precisely, the G aussian m odel is the 2d free m assless scalar eld theory with the action (here z = x + iy, z = x - iy):

which is evidently U (1)-invariant. The eld ' (z;z) takes values in the \circle" of radius R, i.e. one identi es ' and ' + 2 R. The spectrum of this theory is given by (21) [21,32], with the parameter R playing the role of the compactication radius in string theory. The operator $^{0}_{+}$ (0) can be identified with the (anti)chiral U (1)-current $@_{z}'$ ($@_{z}'$), and $_{n,m}$ can be identified with the exponential of the free eld:

This theory is invariant under the dual transform ation R ! 2=R, and R = p - 2 is the self-dual point corresponding to the isotropic (XXX) antiferrom agnet (= 0 in (10)).

3 Scaling dim ensions in lattice m odels

A swe saw in the previous section, the continuous models have an exact symmetry which allows one to obtain the answer immediately, namely, they are invariant with respect to Galilean transformations. In the case of lattice models (9)-(10) the exact Galilean invariance is broken. Nevertheless, we shall see that it is possible to apply the nite-size method in this case too [43]. In this section the most general relations between critical exponents and thermodinam ic parameters of the system will be obtained.

Consider the system of spinless particles on 1d lattice with the H am iltonian (9) m odi ed according to (15). Then $= 0_0=0$ is the density of particles at zero tem perature. W e imply periodic boundary conditions in (9). It will be convenient to imagine the lattice as being rolled up into a ring. Again, we shall assume that there is no gap in the energy spectrum of the system. In this case our arguments do not depend on the speci c form of V (x).

The operators 0 can be constructed in the same way as in the continuous case and their dimensions and correlators are given by the same form ulas (11).

Now we consider the analog of \rotating states" j_{0m} i. By de nition, j_{0m} i is the eigenstate of H with momentum 2 m and minimal energy. Let us represent it in the form (it is convenient to work in the second quantization form alism in this case)

where $p_m = 2 \text{ m L}^1$, j)i is the bare vacuum, N is the (conserved) number of particles. When $m = 0j_{0,0}i = jvaci \text{ and }_0$ is the ground state coordinate wave function. We have extracted the exponential factor in (27) in order to make m close to $_0$. This is really the case because p_m L¹ (note that in continuous systems $m = _0$ for all m):

Acting to $j_{0,m}$ i by the Ham iltonian H (9) one can see that m should be the ground state coordinate wave function (in the N-particle sector) of the following Ham iltonian \hat{H} (p) at $p = p_m$:

Evidently, H (p) is produced from H = H (0) by the following transformation y(x)! exp(ipx) y(x), (x)! exp(ipx) (x). Due to the gauge invariance it means that the uniform magnetic eld B = p is applied to the system. In other words, H (p) describes the system (9) in the uniform magnetic eld orthogonal to our ring lattice (Fig.3). Note that the magnetic ux through the ring is equal to 2 m (because p is quantized: $p = p_m$):

Passing from H to H (p) we can write for the ground state energy shift $_{m}$ (up to L ¹) the following general relation which is evident from the therm odynamic reasoning:

4 A sym ptotics of the correlation functions

In this section we shall obtain the correlation functions of the models (7)-(10) in the asymptotic series form. The most important correlators are density-density correlator H(x) = h(x)(0)i, (x) = (x)(x) being the density operator, and the one-particle density matrix S(x) = h(x)(0)i. In the spin chain the similar objects are $H(x) = h_{x-1}^{3}i$ and $S(x) = h_{x-1}^{+}i$, with $= {}^{1}i^{2}$:

The operators (x), (x) have no de nite conform al dimensions, since they do not behave properly under conform al transform ations. Nevertheless, they are local operators and, as such, can be represented as linear combinations of the primary and descendant operators. For simplicity, we write this sum at the moment rather symbolically without accounting of the \descendant contributions" (their role will be discussed below). As we shall see, to obtain the leading asymptotics it is su cient to take into account only the primary operator contributions. Then, the general expression for a local operator \hat{O} (x) has a form

where the sum runs over primary operators and C are some numerical coe cients. A possible gap in the momentum spectrum leads to appearance of the oscillating factors $\exp(iP_1 x)$ in this formula. To not the correlation functions of the type $h\hat{O}(x)\hat{O}(y)i$ it is su cient to calculate pair correlators of primary operators by using the well-known technique of conformal eld theory [10,33]. The most convenient way to do this is to represent primary elds in the exponential form (24) and to average their products by performing the conventional G aussian functional integrals with the action (23).

The coe cients C are non-zero if $hvacj\hat{O}(x)$ j i \in 0 in the therm odynam ic lim it (here hvacj is the physical vacuum ; for brevity som etim es we merely use the brackets to denote the physical vacuum expectation value). For example, the results of the previous section yield the following series (for Bose statistics):

In the last form ula $_{0;0}$ denotes the identity operator. U sing these series one can directly obtain asymptotical expansions of the correlation functions H (x) and S (x) as well as similar multi-point correlators. Note that the term sh $_{+}^{0}$ (x) $_{+}^{0}$ (0)i = h $_{-}^{0}$ (x) $_{-}^{0}$ (0)i x $_{+}^{2}$ appear in the $_{-}$ -correlator, with the corresponding exponent being equal to the canonical dimension of the operator (independently of the coupling constant). The asymptotical series for H (x) always contains such term but in the most interesting examples this term is non-leading.

Now let us discuss the descendant contributions. Generally speaking, the expression (42) should be supplemented by the descendant operators for each primary one satisfying the above selection rule. The conformal W and identities in ply that the descendant operator $\hat{O}(x)$ in a correlation function can be substituted by a number of dimension of the same correlator in which the primary eld (x) stays instead of its descendant $\hat{O}(x)$. Thus, the descendant contributions correspond to the term s with exponents exceeding the leading ones by a positive integer. For example, the inst descendant of $_{0,1}$ gives a contribution to H (x) of the form x $\frac{1}{2}R^2$ 1 sin (2 x). So, accounting for the descendants carefully, we are write down the whole asymptotical series (x 1):

The formulas (46),(47) are in a complete agreement with some exact results. These are the calculation of the density matrix in impenetrable boson system (V (x) = (x), g = 1 in (7)-(8)) [34,35] and the exact result for the correlator H (x) in the Sutherland model at the special value of the coupling constant g = 4 [28]. These correlators do

really have the form of (46),(47) (Appendix). One can also compare these formulas with the answers of the papers [26,36], where the asymptotics of H (x) and S (x) was obtained by a direct calculation in case of the strongly repulsive particles with long-range interaction. In those papers the perturbation theory with respect to the small parameter g⁻¹, where g is the coupling constant have been constructed. The result was that the parameter R should be determined by the same expression (22) provided that all orders of the perturbation theory are taken into account. However, R is small parameter when g is large, so only the \prim ary" contributions (i.e. the term s with k = 0 in (46),(47)) were essential in refs.[26,36]. The rest term s are negligible on the background of slow ly decreasing contributions $x^{\frac{1}{2}m^2R^2}$. Just the same reason does not allow one to obtain the term x^2 in (46) by the method of ref.[26]. M eanwhile, there are models (e.g. the antiferrom agnet with = 2 < <) where this term becomes the leading one.

The last check of (46),(47) is the calculation of non-equal-time correlators, both the charged and neutralones, by a new exact method proposed in refs.[37]. To compare these results with ours one has to take into account spins of the operators and to consider the combinations x vt instead of x. If we suppose the symmetry with respect to exchange x + vt() x vt, we reproduce the answers of papers [37,38].

Now we would like to discuss the meaning of the series (46),(47) with unknown coefcients. At the st glance quite arbitrary function can be represented in such a form. Nevertheless, the expressions (46),(47) contain an important information.

First, it turns out that in all cases when the correlators can be obtained using other methods (see above) the coe cients A; B quickly decrease when k ! 1, so the series are well convergent. From the other hand, the above mentioned approaches as well as exact methods usually reproduce just several leading terms of (46), (47). Thus these expressions seem to be adequate to the problem. Second, the subseries corresponding to the descendants (the sum s over k in (46), (47)) can be rolled up to sm ooth analytic function, but the sum over primary elds contains the fractional degrees of x :

W hen R^2 is irrational, the number of di erent types of ramication is in nite (x and x give the same ramication if and have the same fractional parts). It apparently in plies the essential singularity. On the contrary, if R^2 is rational the correlators (48), (49) contain the nite number of the ramication types. This case corresponds to the rational conform altheories [39], and demonstrate the niteness of the number of elds which are primary with respect to some large chiral algebra [40].

The question emerges whether the models described by the rational conform altheories in the long-wave limit have any peculiar properties. Our conjecture is that the ground state wave function in such models is analytic function of every variable on the nite covering of the complex plane (may be with puncture at 1). Using the results of refs. [28,29] one can easily check that this is the case for the Sutherland model².

Now we would like to discuss brie y some corrections to the expressions (46),(47) originated from the deviations of the critical point H am iltonian from the xed point one. That is they can di er by the irrelevant operators which have their conform ald in ensions h_{irrel} greater than 2 (and, therefore, do not e ect the critical behaviour). Then they induce contributions to (46),(47) decreasing with the distance faster than the leading term s being suppressed by x h_{irrel}^{+2} . Though the structure of series in this case is more complicated their global structure is the sam e in m ain features. In particular, the notion of rationality (the niteness of the ram i cation types) remains unchanged. Certainly, in special cases the corrections merely ought not to appears as it is the case for in penetrable Box-gas.

M ore interesting point is the possible logarithm ic corrections to leading asymptotics. The reason of this is the appearance of the additional marginal operators (i.e. operators with dimension (1,1)) which m ight be given rise in critical H am iltonian at some special values of coupling constants (and, therefore, R). As a rule, the logarithm ic corrections emerge when the symmetry of the system increases [32]. For example, in the SU (2)-symmetrical case of isotropic antiferrom agnet in zero magnetic eld the leading term of

the correlator h_{x-1} i given by (46) should be multiplied by $(\ln x)^{\frac{1}{2}}$ [41]³. In less sym metrical models the multiplicative corrections to leading terms are absent, but they can appear in sub-leading terms.

To conclude this section two remarks are in order.

One can easily obtain the multi-point correlators using the expressions (43)-(45), as primary elds can be realized as exponentials of free scalar eld and can be averaged directly with the Gaussian action (c = 1!). The nalexpression has a type

and should be compared with the one which can be obtained by the method of [36]. Then the primary eld contributions are the same in both cases (descendant terms, as above mentioned, can not be taken into account by this method).

The second remark concerns the coe cients in the sum s (43)-(47). Generally speaking, the arguments of trigonometric functions in (46), (47) should be added by some constant (or slow ly varying) phase (if $q_n \in c_m$, $q_n \in c_m$, $q_n^0 \in c_m^0$, $q_n^0 \in c_m^0$ and so on). Nevertheless sometimes this phase is absent. For example, this is the case for (46) since $q_n^0 = c_m^0$ due to the evident symmetry with respect to the exchange q_1 g in the wave function ~ of the other inertial frame. Here it would be appropriate to remark that the exponential operators $0_{m} + 0$; m from (16) form closed operator algebra which corresponds to global 0 (2)-invariance instead of U (1)-invariance as it is in (23).

Thus, we have demonstrated that the long wave correlation properties of bosonic spinless systems can be described by the Gaussian model with proper $\mod pactication$ radius" R. The parameter R is de ned by the general form ula (37) which gives (22) and (41) in the cases of continuous bose-gas and H eisenberg antiferrom agnet respectively.

5 Vacuum expectation values of non-local operators

In the main body of this section we shall consider the Heisenberg spin chain (10). Let us consider the following non-local operators in this model:

Our aim in this section will be to nd the asymptotics of the following correlators hvac $\beta(x;y)$ jvaci, hvac $\beta(x;y)$ jvaci, hvac $\beta(x;y)$ jvaci at jx yj 1. Such non-local correlators are quite interesting objects from the point of view of the quantum inverse scattering method [42]. Another application of our results is the calculation of correlation functions in the system of fermions with spin 1=2 [27] where one should know the asymptotics of the above non-local correlators. Due to translational invariance these correlators depend only on jx yj:

We shall show that these correlators have a power-law asymptotics. The corresponding exponents can be calculated using a natural generalization of the nite-size m ethod. The idea is the following. As it was shown in [21], the (extended) G aussian m odel has a non-local sector in which one should choose the numbers n;m in (21) to be half-integers. The corresponding operators, eg. $_{0;\frac{1}{2}}$, are so-called disorder operators. They can be expressed through the free eld ' (see (23)) only in a non-local way. Acting at the ground state of the extended G aussian m odel by such an operator, say $_{0;\frac{1}{2}}$, one obtains a state in the sector with antiperiodic boundary conditions (br:). Therefore, the correlators of even number of disorder operators have sense in the sector with periodic br. A couple of disorder operators at the points x;y in the spin chain looks like a non-local operator acting in the segment [x;y]. Certainly, that is what allow s one to not the asymptotics of the vacuum expectation values of non-local operators by CFT.

Let us consider an extended H ilbert space containing all states of the spin chain with di erent number of sites and di erent br. simultaneously. We introduce the following operators acting in the extended space: the operator $a^{Y}(x)$ (= 1=2) creating a new site of spin between the sites x and x + 1 of the initial chain; the operator b (x) annihilating the site x (of spin x) in the case of x = and giving zero if x = . Thus, $a^{Y}(x)$ acts from the sector of the extended H ilbert space corresponding to the chain with L sites to the sector corresponding to L + 1 sites. Quite similarly, b (x) changes the number of sites from L to L 1. The operator $b_{\frac{1}{2}}$ can be identied with non-local operator $\frac{1}{2}$,0 in extended G aussian m odel above. W e also introduce the operator

If L is even then only even number of such excitations can exist, and if L is odd then there necessarily exist odd number of such \half-m agnons". C learly. in the latter case the ground state is two-fold degenerate.

This can be done using the well-known exact solution (Bethe-ansatz) [12,14]. Certainly, one should modify the Ham iltonian as follows: \hat{H}_{XXZ} ! \hat{H}_{XXZ} __0L where __0 is the energy per one site. We om it these lengthy calculations here.

The results are as follows. The spectrum of scaling dimensions is given by the form ula (21) with half-integer n;m. The parameter R is determined according to (41). The correlation functions look like

The correlators (59)-(61) appear in the calculation of correlation functions in the multiparticle spin 1/2 systems as auxiliary objects. In particular, the result (61) was used in [46] for noting the long-wave asymptotics of the density matrix in the system of spin 1/2 Ferm i particles with strong interaction.

To conclude this section let us make a remark on the corresponding non-local operators in the Bose-gas model (7)-(8). An analog of S (x; y) is dened by the same form ula

6 Critical exponents in ferm ionic system s

So far, dealing with the model (7)-(8), we implied the case of Bose-statistics. It is known that the critical exponent of the ferm ionic eld correlator $S_F(x) = h_F(x)_F(0)$ i di ers from that of the bosonic one $S_B(x) = h_B(x)_B(0)$ i [26]. In this section we shall obtain the answer in the fram ework of the nite-size method.

There are two di erent approaches to this problem. The st one makes use of the fact that the operators (x) (65) produces the Jordan-W igner transform ation from bosonic

eld operators to the ferm ionic ones:

C learly, the neutral excitations with zero energy (\rotations" of the system; see Sect 2) should have momenta $P_0 + 2 \mod (m \ 2 \ Z)$ where P_0 is the ground state momentum. Thus, the dimensions of $_{0,m}$ are given by the same formula (13). It is easy to see that this is also the case when we add even number of particles to the ground state. To avoid m isunderstanding it should be stressed that the dimensions in bosonic and ferm ionic cases are generally not equal to each other, the point is that the sound velocity may be di erent in the two cases.

But the addition of an old number of particles n changes the parity of N , so, according to (71), we have for n = 1:

C on bining the di erent excitations in accordance with (71), we obtain the general form of scaling dimensions in the ferm ionic system s. The spectrum is given by the form ula (21) with the following conditions on n and m :

a) when
$$n \ 2 \ 2Z$$
, $m \ 2 \ Z$;
b) when $n \ 2 \ 2Z + 1$, $m \ 2 \ Z + 1 = 2$;
i.e: $m = m^{0} + \frac{1}{2}$, m^{0} is integer. (73)

7 Concluding rem arks

In this paper we have dem onstrated how one can nd the long-wave asymptotics of various correlation functions in one-dimensional eld-theoretical models using the nite-size technique in CFT. The obtained results are quite general. They are valid both for integrable and non-integrable models with interaction of a general form.

In conclusion, we would like to say a few words about the meaning of our results. We have shown that the long-wave correlation properties of the wide class of one-dimensional

spinless system s are described by the G aussian m odel, the sim plest conform al eld theory. The G aussian m odel still contains a free parameter | \com pactication radius" R.

An important point is that the value of R is determined by the nature of the short-range interaction (of the order of the mean distance between the particles x_c). So the short-range properties of the system are included into the elective long-range CFT through the only one parameter.

One of them aim results of this paper is the expression for R in concrete system s through their therm odynam ic quantities. C learly, it im m ediately gives us all the critical exponents as functions of therm odynam ic parameters of the system . At last, for a given system it is m uch easier to solve the therm odynam ics than to calculate correlation functions directly.

8 Appendix

Let us consider as an example the system of the type (8) with

(in the therm odynam ic lim it (A1) is equivalent to (A2)). The model (A1) is called the Calogero model, (A2) | the Sutherland model [28]. We call its therm odynam ic lim it the Sutherland-Calogero (SC) model.

In order to find the elective central charge we should investigate the behaviour of the free energy f(T) at low temperature T ! 0. The therm odynamics of SC model was studied in [29].

First, we have the general therm odynam ic relation

where P is the pressure. In [29] it was shown that the therm odynam ics of SC -m odel is described by the system of equations

For nding power-like corrections in 1 at ! 1 we can put $x_0 = 1$ and expand sqrt in a power series. Let

Expanding (A13) in a power series of x k we obtain exactly the series (46) which follows from the CFT.
