BICOVARIANT DIFFERENTIAL CALCULUS ON THE QUANTUM D = 2 POINCARE GROUP

A bstract

We present a bicovariant dierential calculus on the quantum Poincare group in two dimensions. Gravity theories on quantum groups are discussed.

DFTT-56/91 December 1991 Quantum groups, or q-deform ed function algebras of classical groups [1], have recently appeared to be the underlying algebraic structures of some two-dimensional and three-dimensional quantum eld theories. In this paper we will be concerned with the geometry of quantum groups, and more precisely with the dierential geometry of the D=2 q-Poincare group.

Our objective is to construct a q-deform ed gravity as a \gauge" theory of the D=4 q-Poincare group, which reduces for q=1 to ordinary gravity. The D=2 case serves both as a preliminary step and as a dierential geometric setting for D=2 q-gravity.

Why should we want to deform ordinary gravity (or supergravity, superstrings etc.)? Continuous deform ations of \classical" theories often have physical relevance: consider e.g. the deform ation parameters v=c, h or the De Sitter radius. Also, for distances of the order of the Planck length the smoothness of spacetime is really a mathematical assumption, leading to in nities in quantum gravity. A generalization of Riemannian geometry to \som ething else" is perhaps necessary, and the geometry of quantum groups seems to o er a way, leading to non-commutative spaces with group structure. For a review on non-commutative geometry (not necessarily linked to quantum groups) and its potential uses in physics, see e.g. ref. [2].

The geom etrical aspects of quantum groups have been very recently investigated by a number of researchers [3,4,5,6,7,8], from two main view points:

i) as the (noncomm utative) geometry of a representation space for the quantum group action [4,5,6];

ii) as the (noncom mutative) geom etry of the group space itself [3,7,8].

The construction of a bicovariant * di erential calculus on quantum groups has been in itiated by W oronow icz in [3], and applied to q-SU (2) [3a] and to the q-Lorentz group [8]. A general fram ework for the general cases of q-SO (N) and q-SU (N) has been proposed in [7].

Here we use most of the tools developed in ref.s [3], and present a bicovariant differential calculus for the two-dimensional q-Poincare group. An analogous result for the D = 4 q-Poincare group will be presented elsewhere [9].

Following the general form ulation of [3c], we consider the q-com mutator algebra:

where:

i) T_i are linear functionals on the algebra A of \functions on the quantum group", the q-analogue of the Lie algebra generators for ordinary groups; they belong to the algebra A^0 , the dual of A . A and A^0 are H opf algebras with dual H opf structures: the product in A^0 , appearing in (1), is de ned by

with = coproduct in A. The unit of A 0 is the counit of A and so on. To x our notations:

- -the coproduct, counit and coinverse of A are denoted respectively , " and . The unit of A is I.
- the coproduct, counit and coinverse of A 0 are denoted respectively 0 , *0 and 0 . The unit of A 0 is 1.
 - ii) $\hat{R^{k}}^{l}_{\ i\dot{\gamma}}$ is the braiding m atrix satisfying

A bicovariant di erential calculus on the quantum group associated to (1) exists when, besides (3) and (4), two additional conditions are satis ed (see later):

The four relations (2), (3), (4) and (5) are henceforth called the bicovariance conditions. Note that the classical lim it of \hat{R}^{ij}_{kl} is $i \atop kl$ so that relations (3), (5) and (6) become trivial in this lim it.

An example where (3) is satisfied, but (4), (5) and (6) are not, is given by the q-SU (2) algebra:

Indeed the di erential calculus corresponding to (7) is only left covariant (and is essentially equivalent to the left covariant di erential calculus on the q-SU (2) of ref. [3a]).

Let us recall the basic facts about bicovariant di erential calculus on quantum groups. It is de ned by [3c]:

- 1) a linearm ap d:A!, satisfying the Leibniz rule d(ab) = (da)b + a(db); 8a;b 2 A. is a bim odule over a, which essentially means that it can be multiplied from the left and from the right by elements of A, and is the q-analogue of the space of 1-form s on a Lie group. Every element of is assumed to be expressible as $= \frac{1}{k} a_k db_k$.

The left action $_{\rm L}$ reduces to L $_{\rm L}$ in the classical lim it. The map $_{\rm L}$ is assumed to satisfy properties that q-generalize the well-known properties of L (see [11] for a detailed discussion).

Left-invariant 1-form s! classically satisfy $L_x! = !$ or equivalently:

where I is the identity in A, i.e. the function on G that sends all elements of G into the identity of G. Indeed

We now sum marize some important consequences of 1), 2), 3) and 4), derived in βcl .

The quantum group element in the adjoint representation can be introduced as follows. It is easy to show that $_R$ (! i) belongs to $_{inv}$ A, and therefore:

in the classical case, M $_j^{\ i}$ is the adjoint representation of G . This justi es our calling M $_j^{\ i}$ the adjoint representation of the quantum group. The coproduct, counit and coinverse of M $_i^{\ i}$ can be deduced to be [3c]:

The last ingredient we need is the exterior product. It is de ned by an autom or phism \hat{R} in that generalizes the ordinary permutation operator:

which can easily be extended to n (d: n ! $^{(n+1)}$) and can be shown to commute with the left and right actions of G , as in the classical case [3c].

Finally, the hypotheses 1), 2), 3), 4) imply the existence of the T_i functionals satisfying eq. (1), and of the corresponding C artan-M aurer equations for the left-invariant form s! i [3c]. In eq. (1) the \hat{R} m atrix is the same that de nes the wedge product in (23). One can prove that the C and \hat{R} tensors do indeed satisfy the four conditions (3), (4), (5), (6). The action of T_i on M $_i^k$ is found to be:

See for ex. [11] for a detailed discussion on how to obtain (5) and (6), and eq. (25); all these relations are already in plicitly contained in [3c] (see also [12]).

U sing (22) and (25), we see that the conditions (3), (5) and (6) can be cast into operator form as:

whereas condition (4) follows from the de nition of the q-commutations (1) applied to M_i^j . In fact, the bicovariance conditions de ne a quasitriangular quantum Lie algebra, whose associated quantum group admits a bicovariant dierential calculus * (see e.g.[12]). By \associated quantum group we mean the Hopf algebra with Hopf structures dual to

those of the quantum Lie algebra. At this juncture we note that the coproduct, counit and coinverse of the q-algebra (1) can be consistently de ned as:

V iceversa, suppose that we nd some tensors \hat{R}^{ij}_{kl} and C^{i}_{jk} satisfying the bicovariance conditions (3), (4), (5), (6). Then we have a quasi triangular quantum Lie algebra, and we can construct a bicovariant calculus on the quantum group dual to the q-com mutator algebra (1). We illustrate the method in the example of D=2 q-Poincare. Consider the 3-parameter deformed algebra:

It is not di cult to check that the bicovariance conditions (3), (4) (5) and (6) are indeed ful led by the tensors given above. In (29) and (30) we have adjoined the equalities due to eqs. (22) and (25). The matrix M_i^j can be seen as the generic quantum group element in the adjoint representation (cfr. eq. (18)). Let us try to give this matrix an explicit form. To get a feeling of what it should look like, we consider it in the limit q=1. In the classical case the Lie algebra generators in the adjoint representation are

The generic group element of D=2 Poincare in the adjoint representation can then be parametrized with exponential coordinates:

as the reader can verify by using eqs. (33).

In the quantum case, the m atrix elements M $_{\rm i}$ do not com m ute any m ore, but satisfy the exchange relations:

From the rst line we see that M $_0{}^0$, M $_+{}^0$ and M 0 must be constants (i.e. proportional to the unit of A); m oreover from eq. (35) we nd that M $_+{}^0$ M 0 = q 1 M 0 M $_+{}^0$, which implies that the constant M $_+{}^0$, M 0 must vanish. The element M $_0{}^0$, which according to (35) commutes with all the other elements, can be chosen equal to the unit I. Finally, the elements M $_+$ and M $^+$ can also consistently be taken as vanishing, and we arrive at the quantum matrix:

whose elements satisfy the commutations:

Note 1: the commutation relation of the quantum plane coordinates x^+ and x^- is formally similar to the one of ref.s [4,5]. However here we are dealing with light-cone coordinates.

Note 2: it is not obvious how one can parametrize the diagonal elements u and v with the coordinate x^0 .

Note 3: as in the classical case, T_i can be represented as $\frac{\theta}{\theta \, \mathbf{x}^i} \, \mathbf{j}_{\mathbf{z}=\, 0}$, the partial derivatives being de ned by da = $(T_i \, ? \, a)!^i$ ($\frac{\theta}{\theta \, \mathbf{x}^i} \, a)!^i$; 8a 2 A.

Note 4: the product of two matrices M (x;u;v) and M (y;w;z) of type (34) yields a matrix M of the same type:

The inverse (in the matrix sense) of (34) gives the explicit form of the coinverse of M $_{i}^{j}$, since (M $_{i}^{j}$)M $_{j}^{k}$ = $_{i}^{k}$ (cfr. eq. (19)):

where we have introduced the new elements u^{-1} and v^{-1} satisfying $u^{-1}u = uu^{-1} = v^{-1}v = vv^{-1} = I$. In the Table we have collected all the information on the quantum group M generated by $I; x^+; x$; $u; v; u^{-1}; v^{-1}$. This group reduces to the matrix group (38) in the classical limit. The product of two quantum matrices in (41) again satisfies the exchange relations (35), if we recall that all the elements of M (x; u; v) commute with

all the elements of M (y;w;z). On the other hand, the inverse satis es the exchange relations (35) with $q! q^1$.

Note 5: the non-commutativity of the quantum plane arises as part of the geometry of the whole Poincare quantum group, rather than of a representation space for the action of the D=2 rotation group as in [4,5]. In fact, here the quantum plane has the coset interpretation q-Poincare / q-Lorentz, the q-Lorentz group in D=2 being the SO (1,1) generated by T_0 .

The functionals f^i_j are also easy to nd: they are determined by their value on the M $_k^{\ 1}$ (then their value on any power of M $_k^{\ 1}$ can be found via the rule (16a)). In the adjoint representation they take the form:

Thus the structure constants C appearing in the Cartan-M aurer equations (45) are in general di erent from the structure constants C of the q-commutator algebra (1). In fact, they coincide only in the case $\hat{R}^2 = 1$ ($\hat{R}^{ij}_{kl}\hat{R}^{kl}_{rs} = \frac{i}{r} \frac{j}{s}$). For our q-algebra (30) we have indeed $\hat{R}^2 = 1$, so that its Cartan-M aurer equations are as given in (44).

The commutation relations of the \coordinates" x^i with the left-invariant one-form s^i ! are deduced from eq. (15), and wedge products of! are de ned in (23). We list them in the Table that summarizes the bicovariant calculus on D=2 q-Poincare.

We point out that other deform ations of the D = 2 Poincare algebra have been found [13,14]. However, only the one given in (28) leads to a bicovariant dierential calculus.

We conclude by outlining a procedure to \gauge" the quantum (Poincare) groups that follows from the geometric approach advocated in [15] (see [15b] for a brief introduction).

The idea is to allow the right-hand side of eq. (45) to be nonvanishing, and then to interpret it as the curvature R k associated to ! k . This is called \softening" of the group G , and form ally the same thing can be carried out for quantum groups. The closure of the d operator, and the quantum Jacobi identities (4) lead to di erential conditions on the curvatures, the quantum B ianchi identities:

A quantum Lie derivative [3,12] can be introduced on the \soft quantum group", using its representation as the operator:

$$l_v = i_v d + di_v \tag{50}$$

that holds also in the quantum case, provided the contraction operator i_y is de ned appropriately [11] (y belongs to the dual of the soft A , and is the q-analogue of a tangent vector).

This allows the de nition of \quantum dieomorphisms":

where r is the quantum covariant derivative whose de nition can be read o the Bianchi identities (49) r $R^k = 0$.

The construction of an action invariant under the transform ations (51) proceeds as in the classical case. For example, the lagrangian for D=4 q-gravity is formally unchanged:

$$L_{q} = R^{ab} \wedge V^{c} \wedge V^{d}_{abcd}$$

 R^{ab} refers now to the q-Lorentz part of the q-Poincare curvature, V^{c} is the softening of the left-invariant one-form corresponding to the translations, the wedge product is de ned as in (23), and the " $_{abcd}$ tensor is the quantum generalization of the alternating tensor for the q-Lorentz group. This of course presupposes that one can nd a q-Poincare group containing q-Lorentz as a subgroup, which is indeed the case [16, 9].
