# C harged Vortex D ynam ics in G inzburg-Landau Theory of the FractionalQ uantum H alle ect

#### Abstract

W e write a G inzburg-Landau H am ittonian for a charged order param eter interacting with a background electrom agnetic eld in 2+ 1 dim ensions. U sing the $m$ ethod of Lund we derive a collective coordinate action for vortex defects in the order param eter and dem onstrate that the vortioes are charged. W e exam ine the classical dynam ics of the vortioes and then quantize their $m$ otion, dem onstrating that their peculiar classicalm otion is a result of the fact that the quantum $m$ otion takes place in the lowest Landau level. The classical and quantum motion in two dim ensional regions with boundaries is also investigated. T he quantum theory is not invariant under $m$ agnetic translations. M agnetic translations add total tim e derivative term s to the collective action, but no extra constants of the $m$ otion result.

## 1. Introduction

Them icroscopic physics of the fractionalquantum H allstate is by now reasonably well understood. ${ }^{[1]}$ W hen the density of electrons is one per an area through which an odd num ber, $2 n+1$, of ux quanta pass, there can be quasiparticle excitations in the $m$ any-body state which cost little energy to produce and which have a fractional e ective charge $e(2 n+1) .{ }^{[2]}$ These excitations are described as vortices in the Laughlin wave function. The fractionally charged quasiparticles them selves form an extended state and can transport charge across a sam ple. Finally, a $m$ any-quasiparticle state $m$ ay itself have vortex excitations, and so on, from which the whole hierarchy ${ }^{[3]}$ of fractional conductivity states $m$ ay be form ed.

W hile the m icroscopic picture is com pelling, there is not yet a com plete m acrosoopic phenom enological description, such as a G inzburg-Landau theory, ${ }^{[4]}$ for the fractional quantum H all system. At present one m ust put in by hand such features as the fractional lling. Ginzburg-Landau theories are useful for describing $m$ anybody system s such as liquid H elium and superconductivity, and one $m$ ight hope that they would nd application to the fractional quantum H alle ect as well. It is wellknown that $G$ inzburg-Landau theories can describe vortex excitations, both in liquid Helium, where they are true m acroscopic uid vortioss, ${ }^{[5]}$ and in type II superconductors, where they are $m$ acroscopic lines ofm agnetic ux. In both of these cases, the vortex excitations, which are uncharged, $m$ ay be observed directly. V ortex solutions, known as cosm ic strings or $N$ ielsen -0 lesen ${ }^{[1]}$ strings, are also postulated to exist in fundam ental eld theories of particle physics. There the theory is derived not from som e phenom enological Landau free energy, but from the fundam ental Lagrangian of the $H$ iggs elds necessary for sym $m$ etry breaking and ferm ion $m$ ass generation. A $1-$ though $G$ inzburg-Landau vortices and $N$ ielsen-O lesen vortices are quite sim ilar, there are signi cant di erences in their dynam ics. ${ }^{[8]} \mathrm{W}$ e wish to extend the vortex description to fractionalquantum H all system s . W e note that this idea has been advocated $m$ any places in the literature. ${ }^{[9]}$

In Sec. 2 we write the $m$ ost general scalar gauge-invariant Landau free energy
function which is second order in spatial derivatives. $W$ e $x$ the param eters in order to nd a solution which is a reasonable approxim ation of a uniform charge density. In this charged uniform uid we postulate vortex-like defect solutions. In Sec. 3, we use the $m$ ethod of Lund ${ }^{[10]}$ to nd the collective coordinate action for the $m$ otion of the vortioes and dem onstrate that they are charged and act as though they carry a single unit ofm agnetic ux.

The equations of $m$ otion for the system appear to be classical, but are best interpreted quantum mechanically. In Sec. 4 we apply the $m$ ethod of $D$ irac to the quantization of the collective coordinate action. The vortices $m$ ay be quantized as having any statistics we like, by postulating the behavior of the $m$ any-body wave function under an exchange oftw o vortioes. These arbitrary statistics $m$ ight be introduced through the use of non-dynam icalChem-Sim ons elds if the order param eter eld is to be single-valued. W e also consider in Sec. 4 them otion ofvortioes in sam ples $w$ ith sim ple boundaries, and nd that questions of gauge are resolved by the boundary conditions. In Sec. 5 we show that $m$ agnetic translations are not a sym $m$ etry of the quantum theory because they add total tim e derivative term s , som etim es called theta term s , to the e ective action.

## 2. The E ective $H$ am ilton ian

In the theory of superconductivity, a Landau free energy is postulated for an order param eter which has the kinetic term of a charged boson. The vector potential is not the extemal vector potential alone, but includes a dynam ically determ ined piece. In order to $m$ inim ize the free energy, the vector potential $w$ ithin $m$ ost of the superconducting $m$ aterial $m$ ust be curl-free, thus the $m$ agnetic eld is concentrated in vortex lines where the $m$ aterial is not superconducting. To observe the fractional quantum $H$ all e ect, the $m$ agnetic elds $m$ ust be extrem ely large. Because of the strength of the $m$ agnetic eld, we do not expect the $m$ icroscopic eld to be bundled into vortioes and vanish throughout $m$ ost of the sam ple. It seem s quite reasonable, therefore, to neglect the self-generated vector potential in the Landau free energy.

W ebegin by w riting them ost generalgauge invariant scalar free energy (or H am i-tonian) function of a complex order param eter , sub ject to an extemal m agnetic eld. In a superconductor, the order param eter is essentially the wave function of a C ooper pair. The interpretation of the order param eter for the fractional quantum H all system from $m$ icroscopic variables is not known, but $m$ ight be, for instance, a collective eld for the charge density. An exam ple of collective eld theory, for ferm ions in $1+1$ dim ensions, is constructed in ref. [11].

The $m$ ost general free energy function involving at $m$ ost two derivatives is

Here $D_{a}=@_{a} \quad$ ieA ${ }_{a}^{\text {ext }}$ is the gauge covariant derivative, and $k$ is a constant.
Term s of higher order in derivatives are irrelevant for critical phenom ena, and can be neglected. The last term above is actually a surface term which m easures the total change in the phase of around the boundary of the sam ple. The total change in phase is a gauge invariant quantity which will count the total vorticity' of the con guration. W e w rite the $m$ ost general free energy (2.1) for com pleteness and later on we will specialize the free energy by choosing the simplest functions $f_{i}($ ) guaranteeing vortex excitations.

W e have avoided introducing Chem-Sim ons gauge elds ab initio, preferring instead that they come out as derived quantities. Even though Chem-Sin ons gauge elds have not been explicitly introduced, we nd in Sec. 4 that charged vortioes do act as though they carry a ux in addition to their charge, which is suggestive of C hem-Sim ons type interactions and fractionalstatistics. H ow ever, we nd in Sec. 4.3 that canonical quantization allow s any type of statistics.

The non-linear Schrodinger equation, $i-(x)=H_{G L}=(x)$ with $H$ am iltonian function (2.1), implies the follow ing equations of $m$ otion for the phase, , and the
square $m$ odulus, , of the order param eter $={ }^{\mathrm{P}}-\mathrm{e}^{\mathrm{i}}$.

W e look for solutions with constant $=0$ and constant $\neg$ because they w ill be a good analogy to a uid in which vortioes can form. It is easy to see that in general there can be no such solution if A has a non-zero curl, unless the functions $f_{i}($ ) are chosen carefully. For now we assum $e$ that there is som e non-negative function $f_{1}()$ such that at them inima, $=0$, ofV ( ), the follow ing conditions are satis ed:

where is som e positive constant. The last condition is necessary in order that vortioes, which have ( $r)^{2}$ singular at their cores, can avoid $m$ aking an in nite contribution to the free energy (2.1) by having vanish there. The function $f_{1}\left(j \jmath_{j}\right)=j$ j, is an exam ple $m$ eeting all conditions but the last. For now it is a reasonable assum ption because we are going to ignore the problem of the singularity at the core when deriving the collective dynam ics of the vortioes. It is sim plest to take the functions $f_{2}$, $f_{3}$ and $f_{4}$ to be zero. A s an aside we note that an interesting ansatz for the function $f_{1}()$ is

which has the properties (2.3) above when $0=\frac{C}{2 n+1}$.

In a C oulom b gauge, r $A=0$, the equations ofm otion (2.2) reduce to the Laplace equation $r^{2}=0$ for the phase function (x). Thus any single vortex solutions, $=A^{(x)}$, m ay be supenposed to form a multi-vortex solution $=P_{A}^{A}(x)$.

## 3. C ollective C oord in ate A ction

In a beautiful paper, ${ }^{[10]}$ Lund has given a construction of the equations of defect dynam ics ${ }^{[12]}$ from a variational principle. $H$ is $m$ ethod is to substitute the collective coordinate vortex ansatz into the action and to vary that action $w$ ith respect to the collective coordinates. W e now show that Lund's m ethod also works to nd the dynam ics of charged vortices. W e follow closely the argum ent, and use the notation, in ref. [10]. W ith the assum ptions of constant density, $j \jmath=0$, all the $f_{i}()$ being zero except $f_{1}()$, which m ust satisfy (2.3), the Schrodinger action

where the function $A\left(x ; X^{A}(t)\right)$ is the polar angle of the di erence vector $x X^{A}$ ( $t$ ) from the center of the $A^{\text {th }}$ vortex to the eld point $x$,

and the integer $n_{A}$ is the $w$ inding num ber or Vorticity' of the $A{ }^{\text {th }}$ vortex. B ecause is a m ultivalued function, it is usefiul to take the dom ain of integration to have cuts in it
in order that allquantities in the integrand be single-valued. W e also take the region of integration to exclude the cores of the vortiges. $F$ igure 1 show $s$ the integration region and boundary cuts for a two vortex con guration. A fter substitution of the ansatz (3.3) into (3.2), the rst term reduces to a sum of integrals over the cuts $S_{A}=f x(t)=Y^{A}(s ; t) j 0<s<1$ gfrom the $A^{\text {th }}$ vortex to in nity, each of the form :

T he last equality is obtained by tw o partial integrations. For now we ignore the total derivative term, which is irrelevant for classicalm echanics, but we m ust retum to the question of adding total tim e derivatives when quantizing the system. The second term in (3 2) leads to a double sum over A and B of term s of the form

where we have specialized to the case of a uniform $m$ agnetic eld in the sym $m$ etric gauge $A=\frac{1}{2} B \quad r$. The integrals over the boundaries at in nity vanish because the integrands fallo quickly enough. The integrals over the sm all circular boundaries $S_{T}$ have been neglected as being $s m a l l$. The diagonal selfenergy term $s$ in the sum $s$ (3.6) do not depend on the collective coordinates and have been dropped. Up to total tim e derivative term $s$, the full collective vortex action is

4. Vortex D ynam ics

### 4.1. C lassical M otion

T he classical equations ofm otion follow ing from (3.8),

have the interesting property that they are rst order in time and not translation invariant. There is one obvious constant of the $m$ otion for the equations of $m$ otion (4.1), which is essentially the angular m om entum,

The m otion of a single vortex in the absence of other vortioes is a circular orbit centered on the origin, w ith angular velocity proportional to the extemalm agnetic eld. If a background of vortiaes of uniform density is added, a vortex will move
with an angular velocity which is the sum of two pieces. O ne piece is proportional to the extemal eld and is identical to the angular velocity of a vortex in the absence of other vortioes and the other is proportional to the total vortex num ber enclosed by the orbit. This can be seen from the equations ofm otion (4.1), by averaging the contributions ofeach vortex inside the orbit. Since the 'eld' is inversely proportional to the separation, in two dim ensions we can sm ear the vorticity uniform ly over the enclosed area and ignore the contributions from outside the onbit, just as one can for elds inversely proportional to the square of the separation in three dim ensions.

Thus the in uence of other vortioes is just the sam e as a background $m$ agnetic eld. Two vortices of the sam e vorticity, $\mathrm{n}_{\mathrm{A}}$, in the absence of an extemal eld or other vortices, will onbit each other with an angular velocity which is inversely proportional to the square of their separation. The vortioes behave as if they carry $n_{A}=e$ units of $u x$ at their cores and a charge-to-m ass ratio $e=m=e=0$. The relative angular $m$ om entum of two vortices can be calculated using the equation of $m$ otion (4.1) and the de nition of the $m$ om entum as the derivative of the Lagrangian (3.8) $w$ ith respect to velocity, $P_{a}^{A}=@ L=@ X_{a}^{A}$. In the case of only tw o vortices $w$ ith the sam e vortex num bers, $n_{A}=n_{B}=n$, there is a very sim ple relation:

where $=X^{A} \quad X^{B}$ is the relative separation of the tw $O$ vortioes $A$ and $B . T$ he term $A_{b}$ in (4.6) is an e ective vector potential, which is that of a point ux of $2 n=e$ units. This also strongly suggests that the vortioes carry attached point uxes in addition to their charge. The factor of two arises because there are two vortices and we m ust add the contribution of each. In fact, using the equations of $m$ otion (4.1), and the
de nition ofm om entum, we nd the suggestive relation

A rovas has argued ${ }^{[13]}$ that the extra factor of two in the statistical gauge eld $A_{a}$ is necessary because each particle carries a ux as well as a charge.

T he equations ofm otion (4.1) are classicalequations giving de nite tim e evolution to the centers of the vortices. C lassically, of course, the m otion of a charge in the background of an in nitesim ally thin ux tube is the sam e as the motion in a eldfree region. T he fact that the classical' m otion of a vortex is in uenced by the other vortices and the existence of the point ux in the relation (4.7) are the rst hints that the $m$ otion described by the action (3.8) is quantal and not classical.

### 4.2. Quantum M otion in Symmetric G auge

W e have said that the true $m$ eaning of the dynam ics of (3.8) is quantal. In order to describe the quantum $m$ echanics of (3.8), one m ust take into account its unusual canonical structure. Unlike the standard Lagrangian for a m assive point particle, the vortex Lagrangian is rst order in tim $e$, which $m$ eans that there are constraints on its phase space. These constraints are second-class according to the classi cation of D irac. ${ }^{[14]}$ They are

T he H am iltonian, which m ust conserve the constraints, is only de ned by its num erical value on the phase space hypersurface de ned by the constraints. This leaves its
algebraic expression in term sof the originalunconstrained phase space variables quite am biguous. U sually it is said that the $H$ am iltonian is de ned only up to the addition
 the $m$ ost general $H$ am ittonian for now, the conservation of the constraints xes the Lagrange $m$ ultipliers, resulting in the $H$ am iltonian

W e have dropped an irrelevant constant term in the Ham iltonian (4.10), which we could have included.

The constraints (4.8) need to be taken into account in the quantum mechanics in order to construct physical states for the system. O ne possible solution is to solve them by choosing, say, the $Y$ variables to be the $m$ om enta con jugate to the $X$ coordinates. Then the states would be functions of $X$ only. W e choose not to do this, but to im plem ent the constraints as operator conditions instead. It is convenient to go to com plex coordinates in the case of the sym m etric gauge. W e w rite

Being purely analytic functions tim es an exponential of $\dot{\vec{z}} \mathfrak{\jmath}$, these states are of the form of the low est Landau level. Because they are also eigenstates of an annihilation operator, these states are of the form of a coherent excitation in the $\mathrm{N}^{\text {th }}$ Landau level as well. O ne needs more evidence to decide which is the proper interpretation. O thers have found that $m$ otion restricted to the low est Landau level can be related to one-dim ensional ferm ions through an action that is rst order in tim e, ${ }^{[15]}$ and we w ill also com e to the conclusion that the low est Landau level interpretation is m ost natural after considering the $m$ otion of vortioes in a half plane.

W e note here that positive and negative w inding num ber vortioes behave as if they have opposite charge in this quantization, in that their wave functions are com plex conjugates of each other. This is in contrast to the classical motion, where one cannot tell the di erence between positive and negative winding num ber vortioes by their direction of $m$ otion because all vortioes onbit the center in the sam e sense.

### 4.3. The M otion of Two Vortices

Thus, from the point of view of this quantization, any statistics are allowed. This result is less restrictive than those obtained in Ref. [16].

### 4.4. Boundary Conditions and G auge Invariance

W e have not yet touched upon boundary conditions for the G inzburg-Landau equations (22). Because the order param eter is essentially a macroscopic wave function, the boundary conditions should ensure that no current ows across free boundaries of a sam ple. This is guaranteed by the usualG inzburg-Landau boundary conditions,

In the derivation of the action (3.8), the sym $m$ etric gauge was chosen. T his choice is forced if one im agines the in nite sam ple to be the lim it of a circular sam ple when the radius increases w ithout bound. T he vector potential m ust be in the sym $m$ etric gauge and vanish at the center of the circle.

A s a sim ple exam ple, we exam ine the $m$ otion of vortioes in a constant $m$ agnetic eld and in a nite circular sam ple. $W$ e then specialize to the case of a single vortex. The derivation of the action starts from the multi-vortex ansatz

### 4.5. Quantum Motion in a Half P lane

In choosing the boundary conditions form otion in a halfplane, wem ust be careful to note that there is not a unique vector potentialA ${ }^{\text {ext }}$ satisfying the conditions (426). $W$ e take our geom etry to be the upper half plane $y>0$. It is $m$ ost natural to take the Landau gauge condition $A_{x}=B y, A_{y}=0$. The non-uniqueness of the vector potentials com es in through the addition of a constant vector eld $A_{x}=C, A_{Y}=0$. If the lim it is taken by starting with a rectangle and letting three of its sides go to in nity, then the constant vector potential is in nite, unfortunately. It is still useful to look at the exam ple to determ ine the behavior of vortioes near a long straight boundary far from other boundaries.

Each vortex in this geom etry has a single re ected im age, $R(X ; Y)=(X ; Y)$. C onstructing the vortex action as in the circular case, we nd

The shifted states do not stay in a single Landau level but are m ixtures of all Landau levels. The only e ect of magnetic translations is to shift the theta term s ,
which leaves the classical equations una ected, but the quantum states are radically changed. Even when no eld is present and $m$ agnetic translations becom e ordinary translations, there is no sym $m$ etry of the theory, so it is not surprising that a m agnetic translation of (3.8) should m ix Landau levels.

## 6. D iscussion and C onclusions

W e have dem onstrated, under the assum ptions of an appropriate Landau free energy, that vortex defects in the order param eter are charged and that these vortioes obey an equation of $m$ otion which is rst order in tim e. A fter quantization these vortioes are seen to behave correctly quantum mechanically, and, in fact, can be taken to occupy the lowest Landau level of the $m$ inim ally coupled single-vortex quadratic H am iltonian

W$ e have not postulated a form for the potentialV ( $j$ f ) in our Landau free energy (2.1), but have assum ed that it can be chosen so that the $m$ inim um will set the param eter to $0=\frac{e B}{2(2 \mathrm{n}+1)}$. The constant can be chosen to $x$ the ective $m$ ass $m$.

A ll the vortioes behave classically, according to (4.1), as if they have the opposite sign charge to the background quantum uid. That is, they all travel in the sam e direction regardless of their vorticities $n_{A}$. The collective $H$ am iltonian function for the vortioes (4.3), has a direct connection to the Laughlin $m$ any-body wave function. The relation between (4.3) and the Laughlin wave function is

W hen all the vortex num bers are taken to be positive, $\mathrm{n}_{\mathrm{A}}>0$, some $\mathrm{n}_{\mathrm{A}}=\mathrm{m}$ and some $n_{B}=1$, and the $m$ agnetic eld is in the $\hat{z}$ direction, (62) is the m odulus of the Laughlin wave function of electrons and quasinoles of charge $1=m$.

N um erical work, solving the rst order equations ofm otion, (4.1), for a random initial con guration of particles, all with the sam e vortex num bers, show $s$ that the system evolves so that the vortioes form a lattice of nearly uniform density whidh rotates rigidly in the e ective $m$ agnetic eld which is the badkground eld plus that produced by the vortioes them selves. ${ }^{[17]}$ Thus it seem s reasonable to w rite an e ective $G$ inzburg-Landau theory for the uid ofvortioes, in which further vortices $m$ ay form . This lends support to the correctness of the phenom enological theory. In this way one $m$ ay hope to reproduce the whole hierarchy of fractional quantum $H$ all states through the use of a G inzburg-Landau theory.

The present work assum es the existence ofm ulti-vortex solutions which have core sizes m uch sm aller than their separations. W e have assum ed that such solutions exist for the appropriate choice of functions $f_{i}(j)$, as they are known to exist in the A belian H iggs m odel ${ }^{[18]}$

W e have not xed all the param eters in the theory to relate the average density of vortices to the $m$ agnetic ux through the sam ple. It seem splausible that this could be done. Instead of choosing nite energy as our criterion, we have chosen that the equations of $m$ otion for the non-linear Schrodinger equation have constant density solutions. Because of the unscreened extemal vector potential, it is im possible to keep just the rst term in (2.1) and dem and nite energy in an in nite sample. It is our hope that inchuding $m$ ore of the term $s$ in the free energy (2.1) will yield a detailed $m$ acrosoopic description of the fractional quantum $H$ all e ect, determ ining, for instance, the vortex density from the applied $m$ agnetic eld, w ithout harm ing the basic picture of vortex dynam ics we have sketched.

From the point of view of rst order vortex dynam ics, it is unclear how the statistics of the quantum vortioes are determ ined. From the discussion leading up to eq. (421), it seem s as though the quantum statistics can be chosen independently of the e ective charge, but there are tantalizing hints, from eq. (4.6) or from (4.7), that the C hem-Sim ons induced statistics directly related to the e ective charge are already im plied.

## APPEND IX A

D irac Quantization of Second-C lass Systems
W hen an action has second-class constraints, ' 0 , there are several options for constructing a quantum system from the classical system. If the constraints are sim ple enough, one can just solve them and w rite the dynam ics in term s of a reduced set of variables. If one chooses not to do this, there are still several possibilities. The electron states in a two dim ensionalconductorw ith a penpendicularm agnetic eld are highly degenerate. These degenerate states, the Landau levels, can easily be found in the Landau gauge
