A bstract

The level spacing distributions in the G aussian Unitary Ensemble, both in the \bulk of the spectrum," given by the Fredholm determ inant of the operator with the sine kernel $\frac{\sin(x - y)}{(x - y)}$ and on the \edge of the spectrum," given by the A iry kernel $\frac{Ai(x)Ai^{0}(y) - Ai(y)Ai^{0}(x)}{(x - y)}$, are determ ined by compatible systems of nonautonom ous H am iltonian equations. These m ay be viewed as special cases of isom onodrom ic deform ation equations for rst order 2 2 m atrix di erential operators with regular singularities at nite points and irregular ones of R iem ann index 1 or 2 at 1. Their H am iltonian structure is explained within the classical R {m atrix fram ework as the equations induced by spectral invariants on the loop algebra $\mathfrak{Sl}(2)$, restricted to a Poisson subspace of its dual space $\mathfrak{Sl}_{R}(2)$, consisting of elem ents that are rational in the loop param eter.

0. Introduction

It has long been known for a class of exactly solvable models in statistical mechanics that the correlation functions are expressible in term s of Painleve transcendents orm ore generally solutions to completely integrable di erential equations possessing the Painleve property [M M T B], [M T W], [SM J]. (For a review see [M c].) It was the great insight of the K yoto School to invent the notion of a {function associated to a system of completely integrable di erential equations [SM J], [JM M S], [JM U], [JM] and to realize that in this class of solvable models the correlation functions are {functions.

In the theory of random matrices it has also long been known (see, e.g., [Po], [Me1]) that the level spacing distributions are expressible in terms of the Fredholm determ inant of an integral operator. In a particular scaling lim it the kernel of this integral operator is the sine kernel. For this case it was shown in [JM M S] that the Fredholm determ inant was also a

{function. This then leads in the simplest case to form ulas for the level spacing distributions in terms of a particular Painleve V transcendent. More generally, the deformation equations consist of a compatible set of nonautonom ous Ham iltonian equations.

Since the original work of [JM M S] on random matrices and impenetrable bosons, the methods for deducing the relevant deformation equations and properties of the {functions have been simplied and generalized, both in the study of random matrices [BTW], [M e2], [D y], [M M], [T W 1], [T W 2], [W] and quantum correlation functions [IIK S], [IIK V]. The H am iltonian structure of the underlying deformation equations can most simply be understood as a nonautonom ous version of the equations induced by spectral invariants on a loop algebra with respect to a suitably chosen classical R {matrix Poisson bracket structure [H].

In the following section, the problem of computing level spacing distributions for the Gaussian Unitary Ensemble (GUE), both in the \bulk of the spectrum " and at the \edge of the spectrum " is formulated in these terms | the two cases di ering only in the kernels resulting from the di erent scaling limits. For the rst case, this is the above mentioned sine kernel

1. Spectral D istributions for R andom M atrices

The dynam ical equations of Jim bo, M iwa, M ôri and Sato [JM M S], which determ ine the dependence of this quantity on the parameters $(a_1; :::; a_{2m})$, are given below, following the approach developed in [T W 1]. We note that in [JM M S], [T W 1], and [T W 2] the case of equal $_j$'s only was considered in the derivation of the equations.

This overdeterm ined system, which we refer to as the JMMS equations, is in fact Frobenius integrable, and has a Ham iltonian structure which we summarize in the next subsection.

The signi cance of this H am iltonian structure in terms of spectral invariants on loop algebras will be explained in x2. First, another similar system occurring in the computation of level spacing distribution functions of scaled random matrices at the ledge of the spectrum " will be described. For the details of what follows see [T W 2]. (Here also only the case of equal $_{j}$'s was considered, the generalization to the case of unequal $_{j}$'s being straightforward.)

It is straightforward to verify that these G_j 's are also in involution, implying the Frobenius integrability of the system (1.40) and the existence of a -function as in eq. (1.31). For the system (1.26) { (1.29) associated to the sine kernel, the leading term in (2.18) vanishes, so the polynom ial P () is of degree 2m and the curve has genus g = 2m 1, with no branch points at 1. For the autonom ous system (2.23), these curves are invariant under the ows. For the nonautonom ous system (2.24), which in these cases reduces to (1.29) or (1.45), it would be of interest to determ ine the dependence of the spectral curves on the deform ation param eters $fa_ig_{i=0;:::2m}$ through a system of PDE's involving the spectral invariants $fG_ig_{i=0;:::2m}$ alone. For the single nite interval case, this is given in [JM M S], [T W 1] by the -function form of the Painleve equation P_V , while for the single sem i-in nite interval case, this is given in [T W 2] by the corresponding {function form of P_{II} .
