## Correlators in non-critical superstrings including the spinor em ission vertex.

We discuss the structure of correlators involving the spinor emission vertex in non critical N = 1 superstring theory. The technique used in the computation is the zero mode integration to arrive at the integral representation, and later an analysis of the pole structure of the integrals which are thus obtained. Our analysis has been done primarily for the 5-point functions. The result con m s previous expectations and prepares ground for a comparison with computations using matrix models techniques.

The recent discovery of the double scaling  $\lim it^1$  in matrix models has led to precise computations of higher genus correlation functions in non critical strings propagating in 2-dimensional target spaces. From the point of view of the theory in the continuum Ы space, however, such calculations have been carried out only for the sphere (genus zero). The computations have been performed either by integrating the Liouville zero mode<sup>2;3</sup> with the subsequent evaluation of the corresponding integrals, or m ore recently by use of the ground ring structure<sup>4</sup>, or also by quantum group technique<sup>5</sup>. The agreem ent of all such approaches (see [2,6] for com parison) encourage us to generalize such correlators on the sphere to the case of the superstring. By use of the zero mode technique this has been done in [7, 8, 9] by som e groups, at least in the N eveu-Schwarz sector in the N = 1 case. The N = 2 non-critical theory is discussed in [10]. A lm ost simultaneously, a supersymmetric version of the one matrix model has appeared in the literature<sup>11</sup>, which describes super (p;q) minimal models with p = 4, q = 4m, m = 1;2;coupled to two dimensional supergravity. An identic ation of scaling operators and comparison analogous to [12] can be successfully carried<sup>13</sup>, but for a more precise comparison in the Ram ond sector we have to calculate further correlators involving the spinor em ission vertex, thus generalizing the calculations of  $[\beta]$ . The aim of this letter is to calculate some of such correlators m issing in the literature.

The supergravity part of the superstring is described by an N = 1 super Liouville theory, de ned by the action (see e.g. [14])

where  $\hat{E}$  is the superdeterm inant of the superzweibein  $E_{ab}$ , and  $\hat{Y}$  is the supercurvature, and  $_{SL}$  is the super Liouville super eld, which de nes the super world sheet dynamics. The matter sector is given by an N = 1 super eld  $_{M}$ , with the action

The matter sector has central charge  $Q_M = 1 + 8 \frac{2}{0}$ , and Q, are dened by

The particle content of the 2D -superstring consists of a scalar (NS-sector) and a spinor (R-sector) particle in the space time. Both are massless. The Neveu-Schwarz vertex (or scalar emission vertex) is simply the supersymmetric extension of a planar wave (the  $\tau$ ), being de ned by

where , are partners of , X , form ing the ferm ionic and bosonic components of  $_{\rm S\,L}$  ,  $_{\rm M}$  . The dressing (k) is given by

It will be necessary for our purposes to have also another form of (4) which corresponds to the gauge xed ( = 0) version of the NS-vertex,  $T_k^{(1)}$ , given by

where is related to the original supersymmetry ghosts via bosonization (see [15] for details), and the (holom orphic part of the) propagator is given by

Note that the denition of in (5) is still the same since e has the same conformal weight of  $d^2$  (in order to check, one can use  $(e^a) = a(a + 2)=2$ ).

In the next step we turn to the spinor emission vertex, which is more complicated. For future convenience, we rst bosonize the two ferm ionic (Majorana) components and

into a free m assless boson h, following the usual rules for the D irac fermions (we om it cocycles)

analogous results hold for the anti-holom orphic part. Follow ing [15] we notice that states in the the Neveu-Schwarz (resp. Ram ond) sector have periodic (antiperiodic) boundary conditions, and the spinor emission vertex which will correspond later to the emission of a ferm ionic particle in the two dimensional embedding space, must interchange such boundary conditions. Therefore, the spinor emission vertex must include a eld S (= 1) {called spin eld{ which introduces a cut at the point of the emission, such that after a rotation of 2 one gets a minus sign, in other words,

where are the two dimensional gamma matrices and  $^{0} =$ ,  $^{1} =$ . The solution to the above OPE constraint is given by

Due to supersymmetry, we need also a spinor  $% \mathcal{A}$  eld corresponding to the ghost  $% \mathcal{A}$  ,

It is not di cult to check that S , as well as V  $\frac{1}{2}$  (k; ) behave like a W eyl spinor under SO (1;1) generators : . Im posing BRST invariance of V  $\frac{1}{2}$  (k; ) we have two di erent dispersion relations for the di erent spin components = 1, as expected for a W eyl spinor in two dimensions<sup>1</sup>:

W e are now in position to compute m ixed correlation functions:

A fter integrating over the matter (X  $_0$ ) and Liouville ( $_0$ ) bosonic zero modes we have<sup>2;3</sup>

As in the previous calculations<sup>8;9</sup>, the strategy is to assume that s is a positive integer and to analytically continue the result for arbitrary reals. For integer s, it is enough to use free propagators to write (12) in an integral representation. In the case of no spinor emission vertex (n = 0) these amplitudes have been calculated in ref. [9] for arbitrary value of N by successive derivatives of the N = 3 point function with respect to the cosm ological constant , the N = 3 point integral was calculated on its turn in ref.[7,8]. In the case where we include the spinor emission vertex V  $_{1=2}$  we have not been able to accomplish the integrals corresponding to the three point function<sup>2)</sup> hV  $_{1=2}^{1}$ V  $_{1=2}^{2}$ T<sub>k</sub>  $_{1}^{1}$  i for non-vanishing integer s and therefore we cannot use the same strategy as above to obtain higher point

am plitudes from the 3-point am plitude, hence we restrict ourselves in this paper to the so called bulk am plitudes (s = 0) where we take the nite part of (s) <sup>s</sup> when s ! 0, namely ln . The simplest non trivial bulk am plitude to be calculated (see ref.[3]) is the two spinor-two scalar scattering four-point am plitude:

It is convenient at this point to rewrite  $T_{k_4}$  from (4) in the bosonized form, using (8), to obtain

where  $m_i = \frac{1}{2} \begin{pmatrix} 2 \\ i \end{pmatrix}$ . From the conservation law derived from the integration of the zero m ode associated with the massless eld h we must have 1 = 2 in order to have  $A_4^{(2;2)} \notin 0$ ; we choose for convenience 1 = 2 = +1. In this case if we follow Seiberg<sup>16</sup> and work only with positive energy particles (E > 0) we use (11) to obtain  $k_1; k_2$  0. The remaining two momenta  $k_3$  and  $k_4$  are chosen such that  $k_3 = 0$  and  $k_4 = 0$ , thus after xing the residual SL(2;<) invariance with  $z_1 = 0; z_2 = 1; z_3 = 1$  and calling  $z_4 = z$  we have

where  $ij = k_i k_j$  ij and (x) = (x) = (1 x). Using (13) with s = 0, we can rewrite  $A_4^{(2;2)}$  in the kinematic region  $k_i$   $_0; i = 1;2;3; k_4 _0:$

This result agrees with refs.[3] and suggests again the rede nition<sup>3)</sup>:

This is in agreement (up to a factor  $^2$ ) with the conjectured result (for N = 4 and s = 0):

The next simplest amplitude to calculate is  $V_1^{1=2}V_2^{1=2}V_3^{1=2}V_4^{1=2}E$  which cannot be calculated directly since the corresponding integral does not converge in the kinem atic

region  $k_1; k_2 = {}_0 k_3; k_1 = {}_0$  which is required by selection rule in posed by the zero mode of h. Therefore, we treat instead the case of the 4 spinor -1 scalar scattering (A  $_5^{(4;1)}$ ),

D ue to the h zero m ode selection rule we need three spinors with the same polarization and the last one with opposite polarization to those three; thus we choose  $_1 = +1 = _2 =$ 

 $_{3} = _{4}$ , and the kinem atic region  $k_{i}$   $_{0}$ , (i = 1;2;3;4),  $k_{5}$   $_{0}$ . Fixing the gauge  $z_{2} = 1, z_{4} = 1, z_{5} = 0$  and de ning  $z_{1} = w$ ,  $z_{3} = z$  we have:  $A_{5}^{(4;1)} = \ln \frac{2}{4} d^{2}zd^{2}w$  $= \frac{2(2m_{2}, 1)}{2} \frac{2(2m_{3}, 1)}{2} \frac{2(2m_{3}, 2m_{3}, 2m_{$

In general, we do not know how to calculate such integrals, but in this speci c case we nd that after a convenient shift in  $m_1$  the above integral can be cast into the form of the bulk ve point correlator of scalars in the bosonic non-critical string, and such integral has been indirectly calculated in [3]; using that result, we arrive at

The above result also con rms formula (19) (up to  $\frac{2}{4}$ ) after the rede nitions (18).

Now we come to the main computation of this paper, namely the two spinors-three scalars scattering amplitude:

Due to the h zero mode, the spinors must have opposite helicity, and we choose 1 = +1 = 2, and the kinematic region  $k_1 = 0$ ,  $k_1 = 0$ , i = 2;3;4;5. Fixing the gauge  $z_1 = 0$ ,  $z_2 = 1$  and  $z_3 = 1$ , and dening  $z_4 = z$ ,  $z_5 = w$ , it is easy to arrive at the following integral representation:

W here the ferm ionic correlators (#) are given by the expression

Therefore we have,

where the st integral is given by the expression

while the second one has already appeared in bosonic computations<sup>3</sup>:

In general the amplitude  $A_5^{2,3}$  is a combination of two unknown integrals, however it is very fortunate that in the case where we place one of spinor vertices at the in nity we end up with the two integrals above where  $I_2$  has been calculated (indirectly) before in ref.[3] with the result:

where we have used the kinematic relation  $m_2 + m_3 + m_4 + m_5 = 1=2$ . At this point it is quite surprising to have the result (28) contributing to  $A_5^{(2;3)}$  since the role of the factors

(m) and (m + 1=2) seem to be interchanged which m ight point to some non universality of the vertices rede nition (18). We will convince the reader by calculating I<sub>1</sub> that this is actually not the case and the m isplaced poles of I<sub>2</sub> are cancelled by corresponding poles of I<sub>1</sub>. In order to obtain I<sub>1</sub> we follow a by now standard procedure. First of all it is convenient to rewrite I<sub>1</sub> using a change of variables after which we have:

U sing a technique developed by D otsenko and Fatteev<sup>21</sup> it is easy to derive from (26) and (29) the asymptotic behaviour:

Now we use the property that at the poles of interm ediate states  $A_5$  factorizes in four point functions, for which we can use the V irasoro-Shapiro formula; in other words by

using  $j_{2j}^{2+} = - (2)$  (z) we get from (26) and (29):

Furtherm one for  $m_5 = 0$  the two integrals over z and w decouple, and we have (up to possible factors 1/2)

Finally  $I_1$  is also calculable at  $m_4 + m_5 = w$  here it contains a double pole:

By taking form ulae (31-33) and the result (28) for  $I_2$  the reader can check that the poles at  $m_3$ ,  $m_4$ ,  $m_5$  and the double pole at  $m_4$ ;  $m_5 =$  are canceled and do not appear in the nal expression for  $A_5^{(2;3)}$ , only the pole at  $m_5 = 1=2 +$  survives which is in agreem ent with our expectations. The reader m ay object at this point that we have only checked the calculation of the rst poles of the gam m a functions of  $I_2$ , how ever by using the factorization properties, i.e.,  $j_2 j^{6+} - (Q_2 Q_{\overline{2}})^{2-(2)}$  (z) we have also obtained after a long algebra:

Introducing the result above and (28) altogether in (25) one checks that the rst excited pole at  $m_3 = 1$  of  $I_2$  does not appear in A<sub>5</sub> and this is a very striking cancelation which leads us to suggest the following result for  $I_1$ :

The above result is in agreement with  $all^{4}$  form u lae we have derived so far from  $I_1$  including the asymptotic behaviors (30) (one uses Stirling form u la to check it). U sing (28) and (35) in (25) we have as expected:

At last we should remark that although we have not been able to explicitly calculate the four spinor bulk (s = 0) scattering  $A_4^{(4;0)}$  it is clear that for s = 1 it corresponds to  $A_5^{(4;1)}$  with  $k_1 = 0$ . In order to calculate correlators involving more than four spinors we need the  $V_{+1=2}$  vertex but this is out of the scope of this letter.

From the result (36) we are reasonably safe to conclude that the correlation functions factorize, and each bosonic external leg contributes a factor  $(m + \frac{1}{2})$ , while a Ram ond vertex gives a contribution (m).

The factorizable result is actually highly non-trivial. A though, as mentioned, some authors already present some of them, it is not clear at all how they should be obtained from the recent supermatrix model techniques<sup>11</sup>, in such a way that a non-trivial check is also required. In some cases, the relevant spinor elds seem to contribute with a zero factor to several correlators (those involving more than two spinors) as opposite to our non-vanishing result (21), which involves four spinors. Nevertheless, there is a possibility of matching the results disentangling the analytical contributions to the ferm ionic correlators in a sim ilar way as it was done in the bosonic matrix models<sup>12</sup>.
