A bstract. This paper is devoted to the exploration of som e of the geom etrical issues raised by the $\mathrm{N}=2$ superstring. W e begin by review ing the reasons that -functions for the $\mathrm{N}=2$ superstring require it to live in a four-dim ensional self-dual spacetim e of signature ( ++ ), together with som e of the argum ents as to why the only degree of freedom in the theory is that described by the gravitational eld. W e then $m$ ove on to describe at length the geom etry of at space, and how a real version of tw istor theory is relevant to it. $W$ e then describe som e of the $m$ ore com plicated spacetim es that satisfy the -function equations. Finally we speculate on the deeper signi cance of som e of these spacetim es.

## x1 Introduction

This paper is aim ed tow ards providing a description of som e of the physics of the $\mathrm{N}=2$ superstring, together $w$ ith som e of the geom etrical consequences of such theories. It follow s on from some sem inal work of O oguri and Vafa [1] who showed how to $m$ ake sense of this type of string theory. They showed that the critical dim ension of such strings is four real dim ensions, and then com puted som e scattering am plitudes. The am plitudes indicate that the bosonic part of the $N=2$ theory corresponds to self-dualm etrics of a spacetim e of ultrahyperbolic signature (+ $+\quad$ ). W e call $m$ etrics of such signature $K$ leinian. T he situation should be contrasted with the bosonic string where we expect 26 -dim ensional $m$ etrics of Lorentz signature to play an im portant role, and the $N=1$ superstring where 10-dim ensionalm etrics of Lorentz signature are the im portant ob jects. If we try to extend the num ber of supersym $m$ etries beyond two superconform al supersym $m$ etries, then we nd that the critical dim ensions are negative. It is unclear how one should think about such types of string theory.
$T$ he present paper is divided into six sections. In section tw 0 , we discuss som e of the basic properties of the $N=2$ superstring, and explain how self-dualspaces ofdim ension four arise. In section three, we discuss the properties of at four-dim ensional K leinian spacetim $e$, and see how a real version of tw istor theory is relevant. In section four we discuss som e curved $m$ etrics that arise in this type of geom etry. In section ve, we discuss som e cosm ic string $m$ etrics which are in som e sense related to the planar strings, and in section six we discuss som em etrics that are related to string ofhigher genus. W e conclude w ith som e speculations. $R$ eaders $w$ ho are $m$ ore interested in $K$ leinian geom etry than superstrings $m$ ay skip section tw o and proceed directly to section three.

## x 2 T he $\mathrm{N}=2$ String

The traditional view of string theory is to regard the string worldsheet as an ob ject em bedded in a classical spactim e background. If we have no other structure then we w ould be thinking about the bosonic string. In perturbation theory, the closed bosonic string describes gravity w th the Einstein action, together with various other spacetim e elds. Such a theory is both conform ally and Lorentz invariant in 26 -dim ensional at spacetim e of Lorentz signature. The bosonic string how ever is believed to be inconsistent because its spectrum contains a tachyon [2].

A di erent string theory can be found by supposing that the worldsheet has som e additional structure. If it has $N=1$ superconform al supersym $m$ etry, we nd that the string is quantum m echanically consistent in a 10-dim ensional spacetim e of Lorentz signature. T he closed superstring describes gravity w ith the E instein action coupled to various other spacetime elds, the massless elds being those found in either of the two $\mathrm{N}=2$ supergravity theories. There is no longer a tachyon in its spectrum and it is believed that this theory is a self-consistent nite theory. N evertheless the description in term $s$ of the worldsheet is incom plete because, like the bosonic string, the density of states function (E)dE, the num ber of physical spacetim e states betw een $E$ and $E+d E$, grow sexponentially. A s a consequence, there is a $m$ axim um tem perature, the $H$ agedom tem perature, at which there is a phase transition to som e other \exotic" phase of string theory [3]. For the superstring th is tem perature is $\left.\mathrm{T}_{\mathrm{H}} \quad\left(8{ }^{2}\right)^{0}\right)^{1}$ where ${ }^{0}$ is the inverse string tension. T he nature of the new phase is not currently understood - although $m$ uch has been $m$ ade of the analogy betw een hadronic physics and QCD. It m ay be extrem ely di cult to resolve the issue problem for the superstring precisely because of the com plexity of the theory.
$W$ hat is needed is a much sim pler model theory in which som e of the issues can be investigated w thout the com plications of the in nite num ber of degrees of freedom of the
$\mathrm{N}=1$ string. T he m odel we propose to investigate here is the $\mathrm{N}=2$ superstring, which is in som e sense a \topological" string theory. The $\mathrm{N}=2$ superstring is a theory w th two supercon form al supersym $m$ etries. The action for such a theory can be conven iently w ritten so that the tw o supersym $m$ etries can be com bined into a single com plex supersym $m$ etry. If we let $Z^{i}$ be the i-th com ponent of a complex bosonic eld and ${ }^{i}$ be the $i$-th com ponent of a com plex world-sheet spinor eld (i.e. a D irac spinor) then the action

is invariant under an $N=2$ rigid supersym $m$ etry. In this expression ${ }^{0}$ is the inverse string tension, and the string w orld-sheet is spanned by coordinates , and hasmetric tensor . Gamm a m atrices are determ ined with respect to the m etric. The spacetim em etric is given by ij and has not, as yet, been speci ed. The rigid supersymm etry is generated by a complex ( $D$ irac) spinor, and the transform ations of $Z^{i}$ and ${ }^{i}$ are given by

$T$ he globalsupersym $m$ etry can be prom oted to a localsupersym $m$ etry by coupling them atter multiplet to $\mathrm{N}=2$ world-sheet supergravity. The graviton m ultiplet contains a com plex gravitino and an $U$ (1) gauge eld A besides the world-sheet metric. The action is now invariant under world-sheet reparam etrizations and world-sheet $W$ eyl rescalings, and can be w ritten explicitly as [4]

There are no kinetic term $s$ for any com ponents of the $N=2$ supergravity multiplet, and in fact these elds can be gauged aw ay by the introduction of the appropriate ghost elds. As it stands the action (2.4) describes a string propagating in a com plex $\frac{1}{2} d$-dim ensional background. H ow ever, it can be reintenpreted as a d-dim ensional real background, where the signature of the $m$ etric ij has an even num ber ofboth positive and negative directions so as to be consistent w ith the complex structure inherent w th $\mathrm{N}=2$ supersym m etry.

W e m ust now exam ine the consistency of our string theory. Suppose that the string is propagating in a at realmetric ij. First, there is the issue of the $W$ eyl anom aly. It is easily com puted, since the contribution to the anom aly from a ghost-antighost pair in which the ghost eld has conform alweight $\frac{1}{2}\left(\begin{array}{ll}1 & j\end{array}\right)$ and statistics ; is $(1 \quad 3 j)$. The graviton ghost has $=+1$ and $j=3$ thus contributes 26 to the anom aly. There are two sets of gravitino ghosts, one for each gravitino both with $=1$ and $j=2$ giving a contribution of 22. The ghost for the $U(1)$ gauge eld has $=1$ and $j=1$ and so contributes 2 . The total ghost contributions are therefore 6 . Them atter elds contribute $d$ from the bosonic elds and d=2 from the ferm ionic elds and thus the $W$ eylanom aly will cancelprovided that $d=4$. Thus we conclude that the $N=2$ string is anom aly-free in a at spacetim e of four dim ensions. The choige ofm etric signature is how ever not com pletely arbitrary. T he target space $m$ ust have a com plex structure and so we can choose the target space $m$ etric to have
signature 4 or 0 . H ow ever, if the worldsheet is to be Lorentzian, then the $m$ etric signature


The next step is to determ ine the physical states of the theory. These are the states of positive norm modulo gauge equivalence. For signature ( $\quad++$ ) one expects tw ige as $m$ any negative norm states as for the bosonic string, and all of these $m$ ust be rem oved by the various ghost contributions. In fact, there are tw o sets of ferm ionic ghosts, those that cancel the graviton, and those that canœel the gauge eld. These are su cient to canœl the negative norm states. O $n$ the face of it, all the states of the theory are cancelled, since each ghost eld absorbs both a tim elike and a spacelike degree of freedom. It is in this sense that we $m$ ean the $N=2$ superstring is a topological string theory.

W e m ust how ever be $m$ ore precise, and look at the question of degrees of freedom $m$ ore carefiully. There are tw o equivalent ways of proceeding. O ne is to exam ine the cohom ology of the BRS operator de ned on a cylindrical worldsheet. Physical states are then those that are $Q$-closed but not $Q$-exact [5]. A ltematively one can look at the partition function evaluated on the torus. This will exhibit contributions from each physical state. Unitarity considerations indicate that the tw o approaches yield the sam e conclusions. In going through such a process, it is clear that there is considerable ambiguity in how one deals w th the global issues, and it appears that there are in fact $m$ any consistent string theories that $m$ ight eventually em erge.

To see what the physical states are in the BRS form ulation, we m ust introduce sets of operators with which to describe the excited states of the string. We are interested in closed strings propagating in the at $m$ etric ij on $R^{4}$. The string worldsheet is cylindrical w ith spacelike coordinate identi ed w ith period 2 , and the tim elike coordinate being unbounded. W e work, for convenience, w ith com plex elds, X ${ }^{i}$ and ${ }^{i}$. It therefore follow s that $X^{i}$ is periodic

As a result of $N=2$ superconform al sym $m$ etry the energy $m$ om entum tensor $T$, the (com plex) supercurrent, $S$ and the $U(1)$ gauge current $T$ m ust all vanish identically.

for a physical state $j$ i. The conditions (2 26-8) are precisely equivalent to the requirem ent that $j$ i be described by the cohom ology of the BRS operator $Q$. It should be noted that these conditions im ply, from equation (2.25), that all physical states have vanishing $U$ (1) charge, whereas the currents $G$ and $G$ have a U (1) charge of 1 and 1 respectively.
$T$ he highest weight representations of the $N=2$ super- $V$ irasoro algebra have been investigated by B oucher, Friedan and K ent [6]. W e can apply their results directly to the string problem. For the NS-sector, the only possible choice of $h$ consistent $w$ ith the requirem ent of neutrality $w$ ith respect to the $U(1)$ charge for the ground state, and central charge corresponding to the physical dim ension in which conform al invariance can be $m$ aintained is
$h=0$. Furtherm ore, beyond the ground state, all excited states form ed by acting $w$ th the $n$ 's or $n$ 's on the vacuum state $w i l l$ not be neutral $w$ ith respect to the $U$ (1) charge, or spurious states. The conclusion is therefore that the only state that represents a spacetim e boson is the ground state of the string, which is a $m$ assless. This agrees $w$ th the results of M athur and M ukhi [7] who exam ined the rst few excited states of this superstring.

In the R-sector of the string, their results can be sim ilarly applied, and we nd no physical states whatsoever. T hus we conclude that the only physical state of the string is a single $m$ assless scalar boson. This string therefore does not su er from a Hagedom transition together w ith its associated com plications.

If instead we w ished to derive the sam e results from considering the cohom ology of $Q$, then we would have to supplem ent the de nitions of $L_{n} ; G_{n} ; G_{n}$ and $T_{n}$ by the inclusion of extra ghost term s. W e would then discover that the (2.18) to (2.25) would still hold, but now all the central term s would cancel, in both the NS and R sectors, as a consequence of choosing the criticaldim ension to be four, and of having zero shift of the vacuum energy in both sectors. W e note that the above situation is rather di erent to the $\mathrm{N}=1$ superstring where there are di erent shifts of the vacuum energies in di erent sectors. H aving carried out this procedure, we w ould be guaranteed that $Q^{2}=0$, and then its cohom ology could be investigated. Thus the analysis of the previous paragraph w ould be repeated.

The interpretation of this scalar particle has been explored by Vafa and O oguri [1] who have com puted the scattering am plitudes at the tree level. They nd that the am plitudes obtained show that the scalar is the $K$ ahler potential for a self-dualgravitational eld. Thus it seem s reasonable to conclude that this string theory is just self-dual gravity, for the case of spacetim e signature ( $\quad++$ ).

O ne can also support their conclusion by tw o other calculations. $F$ irstly, we can com pute the string partition function directly from the path integral which requires the explicit introduction of the ghost and antighost elds for each of the constraints, given by equations (2.14-17). The ghosts are just $m$ inim alb-c system $s w$ ith statistics and conform alweight $j$ referred to earlier. W e can now sim ply evaluate the partition function by standard $m$ ethods. C onsider states at leveln so that the $m$ ass ${ }^{2}$ of these states is proportionalto $n$, and de ne the partition function to be

$w$ here $N$ is the num ber operator which counts the level to $w$ hich the string has been excited, and thus $p(n)$ is the num ber of states at the $N^{\text {th }}$ level. Since we are dealing $w$ th a closed string theory, we m ust take account of both left-m oving excitations and right-m oving excitations, im posing the constraint that the levelofexcitation of the left-m overs is the sam e as that of the right-m overs. C onsider rst of all the NS-sector (for just right-m overs), then

where each term in the product arises from the $\mathrm{X}^{\mathrm{i}} \mathrm{s}$, ${ }^{i}{ }^{i} \mathrm{~S}$, graviton and gauge eld ghosts, and gravitino ghosts respectively. We thus nd that $\mathrm{G}_{\mathrm{N} S}(\mathrm{w})=1$ as was expected from previous considerations. N ow we shall consider the R -sector. T here are no states that have vanishing charge, and so we can conclude im m ediately that $G_{R}(w)=0$. Hence, we believe the only physical state is the $m$ assless scalar. T he fact that $G(w)=1$ is the reason that the theory can be term ed topological.

O fcourse, we have chosen one particular G SO pro jection [8] in the preceeding treatm ent, and it is the one in which all the ferm ions have the sam e choice of periodicity. W e need not have done that, and O oguri and Vafa [1] exhibit other possible choices. W e note here
how ever that if we m ake a choige that results in spacetim e ferm ions, then there $w$ ill be at least tw o spacetim e supersym $m$ etries that are never broken. T hat is because in a self-dual space, we are guaranteed to have at least tw o covariantly constant spinors w hich can be used to generate tw $o$ independent spacetim e supersym $m$ etries.

W e have so far exam ined the theory in at space only. Suppose that instead we started from the m odel type action and asked what would happen if the m odelw ere im m ersed in som e curved space. T hen, the w ould need to com pute the renorm alization group equations for the curved space metric ij. At the one-loop level, we would nd that the -fiunction equation for the renom alization of the $m$ etric would just be

T hus to low est order, we have discovered that the $m$ etric $m$ ust be $R$ icci at. Stringy considerations lead us to believe that this $m$ etric $m$ ust be $K$ ahler because of the behaviour of the scattering am plitudes alluded to earlier. Thus, in perturbation theory we can conclude that there are no other term s . Suppose that we have a R icci at $K$ ahler $m$ etric, since we are four dim ensions we can conclude that the $m$ etric $m$ ust be self-dual. It is therefore im possible to nd any non-trivialhigher order sym $m$ etric tensors built from only the $R$ iem ann tensor and so any such target space will solve the string fiunction equations to all orders. $C$ onsequently in $m$ ost of the rem ainder of our paper, we will describe som e of the geom etry of such target spaces.

W e conclude this section by contem plating the string propagating in a space of signature $(++++$ ) once m ore. $W$ e have discovered that the only physical excitations of the string were the ground state. If we were in at $\mathrm{R}^{4}$ then $w$ ith this signature, there would be no string theory as the ground state would alw ays correspond to the string having collapsed down to a point. H ow ever, if the target space, $M$ had som e non-trivial ${ }^{2}$, then the string at genus zero could shrink dow $n$ onto the non-contractible $S^{2}$ and give som e extra contribution to the partition function. W e can extrapolate our present results to conclude that

in general. Furtherm ore, sim ilar considerations at genus $g$ would seem to indicate that all of $\mathrm{H}_{2}(\mathrm{M})$ can be probed by considering allpossible genera of the string w orldsheet. It $m$ ay even be possible to extract further topological inform ation from $N=2$ string theory. This is a m atter that is currently under investigation.
x3 F lat U ltra-hyperbolic 4-G eom etry

The properties of four-dim ensionalm etrics of signature $(2,2)$ are com paratively unknow $n$ am ongst $m$ ost of the physics com $m$ unity. The purpose of this section therefore is to provide a brief review of their basic properties. $W$ e shallbegin $w$ ith the at space $R^{2 ; 2}$, and discuss curved spaces in the next section.

We will start with som e purely term inological rem arks. In an arbitrary dim ension, an ultrahyperbolic $m$ etric is a $m$ etric $w$ ith signature ( $s ; t$ ) or ( $t ; s) w$ ith $s$ $t$ and for which $t \in 0 ; 1$. The cases of $t=0 ; 1$ are called $R$ iem annian and Lorentzian (or hyperbolic) $m$ etrics respectively. In dim ension four, there rem ains only the case (2;2). In dim ensions greater than four, the term \ultrahyperbolic," as it is usually used, is am biguous. interesting feature of $K$ leinian spacetim es is the com plete sym $m$ etry betw een space and tim e which corresponds to the freedom to $m$ ultiply the $m$ etric $g$ by 1 and obtain a new m etric of the sam e signature. Only in dim ension 2 is it possible for a Lorentzian spacetim e because in that dim ension Lorentzian and $K$ leinian are the sam $e$ thing. In string theory the above sym $m$ etry is associated $w$ ith what is usually referred to as \crossing sym $m$ etry." Since the analogy is not precise and since the word \dual" is used in $m$ any unrelated situations, we prefer to use the term \chronal-chiralsym metry" for the sym $m$ etry under $g \quad!\quad g \quad$ :

The $P$ lucker correspondence has num erous im portant applications to the geom etry and physics of Euclidean 3-space. The extension of the $P$ hucker correspondence to 4-dim ensionalM inkow ski space is what Penrose [11] calls tw istor theory [12]. N evertheless, the great form alsim ilarity betw een them and the com plex num bers, including the ability to introduce an analytic function theory $w$ ith an obvious analogue of the $C$ auchy $R$ iem ann equations $m$ akes them very useful as a calculational tool for ultrahyperbolic geom etry since one can interpret $m$ ost of the usual form ulae of com plex and $K$ ahler geom etry in term $s$ of double num bers. M oreover, it allow s a sim ple passage from the general analysis of P lebanski et. al[13] in term s of com plex $m$ etrics, w ith tw o independent sets of com plex coordinates to the restriction to the ultrahyperbolic case.

## x4 C urved $K$ leinian $E$ instein $M$ etrics

In this section we $w$ ish to $m$ ake a few rem arks about curved $K$ leinian 4 -m etrics. $W e$ com $m$ ence by noticing that on topologicalgrounds not every $4-m$ anifold $M$ can adm it such a $m$ etric. E very paracom pactm anifold $M$ adm its a (not unique) $R$ iem annian $m$ etric, gab say, and thus if $M$ adm its a $K$ leinian $m$ etric $k_{a b}$, then wem ay diagonalize $k_{a b}$ relative to $g_{a b}$. it follow s that M m ust adm it an everyw here non-vanishing $2-\mathrm{plane}$ distribution. A ccording to A tiyah and $D$ upont [14] a necessary condition for this, assum ing that M is closed, $@ \mathrm{M}=$; ,
 and the signature obey certain conditions, nam ely

This is sam e construction as for Lorentzian anti-de Silter space except that the cosm ologicalconstant has been chosen to be positive rather than negative. $W$ e should how ever note that in contrast to the Lorentzian case there is just a single $m$ etric of constant curvature. $T$ his is because changing the sign of
is the sam e as changing the overall sign of the $m$ etric, which is a discrete isom etry in the present case. O ne could regard (4.4) as a generalized Friedm ann R obertson-W alker m etric in a variety of ways, rather as one does for de Sitter spacetim e, but we w ill not explore th is here.

W e now pass on to the analog of the Schw arzschild vacuum solution. For Lorentzian signature, the Schw arzschild $m$ etric is usually regarded as the eld of a particle with a tim elike worldline. Thus it has as its isom etry group SO (3) $R$, the SO (3) having tw o-dim ensional orbits, and the isom etry group being the stabilizer of a tim elike line in M inkow skispacetim e. $T$ his property com pletely characterizes the $m$ etric up to the sign of the $m$ ass param eter $M$. $B$ oth possible signs give rise to an incom plete singular $m$ etric. If $M>0$, the singularity is hidden inside the event horizon, whereas if M < 0 there would be a naked singularity. If instead we had w ished to consider the gravitational eld of a tachyon, that is a particle w ith a spacelike worldline, we would replace SO (3) by SO $(2 ; 1)$. We then have a choice as to whether the orbit of $S O(2 ; 1)$ is spacelike, giving the two-dim ensional hyperboloid $\mathrm{H}^{2}$, or tim elike, giving two-dim ensional de Sitter spacetim e $(\mathrm{dS})_{2} . \mathrm{W}$ e also have a choige of whether the $m$ ass is positive or negative. Since these $m$ etrics are wanped products of a two-dim ensionalLorentzian spactim e and a $R$ iem annian tw o-surface, wem ay illustrate the possibilities by he selfeexplanatory diagram s below which include the analogous possibilities for $K$ leinian and $R$ iem annian choiges of signature.

It is notew orthy that am ong the list are three com plete non-singular $m$ etrics, one for each signature. In each of these cases, the ( $r ; t$ ) plane has a positive de nite $m$ etric, $t$ being periodic w ith period 8 M , and $\mathrm{M}>0$.

W e can construct these solutions in a w ay that is analogous to the de Sitter space exam ple. They can be regarded as algebraic varieties in a seven dim ensional at space of appropriate signature. Lets start w ith the Schw arzschild solution ofL orentz signature. It can be regarded as an algebraic variety in $R^{6 ; 1}$. T hus consider the space

In fact, the algebraic variety described here does in fact cover the entire K ruskalm anifold. Since this construction works in a at seven dim ensional space, it is clear that we can construct $m$ etrics of other signatures in a straightforw ard $w$ ay by com plexifying the entire construction, and taking real sections in an appropriate way. By this technique, we can nd all of the $m$ etrics alluded to earlier. W e will not do this explicitly here as the $m$ ethod is fairly transparent, but rather tedious to record.

If the action of $G$ does not leave I; $S$ and $T$ invariant, it $m$ ust act on them preserving the $K$ illing $m$ etric, in other words the action of $G$ provides a hom om onphism from $G$ to a (possibly im proper) subgroup of $S O(2 ; 1 ; R)$. For exam ple, if $G$ is one-dim ensional, its action on the self-dual tw $o$ form $m$ ay either be a spacelike rotation leaving invariant a privileged com plex structure, a Lorentz boost leaving invariant a privileged double structure, or a null rotation leaving invariant a privileged dualstructure. In the spacelike case it is clear that G w ill not leave invariant any dual or double structure, while in the second case it w ill leave invariant tw o privileged dual structures - or equivalently tw o privileged foliations by -planes, while in the last case there $w$ illbe no privileged double or com plex structures.

The classi cation of isom etries just given is very sim ilar to that in the positive de nite case. M oreover it is obvious that by means of analytic continuation (or $\backslash \mathrm{W}$ ick" rotation) of know $n$ exam ples of $H$ yper $K$ ahler $m$ anifolds one $m$ ay obtain num erous local form $s$ of hypersym plectic 4 m anifolds. Since all know n H yper K ah ler 4 m anifolds adm it isom etries, the corresponding hypersym plectic form swillalso adm it isom etries. T he analytically continued $K$ illing elds $K{ }^{a}$ w ill alw ays have, how ever, non-vanishing length $g_{a b} K{ }^{a} K{ }^{b}$. It follow $s$ that various constructions and uniqueness argum ents in the $R$ iem annian case $w i l l$ pass over to the $K$ leinian case w ithout m uch change. H ow ever, there is a special case which cannot occur in $R$ iem annian geom etry which is when the $K$ illing vector eld is null,

It therefore is conform al to any $R$ iem ann surface of genus $g>1$, after appropriate identi cation to nd the unit cell. Let us suppose that this is the string worldsheet, appropriate for string loop diagram s. It has R iem annian signature indicating that it corresponds to a classically forbidden process, but nevertheless one that is quantum $m$ echanically allowed. The four$m$ anifold is then a self-dual $m$ etric on $T$ ( ). This is precisely the situation envisaged by O oguriand Vafa. $T$ his lends som e support to the con jecture that $N=2$ string theory is in fact the sam e thing as self-dual gravity.

A second rather di erent continuation can be found by $m$ aking the analytic continuation
! i ; ! i . W ere it the case that $f=1$, then this continuation would yield a space di eom onphic to the previous m anifold. H ow ever, we instead nd that

This $m$ etric is also hypersym plectic. $N$ ow how ever the analog of the subspace spanned by $e^{1}$ and $e^{2}$ is a Lorentz $m$ anifold rather than a $R$ iem annian one, again of constant negative curvature, therefore it represents a physical string w orldsheet ., corresponding to a classically allow ed process. D espite this di erence, the four m anifold still has a K leinian self-dual $m$ etric and is of the form $T$ (). It would therefore seem that $K$ leinian self-dual fourm etrics provide an arena for discussing both quantum and classicalprocesses on a dem ocratic footing. $T$ his lends further support to the idea that string theory is in som $e$, as yet ill-understood way, related to self-dual gravity.

## x6 C osm ic Strings

There has been som e considerable interest recently in the relation betw een on the one hand cosm ic strings and solitons, and on the other hand fundam ental strings and p-branes. In particular [22], a fundam entalstring wasm odelled by a solution of the equations ofm otion of the zero-slope lim it of the superstring, w ith a distributional source $w$ ith support on the w orldsheet of the string. On the other hand, there is a dual form ulation in which the tendim ensional superstring w ritten in term s of seven-form eld strengths, there are source-free soliton like solutions of the zero-slope equations of $m$ otion representing a $5-b r a n e$. In the present section, we shall show how to construct non-singular, source-free solutions of the selfdualE instein equations $w$ ith signature $(2 ; 2)$ which $m$ ay be interpreted as a thickening" or \de-singularization" of a distributional cosm ic string w ith curvature supported on a totally null $2-\mathrm{plane}$. W e shallbegin by describing the distributionalm odel, and then its thickening. $T$ he idea of the distributionalm odel is due to $M$ ason [23], but our speci c construction is a little di erent.

A distributional $\backslash$ Regge $C$ alculus" $m$ odel of a cosm ic string $m$ ay be obtained by taking a at spacetim $e R^{t ; s}$, with $s+t=4$, and an isom etry, follow ing them ethod ofE llis and Schm idt
[24]. A suitable isom etry is onew ith an 2-dim ensional xed point setM ${ }^{2}$ and which lies in a one-param eter subgroup. For the construction, it is necessary to x a particular param eter c, so that

The resulting spacetim $e$ is hom eom onphic to $R^{t ; s} \quad M^{2}$, but has a non-standard $m$ etric, the holonom y group for curves encircling the string worldsheet $M^{2}$ being generated by . $T$ he $m$ etric varies continuously $w$ ith the param eter $c$, the case $c=0$ being at space. $T$ he points $M^{2}$ can be reinserted if desired.

The exam ple we are interested in is the case of $\mathrm{R}^{2 ; 2}$, w ith an isom etry xing a totally null 2-plane. By contrast, the exam ple due to $M$ ason, which is constructed by identifying $R^{2 ; 2}$ by alone, results in a rather bizarre spacetime. If the points $M^{2}$ are left in, the identi cation is non $H$ ausdor (but T1). If the points of $M^{2}$ are rem oved, the spacetim e is $H$ ausdor but w ith hom otopy type $S^{1} \quad S^{1}$. This is som ew hat rem iniscent of $M$ isner's spacetim e [25] w ith $t=1$, though the later rem ains non $H$ ausdor even when $M^{2}$ is rem oved.

Now retum to our construction, which includes the action of 1 . Suppose the string worldsheet $M^{2}$ lies on $\mathrm{X}_{1}=\mathrm{x}_{2}=0$, and that M is scaled so that $\mathrm{M}_{12}=1$. T he distributional R iem ann curvature tensor has support on the string worldsheet $M{ }^{2}$ and is given by

In searching for a thickening of the cosm ic string, it is natural to insist that the resulting spacetim e should continue to adm it som e of these sym $m$ etries. In particular we shalldem and that $\mathrm{M}^{4}$ adm its a null self-dualK illing vector eld.

W e therefore have the follow ing:
P roposition. Every ( $2 ; 2$ ) self-dual spactim e adm itting a null self-dual K illing vector eld $K$ is autom atically $R$ ioci at, and locally be cast into the follow ing form :

A special case not covered by this treatm ent is when ! is a function of u only. $T$ hen $d K$ vanishes, and the $K$ illing vector $K$ is covariantly constant. $T$ his class of $m$ etrics is included in the form (620).

 sum ption of a null self-dualK illing vector alw ays im plies the existence of an additional null covariantly constant $K$ illing vector $\frac{d}{@ t}$. T hese solutions are thus $m$ em bers ofP lebanski's class of com plex solutions [13] to the vacuum E instein equations that are analogs of pp-w aves. $T$ hey have also previously been described by $W$ ard [28] in the context of tw istor theory.

Pointsw ith the sam e $u ; v ;$ and $t$ values but $w$ ith $p$ very $s m$ all and positive, and points $w$ ith $p$ very $s m$ all and negative are $m$ apped to points $w$ ith identical $x^{+}$and $y^{+}$but $w$ ith $x$ and $y$ which di er by $c$. The metric (621) with $H=\frac{c}{\mathrm{pj}}$ corresponds to the distributional cosm ic string. To obtain a thickened non-singular string we need only to replace $H$ by a function which is everyw here bounded, but which tends to $\frac{c}{\text { jj }}$ for large values of $p$. Thuswe can construct an everyw here non-singular self-dualspactim e representing a cosm ic string. This contrasts shanply w ith the work of B runo, Shapley and Ellis [27] who found that in signature $(1 ; 3)$ that they could not elim inate the singularities. In fact the situation is strongly resembles that for self-dual metrics $w$ ith signature ( $0 ; 4$ ). The \orbifold" construction is obtained by quotienting $R^{4}$, thought of as $C^{2}$ by the action of a discrete subgroup $S U(2)_{\mathrm{L}} \quad S U(2)_{\mathrm{L}} \quad S U(2)_{\mathrm{R}} \quad S O(4)$. The subgroup can be thought of as generating a self-dual rotation acting on $R^{4}$ which leaves xed the origin. The resulting orbifold has a $K$ leinian singularity at the origin. D eletion of the origin gives a $m$ etric $w$ ith a at connection but w ith self-dual holonom $y$. Since the holonom y is self-dual any distributionalcurvature willbe $R$ icci- at. $T$ hus it is not surprizing that the $K$ leinian singularity can be blown up to obtain a fam ily of com plete non-singular self-dualm etrics which are A LE (A sym ptotically Locally Euclidean). These R iem annian self-dualm etrics, or gravitational instantons as they are som etim es called, depend upon a nite num ber of m oduli. In our case, with signature $(2 ; 2)$ the $m$ oduli space is, by contrast, in nite dim ensional. A nother di erence is that because the support of the curvature is zero dim ensional from the orbifold construction of the self-dual instantons, the usualR egge calculus approach to distributional $m$ etrics, where curvature has support only on two-dim ensional sets, does not apply. W hat is needed is a form alism in which the quadratic functions of the $R$ iem ann tensor that gives rise to the Euler density and the H irzebruch density have support at the origin.

Let us retum to our solution. It is easy to see that the $m$ etric adm its two covariantly constant spinors, since the curvature is self-dual. In addition there is a further covariantly constant spinor of opposite chirality. Let us call these spinors $O_{A} ;{ }_{A}$ and $\Theta_{A} 0$ respectively. It follow s im m ediately from this that the $m$ etric $m$ ust adm it tw o covariantly constant null vectors given by $O_{A} \sigma_{A} \circ$ and ${ }_{A} \sigma_{A} \circ T$ hese vectors autom atically obey $K$ illings equation, and span the covariantly constant null2-surface w ith 2 -form $\Theta_{A} \circ O_{B} \circ O_{A} O_{B}$ which is self-dual. This corresponds to our privileged fam ily of -planes.

It is tem pting to identify these spacetim es $w$ th the physicalspacetim e in which an $N=2$ superstring m oves, and the cosm ic string w th the 2 -surface itself. $T$ he existence of the covariantly constant spinors is prom ising because it show s that the spacetim e can adm it unbroken supersym $m$ etry as one $m$ ight expect.
