A rea-P reserving D iffeomorphisms, W $_1$ and U $_q$ (sl(2)) in Chern-Simons theory and Q uantum Hall system

Abstract

We discuss a quantum U_q (sl(2)) symmetry in Landau problem, which naturally arises due to the relation between the U_q (sl(2)) and the group of magnetic translations. The last one is connected with the W $_1$ and area-preserving (symplectic) dieomorphisms which are the canonical transformations in the two-dimensional phase space. We shall discuss the hidden quantum symmetry in a 2+1 gauge theory with the Chem-Simons term and in a Quantum Hall system which are both connected with the Landau problem.

1. Introduction.

Landau problem [1], i.e. quantum mechanical description of a charged particle with mass m moving on the plane in a constant magnetic eld B normal to the plane, has important applications in dierent areas of theoretical physics. The spectrum of one-body problem consists of degenerate energy levels – the so called Landau level. The degeneracy of each level proportional to total magnetic ux and this system exibits a lot of interesting properties.

Landau Ham iltonian is not invariant under the translation group, however it was known for a long time that it is invariant under the group of magnetic translations [7]. Recently W iegm ann and Zabrodin [8] demonstrated that magnetic translations can be expressed through generators of the quantum algebra U_q (sl(2)) [9], [10] and applied this representation to formulate the Bethe-Ansatz for the Azbel-Hofstadter problem, i.e. the problem of Bloch electron in magnetic eld. The Bethe-Ansatz solution was generalised in [11]. Let us note that several years ago Floratos [12] constructed the representations of the quantum group GL_q (2) with $q = \exp(2 i - N)$ using the N N representations of the Heisenberg group algebra, which were equivalent to the representations of the magnetic translations.

It was also discussed recently that there is a W $_1$ sym m etry [13] in the Landau problem [14] - [16]. This sym m etry was discussed in a context of a topologically massive gauge theory (TMGT) in [14] and of a quantum Halle ect (QHE) in [15], [16]. It is amusing that the W $_1$ algebras are connected with an algebra of area-preserving (or sym plectic) diffeom orphisms of the two-dimensional manifolds, for example it is an in nite-dimensional algebra of canonical transformation in a two-dimensional phase space (p;q). It is also a

sym m etry of the relativistic m em branes after gauge xing - this sym m etry and it connection with the SU (1) were considered in [17], [18].

The aim of this paper is to discuss the connection between quantum symmetry, magnetic translations and area-preserving di eom orphisms in Landau problem and to discuss the U_q (sl(2)) symmetry in 2 + 1 gauge theories with Chem-Simons terms and quantum Hall systems. Let us note that for general q the irreducible representations of U_q (sl(2)) are qualitatively the same as in sl(2) case [19]. However in the case $q^n = 1$ there is only nite number of irreducible representations [20] and the new classication of the states in TMGT and quantum Hall systems exists.

The organization of the paper is as follows. In the next section, which bears essentially a review character, we consider the Landau problem and discuss the relations between canonical transform ations, m agnetic translations and the quantum algebra U_q (sl(2)) . W e shall dem on strate how after the restriction on the rst Landau level the sym m etry under the area-preserving dieomorphisms will appear. We shall demonstrate how the this sym m etry is connected with quantum group sym m etry and will discuss the construction of quantum algebra U_q (s1(2)) from the group of magnetic translations. At the end of this section this construction will be generalaized to the case of Fairlie-Fletcher-Zachos triginom etric algebras with nontrivial central extension [18], which can not be reduced to any magnetic translations. In section 3 the canonical quantization and Landau levels picture in topologically massive gauge theory will be considered and the action of the quantum group on the Hilbert space will be obtained. The corresponding problem, as we shall show, is equivalent to the Landau problem on a torus and we shall consider several exam ples of dierent representations of U_q (sl(2)). It will be shown that the natural value for deform ation parameter $q = \exp(4 + i = k)$ where k is the Chem-Sim on scoe cient. In the section 4 we shall consider the quantum group symmetry in a quantum Hall system. We shall rem em ber how W_1 (to be more precise W_{1+1} appears in a quantum Hall system due to the incompressibility of the ground state and then generalize our construction of W_1 and U_q (s1(2)) on m any-body case and will present arguments in favour of deform ation param eter $q = \exp(2 i)$, where is a lling factor. We shall also consider the action of U_q (s1(2)) on ground state and lowest excitations. In conclusion the obtain results will be discussed as well as some possibilities to nd the quantum group symmetry in other physical models invariant under the area-preserving dieomorphisms and W $_1\,$, such as c = 1 strings and two-dim ensional Yang-Mills theory.

2. W $_{\rm 1}$, m agnetic translations and U $_{\rm q}$ (sl(2)) in Landau problem

2.1. Landau problem

The action for Landau problem, i.e. for particle with mass m moving on the $(x_1; x_2)$ plane in a magnetic eld B is

where we choose a vector potential in a sym m etric gauge $A_i = (B = 2)_{ij}x_j$.

The physical meaning of this reduction is the follows - operators a and a^+ acting on the state at the given level n shift it to n 1. To be at a rst level we must put these operators

to zero after which b and b^+ play the role of the coordinate on the reduced phase space. Let us also note that the action (2.1) in the $\lim i m!$ 0 transforms into

and one can easily see that x_1 and x_2 becomes the coordinates on the phase space, the action in the case of the closed trajectories proportional to the area $A = (x_2 dx_1 - x_1 dx_2)$ and is invariant under the action of the area-preserving dieom orphisms. The last one are nothing but a canonical transformation on the rst Landau level. Let us also note that the connection between Chem-Sim ons theory and Landau problem in the limit $m \cdot 1 = 0$, i.e. reduction on the lowest level, where discussed in [21].

2.2. Canonical transform ation on the $\,$ rst Landau level, W $_1\,$ algebra and the group of magnetic translations

Let us remember some well-known facts about canonical transformations (see, for example [22]). By de nition canonical transformations are dieomorphisms of the phase space which preserve the symplectic structure! = ${}^{P}_{p} dq^{1} \wedge dp^{1}$.

The canonical transform ations are usually de ned by the generation function depending on both old (p or q) and new (P and Q) phase space coordinates, for example one can consider arbitrary F(q;Q) and put

It is easy to see that P;Q are new canonical coordinates. There is however another representation, namely one can consider evolution with respect to some "Ham iltonian" W (p;q) (which is an arbitrary function on the phase space and has nothing common with the physical Ham iltonian). The change in quantities p and q during this evolution p and p itself be regarded as a series of canonical transform ations. Let p and q be the values of the canonical variables at time p and p are their values at another time p. The latter are some function of the form p depending on p as on parameter

where rst term describes in nite number (all possible functions W ()) of the local coexact solutions and the second term describes the nite number (given by the rst Betti number b_l) of the harm onic form s on two-dimensional phase space. It is easy to see that dieom orphisms generated by the rst term are nothing but canonical transformations (2.18).

Any function f on the phase space is transform ed under the canonical transform ation generated by W according to the rule wf = $_{\rm W}$ f = ff;W g, where w is the operator corresponding to function W (). where $n=(n_1;n_2)$ with real $n_1;n_2$ in the case when the phase space is a plane. If the phase space is a torus (as it will be in the case of TMGT or QHE on torus) one has integers $n_1;n_2$ if one de nes a torus phase space T^2 to be a square with both sides equal to 2. One gets the commutation relations for operators w_n computing the Poisson bracket for W_n , [17]

Let us now consider canonical transform ations acting on the Landau problem phase space. The general canonical transform ations are acting on the whole four-dimensional phase space and after quantization they will mix dierent Landau levels. However there is a special subgroup of the canonical transform ations acting on the two-dimensional subspace of the phase space generated by commuting with the Hamiltonian. This means that this transform ations do not mix dierent Landau levels and thus acting on each Landau level as on two-dimensional phase space. It is evident that generators of this area-preserving (symplectic) transform ations will depend on b and b⁺ (see (2.7)) which commute with Hamiltonian (2.6).

A fter quantization we get instead of (2.22) the quantum version

The FFZ algebra (2.24) commutes with the Hamiltonian H (aa⁺ + a⁺a) and thus acts independently on each Landau level. One can construct another W₁ algebra from a; a⁺ operators which we shall call W₁ and gets: W₁ W₁. The rst algebra acts on each Landau level, the second one (tilde) algebra m ixes the level and acts in a simple form onto the coherent states j >_r exp (a⁺)j0>_r.

One can consider another form of generators [15], [16]

Let us note that the de nition of magnetic translations is gauge dependent $-\hat{r} + i\tilde{A}$ commute with a H am iltonian only in a symmetric $A_i = (B=2)_{ij}x_j$ gauge. In general case one must add some gauge dependent terms in (2.25). One can show, however, that the algebra of magnetic translation does not depend on gauge and later we shall work only in the symmetric gauge.

Let us note that FFZ algebra (2.24) is a W eylM oyal [23] deform ation of the Poisson-Lie algebra with usual Poisson brackets $ff;gg = @_zf@_zg$. The M oyal bracket $f;g_M$ is defined as follows:

$2.3. GL_q(2)$ and $U_q(sl(2))$ in Landau problem

There is a natural connection between the FFZ algebra (2.23) [24], [25] and quantum group GL_q (2) . Let us consider the quantum plane

It was shown in [24] that GL_q (2) is the group of automorphisms of the quantum plane (2.33), i.e. $U^0V^0 = qV^0U^0$, where U^0 and V^0 are the images of the action of GL_q (2) on U and V. It is easy to see that $T_n = q^{n_1n_2}U^{n_1}V^{n_2}$ with $q = \exp(iB)$ are generators of the FFZ algebra and thus GL_q (2) naturally acts on this algebra preserving the commutation relations (2.24).

It is am using that one can construct also quantum algebra U_q (sl(2)) from the elements of the magnetic translations group (2.25) (see [8],[11] and references therein). The commutation relations of U_q (sl(2)) are defined as follows [9], [10]:

where the rst relation equivalent indeed to usual commutation relation $[J_3;J] = J$. This algebra is transformed into an ordinary Lie algebra sl(2) in the lim it q!.

The construction of the J and J_3 generators from the given magnetic translations group (2.25) is not unique. One can get arbitrary value for a deform ation parameter q in a general case. However later we shall demonstrate that in physically interesting situations like quantum Halle ect or 2 + 1 dimensional gauge theory the choice of J and J_3 will be dictated by additional physical arguments and there will be some "natural" choice of parameters.

Let us present the following construction depending on two arbitrary noncollinear vectors a and b on a plane and four complex parametres ;;; . Considering the following superpositions of magnetic translation generators:

In the end of this section let us note that that action of U_q (sl(2)) generators J and J_3 on the wave functions on the rst Landau level (generalization on the case of arbitrary level n is straightforward) depends (even after xing ; ;) both on choice of a fundam ental cell (a;b) and a basis of the wavefunctions. We shall present here the action of U_q (sl(2)) on basic wave functions (2.10) for a generic (a;b) for I_q = 1. Using (2.28) one can nd

Let us note that one gets the zero q-dim ension for highest weight representation jj > w ith j = (nk - 1)=2 for q being root of unity $q^k = 1$ because $[j + 1=2]_q = [nk=2]_q = 0$ in this case. The representation theory for q being root of unity was considered in [20], see also [26]. There are two types of representations:

Type-I representations which have q-dimension zero and are either mixed, i.e. not highest weight representations, or irreducible highest weight representations with $j = (nk \ 1)=2$.

Type-II representations with nonzero q-dimension which are irreducible highest weight representations with 0 j < k=2 1.

In our case the deform ation parameter q is arbitrary and depends on our choice of fundam ental cell, to be more precise it depends on the ux = 2B ab through this cell $q = \exp(i = 2)$. For $q^k = 1$ one must have B ab = 2 = k. In the case of A zbel-H of stadter problem which was considered in [8], [11] the fundam ental cell is the minimal plaquette on the lattice and the interesting case is when the ux through plaquette is rational. Here we shall consider two other problem s - 2 + 1 abelian TMGT and QHE where the choice of q also will be dictated by rational numerical parameters of the corresponding problem—the value of the numerical coecient in front of Chem-Simons term or the lling factor in quantum Hall system. One can see that the special values of j corresponds to p = (nk=2 1=2)b. Remembering that momentum in x_1 direction (see (2.10)) is Bp = (nk=2 1=2)b = (2 =a) (n=2 1=2k) we get discrete momenta. There is a natural appearence of discrete momenta in Landau problem on cylinder or torus and as we shall see in the next sections these are precisely the cases which we shall be interested in.

2.4. Ug (sl(2)) from a central extension of the FFZ trigonom etric algebra

It is known that a classical algebra of the area-preserving dieom orphisms on a torus has a central extension (which does not exist in the case of the area-preserving dieom orphisms on a sphere) [17],[18]

We see that in a case of a nontrivial central extension one has to deal with more restrictions when constructing a quantum algebra. First of all the choice of the fundamental cell n; more is no longer arbitrary but the basic vectors must be choosen in a way that no more is orthogonal to the vector a. Besides this the four parameters ; are completely determined by one (complex) parameter (for example,), contrary to a case a=0 with two independent parametres (for example, and).

3. Quantum sym m etry in 2+1 gauge theory with Chern-Sim ons term

3.1. Canonical quantization of the 2+1 TM GT

Is it possible to consider a constant gauge eld as a physical, i.e. gauge invariant variable in the theory? Can one simply gauge away the constant eld? To answer this question we must de ne the boundary conditions at in nity, i.e. to compactify our plane into a 2-dimensional Riemann surface of genus g. It is well-known that any one-form A can be uniquely decomposed according to Hodge theorem as

In our case the "magnetic eld" in (A $_{(1)}$; A $_{(2)}$) plane can be easily obtained from (3.13) and equals to B = (k=4) Im , thus the total number of states will be N = (1=2)(k=4) Im) (2) Im = k=2. and does not depend on but only on k.

We see that it is possible to factorize over whole large gauge transform ations only for even k, for rational k=2m=n one can not any longer maintain the whole large gauge transform ations group and only the subgroup with shifts $A_i! A_i+nN_i$, are survive and so one gets the torus in a phase space 0 $A_i < 2$ n with the total area $(2 \ n)^2$ (we put = i here because as we have mentioned before the number of states does not depend on moduli) and the number of states is N=(1-2)(m-2)n.

3.2. U_q (sl(2)) in Chern-Sim ons theory and Landau problem on a torus

Now it is clear that to study the properties of the ground state in TMGT (or the whole Hilbert space in a topological Chem-Sim ons theory) one has to consider a Landau

In our case the corresponding conform all eld theory is $c=1\,\mathrm{m}$ odeland the states on the rst Landau level are in one-to-one correspondence with the conform all blocks of a $c=1\,\mathrm{m}$ odel [28]. This means that there is U_q (sl(2)) symmetry in $c=1\,\mathrm{CFT}$ and conform all blocks are a representation of quantum algebra.

4. Quantum symmetry in a quantum Hall system

4.1. A rea-preserving di eom orphism s and incom pressibility in a quantum H all system

The area-preserving dieom orphisms and corresponding W $_1$ symmetry were discussed recently in quantum Hall systems in [15], [16]. The physical reason for the very existence of this symmetry is based on a Laughlin idea [29] that ground state of the quantum Hall system at rational (integer and fractional) values of a lling factor = 2 = B, where is an electron density, is described by an incompressible quantum uid, i.e. there is an energy gap in a spectrum of excitations. In the case of an integer quantum Halle ect (IQ HE) this gap is a m obility gap between Landau levels (taking into account the disorder and localised states) which for strong magnetic eld B is much larger then the energy of Coulomb repulsion between electrons. Thus one can neglect the interaction in the IQHE e ect and consider it as a system of completely lled Landau levels. The fractional quantum Halle ect (FQHE) occurs in low-disorder, high-m obility samples with partially lled Landau levels. In this case there is no single-particle gap and only after takking into account many-body correlation due to the Coulomb repulsion the excitation gap appears in a spectrum as a collective e ect. In the case of $\lim_{n \to \infty} = 1 = (2p + 1)$ the ground state wave function is described by Laughlin wave function [29] (let us note that in our notation the wave function on the rst Landau level depends on z, not z)

One can also show using the second-quantized representation and (2.31) that the Fourier-transformed second-quantized density operator $(K) = \frac{R}{d^2x} \exp(iKx)^{-y}(x)$, being projected on the rst Landau level, becomes proportional to a $W_{k,k}$ generator with $k(k) = k_1 - k_2$.

The incompressibility of the quantum Hall liquid thus naturally leads to a some W_1 symmetry (to be more precise it is called W_{1+1} in a literature). If one considers a droplet of a quantum Hall liquid it is evident that the only possible deform ations of this droplet preserving the area turns are the waves at the boundary of the droplet describing the deform ation of shape – the so-called edge excitations [31].

4.2. M agnetic translations and U_q (sl(2)) in quantum Hall system

A fter this brief review of area-preserving dieomorphisms and W $_1$ symmetries in a quantum Hall system let us consider our construction of U_{α} (sl(2)) and ask the obvious

question — what will be a natural value for a deformation a parameter q and how this symmetry will act on the physical states. Let us note that there are two possibilities to construct the generators of a W $_1\,$ algebra in this case. First of all we can use the connection (2.31) between W $_{n,n}\,$ and $L_{n,m}\,$ and construct W $_{n,n}\,$ generators in a complete analogy with $L_{n,m}$, i.e. summing over all one-particle generators W $_{n,m}^{i}\,$

Let us note that because of the projection on a given level the time dependence disappears from (x) because all exp(i(B=2m)t) factors from (x;t) will be cancelled by exp(+i(B=2m)t) factors in (x;t).

W e can, however, de ne the total W $_1$ generators acting on the whole quantum Hall system in another way, namely one can multiply all one-particle generators W $_{n}^{i}$ or equivalent m agnetic translation generators T_{n} and get

$$T_{\sim} = {}^{N}_{i=1} T_{\sim}^{i}; \qquad T_{\sim} T_{\sim} = \exp \frac{iB}{2} N \ (\sim \sim) T_{\sim_{+}}$$
 (4.9)

Before we shall discuss the quantum algebra structure let us consider how the translations (4.9) acts on the Laughlin wave function (4.1). Using (2.27) and the fact that $T_{\tilde{e}}^{i}$ factors act independently on z_{i} ; z_{i} arguments, we can get after simple calculations

$$T_{\sim} (z_1; z_1; \dots; z_n z_n) = \exp \frac{B}{4} \frac{B}{2} x_i (z_1; z_1; \dots; z_n; z_n)$$

One can see that up to an overall phase factor depending only on the center of mass coordinate $^{P}_{\ i}z_{i}$ (which is absent in a center of mass frame) the Laughlin wave function is invariant under the magnetic translations.

Let us consider how the quasihole wave function

is transform ed under the action of T_{\sim} . Repeating the same arguments one gets (let us note that T acts only on z_i , not quasihole coordinate u!)

$$T_{\sim} (u;u;z_1;z_1;:::;z_nz_n) = \int_{i}^{Y} (u z_1) T_{\sim} (u;u;z_1;z_1;:::;z_n;z_n)$$
 (4.12)

and we see that T_{\sim} shifts a quasihole coordinate $u \mid u \quad ; u \mid u \quad .$

Now let us construct the U_q (sl(2)) generators from T_{\sim} . Taking as usually

we get the quantum algebra U_q (sl(2)) with

$$q = \exp(iB N ab)$$
 (4.14)

where N is the total number of electrons. To construct the "m in im al" U_q (sl(2)) one have to choose the m in im al a and b. It can be shown that for a system with sizes L_1 and L_2 the m in im alshifts a and b must be choosen as (see discussion in section 3.2)

$$a = \frac{2}{L_2B}; \quad b = \frac{2}{L_1B}$$

With this choice one has

$$q = \exp(iN B ab)) = \exp 2 i \frac{2 N}{B L_1 L_2} = \exp(2 i)$$
 (4.16)

where we used the fact that lling factor is de ned as the ratio of total number of particles N to the total number of available states on the Landau level B $L_1L_2=2$, i.e = 2 N=B L_1L_2 . We see that the ground state is a singlet (up to total shift of the center of m ass) under the action of a quantum group. However the quasihole wave function is transformed under U_q (sl(2)) and the basis (4.11) is not the convenient one to study

the action of quantum algebra - one can see that J_3 in this basis is not diagonal. One can consider the QHE on a cylinder or a torus and then using the arguments from the section 32 we shall get the same representations as (324) and (325). Let us remember that in a rst case we had $q = \exp(2 i = (2p + 1))$ which is precisely the case of the fractional lling factor with an odd denominator = 1 = (2n + 1). It is amusing that in this case we had 2p + 1-dimensional representation with highest and lowest weight vectors. In the case $q = \exp(2 i = 2p)$ which corresponds to the fractional lling factor with an even denominator = 1=2n there were no higest and lowest weight vectors. It is interesting that it is Pauli principle which prescribes the odd denom inators for Laughlin wave function (4.1) to be antisymmetric under the permutaions z_i ! z_i . It is amusing that our quantum algebra construction know about it in some way. Let us also remind through the cylinder the highest weight representation will be that if it is a ux =in the even denominator case q = exp (i=p) as have been discussed at the end of section 32. However this ux corresponds to the antiperiodic boundary condition which may be treated as a statistical transmutations from ferm ions to bosons - the even denominators appearence in this case becomes obvious.

Let us also mention another relation between quantum algebras in Chem-Sim ons theory and in a quantum Hall system. For CS theory we got the deformation parameter $q_{CS} = \exp(4 \ i=k)$ and for quantum Hall system $q_{DH} = \exp(2 \ i)$. One can describe the large-scale properties of a quantum Hall system by an elective G inzburg-Landau theory with the Chem-Sim ons term for "statistical" gauge eld a (don't mix with electromagnetic eld A) [32], [33]. In a simplest case = 1=(2p+1) one has the elective action with a Chem-Sim ons term

and comparing with (3.1) we get

i.e. for both descriptions -m icroscopical and e ective, based on Chern-Sim ons theory, we got the sam e quantum algebra $\rm U_q$ (sl(2)) .

In a more general case = m = (2pm + 1) [34] instead of one abelian Chem-Sim ons eld we have mones [33] and have to generalize our quantum group construction for multidimensional Landau problem. This interesting question will be discussed elsewhere.

5. Conclusion

We discussed in this paper how the quantum algebra U_q (sl(2)) can be constructed from the generators of the W $_1$ transform ations. The physical model for this construction was the Landau problem and the W $_1$ generators were nothing but the magnetic translations. However as we had demonstrated in the case of the FFZ algebra with a nontrivial central extension one can construct the quantum algebra from the W $_1$ algebra which can not be obtained from the group of magnetic translations. Two examples of a quantum U_q (sl(2)) algebra were considered -w if $q_{CS} = \exp(4 \text{ i=k})$ in an abelian 2+1 gauge theory with a Chem-Sim ons term and with $q_{DH} = \exp(2 \text{ i})$, where is a lling factor, in a quantum Hall system s. We have demonstrated using the elective large-scale description of a quantum Hall system in terms of "statistical" Chem-Sim onsied that $q_{CS} = q_{DH}$ in the case of lling factor = 1=(2p+1). In a general case = m=(2pm+1) we have to consider a quantum algebra construction for a general $\frac{Q}{1+1}$ U_1 (1) Chem-Sim ons theory - which reduces to a multidimensional Landau problem.

There are a lot of other interesting questions which are still open. First of all it is interesting to generalise this construction to the nonabelian case for the Chem-Sim ons theory. It is unclear what will be the analog of quantum algebra in this case. Let us note that this question include not only topologically massive nonabelian Yang-Mills theory but also 2+1-dimensional gravity which can be considered as Chem-Sim ons gauge theory too [35].

It also will be extremely interesting to understand if there is a more general connection between area-preserving dieomorphisms and quantum groups (algebras). One can study the geometric action on the coadjoint orbit of \mathbf{w}_1 or \mathbf{W}_1 as it was discussed in [36], [37]. These actions are relevant to both w gravity and two-dimensional hydrodynamics (the nite dimensional analog of the trigonometric FFZ algebra in an ideal two-dimensional hydrodynamics was considered in [38]). It is unclear if there is a hidden quantum symmetry of these geometrical actions.

It is known that there is a W $_1$ in the c=1 strings and corresponding m atrix m odels [39]-[40]. W hat quantum algebra (if any) can be constructed in this model and what is the natural value of a deform ation parameter q in this case? W ill this quantum symmetry exist in the case of deformed c=1 model, for example in the case of two-dimensional black hole?

It is also known that the action for pure Yang-Mills theory in two dimensions is

invariant under the area-preserving dieom orphisms (see, for example [41]). Can one nd a quantum symmetry in this case?

Let us nally note that recently W $_1$ has been discussed in a context of a bosonization of current-current interactions [42]. In the fram ework of this approach the quantum sym m etry m ay appear in some new condensed matter problems.

W e hope to return to these and related questions in the following publications.
