SUPERSYMMETRY W ITHOUT FERM IONS

A bstract

The sim plest N=2 supersym m etric quantum mechanical system is realized in terms of the bosonic creation and annihilation operators obeying either ordinary or deformed Heisenberg algebra involving K lein operator. The construction comprises both the exact and spontaneously broken supersym metry cases with the scale of supersym metry breaking being governed by the deformation parameter. Proceeding from the broken supersym metry case, we realize the Bose-Fermi transformation and obtain spin-1=2 representation of SU (2) group in terms of one bosonic oscillator. We demonstrate that the constructions can be generalized to the more complicated N=2 supersymmetric systems, in particular, corresponding to the Witten supersymmetric quantum mechanics.

It was demonstrated recently [1] that the classical analog of the quantum m assless superparticle can be constructed without incorporating odd G rassm ann variables being the classical analogs of the corresponding ferm ionic operators. Such \bosonization" was realized with the help of topologically nontrivial classical variables, which after quantization supply the system with the necessary ferm ionic degrees of freedom. But, moreover, the next step can be carried out in the direction of bosonization of the supersymmetry. In recent paper [2], devoted to the generalized harm onic oscillator system s, Brzezinski, Equsquiza and Macfarlane have pointed out on a remarkable possibility of uncovering supersymmetry structure totally described within the Fock space of the bosonic oscillator. In the present letter we shall investigate such a possibility of realizing N = 2 supersymmetry for the case of quantum m echanical bosonic oscillator revealing similarity of the constructions with the standard ones comprising ferm ionic degrees of freedom. Certainly, the bosonization mechanisms for the supersymmetry could not their concrete interesting applications similarly to the Bose-Ferm i transmutaion constructions, known since very long time ago [3], which now days together with the anyonic generalizations are applied, e.g., to the description of the planar physical phenomena, viz. high-T_c superconductivity and fractional quantum Halle ect [4].

We shall start with the case of the ordinary bosonic oscillator and realize N = 2 supesymmetry in terms of its creation and annihilation operators dem onstrating that there are two possibilities corresponding to the cases of exact and spontaneuosly broken supersymmetry. Proceeding from the broken supersymmetry case, we shall construct the fermionic oscillator variables, i.e. realize a Bose-Ferm i transform ation in terms of only one bosonic oscillator. The ferm ionic oscillator variables will perm it us to represent the Hamiltonian for both cases in the form similar to the standard supersymmetric form and construct spin-1/2 representation of the SU (2) group on the one bosonic oscillator Fock space. Then we shall generalize all the constructions to the case of the bosonic oscillator operators obeying the deformed Heisenberg algebra involving the K lein operator [5, 2]. The interesting feature of such generalization is that in the case of the spontaneously broken supersymm etry the scale of supersym m etry breaking is de ned by the deform ation param eter of the system . A fter that we shall show how the described constructions can be generalized to the more complicated N = 2 supersymmetric systems, in particular, corresponding to the W itten supersym metric quantum mechanics.

So, let us consider the Fock space of states for the ordinary bosonic oscillator formed by the complete set of orthonormal vectors

constructed over the vacuum state de ned by the relations:

where a^+ and a are creation and annihilation operators satisfying the algebra

and the norm alization constants can be chosen as C $_{\rm n}$ = (n!) $^{1=2}$. Introduce the K lein operator K de ned by the relations

which separates the complete set of states jn > into even and odd subspaces:

The sign factor can be rem oved here by rede ning the vacuum state and without loss of generality we can put = +1. The operator K can be realized in the form $K = \exp i N$; or, in the explicitely herm it in form

with the help of the number operator, $N = a^{\dagger} a$,

Consider now an operator Q^+ together with herm it ian conjugate operator $Q = (Q^+)^y$ of the most general form linear in the oscillator variables a with coe cients depending on the K lein operator K,

where , , and are arbitrary complex numbers, and dem and that they would be nilpotent operators: $Q^{+2} = Q^{-2} = 0$: This requirem ent leads to the

restriction: = ; = ; where is a sign parameter. Therefore, there are two possibilities for choosing operator Q^+ :

where by we denote the hem itian operators

being the projectors: 2 = ; + = 0; + + = 1: The anticom mutator fQ $^+$;Q g has here the form:

Whence we conclude that the anticom mutator will commute with the number operator N if we choose parameters in such a way that = 0. Putting = 0, normalize the second parameter as $= e^{i'}$. But since the phase factor can be removed by the unitary transformation of the oscillator operators a, we arrive at the nilpotent operators in the very compact form similar to that of the supercharges for the simplest N = 2 supersymmetric systems in the standard approach including fermionic operators (see below eq. (20)):

They together with the operator

form the N = 2 superalgebra:

Let us notice that the herm it is supercharge operators $Q^{1/2}$,

have the following compact form:

in term s of the bosonic operators of coordinate x and m omentum p, a = (x ip) = 2; [x;p] = i:

Consider the spectrum of the supersymmetric Hamiltonian (10). In the case when = , the states $j_1 >$ are the eigenstates of the operator H with the eigenvalues

where [n=2] m eans the integer part of n=2. Therefore, for = we have the case of the spontaneously broken supersymmetry with $E_n>0$ and all the states $j_1>0$ and $j_1+1>0$, $j_2=0$, $j_3=0$, are paired in supermultiplets. For $j_3=0$ we have the case of the exact supersymmetry characterized by the spectrum

D ue to the property $E_n > 0$ taking place for = , we can construct the Ferm i oscillator operators:

i.e. one can realize the Bose-Ferm i transform ation in terms of one bosonic oscillator. Notice here, that though, obviously, operators a do not commute with f , nevertheless, the operator H can be written in the form of the simplest supersymmetric H am iltonian:

Indeed, let us compare the constructed systems, being distinguished by the sign parameter , with the simplest ordinary N=2 supersymmetric systems described in terms of mutually commuting bosonic (a) and fermionic (b) oscillator operators:

with the supercharge and Hamiltonian operators realized as

Here = + and = also give the cases of the exact and spontaneously broken supersymmetries, and we see that the Hamiltonian (18) formally coincides with H for the system (19) { (21). It is just from such reasons of similarity we have chosen the signs in both sides of eq. (16).

Having ferm ionic oscillator variables f, one can construct the operators:

satisfying the su (2) algebra:

Due to the relation $S_iS_i = 3=4$; it means that we can realize unitary spin-1=2 representaion of of the SU (2) group acting on every 2-dimensional space of states ($\frac{1}{2}k > \frac{1}{2}k + 1 >$), k = 0;1;:::, in an irreducible way.

Now let us go to the generalizations of these simple constructions, and rst consider the case of the bosonic oscillator variables satisfying the deformed Heisenberg algebra [5, 2]

Here the K lein operator K is also given by the relations of the form (4). Let us introduce again the vacuum state de ned by eqs. (2) and put = +1 in the relation of the form (5). Then we not that the operator a^+a acts on the states $j_1 > de$ ned by eqs. (1) in the following way:

From here we conclude that in the case when

the space of unitary representation of algebra (24), (4) is given by the complete set of the orthomorm alstates (1) with the coe cients

From eqs. (25) and (5) we get the equality: $a^+a = N + (1 - K)=2$; where through N we denoted the number operator (7). Then, using the previous relation and eq. (24), we get a $a^+ = N + 1 + (1 + K)=2$; and from these two relations we arrive as a result at the following expression for the number operator in terms of the operators a:

Now, we can realize the K lein operator K in terms of the operators a by means of equalities (6) and (27), and the constructions performed with the use of ordinary bosonic oscillator operators can be repeated here in the same way. So, we get the supercharges and supersymmetry H am iltonian in the forms (8) and (9), respectively. Then we not that in the case = + we have again the exact supersymmetry and the states $j_1 > are the eigenstates of the H am iltonian H_+ with the same spectrum (15) as in the case of H eisenberg algebra (3), whereas in the case = , we have the case of the spontaneously broken supersymmetry with the shifted energy spectrum: instead of (14) we have here$

Therefore, in this case the shift of the energy (the scale of the supersym metry breaking) is defined by the deformation parameter, but $E_n>0$ for all n due to the restriction (26). It means that in the case of the deformed bosonic oscillator we can realize again the Bose-Fermi transformation and get spin—1=2 repersentation of SU (2) with the help of the relations of the same form (16), (17), (22) and (23) as in the case of the ordinary oscillator. Therefore, from the point of view of the supersymmetry constructions the deformation of the Heisenberg algebra reveals itself in the scale of supersymmetry breaking.

Let us show how the previous constructions can be generalized to the case corresponding to the more complicated quantum mechanical supersymmetric systems [6]. To this end, consider the operators

with odd mutually conjugate operators $A = A (a^+; a)$, $A = (A^+)^y$, KA = A K. These properties of A guarantee that the operators Q are, in turn, mutually conjugate, $Q = (Q^+)^y$, and nilpotent:

Taking the anticom mutator

as the H am iltonian, we get the N = 2 superalgebra de ned by the relations (30), (31) and by the commutator

The explicite form of the supersymmetric Hamiltonian here is

$$H^{\sim} = \frac{1}{2}fA^{+}; A g \frac{1}{2} K [A ; A^{+}];$$

Choosing the operators A , e.g., in the form

$$A = \frac{1}{2} (ip + W (x))$$

with W (x) = W(x), in the case of undeform ed Heisenberg algebra (3) we get for supesymmetric Hamiltonian (33), in its turn, the form

$$H' = \frac{1}{2} (p^2 + W^2 K W^0)$$

corresponding to the W itten supesymm etric quantum mechanics [7] with odd superpotential W .

Thus, we see that N = 2 supersymmetry is realizable in terms of only one bosonic oscillator in the form very similar to that of the standard approach

comprising ferm ionic oscillator operators. In the case of the simplest supersymmetric system considered above the Hamiltonian (10) in Schrödinger representation takes the form:

$$H = \frac{1}{2} \frac{d^2}{dx^2} + x^2 \frac{1}{2} \sin \frac{1}{2} x^2 \frac{d^2}{dx^2}$$

Therefore, the supersym metrization of the pure bosonic system is conditioned here on the speci c nonlocal character of the Hamiltonian.

To conclude, let us point out two problems to be interesting for further consideration. The set one concerns possible generalizations to the cases of supersymmetric N > 2 and parasupersymmetric quantum mechanical systems. For the purpose one could try to use the generalizations of the K lein operator of the form: $K^n = 1$, n > 2. The second, obvious problem consists in generalizing the bosonization of the N = 2 supersymmetry to the quantum eld systems, (1+1)-dimensional in the simplest case.
