The Quantum A lgebraic Structure of the Twisted XXZ Chain

Abstract

We consider the Quantum Inverse Scattering M ethod with a new R-m atrix depending on two parameters q and t. We not that the underlying algebraic structure is the two-parameter deformed algebra $SU_{q,t}(2)$ enlarged by introducing an element belonging to the centre. The corresponding Hamiltonian describes the spin-1/2 XXZ model with twisted periodic boundary conditions.

M any completely integrable one-dimensional quantum models have been treated [1] by the Quantum Inverse Scattering M ethod (Q ISM) [2, 3] which, among other achievements, led to the discovery of Quantum G roups [4] independently from D rinfeld and Jim bo [5]. In this letter we use this method to describe the relation between the spin-1/2 XXZ chain with twisted periodic boundary conditions and the two-parameter deformed algebra $SU_{q,t}$ (2) enlarged by introducing an element belonging to the centre, showing that the second parameter of the deformation, t, is linked to the twist.

The Q ISM introduces an auxiliary problem with the help of the so-called Lax operator. In our model this operator is

where S_n and Z_n are operators de ned on the n th vectorial space of the periodic $(S_{N+1} \quad S_1; Z_{N+1} \quad Z_1)$ chain, which in the fundamental representation are given by

where ~ are the Paulim atrices and II is the identity operator.

The R-matrix associated to the Lax operator (1) is

clearly, R() = R(;t=1) is the appropriate matrix for the XXZ model [6]. It is easy to check that the matrix R (;t) (eqs. (3-5)) satisfies the Yang-Baxter equation [7,8]

with the R (;t) matrix written as

We notice that the R-matrix is dened on the tensor product of two auxiliary spaces Q^2 and the L-m atrix is de ned on the tensor product of the auxiliary space Q^2 and the internal space Qd, with d the dimension of the representation of the associated algebra satis ed by the operators in the elements of the matrix L.

The reason for R (;t) to satisfy eq. (6) is that it can be written in term s of R () as 1

**Tequivalently one could write*

with S³ and Z given by eq. (2). This form is more appropriate if one wishes to compare the algebraic structure here presented with ref. [9]. In a forthcoming paper we shall discuss this subject, as well as the relationship of our approach with the one in ref. [10].

Moreover, eq. (7) follows from eq. (6), because (for d=2)

where \o" labels the auxiliary space. We also observe that

where P is the permutation operator on the tensor product of the two spaces where the R-m atrix is de ned.

According to the standard procedure of the Q ISM , eq. (7) allows one to build an in nite set of commuting operators

where both the matrix product and the trace are performed in the auxiliary space.

In our case the Bethe Ansatz equations for the fundamental representation are given

explicitly showing the contribution due to the parameter t, as $\$, $\$, a and $\$ c are the same functions appearing in the X X Z m odel.

In order to show the algebraic structure underlying the R and L m atrices de ned in eqs. (1) and (3-5) we perform a suitable similarity transformation [3] on (6) and (7) which perm its us to have the following decomposition:

Substituting eq. (19) in the Y-B equation (6) and in the FCR, eq. (7), one gets the following independent equations:

where $[x]_q = (q^x - q^x) = (q - q^1)$ with $q = \exp(i)$. Eqs. (23) are the commutation relations of the two-parametric deformed SU (2) [9, 11, 12] with Z, an element of the center of the resulting algebra. The coproduct is obtained by considering the product of two L_r acting on two internal spaces and we nd:

The coproduct (24c) is related to the one in ref. [12] by a sim ilarity transform ation generated by the operator t^{S^3} Z Z S³.

Following the Q ISM, a local Hamiltonian can be written as

and thanks to eqs. (14-16), it becomes for the fundamental representation of the algebra

where $\hat{R} = PR$ and R (;t) is given by eqs. (3-5). In the above equation $R_{i;i+1}$ (;t) acts on the two internal spaces (i;i+1) instead of acting on two auxiliary spaces.

Substituting R (;t) given by eqs. (3-5) in eq. (26), apart from an additive constant, we get

Such a H am iltonian is very sim ilar to the X X Z m odel with periodic boundary conditions but for each pair of sites (i; i+1), the site (i+1) is rotated of an angle $(t=e^i)$ in the x y plane with respect to the site i.

The sim ilarity transform ation generated by expf $i\frac{x^N}{2}$ (' 1) $\frac{x}{2}$ takes the H am iltonian (eq. (27)) to

which is the well-known [13] Ham iltonian for the XXZ chain with twisted periodic boundary conditions.

It is am using to observe that, thanks to eq. (13) and following the procedure of ref. [10], the Ham iltonian (eq. (27)) could also be obtained from the R-matrix of the XXZ model R() = R(;t=1), using L_n^0 (;t) = $t^{S^3}L_n$ (;t=1) \in L_n (;t). Conversely, the untwisted XXZ model can be built from R(;t) (eqs. (3-5)) and L_n^∞ (;t) = $t^{S^3}L_n$ (;t). All these topics will be discussed in detail in a forthcoming paper.

Finally, we would like to point out that by introducing a central element Z which enlarges the $SU_{q,t}(2)$ algebra, we make appear the underlying algebraic structure of the so-called twisted XXZ model.
