# Path Integral of Relativistic Coulomb System

#### Abstract

The path integral of the relativistic Coulomb system is solved, and the wave functions are extracted from the resulting amplitude.


[^0]1) While the path integral of the nonrelativistic Coulomb system has been solved some 15 years ago (1] and further discussed by many authors [2] - [14], so that it has become textbook material [15], the relativistic problem has remained open. The purpose of this note is to fill this gap.
2) Consider first a relativistic free particle of mass $M$. If $x(\lambda)$ describes its orbit in $D$ spacetime dimensions in terms of some parameter $\lambda$, the classical action reads

\mathcal{A}_{\mathrm{cl}}=M c \int_{\lambda_{a}}^{\lambda_{b}} d \lambda \sqrt{x^{\prime 2}(\lambda)} \tag{1}
\end{equation*}
$$

where $c$ is the light velocity. This action cannot be used to set up a path integral for the time evolution amplitude since it would not yield the well-known Green function of a KleinGordon field. An action which serves this purpose can be constructed with the help of an auxiliary fluctuating variable $\rho(\lambda)$ and reads 16]

\begin{equation*}
\mathcal{A}=\int_{\lambda_{a}}^{\lambda_{b}} d \lambda\left[\frac{M}{2 \rho(\lambda)} x^{\prime 2}(\lambda)+\frac{M c^{2}}{2} \rho(\lambda)\right] . \tag{2}
\end{equation*}
$$

Classically, this action coincides with the original $\mathcal{A}_{\mathrm{cl}}$ since it is extremal for

$$
\begin{equation*}
\rho(\lambda)=\sqrt{x^{\prime 2}(\lambda)} / c \tag{3}
\end{equation*}
$$

Inserting this back into (2) we see that $\mathcal{A}$ reduces to $\mathcal{A}_{\mathrm{cl}}$.
The action $\mathcal{A}_{\mathrm{cl}}$ is invariant under arbitrary reparametrizations

$$
\begin{equation*}
\lambda \rightarrow f(\lambda) \tag{4}
\end{equation*}
$$

The action $\mathcal{A}$ shares this invariance, if $\rho(\lambda)$ is simultaneously transformed as

$$
\begin{equation*}
\rho \rightarrow \rho / f^{\prime} \tag{5}
\end{equation*}
$$

The action $\mathcal{A}$ has the advantage of being quadratic in the orbital variable $x(\lambda)$. If the physical time is analytically continued to imaginary values so that the metric becomes euclidean, the action looks like that of a nonrelativistic particle moving as a function of a pseudotime $\lambda$ through a $D$-dimensional euclidean spacetime, with a mass depending on $\lambda$.
3) To set up a path integral, the action has to be pseudotime-sliced, say at $\lambda_{0}=$ $\lambda_{a}, \lambda_{1}, \ldots, \lambda_{N+1}=\lambda_{b}$. If $\epsilon_{n}=\lambda_{n}-\lambda_{n-1}$ denotes the thickness of the $n$th slice, the sliced action reads

\mathcal{A}^{N}=\sum_{n=1}^{N+1}\left[\frac{M}{2 \rho_{n} \epsilon_{n}}\left(\Delta x_{n}\right)^{2}+\frac{M c^{2}}{2} \epsilon_{n} \rho_{n}\right], \tag{6}
\end{equation*}
$$

where $\rho_{n} \equiv \rho\left(\lambda_{n}\right), \Delta x_{n} \equiv x_{n}-x_{n-1}$, and $x_{n} \equiv x\left(\lambda_{n}\right)$. A path integral $\int\left(\mathcal{D}^{D} x / \sqrt{\rho}^{D}\right) e^{-\mathcal{A} / \hbar}$ may be defined as the limit $N \rightarrow \infty$ of the product of integrals

\begin{equation*}
\frac{1}{\sqrt{2 \pi \hbar \epsilon_{b} \rho_{b} / M}}{ }^{D} \prod_{n=1}^{N}\left[\int \frac{d^{D} x_{n}}{\sqrt{2 \pi \hbar \epsilon_{n} \rho_{n} / M}}\right] \exp \left(-\frac{1}{\hbar} \mathcal{A}^{N}\right) \tag{7}
\end{equation*}
$$

This can immediately be evaluated, yielding

$$
\begin{equation*}
\frac{1}{\sqrt{2 \pi \hbar L / M c}^{D}} \exp \left[-\frac{M c}{2 \hbar} \frac{\left(x_{b}-x_{a}\right)^{2}}{L}-\frac{M c}{2 \hbar} L\right] \tag{8}
\end{equation*}
$$

where the quantity

$$
\begin{equation*}
L \equiv c \sum_{n=1}^{N+1} \epsilon_{n} \rho_{n} \tag{9}
\end{equation*}
$$

has the continuum limit

$$
\begin{equation*}
L=c \int_{\lambda_{a}}^{\lambda_{b}} d \lambda \rho(\lambda) \tag{10}
\end{equation*}
$$

Classically, this is the reparametrization invariant length of a path, as is obvious after inserting (3).

If the amplitude (8) is multiplied by $\lambda_{C} / 2$, where $\lambda_{C}=\hbar / M c$ is the Compton wavelength of the particle, an integral over all positive $L$ yields the correct Klein-Gordon amplitude

\left(x_{b} \mid x_{a}\right)=\frac{1}{(2 \pi)^{D / 2}}\left(\frac{M c}{\hbar \sqrt{x^{2}}}\right)^{D / 2-1} K_{D / 2-1}\left(M c \sqrt{x^{2}} / \hbar\right), \tag{11}
\end{equation*}
$$

where $K_{\nu}(z)$ is the modified Bessel function.
The result does not depend on the choice of $\rho(\lambda)$, this being a manifestation of the reparametrization invariance. We may therefore write the continuum version of the path integral for the relativistic free particle as

$$
\begin{equation*}
\left(x_{b} \mid x_{a}\right)=\frac{1}{2} \lambda_{\mathrm{C}} \int_{0}^{\infty} d L \int \mathcal{D} \rho \Phi[\rho] \int \frac{\mathcal{D}^{D} x}{\sqrt{\rho}^{D}} e^{-\mathcal{A}} \tag{12}
\end{equation*}
$$

where $\Phi[\rho]$ denotes a convenient gauge-fixing functional, for instance $\Phi[\rho]=\delta[\rho-1]$ which fixes $\rho(\lambda)$ to unity everywhere.

To understand the factor $1 / \sqrt{\rho}^{D}$ in the measure of (12), we make use of the canonical form of the action (2),

\mathcal{A}[p, x]=\int_{\lambda_{a}}^{\lambda_{b}} d \lambda\left[-i p x^{\prime}+\frac{\rho(\lambda) p^{2}}{2 M}+\frac{M c^{2}}{2} \rho(\lambda)\right] . \tag{13}
\end{equation*}
$$

After pseudotime slicing, it reads

$$
\begin{equation*}
\mathcal{A}^{N}[p, x]=\sum_{n=1}^{N+1}\left[-i p_{n}\left(x_{n}-x_{n-1}\right)+\rho_{n} \epsilon_{n} \frac{p_{n}^{2}}{2 M}+\frac{M c^{2}}{2} \epsilon_{n} \rho_{n}\right] . \tag{14}
\end{equation*}
$$

At a fixed $\rho(\lambda)$, the path integral has then the usual canonical measure:

$$
\begin{equation*}
\int \mathcal{D}^{D} x \int \frac{\mathcal{D}^{D} p}{(2 \pi \hbar)^{D}} e^{-\mathcal{A}[p, x] / \hbar} \approx \prod_{n=1}^{N}\left[\int d^{D} x_{n}\right] \prod_{n=1}^{N+1}\left[\int \frac{d^{D} p_{n}}{(2 \pi \hbar)^{D}}\right] e^{-\mathcal{A}^{N}[p, x] / \hbar} . \tag{15}
\end{equation*}
$$

By integrating out the momenta, we obtain (7) with the action (6).
4) The fixed-energy amplitude is related to (12) by a Laplace transformation:

$$
\begin{equation*}
\left(\mathbf{x}_{b} \mid \mathbf{x}_{a}\right)_{E} \equiv-i \int_{x_{a}^{0}}^{\infty} d x_{b}^{0} e^{E\left(x_{b}^{0}-x_{a}^{0}\right) / \hbar}\left(x_{b} \mid x_{a}\right), \tag{16}
\end{equation*}
$$

where $x^{0}$ denotes the temporal component and $\mathbf{x}$ the purely spatial part of the $D$-dimensional vector $x$. The poles and cut of $\left(\mathbf{x}_{b} \mid \mathbf{x}_{a}\right)_{E}$ along the energy axis contain all information on the bound and continuous eigenstates of the system. The fixed-energy amplitude has the path integral representation

\begin{equation*}
\left(\mathbf{x}_{b} \mid \mathbf{x}_{a}\right)_{E}=\int_{0}^{\infty} d L \int \mathcal{D} \rho \Phi[\rho] \int \frac{\mathcal{D}^{D-1} x}{\sqrt{\rho}^{D-1}} e^{-\mathcal{A}_{E} / \hbar} \tag{17}
\end{equation*}
$$

with the action

$$
\begin{equation*}
\mathcal{A}_{E}=\int_{\lambda_{a}}^{\lambda_{b}} d \lambda\left[\frac{M}{2 \rho(\lambda)} \mathbf{x}^{\prime 2}(\lambda)-\rho(\lambda) \frac{E^{2}}{2 M c^{2}}+\frac{M c^{2}}{2} \rho(\lambda)\right] . \tag{18}
\end{equation*}
$$

This is seen by writing the temporal part of the sliced $D$-dimensional action (6) in the canonical form (14). By integrating out the temporal coordinates $x_{n}^{0}$ in (15), we obtain
$N \delta$-functions. These remove $N$ integrals over the momentum variables $p_{n}^{0}$, leaving only a single integral over a common $p^{0}$. The Laplace transform (16), finally, eliminates also this integral, making $p^{4}$ equal to $-i E / c$. In the continuum limit, we thus obtain the action (18). 5) The path integral (17) forms the basis for studying relativistic particles in an external time-independent potential $V(\mathbf{x})$. This is introduced into the path integral (17) by simply substituting the energy $E$ by $E-V(\mathbf{x})$.

For an attractive Coulomb potential in $D-1=3$ spatial dimensions, the above substitution changes the second term in the action (18) to

\mathcal{A}_{\mathrm{int}}=-\int_{\lambda_{a}}^{\lambda_{b}} d \lambda \rho(\lambda) \frac{\left(E+e^{2} /|\mathbf{x}|\right)^{2}}{2 M c^{2}} \tag{19}
\end{equation*}
$$

The associated path integral is calculated with the help of a Duru-Kleinert transformation [1] as follows:

First, we increase the three-dimensional configuration space in a trivial way by a dummy forth component $x^{4}$ (as in the nonrelativistic case). The additional variable $x^{4}$ is eliminated at the end by an integral $\int d x_{a}^{4} /\left|\mathbf{x}_{a}\right|=\int d \gamma_{a}$ (see Eqs. (13.114) and (13.121) in Ref. [15]). Then we perform a Kustaanheimo-Stiefel transformation $d x^{\mu}=2 A(u)^{\mu}{ }_{\nu} d u^{\nu}$ (Eq. (13.100) in Ref. [15). This changes $x^{\prime \mu 2}$ into $4 \vec{u}^{2} \vec{u}^{\prime 2}$, with the vector symbol indicating the four-vector nature of $\vec{u}$. The transformed action reads

\tilde{\mathcal{A}}_{E}=\int_{\lambda_{a}}^{\lambda_{b}} d \lambda\left\{\frac{4 M \vec{u}^{2}}{2 \rho(\lambda)} \vec{u}^{2}(\lambda)+\frac{\rho(\lambda)}{2 M c^{2} \vec{u}^{2}}\left[\left(M^{2} c^{4}-E^{2}\right) \vec{u}^{2}-2 E e^{2}-\frac{e^{4}}{\vec{u}^{2}}\right]\right\} \tag{20}
\end{equation*}
$$

We now choose the gauge $\rho(\lambda)=1$, and go from $\lambda$ to a new parameter $s$ via the time transformation $d \lambda=f d s$ with $f=\vec{u}^{2}$. This leads to the Duru-Kleinert-transformed action

$$
\begin{equation*}
\mathcal{A}_{E}^{\mathrm{DK}}=\int_{s_{a}}^{s_{b}} d s\left\{\frac{4 M}{2} \vec{u}^{2}(s)+\frac{1}{2 M c^{2}}\left[\left(M^{2} c^{4}-E^{2}\right) \vec{u}^{2}-2 E e^{2}-\frac{e^{4}}{\vec{u}^{2}}\right]\right\} . \tag{21}
\end{equation*}
$$

It describes a particle of mass $\mu=4 M$ moving as a function of the "pseudotime" $s$ in a harmonic oscillator potential of frequency

$$
\begin{equation*}
\omega=\frac{1}{2 M c} \sqrt{M^{2} c^{4}-E^{2}} . \tag{22}
\end{equation*}
$$

The oscillator possesses an additional attractive potential $-e^{4} / 2 M c^{2} \vec{u}^{2}$ which is conveniently parametrized in the form of a centrifugal barrier

$$
\begin{equation*}
V_{\mathrm{extra}}=\hbar^{2} \frac{l_{\mathrm{extra}}^{2}}{2 \mu \overrightarrow{\mathrm{u}}^{2}}, \tag{23}
\end{equation*}
$$

whose squared angular momentum has the negative value

$$
\begin{equation*}
l_{\mathrm{extra}}^{2} \equiv-4 \alpha^{2}, \tag{24}
\end{equation*}
$$

where $\alpha$ denotes the feinstructure constant $\alpha \equiv e^{2} / \hbar c \approx 1 / 137$. In addition, there is also a trivial constant potential

$$
\begin{equation*}
V_{\text {const }}=-\frac{E}{M c^{2}} e^{2} . \tag{25}
\end{equation*}
$$

If we ignore, for a moment, the centrifugal barrier $V_{\text {extra }}$, the solution of the path integral can immediately be written down (compare Eq. (13.121) in Ref. [15])

$$
\begin{equation*}
\left(\mathbf{x}_{b} \mid \mathbf{x}_{a}\right)_{E}=-i \frac{\hbar}{2 M c} \frac{1}{16} \int_{0}^{\infty} d L e^{e^{2} E L / M c^{2} \hbar} \int_{0}^{4 \pi} d \gamma_{a}\left(\vec{u}_{b} L \mid \vec{u}_{a} 0\right) \tag{26}
\end{equation*}
$$

where $\left(\vec{u}_{b} L \mid \vec{u}_{a} 0\right)$ is the time evolution amplitude of the four-dimensional harmonic oscillator.
There are no time-slicing corrections for the same reason as in the three-dimensional case. This is ensured by the affine connection of the Kustaanheimo-Stiefel transformation satisfying

\Gamma_{\mu}{ }^{\mu \lambda}=g^{\mu \nu} e_{i}{ }^{\lambda} \partial_{\mu} e^{i}{ }_{\nu}=0 \tag{27}
\end{equation*}

(see the discussion in Section 13.6 of Ref. (15).
A $\gamma_{a}$-integration leads to

\begin{gather*}
\left(\mathbf{x}_{b} \mid \mathbf{x}_{a}\right)_{E}=-i \frac{\hbar}{2 M c} \frac{M \kappa}{\pi \hbar} \int_{0}^{1} d \varrho \frac{\varrho^{-\nu}}{(1-\varrho)^{2}} I_{0}\left(2 \kappa \frac{2 \sqrt{\varrho}}{1-\varrho} \sqrt{\left(r_{b} r_{a}+\mathbf{x}_{b} \mathbf{x}_{a}\right) / 2}\right) \\
\times \exp \left[-\kappa \frac{1+\varrho}{1-\varrho}\left(r_{b}+r_{a}\right)\right], \tag{28}
\end{gather*}
$$

with the variable

$$
\begin{equation*}
\rho \equiv e^{-2 \omega L} \tag{29}
\end{equation*}
$$

and the parameters

$$
\begin{align*}
& \nu=\frac{e^{2}}{2 \omega \hbar} \frac{E}{M c^{2}}=\frac{\alpha}{\sqrt{M^{2} c^{4} / E^{2}-1}}, \\
& \kappa=\frac{\mu \omega}{2 \hbar}=\frac{1}{\hbar c} \sqrt{M^{2} c^{4}-E^{2}}=\frac{E}{\hbar c} \frac{\alpha}{\nu} . \tag{30}
\end{align*}
$$

We now use the well-known expansion

$$
\begin{equation*}
I_{0}(z \cos (\theta / 2))=\frac{2}{z} \sum_{l=0}^{\infty}(2 l+1) P_{l}(\cos \theta) I_{2 l+1}(z) \tag{31}
\end{equation*}
$$

and obtain the partial wave decomposition

$$
\begin{align*}
\left(\mathbf{x}_{b} \mid \mathbf{x}_{a}\right)_{E} & =\frac{1}{r_{b} r_{a}} \sum_{l=0}^{\infty}\left(r_{b} \mid r_{a}\right)_{E, l} \frac{2 l+1}{4 \pi} P_{l}(\cos \theta) \\
& =\frac{1}{r_{b} r_{a}} \sum_{l=0}^{\infty}\left(r_{b} \mid r_{a}\right)_{E, l} \sum_{m=-l}^{l} Y_{l m}\left(\hat{\mathbf{x}}_{b}\right) Y_{l m}^{*}\left(\hat{\mathbf{x}}_{a}\right), \tag{32}
\end{align*}
$$

with the usual notation for Legendre polynomials and spherical harmonics. The radial amplitude is, therefore,

\begin{align*}
\left(r_{b} \mid r_{a}\right)_{E, l}= & -i \frac{\hbar}{2 M c} \sqrt{r_{b} r_{a}} \frac{2 M}{\hbar} \int_{0}^{\infty} d y \frac{1}{\sinh y} e^{2 \nu y}  \tag{33}\\
& \times \exp \left[-\kappa \operatorname{coth} y\left(r_{b}+r_{a}\right)\right] I_{2 l+1}\left(2 \kappa \sqrt{r_{b} r_{a}} \frac{1}{\sinh y}\right) .
\end{align*}
$$

At this place, the additional centrifugal barrier (23) is incorporated via the replacement

$$
\begin{equation*}
2 l+1 \rightarrow 2 \tilde{l}+1 \equiv \sqrt{(2 l+1)^{2}+l_{\mathrm{extra}}^{2}} \tag{34}
\end{equation*}
$$

(as in Eqs. (8.146) and (14.237) in Ref. 15). The integration over $y$ yields

\begin{equation*}
\left(r_{b} \mid r_{a}\right)_{E, l}=-i \frac{\hbar}{2 M c} \frac{M}{\hbar \kappa} \frac{\Gamma(-\nu+\tilde{l}+1)}{(2 \tilde{l}+1)!} W_{\nu, \tilde{l}+1 / 2}\left(2 \kappa r_{b}\right) M_{\nu, \tilde{l}+1 / 2}\left(2 \kappa r_{a}\right) \tag{35}
\end{equation*}
$$

(compare Eq. (9.52) in Ref. [15]).
This fixed-energy amplitude has poles in the Gamma function whenever $\nu-\tilde{l}-1=$ $0,1,2, \ldots$. They determine the bound-state energies of the Coulomb system. Subsequent formulas can be simplified by introducing the small positive $l$-dependent parameter

$$
\begin{equation*}
\delta_{l} \equiv l-\tilde{l}=l+1 / 2-\sqrt{(l+1 / 2)^{2}-\alpha^{2}} \approx \frac{\alpha^{2}}{2 l+1}+\mathcal{O}\left(\alpha^{4}\right) \tag{36}
\end{equation*}
$$

With it, the pole positions are given by $\nu=\tilde{n}_{l} \equiv n-\delta_{l}$, with $n=l+1, l+2, l+3, \ldots$, and the bound state energies become:

\begin{align*}
E_{n l} & = \pm M c^{2}\left[1+\frac{\alpha^{2}}{\left(n-\delta_{l}\right)^{2}}\right]^{-1 / 2} \\
& \approx \pm M c^{2}\left[1-\frac{\alpha^{2}}{2 n^{2}}-\frac{\alpha^{4}}{n^{3}}\left(\frac{1}{2 l+1}-\frac{3}{8 n}\right)+\mathcal{O}\left(\alpha^{6}\right)\right] . \tag{37}
\end{align*}
$$

Note the appearance of the plus-minus sign as a characteristic property of energies in relativistic quantum mechanics. A correct interpretation of the negative energies as positive energies of antiparticles is straightforward within quantum field theory; it will not be discussed here.

To find the wave functions, we approximate near the poles $\nu \approx \tilde{n}_{l}$ :

\Gamma(-\nu+\tilde{l}+1) & \approx-\frac{(-)^{n_{r}}}{n_{r}!} \frac{1}{\nu-\tilde{n}_{l}}, \\
\frac{1}{\nu-\tilde{n}_{l}} & \approx \frac{2}{\tilde{n}_{l}} \frac{\hbar^{2} \kappa^{2}}{2 M}\left(\frac{E}{M c^{2}}\right)^{2} \frac{2 M c^{2}}{E^{2}-E_{n l}^{2}}, \\
\kappa & \approx \frac{E}{M c^{2}} \frac{1}{a_{H}} \frac{1}{\tilde{n}_{l}}, \tag{38}
\end{align*}
$$

with the radial quantum number $n_{r}=n-l-1$. In analogy with a corresponding nonrelativistic equation (Eq. (13.203) in Ref. [15]), the last equation can be rewritten as

\begin{equation*}
\kappa=\frac{1}{\tilde{a}_{H}} \frac{1}{\nu}, \tag{39}
\end{equation*}
$$

where

$$
\begin{equation*}
\tilde{a}_{H} \equiv a_{H} \frac{M c^{2}}{E} \tag{40}
\end{equation*}
$$

denotes a modified energy-dependent Bohr radius. Instead of being $1 / \alpha \approx 137$ times the Compton wave length of the electron $\hbar / M c$, the modified Bohr radius which sets the length scale of relativistic bound states involves the energy $E$ instead of the rest energy $M c^{2}$.

With the above parameters, the positive-energy poles in the Gamma function can be written as

-i \Gamma(-\nu+\tilde{l}+1) \frac{M}{\hbar \kappa} \approx \frac{(-)^{n_{r}}}{\tilde{n}_{l}^{2} n_{r}!} \frac{1}{\tilde{a}_{H}}\left(\frac{E}{M c^{2}}\right)^{2} \frac{2 M c^{2} i \hbar}{E^{2}-E_{n l}^{2}} \tag{41}
\end{equation*}
$$

Using this behavior and a property of the Whittaker functions (see Eq. (9.73) in Ref. (15]), we write the contribution of the bound states to the spectral representation of the fixed-energy amplitude as

\left(r_{b} \mid r_{a}\right)_{E, l}=\frac{\hbar}{M c} \sum_{n=l+1}^{\infty}\left(\frac{E}{M c^{2}}\right)^{2} \frac{2 M c^{2} i \hbar}{E^{2}-E_{n l}^{2}} R_{n l}\left(r_{b}\right) R_{n l}\left(r_{a}\right)+\ldots \tag{42}
\end{equation*}
$$

A comparison between the pole terms in (35) and (42) renders the radial wave functions

$$
\begin{align*}
R_{n l}(r)= & \frac{1}{\tilde{a}_{H}^{1 / 2} \tilde{n}_{l}} \frac{1}{(2 \tilde{l}+1)!} \sqrt{\frac{\left(\tilde{n}_{l}+\tilde{l}\right)!}{(n-l-1)!}} \\
& \times\left(2 r / \tilde{n}_{l} \tilde{a}_{H}\right)^{\tilde{l}+1} e^{-r / \tilde{n}_{l} \tilde{a}_{H}} M\left(-n+l+1,2 \tilde{l}+2,2 r / \tilde{n}_{l} \tilde{a}_{H}\right)  \tag{43}\\
= & \frac{1}{\tilde{a}_{H}^{1 / 2} \tilde{n}_{l}} \sqrt{\frac{(n-l-1)!}{(\tilde{n}+\tilde{l})!} e^{-r / \tilde{n} \tilde{a}_{H}}\left(2 r / \tilde{n}_{l} \tilde{a}_{H}\right)^{\tilde{\tilde{l}}+1} L_{\tilde{n}_{l}-l-1}^{2 \tilde{+}+1}\left(2 r / \tilde{n}_{l} \tilde{a}_{H}\right) .}
\end{align*}
$$

The properly normalized total wave functions are

$$
\begin{equation*}
\psi_{n l m}(\mathbf{x})=\frac{1}{r} R_{n l}(r) Y_{l m}(\hat{\mathbf{x}}) . \tag{44}
\end{equation*}
$$

The continuous wave functions are obtained in the same way as in the non-relativistic case (see Eqs. (13.211)-(13.219) in Ref. [15]).

This concludes the solution of the path integral of the relativistic Coulomb system.
