# M esonic Spectra of B osonized QCD 2 M odels

#### Abstract

W e discussbosonized two-dim ensionall C D w ith $m$ assless ferm ions in the adjoint and $m$ ulti- avor fundam ental representations. W e evaluate the $m$ assive $m$ eson ic spectra of several $m$ odels by using the lightfront quantization and diagonalizing them ass operator $M^{2}=2 P^{+} P$. w e recover previous results in the case of one avor adjoint ferm ions and we nd the exact massive spectrum of multi avor QCD in the lim it of large num ber of avors.

## 1 Introduction

QCD in two space-tim e dim ensions ( $\mathrm{QCD}_{2}$ ) is believed to be a usefiul laboratory to exam ine ideas about the hadronic physics of the real world. O ne such an idea, the expansion in large number of colors $N_{c}$, was applied in the pioneering work of 't H ooft [ilili]. A mesonic spectnum of a \R egge trajectory" type w as discovered in that work for Q C D 2 w ith D irac ferm ions in the fundam ental representation. The large $\mathrm{N}_{\mathrm{c}} \lim$ it is taken while keeping $\mathrm{e}^{2} \mathrm{~N}_{\mathrm{c}}$ xed, where e is the gauge coupling. T he lorthogonal" approach, the strong coupling lim it, was also found to be a fruitfultechnique when com bined w ith bosonizing the system. In that fram ew ork the low energy e ective action of the theory can be derived exactly. Q uantization of soliton solutions of that e ective theory led to the low lying sem i-classical baryonic spectnum [i-1].

The large $\mathrm{N}_{\mathrm{c}}$ approach com bined w th a light-front quantization w as applied to the study of $\mathrm{QCD}_{2} \mathrm{w}$ th M ajorana ferm ions in the adjoint representation. Unlike the case of fundam ental ferm ions, for adjoint ferm ions pair creation is not suppressed in the large $N_{c}$ lim it. The bosonic spectrum includes an in nite num ber of approxim ately linear $R$ egge tra jectories which are associated w ith an exponential grow ing density of states at high-
 sense that the physics of $m$ assive states depends only on the gauge group and the a ne Lie algebra levelbut not on the representation of the group [101].

In the present paper we com bine the bosonization technique $w$ ith that of a large $N$ expansion and a light-front quantization in the analysis of the $m$ assive $m$ esonic spectrum of several Q CD 2 m odels. T he $m$ assless sector which was discussed in ref. $\overline{\underline{T}}]$ is not addressed in the present work. The models include $m$ assless ferm ions in the adjoint representation and $m$ ulti avor fundam ental representations. In the form er case we expand in $N_{c}$ the number of colors w hereas in the latter case we consider large $N_{f}$ number of avors. In case ofm assless ferm ions the bosonization form alism is convenient since it separates the color, avor and baryon num ber degrees of freedom [ढ్1]. M oreover the generalization from ferm ions coupled to YM elds to an arbitrary gauged a ne Lie algebra system is natural in the bosonized picture. The basic di erence betw een our approach and the one taken in refs. [אָ| use of current quanta rather then those of quarks in constructing the $m$ ass operator $M^{2}$ and thus also the wave equation and the $H$ ilbert space. O ur results are in agreem ent w ith the results of refs. $\left[\begin{array}{l}3 \\ \hline 1\end{array}, 1\right.$
ferm ions. In the large $N_{f}$ it is show $n$ that the exact $m$ assive spectrum is a single particle w th $M^{2}=\frac{e^{2} N_{f}}{}$. This phenom enon is explained by the fact that this lim it can be viewed as an \abelianization" of the $m$ odel.

The paper is organized as follow. In section 2 we present the m odels. $T$ he actions are w ritten down in their bosonized versions. $W$ e then derive explicit expressions for the m om entum operators and the m ass operator. The a ne Lie algebra currents are expanded in term $s$ of annihilation and creation operators w ith which a Fock space of physical states is buill. In section 3 the m odel w th adjoint ferm ions is analyzed in the large $\mathrm{N}_{\mathrm{c}} \mathrm{lim}$ it. W e introduce wave functions and write down an eigenvalue equation which generalizes 't Hooft equation tili]. The $m$ assive $m$ esonic spectrum was then deduced. In section 4 we nd that the exact spectrum ofmulti- avor QCD $w$ th fundam ental ferm ions in the regim e of $N_{f} \quad N_{C}$ include only one single $m$ esonic state. $W$ e discuss the relation of this spectrum to that of multiavor QED. The case of large levelW Z W m odels is also considered. Som e conclusions and certain open problem s are discussed in section 5.

## 2 The M odels

C onsider two dim ensionalSU ( $\mathbb{N}_{c}$ ) Yang -M ills gauge elds coupled to (i) $\mathrm{N}_{\mathrm{f}}$ $m$ assless $D$ irac ferm ions in the findam ental representation, or (ii) $m$ assless M ajorana ferm ions in the adjoint representation. These theories are described by the follow ing classical Lagrangian:

In both cases is a two spinor param etrized as follows $=$.

It is useful to handle these $m$ odels in the fram ew ork of the light-front quantization, nam ely, to use light-cone space-tim e coordinates and to choose the chiral gauge $A=0$. In this schem e the quantum Lagrangian takes the

where color and avor indices w ere om itted and $\mathrm{J}^{+}$denotes the + com ponent of the color current $J^{+}{ }^{Y}$.

By choosing $\mathrm{x}^{+}$to be the tim $\mathrm{e}^{\prime}$ coordinate it is clear that $\mathrm{A}_{+}$and are non-dynam ical degrees of freedom. In fact, are decoupled from the other elds so in order to extract the physics of the dynam ical degree of freedom one has to functionally integrate over $A_{+}$. The result of this integration is the follow ing sim pli ed Lagrangian

Since ourbasic idea is to solve the system in term s of the \quanta" of the colored currents, it is natural to introduce bosonization descriptions of the various m odels.
(i) The bosonized action of colored avored D irac ferm ions in the fiunda$m$ ental representation is expressed in term s of a W ZW [īin action of a group elem ent u $2 U\left(\mathbb{N}_{c} \quad N_{f}\right)$ w th an additionalm ass term that couples the color, avor and baryon num ber sectors [īi]. In the $m$ assless case when the latter term is $m$ issing the action takes the follow ing form

(ii) The current structure of free M a jorana ferm ions in the adjoint representation can be recast in term sof a WW action of levelk $=\mathrm{N}_{\mathrm{c}}$, nam ely, $S_{0}^{\text {adj }}=S_{(\mathbb{N} c)}^{W} z_{c}{ }^{W}(g)$ where now $g$ is in the adjoint representation of $S U\left(\mathbb{N}{ }_{c}\right)$, so that it carries a conform aldim ensions of $\frac{1}{2}[\underset{-1}{-1}]$.

M ulti- avor adjoint ferm ions can be described as $S_{N_{f}}^{W} Z^{W}(g)+S_{N_{c}^{2}}^{W} Z_{1}^{W}(h)$ where $\mathrm{g} 2 \mathrm{SO}\left(\mathbb{N}_{\mathrm{c}}^{2} \quad 1\right)$ and h $2 \mathrm{SO}\left(\mathbb{N}_{\mathrm{f}}\right)$. In the present work we discuiss only gauging of $S U\left(\mathbb{N}_{\mathrm{c}}\right) \mathrm{W}$ ZW so the latter $m$ odelw ould not be considered.

Substituting now $S_{0}^{\text {fun }}$ or $S_{0}^{\text {adj }}$ for $S_{0}$ the action that corresponds to ( $\left(\frac{1}{-1}\right)$ is given by

where the current $J^{+}$now reads $J^{+}=i \frac{k}{2} g @ g^{y}$, where the levelk $=N_{f}$ and $\mathrm{k}=\mathrm{N}_{\mathrm{c}}$ for the m ulti- avor fundam ental and adjoint cases respectively.

The light-front quantization schem e is very convenient because the corresponding $m$ om enta generators $P^{+}$and $P$ can be expressed only in term s of $\mathrm{J}^{+}$. W e would like to em phasize that this holds only for the $m$ assless case.

U sing the Sugaw ara construction, the contribution of the colored currents to the m om entum operator, $\mathrm{P}^{+}$, takes the follow ing sim ple form :

where $J^{P}-{ }_{J^{+}}, N_{C}$ in the denom inator is the second $C$ asim ir operator of the adjoint representation and the level $k$ takes the values $m$ entioned above. $N$ ote that for future purposes we have added the color indioes $i_{i} j=1::: N_{C}$ to the currents. In the absence of the interaction w th the gauge elds the second m om entum operator, P vanishes. For the various $\mathrm{QCD}_{2} \mathrm{~m}$ odels it is given by

In order to nd the m assive spectrum of the $m$ odelwe should diagonalize them ass operator $M^{2}=2 P^{+} P$. O urtask is therefore to solve the eigenvalue equation

$W$ ewrite $P^{+}$and $P$ in term of the Fourier transform of $J(x)$ de ned by $J\left(p^{+}\right)=\frac{p x}{2} e^{i p^{+} x} J(x)$. Norm al ordering in the expression of $P^{+}$and P are naturally $w$ th respect to p , where $\mathrm{p}<0$ denotes a creation operator. To sim plify the notation we w rite from here on $p$ instead of $p^{+}$. In term s of these variables the $m$ om enta generators are

D iagonalizing M ${ }^{2}$, is in general, a com plicated task, hence wew illexam ine in detail som e special cases of the theory.

## 3 Large $\mathrm{N}_{\mathrm{c}}$ A djoint Ferm ions

The rst case we analyze is $\mathrm{CD}_{2} \mathrm{w}$ ith ferm ions in the adjoint representation.
 that its $m$ assive spectrum is the sam e as the $m$ odelof $N_{f}=N_{c}$ fundam ental quarks.

Since an exact solution of the $m$ odel is beyond our reach we em ploy a large $\mathrm{N}=\mathrm{N}_{\mathrm{c}}$ approxim ation where some simpli cations occur. A s stated above the $\mathrm{N}_{\mathrm{c}}=\mathrm{N}$ is also the corresponding level of the m odel. F irst, we w rite dow n the general sym m etric singlet states:

H ere ${ }_{n}$; $n$ are the Schrodinger wave functions, and the sum $m$ ation over is, as explained below, over the cyclic group $Z_{n}$. The di erence between the tw o states is that in $j$ i the currents act on the identity vacuum, whereas in $j i^{0}$ the currents act on the adjoint vacuum. The latter is a state that transform s in the adjoint representation ofSU $(\mathbb{N})$ and obeys $J$ ( $p$ ) $\ddagger 0 i_{j}^{i}=0$ for allp>0.The tw o states form tw o distinct equivalence classes, in a sense that one state can not be related to another one by acting $w$ th an operator which is built from a nite num ber of current operators. In principle, other vacuum representations are allowed, but is was proven 还] that in the large $N$ lim it it is su cient to consider only the identity vacuum and the adjoint vacuum. $O$ ther representations lead to m ulti particle states which are suppressed in the large $N \lim$ it. $N$ ote that $M^{2} j 0 i=0$, but $M^{2} j 0 i_{j}^{i}=m_{0}^{2} j 0 i_{j}^{i} \in 0$. The reason is that the zero $m$ ode of the current $J_{j}^{i}(0)$ does not annihilate the
 the second C asm ir of the adjoint representation. Thus $M^{2} j 0 i_{j}^{i}=2 P^{+} P \quad j$ $0 i_{j}^{i}=2 \quad \frac{1}{2 N} \quad N \quad \frac{e^{2}}{2} \quad N \quad j 0 \frac{i}{j}=\frac{e^{2} N}{2}-j i_{j}^{i}$. In the m ore fam iliar C F T term inology this relation translates into $\left.\mathbb{L} ; J_{n}\right]=$ $n J . T$ he calculation of the com $m$ utator $\left.\mathbb{P} ; J_{j_{2}}^{j_{1}}(\mathrm{p})\right]$ is $m$ ore com plicated. In the procedure of evaluating the spectrum we nd the eigen wave-finnction by solving an integralequation that generally mixes $n$ (or $n$ ) with di erent $n$ 's, nam ely, it $m$ ixes the num ber of currents. Since the general equation is highly non-trivialwe w illuse an approxim ation in which we take into account only singular term $s$ and term $s$ w ith the sam e num ber of current operators. Those tem s have the dom inant contribution to the wave equation [3్1-1]. A detailed calculation of the com m utators which includes all the term $s$ is w ritten in the A ppendix. H ere we w rite only the m ost signi cant term of the com m utator

The above term includes an annihilation operator $J$ ( $p$ ), which has non-zero contribution $w$ hen it com $m$ utes $w$ ith another creation operator, say $J(\hat{P})$. A non-negligible comm utator occurs only $w$ ith a heighbor' of $J_{j_{2}}^{j_{1}}(\mathrm{P})$, nam ely, a commutator with a current whidh carries the same group indices. O ther com $m$ utators are suppressed by factors of $\frac{1}{N}$. A tedious though straightforw ard calculation yields

were bther term $s^{\prime}$ are either term $s$ that are suppressed in large $N$, or term $s$ that change the num ber ofcurrents. W e com $m$ ent on the validity ofdropping the latter term s in section 5. T he result of the last tw o com m utators is that if one starts $w$ ith two currents $J\left(Q_{1}\right)$ and $J\left(\beta_{2}\right)$ he ends $w$ th two other currents which are multiplied by singular denom inators. This result leads to the follow ing eigenvalue equation

This expression of the eigenvalues indicates an exponential grow th of the num ber of states, in accordance w ith previous results [i了]. There is, how ever, a slight di erence between our results and those of ref. $\mathrm{B}_{\mathrm{i}}^{\mathrm{l}} \mathrm{I}$. W e found that the values of the integers $m$ ust be odd whereas in $K$ utasov's paper, they are even. The source of this di erence is the sym $m$ etric boundary conditions that we have used (1ī2).

The spectrum contains tw o blocks. The identity-block has integer dim ension and hence can be interpreted as the boson-block, whereas the adjointblock has half integer dim ension and thus $w i l l$ be referred as the ferm ionblock. W e have seen that the tw o blocks have sim ilar structure since the tw o sectors obey the same wave function equation. Furthem ore, m ixture betw een the two sectors is avoided due to the fact that the ham iltonian creates and destroys even num bers of \quarks".

The\quark" content of the spectrum is determ ined by the relation between the currents and the quarks. This relation is given by

and can be thought of as a m ixture of $2 n ; 2 n \quad 2 ;::: ; 2$ quarks. In a sim ilar way, a state in the ferm ion $-b l o c k$ is a $m$ ixture of $2 n+1 ; 2 n \quad 1 ;::: ; 3$ quarks.

## 4 Large $\mathrm{N}_{\mathrm{f}}$ Q CD

M assless $Q C D_{2}$ w ith $\mathrm{N}_{\mathrm{f}}$ avors of quarks in the fundam ental representation is described by the Lagrangian of $\left(\frac{\overline{4}}{\mathbf{4}}\right)$. Setting aside the avor and baryon num ber sectors, the left over system is that of a $k=N_{f} \operatorname{levelSU}\left(\mathbb{N}_{c}\right)$ W ZW action with an additional non-local interaction term . W e are thus led to analyze the spectrum of the $m$ odelw th levelequalto $\mathrm{N}_{\mathrm{f}}$. In practicalterm s the latter $m$ eans substituting $k$ by $N_{f}$ in the expression for $P^{+}$eqn. ( $(\underline{9})$ and in the A ne Lie algebra eqn. ( 1

The idea is to invoke a large $\mathrm{N}_{\mathrm{f}}$ approxim ation, nam ely, to considerm odels in which $k=N_{f} \quad N_{c}$. M odels w ith num ber of colors and avors which fall into this regim $e$, are signi cantly sim pler than $m$ odels that don't obey this inequality. The basic reason for that is the sim pli cation of the algebra eqn. ( $10 \overline{1} \bar{\prime}$ ). The com mutator of $P$ with $J$ in the large $N_{f}$ lim it takes the form

U pon neglecting the second term which is suppressed by a factor of $\frac{1}{\overline{\mathrm{~N}}_{f}}$ we get the follow ing solution to the eigenvalue problem

N otioe that the current operator acts on the adjoint vacuum and not on the identity vacuum. The reason for that is obviously the requirem ent that
states have to be color singlets. $j 0 i_{i b}^{j a}$ stands for $j 0 i_{i}^{j} \quad j 0{ }_{i}^{i}$, nam ely, the tensor product of the color adjoint vacuum and its avor countenpart. Recall that follow ing eqn. ( $\overline{4}$ ) ) the vacuum state is an outer product of the vacua of the three independent H ibert-spaces of the color, avor and baryon num ber sectors. This \decoupling" of these spaces of states is an artifact of the m assless lim it of the bosonized picture. It is further discussed in section 5.

The above state is the only one-particle state of the theory. All other $m$ assive state are $m$ ultiparticle state which are built from this ' $m$ eson'.

The content of massless multi- avor QCD 2 in the large $N_{f} \lim$ it is thus very sim ple and is in fact closely related to $m$ ulti- avorm assless Q ED 10111$].$ In the latter case $m$ odel the spectrum of single particles contains the follow ing single state

The reason of this sim ilarity is very clear. $N$ eglecting the $O\left(\mathbb{N}_{f}{ }^{\frac{1}{2}}\right)$ term in eqn. (2-14) corresponds to dropping the structure constant term in the A neLie algebra. In other words, in this lim it we perform an Abelianization of the theory.

H ow ever, one $m$ ay identify a di erence in the substructure of the two $m$ esons. The A belian $m$ eson is built up from tw o quarks since current quanta is $m$ ade out oftw o quarks, whereas the non A belian $m$ eson is a $m$ ore com plex ob ject. T he di erence can be seen by writing the state explicitly in term s of quarks operators. The (traceless) current is w ritten as:

nam ely, a color singlet which is a m ixture of four quarks and tw o quarks.
The basic feature used in this section has been the fact that $\mathrm{k} \quad \mathrm{N}_{\mathrm{C}}$. This holds, in fact, not only for large num ber of findam ental representations but obviously also for any large level gauged W ZW SU (N) m odel.

## 5 sum m ary

In this work we have calculated the $m$ esonic spectra of severalQ C D 2 m odels by em ploying bosonization, light-front quantization and expansion in large num ber of colors or avors.

Them ain results of the work are
a) A $n$ approxim ated spectrum of the \adjoint ferm ions" model.
b) The exact leading order in $\frac{1}{\mathrm{~N}_{\mathrm{f}}}$ spectra of m ulti- avor fundam ental representation.

A sfor (a), our approxim ation is sim ilar to the one used in the ferm ionic picture []. $]$, nam ely, dropping the term $s$ that $m$ ix wave-functions w ith different num ber of current creation operators. The physical $m$ eaning of such approxim ation is suppressing pair creation and pair annihilation. This approxim ation is not quite justi ed, but it gives us hint about the structure of the spectrum. O bviously, the $m$ ost urgent task in this direction is to look for $m$ ethods to solve the fullwave equation.
$T$ he second result states that the spectrum of the large $N_{f}$ fundam ental ferm ions is built out of a single $m$ assive particle w ith $M^{2} \quad e^{2} N_{f}$. For com parison see ref. $[1 \overline{2} \overline{2}]$ w were an analysis of sim ilar cases is discussed in the H am iltonian form alism. In fact, it is a universal behavior of any gauged SU (N)W ZW modelwith k N.

The interesting question that naturally arise is what happens in the interm ediate region, where k N. This region can be realized for instance, in the case ofm ulti- avor Q CD ${ }_{2}$ w th $N_{f} \quad N_{c}$. It is reasonable to expect that the $m$ esonic spectrum in this region $w$ ill lie betw een that of a single $m$ assive state and that w th an exponential density grow th. In the absence of exact analyticalm ethods one $m$ ay have to invoke num erical diagonalization of the bosonized $M^{2}$ operator in a sim ilar way to that of the ferm ionic picture $[\overline{4}]$.

For the analysis of the baryonic spectrum in the bosonization approach it is essential to consider the case of $m$ assive quarkstē]. This $m$ aybe also the case for the $m$ esonic spectrum since the $m$ ass term couples the colored,
avored and baryon num ber sectors. In fact, even for the $m$ assless case a better strategy is to solve the $m$ assive case and then go to the $m$ assless lim it. The extraction of the $m$ esonic spectrum in the $m$ assive case is $m u c h ~ m o r e$ evolved since the $m$ ass term can not be w ritten in a sim ple fashion in term $s$ of the currents. H ow ever, one can system atically expand the $m$ ass term in powers of $\frac{m_{q}}{e}$ where $m_{q}$ is the quark $m$ ass. Solving the wave equations in the presence of these $m$ assive perturbation deserves a further fiuture study.

Recently, the theories of $Y M_{2}$ and QCD 2 were analyzed as \perturbed" topological coset m odels [i] 3 in. The spectrum in that approach which was deduced using a BRST procedure includes a peculiar m assive state which was not detected in other approaches including the present. This discrepancy $m$ aybe related to the di erent approxim ation used in that approach. C learing up this point as well as the im plem entation of that $m$ ethod to the case of adjoint ferm ions and other possible generalization deserves a further investigation. O ther $m$ ethods inherited from string theory and conform al eld theory can be also be applied to the analysis of the $m$ odels discussed [1]

QCD 2 m odels can be generalized to a m uch richer class of theories which are also gauge invariant and renorm alizabletisin]. The fram ew ork of this generalization is the form ulation of the $Y M_{2}$ functional integral in term $s$ of an action which is linear in F and includes an additionalauxiliary pseudoscalalr eld. O rdinary QCD 2 has a quadratic tem in the latter eld while taking any arbitrary function $f$ of this auxiliary eld spans the space of generalized m odels. The analysis presented in the present paper can be applied also to those $m$ odels. The $m$ om entum operator $P$ rather then being quadratic in $\frac{1}{@} J$ it $w$ ill take the general form off ( $\left.\frac{1}{e} \mathrm{~J}\right)$. It $w$ illlbe interesting to com pare the outcom e of the $m$ ethods used in the current work to those derived in ref.

The rst one $\frac{k}{2 p} J(\mathrm{p}$ ), does not change the number of currents (it has only one current) and it is proportional to the levelk. It will play a central role in the large k lim it.

The second term is sim ilar to the rst one, but it is proportional to N and it diverges. The divergent part w illbe com pensated by another divergent term (which arises from the fourth term).

The third term include two creation currents. Thus the interaction $P$, w th the help of the algebra created a current. In our discussion we will ignore this part, for the sake of sim plicity.

The last term includes annihilation currents, and therefore we should evaluate its com $m$ utator $w$ ith other creation current.
