# M esonic Spectra of B osonized Q C D $_2$ M odels

#### Abstract

W ediscuss bosonized two-dimensionalQCD with massless fermions in the adjoint and multi- avor fundamental representations. We evaluate the massive mesonic spectra of several models by using the light-front quantization and diagonalizing the mass operator M<sup>2</sup> = 2P<sup>+</sup>P<sup>-</sup>. We recover previous results in the case of one avor adjoint fermions and we not the exact massive spectrum of multi-avor QCD in the limit of large number of avors.

### 1 Introduction

QCD in two space-time dimensions (QCD<sub>2</sub>) is believed to be a useful laboratory to exam ine ideas about the hadronic physics of the real world. One such an idea, the expansion in large number of colors N<sub>c</sub>, was applied in the pioneering work of 't Hooff [1]. A mesonic spectrum of a \Regge trajectory" type was discovered in that work for QCD<sub>2</sub> with D irac ferm ions in the fundam ental representation. The large N<sub>c</sub> limit is taken while keeping e<sup>2</sup>N<sub>c</sub> xed, where e is the gauge coupling. The \orthogonal" approach, the strong coupling limit, was also found to be a fruitful technique when combined with bosonizing the system. In that fram ework the low energy e ective action of the theory can be derived exactly. Quantization of soliton solutions of that e ective theory led to the low lying sem i-classical baryonic spectrum [2].

The large N<sub>c</sub> approach combined with a light-front quantization was applied to the study of QCD<sub>2</sub> with M a prana ferm ions in the adjoint representation. Unlike the case of fundamental ferm ions, for adjoint ferm ions pair creation is not suppressed in the large N<sub>c</sub> limit. The bosonic spectrum includes an in nite number of approximately linear Regge trajectories which are associated with an exponential growing density of states at high-energy [3, 4]. Recently, a \universality" behavior of QCD<sub>2</sub> was found in the sense that the physics of massive states depends only on the gauge group and the a ne Lie algebra level but not on the representation of the group [5].

In the present paper we combine the bosonization technique with that of a large N expansion and a light-front quantization in the analysis of the m assive m esonic spectrum of several QCD<sub>2</sub> m odels. The m assless sector which was discussed in ref.[5] is not addressed in the present work. The models include massless ferm ions in the adjoint representation and multi avor fundam ental representations. In the form er case we expand in N  $_{
m c}$ the num ber of colors whereas in the latter case we consider large N f number of avors. In case of massless fermions the bosonization formalism is convenient since it separates the color, avor and baryon number degrees of freedom [6]. M oreover the generalization from fermions coupled to YM elds to an arbitrary gauged a ne Lie algebra system is natural in the bosonized picture. The basic di erence between our approach and the one taken in refs. [3, 4] is the use of current quanta rather then those of quarks in constructing the mass operator M $^2$  and thus also the wave equation and the H ibert space. Our results are in agreement with the results of refs.[3, 4] for the case of adjoint

ferm ions. In the large N<sub>f</sub> it is shown that the exact massive spectrum is a single particle with M<sup>2</sup> =  $\frac{e^{2}N_{f}}{m}$ . This phenomenon is explained by the fact that this limit can be viewed as an \abelianization" of the model.

The paper is organized as follows. In section 2 we present the models. The actions are written down in their bosonized versions. We then derive explicit expressions for the momentum operators and the mass operator. The a ne Lie algebra currents are expanded in terms of annihilation and creation operators with which a Fock space of physical states is built. In section 3 the model with adjoint fermions is analyzed in the large N<sub>c</sub> limit. We introduce wave functions and write down an eigenvalue equation which generalizes 't Hooff equation [1]. The massive mesonic spectrum was then deduced. In section 4 we nd that the exact spectrum of multi- avor QCD with fundamental fermions in the regime of N<sub>f</sub> N<sub>c</sub> include only one single mesonic state. We discuss the relation of this spectrum to that of multi-avor QED. The case of large level W Z W models is also considered. Some conclusions and certain open problems are discussed in section 5.

## 2 The Models

Consider two dimensional SU (N<sub>c</sub>) Yang-M ills gauge elds coupled to (i) N<sub>f</sub> massless D irac ferm ions in the fundamental representation, or (ii) massless M ajorana ferm ions in the adjoint representation. These theories are described by the following classical Lagrangian:

In both cases is a two spinor parametrized as follows = .

It is useful to handle these models in the framework of the light-front quantization, namely, to use light-cone space-time coordinates and to choose the chiral gauge A = 0. In this scheme the quantum Lagrangian takes the

form

where color and avor indices were on itted and  $J^+$  denotes the + component of the color current  $J^+$   $^{\rm Y}$  .

By choosing  $x^+$  to be the 'time' coordinate it is clear that  $A_+$  and are non-dynam ical degrees of freedom. In fact, are decoupled from the other elds so in order to extract the physics of the dynam ical degree of freedom one has to functionally integrate over  $A_+$ . The result of this integration is the follow ing simpli ed Lagrangian

Since our basic idea is to solve the system in term s of the \quanta" of the colored currents, it is natural to introduce bosonization descriptions of the various m odels.

(i) The bosonized action of colored avored D irac ferm ions in the fundam ental representation is expressed in terms of a W ZW [7] action of a group element u 2 U (N<sub>c</sub> N<sub>f</sub>) with an additional mass term that couples the color, avor and baryon number sectors[8]. In the massless case when the latter term is missing the action takes the following form

where g 2 SU (N<sub>c</sub>); h 2 SU (N<sub>f</sub>) and e  $\frac{q}{\frac{4}{N_cN_f}}$  2 U<sub>B</sub> (1) with U<sub>B</sub> (1) denoting the baryon number symmetry and

(ii) The current structure of free M a prana ferm ions in the adjoint representation can be recast in terms of a W ZW action of level  $k = N_c$ , namely,  $S_0^{adj} = S_{(N_c)}^{WZW}$  (g) where now g is in the adjoint representation of SU ( $N_c$ ), so that it carries a conform aldimensions of  $\frac{1}{2}$  [9].

Multi-avor adjoint ferm ions can be described as  $S_{N_f}^{WZW}(g) + S_{N_c^2 1}^{WZW}(h)$  where  $g 2 \text{ SO} (N_c^2 1)$  and  $h 2 \text{ SO} (N_f)$ . In the present work we discuss only gauging of SU (N<sub>c</sub>) WZW so the latter model would not be considered.

Substituting now  $S_0^{fun}$  or  $S_0^{adj}$  for  $S_0$  the action that corresponds to (3) is given by

where the current  $J^+$  now reads  $J^+ = i\frac{k}{2}g@g^y$ , where the level  $k = N_f$  and  $k = N_c$  for the multi- avor fundam ental and adjoint cases respectively.

The light-front quantization scheme is very convenient because the corresponding momenta generators  $P^+$  and  $P^-$  can be expressed only in terms of  $J^+$ . We would like to emphasize that this holds only for the massless case.

U sing the Sugawara construction, the contribution of the colored currents to the momentum operator,  $P^+$ , takes the following simple form :

where J  $^{p}$   $^{-}$  J<sup>+</sup>, N<sub>c</sub> in the denom inator is the second C asim ir operator of the adjoint representation and the level k takes the values mentioned above. Note that for future purposes we have added the color indices i; j = 1 ::: N<sub>c</sub> to the currents. In the absence of the interaction with the gauge elds the second momentum operator, P vanishes. For the various QCD<sub>2</sub> models it is given by

In order to nd the massive spectrum of the model we should diagonalize the mass operator M  $^2$  = 2P  $^+$  P  $\,$  . O untask is therefore to solve the eigenvalue equation

We write P<sup>+</sup> and P in term of the Fourier transform of J(x) dened by  $J(p^+) = \frac{P}{\frac{dx}{2}}e^{\frac{ip^+x}{2}} J(x)$ . Normal ordering in the expression of P<sup>+</sup> and P are naturally with respect to p, where p < 0 denotes a creation operator. To simplify the notation we write from here on p instead of p<sup>+</sup>. In terms of these variables the momenta generators are

D is gonalizing M  $^2$ , is in general, a complicated task, hence we will exam ine in detail some special cases of the theory.

# 3 Large N<sub>c</sub> Adjoint Ferm ions

The rst case we analyze is QCD  $_2$  with fermions in the adjoint representation. This model was investigated in the past [3] [4] and recently it was shown [5] that its massive spectrum is the same as the model of N  $_f = N_c$  fundamental quarks.

Since an exact solution of the model is beyond our reach we employ a large N = N<sub>c</sub> approximation where some simplications occur. As stated above the N<sub>c</sub> = N is also the corresponding level of the model. First, we write down the general symmetric singlet states:

Here  $_{n}$ ;  $_{n}$  are the Schrödinger wave functions, and the sum m ation over is, as explained below , over the cyclic group  ${\rm Z}_n$  . The di erence between the two states is that in j i the currents act on the identity vacuum, whereas in j i<sup>0</sup> the currents act on the adjoint vacuum . The latter is a state that transform s in the adjoint representation of SU (N) and obeys J (p)  $\hat{J}_{i}^{i} = 0$  for allp > 0. The two states form two distinct equivalence classes, in a sense that one state can not be related to another one by acting with an operator which is built from a nite number of current operators. In principle, other vacuum representations are allowed, but is was proven [5] that in the large N limit it is su cient to consider only the identity vacuum and the adjoint vacuum. O ther representations lead to multi particle states which are suppressed in the large N limit. Note that M<sup>2</sup> jDi = 0, but M<sup>2</sup>  $jDi_j^i = m_0^2 jDi_j^i \in 0$ . The reason is that the zero mode of the current  $J_j^i(0)$  does not annihilate the adjoint vacuum and actually  $J_1^k(0)J_k^1(0) j0i_j^i = N j0i_j^i[10]$ . The factor N is the second Casim ir of the adjoint representation. Thus  $M^2 Ji_1^i = 2P^+P_- j$  $0i_j^i = 2 \frac{1}{2N}$  N  $\frac{e^2}{2}$  N  $Di_j^i = \frac{e^2N}{2} Di_j^i$ . This non-zero value of  $m_0^2$  will lead to m ass splitting between eigenvalues of j i and j  $i^0$ .

nJ. The calculation of the commutator  $\mathbb{P}$  ; $J_{j_2}^{j_1}$  ( p)] is more complicated. In the procedure of evaluating the spectrum we nd the eigen wave-function by solving an integral equation that generally mixes  $_n$  (or  $_n$ ) with di erent n's, namely, it mixes the number of currents. Since the general equation is highly non-trivial we will use an approximation in which we take into account only singular terms and terms with the same number of current operators. Those terms have the dominant contribution to the wave equation [3]. A detailed calculation of the commutators which includes all the terms is written in the Appendix. Here we write only the most signi cant term of the commutator

The above term includes an annihilation operator J (p), which has non-zero contribution when it commutes with another creation operator, say J ( $p^0$ ). A non-negligible commutator occurs only with a heighbor' of  $J_{j_2}^{j_1}$  ( $p_1$ ), namely, a commutator with a current which carries the same group indices. O ther commutators are suppressed by factors of  $\frac{1}{N}$ . A tedious though straightforward calculation yields

were behavior term s' are either term s that are suppressed in large N, or term s that change the num ber of currents. We comment on the validity of dropping the latter term s in section 5. The result of the last two commutators is that if one starts with two currents J(p) and J(p) he ends with two other currents which are multiplied by singular denom inators. This result leads to the follow ing eigenvalue equation

This is a generalization of 'tH coff's equation. O byiously, the same equation holds also for  $_{\rm n}$  .

Equation (19) can be solved analytically with the boundary conditions (12) and (13). The simplest solution is for  $_2$ :

The general solution for  $_{2n}$  is quite involved but the eigenvalues are rather simple:

The result for the j  $i^0$  sector is sim ilar, with the sm all  $m_0^2$  di erence:

This expression of the eigenvalues indicates an exponential growth of the number of states, in accordance with previous results [3]. There is, however, a slight di erence between our results and those of ref.[3]. We found that the values of the integers must be odd whereas in K utasov's paper, they are even. The source of this di erence is the symmetric boundary conditions that we have used (12).

The spectrum contains two blocks. The identity-block has integer dim ension and hence can be interpreted as the boson-block, whereas the adjointblock has half integer dimension and thus will be referred as the ferm ionblock. We have seen that the two blocks have sim ilar structure since the two sectors obey the same wave function equation. Furtherm ore, m ixture between the two sectors is avoided due to the fact that the ham iltonian creates and destroys even numbers of \quarks".

The\quark" content of the spectrum is determined by the relation between the currents and the quarks. This relation is given by

and can be thought of as a mixture of 2n;2n 2;:::;2 quarks. In a similar way, a state in the ferm ion-block is a mixture of 2n + 1;2n 1;:::;3 quarks.

## 4 Large N<sub>f</sub> QCD

M assless QCD<sub>2</sub> with N<sub>f</sub> avors of quarks in the fundam ental representation is described by the Lagrangian of (4). Setting aside the avor and baryon number sectors, the left over system is that of a k = N<sub>f</sub> level SU (N<sub>c</sub>) W ZW action with an additional non-local interaction term. We are thus led to analyze the spectrum of the model with level equal to N<sub>f</sub>. In practical term s the latter means substituting k by N<sub>f</sub> in the expression for P<sup>+</sup> eqn. (9) and in the A ne Lie algebra eqn. (10).

The idea is to invoke a large N<sub>f</sub> approximation, namely, to consider models in which  $k = N_f N_c$ . Models with number of colors and avors which fall into this regime, are significantly simpler than models that don't obey this inequality. The basic reason for that is the simplication of the algebra eqn. (10). The commutator of P with J in the large N<sub>f</sub> limit takes the form

Upon neglecting the second term which is suppressed by a factor of  $\frac{1}{N_f}$  we get the following solution to the eigenvalue problem

Notice that the current operator acts on the adjoint vacuum and not on the identity vacuum. The reason for that is obviously the requirement that states have to be color singlets.  $j0i_{ib}^{ja}$  stands for  $j0i_{i}^{j}$   $j0f_{b}^{a}$ , nam ely, the tensor product of the color adjoint vacuum and its avor counterpart. Recall that following eqn. (4) the vacuum state is an outer product of the vacua of the three independent H ilbert-spaces of the color, avor and baryon number sectors. This \decoupling" of these spaces of states is an artifact of the massless lim it of the bosonized picture. It is further discussed in section 5.

The above state is the only one-particle state of the theory. All other massive state are multiparticle state which are built from this 'm eson'.

The content of m assless multi- avor QCD  $_2$  in the large N  $_f$  lim it is thus very simple and is in fact closely related to multi- avorm assless QED [11]. In the latter case model the spectrum of single particles contains the following single state

The reason of this similarity is very clear. Neglecting the O (N<sub>f</sub><sup> $\frac{1}{2}$ </sup>) term in eqn.(24) corresponds to dropping the structure constant term in the A ne-Lie algebra. In other words, in this limit we perform an Abelianization of the theory.

However, one may identify a di erence in the substructure of the two m esons. The Abelian m eson is built up from two quarks since current quanta ism ade out of two quarks, w hereas the non Abelian m eson is a m ore com plex object. The di erence can be seen by writing the state explicitly in term s of quarks operators. The (traceless) current is written as:

It is a state of two quarks with zero (light-cone) momentum acting on the identity vacuum. Thus the massive meson is

namely, a color singlet which is a mixture of four quarks and two quarks.

The basic feature used in this section has been the fact that  $k = N_c$ . This holds, in fact, not only for large number of fundam ental representations but obviously also for any large level gauged W ZW SU(N) m odel.

## 5 sum m ary

In this work we have calculated the m esonic spectra of  $evenal Q C D_2$  m odels by employing bosonization, light-front quantization and expansion in large number of colors or avors.

The main results of the work are

a) An approximated spectrum of the \adjoint ferm ions" model.

b) The exact leading order in  $\frac{1}{N_f}$  spectra of multi-avor fundamental representation.

As for (a), our approximation is similar to the one used in the fermionic picture [3], namely, dropping the terms that mix wave-functions with different number of current creation operators. The physical meaning of such approximation is suppressing pair creation and pair annihilation. This approximation is not quite justied, but it gives us hint about the structure of the spectrum. O byiously, the most urgent task in this direction is to look for methods to solve the full wave equation.

The second result states that the spectrum of the large N<sub>f</sub> fundamental fermions is built out of a single massive particle with M<sup>2</sup>  $e^{2}N_{f}$ . For comparison see ref.[12] where an analysis of sim ilar cases is discussed in the Ham iltonian formalism. In fact, it is a universal behavior of any gauged SU (N) W ZW model with k N.

The interesting question that naturally arise is what happens in the intermediate region, where k N. This region can be realized for instance, in the case ofmulti- avor QCD<sub>2</sub> with N<sub>f</sub> N<sub>c</sub>. It is reasonable to expect that the mesonic spectrum in this region will lie between that of a single massive state and that with an exponential density growth. In the absence of exact analytical methods one may have to invoke numerical diagonalization of the bosonized M<sup>2</sup> operator in a similar way to that of the fermionic picture[4].

For the analysis of the baryonic spectrum in the bosonization approach it is essential to consider the case of massive quarks[2]. This maybe also the case for the mesonic spectrum since the mass term couples the colored, avored and baryon number sectors. In fact, even for the massless case a better strategy is to solve the massive case and then go to the massless limit. The extraction of the mesonic spectrum in the massive case is much more evolved since the mass term can not be written in a simple fashion in terms of the currents. However, one can system atically expand the mass term in powers of  $\frac{m_q}{e}$  where  $m_q$  is the quark mass. Solving the wave equations in the presence of these massive perturbation deserves a further future study.

Recently, the theories of YM  $_2$  and QCD  $_2$  were analyzed as \perturbed" topological coset m odels[13]. The spectrum in that approach which was deduced using a BRST procedure includes a peculiar massive state which was not detected in other approaches including the present. This discrepancy maybe related to the di erent approximation used in that approach. C learing up this point as well as the implementation of that method to the case of adjoint fermions and other possible generalization deserves a further investigation. O therm ethods inherited from string theory and conformal eld theory can be also be applied to the analysis of the models discussed [14].

QCD<sub>2</sub> models can be generalized to a much richer class of theories which are also gauge invariant and renorm alizable[15]. The fram ework of this generalization is the formulation of the YM<sub>2</sub> functional integral in terms of an action which is linear in F and includes an additional auxiliary pseudoscalalr ed. Ordinary QCD<sub>2</sub> has a quadratic term in the latter eld while taking any arbitrary function f of this auxiliary eld spans the space of generalized models. The analysis presented in the present paper can be applied also to those models. The momentum operator P rather then being quadratic in  $\frac{1}{e}$  J it will take the general form of f( $\frac{1}{e}$  J). It will be interesting to compare the outcom e of the methods used in the current work to those derived in ref.[15].

In the above expression there are four term s:

The stone  $\frac{k}{2p}J$  (p), does not change the number of currents (it has only one current) and it is proportional to the level k. It will play a central role in the large k lim it.

The second term is similar to the stone, but it is proportional to N and it diverges. The divergent part will be compensated by another divergent term (which arises from the fourth term).

The third term include two creation currents. Thus the interaction P  $\,$ , with the help of the algebra created a current. In our discussion we will ignore this part, for the sake of sim plicity.

The last term includes annihilation currents, and therefore we should evaluate its commutator with other creation current.

The rst term includes only creation currents, therefore there is no need to evaluate its commutators with other currents.

The second term contains creation and annihilation currents, but it is suppressed in the large N  $\,$  lim it.

The last term is an important term . It is not suppressed at large N , and it contains the following expression in it:
