# Strong Coupling $H$ adron $M$ asses in 1=d Expansion for $W$ ilson

#### Abstract

M otivated by the weak-strong coupling expansion [1]1], we calculate the spectrum of hadrons using a system atic 1=d (d - dim ensionality of spacetim e) in addition to a strong coupling expansion in . T he 1=d expansion is pushed to the next to leading order in $(1=d)$ form esons and next to next to leading order forbaryons. W e do the calculation using $W$ ilson ferm ionsw th arbitrary $r$ and show that doublers decouple from the spectrum only when $r$ is close to the $W$ ilson's value $r=1$. For these $r$ the spectrum is $m$ uch closer to the lattioe results and the phenom enological values than those obtained by using either the (nonsystem atic) "random walk" approxim ation or the hopping param eter expansion. In particular, the value of the nucleon to $-m$ eson $m$ ass ratio is low ered to $\frac{3 \operatorname{logd} 1=4}{2 \text { arccosh2 }}+\mathrm{O}(1=\mathrm{d}) \quad 1: 48$. T he result holds even for as large as 5, where the w eak-strong coupling expansion is applicable and therefore these results are expected to be reasonable.


It is com $m$ only believed that for low energy physical quantities in QCD, such as hadron $m$ asses, there is no sm all expansion param eter, and the theory is "strongly coupled". The theory only has an asym ptotic weak coupling expansion successfully describes high energy quantities but breaks down at low energies. Recently one of us proposed a schem ecombining weak and strong coupling expansion in a "double expansion schem e" [ī1]. The high
energy $m$ odes are integrated out using expansion in weak coupling $s$, the resultant e ective Lagrangian is then expanded in derivatives and solved using strong coupling expansion in

A priori it would seem that the dom ain of applicability for the expansion in $w$ ill have very little chance to intersect with that of the expansion in. Indeed, if the gauge coupling constant $g$ is sm all, $1=g$ is large and vice versa. Fortunately, how ever, a sm all (g), does not necessarily imply that ( g ) will be large and vice versa. In fact, this schem e of a sim ultaneous weak and strong expansion has been tested on certain solvable low dim ensional asym ptotically freem odels like Ising chain and d $=2 \mathrm{G}$ ross -N eveu m odels [in] and the results agree very well w ith the exact values.
 the asym ptotic scaling region is out of reach, the e ective weak coupling near the strong coupling radius of convergence is quite sm all. In the SU (3) YM theory the radius of convergence (roughening phase transition), is larger than $m$ ax $6=g_{m}^{2}$ in $5[\underline{4}]$ which corresponds (using naive perturbative RG) to a relatively sm alle ective weak coupling expansion param eter lat $g_{\text {lat }}^{2}=4 \quad 0: 1$. Even taking into account the fact that lat is a lattioe one (not the $\overline{\mathrm{MS}} ; \overline{\mathrm{MS}} \quad 0: 3)$, this corresponds to the values at w hich perturbation theory is supposed to work for energies above 1:5 2 GeV . Recently, this fact has been fully understood for lattice weak coupling perturbation theory 位]. Therefore, there exists a (albeit sm aller then the one for the $G$ ross $-N$ eveu model) $w$ indow in the coupling in which both and are sm allenough to produce a reasonable series. The well known \loop factors" $1=(4)^{2}$ in the weak coupling expansion param eter are partly responsible for this, although this generally is not su cient since sym $m$ etry group factors tend to reduce the $w$ indow . $N$ ote also that the leading order term in coincides with the conventional \phenom enological" strong coupling model, in which the inverse lattioe spacing $M$ is lim ited to values inside the weak-strong applicability window. This would seem to be a strong indication that the simultationeous weak-strong expansion will.be applicable to Q CD .

The complexity of such a calculation depends on the quantity and the precision one would like to achieve. Usually strong coupling series are relatively easy to evaluate to very high orders. Consequently the scale $M$ can be chosen in such a way that $m$ is just
below the strong coupling expansion radius of convergence. Sim ultaneously, the scale M should be su ciently high or altematively the relevant energy scale su ciently low so that just a few orders in the derivative expansion are needed to achieve the desired accuracy. C onsequently, this $m$ ethod is lim ited to low energy quantities only. Therefore, inside this weak-strong coupling $w$ indow the usual lattice action $w$ ith renom alized coupling can serve as a reasonable e ective action '[ $[\bar{\sigma}]$. The expected accuracy is rather low : up to corrections of order $\overline{\mathrm{MS}} 0: 3$ due to weak coupling expansion. On the top of this we $m$ oreover $w i l l$ then have to perform the strong coupling expansion. Fortunately it is well known that in the hadronic sector (unlike the gheball or pure ghe sector in which the above estim ates of the radius of convergence of the strong coupling were taken) the situation is m uch better. The strong coupling lim it $=0$ already produces a reasonable spectrum of hadrons. In addition, it is known that the next to leading order term $s$ in for the hadronic spectrum are num erically very $s m$ all $[1010,1,1]$. Even for the $w$ indow value of $=5$ the corrections do not exceed 15\% .

H ow ever even in this lim it QCD is nontrivial and an additional expansion param eter should be utilized. This $m$ ay be the hopping param eter, $1=N_{c}$ or $1=d$ expansions. The hopping expansion param eter $\quad 1=2$ is de ned as a bare coupling in units of lattioe spacing
 extensively used, but is notoriously di cult to perform beyond the leading order. Indeed, it is
 the spectrum at strong coupling. In this approxim ation the hopping param eter expansion is
 be superior than the sim ple hopping param eter expansion, one does not nd a controllable expansion param eterw ithin this approxim ation. M oreover, the results of this approxim ation as well as those of the hopping param eter expansion were rather discouraging. A though the ordering of the lowest hadronic states is correct, som e m ass ratios are grotesque. A $n$ especially bad exam ple is the nucleon to -m eson m ass ratio which is about 2.2 instead of the phenom enological 12 or (at $=5$ ) lattioe M C sim ulation value of $1: 4$.

In this paper we use the $1=\mathrm{d}=1=4$ expansion to calculate the hadron $m$ ass spectrum , which allows managable higher order calculations. This was rst applied to Yang -M ills
theories for staggered ferm ions in [1] 1 which, although better the previously $m$ entioned strong coupling result is still so di erent from the phenom enological value that it cannot be accounted for by next to leading order corrections. M oreover, the interpretation of particle spectrum for staggered ferm ions is by no $m$ eans straightforw ard. $W$ e, therefore, shall consider $W$ ilson ferm ions which allow s us to discuss splltting due to three avors and for which the interpretation is straightforw ard.

In view of these above results for the spectrum, one of the follow ing should be valid: (a) som ething is nevertheless $w$ rong $w$ ith the argum ent for the existence of the weak-strong coupling window and the quenched lattioe results are not precise enough. The spectrum at
$=5$ is indeed very di erent from the observed experim ental one because the continuum lim it is still far from this point or (b) the random walk and the hopping expansion (and to a sm aller degree the staggered ferm ion) results are inaccurate. $W$ e show in this paper that when a system atic $1=\mathrm{d}$ expansion is applied to the W ilson action w ithin the weak-strong w indow, a spectrum is obtained which is in agreem ent with the above lattice M C results within the expected accuracy of the expansion.

W e now $x$ notation and outline the form alism, which is well-known, focusing on the di erences with random walk approach. No details of higher order calculations will be given. T he standard lattice $W$ ilson action is

Integration over the gauge elds U give in the leading order '['] $]$,

where the determ inant is over the color indioes. The : : : indicates a nite num ber of term $s$ which contribute to higher order term $s$ in $1=d$. C onsidering rst the $m$ esonic sector, we note that although we have introduced di erent avors, for the leading order in $1=\mathrm{d}$, they
w ill not play a role and we shall suppress them for now. W e then introduce the $m$ esonic elds through $M^{A}(x)={\frac{1}{N_{C}}}^{q} \frac{d}{2}-A \quad A \quad A$. The \channel" index A runs from 0 to 15 and norm alization of $m$ atrioes is chosen so that $\operatorname{Tr}{ }^{A}{ }^{B}={ }^{A B}$ [ī$]$. In term $s$ of these elds the $m$ esonic part of the action becom es

where unless otherw ised stated sum $m$ ation over repeated channel indioes willbe understood. We now integrate over the ferm ion elds. This is done by rst introducing auxillary elds conjugate to $\mathrm{M}^{\mathrm{A}}$ [1] 1 i$]$ :

The factor ${ }^{\mathrm{p}} \overline{\mathrm{d}} \mathrm{w}$ as introduced in them ass to facilitate the $1=\mathrm{d}$ expansion [īī]. The functional A M (x)] of hadronic elds is an e ective hadronic action describing dynam ics of the color invariant "basic" elds only. In the m eson sector, which is being considered now, these elds interpolate betw een the pseudoscalar and vector $m$ esons. They correspond to the lowest energy states of the naive quark $m$ odel. Later on baryonic elds intenpolating betw een the octet and decouplet (N and ) eldswill.be introduced.
$T$ he quadratic part of the $m$ esonic action to low est order is then

To nd the $m$ ass spectrum of the theory, we need to nd the zeros of $G^{1}$ in $m$ om entum space. This would seem to be di cult, but note that $G{ }^{1}$ and $k \quad{ }_{0}^{2} G{ }^{1} D$ have the same zero
eigenvalues, as long asD does not vanish and nding the zeros of the latter quantity is fairly straightforw ard.

There are two coupled channels for the $m$ esonic sector. $F$ irst, the pseudoscalar couples $w$ ith the tim e com ponent of the axial vector giving the $m$ ass term for the pion. In this channel,
where we included the correct powers of $1=d$ and have taken the $d-m$ om entum to be (0;::; $0 ; i m$ ). W thin the $1=$ d expansion, we can generically w rite

where, of course, y cannot be determ ined as yet since higher orders in 1=d term s have not been inchuded. U sing eq.(인) and expanding the eigenvalue equation of the $m$ atrix eq. (7) in orders of $1=d$, we nd tw o solutions. The one which is nite for all relevant $r$, is

and determ ines the $m$ ass of the $m$ ass of the $p i o n$. The second eigenvalue $x_{d}$ is nonzero and describes a doubler (it is a bound state of two ferm ionic doublers at the opposite comers of the B rillouin zone) :

O ne then requires that the pion be $m$ assless for all $r$, and sets $x=0$ and $y=1$. This, to low est order, determ ines the tra jectory in param eter space relating bare m ass to r: ${ }_{0}^{2}=$ $1+r^{2}$.

where we have considered only one spatial com ponent of the vector eld interpolating m esons. O n this tra jectory we w rite cosh $\mathrm{m}=\mathrm{x} \mathrm{d}+\mathrm{y}+\mathrm{O}(1=\mathrm{d})$ and obtain

to the leading order in $1=\mathrm{d}$. There are two eigenvalues to this m atrix. The rst is $\mathrm{x}=0$. Thism eans that the $m$ eson'sm ass does not have a \natural" order of log d, but is, in fact, sm aller \{ just of order 1 . It is, how ever, inconsistent to to determ ine y by solving equation for vanishing determ inant of eq. (112). . T he $1=d$ corrections to this $m$ atrix, considered in the follow ing, $m$ ust be taken into account. O ther channels, scalar, tensor, etc, contain doublers only.

Genericly, in any next to leading order calculation in 1=d there are two types of contributions $[1] i \overline{1}]$. The rst is the "tree" contribution which arises from additionalterm $s$ in the integral over gauge elds eq.'(1) , while the second is the one loop diagram s involving the propagator and vertioes of the leading e ective action eq. ${ }_{(1)}^{(T)}$. K eeping the pion $m$ ass zero, the \next to leading" contribution to the $m$ eson's $m$ ass $y$ (which is actually the leading $\sin œ x=0)$ is:

This value is consistent w th the $r=0$ result obtained in $\left[\begin{array}{l}{[1]} \\ \hline\end{array}\right]$ for staggered ferm ions. $N$ ote that for $r=1$ the $m$ ass is signi cantly larger then in the random walk approxim ation.

The purpose of introducing the chiral sym $m$ etry breaking $m$ ass and $W$ ilson's term $s$ was to rem ove doublers. T he value of $r$ should, in principle, be optim ized in such a way that on the one hand doublers do not interfere w ith physical particles and, on the other hand, the chiral sym $m$ etry is $m$ inim ally violated. A s is well know $n$, setting the pion $m$ ass to zero does not $m$ ean that the chiral sym $m$ etry is som ehow restored on the tra jectory. It just $m$ eans that we are situated on the spontaneous parity breaking phase transition line. On Fig. 1 we show the $r$ dependence of various doublers $m$ asses com pared to the $m$ eson $m$ ass. $W$ e can see that the doublers are signi cantly heavier then $m$ esons only near $W$ ilson's value of $r=1$, where they allbecom e in nitely heavy. Therefore we conclude that there is no great advantage to work w ith $r<1$ contrary to som e lattice $[1$ [峿] results in which doublers were not considered.

Tuming our attention to the baryonic sector, we note that the general expression for the exponent of the baryon $m$ asses contains, half integer as well as integer pow ers of $1=\mathrm{d}$ :

$W$ e calculated $x ; x^{0} ; y$ and $y^{0}$. To the leading order the $m$ ass on the $m=0$ trajectory is

$N$ otioe that for $r=0, x=2^{p} \overline{2}$ which reproduces the result obtained in [1] ferm ions calculation. The nucleon is degenerate with up to the order of $1=\mathrm{d}$ we have considered when $r=1$. The form ulas for the higher order corrections to the baryon $m$ asses for other values of $r$ are cum bersom $e$ and $w$ ill be given elsw here. Instead, for $r=1$

W e also calculated the leading order corrections to the and baryons. These types of corrections has been studied for staggered ferm ions in $[\underline{1}[\underline{1} 1]$ and with the random walk approxim ation schem e in $[\underline{1} \mathbf{1}-10]$. They vanish for $r=1$ and are $s m$ all for other values of $r$ near the window range.

To sum $m$ arize, we have system atically studied the spectrum of the $W$ ilson action $w$ ith arbitrary $r$ using strong coupling and the $1=d$ expansions. The Lagrangian is considered as a phenom enological low energy e ective Lagrangian for the values of at which the expansion is still reasonable. It tums out that the doublers decouple from the physical spectrum only $w$ hen $r$ is quite close to the $W$ ilson's value $r=1$. T he results of the system atic $1=d$ expansion for the nucleon to m ass ratio is $\frac{3 \log \mathrm{~d} 1=4}{2 \text { arcoosh2 }}+\mathrm{O}(1=\mathrm{d}) \quad 1: 48$. This value is w thin the range of the next correction of the $M$ onte $C$ arlo results.

W e now com pare the $1=$ d results form esons $w$ th those obtained $w$ thin the random walk approxim ation in $d=4$. To understand the di erence with the random walk approach, we have extended the random walk calculation [ī్1] to arbitrary $d$ and obtained the $m$ ass of $m$ eson for $\mathrm{r}=1 \mathrm{as}$ :

The rst term in this expansion coincides $w$ ith the system atic $1=d$ expansion. There is how ever no reason to expect that the next order term in $1=d \mathrm{w}$ ill resem ble that in eq. (1] $\overline{1} \mathbf{Z})$. A priori this is not obvious since at the special value $r=1, m$ any contributions to the next to leading order term vanish. This is due to the well-known result from the random $w a l k$ approxim ation [1]-10] that to this order all the propagators travel along a single direction. As such, we will necessarily encounter product of two projectors $P^{+} P=0$. H ow ever if we go to the next to next to leading order there will certainly be m any contributions which w ill not vanish for the sim ple reason that certain diagram swill not \linear", but rather \planar".

The coe cient in front of $1=d$ in eq. (1] $\overline{1})$ is negative and large num erically for $d=4$. This leads to signi cant underestim ate for the m ass and consequently for the overestim ation of $m_{N}=m$. Let us em phasize that this term cannot be taken seriously at this point since corrections to the m ass at this order in $1=$ d have not been done as yet. Indeed, it w ould be very interesting to calculate this next ( $1=$ d for cosh m ) order term to obtain better estim ate of the mass.

This feature ofrandom walk approxim ation does not carry over to baryon sector, how ever. The corresponding expansion for the nucleon $m$ ass in pow ers of $1=\alpha$ is:

The nst two term s of these now coincide w ith our system atic $1=d$ expansion results. W hen a sim ilar expansion is done for the $D$ elta $m$ ass, we nd that for som $e$ unknow $n$ reason all four term s now coincide w ith eq. ( $\left(\overline{1} \overline{1}_{1}\right)$ ). O nce again, how ever, any term $s$ which is of higher order than $d$ in eq. ( $(\underline{1} \overline{9})$ are unreliable, since they $w$ ill be alm ost certainly be changed by higher order $1=d$ corrections. In particular, we see that $s m$ all splitting betw een the nucleon and found in random walk approach is due these unreliable higher order term s . W ithin the system atic $1=d$ expansion, the D elta and $N$ ucleon are degenerate.

O fcourse there are num erous other corrections to the w eak-strong approxim ation schem e. Here we discuss few of the $m$ any which have not been calculated. O ur previous discussion revealed the peculiar fact $m$ ost of the contributions to the next to leading order term $s$ in $1=d$ vanish for $r=1 . W$ e can ask the follow ing question: W hat are the corrections that do not vanish? In particular, we note that to the next to leading order there is no splitting betw een Goldstone bosons and avour singlet - the particles. As is well known, this spllilting is
due to an anom aly. The plaquette correction also does not lead to the spletting. This is easy to understand. The argum ents of Frohlich and $K$ ing [1] expansion. W e therefore expect these anom aly e ects to appear only at very high orders in $1=$ or, when a diagram which spreads in all four directions can be constructed. A nother possibility is that the $m$ ain $m$ echanism for the splitting is not due to these corrections but rather to direct anom aly breaking term s whidh are proportional to s . These appear due to the presence of instantons at energies higher then the scale $M$.

The actualsplitting betw een and the nucleon is also probably due to higher order term s in the e ective Lagrangian. $N$ ote that in lattioe sim ulations at relatively sm all $\left(\begin{array}{l}\text { ) the }\end{array}\right.$ splltting is also sm aller then the phenom enological values. T he presence of higher dim ension term $s$ are also crucial for two other punposes: restoration of the Lorentz invariance and the chiralsym $m$ etry. Chiralsym $m$ etry is explicitly broken by the $m$ ass and $W$ ilson term $s$. A swe have $m$ entioned, the vanishing of the pion $m$ ass is not su cient to restore chiral sym $m$ etry. Instead it is sim ply a signal criticality $w$ th respect to a discrete sym m etry. It would be therefore be interesting to investigate whether the chiral properties are gradually restored once higher dim ensional operators are introduced. For exam ple the pion scattering at sm all $m$ om enta is nonvanishing $[\underset{-1}{-9}] \mathrm{w}$ thout higher dim ensional term s . It is reasonable to expect that with the inclusion of the term due to next order correction in $1=\mathrm{M}^{2}$ of the derivitive expansion of thee ective action the correct zero $m$ om entum $\lim$ it at least $w$ ill be recovered. Existing results, which are quite scarce within the random walk approxim ation schem $e$, in which only part of the higher dim ensional (im provem ent) operators are considered did not address this question.
