String techniques for the calculation of renorm alization constants in eld theory

Abstract

We describe a set of methods to calculate gauge theory renormalization constants from string theory, allbased on a consistent prescription to continue o shellopen bosonic string amplitudes. We prove the consistency of our prescription by explicitly evaluating the renormalizations of the two, three and four-gluon amplitudes, and showing that they obey the appropriate W and identities. The eld theory limit thus performed corresponds to the background eld method in Feynman gauge. We identify precisely the regions in string moduli space that correspond to di erent classes of Feynman diagrams, and in particular we show how to isolate contributions to the elective action. Ultraviolet divergent terms are then encoded in a single string integral over the modular parameter . Finally, we derive a multibop expression for the elective action by computing the partition function of an open bosonic string interacting with an external non-abelian background gauge eld.

1 Introduction

String theories, unlike eld theories, contain a physical dimensional parameter, the Regge slope ⁰, that acts as an ultraviolet cuto in the integrals over loop momenta, making multiloop amplitudes free from ultraviolet divergences. This is a basic reason why a string theory can provide a consistent perturbative quantum theory of gravity, uni ed with non-abelian gauge theories.

A nother useful feature of string theory is the fact that, at each order of string perturbation theory, one does not get the large proliferation of diagram s characteristic of eld theories, which makes it extrem ely di cult to perform high order calculations. In the case of closed strings one gets only one diagram at each order, while in the open string the number of diagram s remains small. Furtherm ore, the expression of these diagram s is known explicitly, in the case of the bosonic string, for an arbitrary perturbative order, including also the measure of integration on m oduli space [1].

Finally, it is well known that in the limit of in nite string tension (0 ! 0) string theories reduce to non-abelian gauge theories, uni ed with gravity, order by order in perturbation theory. This means, in particular, that in this limit one must reproduce, order by order, S-matrix elements, ultraviolet divergences, and all other physical quantities that one computes in perturbative non-abelian gauge theories.

The combination of these di erent features of string theory has led several authors [2, 3, 4, 5, 6, 7] to show that in many cases string theory can be an elicient conceptual and computational tool in di erent areas of perturbative eld theory. In particular, because of the compactness of the multiloop string expression, it is easier to calculate non-abelian gauge theory amplitudes by starting from a string theory, and perform ing the zero slope lim it, rather than using traditional techniques. In this way the one-loop amplitude involving four external gluons has been computed, reproducing the known eld theoretical result with much less computational cost [8]. Follow ing the same approach, also the one-loop vergluon amplitude has been computed for the rst time [9].

As observed in Ref. [10], in order to extract eld theory results from string theory, it is not necessary to use a consistent string theory. It can be su cient to use the simplest string theory that contains the desired eld theory in the zero slope lim it (the open bosonic string if one is interested in non-abelian gauge theories). String theory in fact proves itself to be a rather versatile and robust tool: as we shall see, one recovers correct results in the eld theory lim it even when the consistency of the full string theory has been severely dam aged, for example by continuing the results to arbitrary space-time dimension, and by extending o shell the string amplitudes, which implies a breaking of conform al invariance. Sim ilar observations have led to the conjecture that the string organization m ay be understood entirely in terms of a eld theory analysis, and in fact in some instances this has been shown [11, 12, 13]. However, in view of a possible multibop generalization of the known results [14], we believe that further input from string theory may prove necessary.

In a previous letter [15] we have considered the open bosonic string with Chan-Paton factors, and we have computed the one-bop two-gluon amplitude, with a suitable o -shell extrapolation in order to get rid of infrared divergences. By performing then the zero slope limit, we have obtained the gluon wave function renormalization constant Z_A , which turned out to coincide with the one calculated in the background eld method.

In this paper we extend our procedure to the three and four-gluon amplitudes, and thus compute also the renorm alization constants Z_3 , for the three-gluon vertex, and Z_4 , for the four-gluon vertex. This is a test of the consistency of our o -shell prescription, as we can show the validity of the W and identities $Z_A = Z_3 = Z_4$, that are characteristic of the background eld m ethod.

The information obtained with ourmethod complements the knowledge of how gauge-invariant on-shell scattering am plitudes can be derived from string theory. In fact, in eld theory, one is in general interested in calculating o -shell, gaugedependent quantities such as anom alous dim ensions or general G reen functions. An alternative set of rules for calculating these objects is useful only if the choice of gauge, regularization and renorm alization prescriptions is uniquely specied. The di culty with string theory is of course that all one starts with is a prescription to calculate scattering am plitudes, which is only valid on shell. Dierent o -shell continuations must be shown to be consistent, and may lead to di erent gauges or renorm alization schemes. To date, the only known consistent prescription for the o -shell continuation of string am plitudes [20] leads to a vanishing wave-function renorm alization for the gauge eld, in apparent contradiction with the results of a detailed analysis of on-shell amplitudes [11], which implies that string theory leads to a combination of the background eld method with the non-linear Gervais-Neveu gauge. In the following we will solve this puzzle by proposing a dierent, and simpler, prescription for the o-shell continuation of the amplitudes, which leads unambiguously to the background eld method.

The calculation of renormalization constants can be performed using three different, although closely related methods. The most straightforward method, in the spirit of [6], is based on the evaluation of the eld theory limit of the full string amplitude, from which ultraviolet divergences can be consistently extracted affer o -shell continuation. A careful analysis of the string amplitudes leads to a precise identication of the regions in moduli space that correspond to dierent classes of Feynman diagrams in eld theory. Having learnt how to identify one-particle irreducible diagrams, contributing to the elective action, one may look for a method to isolate these contributions directly in the general expression for the amplitude. This is achieved by using a dierent expression for the bosonic world-sheet G reen function, along the lines of [2]. We establish a precise relationship between these two methods, showing explicitly how the contributions to the elective action are picked out of the full string amplitude. Finally, having observed how string amplitudes seem to be intimately connected with the background eld method, we go on to show how e ective actions with arbitrary numbers of legs and loops can be compactly represented in terms of a generating functional describing the propagation of an open string in an external non-abelian gauge eld. The renorm alization constants derived from this generating functional coincide with those previously obtained calculating string scattering amplitudes.

The rst method (presented in Sections 3, 4 and 5) uses the open bosonic string amplitudes for two, three and four gluons, suitably continued o shell. The amplitudes are expressed as an integral over the puncture coordinates, representing the locations of the insertions of the gluon operators on the open string boundaries, and over the modular parameter of the annulus, . The integral over the punctures has a Laurent expansion in term s of the variable $k = e^2$. The leading term of this expansion, of order k¹, corresponds to tachyon exchange in the loop, and must be discarded by hand. The next-to-leading term, of order 1, corresponds to gluon exchange in the bop, and gives the eld theory limit. Higher order contributions, behaving as k^n with n > 0, are negligible in the eld theory limit. If we then concentrate on the term of order 1, we see that the in nities appearing in the eld theory limit arise from di erent regions of integration over the punctures. There are basically two kinds of contributions [8]. The rst one is obtained by expanding the integrand for large , isolating the term of order 1 in k, and then integrating the resulting expression over the punctures. This contribution corresponds to oneparticle irreducible diagram s in eld theory. The second kind of contribution arises instead from regions of integration in which some punctures are taken to be very close to each other. This is often referred to as the pinching limit, and corresponds to eld theory diagram s that are connected but not one-particle irreducible. The sum of the two contributions reproduces the in nities of the full connected G reen functions, truncated with free propagators and suitably continued o shell.

The second method is based on the use of an alternative form of the bosonic G reen function, proposed in Ref. [16], in which the logarithm ic singularity associated with the pinching limit is regularized by means of a -function regularization. U sing this regularized expression for the G reen function simplifies considerably the evaluation of renormalization constants. In fact, as we shall see, having eliminated the reducible diagram s associated with the pinching regions, one can easily isolate ultraviolet divergent contributions by focusing on the terms in the integrand with the appropriate power of the modular parameter. It is then possible to neglect the exponentials of the bosonic G reen functions that constitute the bulk of the integrand. This simplifies the calculation to the point that it is actually possible to perform the integrals over the punctures exactly, before the eld theory limit is taken.

F inally, we show how all divergent contributions to the e ective action can be generated from a single functional, describing the interaction of an open bosonic string with an external non-abelian background gauge eld. U sing this form alism, one sees the connection between string theory and the background eld method from a di erent angle. String-derived gluon am plitudes without pinchings can be understood as scattering am plitudes in a background eld constructed out of plane waves. Contributions to the elective action can be isolated by focusing on slow ly varying background elds, and are then connected to gluon am plitudes for low energy gluons. Manipulating the expression for the all-order partition function of the string in such a slow ly varying background, we can form ally generalize the calculation of the elective action, and we obtain a compact expression for the string integral generating the renorm alization constants, valid for any number of string loops.

The paper is organized as follows. In Section 2 we consider the open bosonic string, and we write the explicit expression of the M -gluon am plitude at h bops, including the overall norm alization. We specialize then to the case of tree and one-bop diagram s, detailing various choices of integration variables. In Section 3 we sketch the calculation of the one-loop two-gluon amplitude, already presented in [15], and we show how to extract the gluon wave function renorm alization constant Z_A . In Section 4 we extend our previous calculation to the one-loop three-gluon am plitude, and we discuss in detail the various regions of integration over the punctures that contribute to the eld theory limit. In particular, we show how one can identify at the string level the classes of Feynm an diagram s that correspond to each such region, and we derive the renorm alization constant Z_3 . In Section 5 we consider the one-loop four-gluon amplitude, we extract the renormalization constant Z_4 , and we discuss some subtleties arising in the treatment of contact term s. In Section 6 we show how, using a regularized expression of the G reen function, one is naturally led to calculate contributions to the elective action, and nally in Section 7 we recover and extend these results by computing the partition function of a string interacting with an external non-abelian eld. Section 8 sum marizes our results and com pares the di erent approaches, having in m ind possible applications to multiloop calculations in gauge theories.

2 The M-gluon am plitude

The properly normalized (connected) S-matrix element describing the scattering of M string states $j_1i_j:::;j_M$ is

where d is the dimension of the target space-time with metric (;+;:::;+), $E_i = \dot{p}_i^0 j$ is the energy of the i-th particle and A ($_1;:::;_M$) is the M -point amplitude in which all propagators of the M external states have been removed. Borrowing the term inology from eld theory, we call A ($_1;:::;_M$) the (unrenormalized) connected M -point amplitude. In string theory, these amplitudes can be computed

pertubatively, and are written as

where g_s is a dimensionless string coupling constant, which is introduced to form ally control the perturbative expansion. In Eq. (2.2), A ^(h) represents the h-loop contribution. In particular, for the open bosonic string, A ⁽⁰⁾ corresponds to the scattering of string states inserted on the boundary of a disk, while A ⁽¹⁾ corresponds to the scattering of states inserted either on one of the boundaries of an annulus (planar diagram), or on the boundary of a M oebius strip (non-orientable diagram), or on both boundaries of an annulus (non-planar diagram). Sim ilarly the higher loop am plitudes A ^(h) with h 2 correspond to the scattering of states inserted on the various boundaries of an open R iem ann surface with a m ore com plicated topology. In what follow s we will lim it our discussion to planar diagram s, but our analysis can be extended to the other cases as well.

An e cient way to explicitly obtain A $^{(n)}(_1;:::;_M)$ is to use the M -point hloop vertex $V_{M,h}$ of the operator form alism [1], which can be regarded as a generating functional for scattering am plitudes among arbitrary string states, at all orders in perturbation theory. In fact, by saturating the operator $V_{M,h}$ with M states j_1;:::;j_M i, one obtains the corresponding am plitude,

The explicit expression of $V_{M,h}$ for the planar diagram s of the open bosonic string can be found in Ref. [1]. That expression still has to be properly norm alized, and the correct norm alization factor C_{h} is given by

where 0 is the inverse of the string tension (we refer to Appendix A for a derivation of this form ula).

The vertex $V_{M,ih}$ depends on M realK oba-N ielsen variables z_i through M projective transform ations $V_i(z)$, which de ne local coordinate system s vanishing around each z_i , i.e. such that

W hen $V_{M,ih}$ is saturated with M physical string states satisfying the mass-shell condition, the corresponding amplitude does not depend on the V_i 's. However, as we discussed in Ref. [15], to extract inform ation about the ultraviolet divergences that arise when the eld theory limit is taken, it is necessary to relax the mass-shell condition, so that also the amplitudes A ^(h) will depend on the choice of projective

transform ations V_i 's, just like the vertex $V_{M,h}$. This is rem in iscent of a well-known fact in gauge theories, namely that on-shell amplitudes are gauge invariant, whilst their o -shell counterparts are not. Indeed, one can regard the freedom of choosing the projective transform ations V_i 's as a sort of gauge freedom.

Let us now specialize to the case in which all M states are gluons, and let us denote by jp; "i a state representing a gluon with momentum p and polarization ". Such a state is created by the vertex operator

where colons denote the standard norm all ordering on the m odes of the open string coordinate X (z), and N $_{\rm 0}$ is a norm alization factor given by

with g_d being the gauge coupling constant of the target space Yang-M ills theory. The latter is related to the dimensionless string coupling constant g_s of Eq. (2.2) by

as described in Appendix A.N otice that the vertex in Eq. (2.6) does not depend on the color index of the gluon, and thus the gauge group structure must be recovered via the Chan-Paton procedure.

If we write as usual

W e will always enforce the transversality condition (2.12), while in discussing the eld theory limit of the string amplitudes we will relax the mass-shell condition (2.11) (see also [15]). Relaxing also the transversality condition would just lead to more cumbersome expressions without changing the nal results.

If we saturate the vertex $V_{M,in}$ with M gluon states and multiply the result with the appropriate Chan-Paton factor, we obtain the color-ordered M -gluon planar amplitude at h loops, which we denote by $A_p^{(n)}$ (p₁;:::;p_M). If we pick the gauge group SU (N), use transverse gluons, but choose not to enforce the mass-shell condition, we nd

where the subscript m l." stands form ultilinear, meaning that only terms linear in each polarization should be kept. In Eq. (2.13), which can be considered the master form ula of our approach, N^hTr(^{a1}^aM) is the Chan-Paton factor appropriate for an M -gluon h-loop planar diagram, with the 's being the generators of SU(N) in the fundam ental representation, norm alized as

Further, $G^{(h)}(z_i; z_j)$ is the h-loop world-sheet bosonic G reen function, and $[lm]_h^M$ is the measure of integration on moduli space for an open R ism ann surface of genus h with M operator insertions on the boundary [1]. The G reen function $G^{(h)}(z_i; z_j)$ can be expressed as

All these objects, as well as the measure on moduli space [dm J_h^M , can be explicitly written down in the Schottky parametrization of the R ismann surface, and their expressions for arbitrary h can be found for example in [17]. Here we will only reproduce the explicit expression for the measure, to give a avoir of the ingredients that enter the full string theoretic calculations. It is

where a, b, c are any three of the M K oba-N ielsen variables, or of the 2h xed points of the generators of the Schottky group, which can be xed at will; nally, the primed product over denotes a product over classes of elements of the Schottky group [17]. Notice that in the open string the K oba-N ielsen variables must be cyclically ordered, for example according to

and the ordering of K oba-N ielsen variables autom atically prescribes the ordering of color indices.

C learly expressions such as Eq. (2.16) can be very di cult to handle in practice, as they involve in nite products (or sum s) over subgroups of a discrete group. However, as we shall see, all such expressions sim plify drastically in the eld theory lim it ⁰! 0. In this lim it, only a nite num ber of term s contribute to the products, and calculations remain manageable.

The reader m ay also have noticed that we have left the value of the spacetime dimension d arbitrary, and we have not xed it to the critical dimension, d = 26. As we shall see, this agrant violation of string consistency does not a ect the eld theory limit. This may be understood if we interpret d as the number of uncompacti ed dimensions, and we assume that $d^0 = 26$ d dimensions have been compacti ed. Of course the d^0 compacti ed dimensions will contribute to the string partition function and to the scattering amplitudes, but those contributions factorize, and, in the eld theory limit, behave just as d^0 scalars coupled to the gauge eld. The na ve procedure, simply letting d be arbitrary, just corresponds to neglecting ab initio the contribution of these scalars.

For h = 0 the situation is particularly simple. The G reen function in Eq. (2.15) reduces to

Inserting Eq. (2.19) and Eq. (2.20) into Eq. (2.13), and writing explicitly all the norm alization ∞ cients, we obtain the color-ordered, on-shell M-gluon amplitude at tree level¹

where $_0$ is the region identi ed by Eq. (2.18). Notice that any dependence on the local coordinates $V_i(z)$ drops out in the amplitude after enforcing the mass-shell condition. Eq. (2.21) is valid for M 3, since the tree-level measure Eq. (2.20) is ill-de ned for M 2.

For h = 1 the situation is more complicated but still manageable. In the Schottky representation, the annulus is described by a Schottky group generated by one real projective transform ation S. This can be characterized by a multiplier k and the attractive and repulsive xed points and . In terms of these variables, the measure $[\text{Im}]_{1}^{M}$ on moduli space turns out to be

where dV_{abc} is given again by Eq. (2.17), with a, b and c being any of the M + 2 variables $fz_1; :::; z_M$; ; g, which can be xed at will. The remaining M 1 variables and k are the moduli of the annulus with M operator insertions on one boundary. In deriving Eq. (2.22) from Eq. (2.16), one should remember that the determ inant of the period matrix, coming from the integration over the momenta circulating in the loops, can be expressed at one loop in terms of the multiplier of the Schottky generator as

Here, in the one-loop case, we have called the period matrix \sim instead of , as usually done, because later on we will use for a rescaled version of it (see Eq. (2.29)).

A crucial point that must be discussed before we proceed is the region $_1$ over which the modulim ust be integrated. One way of determining $_1$ is to observe that the vertex $V_{M \ 1}$ can be obtained with the sewing procedure from $V_{M \ 2;0}$ [18]. As we mentioned before, $V_{M \ 2;0}$ depends on $M \ + 2$ K oba-N ielsen variables ordered on the real line, as in Eq. (2.18). In the sewing process one identies, say, legs $M \ + 1$ and $M \ + 2$ by means of a propagator P (x) depending on a sewing parameter x, with 0 < x < 1. The specie c form of P (x) is determined by the local coordinates $V_i(z)$ of the two legs that are sew n, in such a way that the factorizability and the cyclic properties of the vertex are maintained after sewing. We refer the reader to [18] for a thorough discussion of this point and of the sewing procedure in general. Here we simply want to point out that the two sets $fz_1; \ldots; z_M; z_{M \ 1}; z_{M \ 2}; q$ and $fz_1; \ldots; z_M; j$ g are equivalent, and that we can establish a precise relation between the original K oba-N ielsen variables of the tree-level vertex $V_{M \ 2;0}$, the xed points

and , and the multiplier k of the Schottky generator at one loop. To do so, we must use the explicit expression of the propagator P (x) and of the chosen local coordinates $V_{\rm i}$ (z). If we choose the Lovelace coordinates for i = M + 1;M + 2, and

It is important to notice that the G reen function in Eq. (2.34), or in Eq. (2.39), is logarithm ically divergent in the lim it $_{i}$! $_{j}$. This singularity is essential to get, for example, the correct pole contributions in the various channels at tree level, as well as to extract, in the eld theory lim it, the contribution of one-particle reducible diagram s at one loop, as we will see in Sections 4 and 5. If we rewrite the G reen function as in Eq. (2.41), this logarithm ic singularity has not disappeared, but it manifests itself as a divergence in the sum .

In what follows we will show how, in the eld theory limit, the one-loop gluon amplitudes derived from Eq. (2.35) develop ultraviolet divergences, and these divergences with our prescription reproduce exactly the results of the background eld m ethod in the Feynm an gauge.

3 The two-gluon am plitude

Let us brie y recall the results for the two-gluon amplitude that we already presented in Ref. [15]. From Eq. (2.13) with M = 2 we see that the color-ordered two-gluon amplitude at h loops (h 1) is²

where we dropped the subscript P, since for SU (N) the planar diagram is the only one contributing to the two-point function. This formula generates, in the eld theory limit, all the loop corrections to the Yang-M ills two-point function. In particular, as we showed in Ref. [15], A ^(h) (p_1 ; p_2) can be considered as a master formula containing all information necessary to compute the multiloop Yang-M ills beta function.

Let us now specialize to one loop (h = 1), using the explicit expressions written in the previous section, and in particular using $_{i}$ as integration variables. We have

Notice that if the mass shell condition (2.11) is enforced, the two-gluon am plitude becomes ill dened, as the kinematical prefactor vanishes, while the integral diverges. It is then necessary to somehow continue on shell the string am plitude, and then test that the results remain consistent in the eld theory limit. This was not attempted in Ref. [20], where a prescription was found that leads to a vanishing wave function renormalization in the eld theory limit. On the other hand, in Ref. [15] we have shown that, if we form ally extend the gluon momenta on shell according to Eqs. (2.35) and (2.36), then in the limit 0 ! $0 A^{(1)}$ (p₁;p₂) develops an ultraviolet divergence, which in turn determines a non-vanishing wave function renormalization constant Z_A , equal to the one computed in the background eld method.

In order to see this, we follow R ef. [8], and notice that the modular parameter and the coordinate are related to proper-time Schwinger parameters for the Feynman diagrams contributing to the two-point function. In particular, t ⁰ and t_1 ⁰, where t_i is the proper time associated with one of the two internal propagators, while t is the total proper time around the loop. In the eld theory limit, with the possible exception of pinching congurations, to be discussed later, these proper times have to remain nite, and thus the limit 0 ! 0 must correspond to the limit f; g! 1 in the integrand. This can also be checked directly by examining the integral in Eq. (3.5), and is most easily seen by rescaling the integration variable according to ^ = . The eld theory limit is then determined by the asymptotic behavior of the Green function for large , namely

In most cases it will be su cient to keep only the rst term in the in nite series appearing in Eqs. (3.7)-(3.9). The only exceptions are discussed in Section 5.

We now substitute these results into Eq. (3.2), and keep only term s that remain nite when $k = e^2$! 0; divergent term s are discarded by hand, since they correspond to the propagation of the tachyon in the loop. Notice that the divergence associated with the tachyon is not regularized by continuing the space-time dimension away from four, whereas all divergences associated with gluons are turned into the usual poles of dimensional regularization. Notice also that by taking the large

lim it with ^ 0 (1) we have discarded two singular regions of integration that potentially contribute in the eld theory lim it, nam ely ! 0 and ! . In these regions the G reen function has a logarithm ic singularity corresponding to the insertion of the two external states very close to each other, and this singularity, as we shall see the in the next section, in general gives non-vanishing contributions in the eld theory lim it. However, in the case of the two-gluon am plitude, these regions correspond to Feynm an diagram s with a loop consisting of a single propagator, i. e. a \tadpole". M assless tadpoles are de ned to vanish in dimensional regularization, and thus we are justi ed in discarding these contributions as well.

If we delete all unwanted contributions, replace the variable with $^{=}$, and integrate by parts to remove the double derivative of the G reen function, Eq. (3.5) becomes

If we now substitute Eq. (3.11) into Eq. (3.2), we see that the ⁰ dependence cancels, as it must. The ultraviolet nite string amplitude, Eq. (3.2), has been replaced by a eld theory amplitude which diverges in four space-time dimensions, because of the pole in the function in Eq. (3.11). Reverting to the custom ary conventions of dimensional regularization, we set d = 4 2 and $g_i = g$, where g is dimensionless and an arbitrary scale. Putting everything together we nd

Eq. (3.12) is exactly equal to the gluon vacuum polarization of Y ang-M ills theory, computed with the background eld m ethod, in Feynm an gauge, with dimensional regularization.

From Eq. (3.12) we see that the ultraviolet divergence at d = 4 can be rem oved by a wave function renorm alization, with a minimal subtraction Z factor given by

W hile this result is what we expected, to make sure that our prescription is consistent we need to go on to compute the three and four-point renormalizations as well, and verify that gauge invariance is preserved. This we will do in the next two sections.

4 The three-gluon am plitude

The color-ordered amplitude for three transverse gluons at tree level is given by Eq. (2.21) with M = 3, that is

(4.1) becomes the standard Yang-M ills color-ordered three-gluon amplitude, and the reader may easily verify the correctness of the normalization, taking into account our conventions.

O ur task is now to compare A ⁽¹⁾ ($p_1; p_2; p_3$) with A ⁽⁰⁾ ($p_1; p_2; p_3$) in the lim it ⁰! 0, and thus derive the three-gluon vertex renorm alization constant at one loop.




Figure 1: Representative diagram for the type I region of the three-gluon am plitude.

A careful analysis of Eq. (4.2) allows us to distinguish three di erent types of regions in the integration domain that contribute to the eld theory limit, and to associate the three corresponding contributions to the three classes of Feynman diagrams depicted in Figs. 1–3. To understand this, let us concentrate on two of the punctures, say $_2$ and $_3$, and follow the reasoning of Section 3, which again leads us to identify the eld theory limit of the amplitude (4.2) with the limit ! 1 in the integrand (4.3). There are now, however, three di erent ways of taking this limit that give nite contributions. First of all, one can let

which corresponds to shrinking the width of the annulus, while keeping the punctures widely separated. This region is strictly analogous to the only region that contributes to the two-point function, and can be discussed along the sam e lines of Section 3. We refer to it as a region of type I. A swe shall see, this region will generate the contribution of one-particle irreducible diagram s with three propagators in the bop, and thus only three-point vertices, as shown in Fig. 1.

Here the coordinates are still widely separated, since $_{3}_{2} = 0$ (1), but the proper time of the corresponding propagator vanishes as ! 1, so that the two punctures come together in the eld theory limit. This region, which we call of type II, will generate the contribution of a diagram with a four-point vertex and only two propagators in the loop, as shown in Fig. 2. Notice that since the 's are still widely separated, the expansion given in Eq. (3.6) for the G reen function G ($_{32}$) can still be applied, as we are still away from the singularity corresponding to $_{2} = _{3}$.

F inally, the third relevant region is the pinching region, de ned by




Figure 3: Representative diagram for the pinching region 32 = 0 (²) of the three-gluon amplitude.

for the G reen function and its derivatives. As shown already in Ref. [8], pinching two variables is equivalent to the introduction of a propagator attached to the loop, and thus generates an exchange diagram in the channel determined by the two pinched punctures. W hen such an exchange involves only gluons, the corresponding contribution to the amplitude in the lim it ⁰! 0 certainly corresponds to a one-particle reducible diagram, as shown in Fig. 3. However, there may be cases in which after pinching, the resulting exchange involves also the tachyon of the bosonic string. This leads to a divergence which we discard by hand, as we did for the divergence due to tachyons circulating in the loop. A swe shall see in Section 5, there are circum stances in which the propagation of a tachyon in a pinched con guration can give a contribution that survives in the eld theory lim it, in the form of a contact interaction among four gluons. Such contributions are properly dealt with by assigning them to a type-II region, together with all other contributions corresponding to four-point vertices directly attached to the loop.

Since we are interested in m in in al subtraction renorm alization constants, in the following we will concentrate on the contributions that diverge as d ! 4. They are easy to isolate, as they can be produced only by an integral over the modular parameter containing the factor 1 d=2, that gives (2 d=2) (lower powers of are suppressed by corresponding extra powers of 0). Since each integration generates a factor of through the change of variable ! ^, we actually need the square bracket in Eq. (4.3) to generate a single negative power of , in order to produce a divergent integral.

In order to display the relevant contributions, let's focus our attention on the term of Eq. (4.2) proportional to $"_1$ 2" which, up to the constant prefactors, is given by

W e can now check that the region of moduli space just considered in fact corresponds to the diagram s in eld theory with three propagators in the loop. 


Figure 4: Representative diagram for the type II region 1 3 = 0 (¹) of the three-gluon amplitude.

in Eq. (4.13) corresponds to a vanishing proper time between $_3$ and $_1$, and thus it can be associated with the diagram represented in Fig. 4. Finally, the third region, Eq. (4.14), corresponds to a vanishing proper time between $_1$ and $_2$ and can be associated with a diagram with two propagators and a four-point vertex between the gluons 1 and 2.

In order to see how these regions contribute to $J(p_1;p_2;p_3)$, we use for $0 \in ()$ and $0^2G()$ the term s of their expansions, Eqs. (3.8) and (3.9), that are of the form k^{-} . They combine to give

in region (4.13). For general values of 2 and 3 such term s, as well as all the others which we have not exhibited, fail to compensate the leading factor of k¹ from the measure. However, precisely in the regions (4.12) and (4.13) the term s written in Eqs. (4.15) and (4.16) become proportional to k, and thus give a nite contribution. Once again, if we are only interested in the ultraviolet divergence we can replace the exponential of the G reen functions by an infrared cuto as above, whereupon the integral over the punctures becomes trivial. Indeed, the expression in Eq. (4.15) yields a factor of (8=) ("1 2"p1 3") from region (4.12), while Eq. (4.16) produces a factor of (8=) ("1 2"p2 3") from region (4.13). On the other hand, one can check that region (4.14) does not give any contribution to the ultraviolet divergence of J (p1; p2; p3). In fact, in this case it is not possible to produce the right power of the modular parameter from the ^ integration.

Recalling that p_1 $"_3 = p_2$ ", the total contribution to J (p_1 ; p_2 ; p_3) from regions of type II is then

and one can verify that this is exactly the contribution from diagram s with a fourgluon vertex in the background eld method, as conjectured.

F inally, we turn to the analysis of the pinching regions. In our case, there are three such regions, namely ! 1 with

as dictated by cyclic symmetry and periodicity on the annulus. One can easily see that in all those regions at least one of the G reen functions in Eq. (4.8) is singular.

Let us consider, for example, the stpinching, i.e. $_2$! 0. Since $_2$ is localized in a neighbourhood of 0, we can replace the integral $_0^3$ d $_2$ with an integral $_0^3$ d $_2$, where is an arbitrary sm all number. Further, we can use the approximation in Eq. (4.7) for the G reen function G ($_2$) and its derivatives. A fler this is done, we can expand G ($_{32}$) in powers of $_2$, which turns the amplitude J (p_1 ; p_2 ; p_3) into an in nite series. The n-th term of this series is proportional to an integral of the form

Therefore, when the pinching $_2$! 0 is performed, the amplitude J (p_1 ; p_2 ; p_3) becomes an in nite sum over all possible string states that are exchanged in the (12)-channel, n = 0 corresponding to the tachyon, n = 1 to the gluon and so on. In the case of the three-gluon amplitude, the exchange of a tachyon does not give any contribution: in fact, for $_2$! 0

U sing the trasversality of the external states, we see that the coe cient of the quadratic divergence $\frac{1}{2}$ is zero. Even if this tachyon contribution had not been vanishing, we would have discarded it, according to our prescription. On the other hand, the gluon term survives in the eld theory limit, and actually contributes to the ultraviolet divergence, as expected: in fact, the single pole in $_2$ generates, through the change of variables to 2 , the negative power of needed for the integral




Figure 5: Representative diagram for the pinching region $_2$! 0 of the three-gluon am plitude.

to diverge. A llother term s in the series, corresponding to n 2, and to states whose mass becomes in nite as 0! 0, vanish in the eld theory limit.

K exping this in m ind, and collecting all relevant factors, we nd that the contribution to $J(p_1;p_2;p_3)$ from the pinching $_2$! 0 is

where R is the integral de ned in Eq. (3.5). Notice that Eq. (4.24) contains a ratio of m om entum invariants which are vanishing on shell. The appearance of such ratios in string am plitudes, in the corners of m oduli space corresponding to loops isolated on external legs, is a well-known fact, which for example motivated the work of Ref. [20]. As we already remarked in Ref. [15], this 0=0" am biguity is sim ilar to the one that appears in the unrenormalized connected G reen functions of a massless eld theory, if the external legs are kept on them ass-shell and divergences are regularized with dimensional regularization. There, such am biguity is removed by going o shell; sim ilarly here, we form ally continue the gluon momenta o the mass shell, following the same prescription we already adopted in the previous section for the two-gluon am plitude, i.e. we put o shell the momentum of the gluon attached to the loop, according to

In the present case, however, this prescription is not enough to rem ove the am biguity in Eq. (4.24), and we must further decide whether and how to continue o shell also the other gluon m on enta, p_1 and p_2 . Here we rely on the assumption, substantiated by the results obtained so far, that string am plitudes lead to eld theory am plitudes calculated with the background eld method. A swas shown in Ref. [22], to calculate am plitudes with the background eld method it is necessary to treat one-particle

irreducible and one-particle reducible diagram squite di erently. S-m atrix elem ents are obtained by rst calculating one-particle irreducible vertices to the desired order, and then gluing them together with propagators that can only be de ned when the gauge for the background eld has been xed. As noticed also in Ref. [11], the gauge chosen for the background eld is quite independent from the gauge that had been chosen for the quantum eld, in our case the Feynm an gauge. This leads us to interpret Eq. (4.24) as a one-loop, one-particle irreducible two-point function, whose m on entum must be continued o shell according to Eq. (4.25), glued to a tree-level three-point vertex, for which no o -shell continuation is necessary. W e thus keep $p_1^2 = p_2^2 = 0$, which, using m on entum conservation, im plies

where we have used Eq. (3.11) with d = 4 2. One can easily check that this is exactly the contribution of one-particle reducible diagram s with the loop isolated on the third leg as shown in Fig. 5.




Figure 6: Representative diagram for the pinching region $_3$! of the three-gluon am plitude.

The other two pinchings, Eq. (4.19) and Eq. (4.20), can be analyzed in a similar way with obvious changes of labels. One nds that they lead to the same result of Eq. (4.27) and can be associated with the diagram s represented in Fig. 3 and Fig. 6 with the loop isolated on the rst and the second leg respectively. The total contribution to $J(p_1;p_2;p_3)$ from the type III region is then

As we have mentioned before, the other two terms of the amplitude (4.2) that are proportional to "2" and "3", can be simply obtained from $J(p_1;p_2;p_3)$ by cyclic permutations of indices. We can now write the eld theory limit of the full one-loop amplitude A⁽¹⁾ ($p_1; p_2; p_3$) and extract from it the vertex renormalization constant. Reinstating all normalization factors, and summing the contributions from regions I, II and III, we not that the total divergence is

The W ard identity

is typical of the background eld method. Thus our present result is a con mation of what we have already found in Section 3, and provides also a non-trivial consistency check on the whole procedure.

Further evidence of this fact is given by the following observation: since the contributions from regions I and II are represented by the one-particle irreducible diagram s of F igs. 1, 2 and 4, while those of the pinching regions are given by the reducible diagram s of F igs. 3, 5 and 6, we are led to believe that the sum of the contributions from regions I and II should be the proper three-point vertex and give directly the renorm alization constant Z_3 . This is exactly what happens. In fact,

which once again leads to the background eld W and identity (4.31).

In order to obtain these results, we could have adopted a slightly di erent procedure, integrating by parts the double derivatives of the G reen functions as we did in Section 3. D oing that one arrives at the sam e result found by B ern, K osow er and R oland in R ef. [20] (they used a di erent string m odel, but that does not have any in uence on the eld theory lim it). Integration by parts moves all contributions to the renorm alization constants to the pinching regions, and thus spoils the identi – cation of the di erent regions of moduli space with classes of Feynm an diagram s, which is clearly displayed here. However, if one uses our prescription, Eq. (4.25) and Eq. (4.26), to remove the ambiguity associated with the pinching, Eq. (4.31) is again obtained.

As a nalconsistency check, we will verify the gauge invariance of our prescription, by calculating in the following section the renorm alization of the four-point vertex, and showing that it is properly related to the renorm alization of the gauge coupling.

5 The four-gluon am plitude

In order to obtain the renorm alization constant Z_4 of the four-point vertex, we need to compare the four-gluon amplitude at one loop with the tree-level expression,



Here terms of the form ("")(" 2 p) as well as higher orders in 0 , have not been written explicitly, since they will not play any role in our discussion. A more complete expression for A ${}^{(0)}$ (p_{1} ; p_{2} ; p_{3} ; p_{4}) can be found in Eq. (A.6) of Appendix A.

The color-ordered planar amplitude with four gluons at one loop is given by Eq. (2.35) in the case M = 4. Notice that in the open bosonic string the complete one-loop four-gluon amplitude receives a contribution also from the non-planar diagram, where two gluons are emitted at one boundary of the annulus and two at the other. However, the non-planar diagram does not contribute to the renorm alization constant Z_4 , so we need not consider it here.

To simplify the analysis, we will again focus on a single term of the full fourgluon amplitude. The simplest choice is the term proportional to $"_1 "_3"_2 "_4$: in fact, for the chosen color ordering, at tree-level this term is generated only by the 1PI diagram given by the four-point vertex ⁴. Thus, we will calculate the contributions from the three regions described in the previous section to the integral

⁴At the end of this section we will brie y comment on the term proportional to $"_1 "_2 "_3 "_4$, which does not share this property.

where $_{54}$ 1 $_4$. Since we are boking for those contributions that in the eld theory limit diverge when d ! 4, again we need to isolate in the integrand of Eq. (5.2) the term proportional to $^{1 d=2}$. Then, to nd the divergence, we can replace the exponentials of the G reen functions by a simple infrared cuto, as we did in Eq. (4.10). Substituting $Q^2G()$ with the leading term of its expansion, Eq. (3.9), the contribution to J (p₁;p₂;p₃;p₄) coming from region I is

We can check that this corresponds to the contribution of the eld theory diagram s with four propagators in the loop, as depicted in Fig. 7.

In the previous section we learnt that factors of 1= are produced also by the type II regions. In the present case we have four such regions, namely

To generate the desired factor of $1 = we must recover in the integrand of Eq. (5.2) an expression similar to Eq. (4.15), and thus we must employ the last two terms of the expansion (3.9) for both of the factors <math>0^2G$ () present in Eq. (5.2). However, if

only one pair of $^$ variables satis es Eq. (5.5), while the others are widely separated, only one factor of 1= is produced by the integration, and the nal result is not ultraviolet divergent in d = 4. This means that diagram swith three propagators in the loop, like those depicted in Fig. 8, do not contribute to the coe cient of the 1= pole for the term "1 3""2 4". On the contrary, to produce a divergence we must consider two of the regions in Eq. (5.5) at the same time. We have the following two possibilities




Figure 9: Representative diagram for the region $^{2}_{2} = 0$ (¹) and $^{4}_{43} = 0$ (¹) of the four-gluon amplitude.




Figure 10: Representative diagram for the region $^{32}_{32} = 0$ (¹) and 1 $^{4}_{4} = 0$ (¹) of the four-gluon amplitude.

They correspond to the diagram s represented in Fig. 9 and Fig. 10 respectively, which have two propagators and two four-point vertices. The procedure is now alm ost identical to the one followed in Section 4. A fler using Eq. (3.9), we nd that the relevant term s of the form k^{2} combine to give

F inally, we turn our attention to one-particle reducible contributions originating from the pinching regions. By analyzing the structure of the integrand of Eq. (5.2), one realizes that pinching singularities contribute to the ultraviolet divergence of the term we are examining only when three consecutive punctures are pinched together,




Figure 11: Representative diagram for the pinching $_2 ! _3 ! _4$ in the four-gluon amplitude. The other three double pinchings, $_3 ! _4 ! , _2 ! 0$ with $_4 ! ,$ and $_3 ! _2 ! 0$, give rise to similar diagram s with the loop isolated respectively on the second, the third and the fourth external gluon.

that is when $_2 ! _3 ! _4$, or $_3 ! _4 !$, or $_3 ! _2 ! _0$, or $_2 ! _0$ with $_4 !$. Each of these four regions gives the same contribution, that we expect to be simply proportional to the two-gluon amplitude, since the loop is isolated on an external leg, as shown in Fig.11.

Let us concentrate on the pinching $_2 ! _3 ! _4$, which isolates the loop on the rst leg. In this case Eq. (5.2) becomes

A s expected, this last equation contains a ratio of invariants that becom es indeterm inate when the external states are on shell. We solve the am biguity with the same prescription used in the previous section, i.e. we put o shell only the momentum of the gluon attached to the loop and keep the others on shell, according to

C om paring with what we expect from eld theory for a truncated, connected fourpoint G reen function, we obtain

This result is further con m ed by the fact that the contributions from the type I and type II regions, associated with one-particle irreducible diagram s, properly add. Indeed,

We conclude with a brief analysis of the term proportional to $"_1 ~ 2""_3 ~ 4"$ in the four-gluon amplitude, and show that our results, Eq. (5.21) and Eq. (5.22), still hold in this case. Let us then consider the integral

The contribution from the type II region is, however, di erent from Eq. (5.10). This can be traced to the fact that in this case there are contributions from regions of type II in which the two $^$ variables that are taken to be close to each other are precisely the ones that appear in the argument of one of the G reen functions whose double derivative is taken in Eq. (5.24). As a consequence, there will now be non-vanishing contributions also when a single pair of $^$ variables approach each other. Let us, for instance, consider the region

with all other variables widely separated. It corresponds to the diagram depicted on the left in Fig. 8. Using Eq. (3.9), we see that in this region the relevant terms of ℓ_2^2 G (₂) ℓ_4^2 G (₄₃) combine to give

Now however, in contrast to all previous cases, the entire series in n, and not just its rst term, must be taken into account: in fact, in region (5.26) all terms of the form e²ⁿ² are on equal footing for any n since ² is nite. Computing the integrals, and extracting the right power of that is necessary to produce the divergence in d = 4 2, we not that

It should be apparent that the reason for this divergence is the singularity of the G reen function as $_2$! 0, which did not cause problem s when only the rst term in the series in Eq. (3.7) was used, but cannot be avoided when the whole series is included. One may thus wonder whether we are not double counting some term s,

which m ight as well be included in the pinching region. This does not happen, and the reason is that the residual contribution from the pinching region, which is included in Eq. (5.28), can be traced to the exchange of a tachyon in the pinched channel, that is explicitly discarded when we study region III. In fact, if one uses Eq. (4.22) for n = 0 to isolate the tachyon contribution in the relevant channel, the result is divergent in the eld theory limit. This divergence can be regularized by taking the residue of the tachyon pole, which corresponds to a contact interaction with a four-gluon vertex and no propagating tachyon. This calculation leads precisely to a contribution m atching Eq. (5.28). By including this contact interaction in region II we are correctly identifying it as a one-particle irreducible contribution. A similar reasoning leads to identify an identical contribution from the region

6 A direct com putation of proper vertices

From the detailed analysis of the previous sections we learnt that it is possible, and indeed desirable, if one wishes to calculate renorm alization constants, to isolate from the amplitude one-particle irreducible diagrams that contribute to the e ective action. In this section we will show how this can be done directly at the level of the string am plitude, following the ideas of M etsaev and T seytlin [2]. The starting point of this approach is the introduction of an alternative expression for the bosonic G reen function, Eq. (2.41), which is suitable for a regularization of pinching singularities. As we shall see, the -function regularization used in this case is precisely the one introduced in Eq. (5.29), and thus it handles correctly also the residual contributions from the propagation of the tachyon in the pinched channel, assigning them to one-particle irreducible diagram s. The most interesting feature of this approach is that, at least at one loop, it allows to integrate exactly over the punctures, before the eld theory limit is taken. This is possible because, having regularized the pinching singularity, there is no integration region that generates negative powers of ⁰ in the eld theory lim it. One can then focus on term s proportional to $\binom{0}{2}^{d=2}$, and for those terms one is allowed to replace the exponentials of the G reen function by a simple infrared cuto, of the form exp $(2^{\circ} m^2)$, as we learnt in the previous sections. The simpli ed integral over the punctures can then be performed exactly, using the Green function given by Eq. (2.41). Using these techniques we will be able to express the renorm alizations of the various divergent am plitudes in terms of a single string integral, Z (d), which in the eld theory lim it reproduces the wave function renormalization Z_A .

Our starting point is Eq. (2.35), with the choice of projective transform ations given in Eq. (2.38). We rewrite it as

where terms needed for cyclic symmetry and terms of order 0 are not written explicitly, and we discarded the exponentials of the G reen functions, that are again irrelevant for ultraviolet divergences. Notice that for the three-point function the overall power of 0 is correct provided we do not perform the partial integration of double derivatives, as was done for the two-point amplitude. As remarked at the end of Section 4, partial integration of the three-gluon integrand reshu es the contributions of di erent diagrams in the eld theory limit, so that it is no longer possible to identify unambiguously the one-particle irreducible ones.

The integrals over $_2$ and $_3$ can now be done, using as before Eq. (2.41) for the G reen function. It is easier to start by performing the integral over $_3$, from $_2$ to 1. Then the integral over $_2$ can be performed, as in the case of the two-gluon amplitude, using an identity similar to Eq. (6.4), but with the cosines replacing the sines. The result is

7 String in a non-abelian background eld

The results of the previous sections show that the eld theory limit of string theory leads unambiguously to the background eld method. Furtherm ore, we have learnt that contributions to the eld to the eld method. Furtherm ore, we have learnt that contributions to the eld to the Green function. In this section we will show how, under appropriate assumptions, these results can be derived directly, for any number of string loops, from the partition function of a string interacting with an external non-abelian background eld. We will give a general expression for the planar contribution to this partition function, and we will form ally generalize the analysis of Section 6 to all loops, verifying explicitly that gauge invariance is respected, and constructing a general expression for the multiloop analog of the one-loop integral Z (d). We will then deal with the special problem s arising at tree level and one loop, along the lines of R ef. [23], and show how the results of the previous sections are correctly reproduced with this construction. This also substantiates the som ewhat form alm anipulations that one has to perform on the multiloop expressions.

Let us consider the planar contribution to the partition function of an open bosonic string interacting with an external non-abelian SU (N) background. It is given by

The measure of integration over the moduli, $dM_{\rm h}$, is equal to the one given in Eq. (2.16), but does not include the di erentials of the punctures, nor at this stage the factor dV_{abc} , responsible for the xing of projective invariance. For h 2 the factor dV_{abc} can be included without problem s, provided we do not x the position of any of the punctures, choosing instead three of the xed points of the surface in the Schottky representation. For h = 0 this cannot be done, and for h = 1 it can be done only partially, as the surface in these cases has less than three xed points. One is then led to x some of the punctures, as was done in the previous sections. In the present context, how ever, xing som e of the punctures would interfere with the de nition of path ordering given by Eq. (7.2), and would signi cantly complicate the following derivation. We then choose not to x any of the punctures, which ensures that our form ulas are valid for any number of loops. The price we pay is that at tree level the expressions we write are form ally in nite, because we failed to divide by the volume of the projective group. This however can be repaired by treating the projective in nities with a renormalization prescription: rst we regularize them by compactifying the range of integration, then we divide by the com pacti ed projective volume, obtaining a quantity that remains nite when the com pacti cation radius is taken to in nity. As with any renorm alization prescription, this leaves us with an undeterm ined nite overall constant, that can be xed by comparing with the results of the previous sections, or with a eld theory calculation. For this reason we are unable to deduce Eq. (2.8) in this functional integral approach (see also [23]). At one loop, we can partially deal with the projective invariance by xing the positions of the two xed points of the Schottky generator. W e are then left with an overall translational invariance, that we do not eliminate by xing one of the punctures. Rather, we integrate over all punctures, dividing at the end by the volume of translation, which is nite at one loop. This way we get the correct one-bop result, including the overall constant.

Since Eq. (7.1) is the string expectation value of a W ilson loop winding around one boundary of the string, we expect it to be gauge invariant. It is instructive to see how gauge invariance emerges out of the calculation, for any number of string bops. To this end, we will compute separately the three contributions $C_2^{(h)}(A); C_3^{(h)}(A)$ and $C_4^{(h)}(A)$, and see how they correctly reconstruct the gauge invariant elective action. We will assume that pinching singularities have been regularized, and thus we will discard all terms arising from partial integrations that involve the G reen function evaluated at the pinching. We will also use the periodicity of the G reen function to discard all boundary terms corresponding to integrations over the com – plete boundary loop.

Let us start by considering $C_2^{(h)}$ (A). It is given by

As we mentioned before, tree-level and one-loop contributions need extra care because of the un xed projective invariance of the functional integral. Here we sketch how this problem can be handled, drawing on the results of the previous sections and on the ideas of [23]. In the process, as expected, we rederive the one-loop integral Z (d). At tree level, the projective in nity that would have been eliminated by xing three of the punctures can be regularized by compactifying the integration region of the variables z_i , mapping them from the real axis to a circle. On a circle, following Ref. [23], we can use the G reen function

If we can pute the six integrals in Eq. (7.14), and the three integrals in Eq. (7.16), we see that the cambination of $C_2^{(0)}$ (A), $C_3^{(0)}$ (A) and $C_4^{(0)}$ (A) in Eq. (7.6) correctly reconstructs the full non-abelian gauge invariant action, in agreement with the results of Ref. [23], where only $C_2^{(0)}$ (A) is explicitly computed while $C_3^{(0)}$ (A) and $C_4^{(0)}$ (A) are deduced from gauge invariance. The result is of the form

The one-loop coe cients C $_{i}^{(1)}$ (A) can be similarly computed without xing any of the punctures. We can however x the location of the xed points and of the Schottky group, as was done in the previous sections. Having done that, we are left with invariance under translations of the z_i , or, more conveniently, of the variables $_{i}$, related to the z_i by Eq. (2.30). The difference with respect to the tree level integrals is that now the variables $_{i}$ are integrated in an ordered way in the interval (0;) instead of (0;2). As a consequence, instead of the factor 2 arising from the redundant integration of a translationally invariant function, we will get a

factor . We have to remember, however, to divide the computed expression by the volume of the translational part of the projective group, that has not been xed, and that is equal to $\frac{R_1}{k} \frac{dz}{z} = \log k = 2$. With the inclusion of this factor the measure of integration over k is

We have thus veried that the general form alism developed in the rst part of this section applies to the somewhat special cases h = 0 and h = 1, and we have also veried that the assumptions made for general h, concerning the cancellation of boundary terms and the regularization of the pinchings, are satisted for h < 2. Notice nally that the present functional integral derivation of the renormalization factor C_h given in Eq. (2.4). The h-loop contribution to Z_P (A) contains in fact precisely a factor of (2)^(dh) corresponding to the integration over h loop momenta, a factor of (2⁰) d=2 from the change of measure given by Eq. (7.5), and the correct power of the string coupling constant.

8 Summary and perspectives

W e have analyzed in detail three related m ethods to calculate renorm alization constants in Yang-M ills theory, all based on a consistent prescription to continue o the m ass shell multipluon am plitudes derived from string theory. Our prescription leads unam biguously to the background eld m ethod, and is phrased directly in the language of dim ensional regularization.

The use of the open bosonic string has introduced undesired di culties due to the presence of a tachyon, but we have shown explicitly how such di culties can be overcom e, at least at one loop. In this context, perhaps the most signi cant observation is that divergences associated with the tachyon are not regularized by analytic continuation of the space-time dimension, whereas all divergences associated with Yang-M ills gauge bosons turn into the usual poles at d = 4.0 n the other hand, using the simplest available string theory has allowed us to phrase our technique directly in the language of multiloop string am plitudes, while m in im izing the am ount of string technology needed for the calculations. This may prove necessary when practical multiloop calculations are attempted.

Our work com plements what is known about string-derived on-shellmultigluon am plitudes [8], and e ective actions [2], in several ways. Our prescription, clearly tied to, and in fact inspired by the background eld method in eld theory, provides an o -shell extension of the analysis of Ref. [11]. By working with a simple string theory, and by not perform ing the partial integration of double derivatives of the world-sheet G reen functions that appear in the amplitudes, we have been able to m ap explicitly each region of moduli space that contributes to the eld theory limit to a specic set of Feynm an diagram s. This mapping, which may prove useful in future applications going beyond one loop, has enabled us to identify precisely the regions of moduli space that contribute to the e ective action, leading to considerable simplications in the calculation of renorm alization constants. At one bop, ultraviolet divergences of gluon amplitudes turn out to be sum marized by a single integral over the string modular parameter, which still contains all contributions from the in nite tower of massive string states. The eld theory limit of this integral is the gluon wave function renorm alization of the background eld method. We have thus made a precise connection between the techniques of R ef. [8] and those of Ref. [2]. In particular, we have shown how the -function regularization of pinching singularities introduced in Ref. [16] is precisely suited to handle correctly the contact terms left over by the propagation of tachyons in pinched con gurations. F inally, we have studied the partition function of an open string interacting with a background Yang-M ills eld, to allorders in string perturbation theory, focusing on planar diagram s. As m ight have been expected from the explicit results obtained at tree level and at one loop, this partition function is a generating functional for the contributions to the gluon e ective action of string diagram swith an arbitrary number of legs and loops. A form all analysis of this partition function shows how string theory generates a gauge-invariant e ective action for any number of loops, and in fact leads to a multiloop generalization of the one-loop integral, Z (d), generating the renorm alization constants. Tree-level and one-loop diagram s are special, because of the extra invariances that reduce the dimensionality of the corresponding string moduli space, but the di erences can be handled and the known results are recovered also from the general h-loop form alism.

The general form alism developed in Section 7 helps perhaps to shed som e light on the relationship between string theory and the background eld m ethod. Exam ining the expression for the string partition function, Eq. (7.1), one m ay observe that any string am plitude m ay be written in terms of interactions with a background eld, provided the bakground eld satis es the string equations of m otion. In particular, ordinary gluon am plitudes correspond to a background eld constructed out of plane waves. The only apparent obstacle to this interpretation is the presence in the full string am plitudes of the pinching singularities, that correspond to interactions of the external elds happening far away (on the string scale) from the string loops. This is exactly the same problem that arises in eld theory, in background eld calculations of S-m atrix elements. There, if one allows for interactions among the background elds, one is forced to quantize them also, introducing a new gauge xing term and constructing the corresponding propagator. Here, once the pinching singularities are removed, the calculation of the elective action perform ed along the lines of Section 6, or of Section 7, can be simply understood as an infrared limit of the calculation of a gluon scattering am plitude, where a quasi-constant background eld has taken the place of the plane wave representing the gluon.

A few remarks may be added concerning the choice of regularization scheme. This paper makes extensive use of dimensional regularization, which is very practical if one whishes to compare the results with QCD calculation, where it is by far the m ost com m only used scheme. However, it should be kept in m ind that this choice is not by any means the only possible one. In fact, it may not be the best choice if one wishes to extend to more than one bop the elective action calculations performed in Section 6. In general, h-loop contributions to renorm alization constants appear in dimensional regularization as coe cients of the single pole in = 2 d=2, and m ay be m issed if one uses a m ethod that neglects 0 () corrections. Regularization with, say, a momentum space cuto may be more appropriate, since in that case divergences are further classi ed according to the power of the cuto involved (see for example Ref. [2]). It may also be argued that string theory by itself provides a regularized version of Y ang-M ills theory, with the role of the cuto being played by 1= °. In fact, this \stringy" regularization is quite sim ilar in spirit to Pauli-Villars regularization, in the sense that the theory is made nite by adding an in nite number of new degrees of freedom with heavy masses and with carefully selected coe cients. It might be instructive to study how this \stringy" regularization translates in a eld theory language.

Sum m arizing, we believe we have shown that the multiloop string technology needed to study perturbative Yang-M ills theory exists, and the complexity of the necessary calculations may remain manageable, provided one uses a su ciently simple string theory, as we have done in this paper. This may have wide-ranging applications, not only to practical calculations of phenom enological interest, but m ore generally to develop a deeper understanding of the organization of the perturbative expansion of gauge theories. String theory has proven to be remarkably clever in organizing gauge theory amplitudes both at tree level and at one loop, suggesting the best choices of color and helicity organizations, as well as the best combination of gauges. It is fair to hope that sim ilar results may be achieved at least at two loops. On the other hand, the very existence of explicit all-order expressions for the amplitudes in string theory suggests that these tools might also be useful to derive all-order results in eld theory, as was mentioned in Section 3. A simple example of such a derivation is given by our discussion of string propagation in a background eld.

In this appendix we compute the normalization coecients of the h-loop string amplitudes, C_h , and of the gluon states, N_0 , given respectively in Eqs. (2.4) and (2.7). Our strategy to do so is the following: we instead put the three and fourgluon amplitudes at tree level, and require that in the limit ⁰! O they reduce to the corresponding amplitudes derived from the Yang-M ills Lagrangian. This is C_0 and N_0 as functions of the Yang-M ills coupling constant g_d ; we then check that these normalizations are consistent with the factorization properties required by unitarity, and nally we implement the sewing procedure to obtain the multiloop amplitudes, and their overall normalization C_h .

As discussed in section 4, in the open bosonic string the color-ordered threegluon amplitude at tree level is

It is instructive to exam ine also the contributions due to exchanges of other string states. For example, let us consider the tachyon (I = 1). In order to check Eq. (A 11) in this case, we need to know the ordered amplitude A $_{1}^{(0)}$ involving two gluons and one tachyon. This can be easily computed in the operator form alism, and one nds

where N₁ denotes the norm alization of the tachyon state. Repeating the same steps as before, we can see that the residue of the four-gluon amplitude at the tachyon pole, Eq. (A.6), factorizes into the product of two three-point amplitudes, like Eq. (A.17), if $C_0 N_1^{2} = 2$. W ithout much di culty it is possible to generalize this relation to the I-th string state, with norm alization N_I, and thus one can conclude that unitarity in plies that

Let us now turn to the normalization C_1 of the one-loop amplitudes. Since a loop can be obtained by sewing two legs of a tree-level amplitude, the coe cient C_1 can be deduced from C_0 . To see this, let us consider a color-ordered amplitude for the scattering of M gluons and two arbitrary states I and J (which for simplicity we take to be adjacent in the chosen ordering along the loop), at tree level. We schem atically denote such amplitude by

where K_{IJ} (p_I ; p_J) is an appropriate kinem atic factor. To obtain the M -gluon am plitude at one bop we ist identify the states I and J by m eans of the sew ing operator, which carries a factor of ⁰, and then we integrate over their m om entum q and sum over their color index b. F inally, we must sum over all possible interm ediate states. Thus, upon sew ing, Eq. (A.19) is replaced by

where $K_{JJ}(q;q)$ is what it is obtained from $K_{JJ}(q;q)$ with the inclusion of the sewing operator. The integral over q produces a factor of (2⁻⁰) ^{d=2} and leaves the non-zero mode part of $K_{JJ}(q;q)$, which we denote by K_{JJ}^{0} , whereas the sum over colors yields

All factors in this expression have a simple interpretation: the rst ensures the canonical normalization of all loop momentum integrals, the second contains the correct power of the string coupling costant, dictated by string perturbation theory, and nally the last is necessary to give the vacuum amplitude the proper dimension, (length) $^{\rm d}$.

Appendix B

In this appendix we compute the integral Z (d), Eq. (6.7), in the eld theory limit, and thus derive Eq. (6.17) from Eq. (6.16).

The rst important step is the observation that the sum appearing in Z (d) can be written as

It is interesting then to notice that the result of the integration over the punctures in the open string becomes very similar to what has been found by K aplunovski [5] for the closed heterotic string.

U sing the identity

By expanding the partition function

we see that the coe cient of the term 1 d=2 in the integral contains an expansion in powers of k, possibly also with some extra factors coming from the rst two terms in braces in Eq. (B.3).

The leading term, O (1=k), corresponds to tachyon exchange in the loop and, as always, we just neglect it by hand. We neglect also term s O $(\frac{1}{k (\log k)^a})$, where a = 1;2, for the same reason.

The next term is of 0 (1) in k, and corresponds to the exchange of massless gluons. It is given by

where a term with an infrared cuto m^2 , rem iniscent of the exponentials of G reen functions that we discarded, has been added. We stress again that the eld theory lim it is performed by sending ⁰ to zero while keeping the ultraviolet cuto xed and positive.

Eq. (6.17) is obtained by expanding for small after inserting Eq. (B.5) in Eq. (6.16).

Higher order terms in Eq. (B.3), O (k^{I+1}) with I > 0, are negligible in the eld theory limit. This is clearly understood in string theory remembering that the power I is related to the mass of the string excitation exchanged in the loop, and to ⁰, by the formula $I = {}^{0}m_{I}^{2}$ (see also Eq. (A.10)).
