QED for a Fibrillar Medium of Two-Level Atoms

We consider a brillar medium with a continuous distribution of two-level atom s coupled to quantized electrom agnetic elds. Perturbation theory is developed based on the current algebra satis ed by the atom ic operators. The one-loop corrections to the dispersion relation for the polaritons and the dielectric constant are computed. Renorm alization group equations are derived which demonstrate a screening of the two-level splitting at higher energies. Our results are compared with known results in the slow ly varying envelope and rotating wave approximations. We also discuss the quantum sine-G ordon theory as an approximate theory.

1. Introduction

The interaction of radiation with a medium of atom s is an important problem with m any applications, in particular to the propagation of optical pulses and to lasers. W hen studying resonance phenom enon it is natural to approxim ate the atom s as two-level system s, resulting in optical B loch equations. For a single atom in an external classical electric eld, this problem was solved by R abi[1]. A collection of atom s coupled to radiation is described by the so-called M axwell-B loch equations. P ropagation e ects in the latter m odel, were studied by M cC all and H ahn [2]. There, a sem i-classical approxim ation was m ade wherein the electrom agnetic eld was purely classical. W ith som e additional approxim ations (see below) it was shown that the equations of motion reduce to the well-known sine-G ordon equation, and the optical soliton solutions were observed experimentally also in [2]. The problem of many-atom spontaneous em ission was studied in a simplied m odel by D icke[3], which does involve quantized electric elds. W e refer the reader to [4] for an excellent account of optical resonance phenom ena.

In this paper we study the fully quantum system of radiation in interaction with a continuous distribution of atoms in a ber geom etry. Two di erent models are studied, one following from taking the interaction ham iltonian to be $\mathfrak{A} \to \mathfrak{E}$, which we refer to as the current-model', the other following from them inim alcoupling prescription \mathfrak{p} ! $\mathfrak{p} \in \mathfrak{A}$ and referred to as the charge-model'. We develop perturbation theory using the current algebra satis ed by the atom ic operators. This allows us to easily determ ine the dependence of various physical quantities on the number of atom s N. In particular by computing the photon self-energy we determ ine the rst quantum corrections to the polariton dispersion relation and dielectric constant.

In the current model, we show how the quantum corrections imply a renormalization group equation for the two-level energy splitting, this splitting becoming screened at higher energies.

In the last sections of the paper we com pare our results with known results obtained under various approximations, namely the slow ly-varying envelope and rotating wave approximations. We also argue that the quantum sine-Gordon theory has some validity as an eld theory.

The two-dimensional quantum eld theories we study are interesting in their own right. The more interesting of the two models we study (the current-model) is de ned by the ham iltonian

where H_0 is a free ham iltonian for a scalar eld $, S_3; S$ satisfy a current algebra (see equation 2.29), $!_0$ is the two-level splitting of the atom s, and is a dimensionless coupling that depends on the strength of the dipole transition. The renorm alization group equation for the radiative level shifts is a consequence of the beta-function for $!_0$, which we compute to low est order. To the best of our know ledge, this model is not integrable, though various approxim ations to it are integrable (see below).

2. Two M odels for the Quantum M axwell-B loch Theory

There are two related models describing the coupling of two-level atom s to quantized electrom agnetic elds. One follows from taking the interaction ham iltonian to be \tilde{d} E' where \tilde{d} is the dipole moment operator and E' the electric eld. The other follows from the usual minimal coupling prescription, p ! p $d\tilde{d}$ where p is the momentum operator and A' the vector potential. W e will refer to these as the 'current-model' and 'charge-model' respectively. In this section we describe the reduction of both these models to one spacial dimension. W e will rst consider the case of a single atom, and then extend this to a continuous distribution of atom s. W e set c = 1 in most places, but keep h $\frac{1}{2}$ 1 in some form ulas to clarify certain points. All form ulas with $c \in 1$ have both c and h restored.

For both cases, we model a single unperturbed atom as a single electron which has two eigenstates $\frac{1}{2}$ i; jli, with energy di erence h!₀. Letting H₀^{atom} denote the unperturbed atom ic ham iltonian, one has

2.1 Current-Model

O ne can couple the 2-level atom s to the electrom agnetic eld starting from the energy of an electron in an external electric eld. Let the single atom be centered at x_0 , and let $\hat{a} = e x$ denote the electric dipole m om ent operator. The complete ham iltonian is

where H $_0^{\text{eld}}$ is the free M axwell ham iltonian, and x is the position of the electron. Let us further assume that the electric eld does not vary significantly over the region where the atom ic wavefunction is non-zero, i.e.

Consider a brillar geometry, where the atom can be viewed as an impurity in an optical ber of length L and cross-sectional area A, where L P. One can perform a

reduction to this essentially one-dimensional theory as follows. The free M axwell action which determ ines H $_0^{eld}$ is

where F = @ A @ A. Let is denote the direction along the ber, and is is the directions transverse to it. One can not consistently set $A_0 = 0$. We also require the energy ux to be along the ber, so that the Pointing vector is in the b direction. This requires $A_x = 0$ and $@_yA_z = @_zA_y = 0$. Thus, we only have to deal with the components of A transverse to the direction of the ber. Of these, only A = A b couples to the atom. A ssum e A is independent of y; z, and let $A = A \cdot O$ ne has

One can alternatively understand the appearance of the cross-sectional area A by considering the mode expansion of a free scalar eld in nite volum eV,

In the brillar geometry, V = AL and $\stackrel{p}{A}$ is very small compared to L. As L ! 1, the modes in the k-direction are nearly continuous. The transverse modes in the k; b directions have a maximum wavelength on the order of $\stackrel{p}{A}$ and are thus very energetic in comparison to the low energy modes in the L-direction. Thus, we are assuming these high energy transverse modes are negligibly excited, which is reasonable if $1 = \stackrel{p}{A} = !_0$. In general A should be replaced by A_e , which is the elective cross-sectional area of the ber as a waveguide.

The term inology `current-m odel' refers to the fact that the spin operators couple to Q_t which is the spacial component of the conserved topological current Q, where is the anti-symmetric tensor.

The parameter is the important dimensionless coupling constant of the model. Since $d = R_{atom}$, where R_{atom} is an atom ic dimension,

Thus, generally, 2 =8 is very small. An idealized upper limit would correspond to a chain of atom s in a waveguide that is one atom in thickness, so that R_{atom}^{2} A_e. This is perhaps nearly realizable with a polymer waveguide. In this situation 2 =4 1=137. We will refer to this hypothetical limiting case where the quantum elects are strongest as the quantum optical chain.

The parameter $^2=8$ determines the spontaneous decay rate 1= of a single excited atom. First order perturbation theory gives

2.2 Charge-M odel

For the charge-m odel we begin with the standard way to couple particles to electrom agnetic elds and consider a single electron ham iltonian

We refer to this as the charge-model' since (1) (1) is the charge associated to the topological current Q.

The spontaneous decay rate to lowest order for the charge-m odel is the same as for the current-m odel (2.20).

2.3 Continuous D istribution of A tom s

Consider now a collection of atom s, with the N atom spositioned at $x = x_i$, i = 1; ::: N. A lso, let $\tilde{d}_i = e(\mathbf{x} \quad \mathbf{x}_i)$, $jl; 2i_i$ and (i) denote the dipole m om ent, 2-level states, and P auli m atrix operators for the ith atom. Since $ihl j\tilde{d}_i jl i_i = ih2 j\tilde{d}_i jl i_i = 0$, and $ihl j2i_i = 0$, the m atrix elements of \tilde{d}_i don't depend on \mathbf{x}_i . To simplify the situation, we assume that all the atom s are somehow aligned, for example by some external electric eld or by being embedded in a crystal. Then,

A diagram matic technique can be developed for organizing the computation. One rst draws a diagram with n + 1 unconnected lines representing $\mathfrak{S}_0^{(2n+2)}$, where each line is a propagator assigned the value $i = (k^2 - 2 + i)$, and one repeats this diagram for each possible assignment $(k;k^0;k_1;...;k_{2n})$ of the ends of the propagators. Here, the imaginary part arises from choosing a positive argument of the log, i.e. $^2 > !_0^2$, which is physically sensible if resonant photons (with energy $!_0$) have a longer wavelength than the size of atom s. 5. Polaritons and Spontaneous D ecay

7. C om parison with the R educed M axwell-B loch Theory

Two approximations commonly made in the quantum optics literature are the so-called slow ly varying envelope and rotating wave approximations. In this section we compare the above results with the analogous results obtained in these approximations.

The classical SG equation has a rich spectrum of solutions consisting of solitons and breathers. The lowest energy breather solution can be identified with the polariton, as (8.8) shows. The existence of these solutions suggests that the quantum M axwell-B loch theory m ay have a rich spectrum of bound states in addition to the polariton. In the next section we attempt to study this question by considering the quantum version of the SG theory.

9. Quantum Sine-Gordon as an E ective Theory

In the last section we saw how the classical sine-G ordon equation emerged from the reduced M axwell-B loch theory in a sem i-classical approximation wherein the electrom agnetic eld was treated classically. Suppose one attempts to re-quantize the sem i-classical treatment by quantizing the sine-G ordon theory in the canonical manner. W hat such a quantum theory has to do with the fully quantum M axwell-B loch theory is a delicate question. One can hope that an intricate manifestation of the correspondence principle in the end will save the day. In this section we explore these issues and conclude that the quantum sine-G ordon theory has some validity.

O ne does not expect of course that the quantum SG theory precisely reproduces the quantum corrections computed in section 4 for the fully quantum M axwell-B loch theory. O ne can study this explicitly by computing one loop corrections in the SG m odel. Ex- panding out the cos(), the lagrangian is

The one loop contribution to the photon self-energy can be computed using standard perturbation theory. In the conventional coordinates $\mathbf{x}; \mathbf{c}$, the frequency and wave-vector $\mathbf{e}; \mathbf{k}$ are related to the envelope quantities by $\mathbf{e} = !_e$ $k_e=2, \mathbf{k} = k=2, \text{ so that } \mathbf{e}^2$ $\mathbf{k}^2 = !_e^2$ $!_e^k$. Introducing a u.v. cutto e as in section 4, one nds the dispersion relation:

This should be compared to the dispersion relation $!^2 k^2 = 0$ for the current-m odel near resonance, i.e. with $! = !_0 + !_e$, $k = !_0 + !_e$. U sing the slow ly varying inequalities (7.26), and the expression (4.28), one obtains:

The expressions (9.13) and (9.12), including the imaginary parts, agree when both cuto s are large and when $!_e$ $!_0$; how ever this contradicts the slow ly varying inequalities.

The conclusion of the above analysis is that the quantum SG theory captures some aspects of the fully quantum M axwell-B loch theory, in particular the current-m odel de ned in section 2, and does incorporate spontaneous em ission, but is not equivalent to it even in the slow ly varying envelope approximation.

As a step toward understanding the spectrum of the quantum M axwell-B loch theory, one can assume the approximate validity of the quantum SG description. The quantum SG spectrum is known to consist of breathers, the lowest mass breather being the particle associated with the SG eld itself, and a pair of solitons. See e.g. [10]. The mass of the n-th breather is given by

$$m_n = 2m_s \sin \frac{n}{16}$$

where m_s is the mass of the soliton. As ! 0, the mass of the lowest breather m_1 approaches m thus the polariton is identied as the lowest breather. The higher breathers are polariton bound states. As ! $0, m_s = 2$, thus for very small , the mass of the soliton can be very large compared with the polaritons. In the quantum theory, the polariton can actually be viewed as a bound state of two solitons.

It would be very interesting to understand whether aspects of this spectrum can be seen in the models de ned in section 2.

10. Conclusions

We have de ned som e m odels which describe quantized radiation in interaction with a medium of two-level atoms arranged in a ber geometry. Our main computational results are the photon self-energy (4.21) and (4.28), which determine the rst quantum corrections to the polariton dispersion relation. We also compared our results with known sem i-classical results in the slow ly-varying envelope and rotating-wave approximations, and argued for the approximate validity of the quantum sine-G ordon theory. We found that the model which follows from an interaction ham iltonian \mathcal{C} E (current-model) is better behaved than the model which follows from the minimal coupling p ! p \mathcal{C} , the latter su ering from infrared divergences. In the current model we derived a renormalization group equation for the energy splitting of the two-level atom swhich follows from the beta function (6.4), and shows that the splitting is screened at higher energies. Though the quantum corrections are generically small, we hope that the trend toward fabricating smaller optical devices will eventually lead to the observation of these quantum e ects.

The models de ned in section 2 deserve further theoretical study, in particular it would be interesting to determ ine whether they have a bound state spectrum that resembles the spectrum of the quantum sine-G ordon theory.
