# M ultiple-Scale A nalysis of the Q uantum A nharm on ic O scillator

#### Abstract

C onventional weak-coupling perturbation theory su ers from problem sthat arise from resonant coupling of successive orders in the perturbation series. M ultiple-scale perturbation theory avoids such problem s by in plicitly perform ing an in nite reordering and resum $m$ ation of the conventional perturbation series. M ultiple-scale analysis provides a good description of the classical anharm onic oscillator. Here, it is extended to study the $H$ eisenberg operator equations ofm otion for the quantum anharm onic oscillator. The analysis yields a system of nonlinear operator di erential equations, which is solved exactly. The solution provides an operatorm ass renorm alization of the theory. M ultiple-scale perturbation theory (MSPT) is a pow erfuland sophisticated perturbative
 to both linear and nonlinear problem s. Indeed, it is so general that other perturbative $m$ ethods such as W K B theory and boundary-layer theory, which are usefulin m ore lim ited contexts, $m$ ay be view ed as special cases of M SP T [iT1].

M SP T recognizes that dynam ical system s exhibit characteristic physical behaviors at various length or tim e scales. The problem w th conventional perturbation theory is that there is often a resonant coupling between successive orders. This coupling gives rise to secular term $s$ (term $s$ that grow rapidly with the length or tim e variable) in the perturbation series. Secular term $s$ con ict w ith physical requirem ents that the solution be nite. M SP T reorganizes the conventional perturbation series to elim inate secular term $s$, and in doing so it describes quantitatively the behaviors that occur at $m$ any scales.

O rdinarily, M SP T is applied to classicaldi erentialequations such as D u ng's equation (the nonlinear equation of $m$ otion for the classical anharm onic oscillator):

The positivity of ensures that $y(t)$ is bounded $\left.{ }_{[1]}^{[1]}\right]$. The classical harm onic oscillator $(=0)$ has only one tim e scale, the period of oscillation. H ow ever, when 0 , the nonlinear term in Eq. (1]i) introduces m any tim e scales. U sing M SP T one can show that on a long-tim e scale $\left.t=O\left({ }^{1}\right)\right]$ there is a frequency shift of order .

In this letter we generalize M SP T and apply it to the H eisenberg operator equations of $m$ otion of the quantum anharm onic oscillator (the quantum version of ung n 's equation). This generalization of M SPT techniques is nontrivial because it gives rise to a nonlinear
 system and thereby obtain the quantum operator analog of the classical frequency shift \{ an operator $m$ ass renom alization that expresses the rst-order shift of all energy levels.

W e begin our presentation by review ing the di culties one encounters when one tries to solve D u ng's equation using a conventional perturbation series, $y(t)={ }^{P}{ }_{n=0}^{1}{ }^{n} y_{n}(t) . W e$
choose as initial conditions

which translate into $y_{n}(0)=n_{n ; 0}$ and $y_{n}^{0}(0)=0$, and substitute $y(t)$ into Eq. (11). To zerothand rst-order in powers of ,we have

The solution to Eq. (Зై) satisfying the intial conditions is $y_{0}(t)=$ cost. Introducing this solution into Eq. ( $\underline{i}_{1}$ ), we obtain $y_{1}^{\infty}+y_{1}=\cos (3 t) 3$ cost, which represents a forced harm onic oscillator whose driving term has frequencies 3 and 1. A harm onic oscillator when driven at its natural frequency, which in this case is 1 , exhibits resonance. A s a result, the solution $y_{1}(t)=\frac{1}{8} \cos (3 t) \quad \frac{1}{8} \cos t \quad \frac{3}{2} t \sin t$ contains a secular term that grow sinearly $w$ th time $t$. The function $y_{1}(t)$ cannot be valid for long tim es because the exact solution to Du ng's equation rem ains bounded for all $t$ [1]. Hence, the conventional perturbation expansion is sensible only for short tim est<< ${ }^{1}$.

If one is clever, one can use the conventional perturbation series to determ ine $y(t)$ for long tim es, say of order ${ }^{1}$. To do so we note $\left.{ }_{[1]}^{1}\right]$ that the structure of the $m$ ost secular (highest power in $t$ ) term in $y_{n}(t)$ has the form $\frac{1}{2}(3 i t=2)^{n} e^{\text {it }}=n!+c: c:$; we then approxim ate $y(t)$ by sum $m$ ing the $m$ ost secular tem in every order and the result is a cosine function that rem ains bounded for alltim es $t$ :

Hence, on the long-tim e scale = t we see a frequency shift in the oscillator of order $\frac{3}{2}$. This result is not exact because there are less secular term $s$ to all orders in the perturbation expansion; such term s give rise to frequency shifts of order ${ }^{2}$; $^{3}$; ::: .

The advantage ofM SP T is that it reproduces E q. (5, ) directly and bypasses the elaborate procedure ofsum $m$ ing the conventionalperturbation series to allorders by excluding ab in itio
secular term s from the perturbation expansion. M SP T assum es the existence ofm any tim e scales ( $t,=t$, $={ }^{2} t$, :::), which can be tem porarily treated as independent variables. H ere, we illustrate by perform ing just a rst-order calculation. W e use only the tw o variables $t$ and $=t$ and seek a perturbative solution to Eq. (lī1) of the form

The chain rule and the identity $\frac{d}{d t}=$ convert Eq. (lin) to a sequence of partialdi erential equations for the dependent variables $Y_{0}, Y_{1}$, ::: . T he rst two are

 into the right side of Eq. ( $(\underset{1}{-1})$ and use triple-angle form ulas such as $\cos ^{3} t=\frac{1}{4} \cos (3 t)+\frac{3}{4} \operatorname{cost}$ to simplify the result. To determ ine the functions A ( ) and B ( ) we dem and that there be no resonant coupling between zeroth and rst order in perturbation theory so that no secular term $s$ appear in $Y_{1}$. That is, we require that the coe cients of $\sin t$ and cost van ish:

To solve this system we multiply the rst equation by B ( ), the second by A ( ), and add the resulting equations. Letting $\left.\left.C()=\frac{1}{2} \mathbb{A}()\right]^{2}+\frac{1}{2} \mathbb{B}()\right]^{2}$, we obtain

Thus, C ( ) is the constant C ( 0 ) and the di erential equation system (9, ${ }_{1}$ ) becom es linear:

The solution to this system that satis es the initial conditions is $C(0)=\frac{1}{2}$ and $Y_{0}\left(t_{;}\right)=$ $\cos ^{\mathrm{h}}\left(1+\frac{3}{2}\right) t^{\text {i }}$, which reproduces the approxim ate solution in Eq.( $\underline{L}_{1}$ ). W hile conventional perturbation theory is valid for $t \ll 1$, the M SPT approxim ation is valid for $t \ll{ }^{2}$.

W e now consider the quantum anharm onic oscillator, whose H am iltonian is $\mathrm{H}(\mathrm{p} ; \mathrm{q})=$ $\frac{1}{2} p^{2}+\frac{1}{2} q^{2}+q^{4}$. Here, $\quad 0$ so that the spectrum of $H(p ; q)$ is bounded below and $p$ and $q$ are operators satisfying the canonicalequal-tim e commutation relation $[q(t) ; p(t)]=i h$.

The $H$ eisenberg operator equations of $m$ otion, $\frac{d}{d t} q=\frac{1}{\mathrm{ih}}[\mathrm{q} ; \mathrm{H}(\mathrm{p} ; \mathrm{q})]=\mathrm{p}$ and $\frac{\mathrm{d}}{\mathrm{dt}} \mathrm{p}=$ $\frac{1}{\mathrm{ih}}[\mathrm{p} ; \mathrm{H}(\mathrm{p} ; q)]=\mathrm{q} 4 \mathrm{q}^{3}$, com bine to give the quantum $\mathrm{Du} \mathrm{ng}^{\prime}$ s equation (1) $)_{1}$ :

Since $p(t)$ and $q(t)$ are operators, we cannot im pose num erical initial conditions like those in Eq. $(\underline{\overline{2}})$; rather, we enforce a general operator initial condition at $t=0$ :

$w$ here $p_{0}$ and $q_{0}$ are tim e-independent operators obeying the $H$ eisenberg algebra $\left[q_{0} ; p_{0}\right]=$ ih .
W e now apply M SP T to Eq. (İ- $\overline{2})$. A ssum ing that $q(t)$ exhibits characteristic behavior on the short-tim e scale $t$ and on the long-tim e scale $=t$, we write

This equation is analogous to Eq. ( $(\underset{-1}{-\overline{1}})$ but here $Q_{0}$ and $Q_{1}$ are operator-valued functions.
W e substitute $q(t)$ in Eq. ( $(\overline{1} \overline{4})$ into Eq. ( $\overline{1} \overline{2})$, collect the coe cients of 0 and ${ }^{1}$, and obtain operator di erential equations analogous to Eqs. (iTi) and (徱):

Because Eq. (19) is linear, it is easy to nd its general solution,

It is now necessary to nd the coe cient functions A ( ) and B ( ), which are operators. The canonical com $m$ utation relation in $[q(t) ; p(t)]=$ in implies that these operators satisfy A ( );B ( )] = ih. A lso, the initial conditions in Eq. (1̄3̄) give

W e determ ine A ( ) and B ( ) by evaluating the right side of Eq. ( $\overline{1} \overline{\mathrm{q}})$ and expanding the cubic term , taking care to preserve the order of operator multiplication. A s in the classical case, we sim plify the result using triple-angle form ulas. To prevent secularity in $Q_{1}(t ;$ ) we set the coe cients of cost and $\sin t$ to zero and obtain

This system of operator-valued di erentialequations is the quantum analog of Eq. (9, ${ }^{(9)}$.
To solve the system ( $\overline{1} \overline{-1}$ ) we pre- and post-m ultiply the rst equation by B ( ) and the second equation by A ( ). A dding the resulting four equations, we get

Equation ( $(\overline{2} \overline{\mathrm{O}})$, the quantum analog of Eq. $(\overline{1} \overline{\mathrm{O}})$, show , that H is independent of the long-tim e variable. Thus, Eq. (190) allows us to express H in term s of the fiundam ental operators $p_{0}$ and $q_{D}: H=\frac{1}{2} p_{0}^{2}+\frac{1}{2} q_{0}^{2}$. We then use the commutator A ( );B( )] = ih to rew rite Eq. (19 $\overline{1})$ in $m$ anifestly $H$ erm itian form :

Suppose for a mom ent that we could replace the operator $H$ by the num erical constant C (0) in Eq. (2̄īin). Then we would obtain the c-num ber coupled di erential equations in Eq. (ī11). That system is linear so we could ignore operator ordering and easily nd the solution satisfying the intial conditions (1̄ī): A ()$=q_{0} \cos [3 C(0)]+p_{0} \sin [3 C(0)]$ and $B()=p_{0} \cos [3 C(0)] \quad q_{0} \sin [B C(0)]$. This solution suggests the structure of the exact solution to the operator di erential equation system (211). The form al solution is a natural generalization using $W$ eyl-ordered products of operators:

The operator ordering $W\left[g_{0} f(H)\right]$ is de ned as follows: (1) Expand $f(H \quad$ ) as a Taylor series in powers of the operator $H$; (2) W eylorder the Taylor series term toy-term : $W\left(Q_{0} H^{n}\right) \quad \frac{1}{2}^{P}{ }_{j=0}^{n}\binom{n}{j} H^{j} O_{0} H^{n}{ }^{j}$. U sing this de nition it is easy to verify that Eq. (E-2i)
 sim plify the form alsolution in Eq. (2̄2̄) and re-express it in closed form by observing that if we reorder $W\left(q_{0} H^{n}\right)$ by com $m$ uting $q_{0}$ sym $m$ etrically to the left and to the right to $m$ aintain the $H$ erm itian form we generate a set of polynom ials $[\underline{4}[\underline{i}]$ of degree $n$ :

Equation (2 $\overline{2} \overline{-1})$ is the quantum operator analog ofE q. (5-1) and is the ob jective ofourm ultiscale analysis. [W e can recover the classicalM SP T approxim ation in Eq. (5ㅓㅣ) by taking the lim it $\mathrm{h}!0$ and im posing the classical initial conditions $p_{0}=0$ and $q_{0}=1$, which give $H=\frac{1}{2}$.] Recall that in the classical case we identify the coe cient of the time $t$ as a rst-order
approxim ation to the frequency shifl. Since the coe cient of $t$ in Eq. ( $24 \overline{4} \overline{1})$ is an operator, we have derived an operator form of $m$ ass renom alization.

To elucidate this operator $m$ ass renorm alization we study $m$ atrix elem ents of Eq. (2َīi). The tim e dependence of a $m$ atrix elem ent reveals the energy-leveldi erences of the quantum system. It is easy to construct a set of states because the operators $q_{0}$ and $p_{0}$ satisfy the H eisenberg algebra $\left[q_{6} ; p_{0}\right]=$ ih. Hence, appropriate linear combinations of $q_{0}$ and $p_{0} m$ ay be used as raising and low ering operators to generate a Fock space consisting of the states jni. By construction, these states are eigenstates of the operator $\mathrm{H}: \mathrm{H} j \mathrm{ji}=\mathrm{n}+\frac{1}{2} \mathrm{~h} j \mathrm{i}$.
 to the left and the right, we obtain

which predicts that the energy-level di erences of the quantum oscillator are $1+3 \mathrm{nh} . \mathrm{We}$ $m$ ay verify this result by recalling that the rst-order correction to the energy eigenvalues [白] $]$ is $\mathrm{E}_{\mathrm{n}}=\mathrm{n}+\frac{1}{2}+\frac{3}{4} \mathrm{~h}\left(2 \mathrm{n}^{2}+2 \mathrm{n}+1\right)+\mathrm{O}\left({ }^{2}\right)$. Thus, $\mathrm{E}_{\mathrm{n}} \quad \mathrm{E}_{\mathrm{n} 1}=1+3 \mathrm{nh}+\mathrm{O}\left({ }^{2}\right)$.
$W$ e conclude by noting that in addition to the operators $q(t)$ and $p(t)$, the wave function
(x) for the quantum anham onic oscillator also exhibits m ultiscale behavior. Speci cally, to allorders in conventional weak-coupling $R$ ayleigh-Schrodinger perturbation theory, (x) behaves like the G aussian $e^{x^{2}=4}$ for large $x$; how ever, a geom etrical-optics approxim ation to ( $x$ ) from W K B theory predicts that for large $x$, $(x)$ decays like the exponential of a
 perturbation series by resum $m$ ing secular term $s\left[\begin{array}{l}\text { Thin }\end{array}\right]$.

The wave function (x) obeys the Schrodinger equation

The recursion relation for the polynom ials $\mathrm{P}_{\mathrm{n}}(\mathrm{x})$ is typical of all perturbative calculations; the hom ogeneous part of this recursion relation is independent ofn while the inhom ogeneous part contains all previous polynom ials. This recursive structure is responsible for successive orders of perturbation theory being resonantly coupled and causes the degree of the polynom ials to grow w ith $n$.

To study the behavior of the wave function ( $x$ ) for large $x$ we approxim ate $(x)$ by resum $m$ ing the perturbation series and keeping just the highest power of $x$ in every order. [I his is an exact analog of nding the coe cient of the highest power of $t$ ( $m$ ost secular term ) in nth order in perturbation theory for the classical anharm onic oscillator.] This resumm ation gives a new representation of $(x)$ : $e^{x^{2}=4} e^{x^{4}=16} \mathrm{~m}$ ultiplied by a new set of polynom ials. For the classicalanharm onic oscillator sum m ing leading secular term salso gives an exponentialapproxim ation [see Eq. (⿹ㅣㄴ) ]. H ow ever, the classical and quantum anharm onic oscillators are quite di erent; although we have sum $m$ ed the $m$ ost secular term $s$ to allorders in perturbation theory, the result is not the actual behavior of the wave function $(x)$ for large x ; the correct behavior is an exponential of a cubic and not a quartic!

If we iterate this resum $m$ ation process we nd that each reorganization of the perturbation series gives an additional term in the exponential

and a new set ofpolynom ials. It seem sim possible for this approach to give cubic exponential behavior because at each stage in the reorganization of the perturbation series the variable $x$ appears only in even powers. H ow ever, we recognize that the exponent in Eq. (2̄-1) is the beginning of a binom ial series whose sum is $\frac{1}{6}{ }^{h} 1\left(1+x^{2}\right)^{3=2^{i}}$. If we now let $x$ be large
