Abstract

W e outline the renorm alization of the standard m odel to all orders of perturbation theory in a way which does not m ake essential use of a speci c subtraction scheme but is based on the Slavnov-Taylor identity. Physical elds and parameters are used throughout the paper. The W ard-identity for the global gauge invariance of the vertex functions is form ulated. As an application the C allan-Sym anzik equation is derived.

1. Introduction

The renorm alization of the electroweak standard model is a well studied subject (s.[1,2]). The one-bop approximation is almost complete, two-bop calculations have been started. For the all order treatment however only $[\beta]$ is available, where the necessary reasoning has been performed in terms of the symmetric variables i.e.

elds which would occur without the spontaneous symmetry breaking. But if one wants to support the explicit calculations and e.g. form ulate rigid invariance as it is needed in practice then one has to renorm alize in the on-shell scheme which means formulate the renormalization in terms of the physical elds. Due to the 5-problem dimensional regularization will not be invariant with respect to the symmetry hence a formulation of the model is desirable which does not make explicit use of a speci c subtraction scheme, but relies only on general properties like locality and power counting. In the present note we describe a few results of the respective analysis. Specifically we write down the Slavnov-Taylor (ST) identity and discuss its general solution in the classical approximation. As important applications we derive then the rigid invariance and the Callan-Symanzik equation in the one-loop approximation. In order not to overload the paper we have never written down the ferm ionic sector (i.e. quarks, leptons and their couplings) but mentioned when we made simplifying assump-

tions (like CP-invariance) concerning them .

2. The classical Lagrangean

The standard m odel of electrow eak interactions is a non-abelian gauge theory with gauge group SU (2) U (1). After spontaneous symmetry breakdown one has to identify the physical elds W ;Z ;A and H (for Higgs) in the bosonic sector, quarks and leptons in the fermionic sector by diagonalizing the mass matrices. At the same step one identies the currents (charged, neutral, electrom agnetic) by constructing the charge eigenstates. For the bosonic sector we have the following classical approximation

W e use the summation convention for the roman indices with values +; ;Z;A and have introduced convenient notations. The tensor

T he m atrix $T_{aa^{0}}$ guarantees the charge neutrality of the classical action

The value $v = 2M_W = g$ for the shift parameter yields the desired masses for the physical elds. W e may now turn to the global and local symmetries of the action. By construction we conserved the electric charge and can obviously express this conservation law by 7

which according to (14) de nitely is the electrom agnetic current but nevertheless does not have a simple QED-like form because it contains nonabelian contributions in the eld strenght G and the covariant derivative D . The nalform of these relations is now obtained by verifying that

This functional form of Noethers theorem and bcalgauge invariance permits to identify the coupling of the electrom agnetic current to the photon as the elementary charge e

It is noteworthy that the coupling g of the abelian factor in SU (2) U (1) was not constrained by the algebra but xed by the assignment of the weak hypercharge and is now identied by (18).

For the weak currents a similar reasoning is possible up to the point where the spontaneous breakdown of the chiral SU $(2)_L$ symmetry intervenes. So the global operator

when acting on $_{GSW}$ will not produce zero but soft breaking terms which correspond to the action of an inhom ogeneous operator

and the bosonic contributions to the charged weak current comprise also lower dimensional terms whose origin is the spontaneous breaking. A nalogously one proceeds for the neutral current. The virtue of (17) and (21) is that they exhibit the currents and their (non-)conservation depending on their type. For the purposes of renorm alization and compact writing one incorporates of course the inhom ogeneous di erential operators into the lhs. and de nes

3. Gauge xing, quantization and the Slavnor-Taylor identity

The importance of the standard model originates from the fact that it is a renormalizable eld theory and thus permits consistent higher order calculations. A nessecary prerequisite for this is gauge xing which very often is done in the term s of the so-called R -gauges:

Applying the W and identity operators W_a to $_{g:f:}$ one nds that only W_b yields zero this being due

to charge neutrality. All other W and identities are broken by the mass term s in (26). This is a fortioritrue for the local version of which we give but one example:

The terms in W indicate that @A is not a free eld hence unitarity cannot be deduced from the localW and identity. In order to remedy this situation one has to add the Faddeev-Popov () elds c_a , \bar{c}_a (a = +;; Z;A) and to enlarge the gauge sector by a ghost action in such a way that BRS invariance is achieved. The BRS transformations of the physical elds read:

BRS invariance turns out to be the relevant invariance for quantization and renorm alization because it was the interactions amongst the unphysical elds in such a way that the complete action is renorm alizable and eventually the physical S-m atrix unitary. The proof of renorm alizability and unitarity is based on a speci c functional form expressing the BRS invariance to all orders: the ST identity. The main reason for the form ulation given below is the questionable existence of an invariant regularization for the standard model. One thus prefers not to rely on a very specic regularization scheme and to control the non-linear BRS transform ations i.e. their non-trivial renorm alization by a suitable technicaltool: external elds coupled to the eld variations.

the vertex functional ordered according to the number of closed loops. In writing down (33) we have slightly changed the gauge xing by introducing auxiliary elds B_a of dimension 2 and the BRS transform ations

The BRS transform ations are then nilpotent on all elementary elds and $_{g:f:} + _{ghost}$ is a variation; this sim pli es the algebraic analysis to be performed later on.

Q uantization and consistent renorm alization of the standard m odel m eans to establish (33) to all orders of perturbation theory for the 1PIG reen functions collected in the functional $\$.

The use of (33) proceeds in two steps: First one has to show that the classical action (which is local) is the general solution of (33) on which one has imposed a set of norm alization conditions i.e. one has disposed of a (nite) speci c set of param eters. This set must not be changed in higher orders otherwise one has no operator interpretation in a xed Fock space. Second one has to show that all possible breakings of the ST identity arising in higher orders can be rem oved by adjusting nitely m any local counterterm s. For the purpose of the present paper we restrict ourselves to step one and refer for step two to the literature [3]. There it has been shown (in terms of the "symmetric" variables) that the only true obstruction to (33) is the A dler-B ardeen anom aly which is absent in the standard model family by family due to the doublet structure and colour multiplicity.

In order to simplify for a rst trial our task we assume that CP is conserved. This amounts to forbid mixing in the ferm ion families. We choose the Higgs eld to be even, the eld to be odd under CP. Then we insert into (33) the most general $_{cl}^{gen}$ which is neutral with respect to electric and charge and has dim ension less than or equal to four. The outcom e of the rather lengthy calculation can be sum m arized as follow s: The gauge xing and ghost part of $\frac{\text{gen}}{\text{cl}}$ is com pletely separated from the rest. The vector and scalar eld contributions are self-consistently determ ined from the external eld part, which xes the transform ation properties of the elds. Input parameters are the masses M_{W}^{2} ; M_{Z}^{2} ; m_{H}^{2} of the vectors and Higgs respectively and one coupling g. If one requires that these parameters do not vanish, the action is uniquely determ ined up to (non-diagonal) eld rede nitions. I.e. $\frac{gen}{cl}$ is obtained from the standard form by perform ing the eld transform ations

The general form of z is the following

They separate the Z-boson and the photon onshell and identify the photon as the massless particle. As the explicit one-loop calculations have shown one needs precisely these parameter redefinitions found here in the general solution of the ST identity if one wants to adjust the non-local mixing term s between Z and A .

4. W ard-identities of global sym m etries

In section 2 we have indicated the global sym metries valid for the classical action of the standard model, which are however violated in the course of quantization by the mass terms of the gauge xing. In higher orders the splitting up into gauge xing and physical part becomes nontrivial, because the breaking can be inserted in any bop diagram with internal vector and scalar lines, but still is soft, i.e. it vanishes form om enta larger than all masses. In order to form ulate rigid sym m etries in higher orders system atically and independently of the scheme we couple the soft breaking to external non-propagating elds, so that the sym metry is form ally restored. Explicitly: First we enlarge the gauge xing by an external scalar doublet

with the same quantum numbers as the scalar doublet and a shift in its CP-even neutral com – ponent \hat{H} . Then we write

Equ. (46) is written in a manifestly invariant form [5]. It reduces to the original gauge xing for vanishing external elds, because it is the shift of the external Higgs, which produces the gauge xing of the quantum elds

Enlarging W $_{a}$ by the transform ation of a and B $_{a}$, the latter transform ing in the same way as the vectors V $_{a}$, $_{g:f:}$ is seen to be invariant. Finally we read o from the BRS-transform ations that the -ghosts transform also like the vectors, and from the ST identity we read o the transform a-tion of the respective external elds. We thus arrive at

and having form ulated the symmetry as a W ard identity one again can interpret $_{\rm cl}$ as the lowest

order of the functional of IP IG men functions and deduce consequences for the 1-loop order by using the action principle. It tells us that the W I is at m ost broken by local contributions, hence all the non-local contributions sum up to symmetry. It is clear that such identities constitute im portant consistency checks in concrete calculations.

How to proceed for higher orders? Neglecting for the moment the fermion sector with the parity violating interactions we remain with the Higgsvectorm odel and know that dimensional regularization is an invariant scheme. Then from the general classical action one reads o that the W I in its classical form is valid for the bare elds. The renormalized G reen functions satisfy therefore deform ed W I which have 1-loop corrections due to the eld renormalizations (37). For the vector part this reads:

For the complete theory this simple argument does no longer hold and one has to carry out the proof of rigid symmetry constructively by algebraic consistency. The main point is the observation that the deformed W and operators (50) are derived from an equivalence transform ation and are the unique CP-odd solution of the SU (2) U (1) algebra (23). Then a deformed W I can be established including the ferm ion sector to all orders of perturbation theory.

5. The Callan-Sym anzik equation

Finally as an application of rigid symmetry we derive the Callan-Symanzik (CS) equation of the standard model in the spontaneously broken phase. The CS equation describes the behaviour of the G reen functions under dilatations. The hard breakings of dilatations which appear due to the existence of asymptotic logarithms are the functions and anom alous dimensions. These functions are constrained in one loop by the global symmetry of the classical action.

The soft breaking of dilatations is in the classical approximation given by the mass term s, in higher orders it can be constructed along the lines of [6].

A coording to the action principle one has in 1-loop order

From BRS invariance one can deduce that these local polymials can be written as diemential operators acting on the classical action. From algebraic consistency with rigid symmetry one nds that the hard breakings are moreover globally symmetric:

This form is valid for all tests with respect to propagating elds. To simplify the writing the external elds have been put to zero.

There are two rem arks concerning the CS equation: In the spontaneously broken phase the CS equation contains the -functions with respect to the on-shell masses of the theory. A similar feature we have already discussed in the U (1)-axial model with ferm ions [7].

The anom alous dimensions ^ appear in connection with the abelian subgroup of the standard model. There we have to introduce also the di erentiation with respect to the abelian gauge parameter ^;

This gauge xing contains non-diagonal contributions and is generally taken to be zero in lowest order. The fact, that it has to be introduced into the CS equation with a nonvanishing coe cient $^{n} = (e_{2_{M_{W}}} \frac{\sin w}{\cos w})^{2} + ^{N}$ shows that the choice $^{2} = 0$ is not stable under renorm alization.

F inally we want to m ention that there is a relation between the -functions and anom alous dimensions due to the abelian subgroup:

$$_{e} = _{M_{W}} \frac{\sin_{W}}{\cos_{W}} + ^{V} + ^{V} \frac{1}{\cos^{2}_{W}}$$

6. Conclusions

The ST identity governs the construction of gauge theories. It de nes the model in question once the symmetry group and the multiplets are given; it then determines the rigid invariance which embodies the remaining physical symmetry. W ithin the standard model we have sketched as an example how the general solution of the classical approximation exhibits the free parameters which have to be xed by normalization conditions or can partly be constrained by the rigid invariance. The expression of the rigid symmetry in terms of a W ard identity turns out to be nontrivial. The e ect of the classical symmetry to the one-bop approximation and the CS equation has been indicated.
