#### Abstract

$U$ sing $W$ egner $H$ oughton equation, $w$ th in the LocalP otentialA pproxim ation, we study criticalproperties of ( $(\mathbb{N}$ ) vectorm odels. $F$ ixed P oints, together $w$ ith their critical exponents and eigenoperators, are obtained for a large set of values of $N$, including $N=0$ and $N$ ! 1 . Polch inskiequation is also treated. T he peculiarities of the large $N$ lim it, where a line of $F$ ixed $P$ oints at $d=2+2=n$ is present, are studied in detail. A derivation of the equation is presented together $w$ ith its projection to zero m odes.

## 1 Introduction

In this article we study $O(\mathbb{N})$ linear sigm a m odels near criticality, with in the fram ew ork of the E xact $R$ enorm alization $G$ roup ( $E R G$, hereafter), m ainly in its sim pler nonperturbative approxim ation, the LocalP otential A pproxim ation (LPA). W e concentrate $m$ ostly in the $W$ egner $H$ oughton equation [ITI], although other equations are_also considered [ $\underline{R}_{1}^{1}$, ,

Recent results [] [] have raised interesting questions about the behaviour of the RG near rst-order phase transitions. They are in som econ ict $w$ ith exact results of $W$ egner $H$ oughton equation at $N$ ! 1 [-山్త]. A system atic study of this subject at nite N is still lacking. A though our interest points in that direction, $m$ any aspects of second order phase transitions had to be previously worked out. This paper is m eant to llthis gap, as well as review the derivation and pro jection of the equation $w$ ith a $m$ odem language, pay ing specialattention to som e aspects not fully treated in the literature, which we hope w ill be useful for a subsequent study of $O(\mathbb{N}) \mathrm{m}$ odels at discontinuous phase transitions. $N$ evertheless, as this paper is focused in continuous transitions, we leave to the conclusions further com $m$ ents on rst-order ones.

ERG $m$ ethods are exact form ulations of the RG in di erential form (see Ref. [ [G]]), that is, the evolution of the renom alized action along the RG ow is studied in term $s$ of di erential equations. There are $m$ any such equations, being one of the oldest that of $W$ egner and H oughton [III], which corresponds to a decim ation in $m$ om entum space, i.e., a lowering of a sharp $m$ om entum cuto . Unfortunately, those equations are very involved and exact solutions are only available for very sim ple $m$ odels. N evertheless, several feasible nonperturbative approxim ations are possible, being the $m$ ost prom ising an expansion in powers ofm om enta. The LPA $[\overline{[ }]$ is just the rst term of such an expansion $\overline{[1} \overline{1}]$.
$T$ he organization of the paper is as follow s. In Section ${ }_{2}^{2} 1 \mathrm{~W}$ egner H oughton equation is derived in som e detail. The LPA is discussed in S'ection $\overline{12}$, and exten-
 at nite N as well as its eigenoperators. It is also show n that irrelevant eigenvalues, which are related to the anom alous dim ensions of higher-dim ensional com posite operators, $m$ ay be obtained $w$ th ease. The com parison $w$ th our results from Polchinskiequation as well as other determ inations is left to Section
 som e striking results are obtained. Section $\bar{T}$, is devoted to the conclusions. Finally, som e peripheral sub jects are treated in tw o A ppendices.

## 2 D erivation

In this section a carefulderivation of $W$ egner $H$ oughton equation is presented, trying to be as self-contained as possible. N evertheless, for the sake ofsim plicity, we concentrate on the $N=1$ case. $O$ nce th is case is m astered, its generalization for arbitrary $N$ is straightforw ard.
$W$ e assum e that our action is regulated with a t-dependent shanp cuto in
$m$ om entum space $t=e^{t} 0, w$ ith allm odes $w$ ith $\dot{\mu} j>t^{t}$ already elim inated, where t param etrizes the RG ow and 0 is a xed scale. A RG transform ation consists of two steps, a blocking or elim ination of short-distance degrees of freedom, and a change of length scale. In this way one goes from an action cuto at $t$ to one at $t+$, in physical units. From now on, we work with dim ension less quantities, the dim ensions being given, if needed, by $t$. We derive $W$ egner $H$ oughton equation rst considering the blocking, and afterw ards the rescaling.

As we are seeking a di erential equation for the renorm alized action, we need to consider just an in nitesim alblocking, hence we discard term s of order

W e perform the $q_{i}$-integrals in pairs, using Lemma 2 to extract the leading dependences in . At the end, we obtain, in agreem ent with Lem ma3, that it is $O\left({ }^{n=2}\right)$ for $n$ even or else $O\left({ }^{(n+1)=2}\right)$ for $n$ odd, $w$ th the nalaid of Lem $m a$ 1. Furtherm ore, let us assum e that Lemma 3 is true for all diagram $s w$ ith $K$ vertices other than 1-leg ones. Let us now prove that it is also true for diagram $s$ w ith $\mathrm{K}+1$ such vertices. To this end, note that a generic tree diagram $G \mathrm{w}$ ith $K+1 \mathrm{~m}$ ore-than-one-leg vertioes contains at least one n -vertex (for som en $\in 1$ ) w ith allbut one leg connected to 1 -vertioes ${ }_{L^{\prime}}^{\mathrm{T}}$

If the selected vertex is a n-vertex, w ith n odd, perform all integrals associated with its legs but the one that connects it to the rest of the diagram. Perform ing the integrals in pairs, and using Lem ma2, it brings about a contribution $\left.O\left({ }^{(n} 1\right)=2\right)$. It rem ains a diagram $G^{0} w$ th $K m$ ore-than-one-leg vertioes, where the form er selected vertex enters now as an additional1-vertex (w ith $S_{q}^{0}$ replaced by som e other function). If n is even, then integrate over all its legs connected to 1 -vertioes but one. $T$ his is, using Lem ma 2 again, $O\left(\begin{array}{ll}\left(\begin{array}{l}2\end{array}\right)=2\end{array}\right)$. There is left over a 2 -vertex connected both to the rem aining sub-diagram and to a 1 -vertex. The argum ent that leads to the proofofLem m a 3 has to be slightly modi ed for diagram s w ith L loops. A ny 1P I part contains one q-integral per loop, w ith the only restriction that of being within the shell. A fter perform ing those integrals, we end up with a contribution $O$ ( ${ }^{\mathrm{L}}$ ) tim es an e ective tree diagram. $T$ herefore, the correct formula is to add the number of loops to the result of

W e conchide then that there cannot be diagram swith m ore than one loop and that one-loop diagram sm ust have zero extemal legs. Furtherm ore, it happens again that diagram $s w$ ith $m$ ore than two legs generate further loops and that tw o-legs ones $m$ ust have the form of Eq. 1

The $\mathrm{N}=1$ case was rst com puted in Ref. $\overline{1}$,, w th results $=0: 687$ (1) and $!=0: 595(1)$, and afterw ards in Ref. [11]. O ur num bers are com patible w ith the form er and coincide $w$ th the latter.

E igenoperators are obtained as an additionalbonus. A s a m atter ofexam ple, we plot in Fig. to di erent values of $N$ at $d=3$.

TheN ! 0 lim it deserves a specialrem ark, as the $R G$ equation, at $N=0$. $N$ evertheless, one $m$ ay com pute its eigenvalues in an indirect way. Taking values of $N$ betw een $0: 1$ and $0: 01$, one nds that they perfectly $t$ a straight line, with no sign at all of subleading corrections. C ritical exponents reported in Table ${ }_{1}^{-1 / 1}$ are just their extrapolation to $N=0$. In Fig.' ${ }_{1}^{\prime}$ we plot the

## 5 C om parison w ith other equations

In this section we com $m$ ent on other ERG equations and com pare $w$ ith know $n$ results.

A part from the $W$ egner $H$ oughton equation studied above, one of the oldest

It presents som e attractive features: in the lim it where the $\mathbb{R}$ cuto vanishes (which corresponds to the continuum lim it) it is directly observable, as it is the equation of state of the system. M oreover, it presents a natural expansion which can be directly $m$ apped to the usual loop expansion of perturbation theory [ $\left.1{ }^{-1}{ }^{4}\right]$. Various regulators have been used in connection $w$ ith this equation. If a sharp $m$ om entum cuto is chosen, its LPA coincides w th that of $W$ egner $H$ oughton's. On the other hand, it has been extensively worked out using the special polynom ial cuto introduced in Ref. 든ㄴ, which has the advantage of preserving som e sym $m$ etries of the exact equation through the derivative expansion. T his equation is $m$ uch harder to num erically analyze than the above tw o ones. W e do not discuss it further, but only quote the results


To assess the system atic errors involved in such calculations would require to com pute corrections to the LPA. Instead, we com pare our results w ith som e derived from other techniques.

 for ! are not so precise. A com parison of our results from $W$ egner $H$ oughton and Polchinskiequationsw th those from the $\mathbb{R}$-cuto e ective action and other existing estim ates are shown in Tables,

Criticalindices from $W$ egner $H$ oughton equation are 10 15\% 0 for $N<10$, except at $N=0$, which is quite accurate ( 3\%). In the interval10 $<N<100$, they are o by a few per cent, and for $N>100$, the errors are less than one perm ile. O ther ERG perform slightly better, specially Polchinski's equation in which critical indiges are a few per cent o at most. This should not com e as a sunprise, since in spite of its conceptual clarity, the sharp $m$ om entum cut-o leads to bad locality properties of the renorm alized actions, being then very much sensitive to truncations. In order for the pro jected ERG equation to deliverm ore precise outcom es, one should nd RG blockingsw ith the property that renorm alized actions are as m uch local as possible, as it is achieved in the lattice regularization w ith blockings in real space [23].

## 6 N ! 1

W egner and H oughton [in] already studied the lim it $N$ ! 1 of their equation, encountering both the G FP and the HFP.T hey also brie y m entioned the possibility of further FPs. O ur aim is to discuss in œrtain detail those not previously studied and present a general fram ew ork to dealw ith this kind of large $N$ equations. An application of these $m$ ethods for the Polchinskiequation is given in

B efore getting into a detailed analysis, let us state that, for any allow ed C , these FP s are reached by Eq. ${ }^{6} \bar{L}_{1}^{1}$, at $t!1$, from an in itial potential

The adm issible values of C are $0<C \quad 1$. A lthough the HFP corresponds to $C=0$, it does not belong to this line ofFPs. This is not so sunprising in view of Eq.īg: critical properties are not continuous in $C$ at $C=0$. Note, how ever, that these singularities have nothing to do w ith RG transform ations: C labels di erent initial conditions for the RG transform ations, but once one C is chosen, it is not changed along the ow.
$T$ he FP in the $n$ even case com es from $m$ atching the two branches of $y(u)$ at $Y$,

$T$ he case $C=\frac{A_{d}}{2 \sin _{n}}$ deserves further considerations because the FP is not analytical at $y=0$. It behaves like $u(y)=\frac{n A_{d}}{2(n+1)} \frac{1}{y}+O(1)$, and its eigenvectors like,

The case $n=2(d=3)$ were previously studied in Ref. [2]-1] and these features were identi ed as the RG structures which make the existence of the BM B phenom enon [2] possible. T hat is, the possibility that at $C=\frac{A_{3}}{2 \sin \frac{1}{2}}$, the FP acts as an ultraviolet stable one, allow ing to de ne a new continuum lim it other than the G aussian and H eisenberg FPs. In fact one that has $m$ ass generation and spontaneous sym $m$ etry breaking of scale invariance accom panied w th the appearance of a dilaton. $W$ hat we now see, is that all RG properties that m ake this phenom enon to appear at d = 3, are present for all the rest ofn even values, hence a sim ilar scenario is likely to take place. To elucidate these issues would require a further analysis of the e ective potential at the vicinity of this peculiar FP. This is, how ever, beyond the scope of this paper.
$T$ he preceding considerations have show $n$ the existence of a line ofFP s starting at the G FP and including it. This scenario is only feasible provided that the G FP containsm arginalnon-redundant operators. This restricts the dim ensions of space (space-tim e) to be

which gives a nige physical interpretation of the dim ensions previously derived from analyticity considerations. Thus, in the large $N$ lim it, the $m$ arginaloperator becom es com pletely $m$ arginal and a line of inequivalent FP appears, though
they have the criticalexponents of the GFP. Thism ight be a general feature of this $\lim$ it.

Before closing this section we would like to rem ark that, although our analysis of Eq. ${ }^{\prime} 6 \bar{O}_{1}^{\prime \prime}$ is restricted to dim ensions $2<d<4$, a sim ilar study in other dim ensions is possible along the sam e lines. For instance, in $d=4, \mathrm{Eq} .{ }^{\circ} \mathrm{G} 1 \overline{1}_{1}^{1}$ is substituted by

## 7 C onclusions

This paper presented a detailed study of $W$ egner $H$ oughton equation. W e have show $n$ that in spite of its intractable appearance, the use of the LPA m akes it am enable for extracting plenty of valuable inform ation.

The derivation of the equation has been w orked out, with special care about the term s that contribute to the blocking. T he pro jection has been derived, and explained in which sense it is exact in the N ! 1 lim it.

W hat we feel rem arkable about the ERG $m$ ethods $w$ thin the LPA is, succinctly; (i) The qualitative features of the RG at $2<d \quad 4$ are the same as in the expected full com putation; (ii) E igenvalues and eigenvectors are obtained w ith ease, both relevant and irrelevant ones; (iii) $N$ um erical results are, at th is order in the derivative expansion, not as accurate as otherm ethods, at least for low enough $N$, but those are com putationally much harder; (iv) The N ! 0 lim it is reliable within this fram ew ork.

The LPA of Polchinskiequation has been also studied, and found that the accuracy is im proved. This suggests that a calculation of next order in the $\mathrm{m} \mathrm{o}^{-}$ $m$ entum expansion $m$ ay deliver quite rigorous results. $N$ evertheless, am biguities appear in connection w the determ ination of the non-vanishing anom alous dim ension, which are not present at low est order [131]. A further study of these issues, hence, seem s justi ed $\left.{ }_{2}^{2} \bar{T}_{1}^{\prime}\right]$.

Section ${ }_{1}{ }^{1}$, has been devoted to the N ! 1 lim it. Som e existing results, scattered throughout the literature, have been review ed within a general fram ew ork, which has also been fruitfulto study new FP s at criticaldim ensions $d=2+2=n$, as well as to dealw ith other RG equations. A s an exam ple, we have w orked out the large $N$ lim it ofP olchinskiequation.
$T$ he scope of the paper did not perm it to consider other sub jects of interest. Am ong those, the study of the projected RG equation ins, outside the linear
approxim ation, usefiul to elucidate the topology of the RG the e ective potential of the new FPs at N ! 1, w ith specialem phasis on the singularities that we associate to the BM B phenom enon; and a m ore system atic study of Poldhinskiequation. W e hope that those issues will be tackled in a near fiuture.

B efore closing, we w ould like to com eback to our originalm otivation on rstorder phase transitions, singling out som e ofour results w hich have im plications for them. W e have explicitly show in Section that in the large $N$ lim it, the
 Ref. [T]'] to lead to singularities of the RG whenever two com peting m in im a exist, which is the case when rst-order phase transitions take place. Those exact results point that the RG trajectories are singular and $m$ ulti-valued, which is at odds w ith Fundam ental Theorem sone and Two of Refs. $\left[\begin{array}{l}i \\ \hline\end{array}\right]$. N onetheless, one should keep in $m$ ind that those theorem $s$ do not rigorously apply for unbounded spins. On the other hand, the derivation of $W$ egner $H$ oughton equation of Sec-
 as suggested in Ref. [7], $m$ ay not be the case if $m$ etastable states do exist. A further study on all those sub jects is beyond the scope of this paper, but we think that they pose interesting questions on the conventionalwisdom of the RG.

In this section we work out the GFP from a direct com putation of the partition function, reobtaining in quite a di erent way expressions already quoted in Section $\overline{1} \mathbf{4}$. W e use diagram $m$ atic techniques very sim ilar to the ones in deriving the approxim ate recursion form ula $\left[\frac{\sigma}{6}\right] . W$ e explicitly treat the $N=1$ case, but the N arbitrary situation is com pletely analogous.

W e consider the splltting in Eq.

In this appendix, we sketch the results for the large $N \lim$ it ofP olchinskiequation. Our am is tw ofold: on one hand to show that our techniques introduced for $W$ egner $H$ oughton equation are quite general and $m$ ay be easily applied to other RG equations as well; also to prove that the annoying restriction $u>1$ of the form er equation is not an essential feature. This last fact would $m$ ake interesting to repeat the large $N$ analysis of $R$ ef. "]le for Polchinskiequation.

This allows $u=O\left(\frac{1}{y}\right)$ in the vicinity of $y=0$, like in the $W$ egner $H$ oughton case. These non-analyticities associated to the BM B phenom enon seem to present, therefore, som e kind of universality.
